I claim the ornamental design for a container for food products, as shown and described.

**DESCRIPTION**

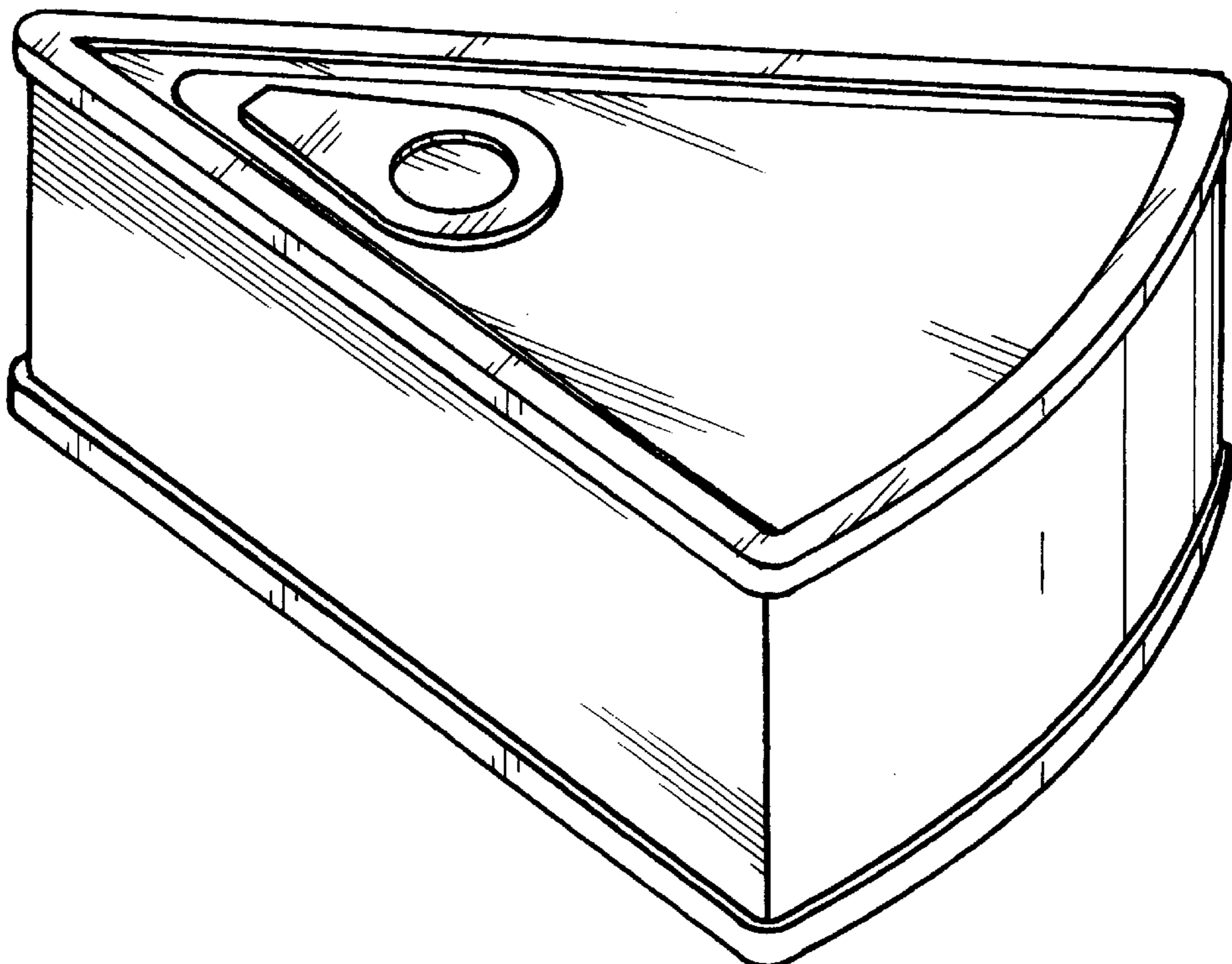

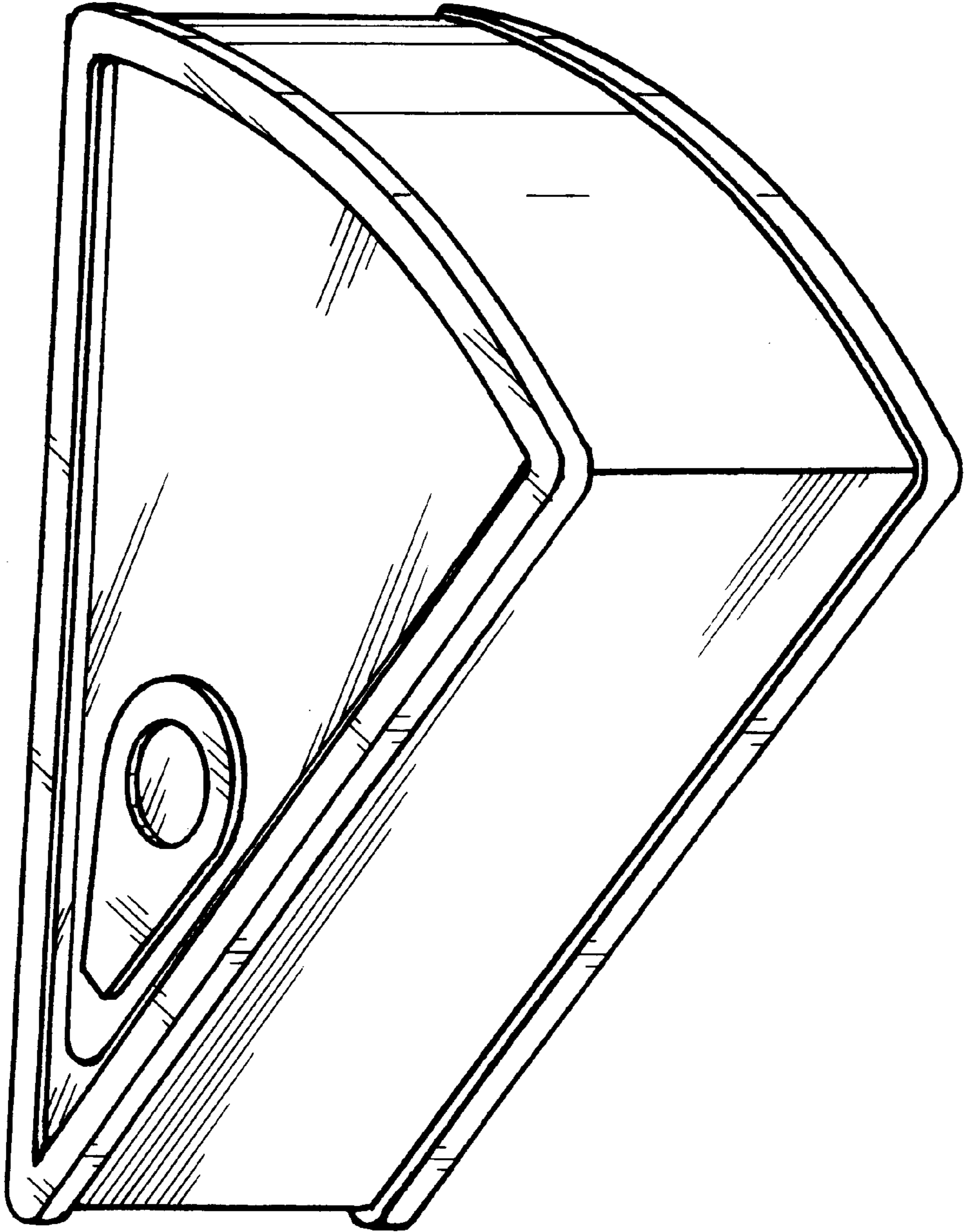

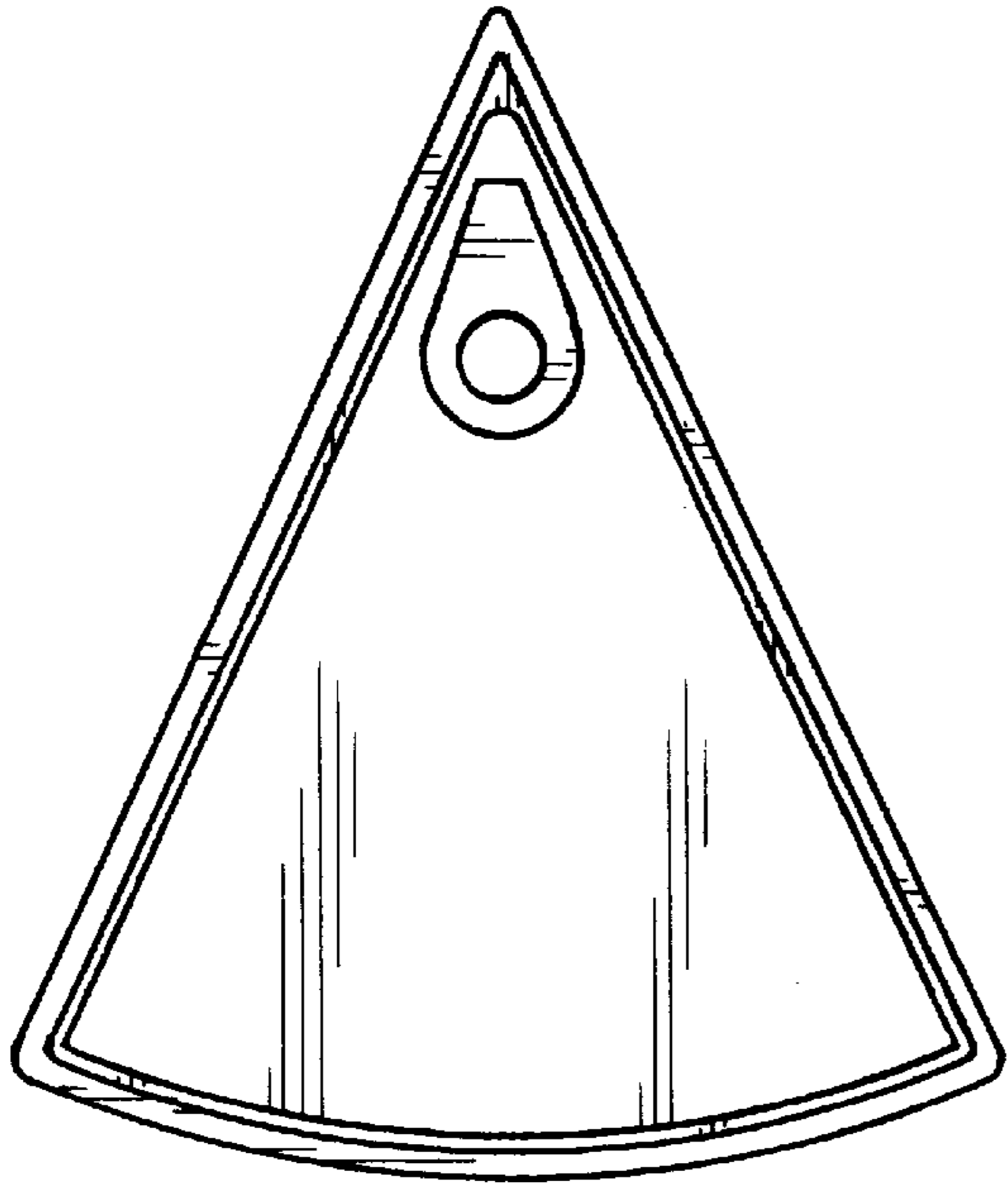

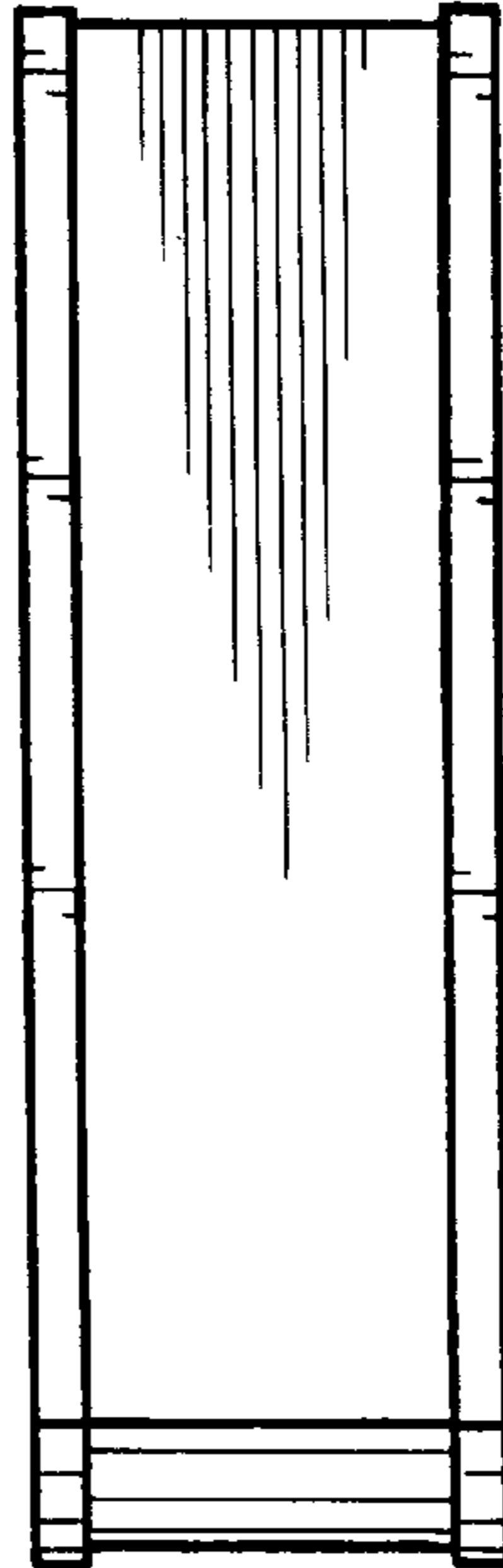

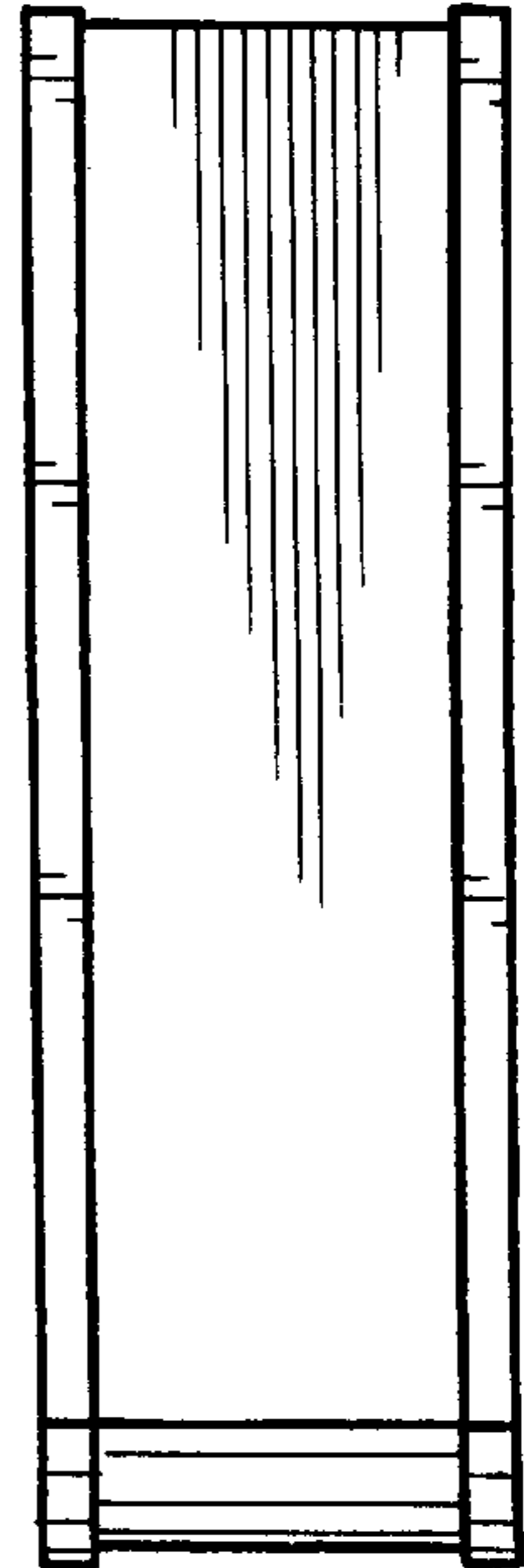

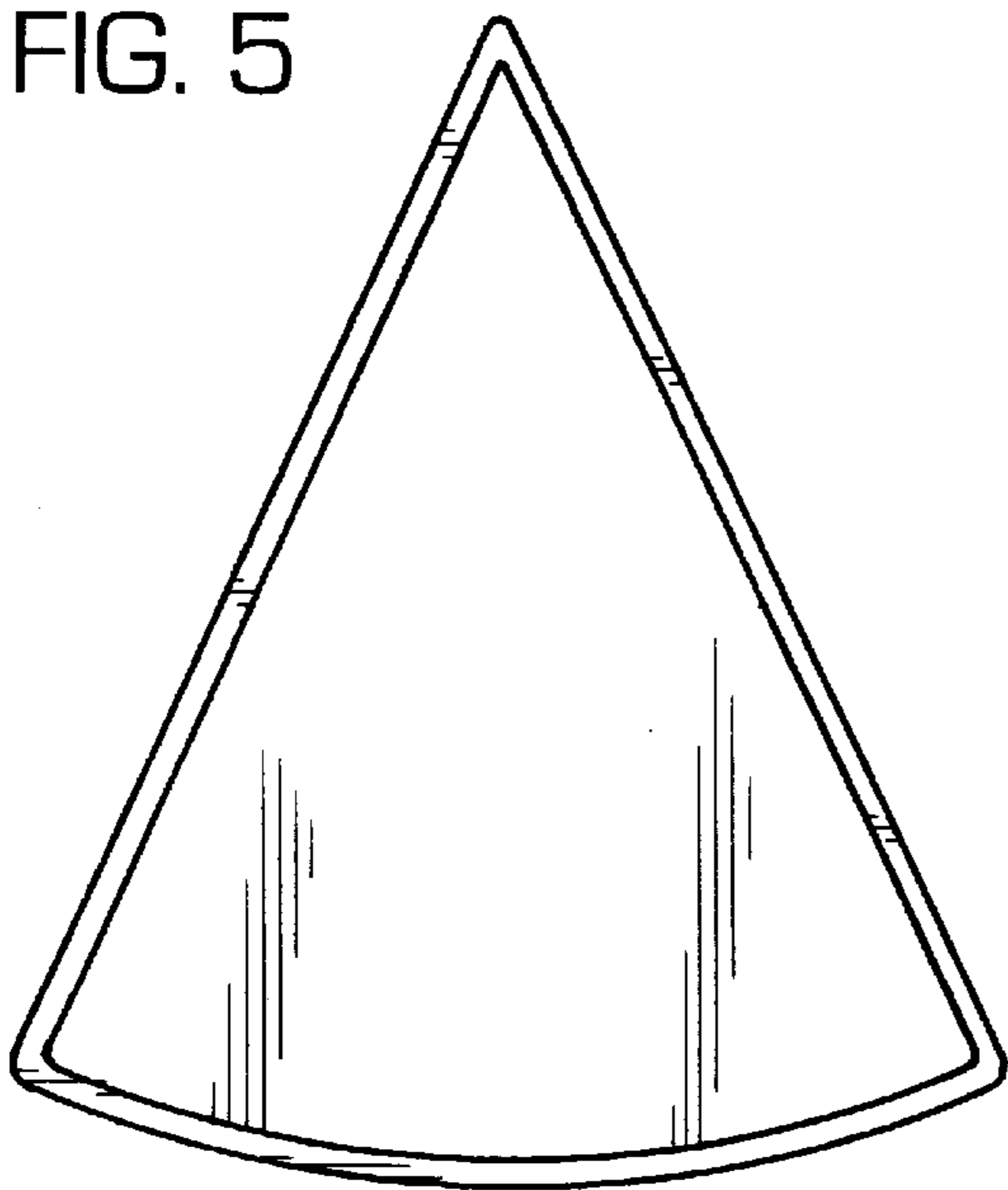

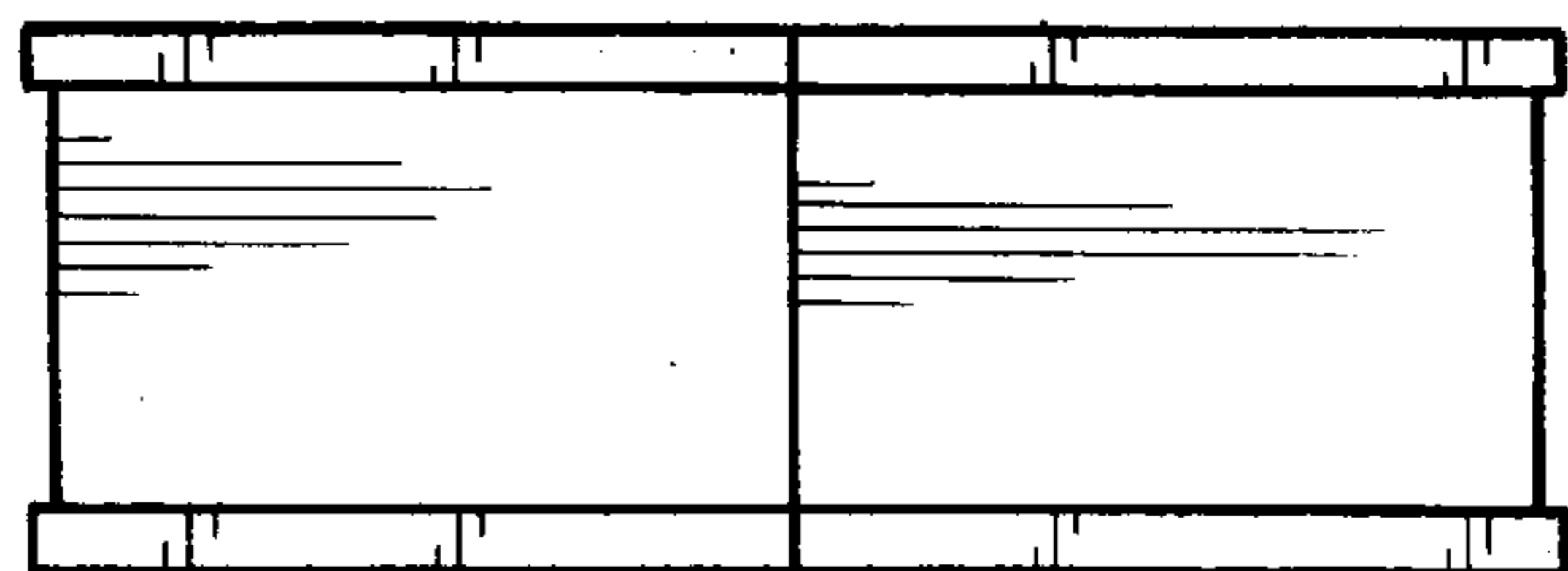
