(57) **CLAIM**

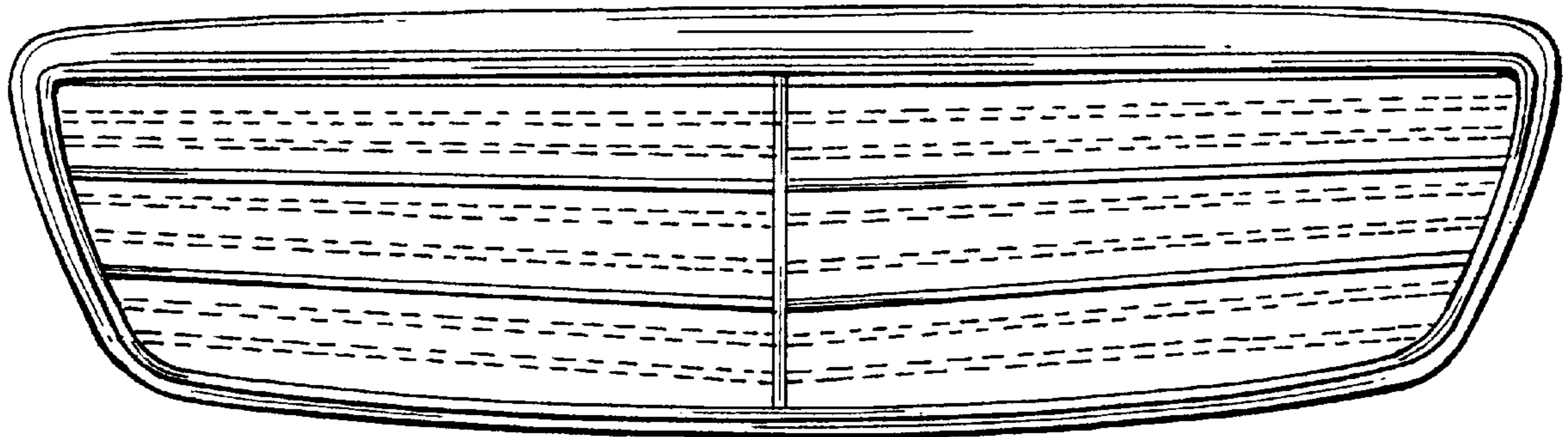
The ornamental design for a radiator grill for a vehicle, as shown and described.

DESCRIPTION

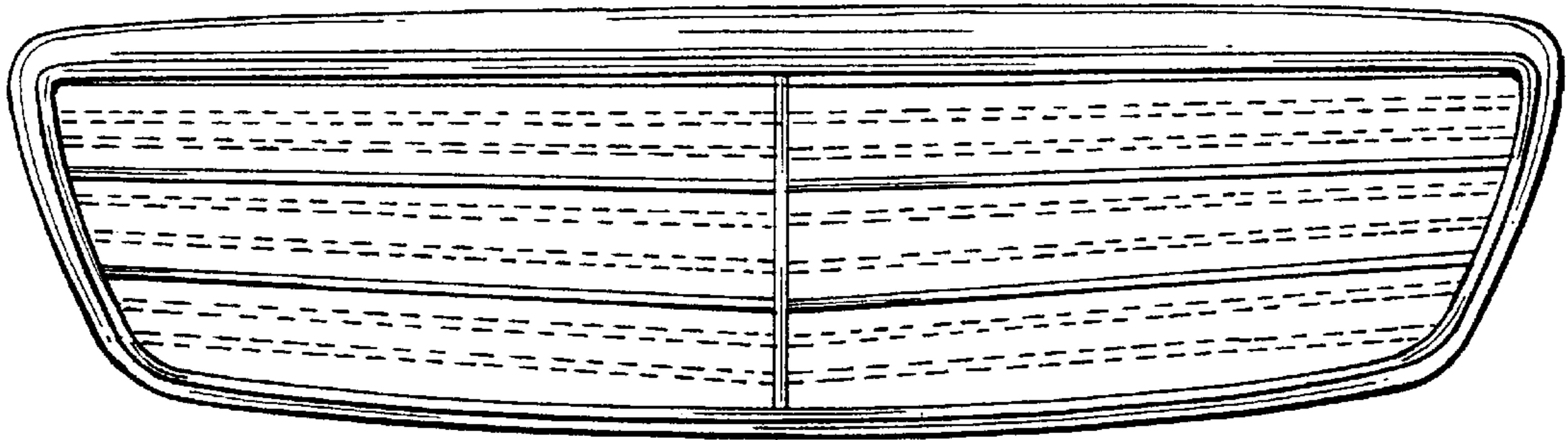

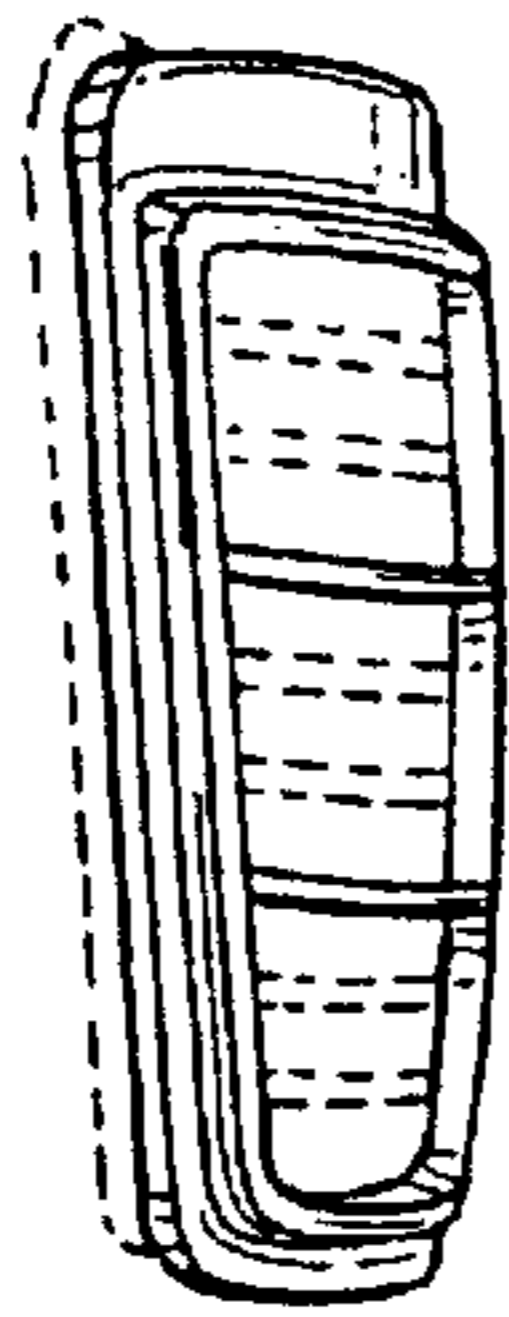

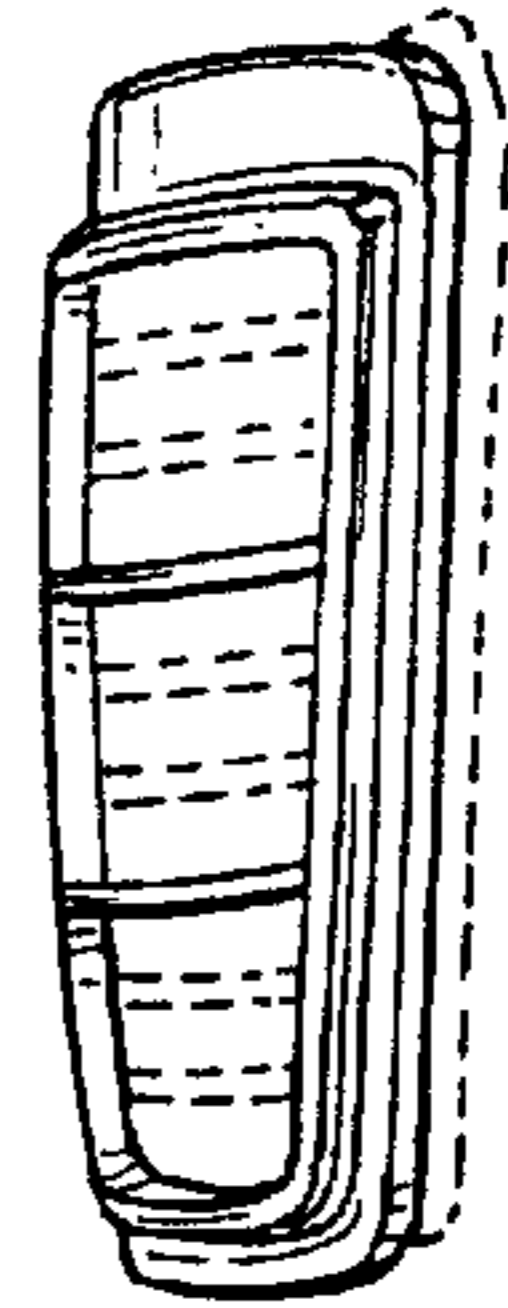

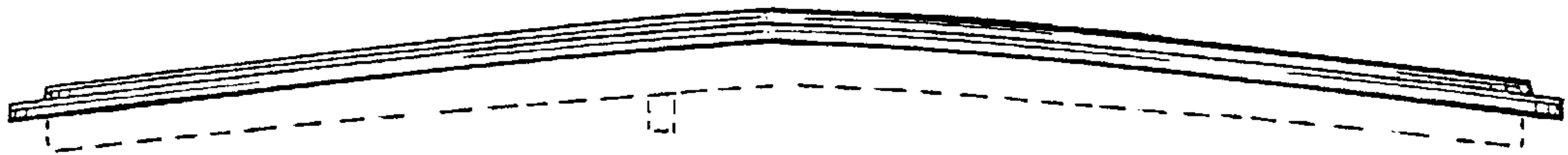
