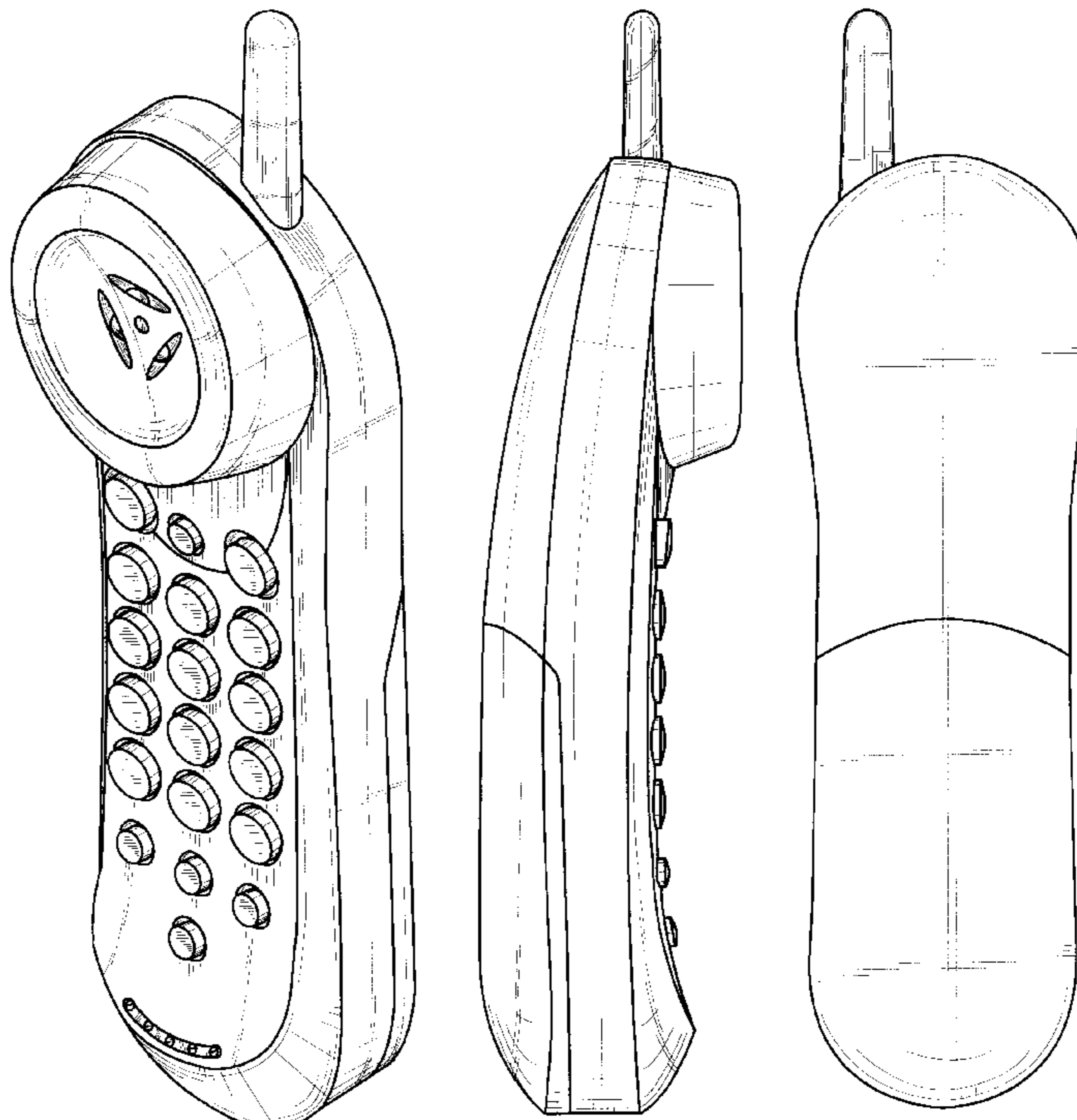

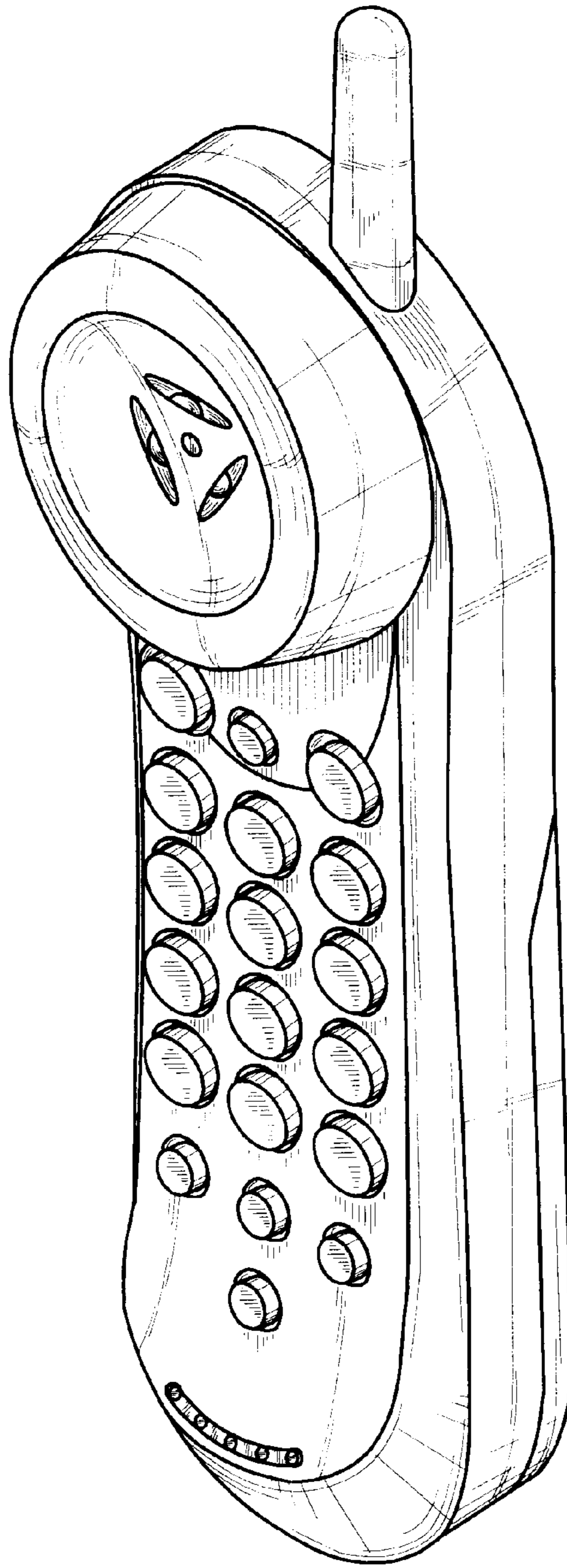
The ornamental design for a wireless telephone, as shown and described.

**DESCRIPTION**

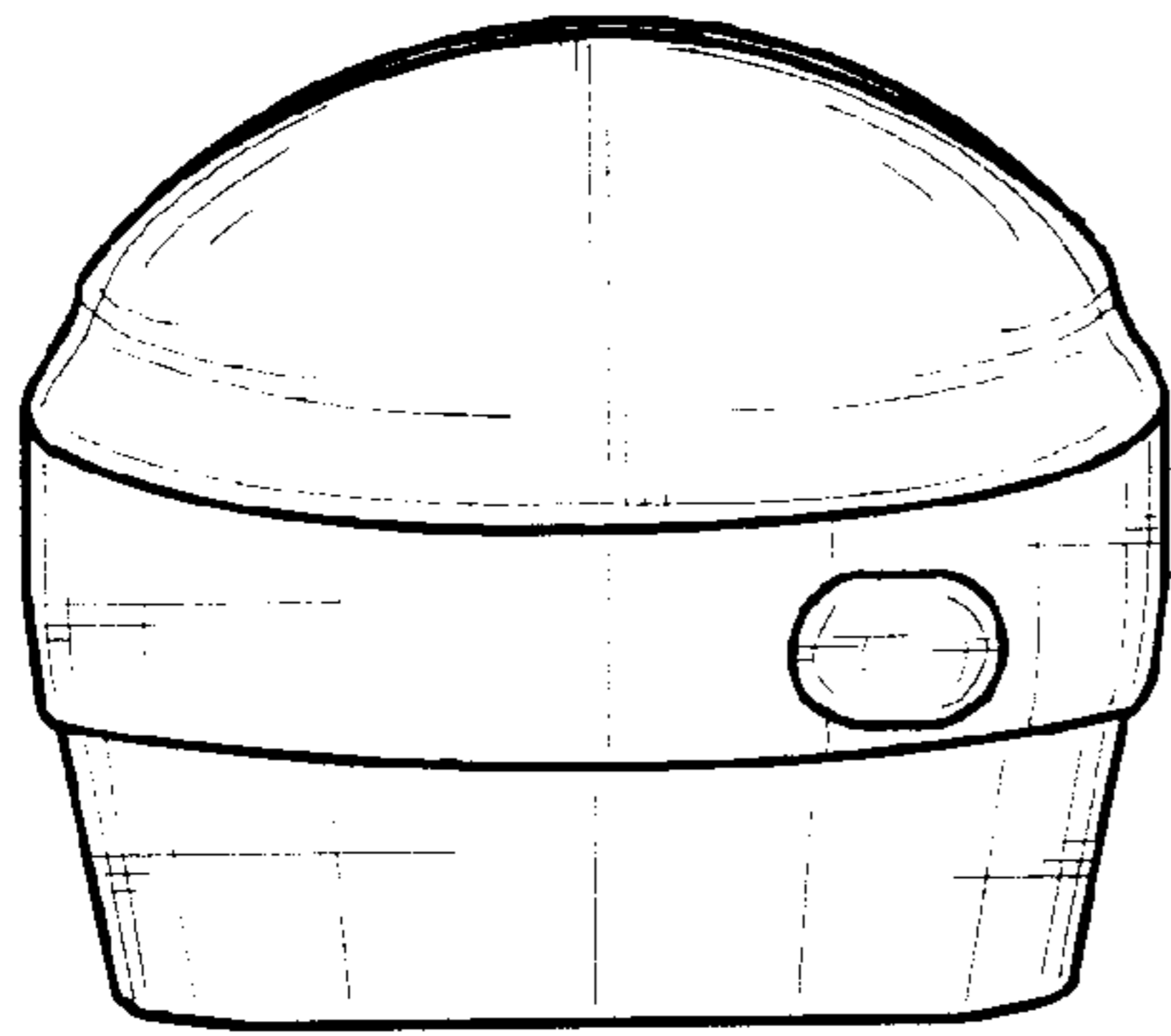
FIG. 1 is a perspective view of a wireless telephone showing my design;

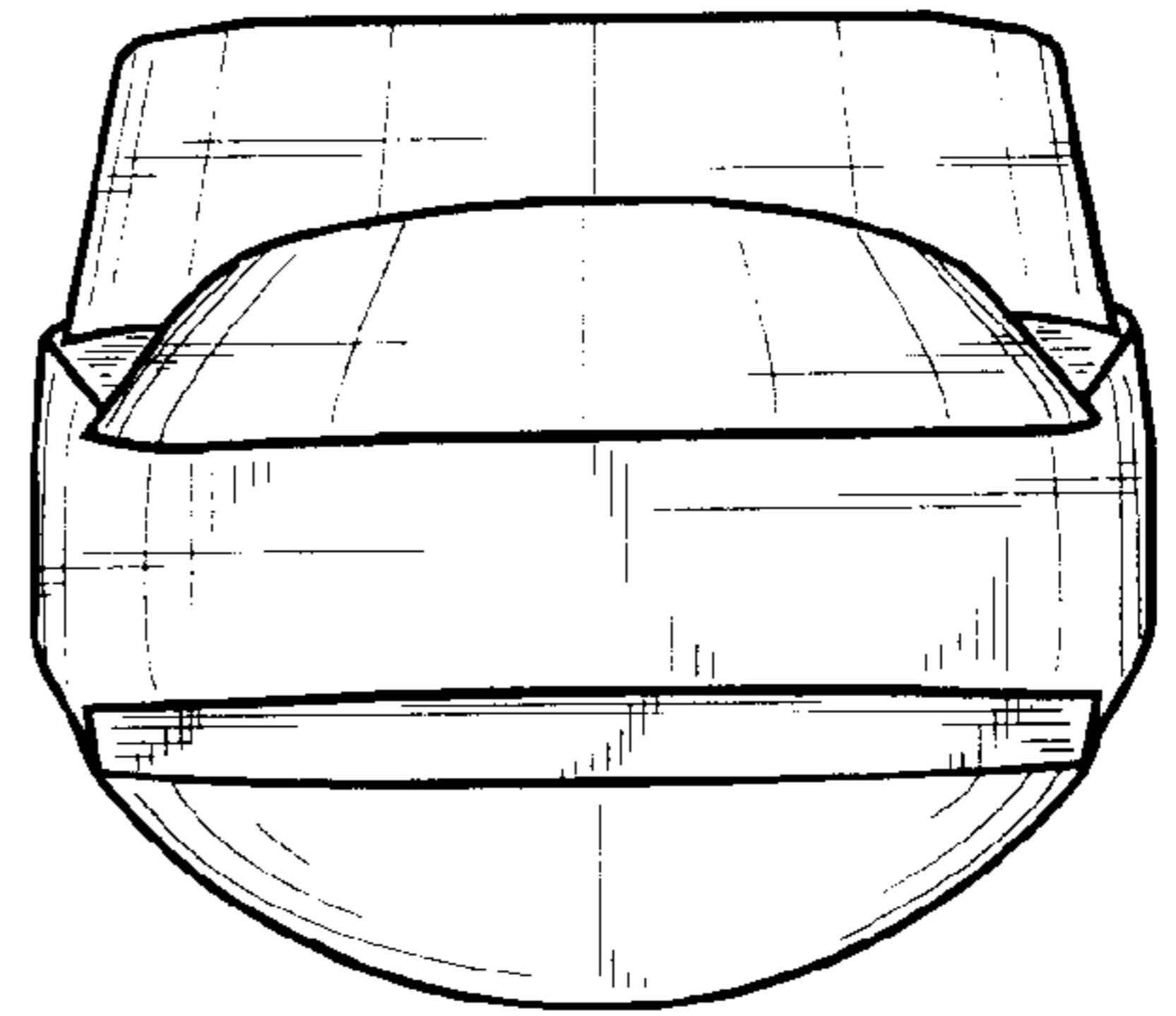




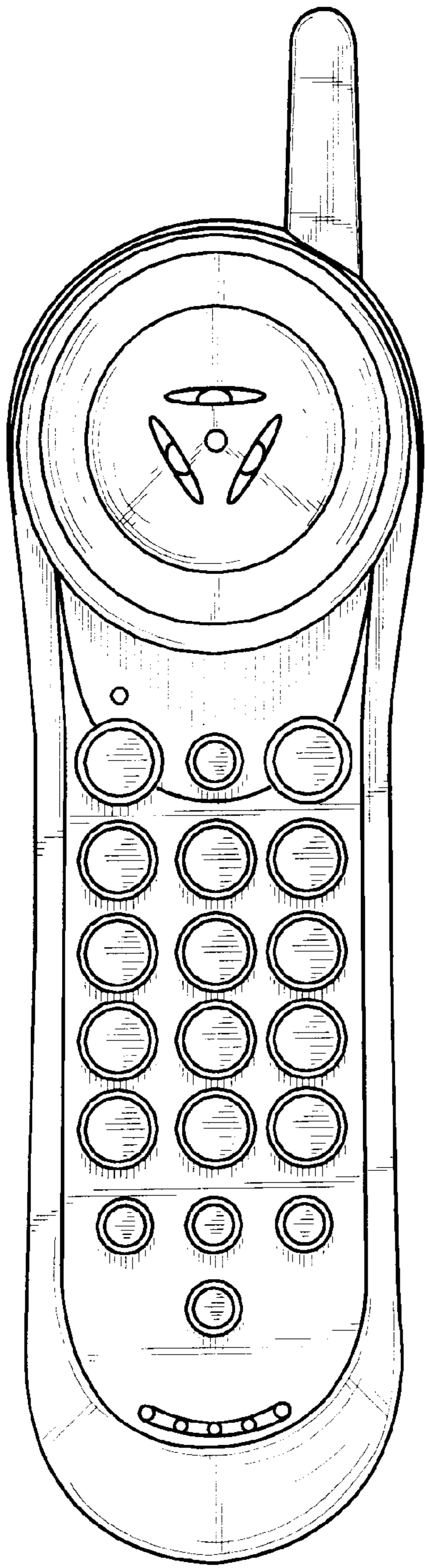

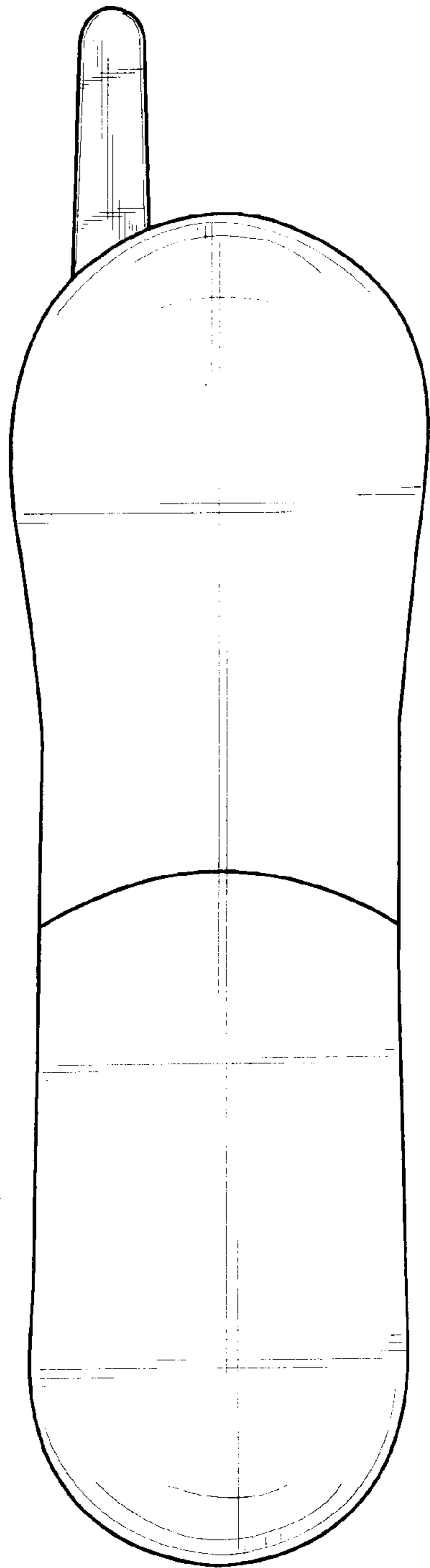

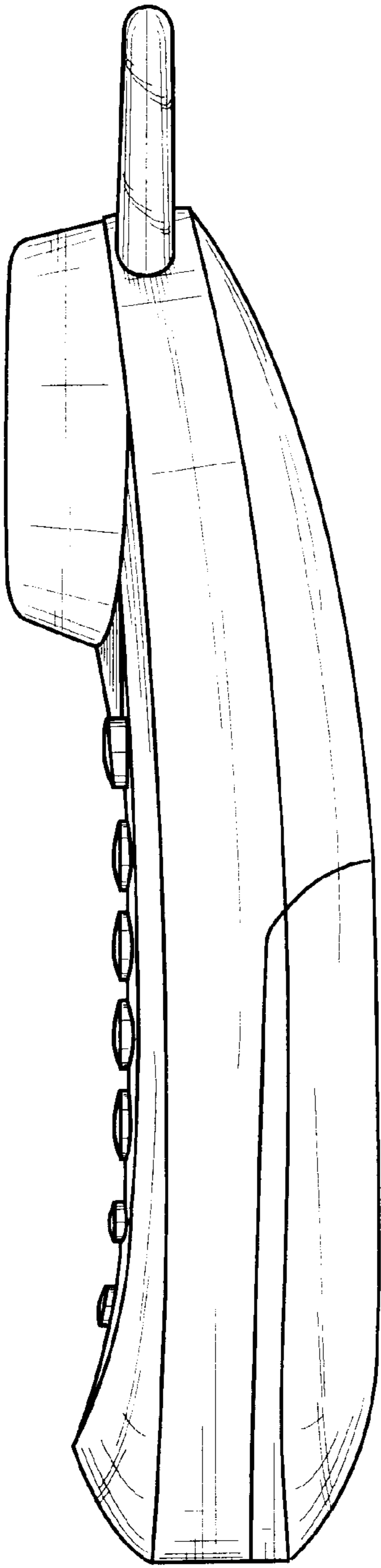

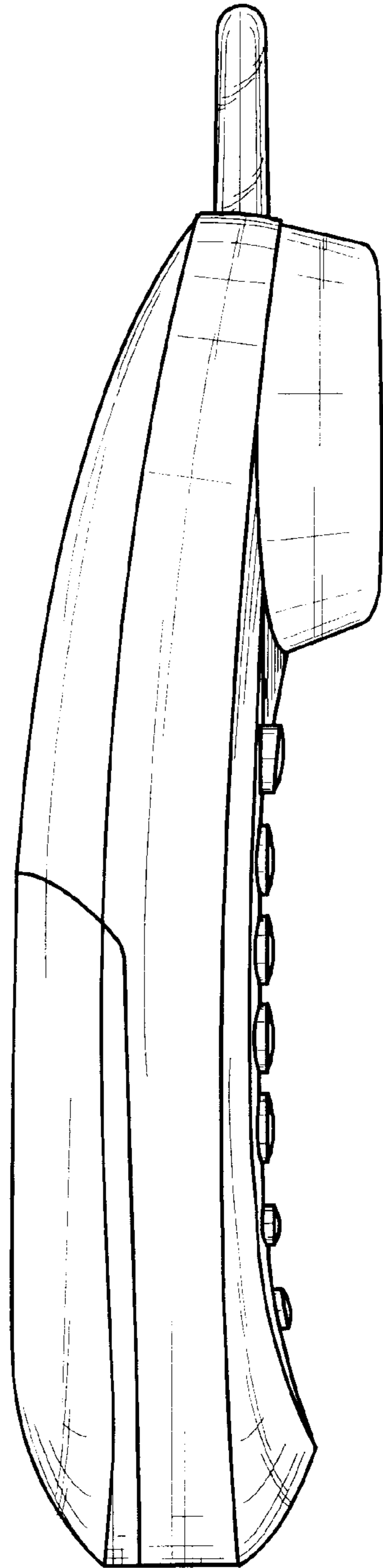
