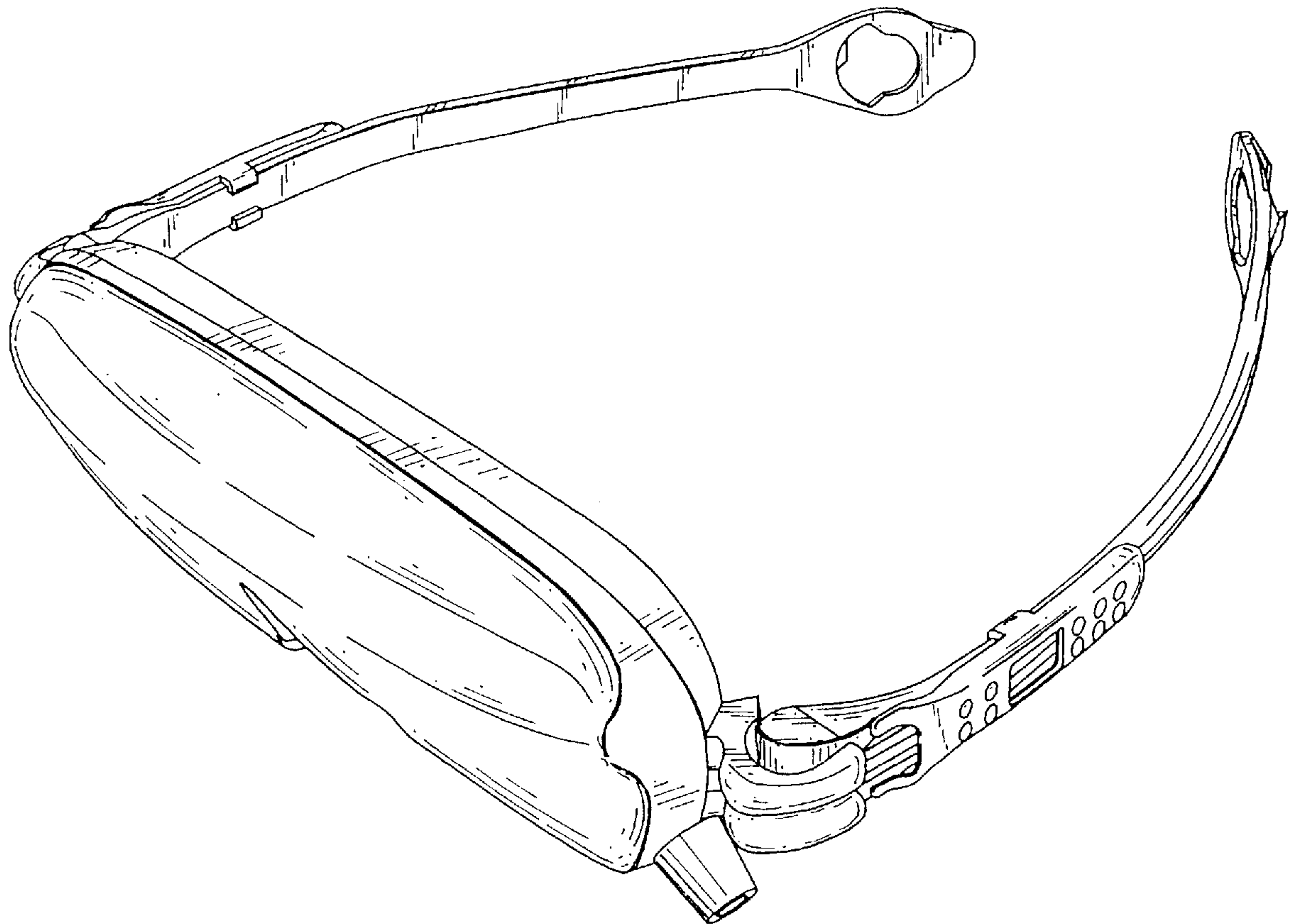
(57) **CLAIM**

The ornamental design for a spectacles-shaped display, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and right side perspective view of a spectacles-shaped display, showing my new design; FIG. 2 is a rear, top and left side perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a right side elevational view thereof; FIG. 8 is a left side elevational view thereof; and, FIG. 9 is a reference view thereof showing the state of use and the broken lines are only for the purpose of illustration and form no part of the claimed design.

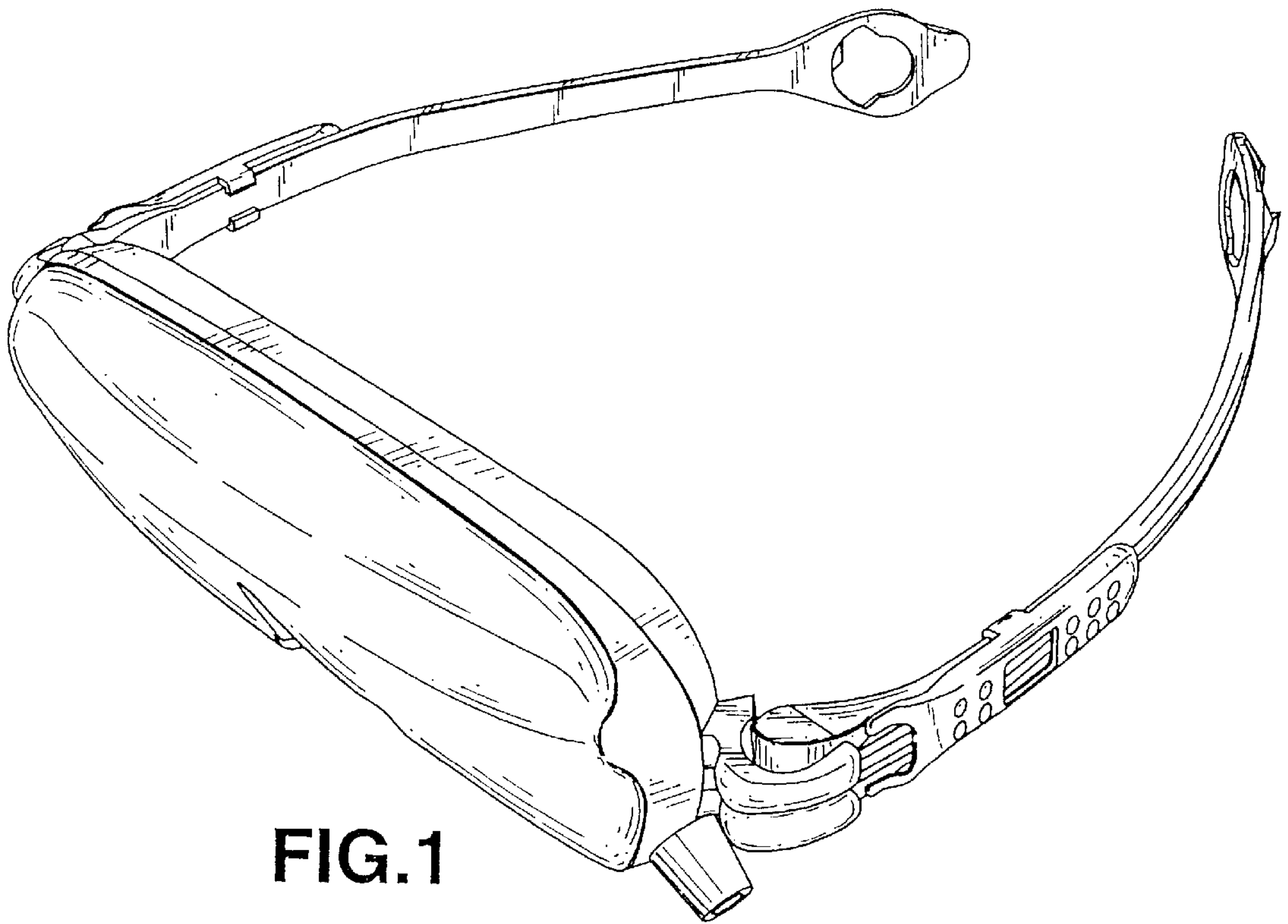

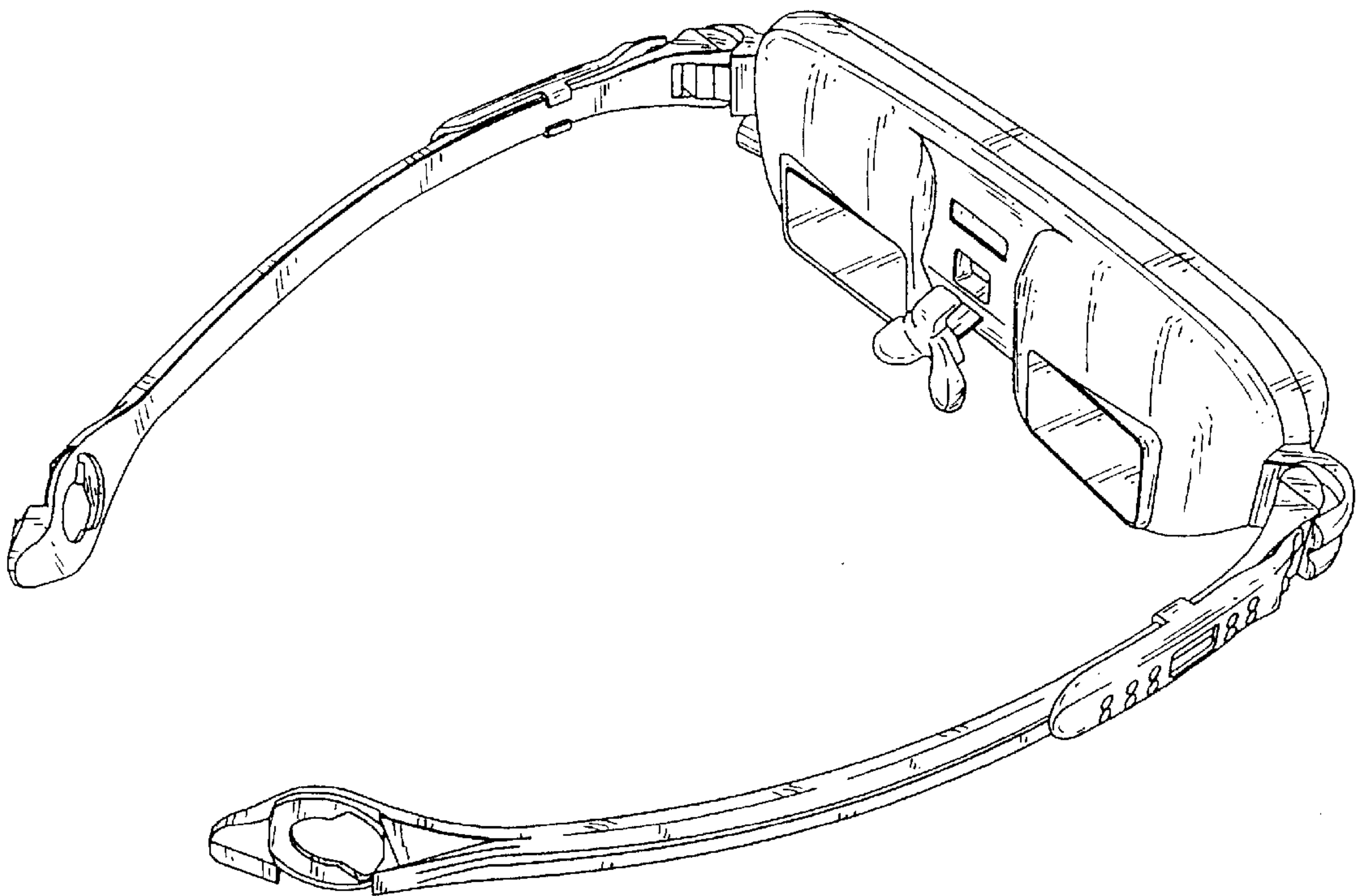

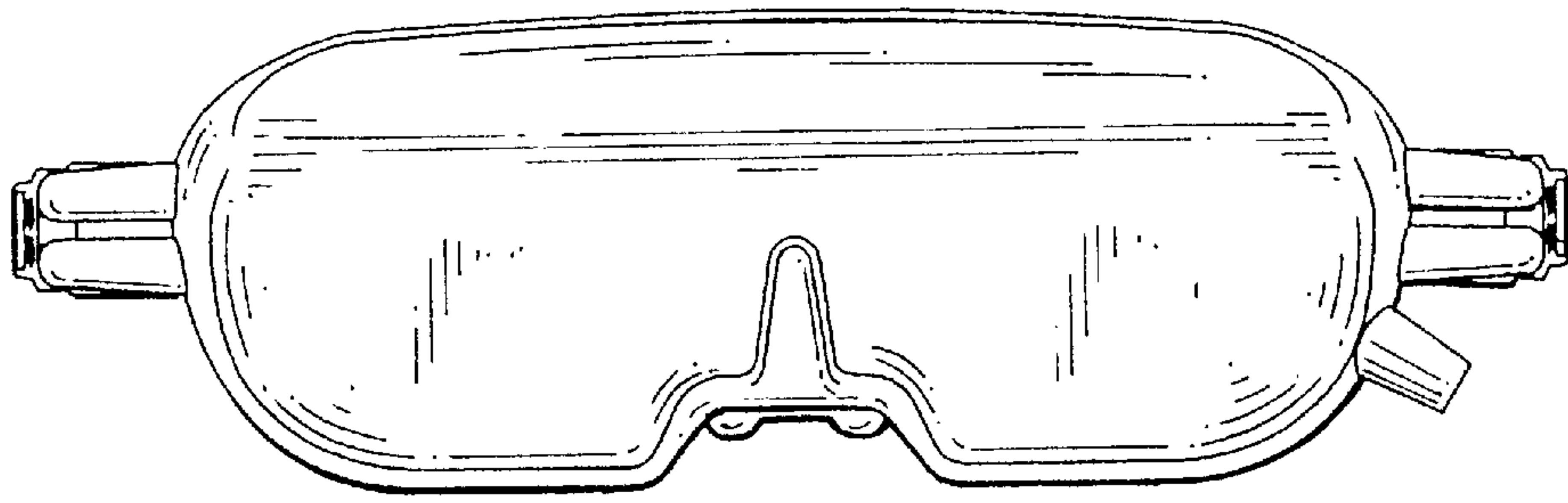

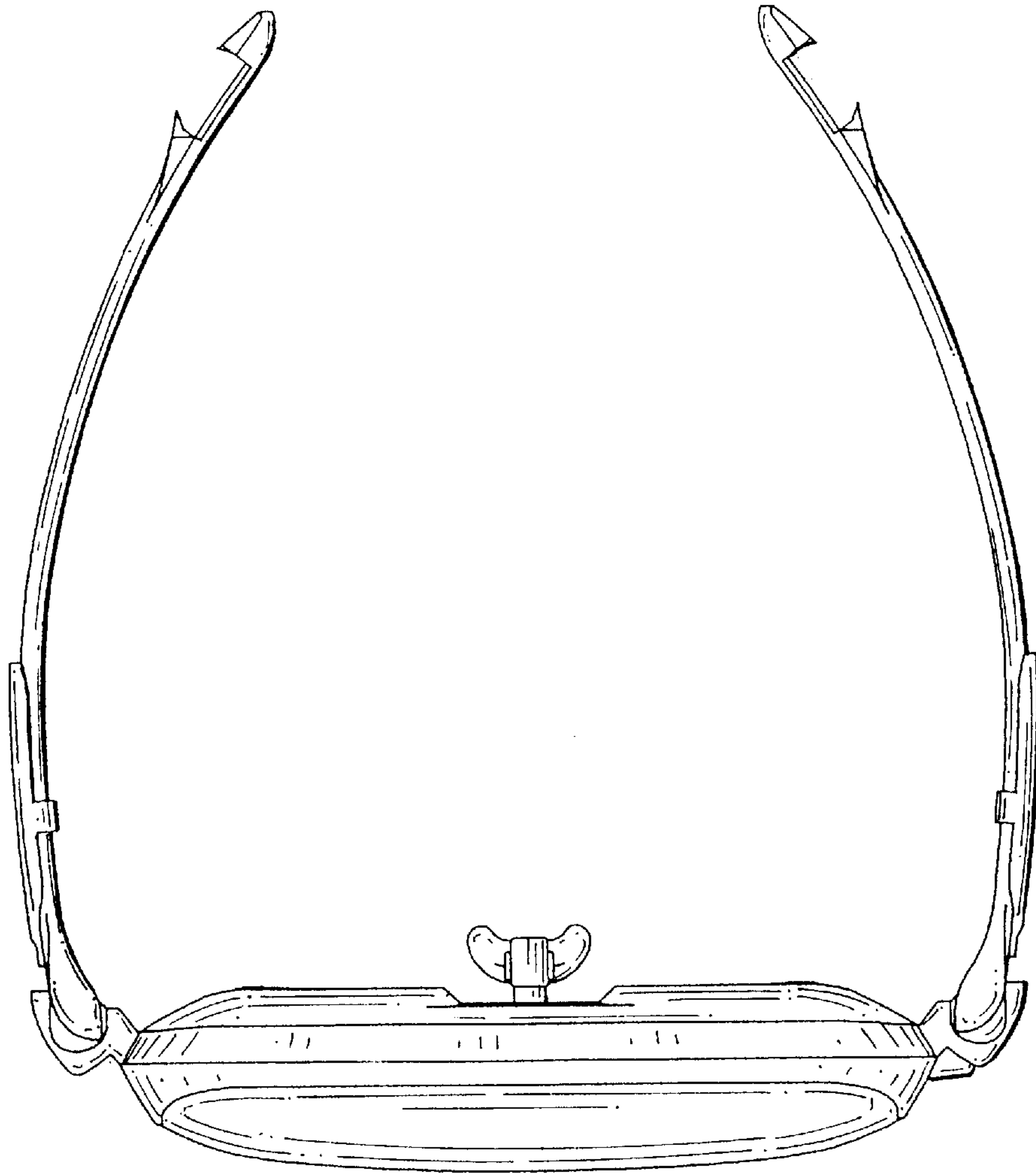

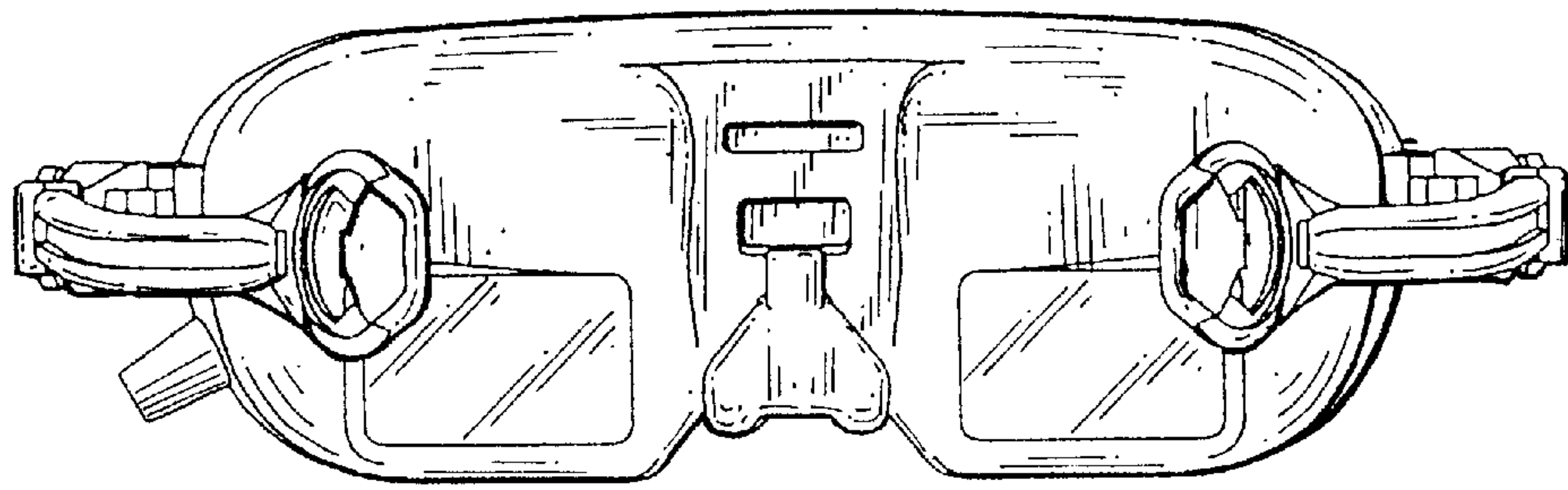

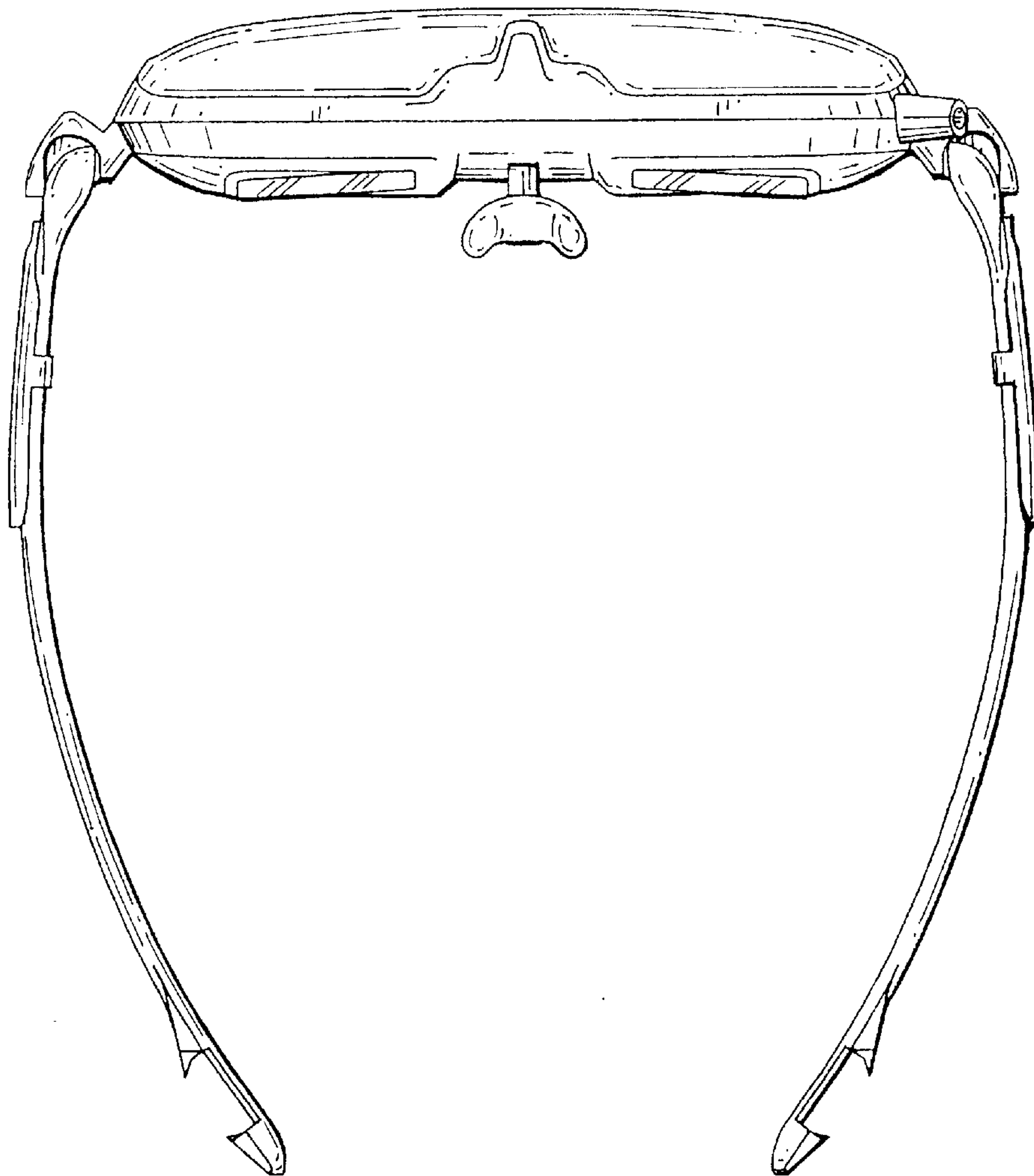
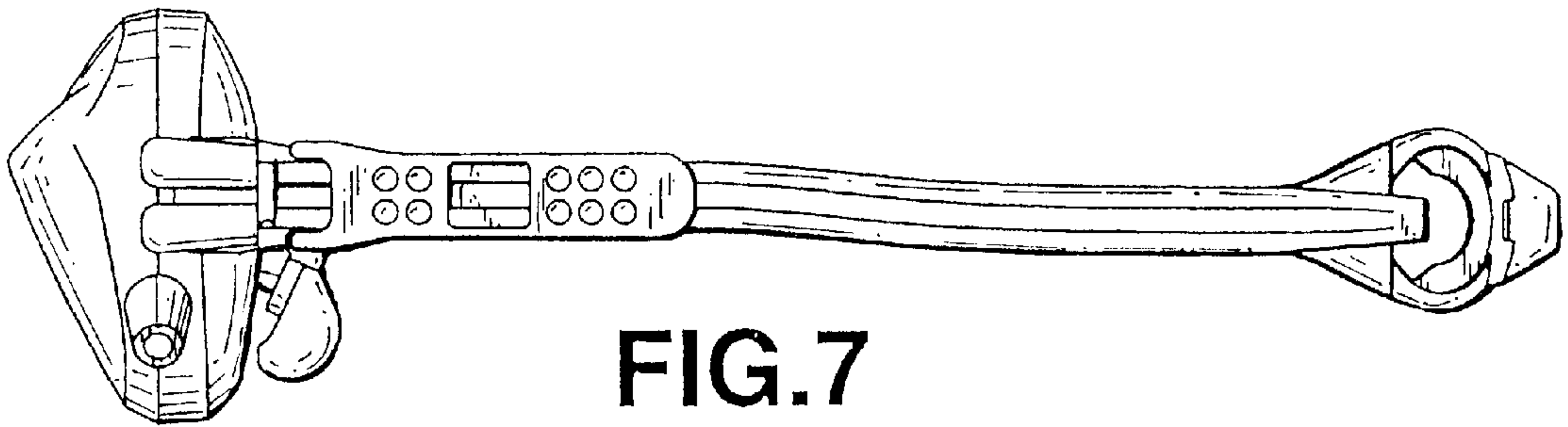
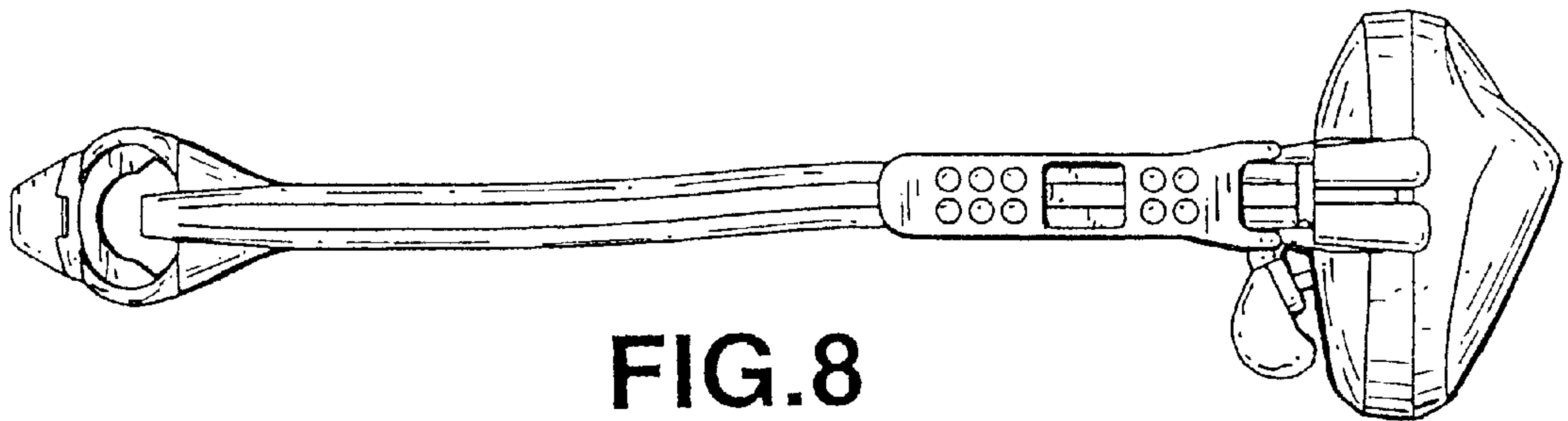

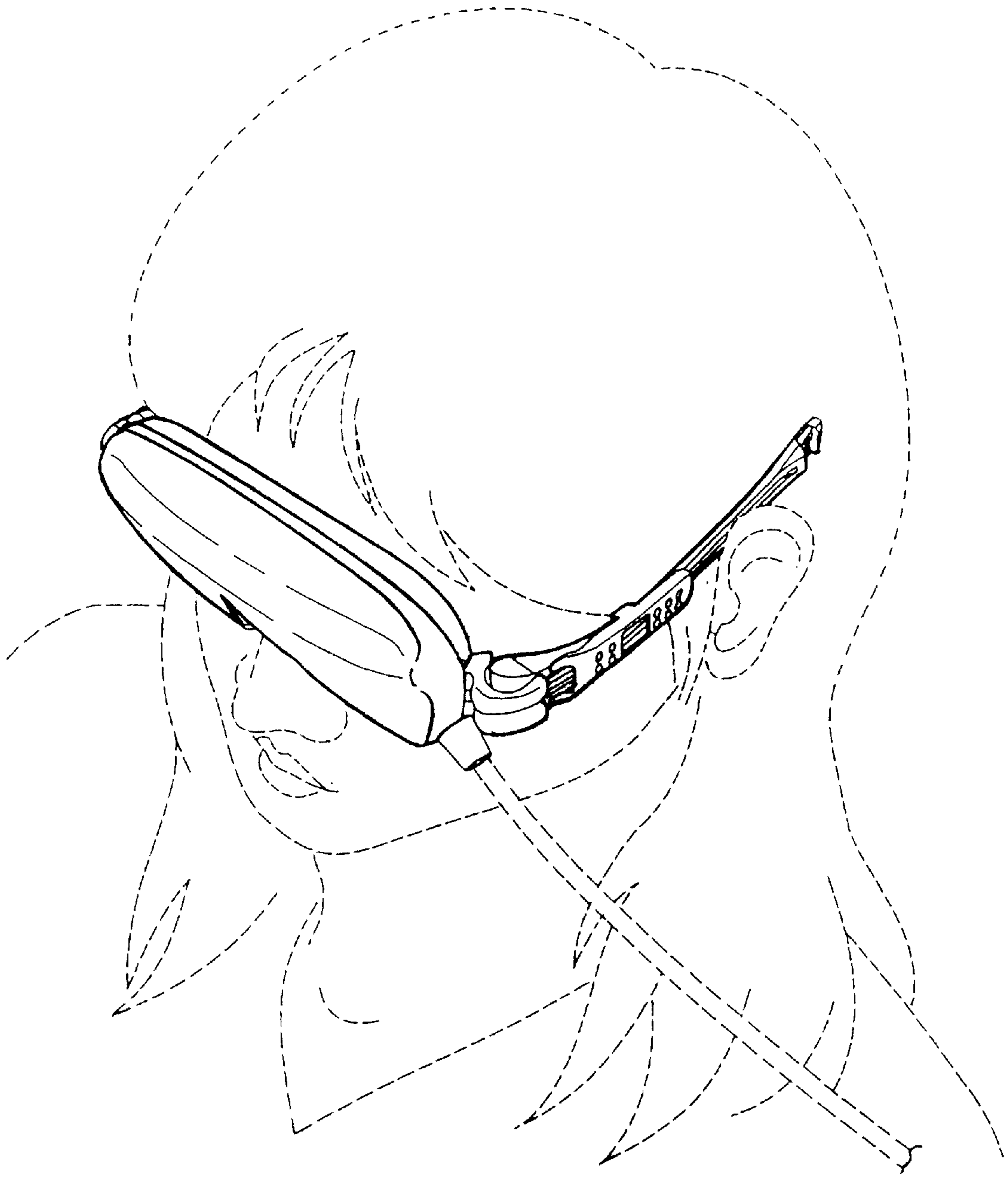
