(57) **CLAIM**

The ornamental design for a shower head, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a shower head showing my new design;
FIG. 2 is a left side view thereof, the right side, top and bottom view being a mirror image of the left side;
FIG. 3 is a front view thereof; and,
FIG. 4 is a rear view thereof.
The broken line showing in FIG. 2 is for illustrative purposes only and forms no part of the claimed design.
