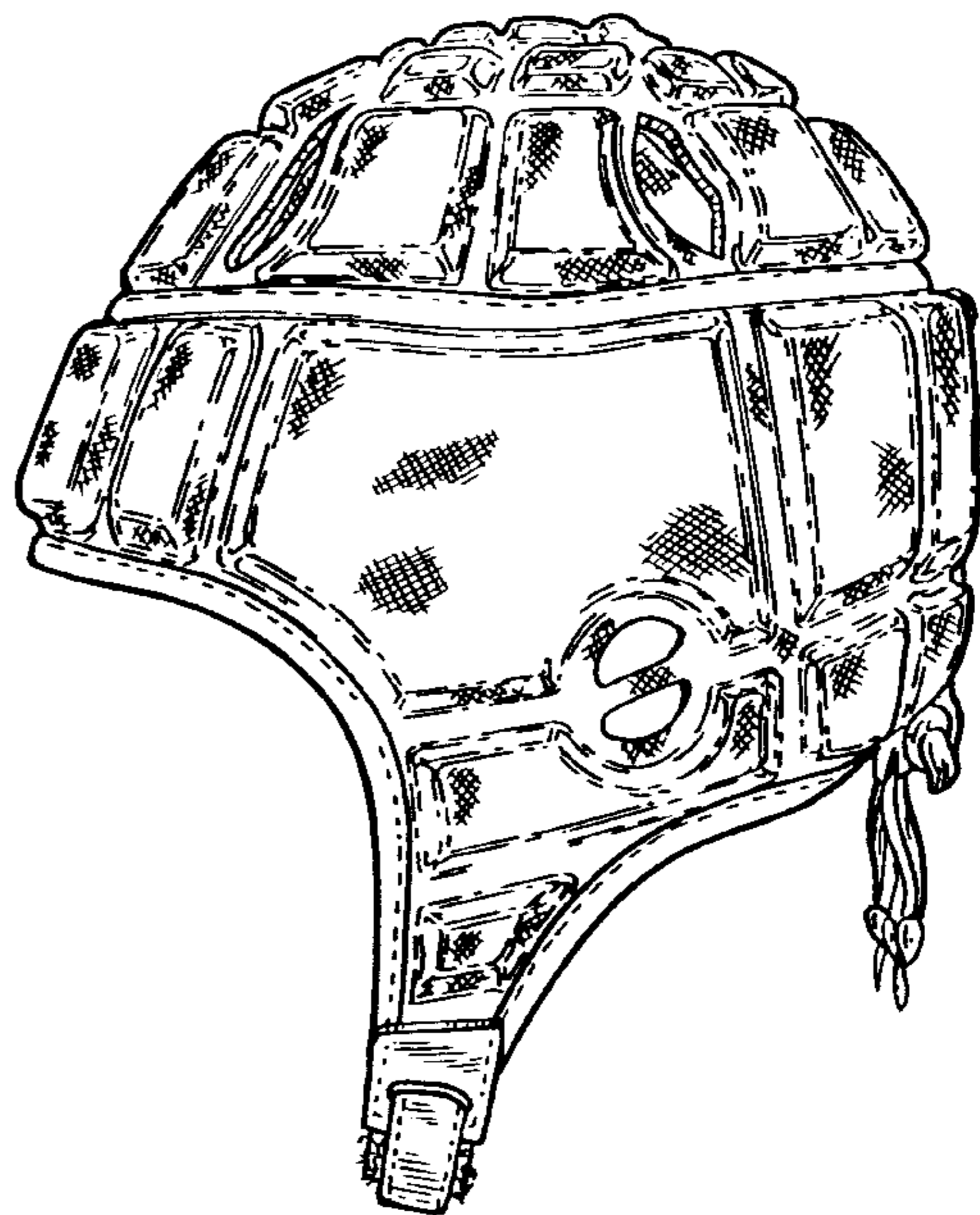
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top, front perspective view of a sports headgear showing my new design;  
FIG. 2 is a front elevational view thereof;

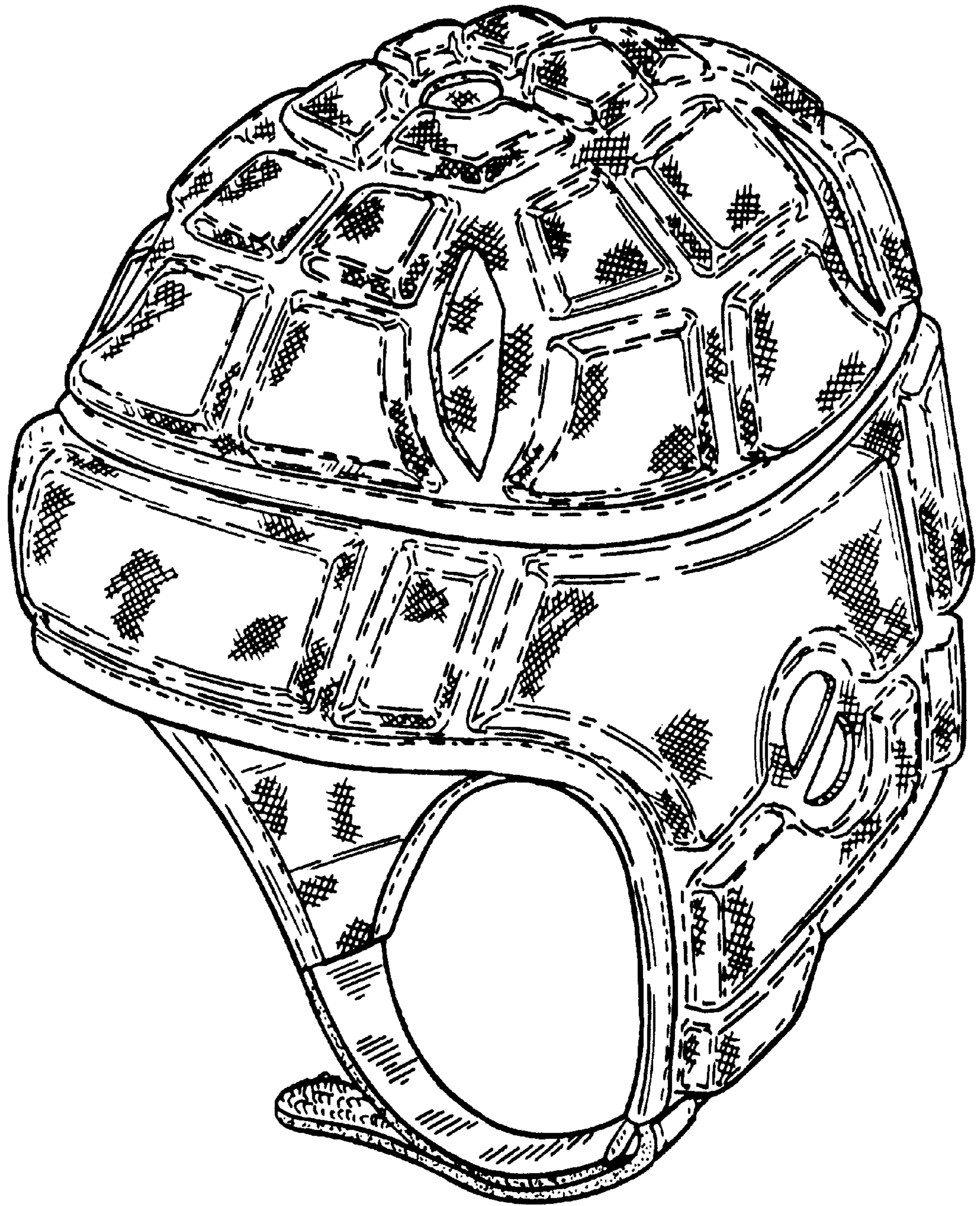

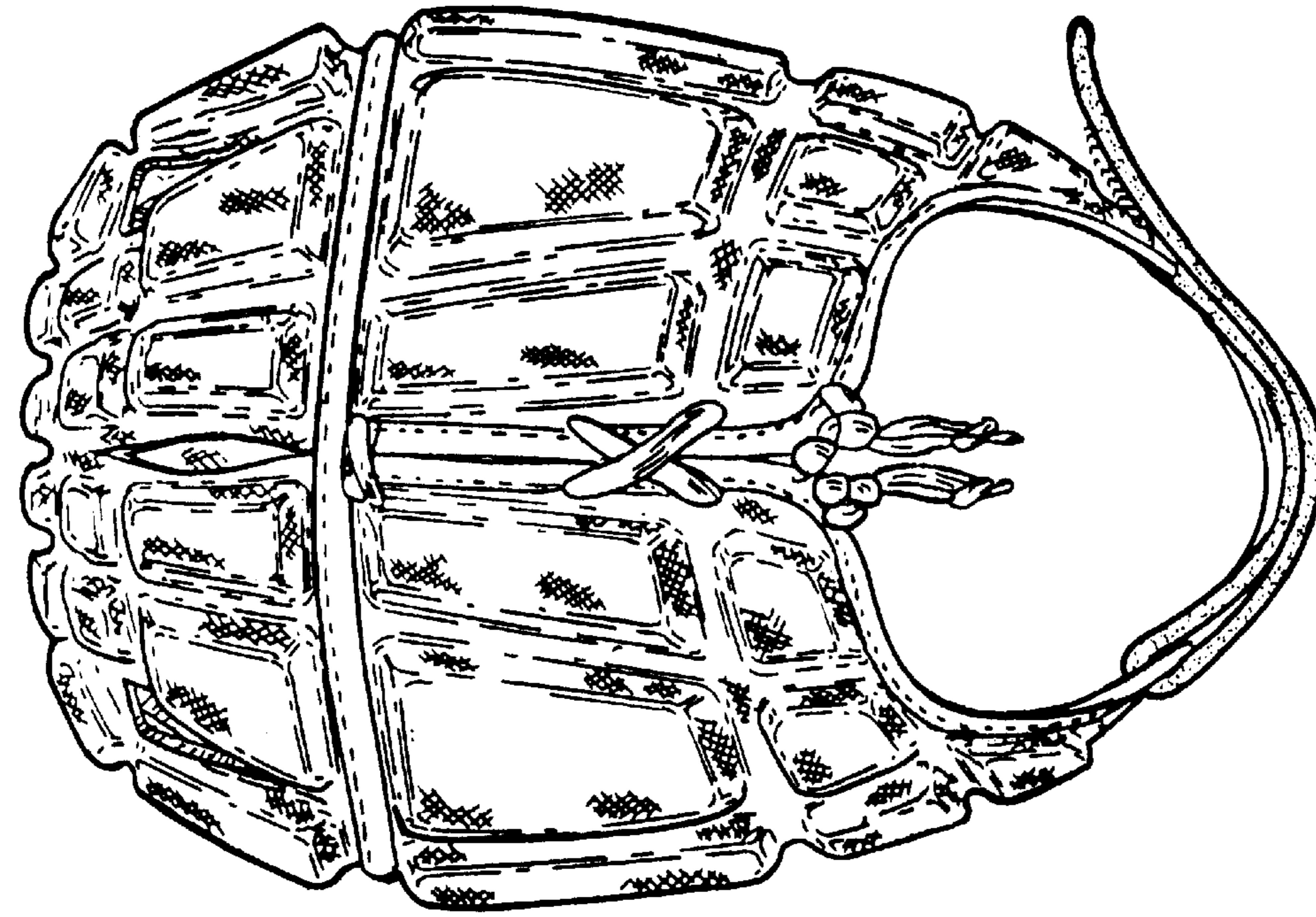

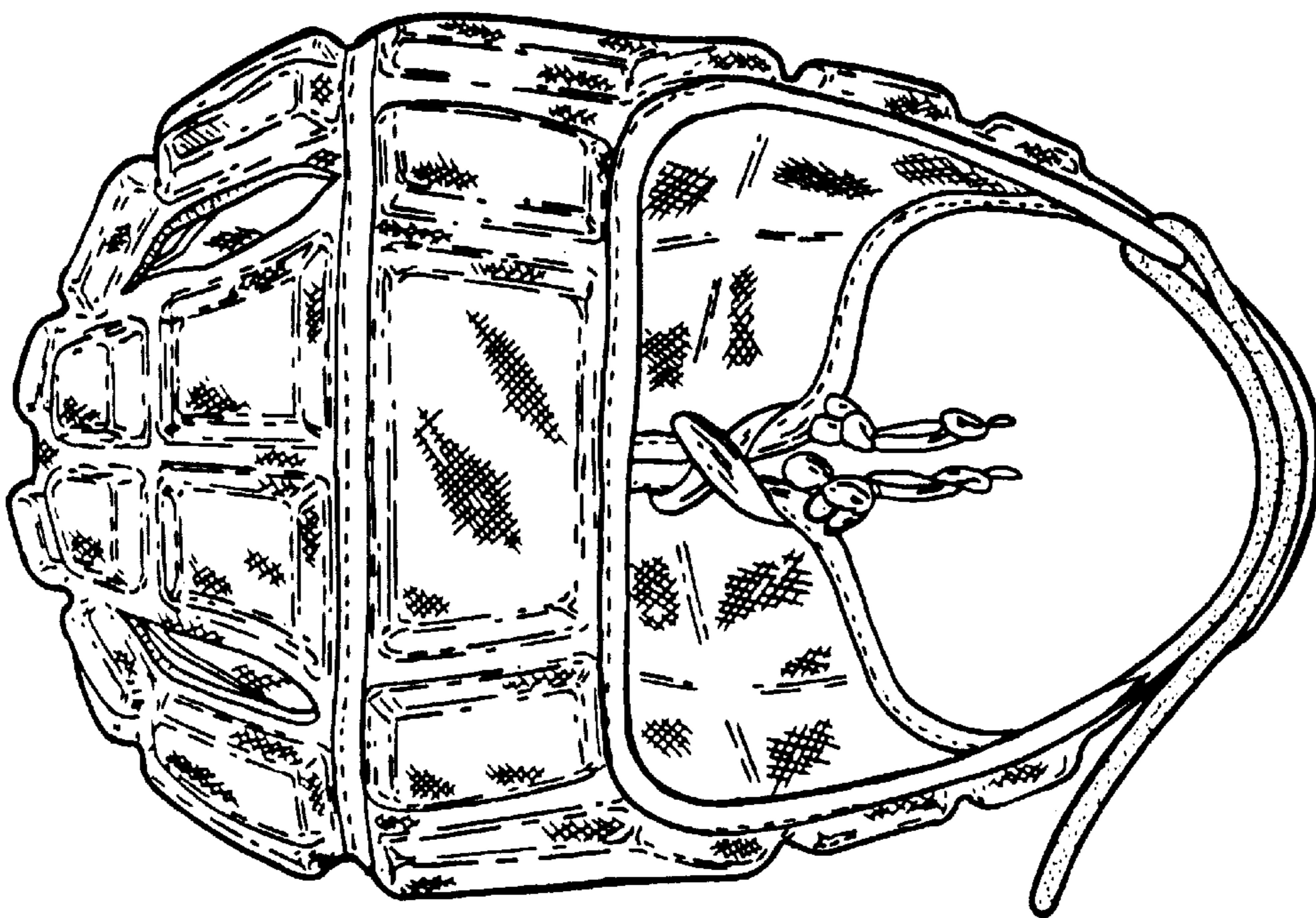

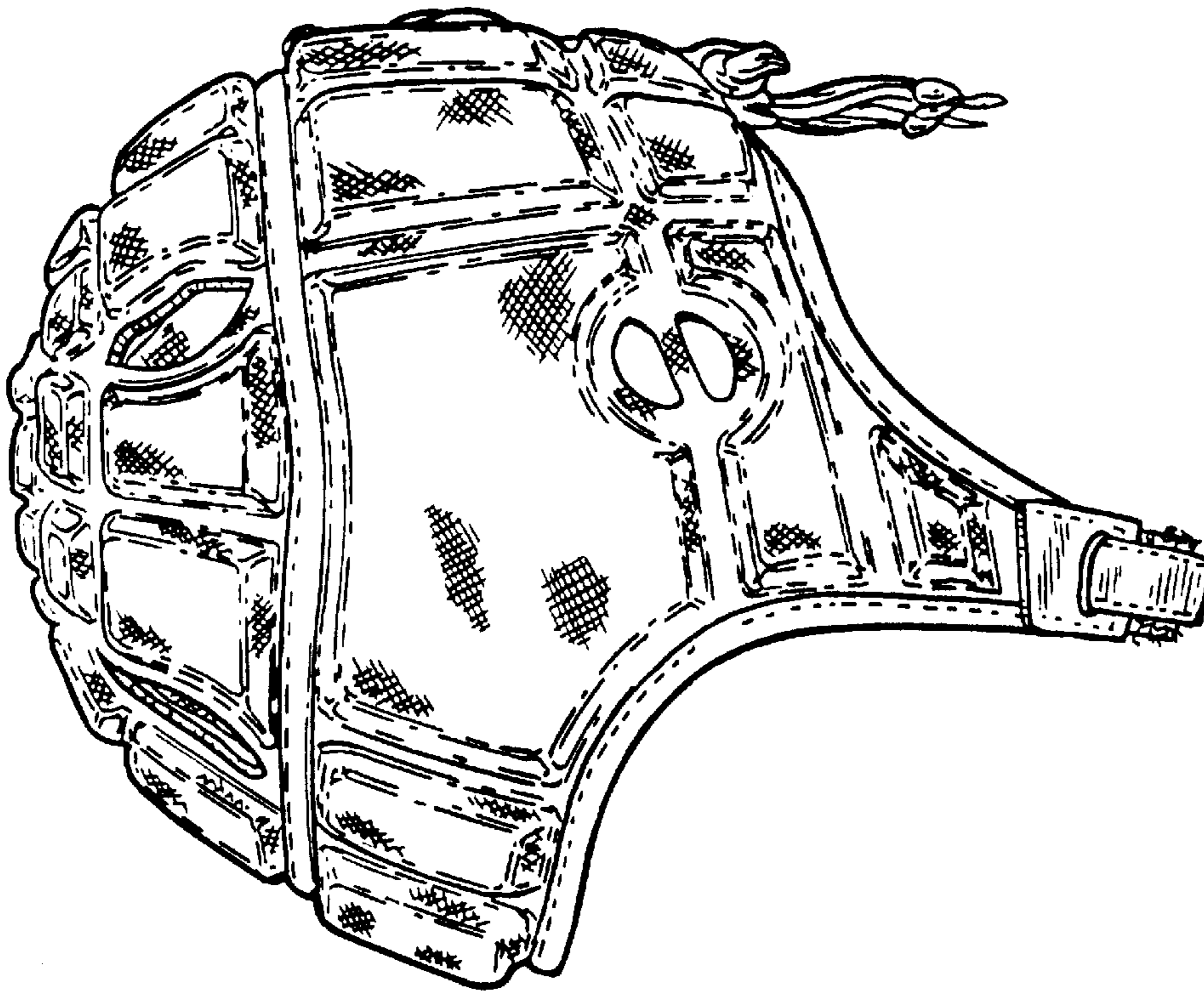

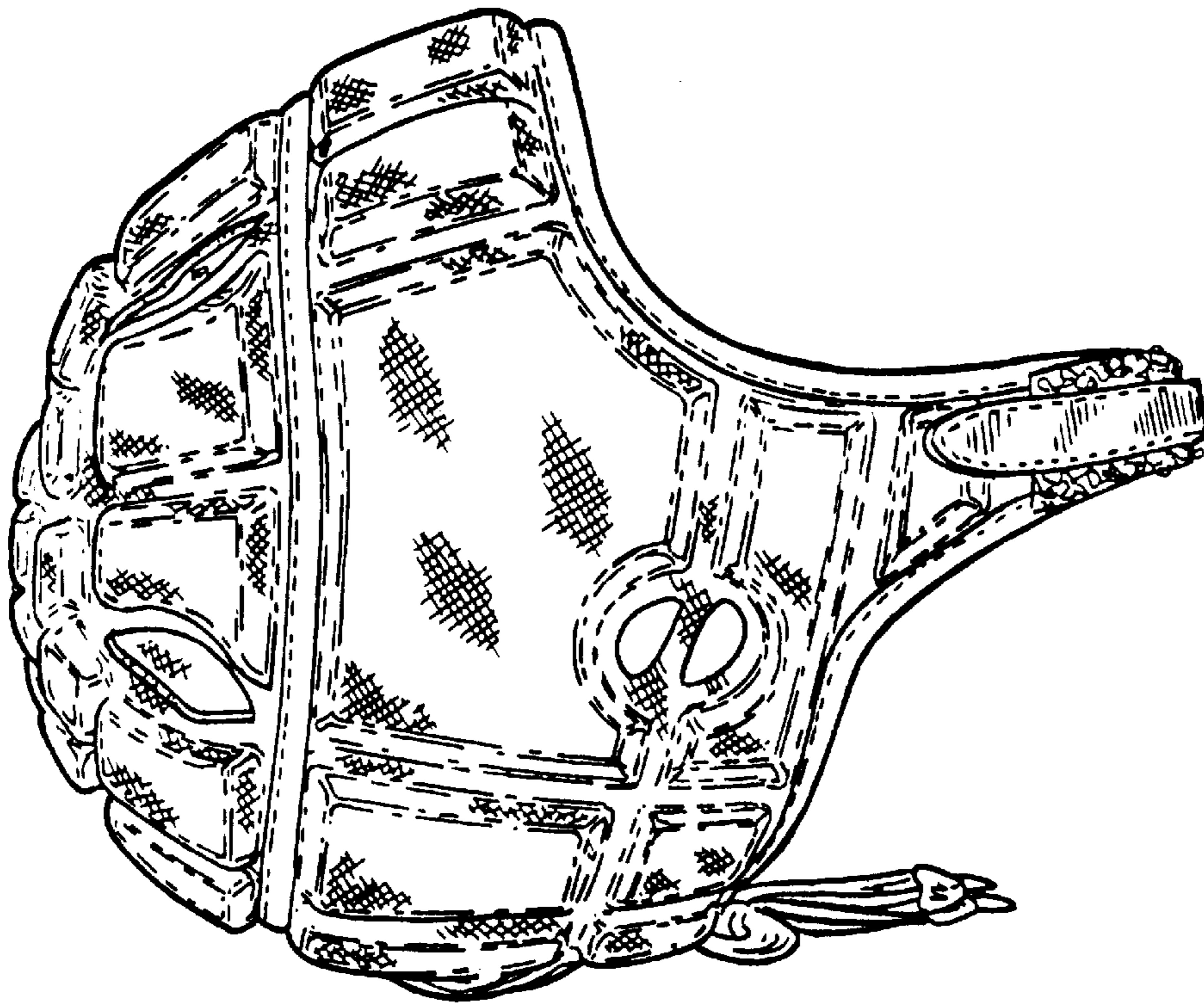

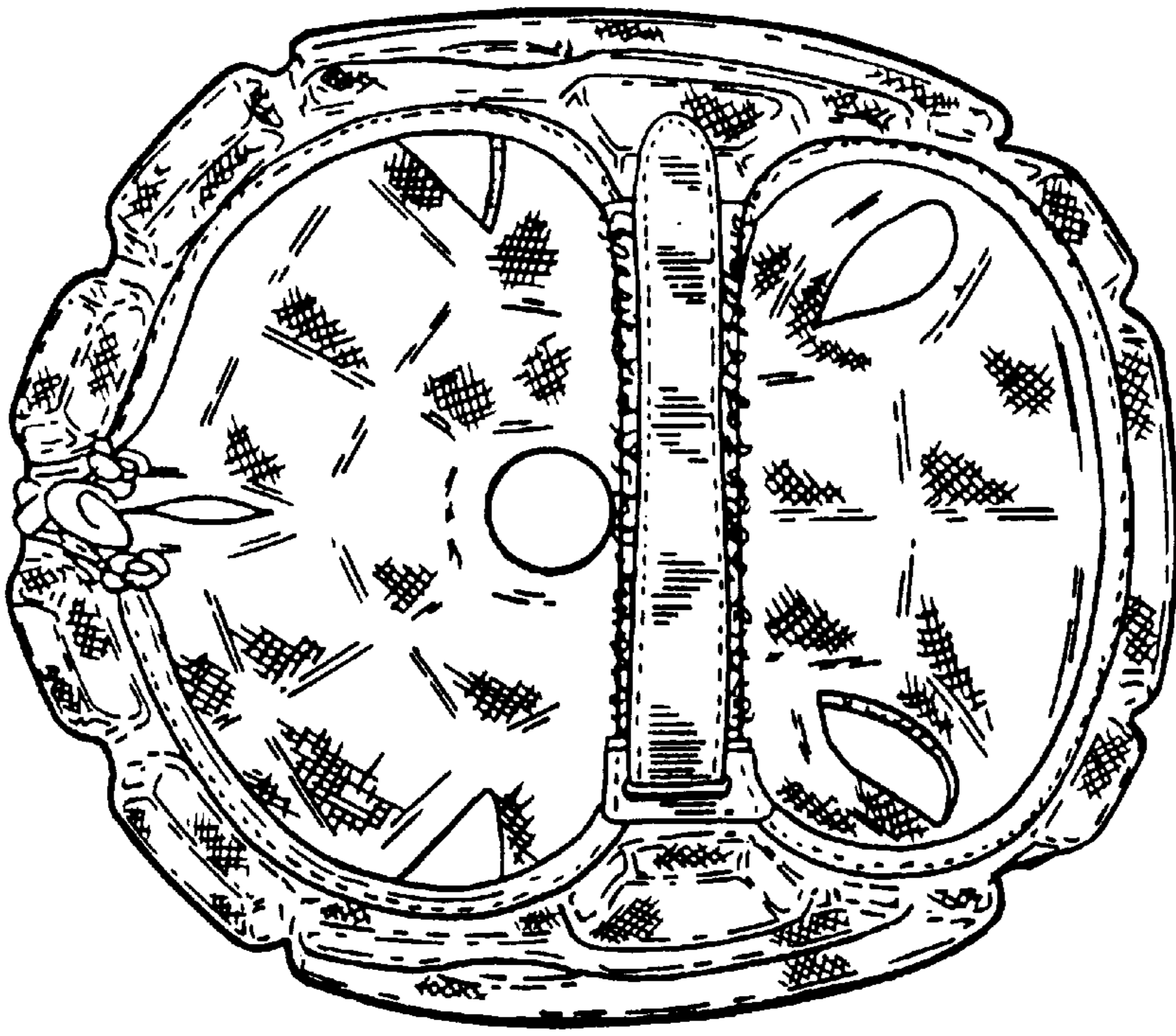

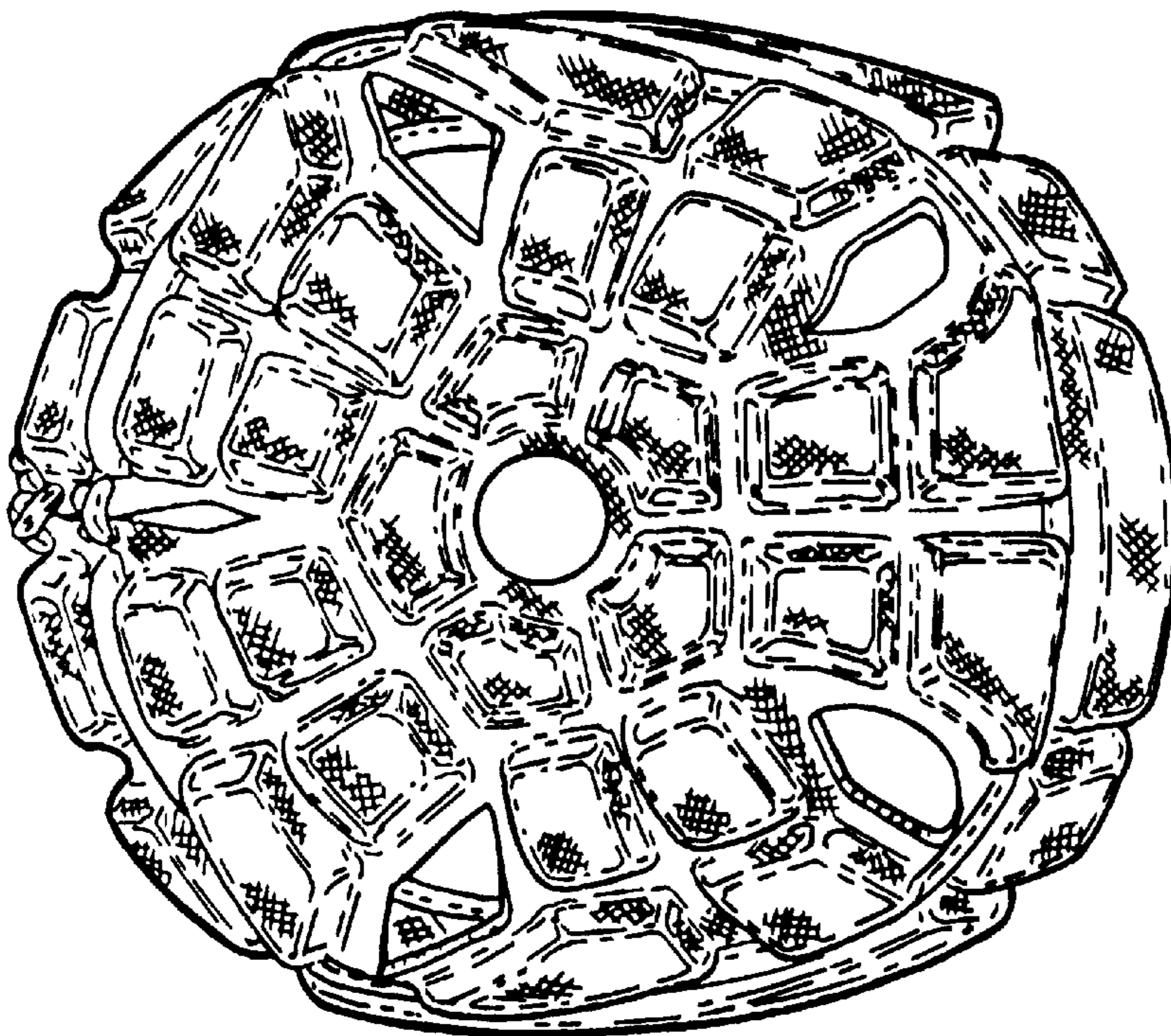
