FIG. 4 is an elevational left side view thereof;

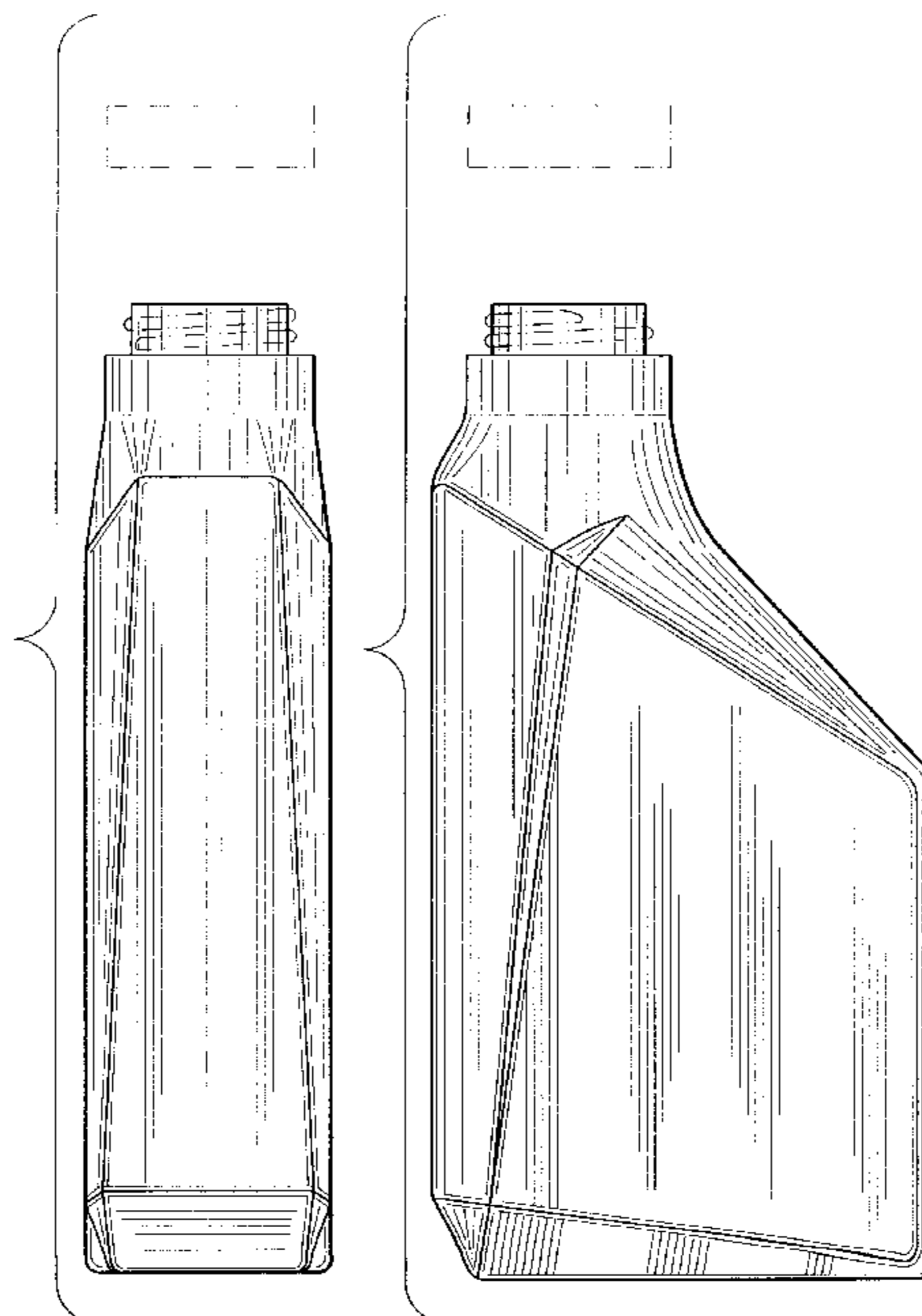
FIG. 5 is an elevational front plan view thereof; and

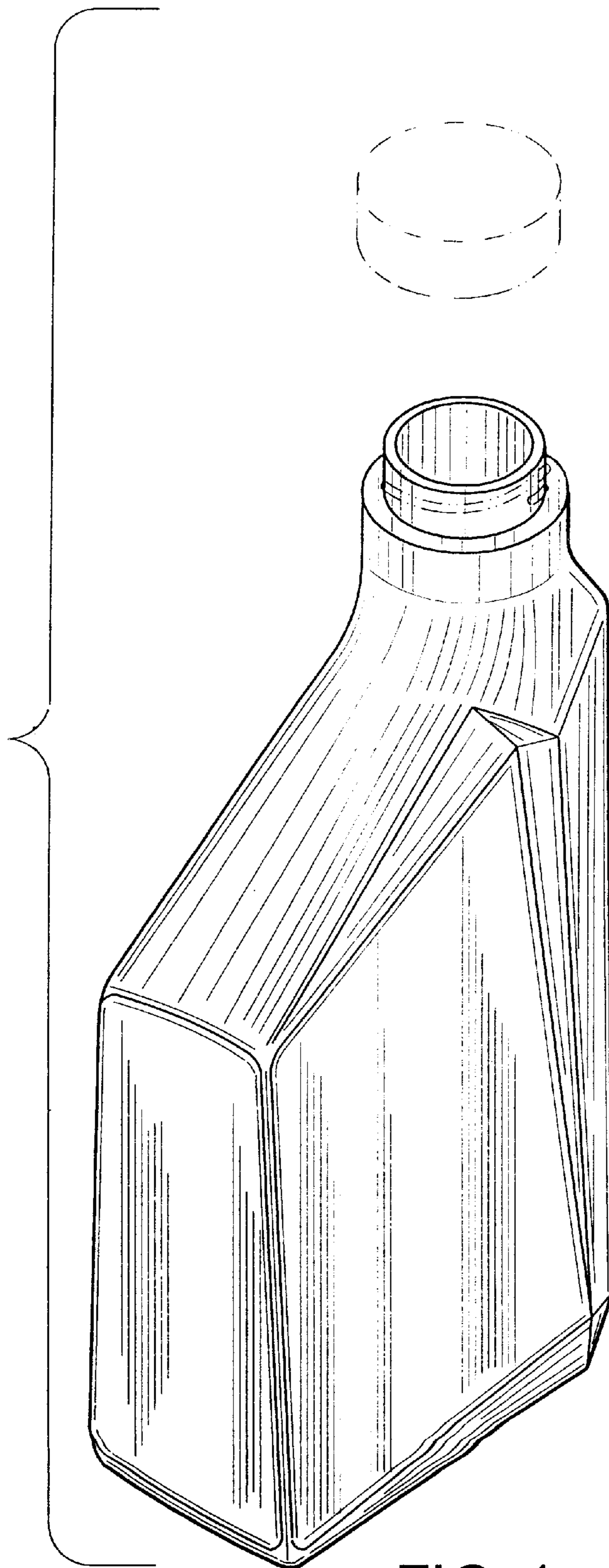

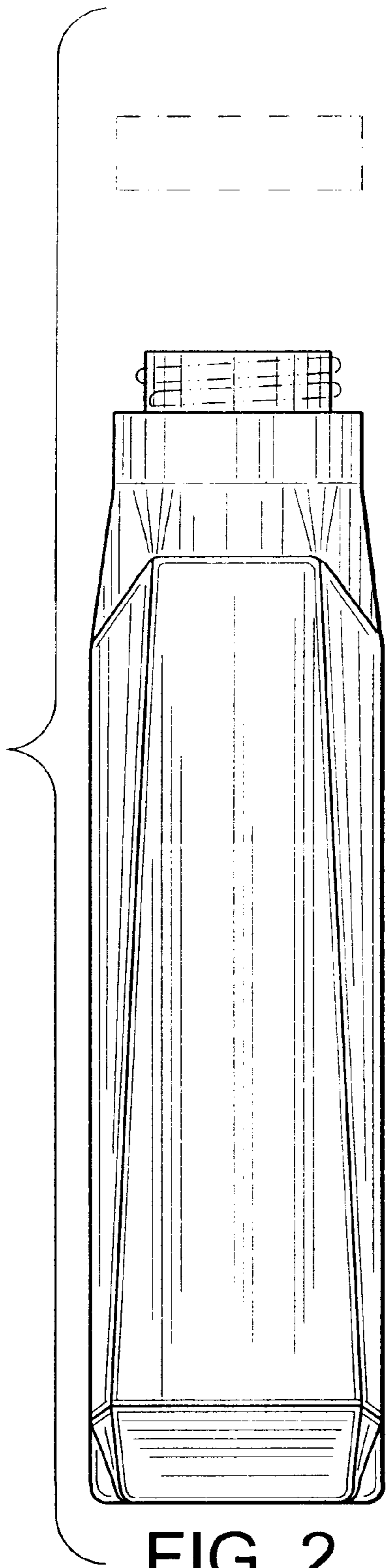

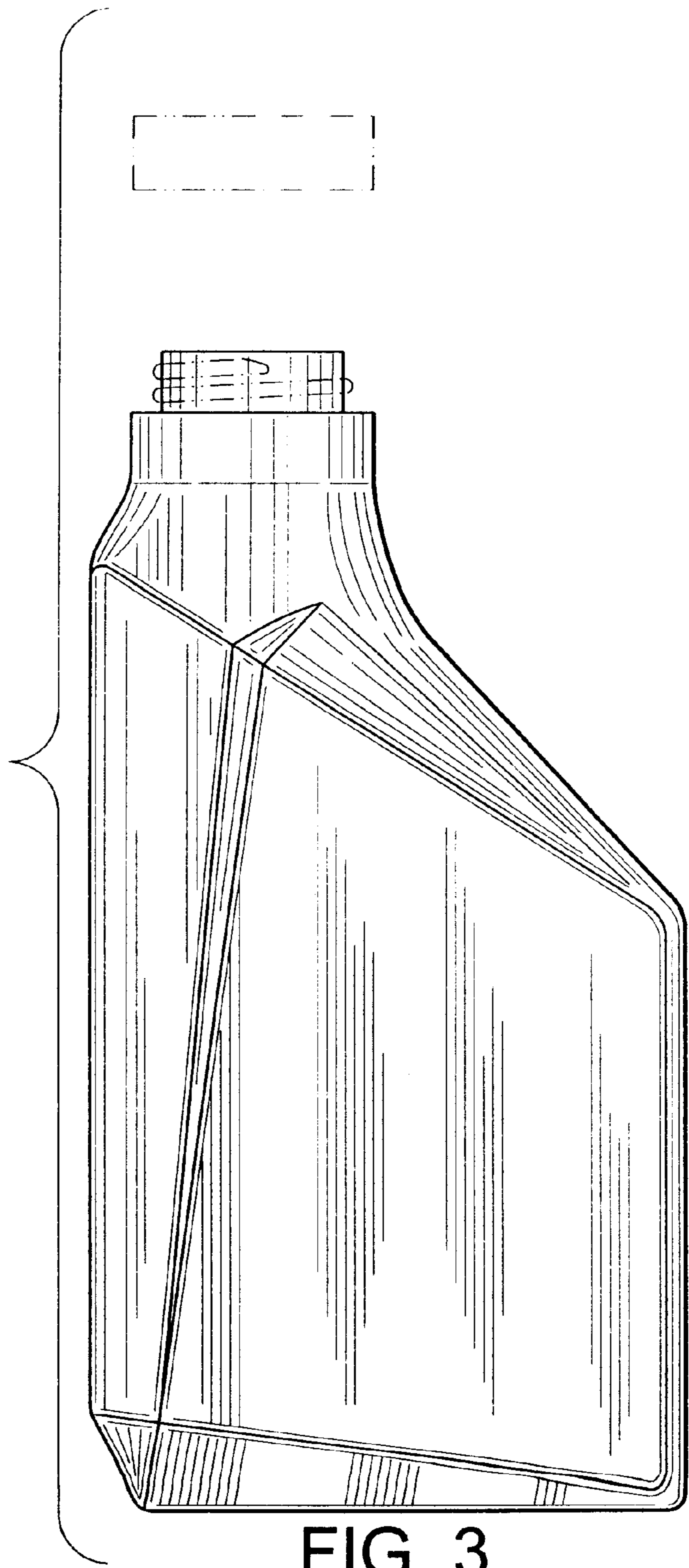

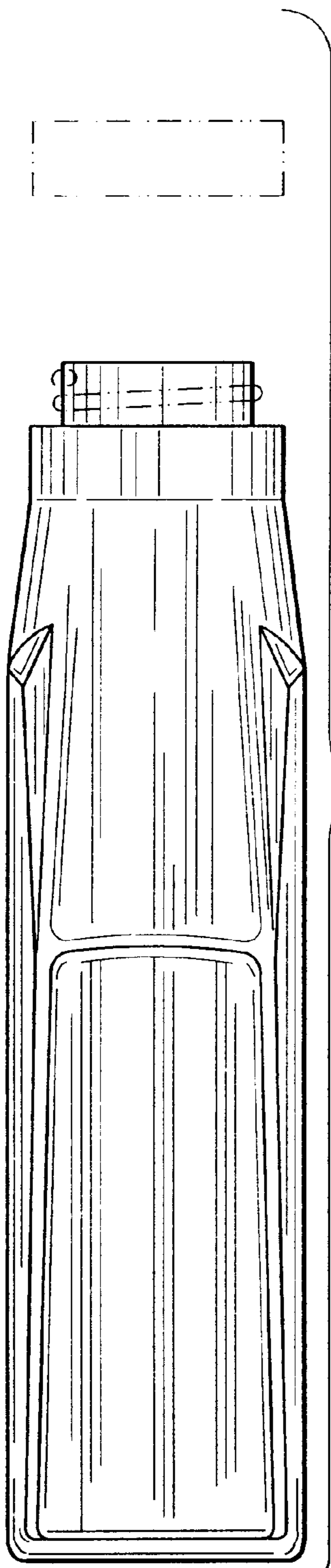

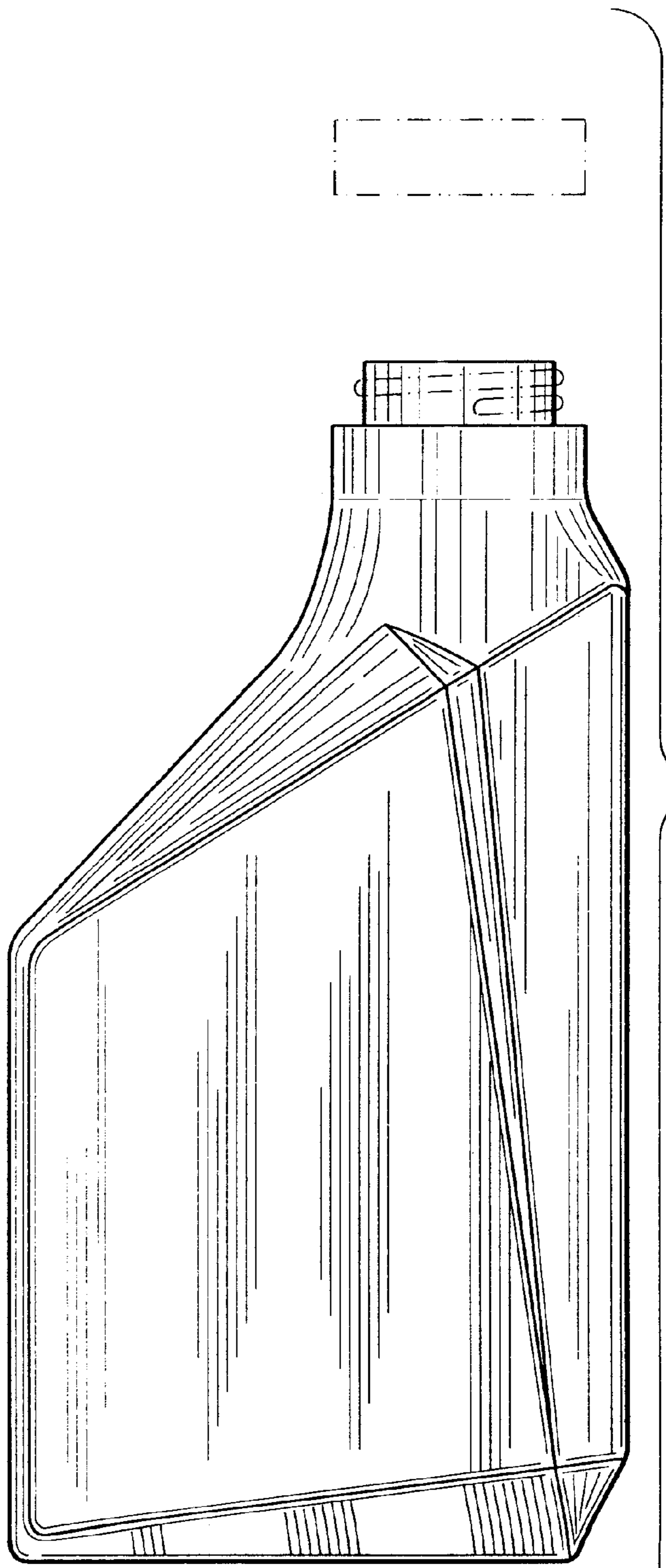

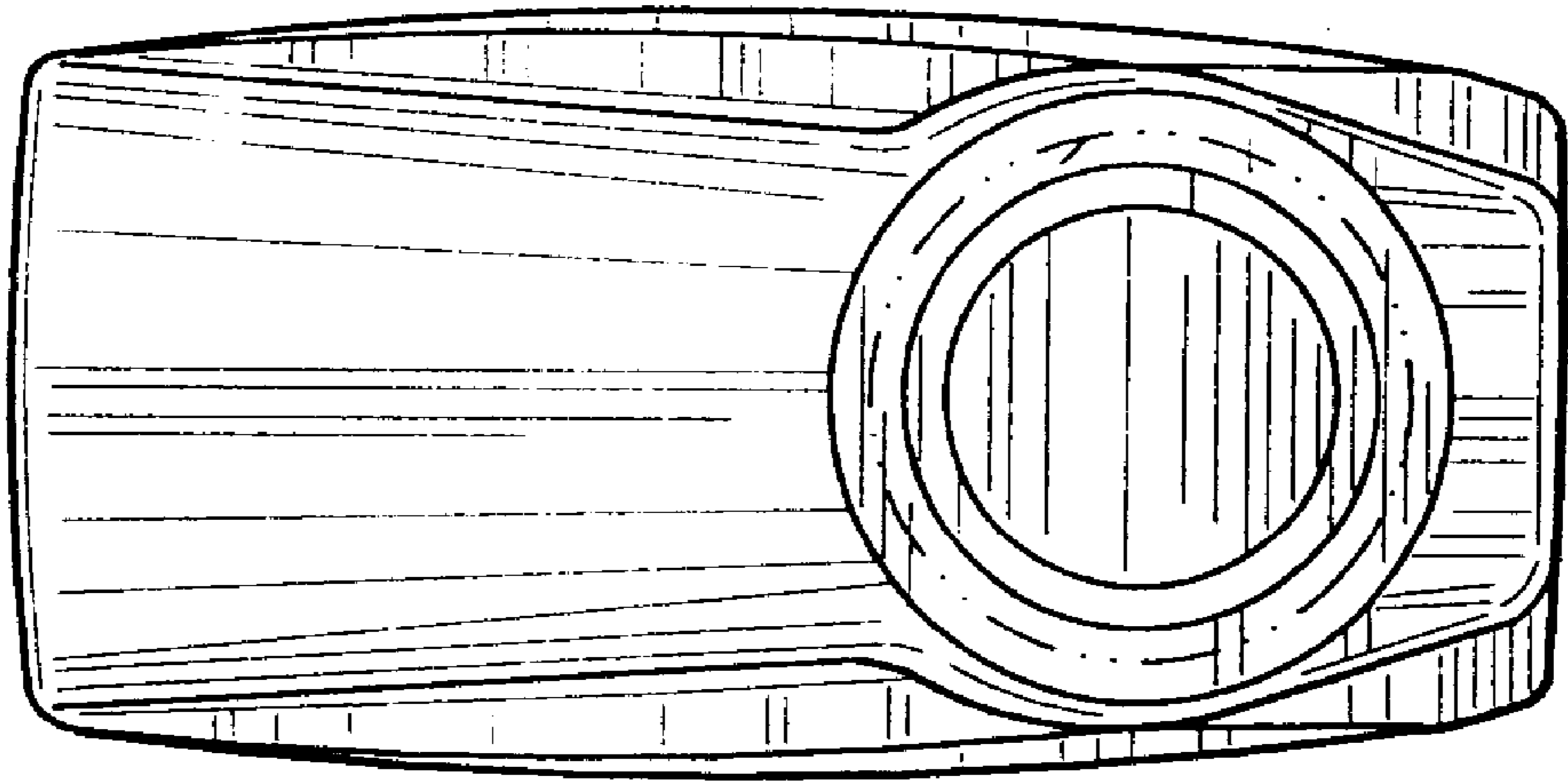

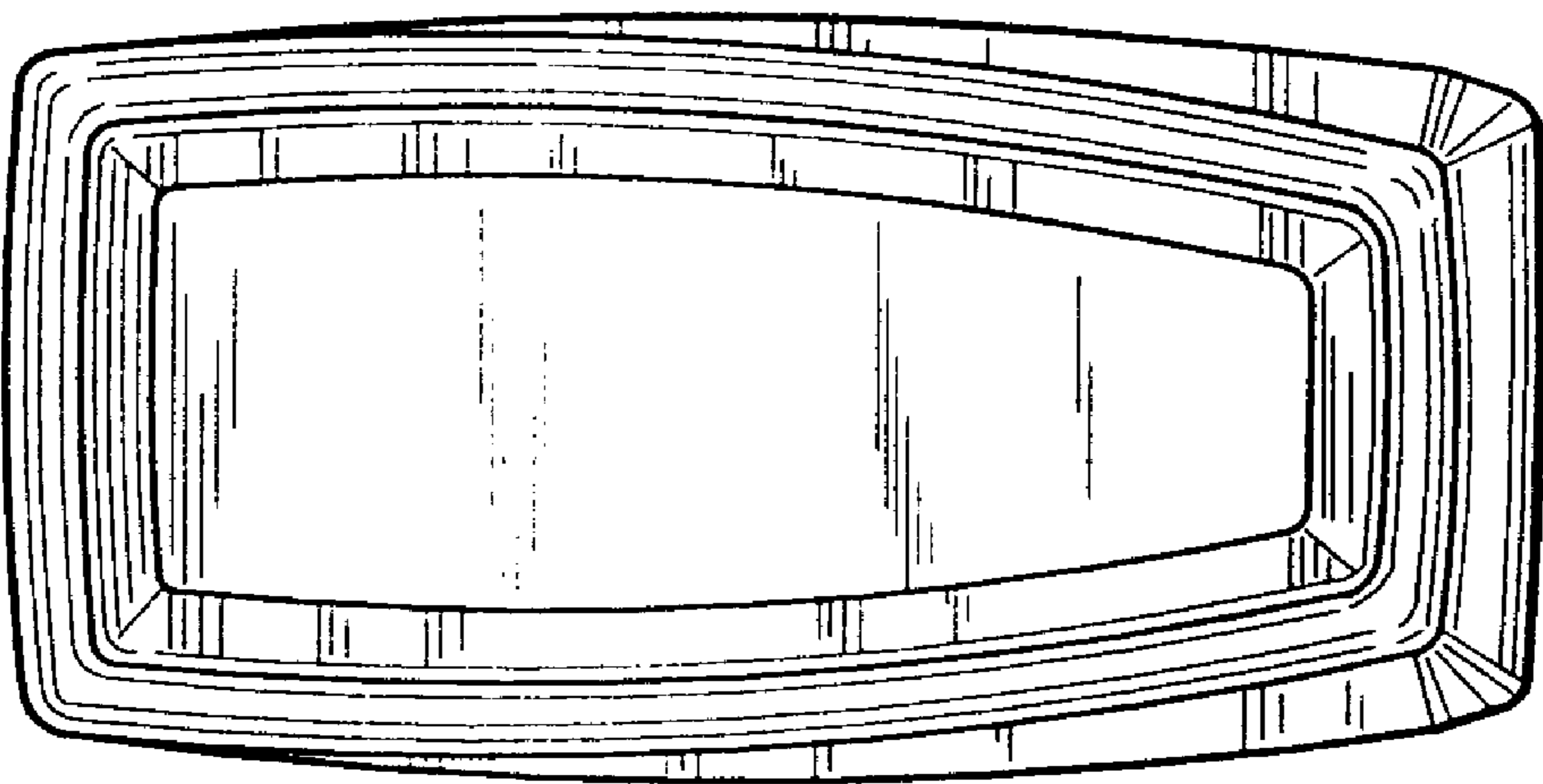
