DESCRIPTION

FIG. 1 is a left front elevated perspective view of a utility vehicle body showing our new design, the broken line showing the vehicle being for illustrative purposes only, and forming no part of the claimed design;

FIG. 2 is a plan view of the utility vehicle body design of FIG. 1;

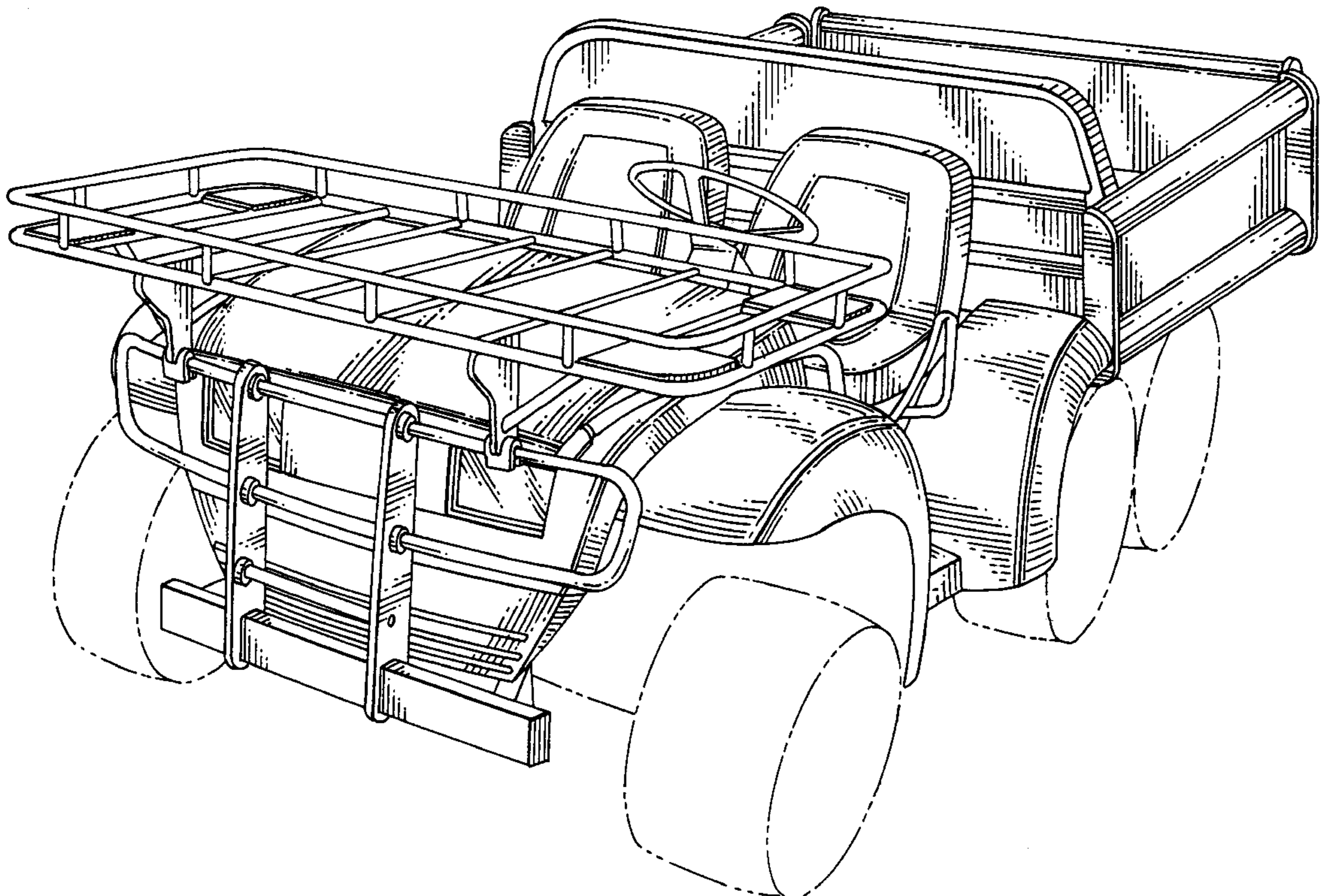
FIG. 3 is a left side view thereof;

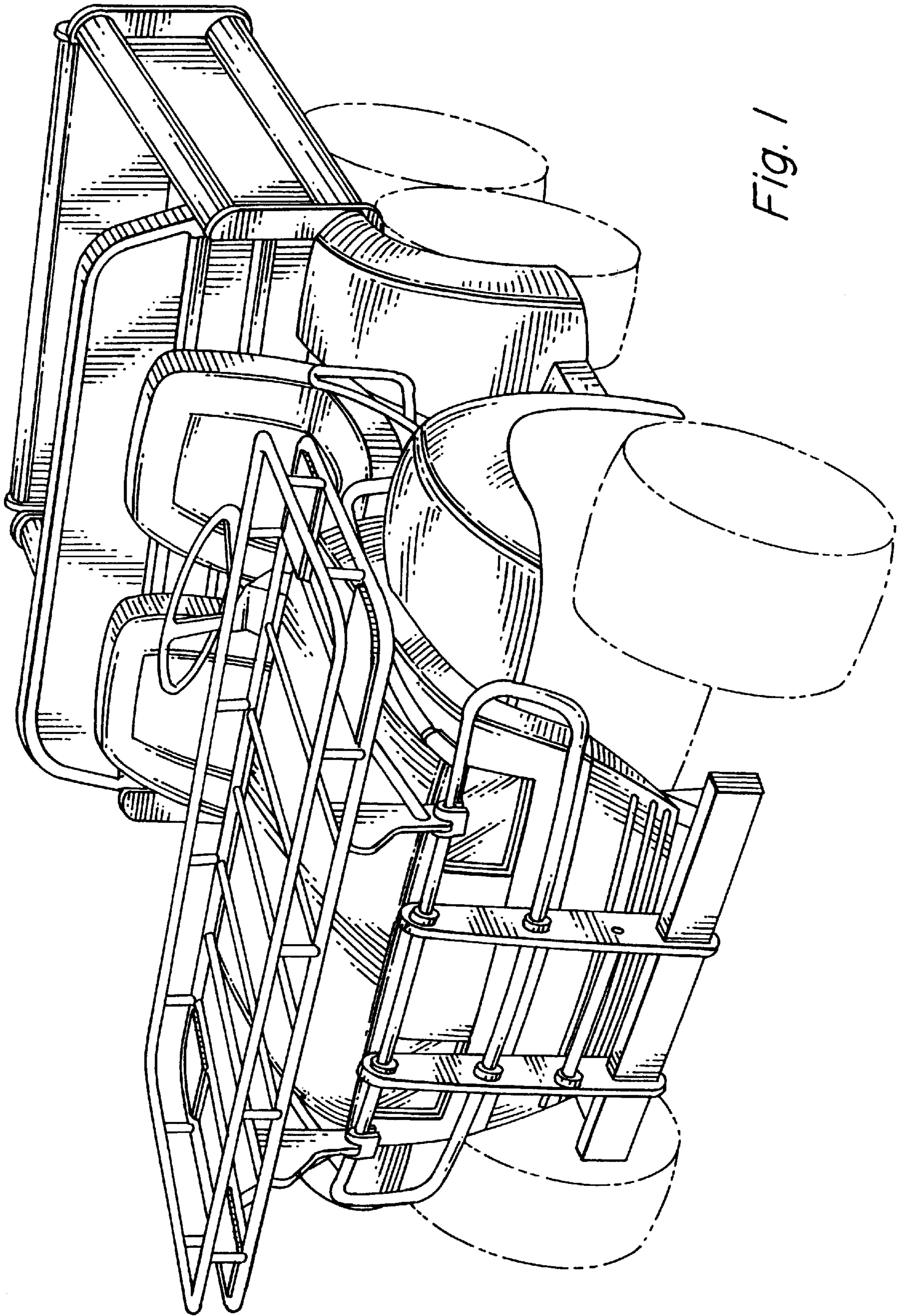

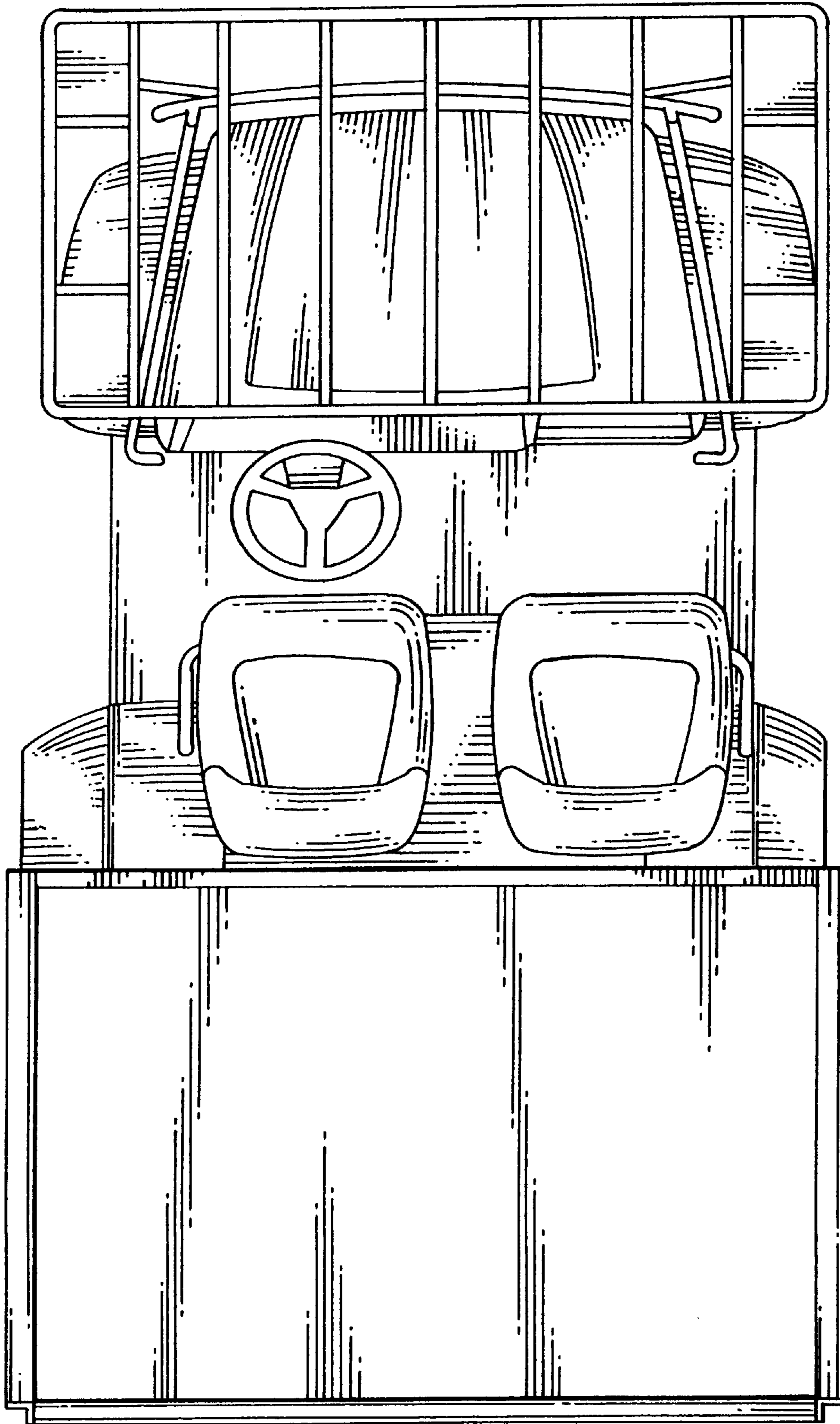

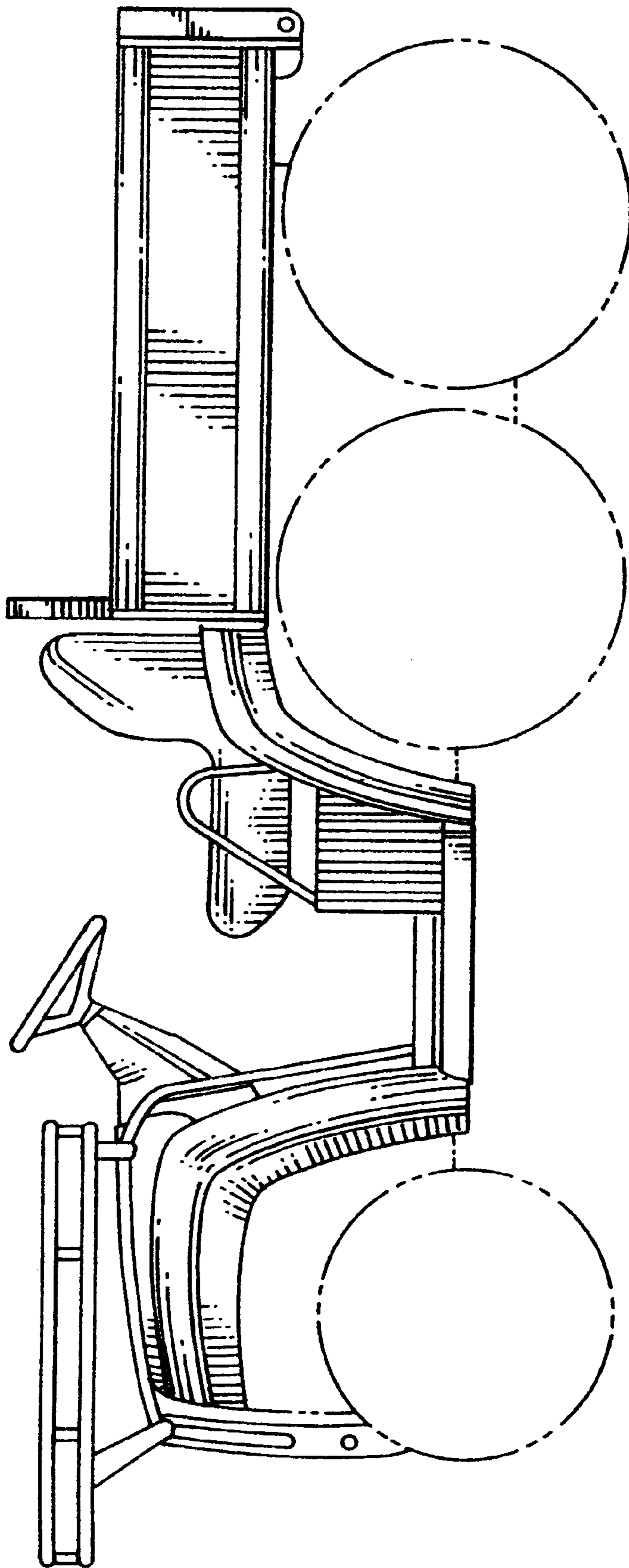

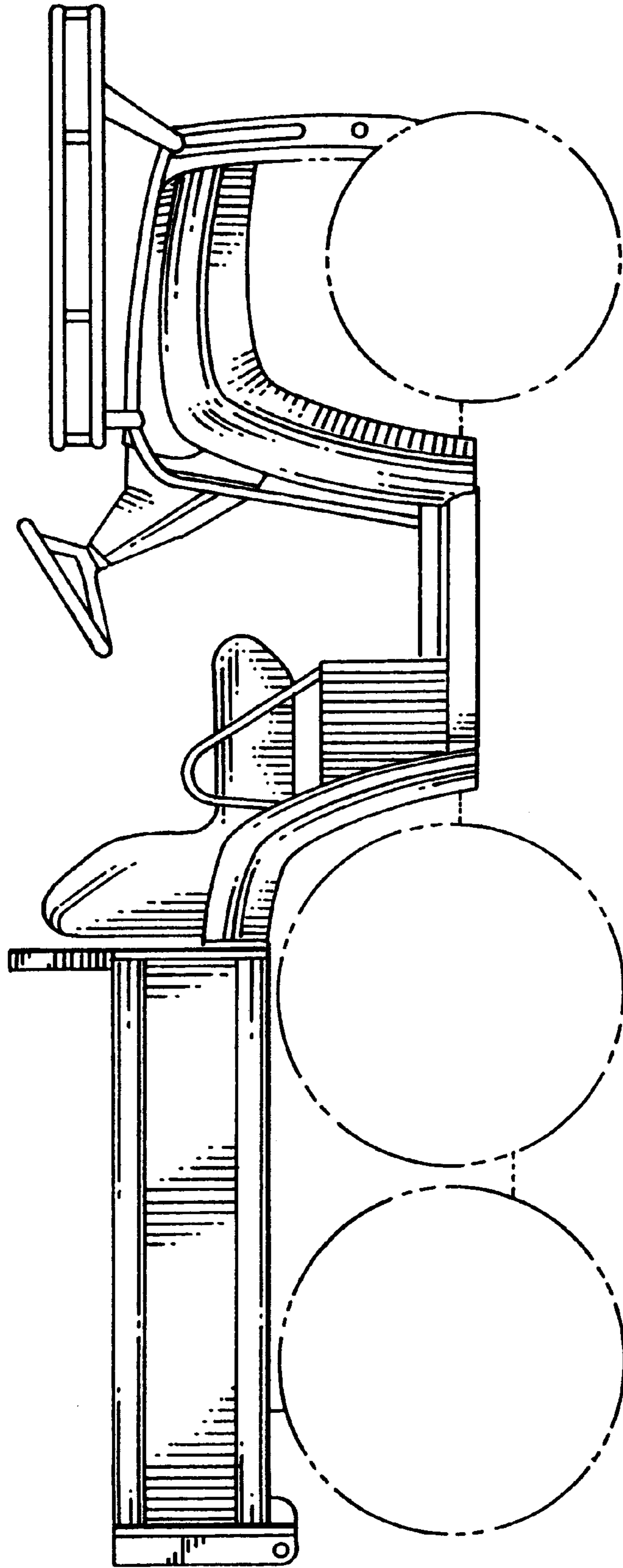

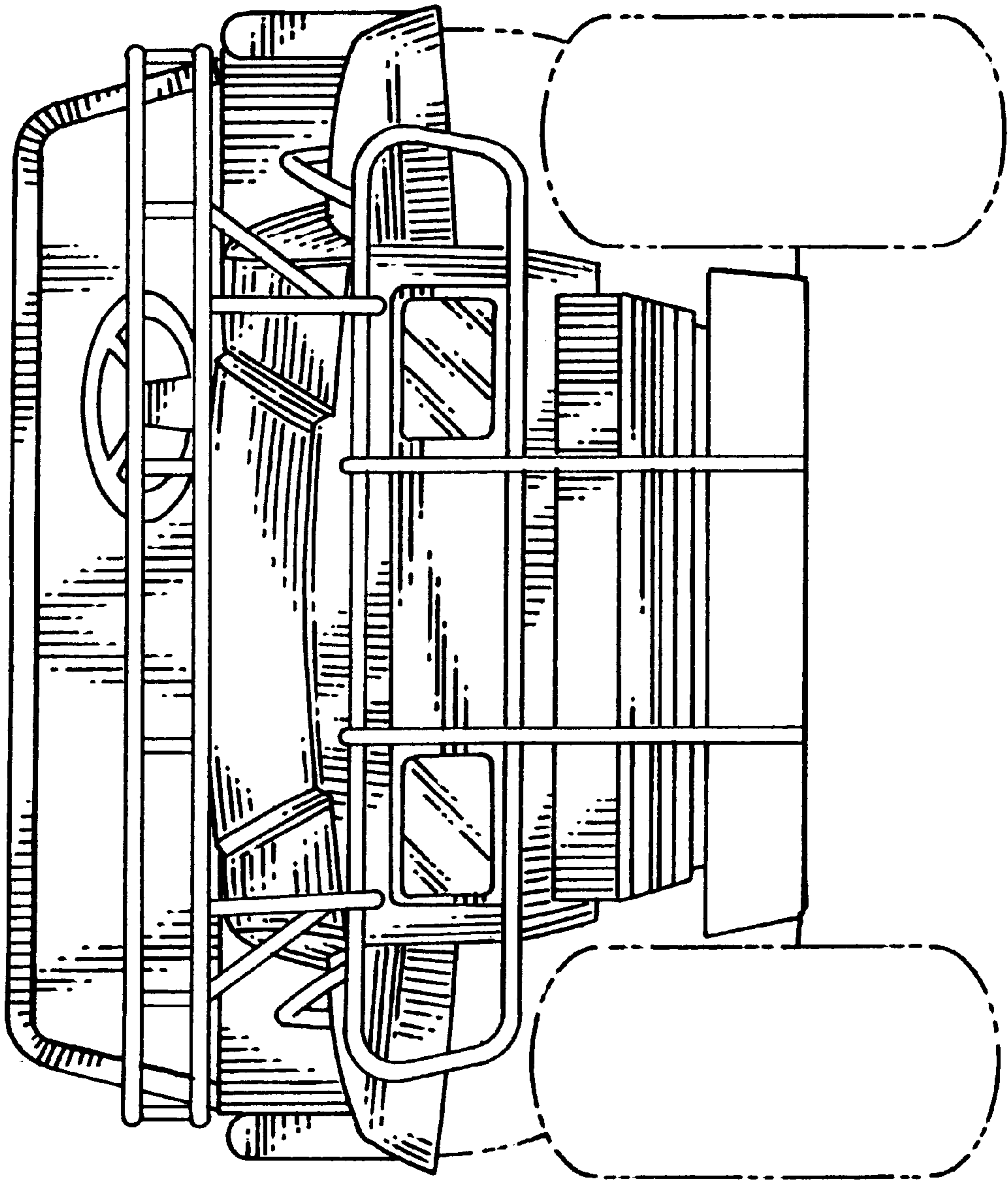

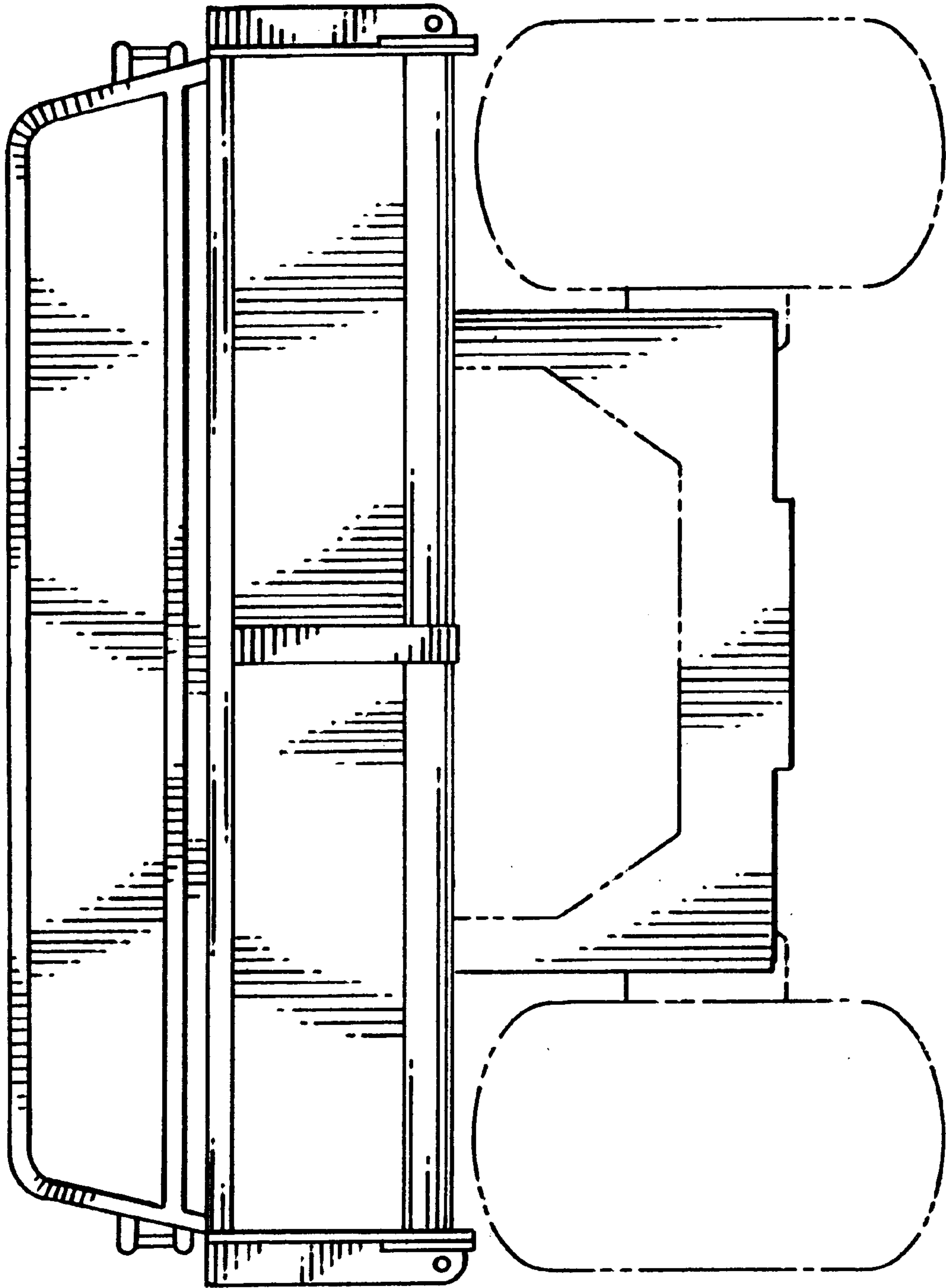
