The ornamental design for a motorcycle, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of a motorcycle showing our new design;
FIG. 2 is a front right perspective view thereof;
FIG. 3 is a rear left perspective view thereof;
FIG. 4 is a rear right perspective view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;

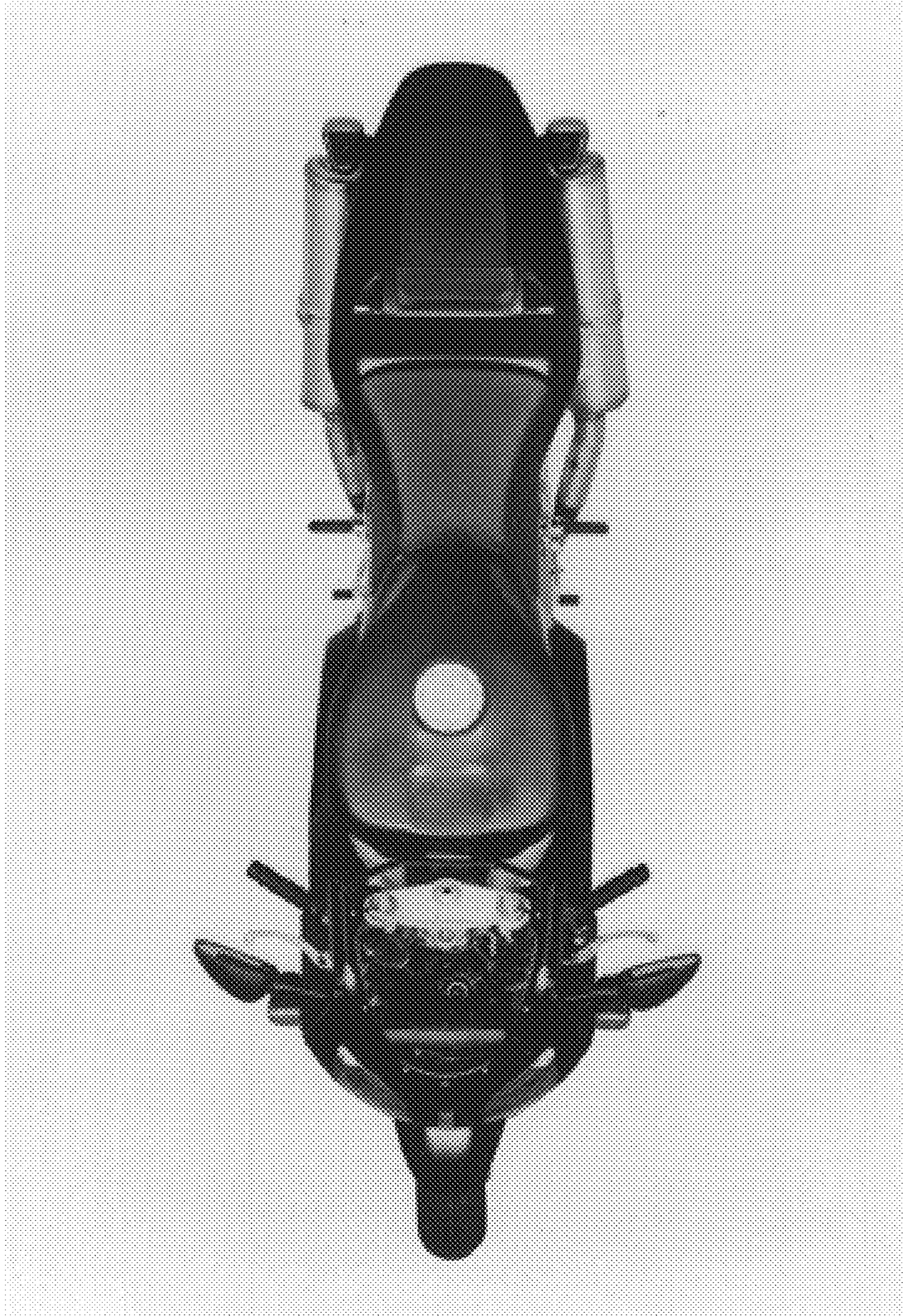
