(57) **CLAIM**

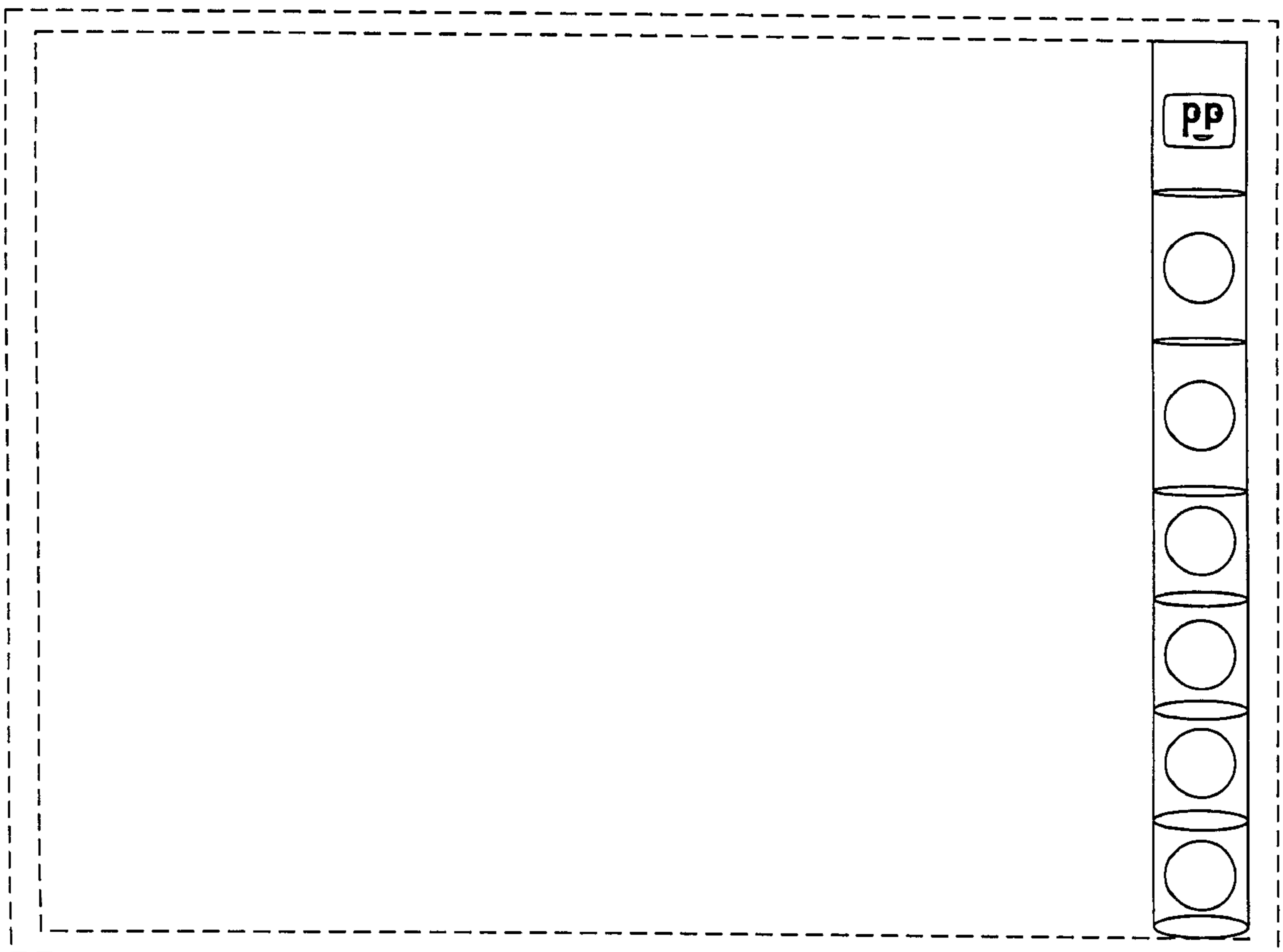
The ornamental design for a computer generated image for a display panel or screen, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a computer generated image for a display panel or screen, showing our new design; FIG. 2 is a front view of a second embodiment thereof; FIG. 3 is a front view of a third embodiment thereof; FIG. 4 is a front view of a fourth embodiment thereof; FIG. 5 is a front view of a fifth embodiment thereof; FIG. 6 is a front view of a sixth embodiment thereof; FIG. 7 is a front view of a seventh embodiment thereof; and, FIG. 8 is a front view of an eighth embodiment thereof.

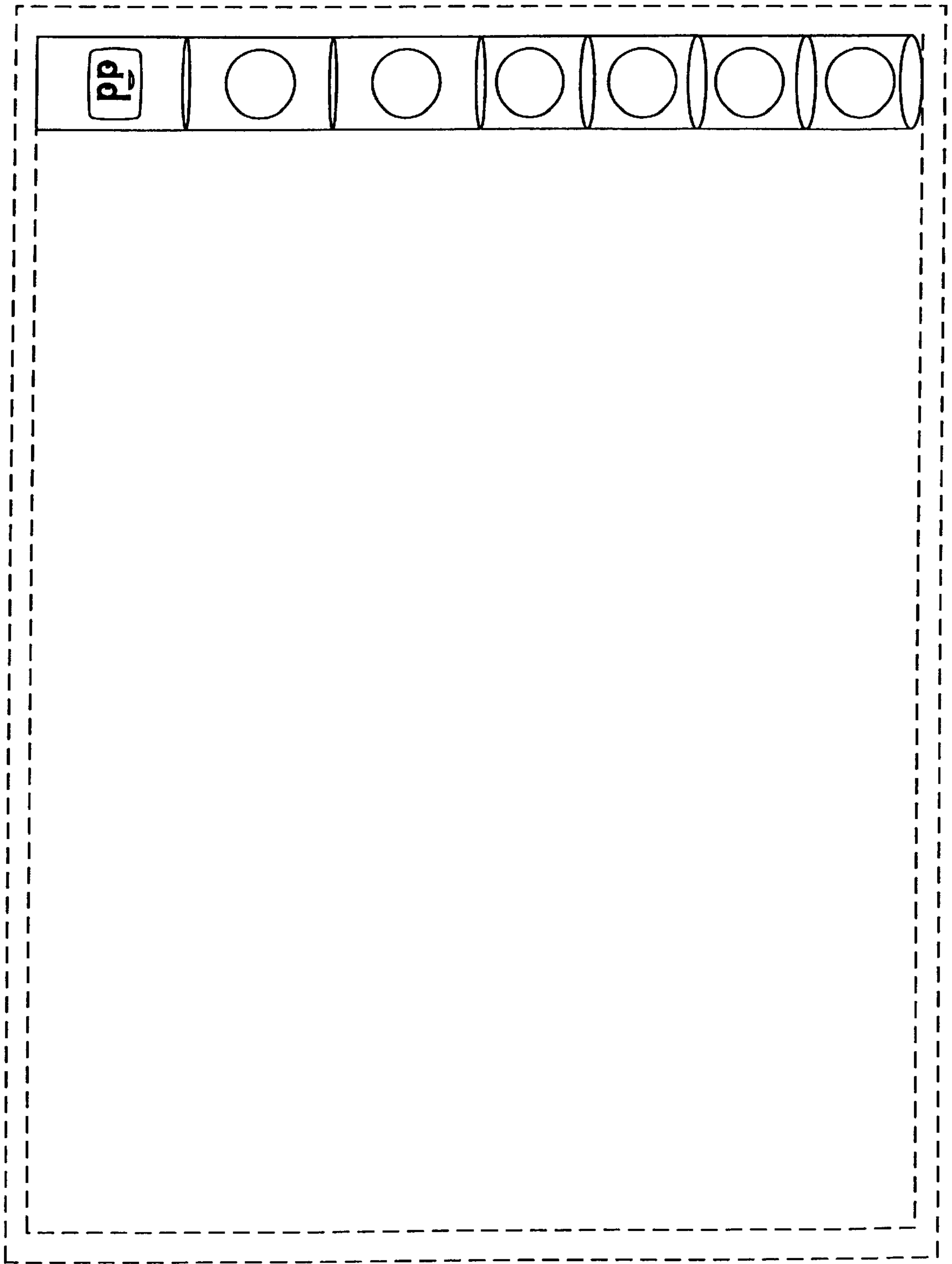

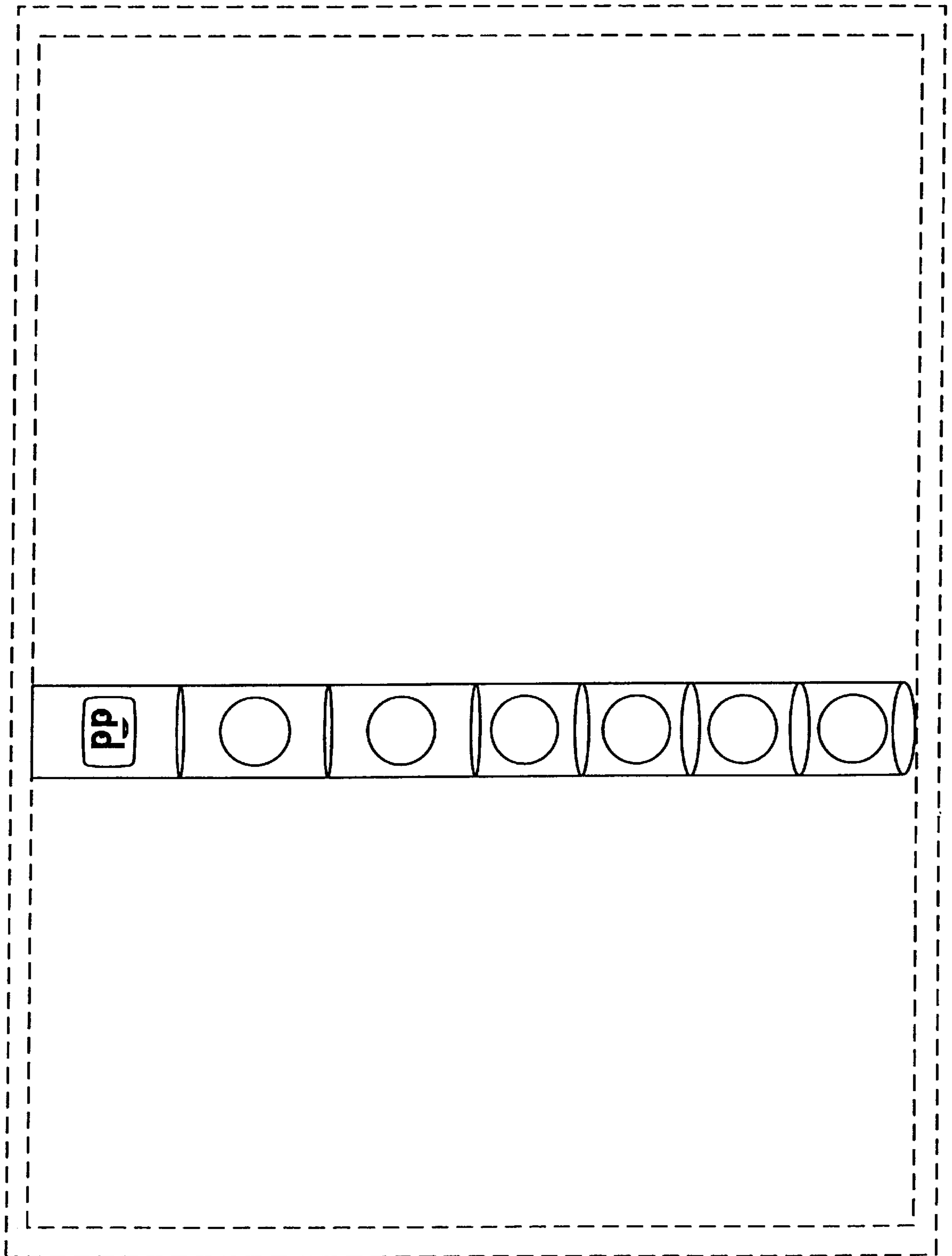

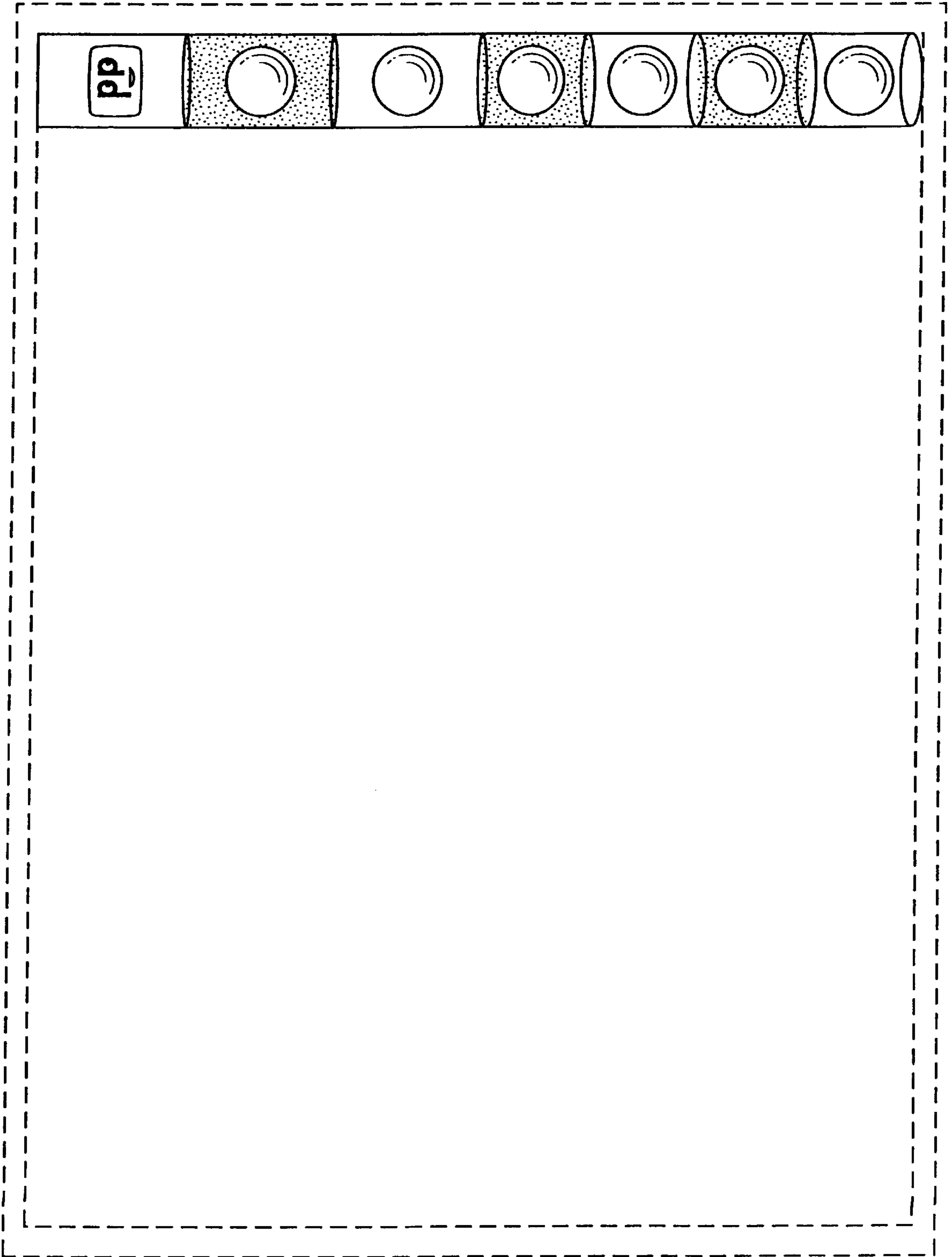

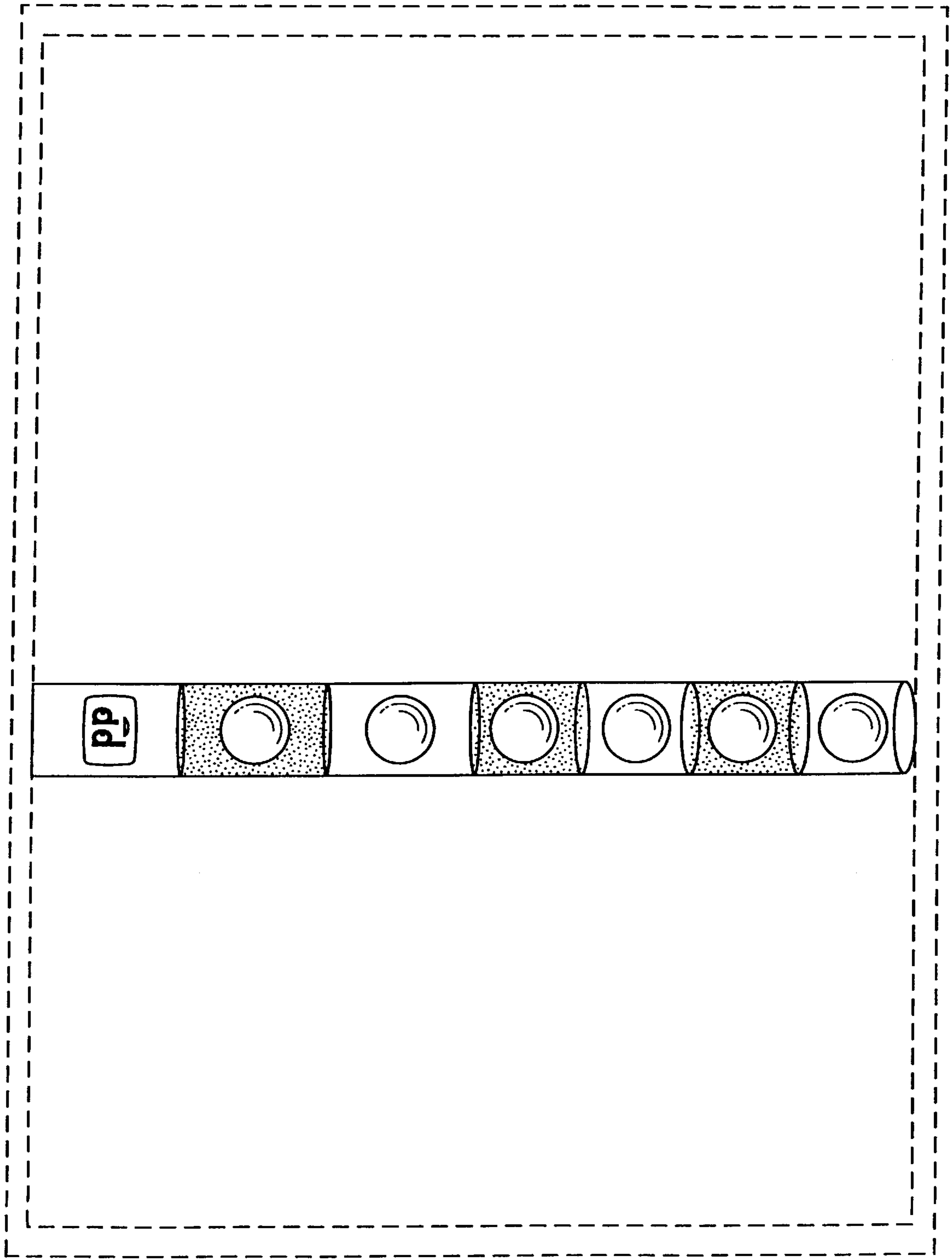

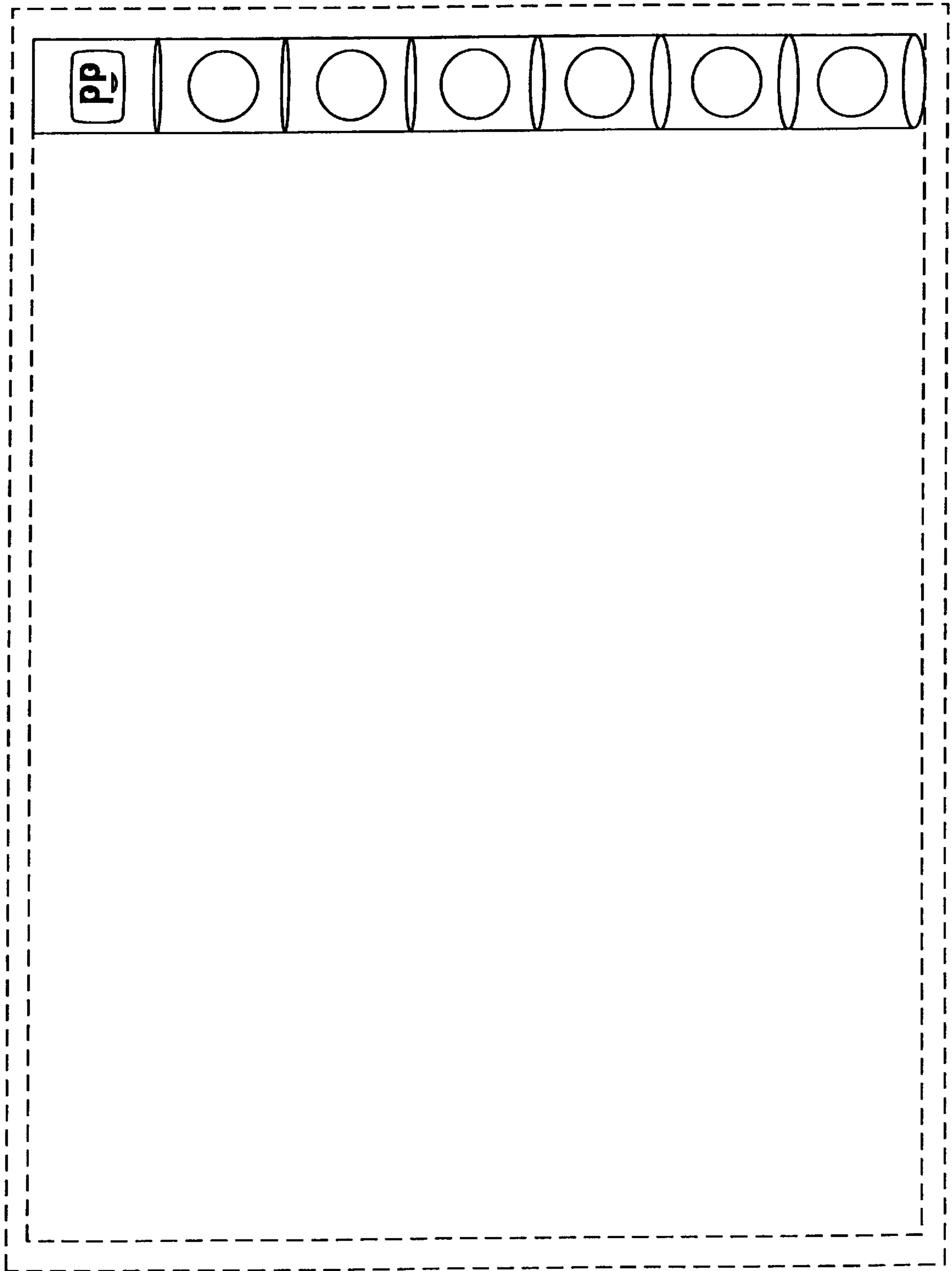

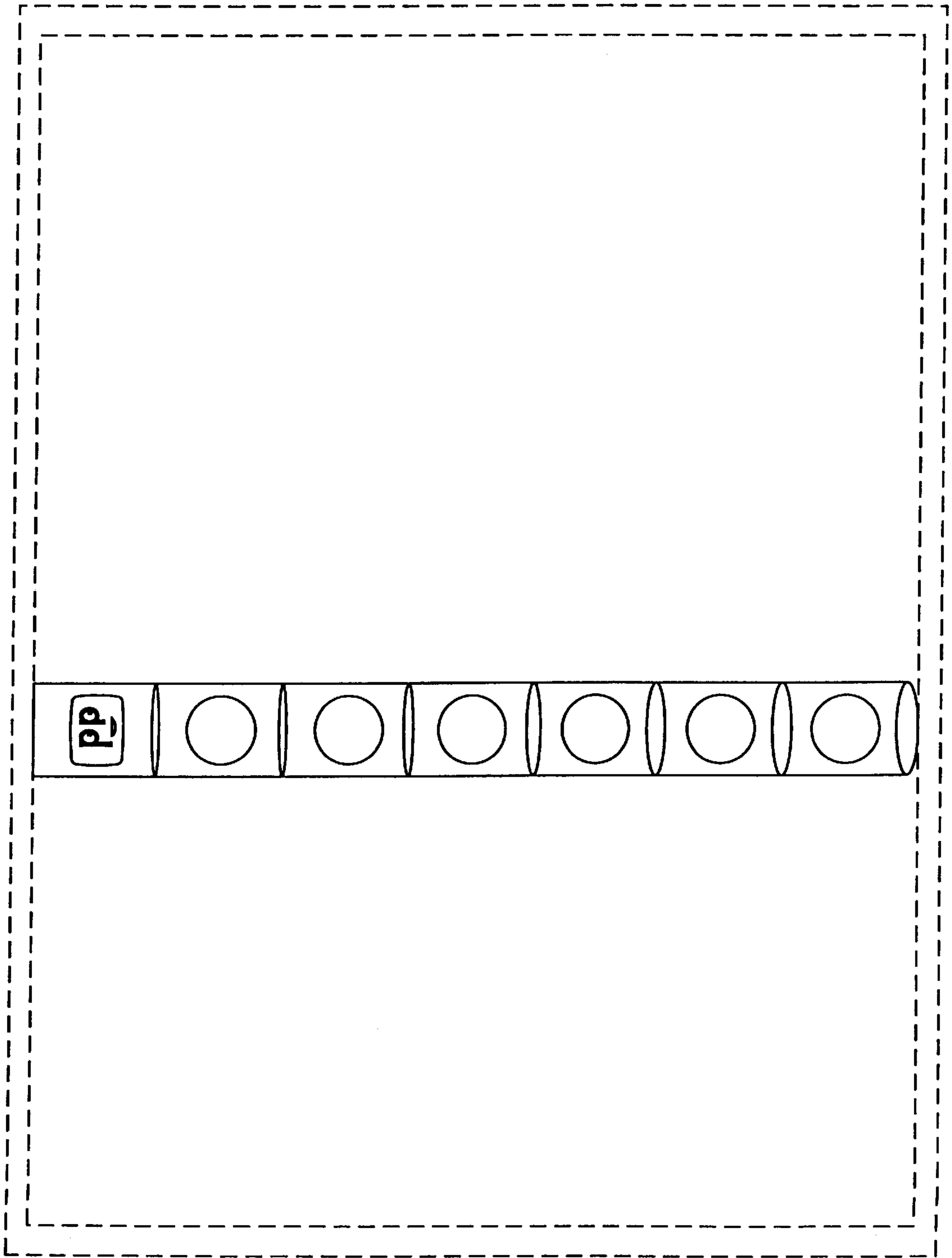

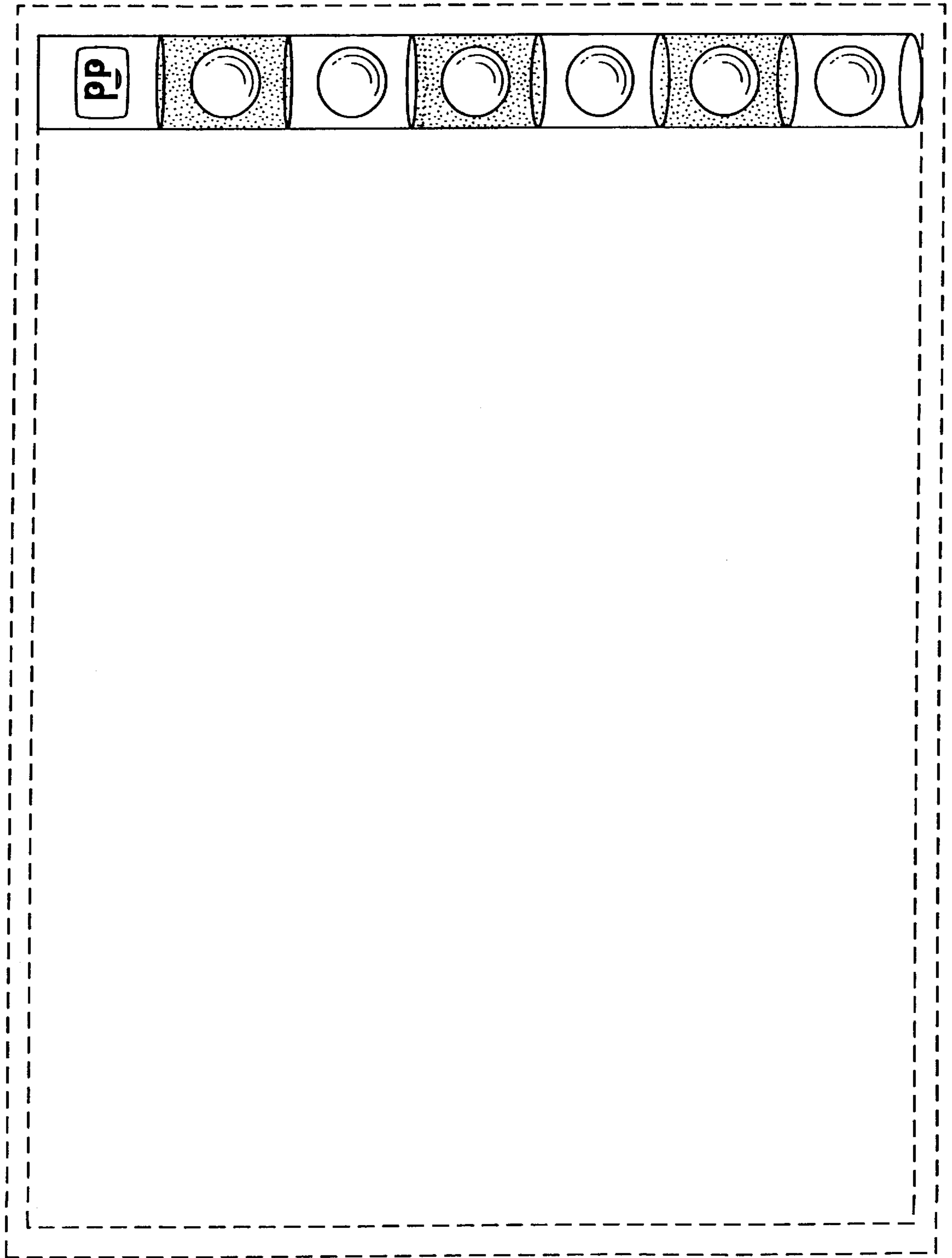

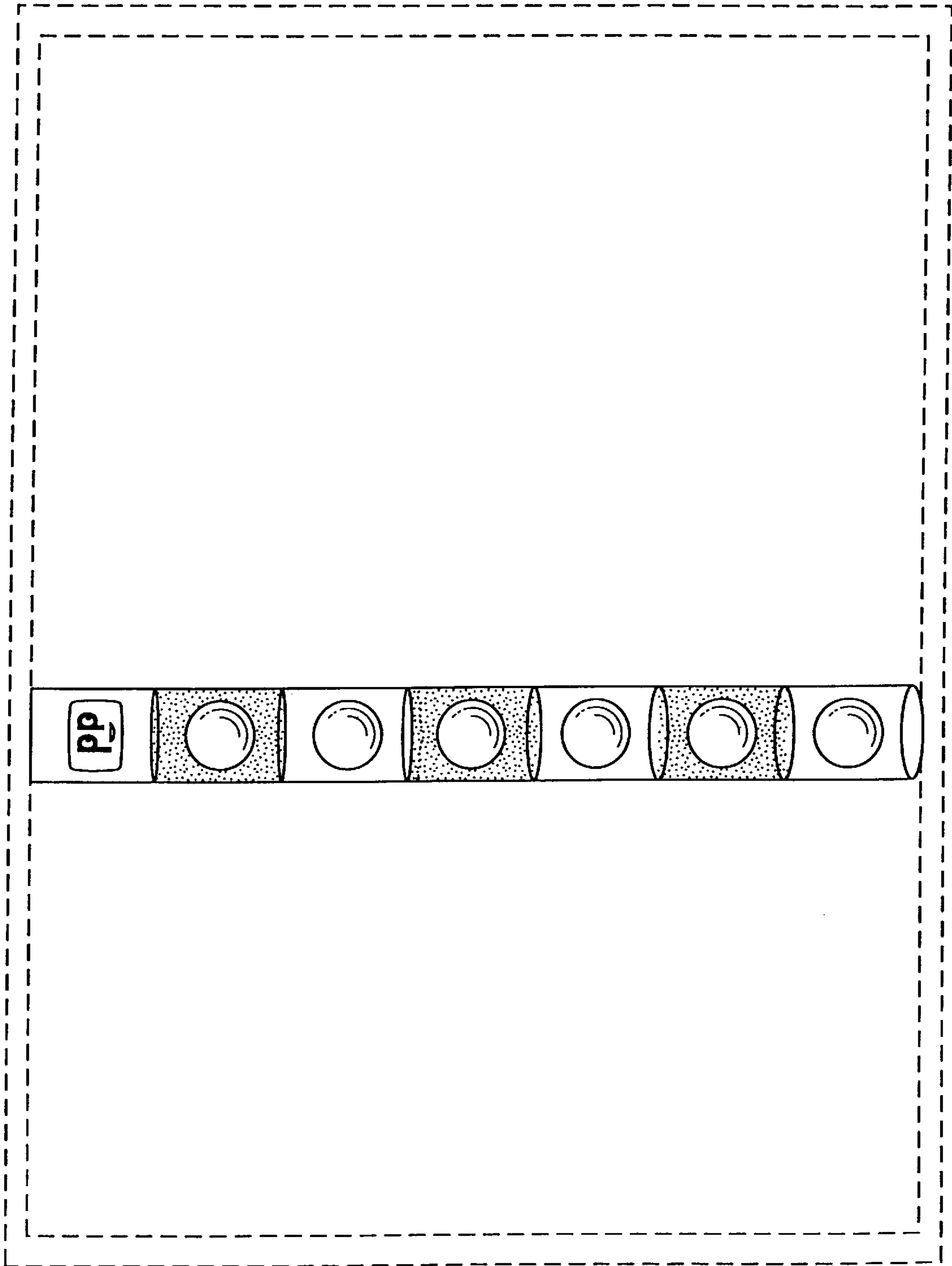
