FIG. 1 is a bottom, front, left perspective view of a showing my new design;

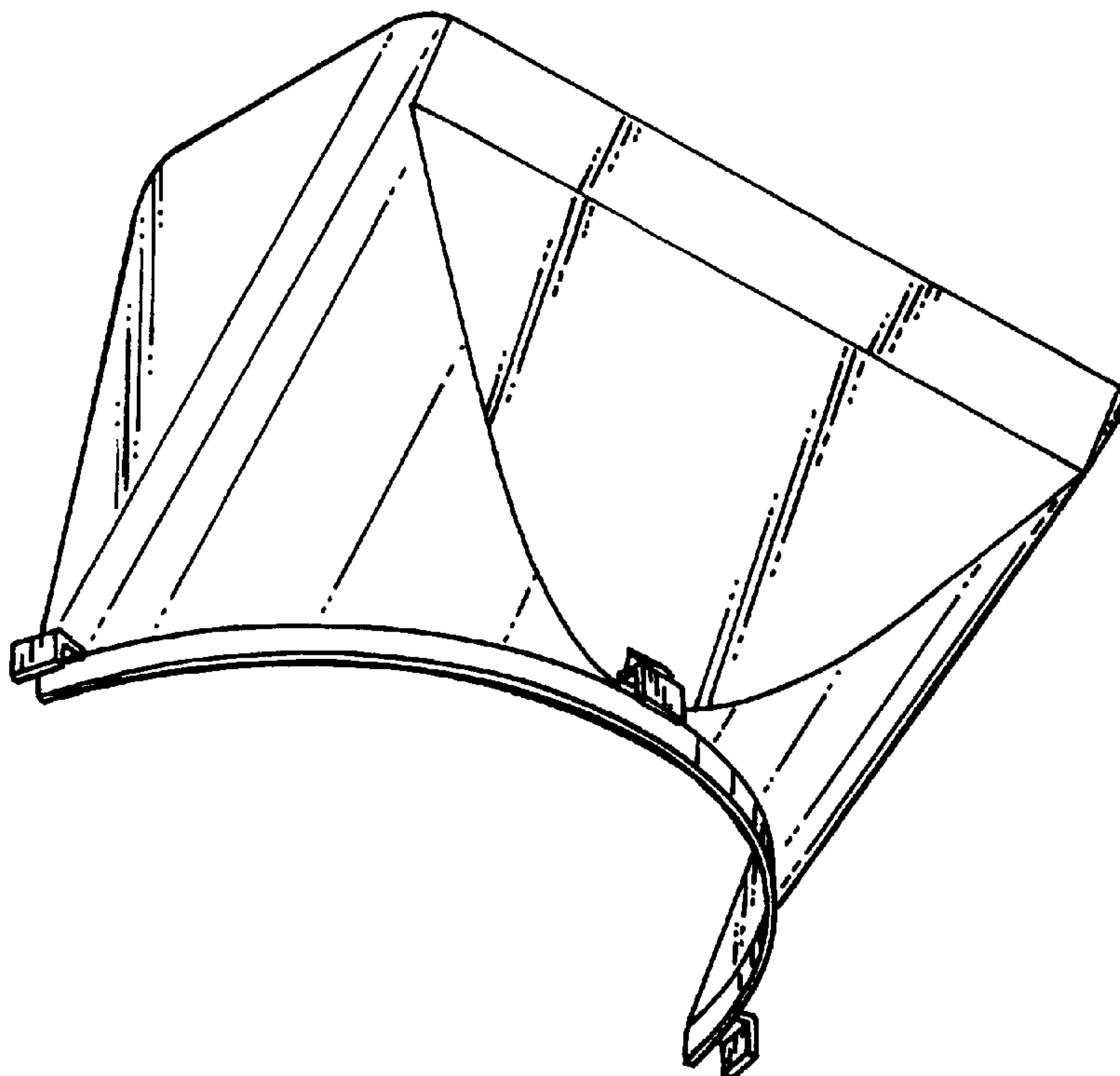
FIG. 2 is a top plan view showing inside surfaces thereof; FIG. 3 is a rear elevational view showing inside surfaces thereof;

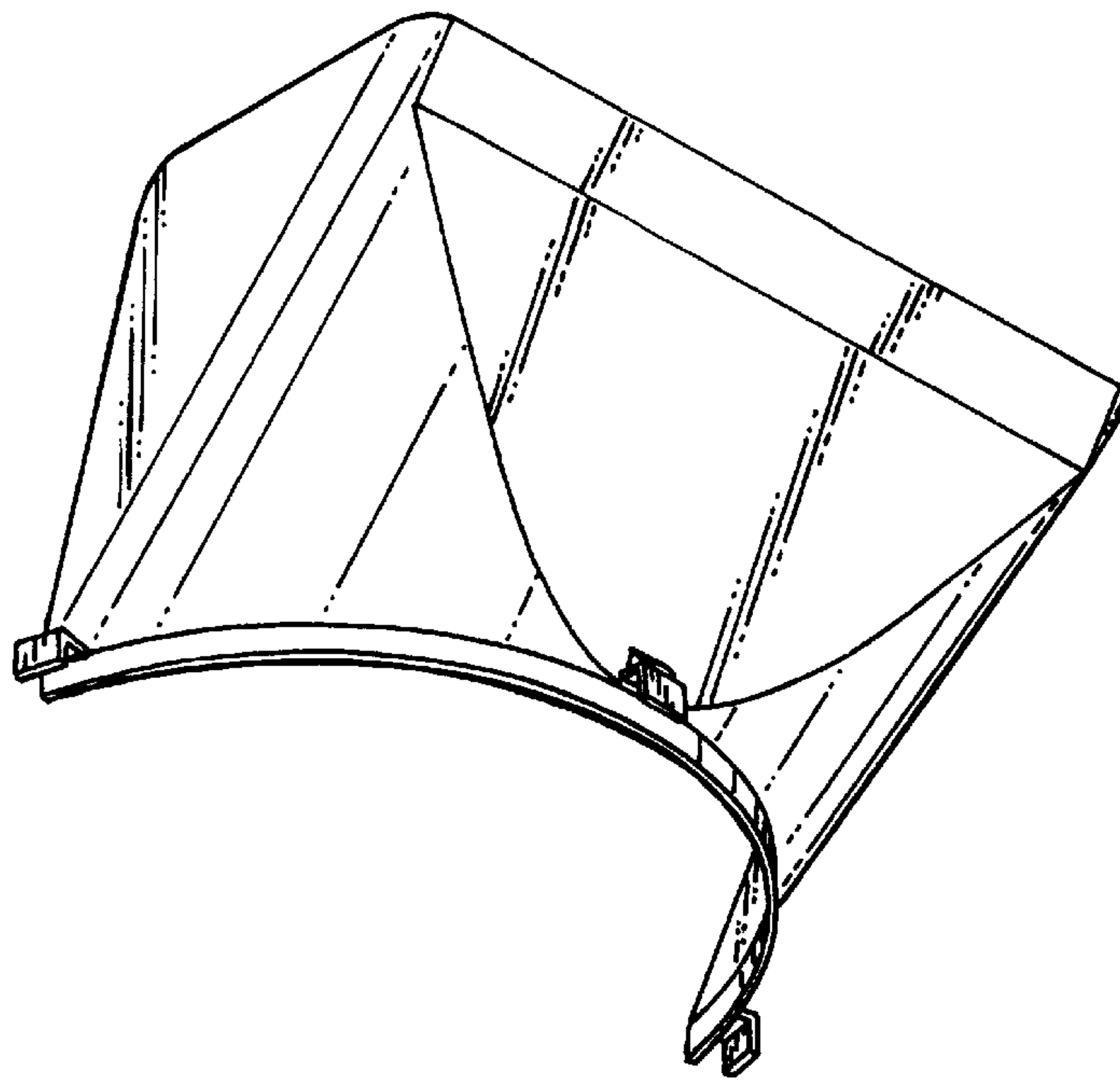

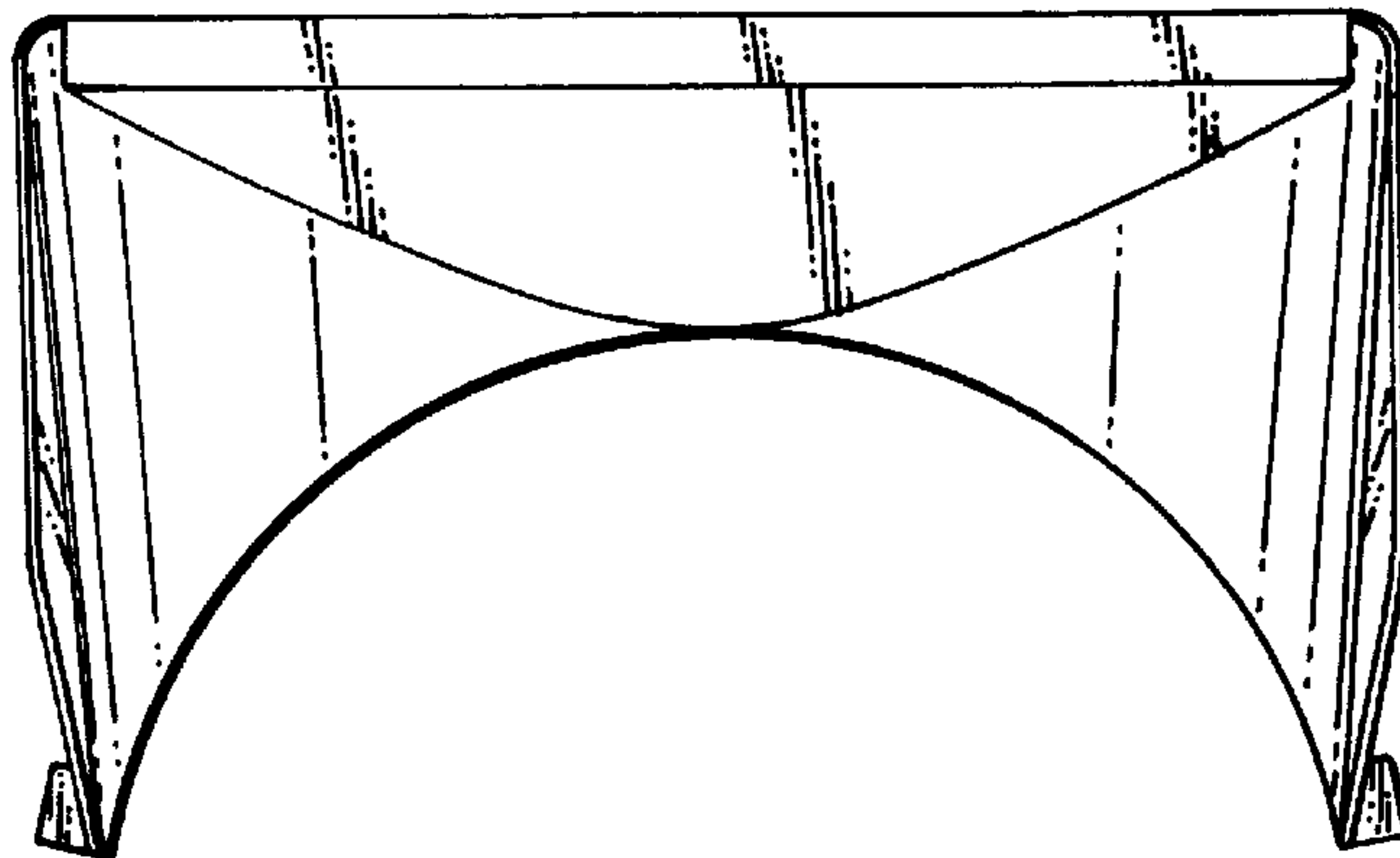

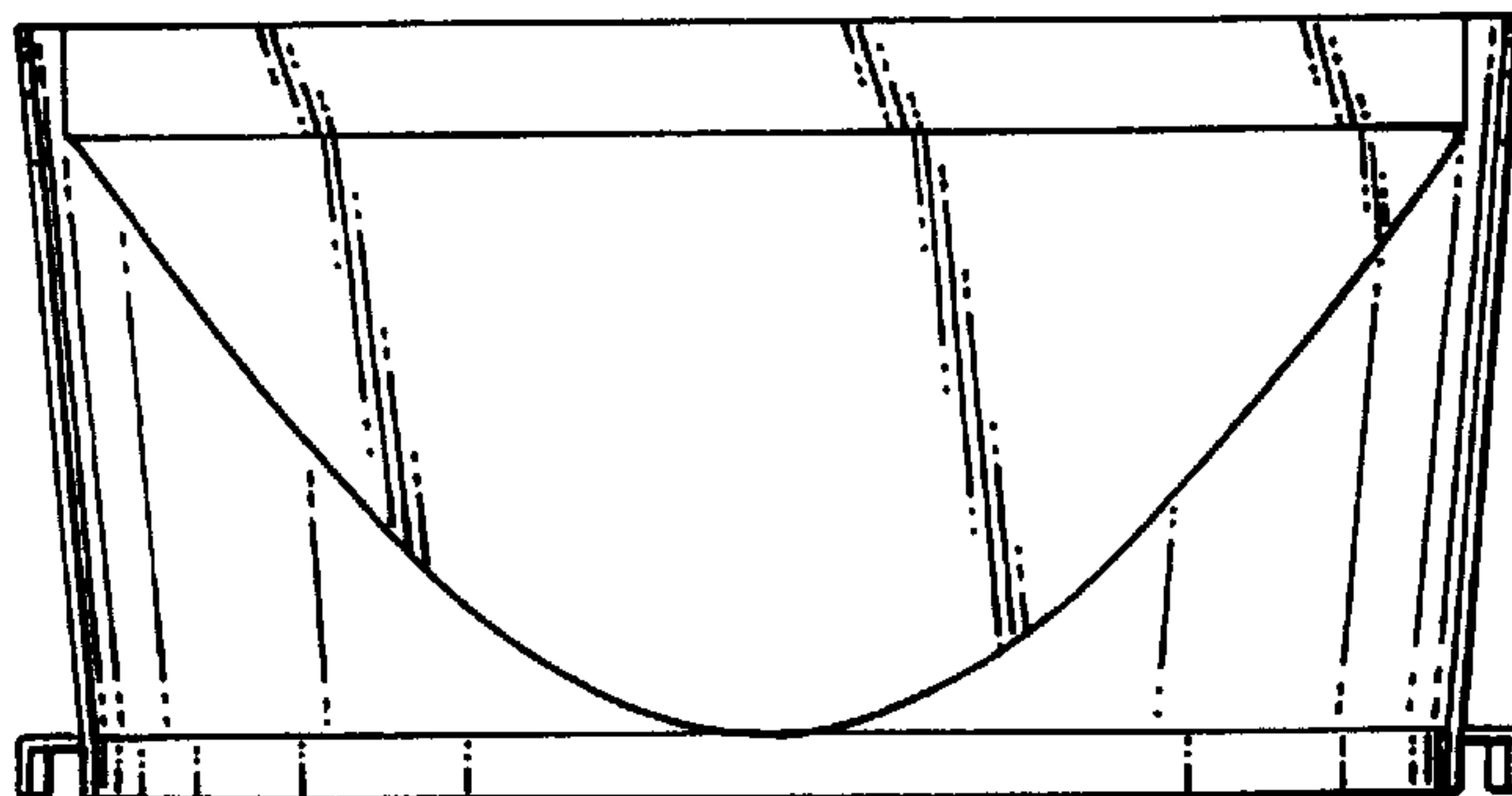

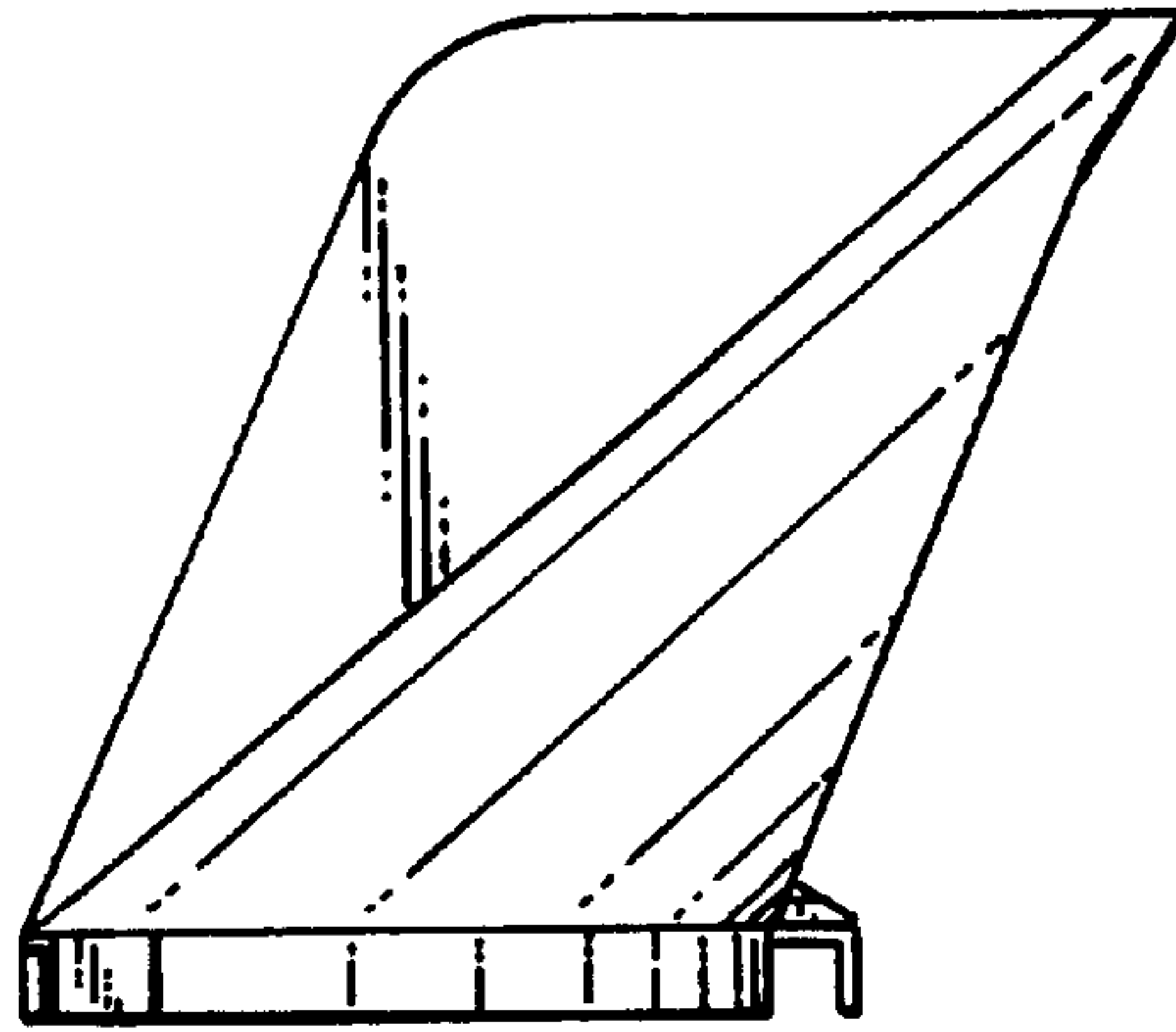

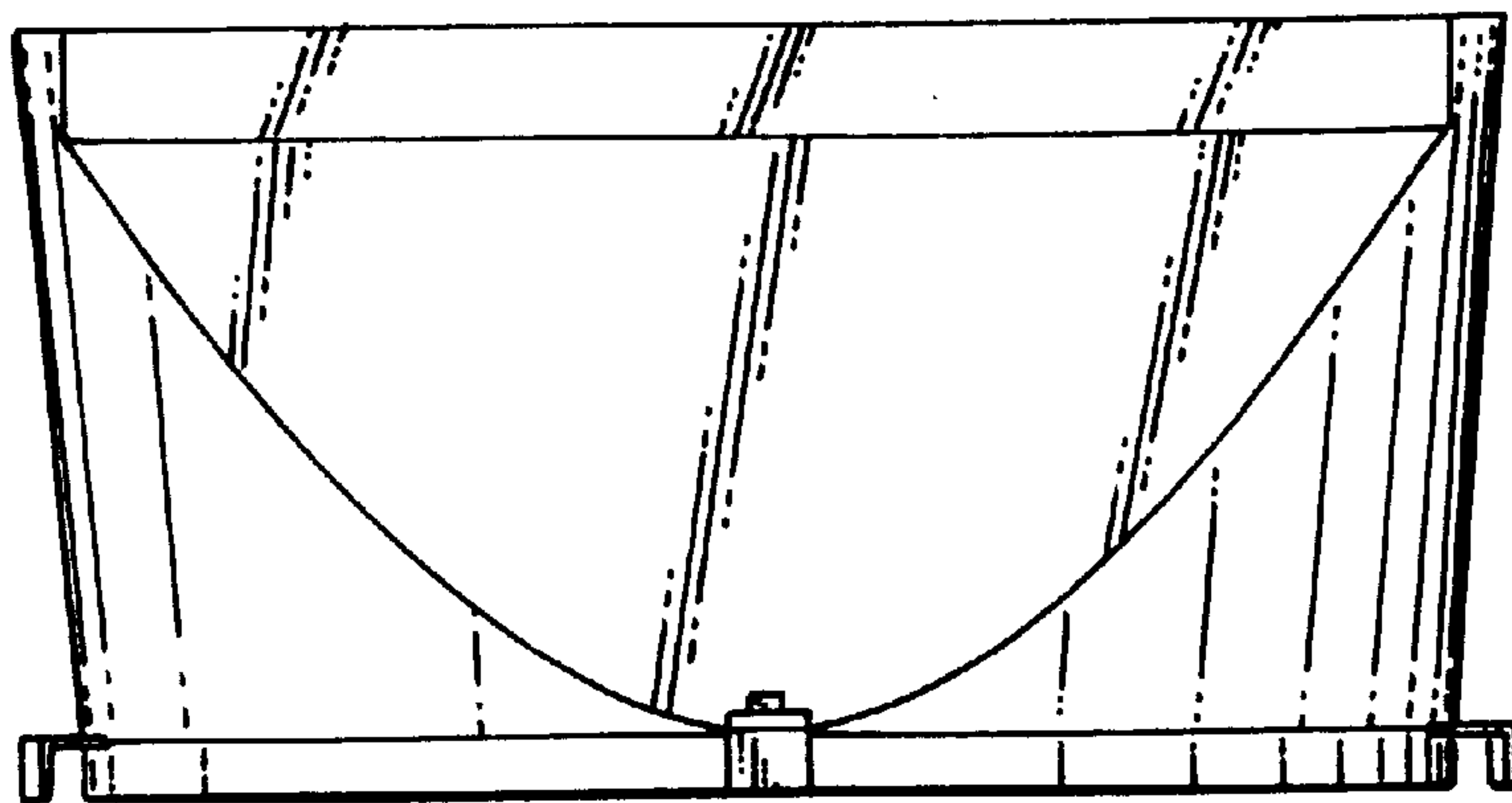

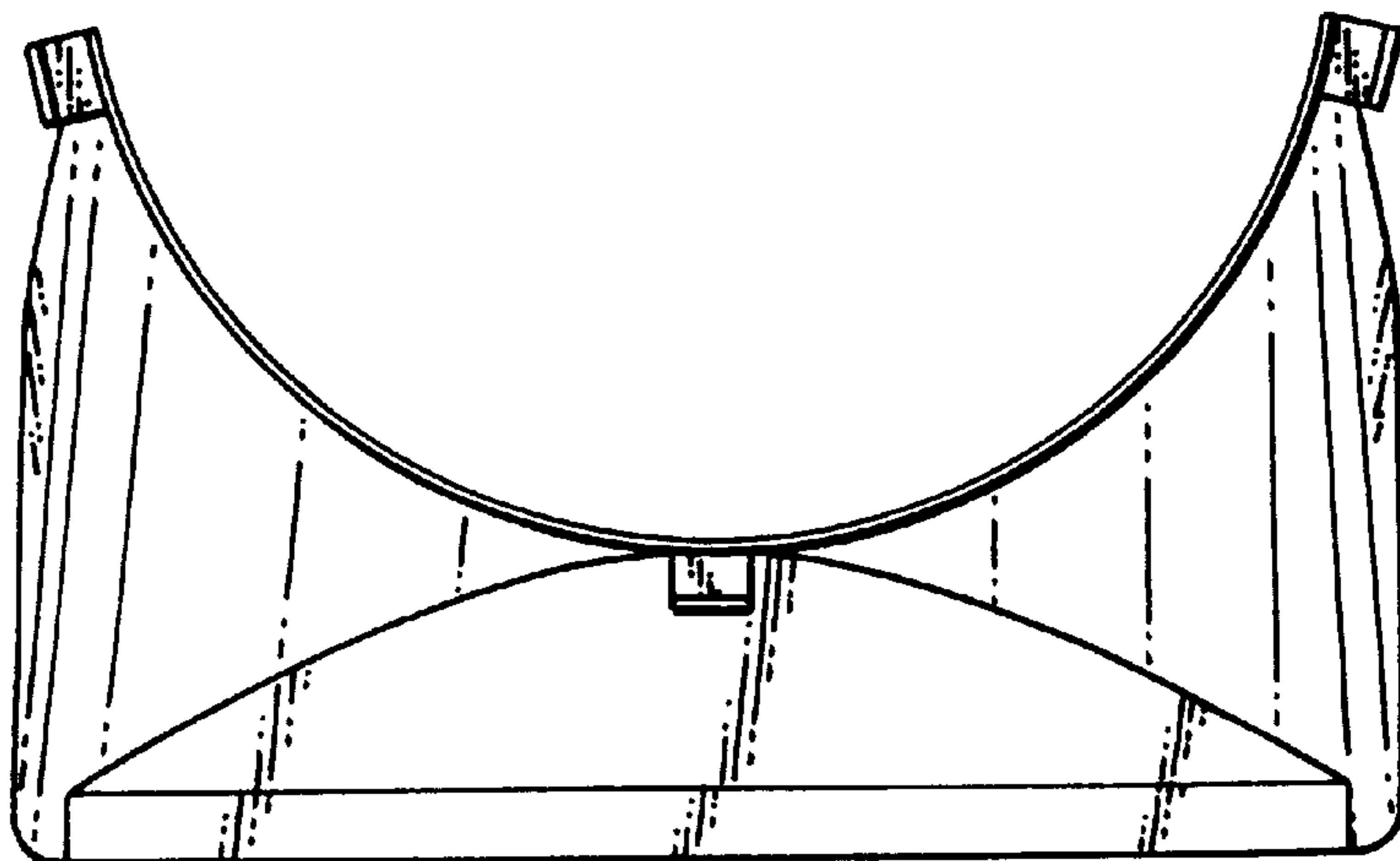
