(57) **CLAIM**

The ornamental design for a reversible denim vest, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a reversible denim vest showing my new design;

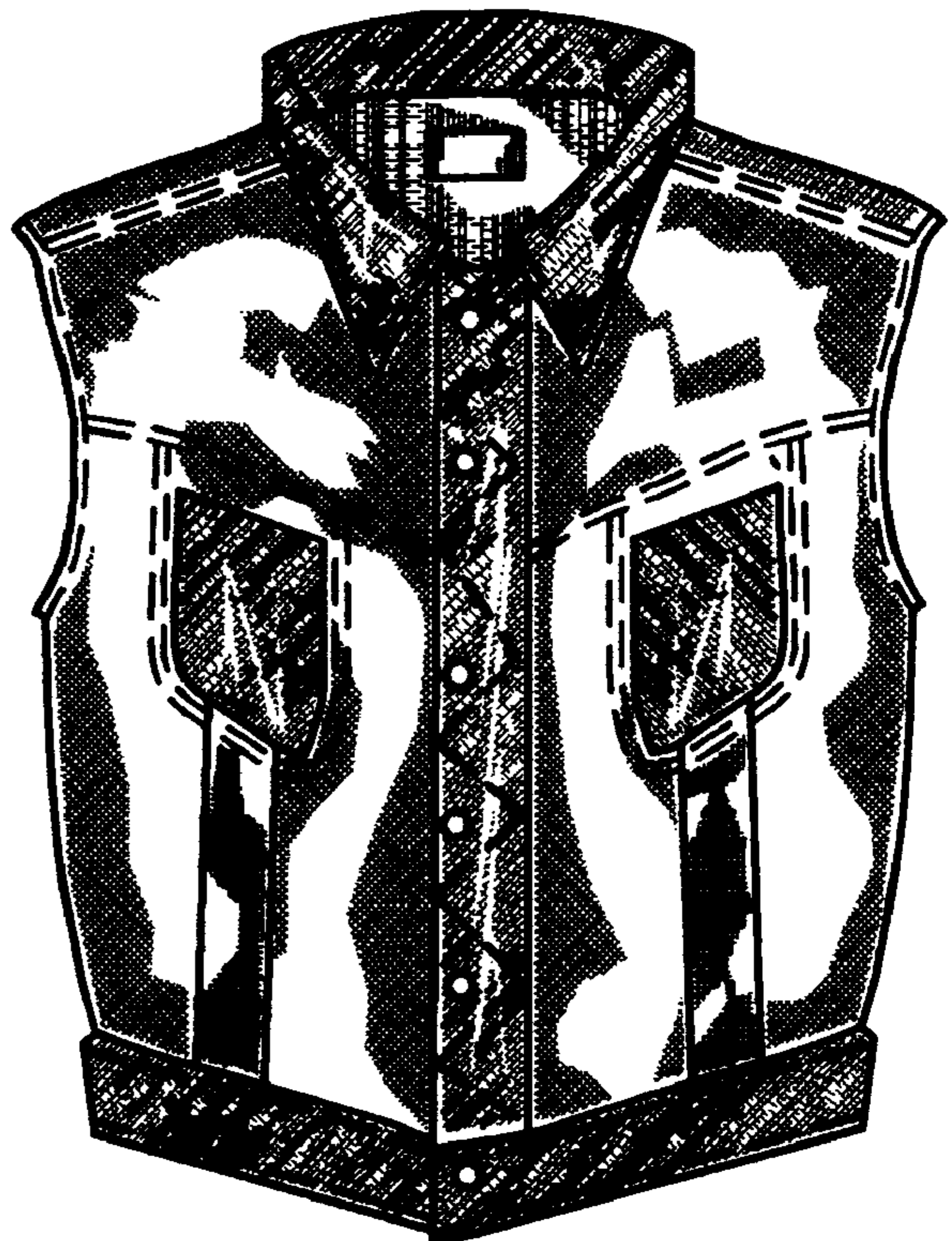
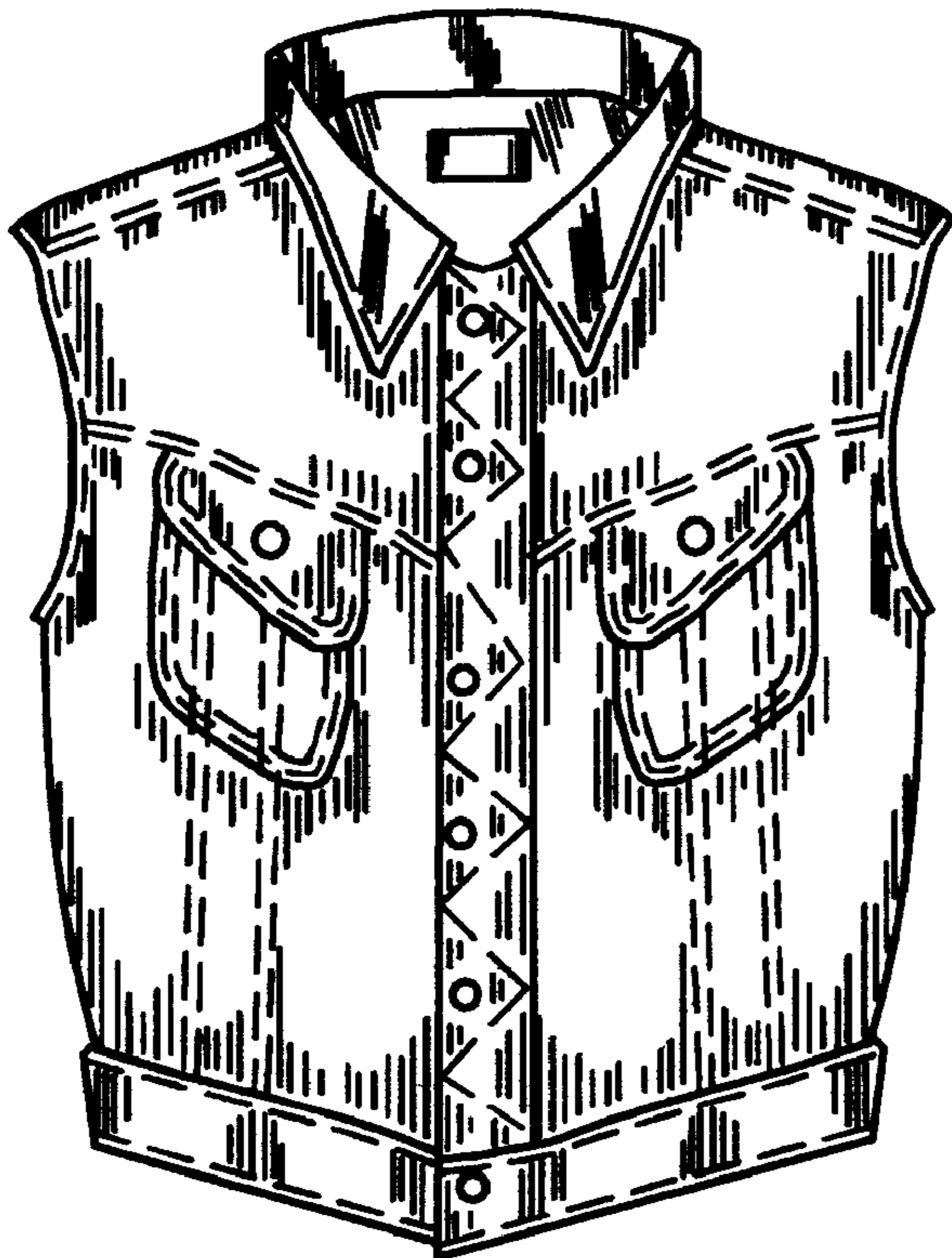
FIG. 2 is a rear perspective view thereof;

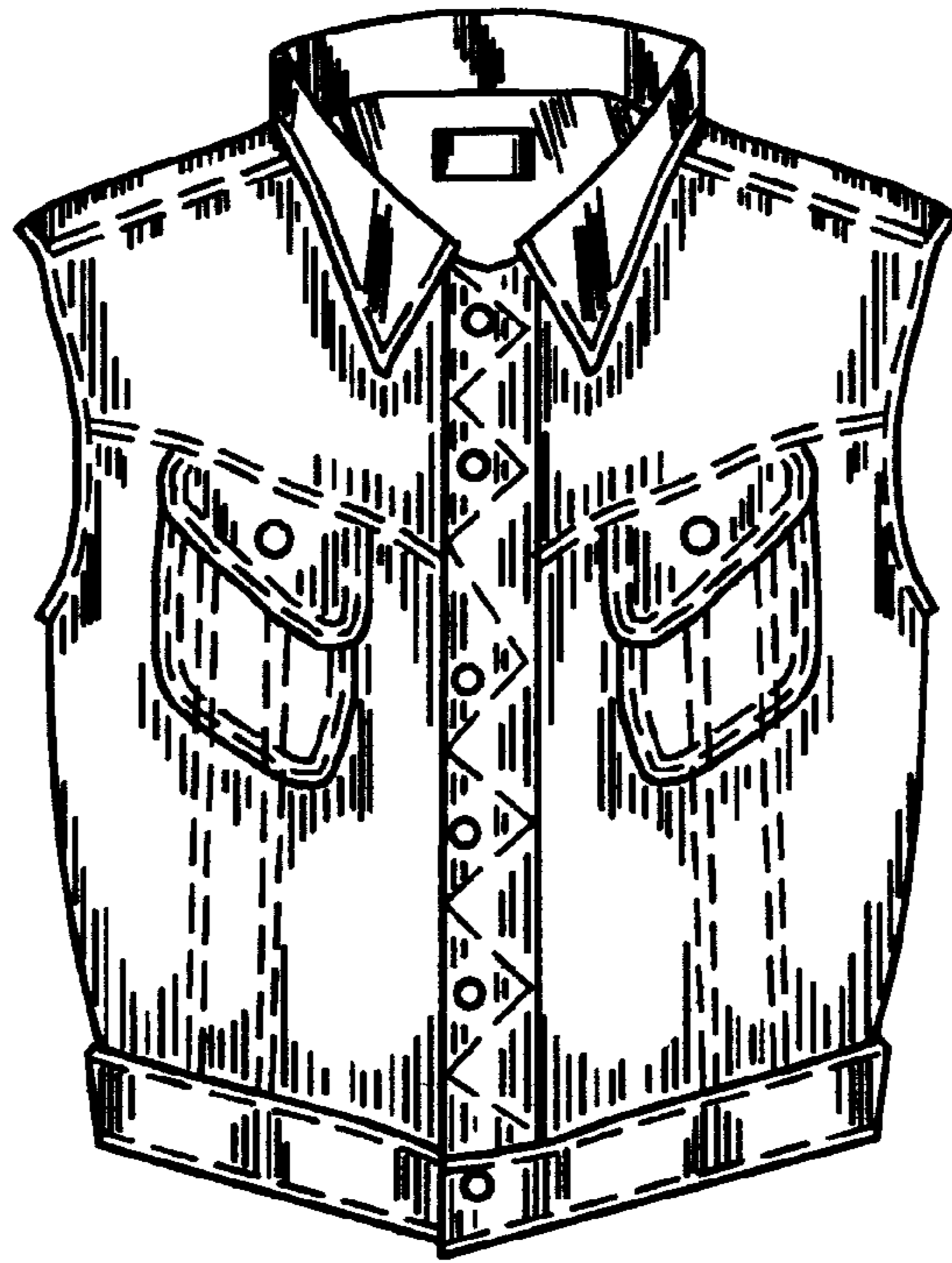

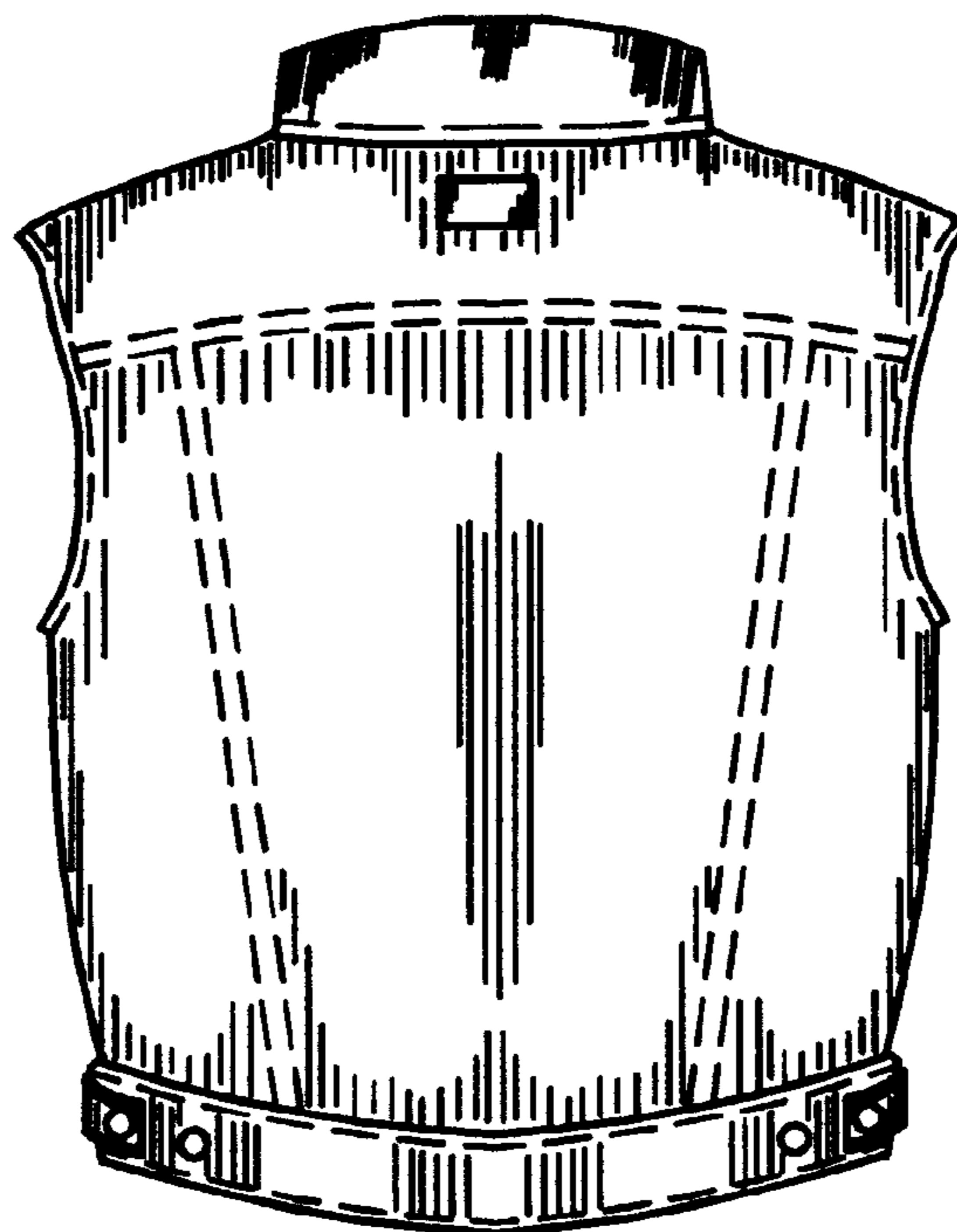

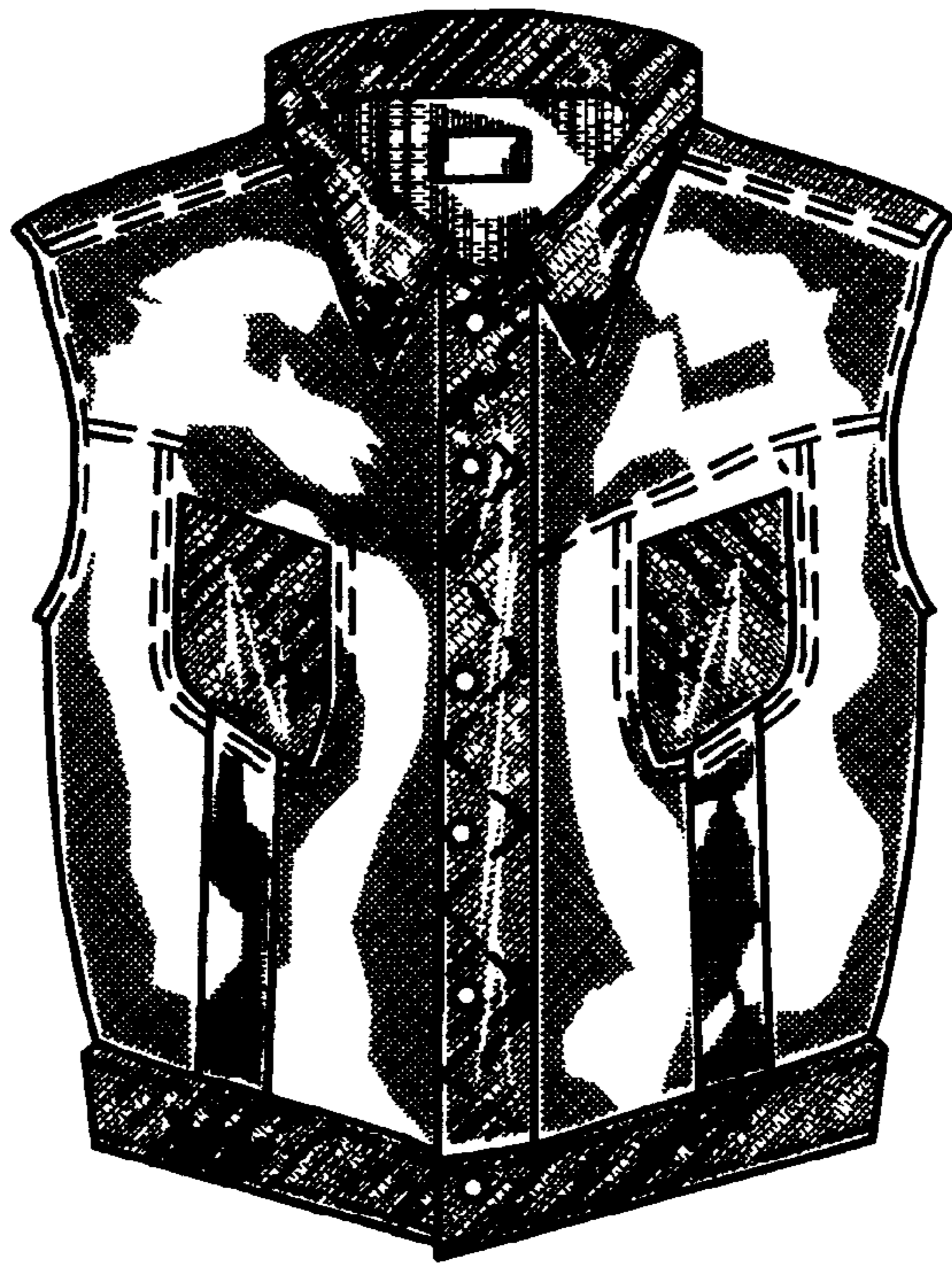

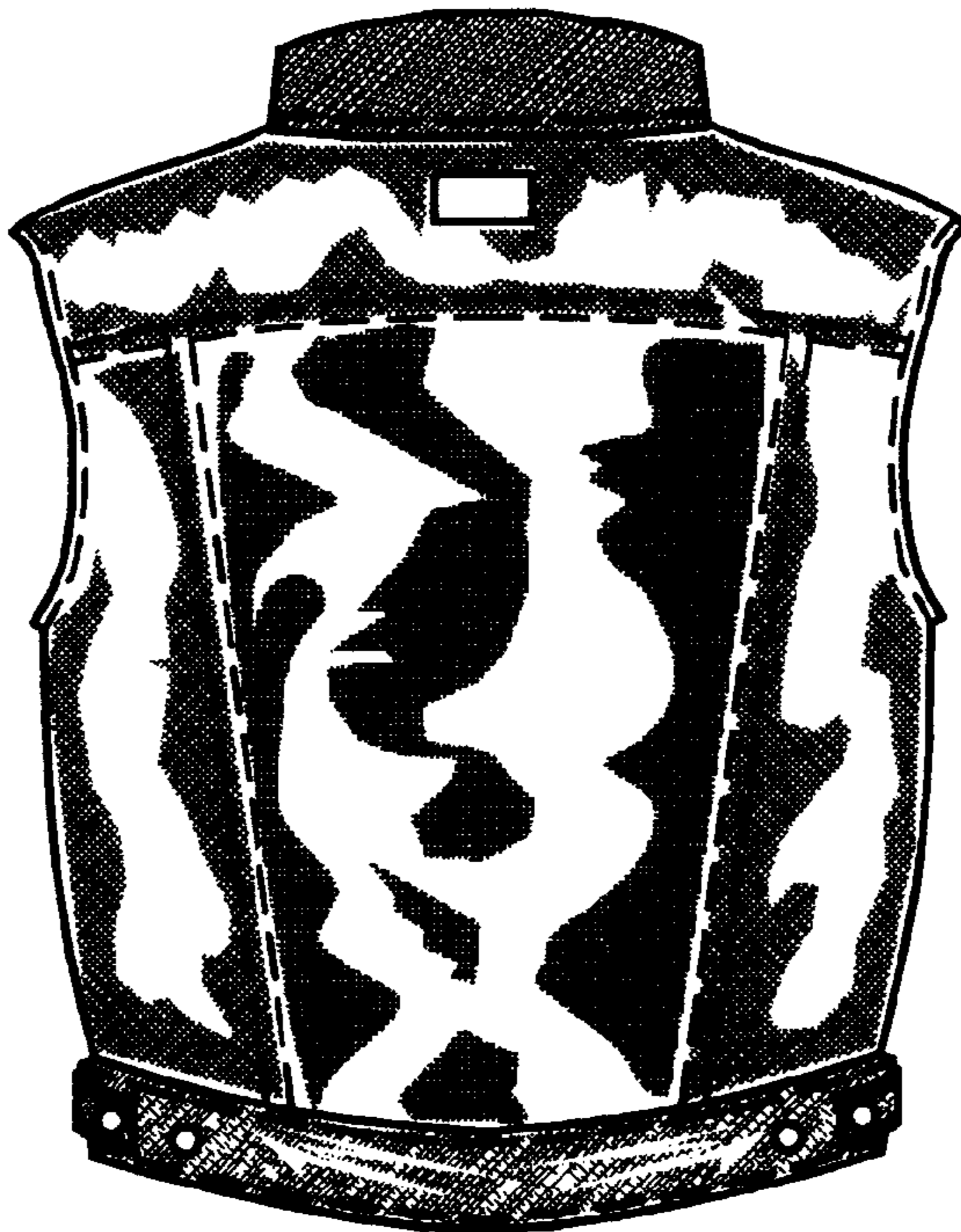
