FIG. 2. is a rear view thereof;

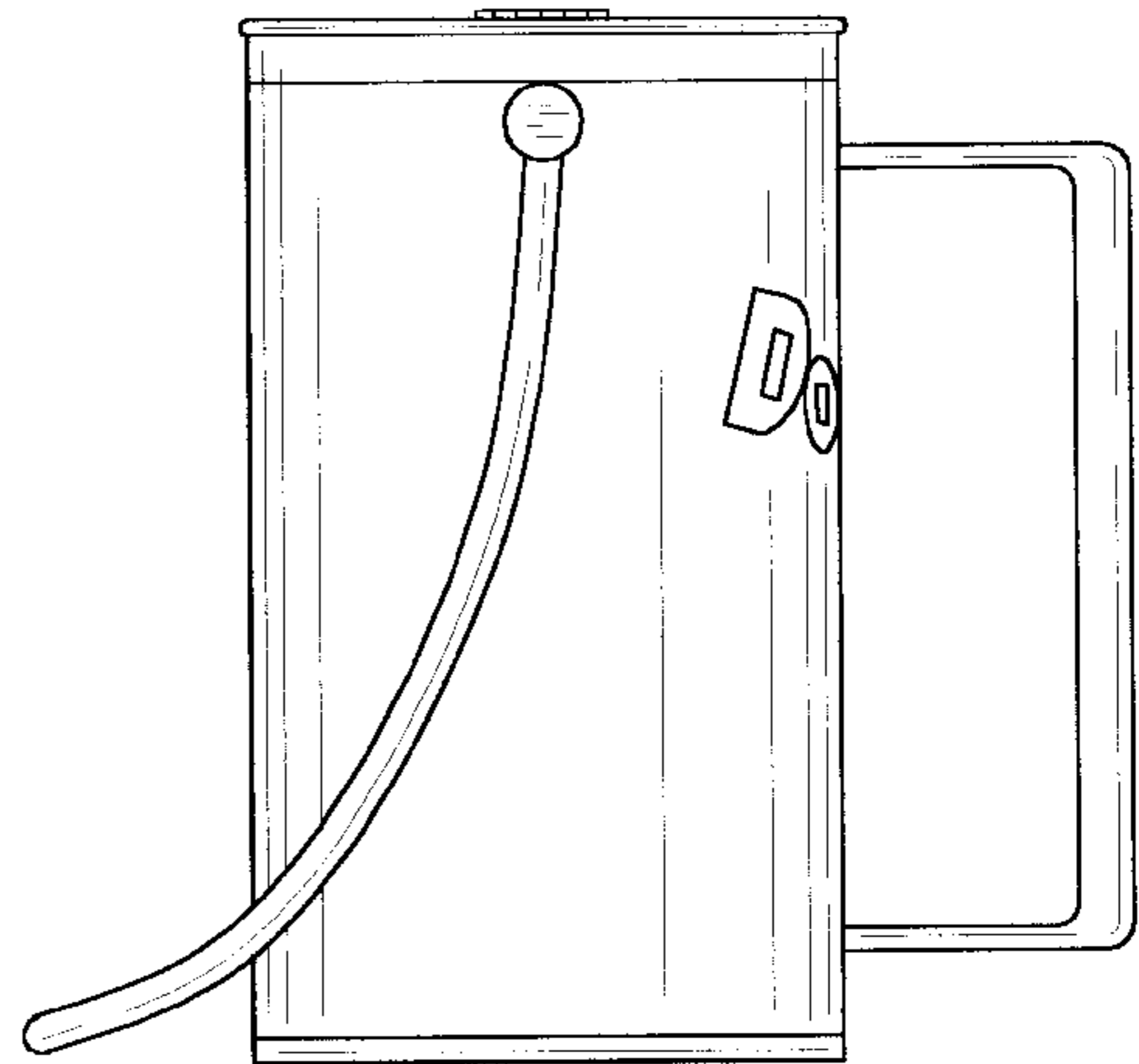
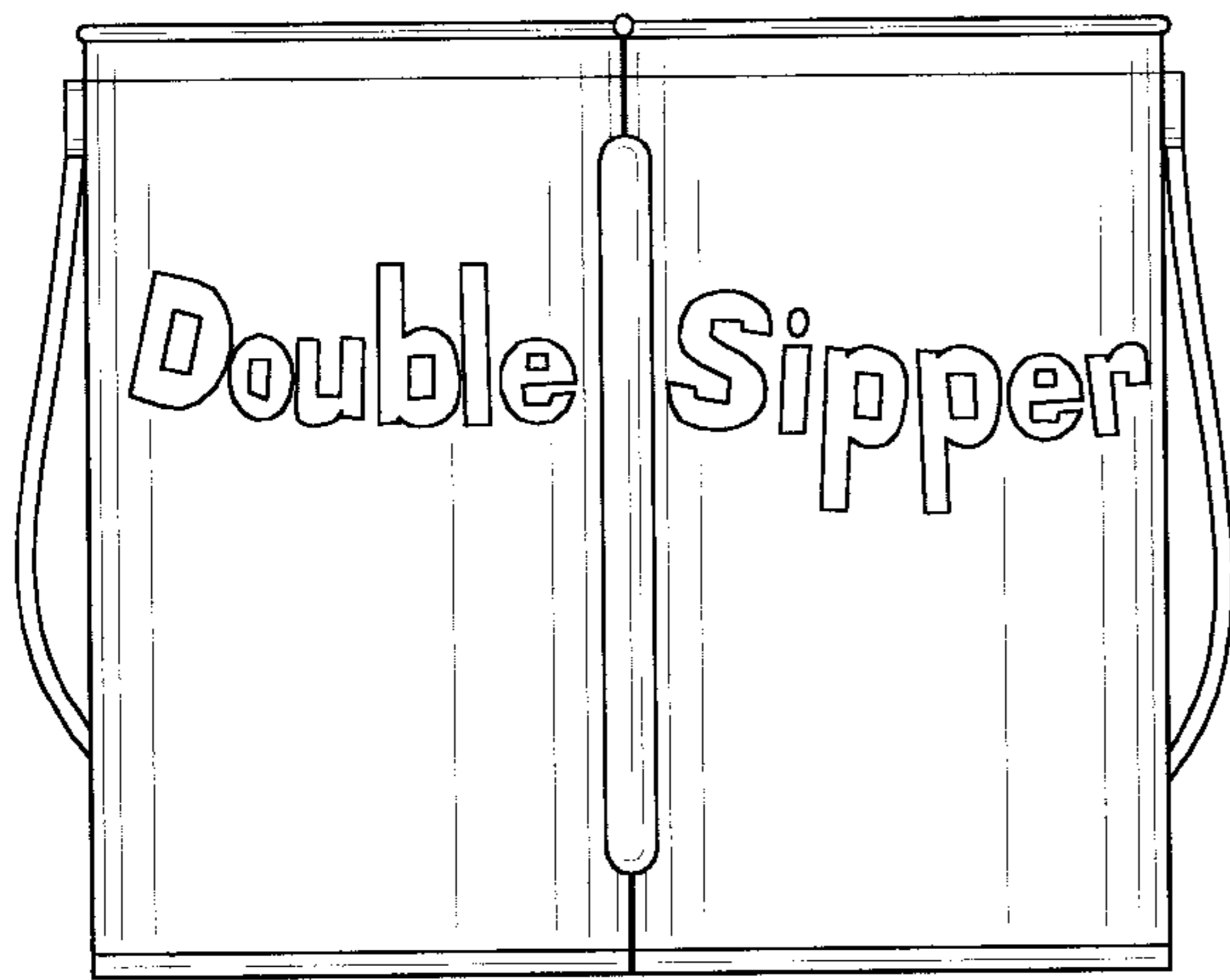
FIG. 3 is a left view thereof;

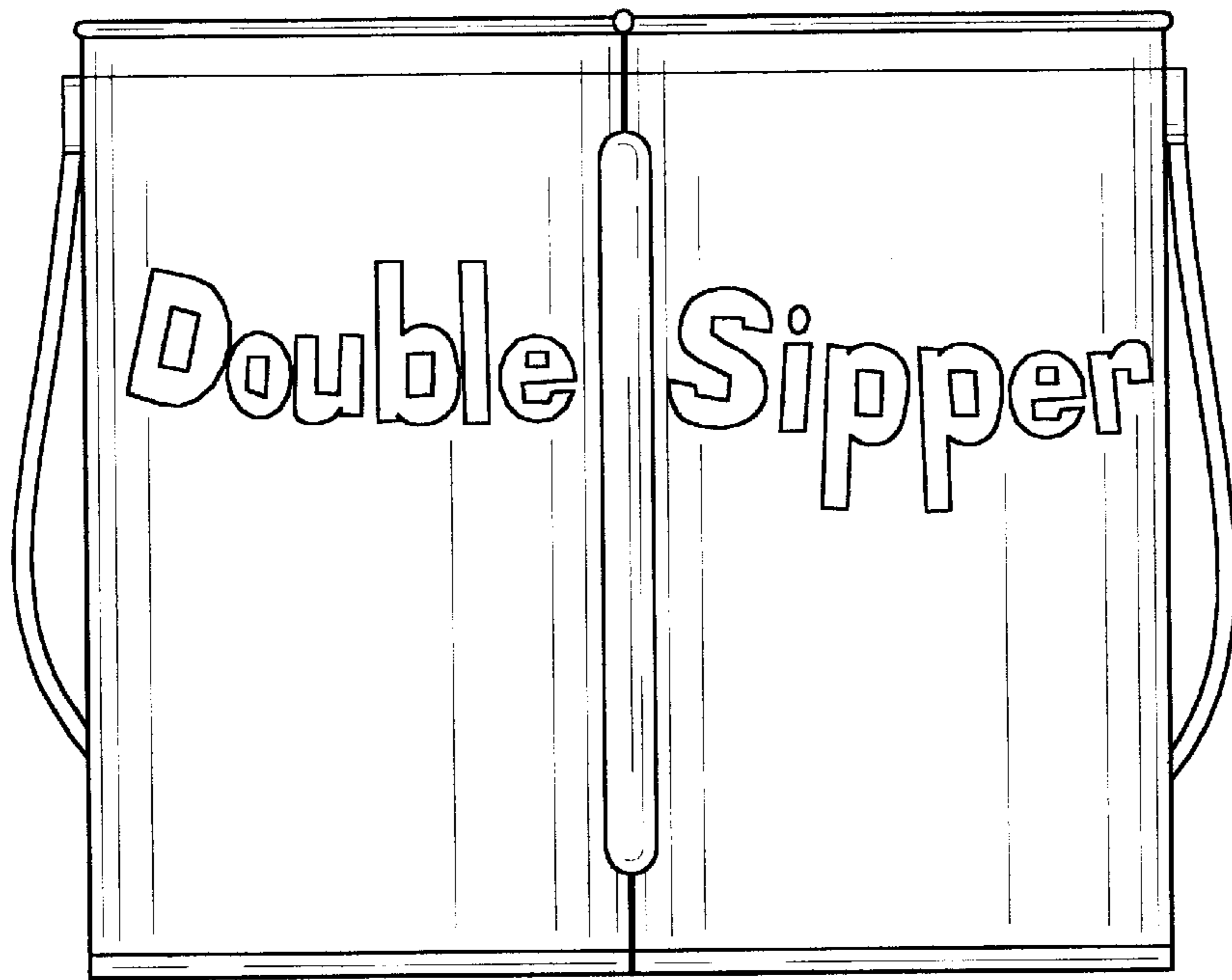

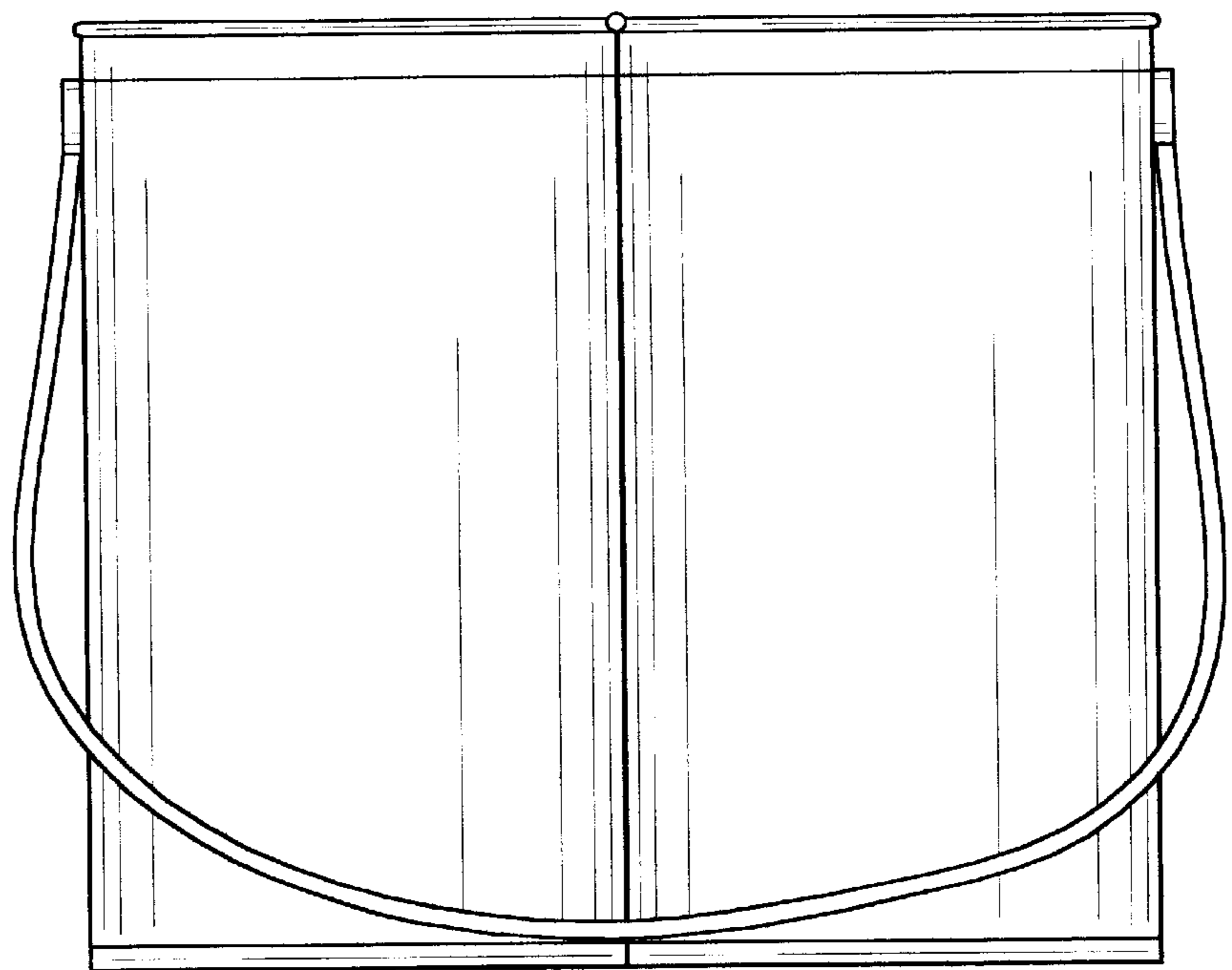

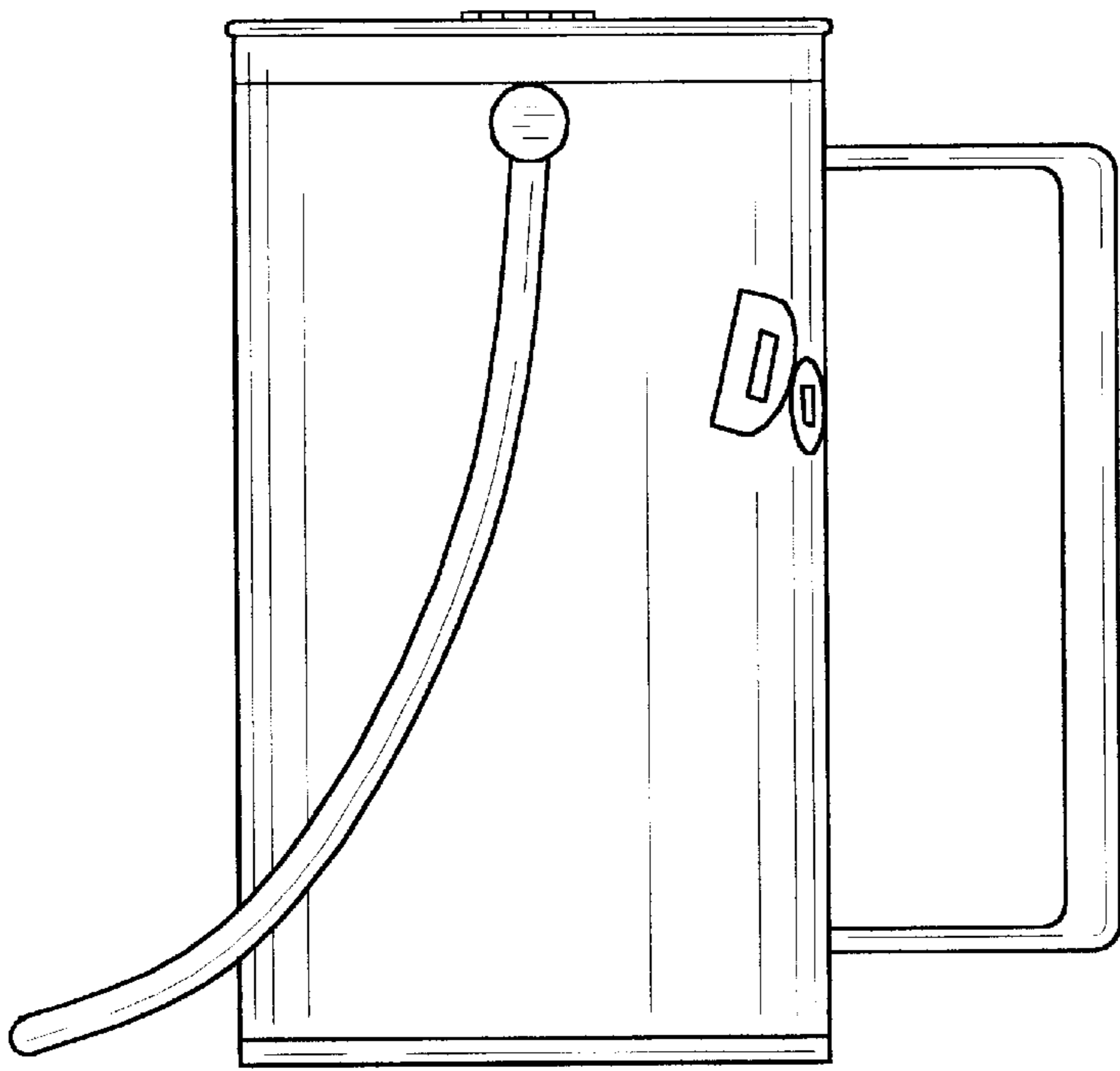

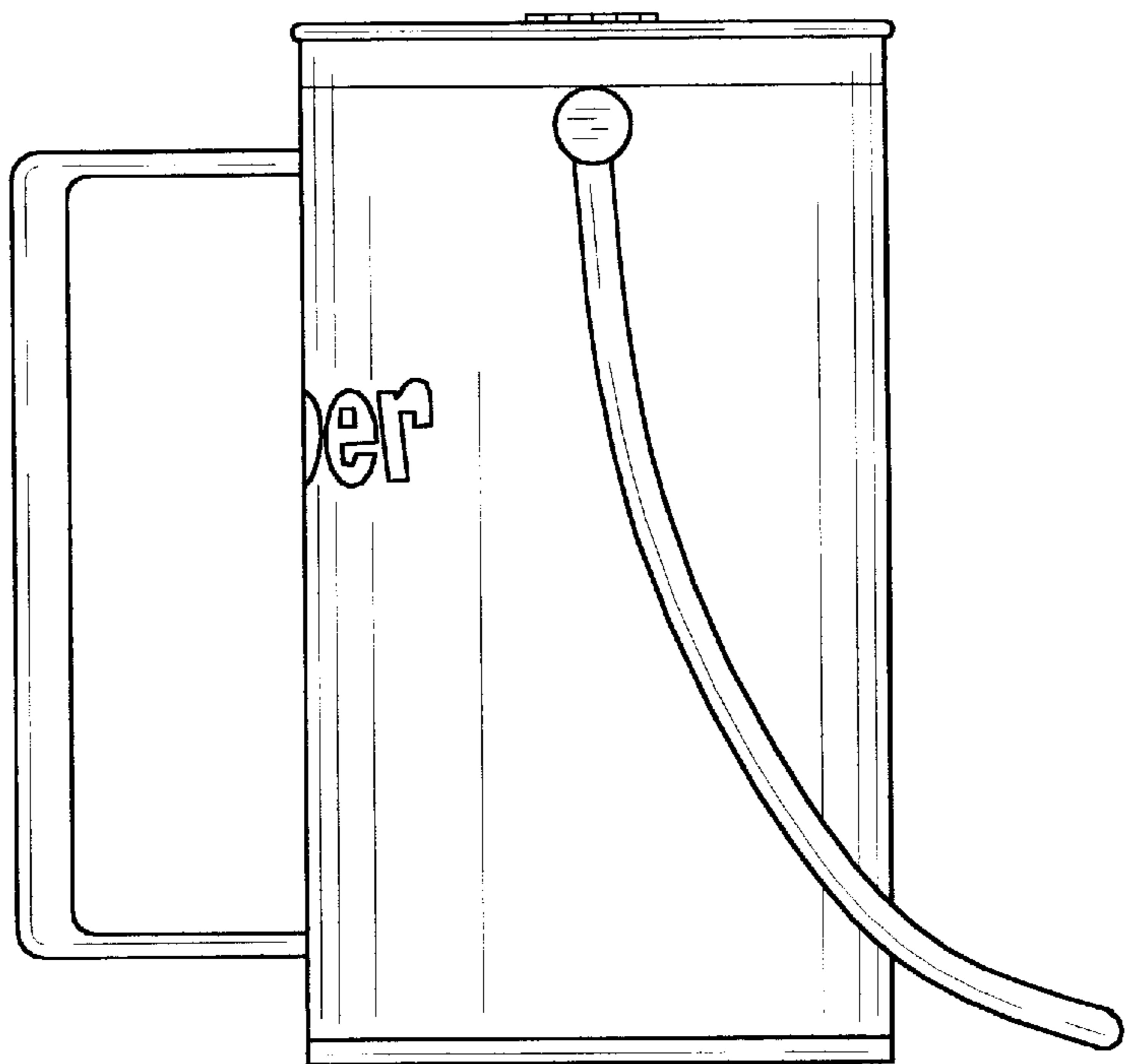

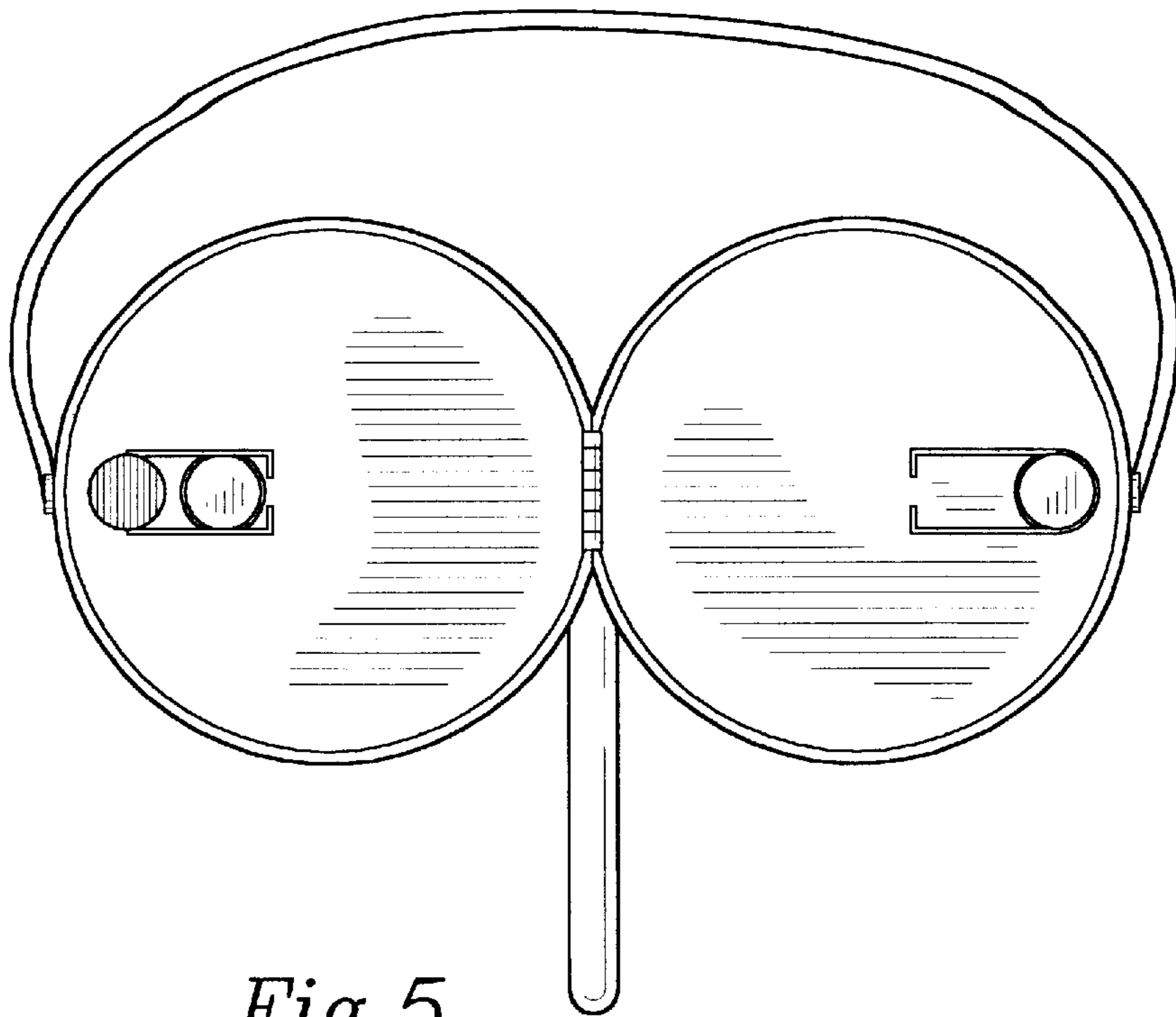

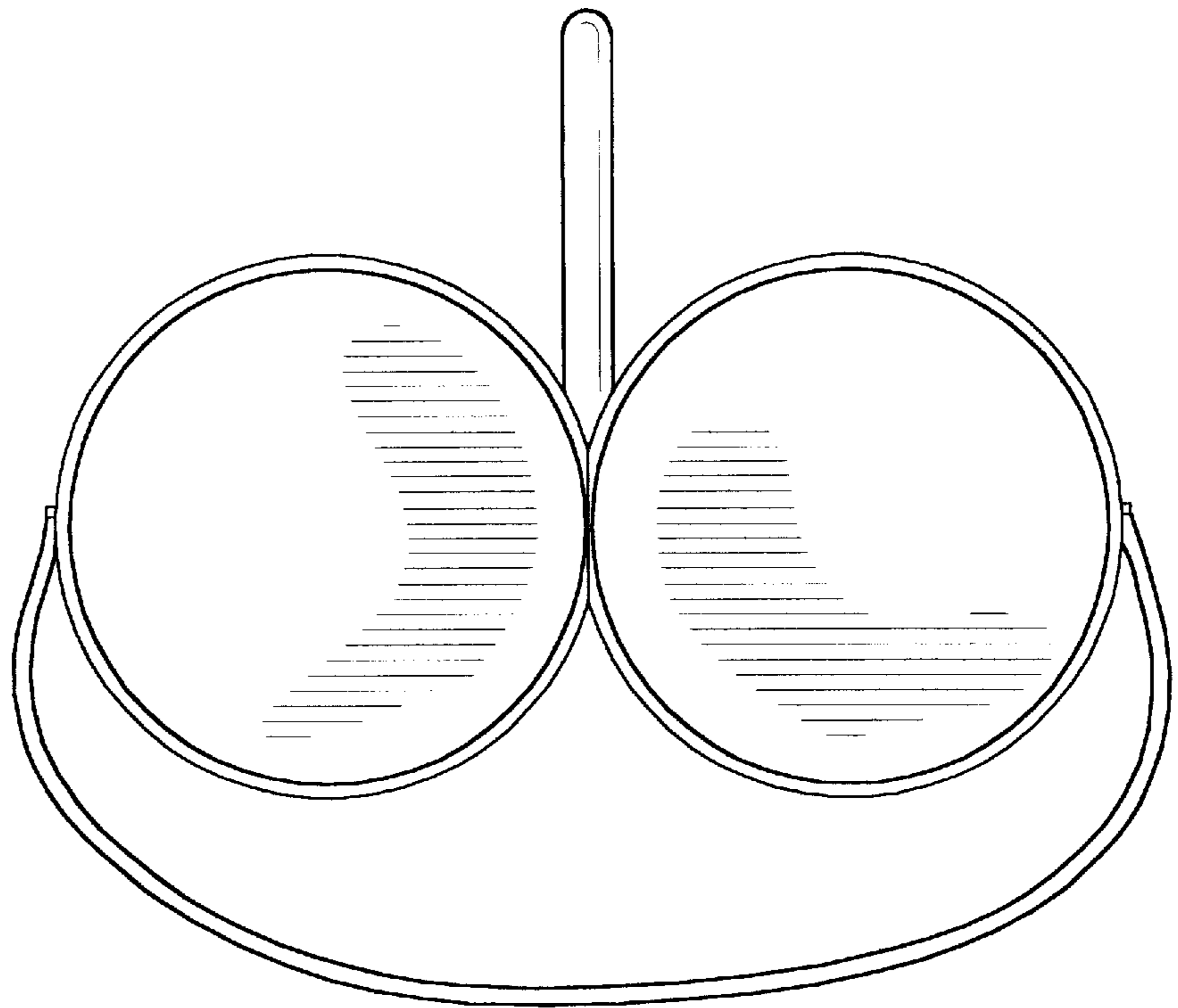
