DESCRIPTION

FIG. 1 is a perspective view the dial indicator torque wrench showing our new design;

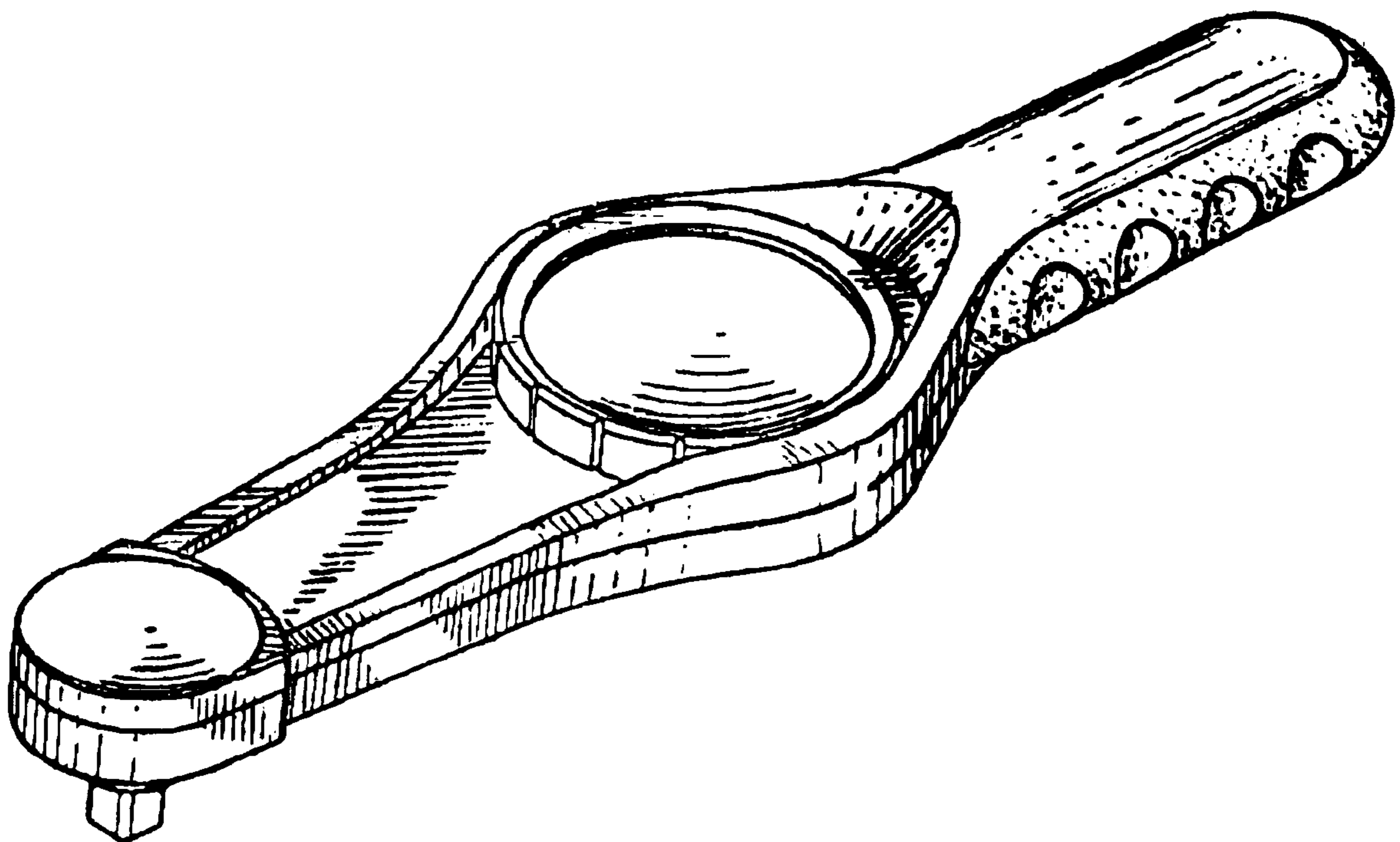

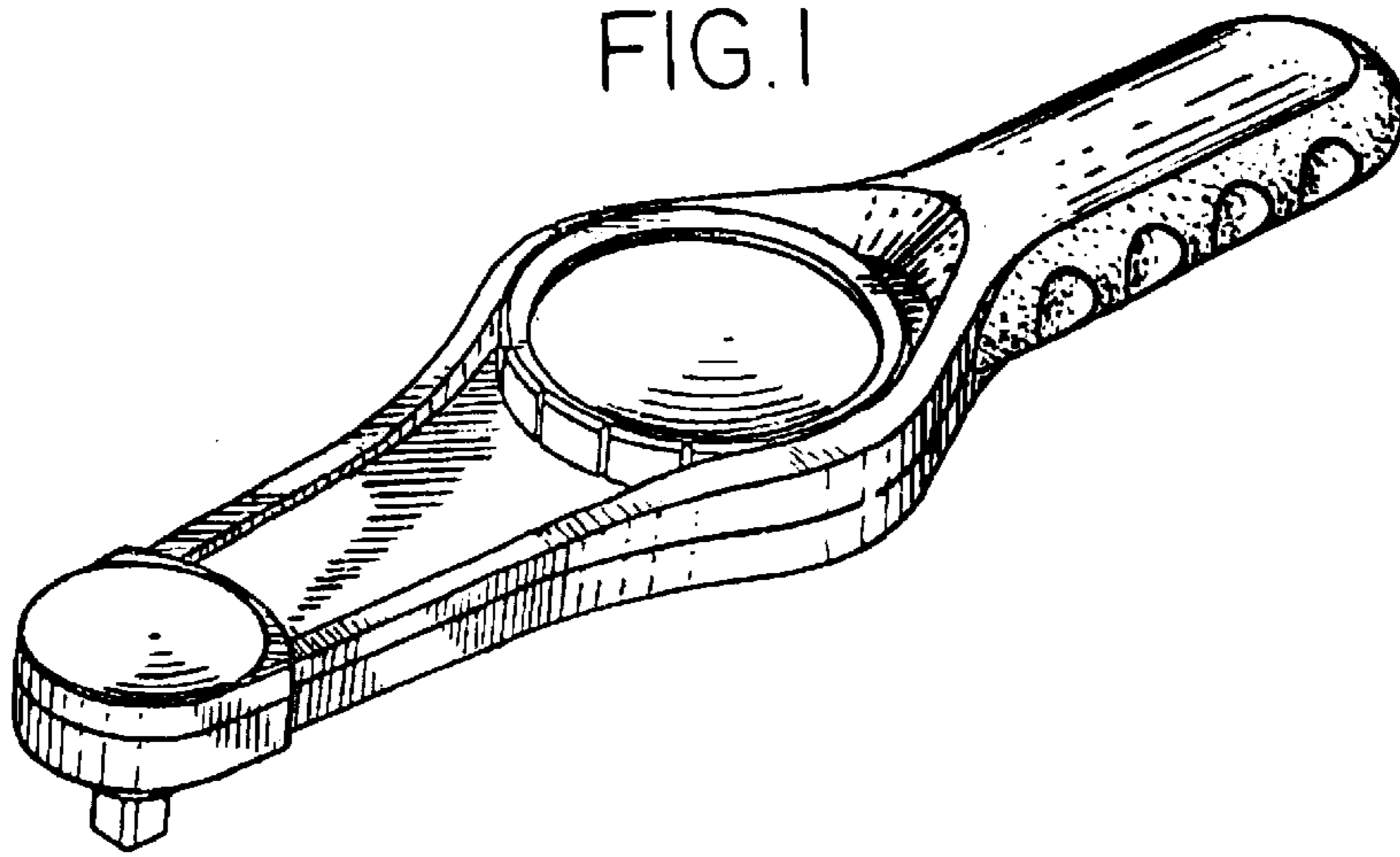

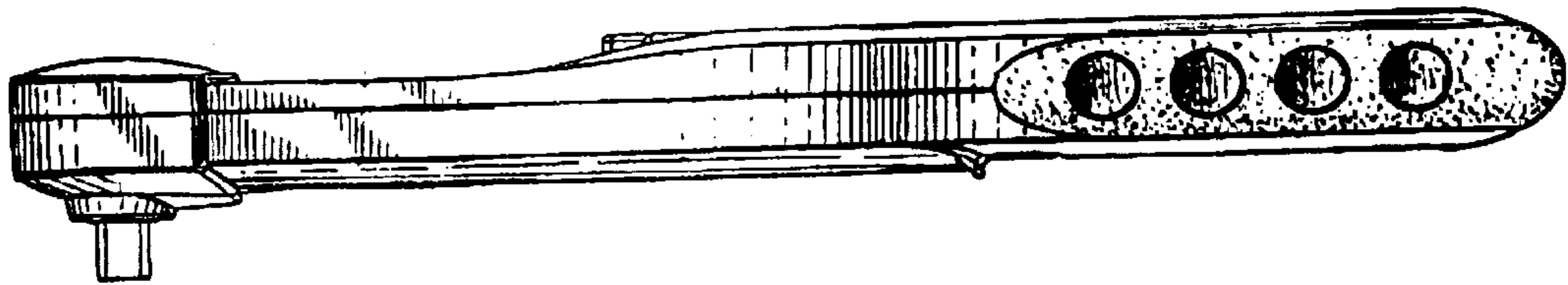

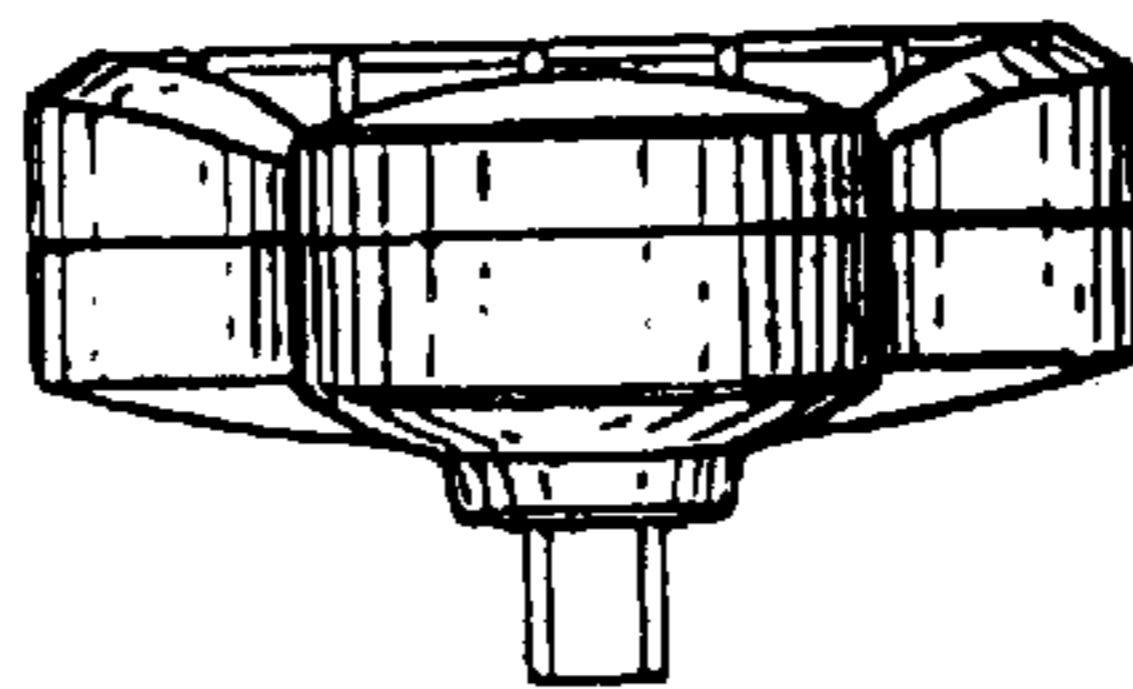

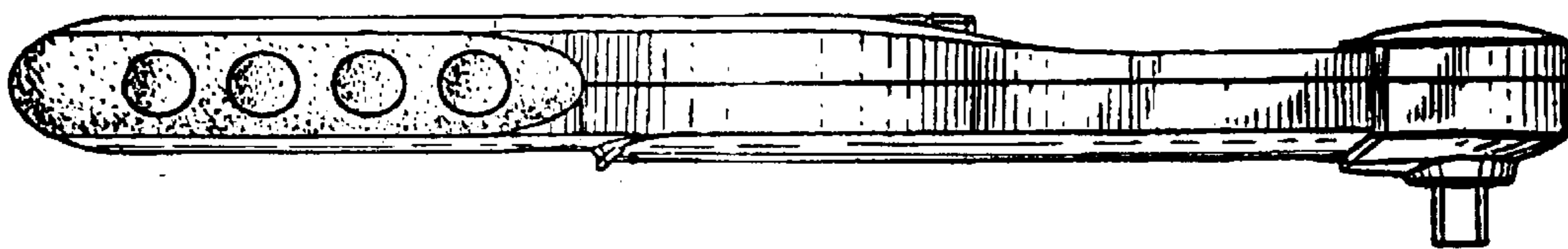

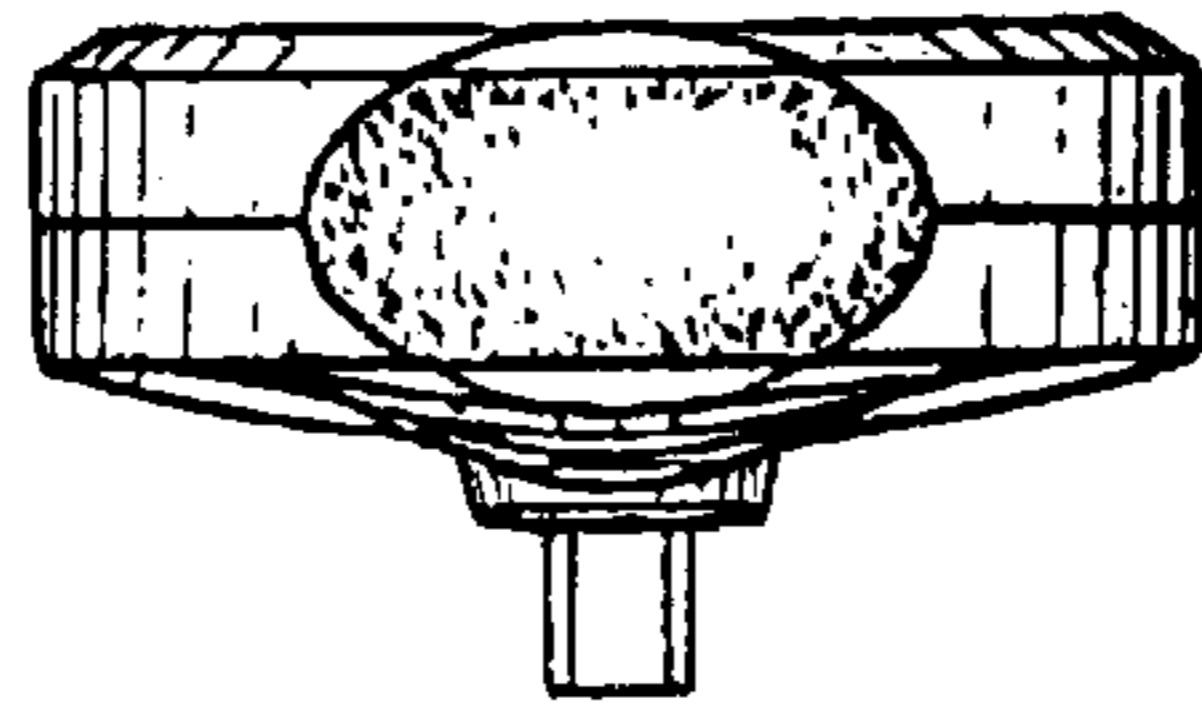

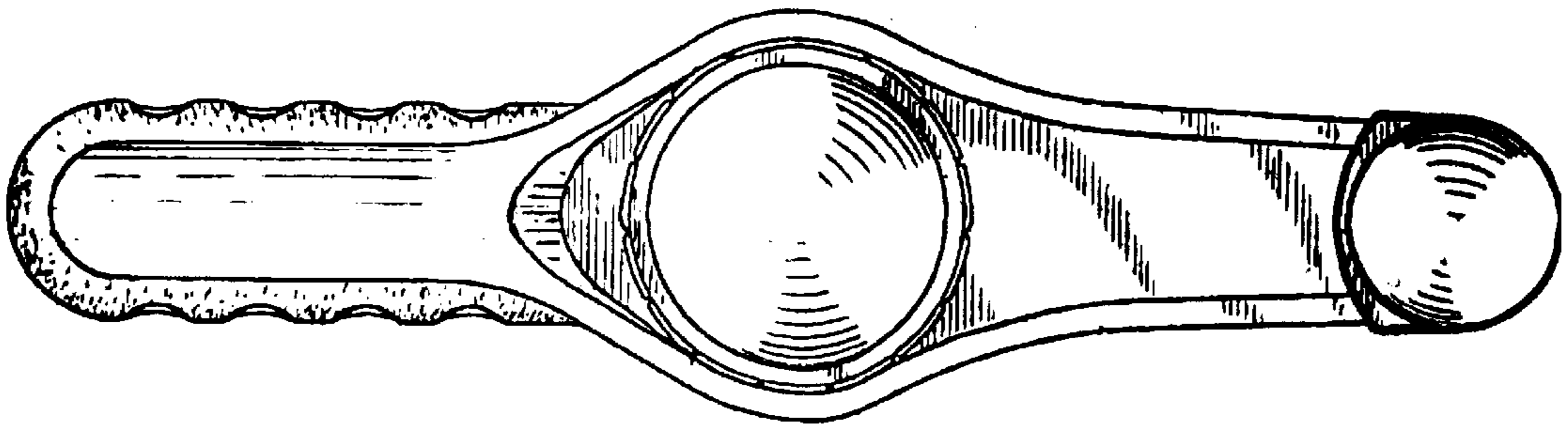
