FIG. 9 is a bottom view thereof.

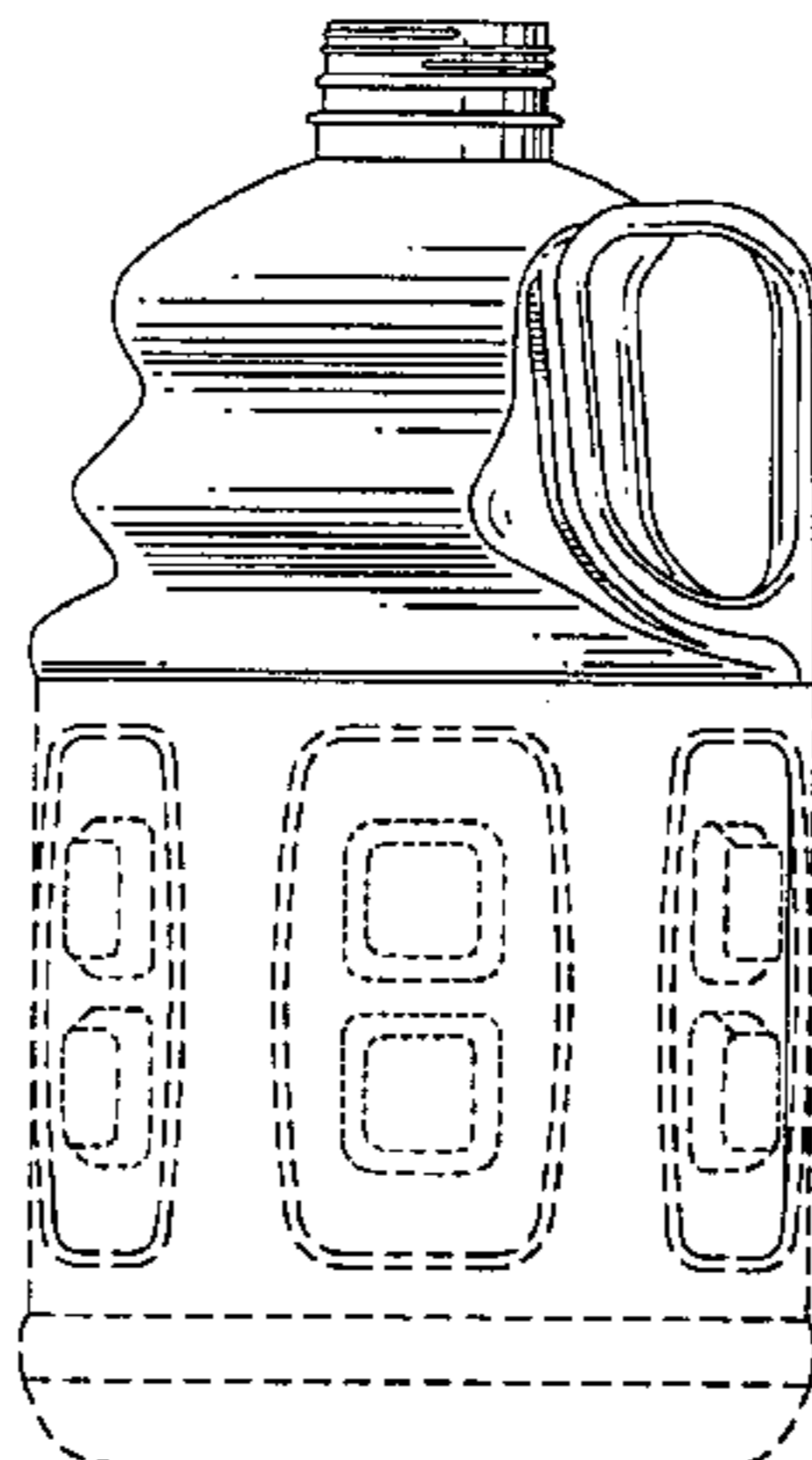

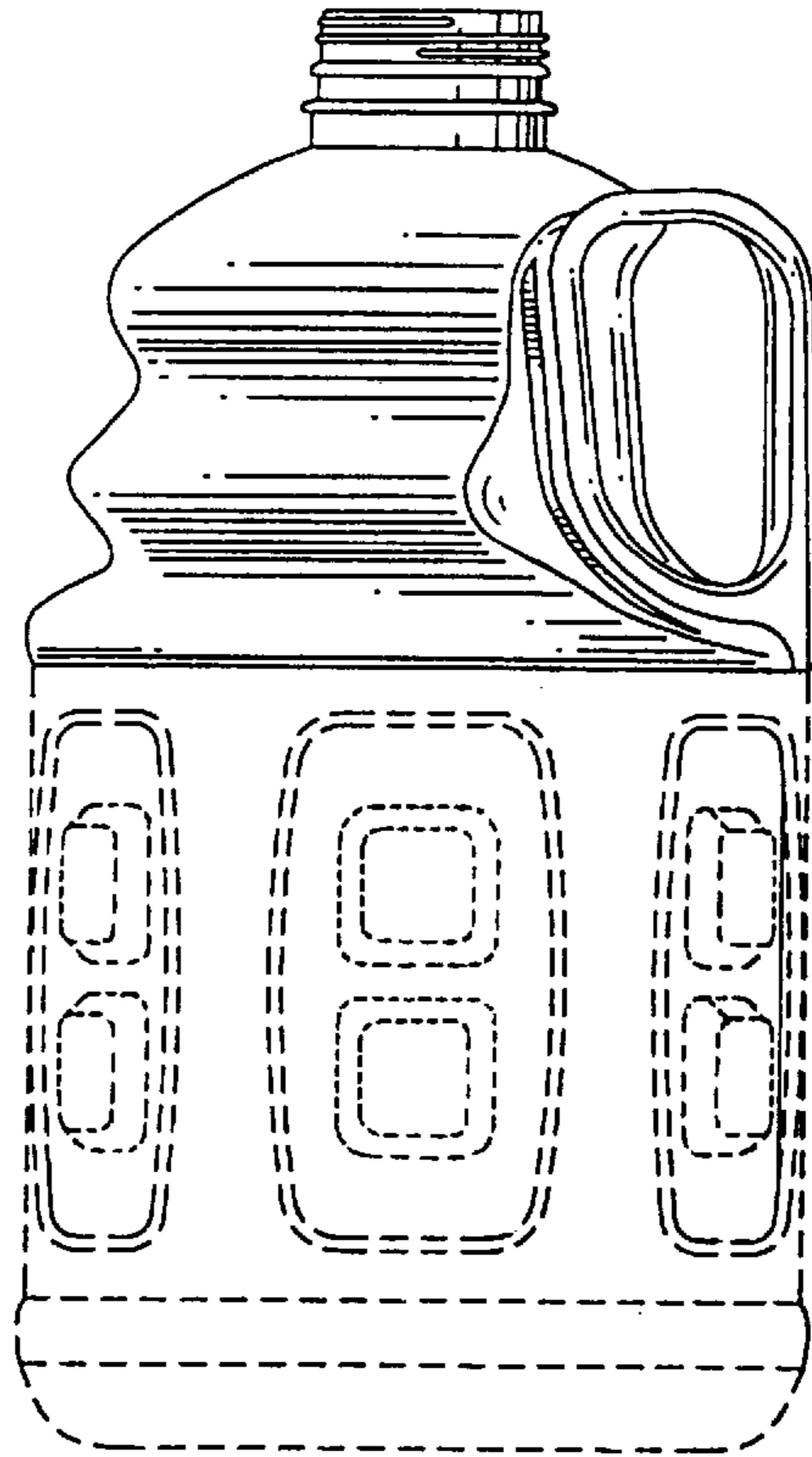

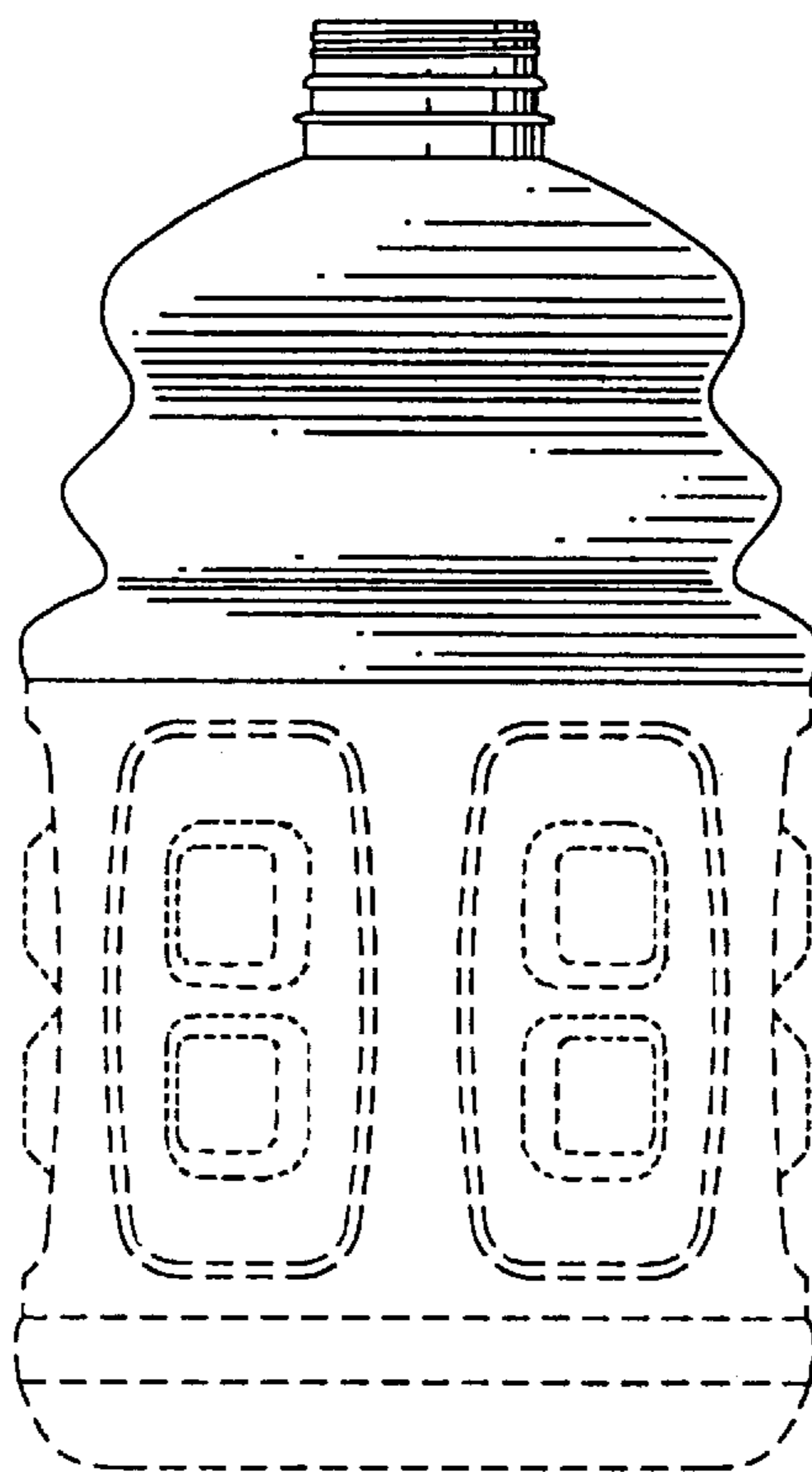

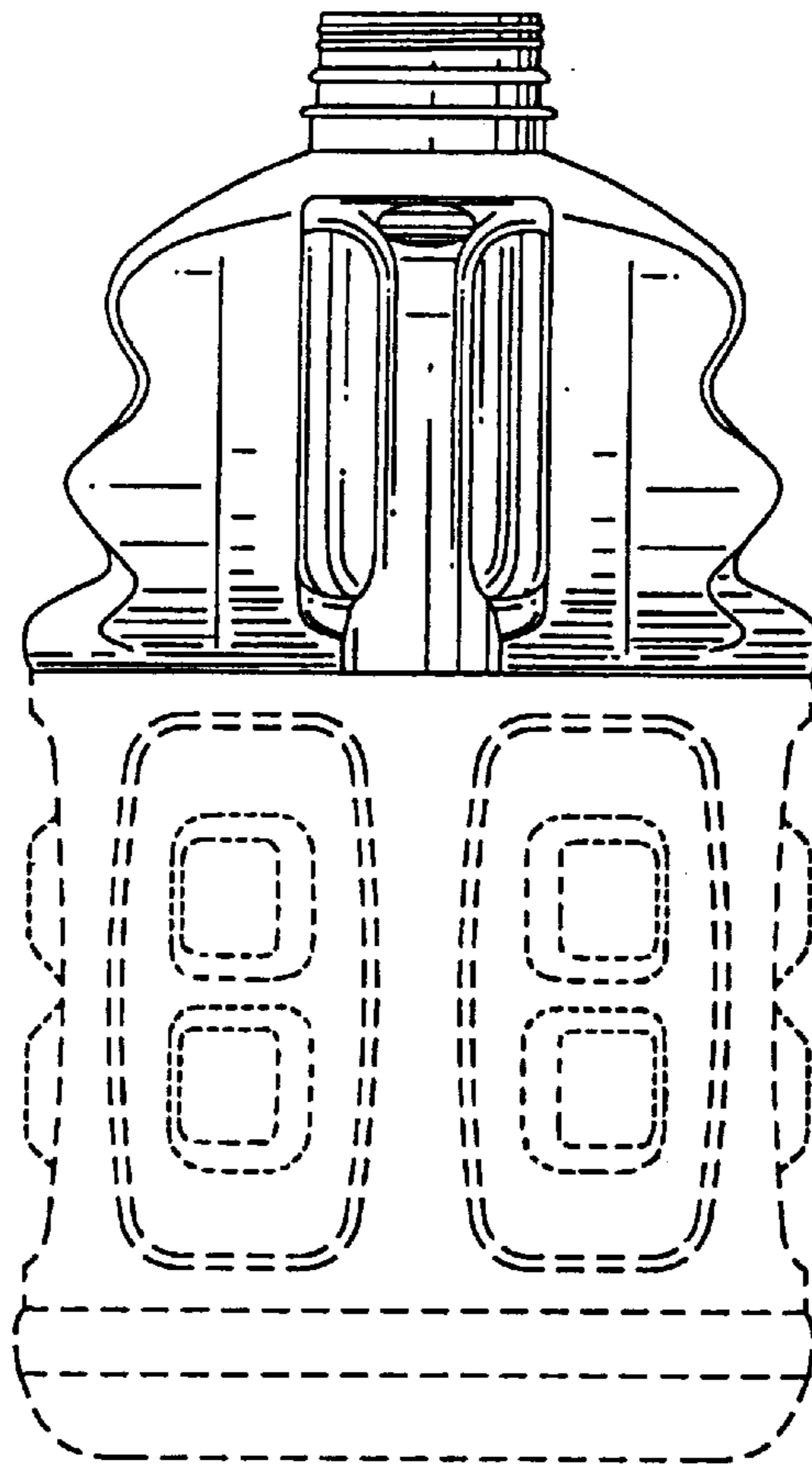

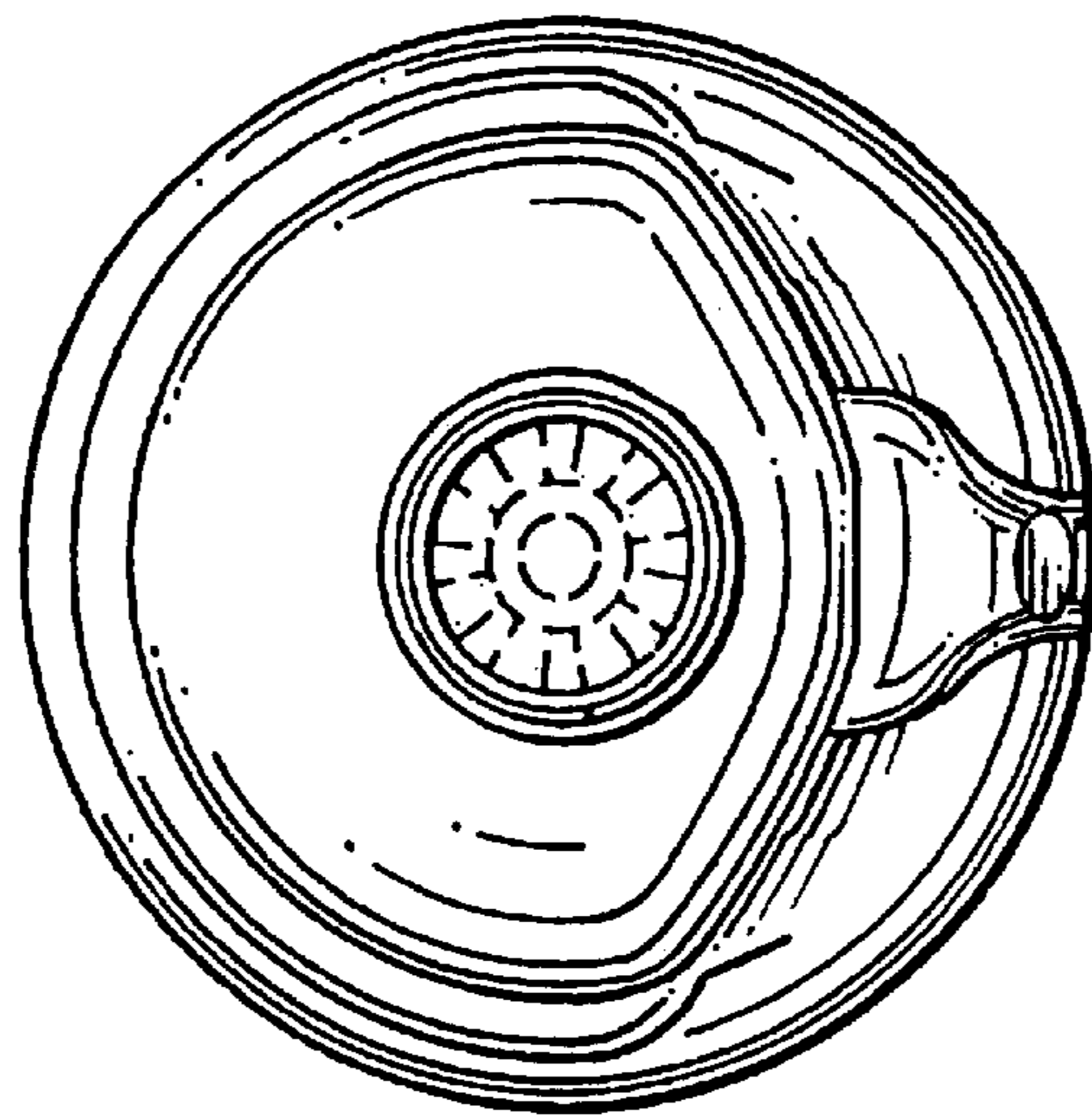

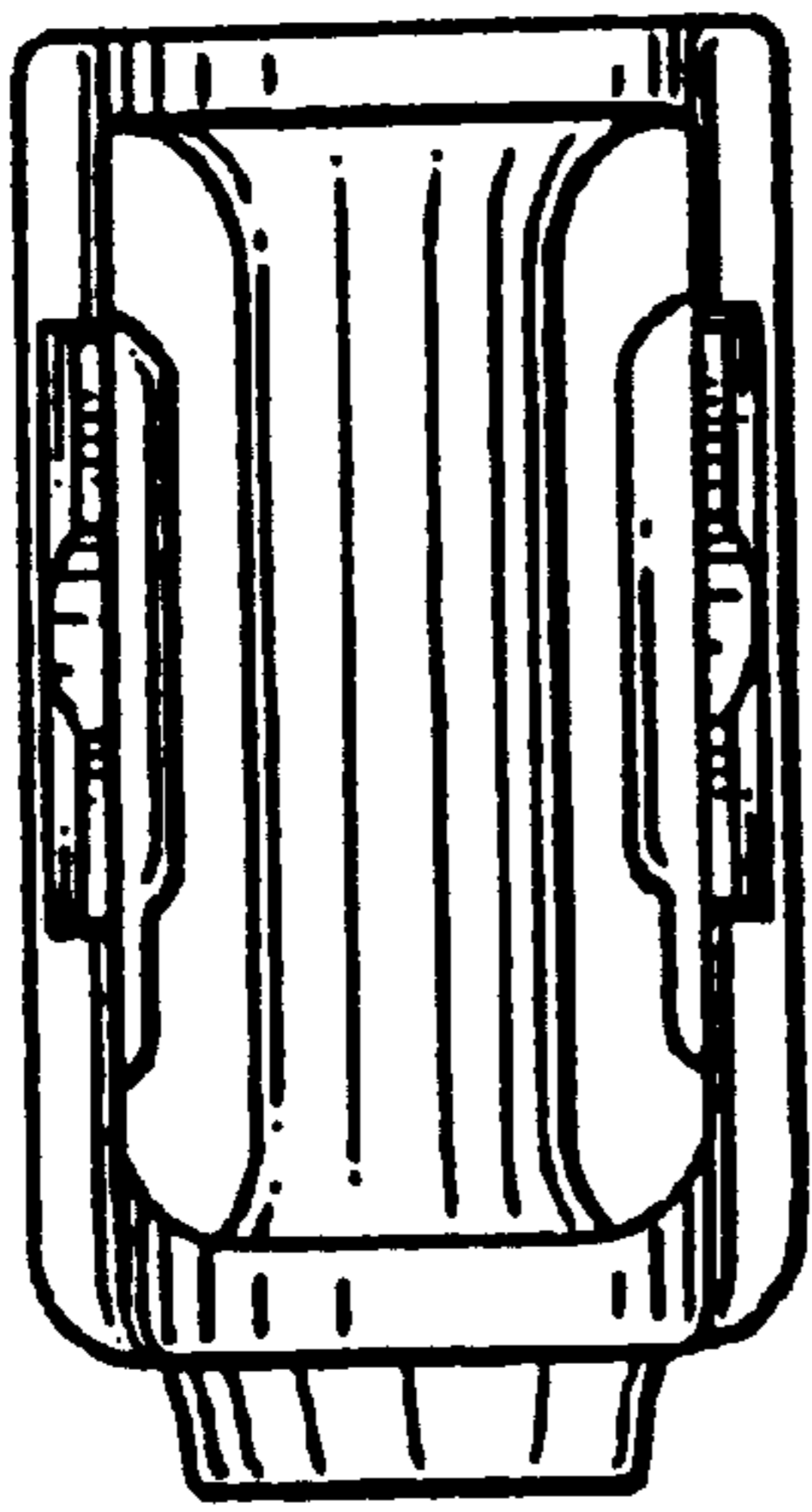

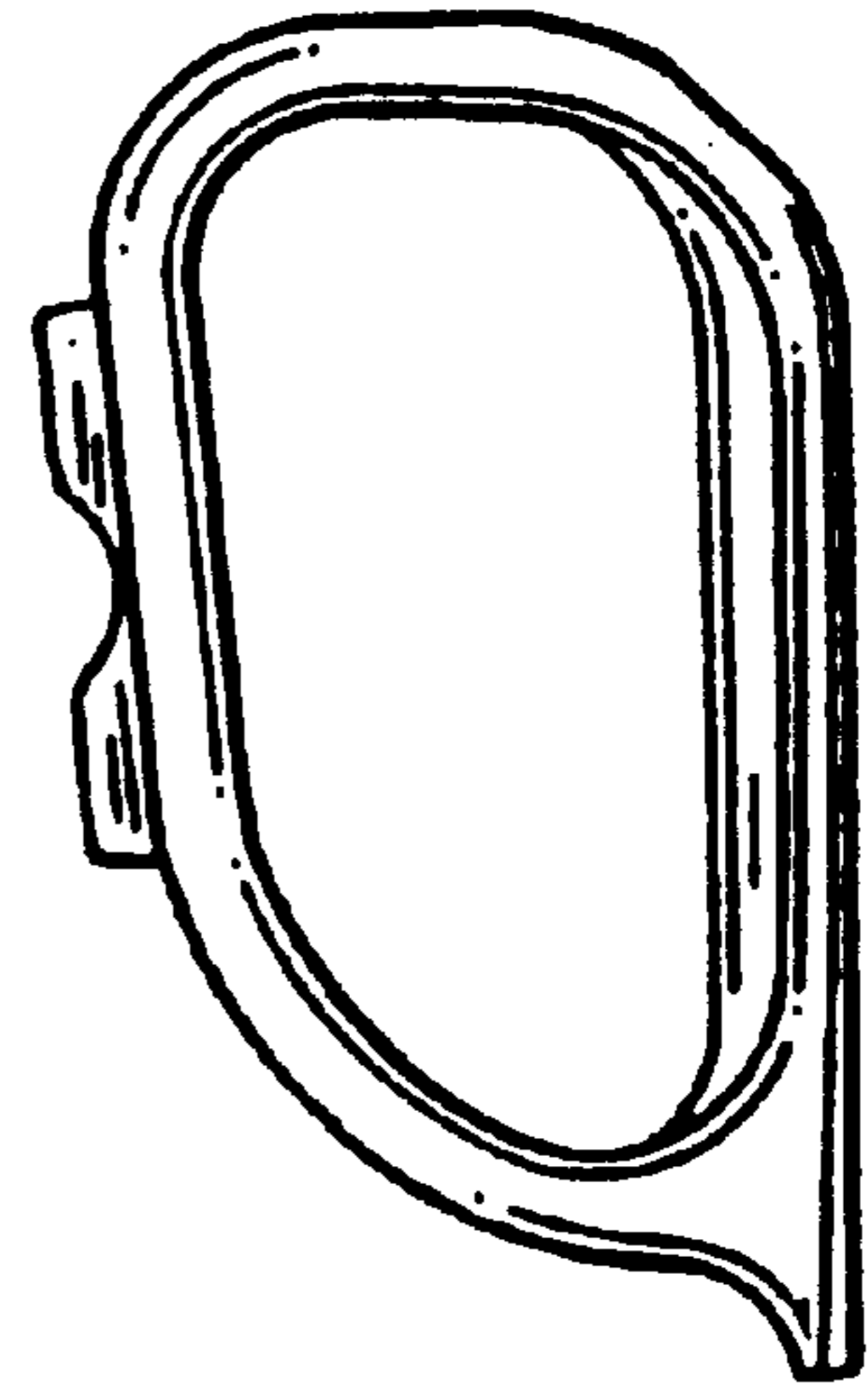

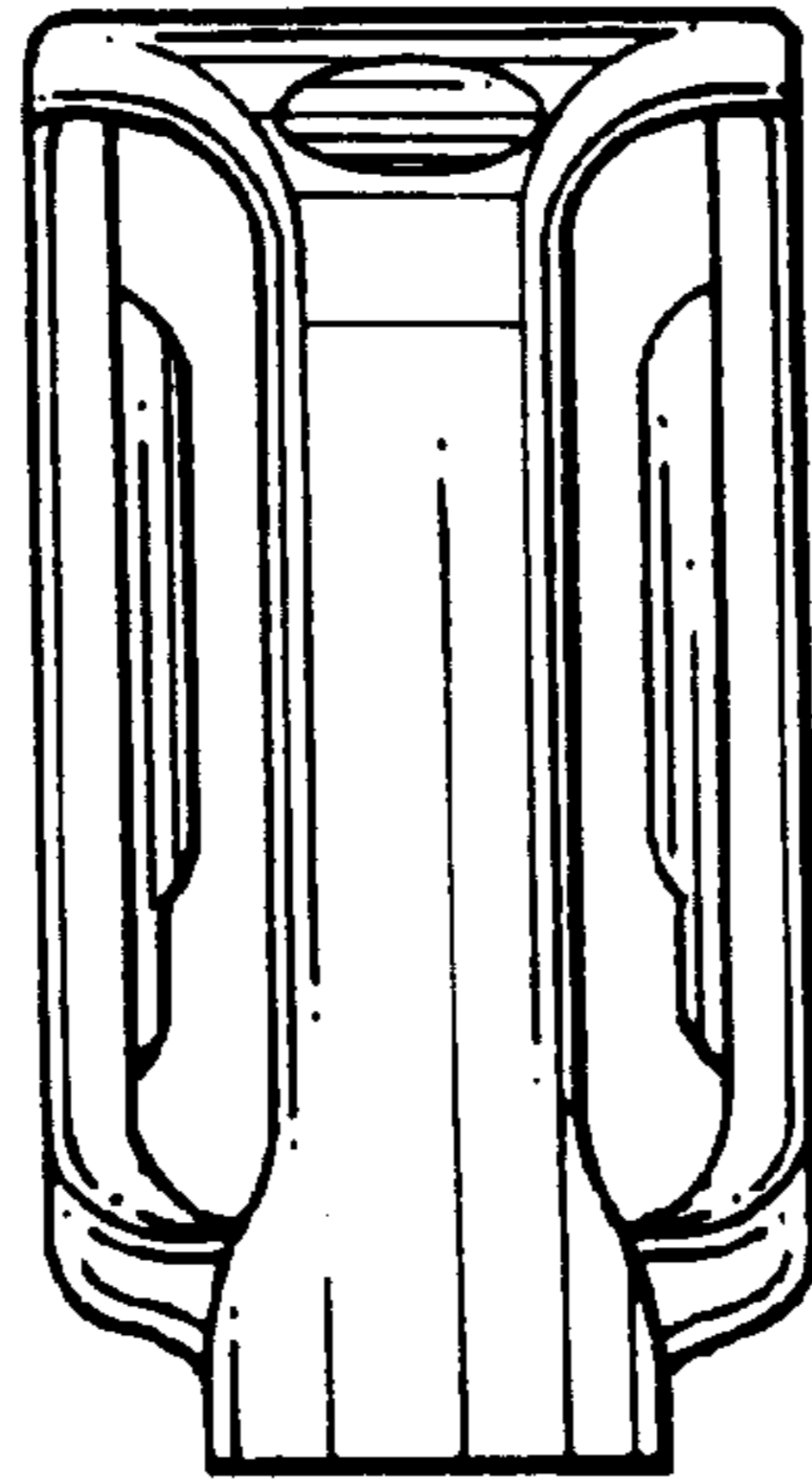

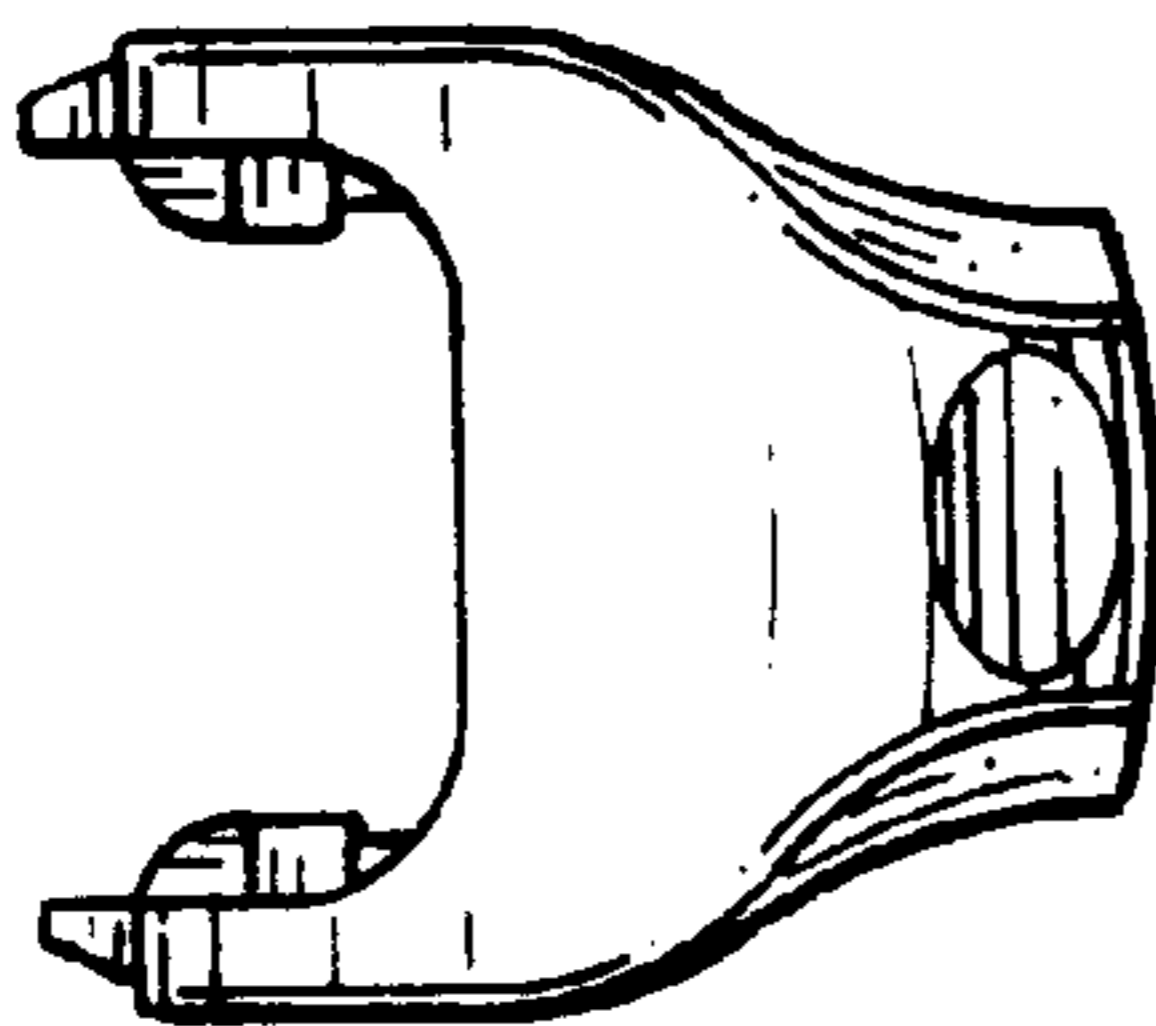

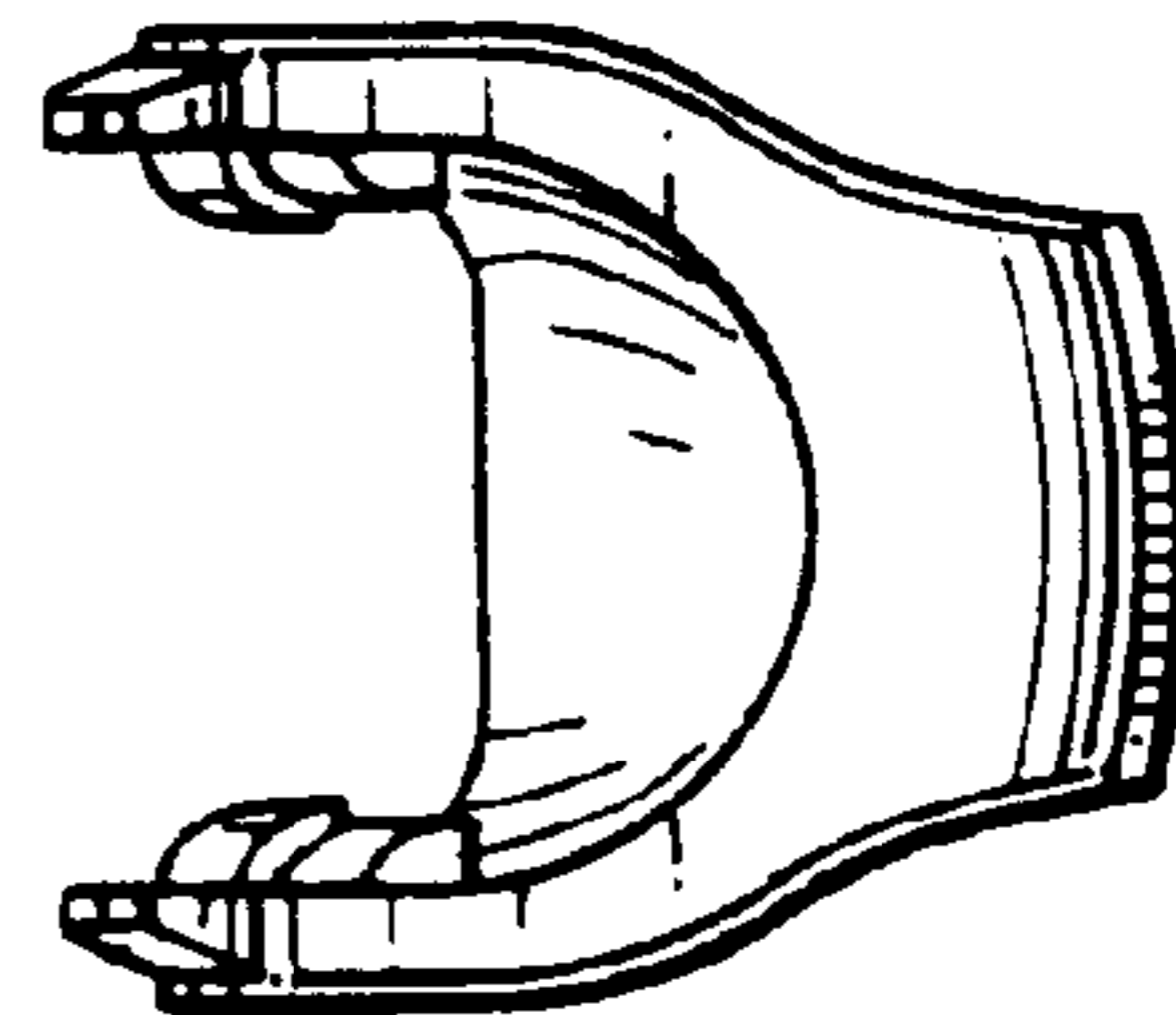
