The ornamental design for a communication device, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and left side perspective view of a communication device in an opened position;

FIG. 2 is a top, front and left side perspective view of the communication device of FIG. 1, but in a closed position;

FIG. 3 is a left side elevation view of the communication device of FIG. 2;

FIG. 4 is a top plan view of the communication device of FIG. 2;

FIG. 5 is a front elevation view of the communication device of FIG. 2;

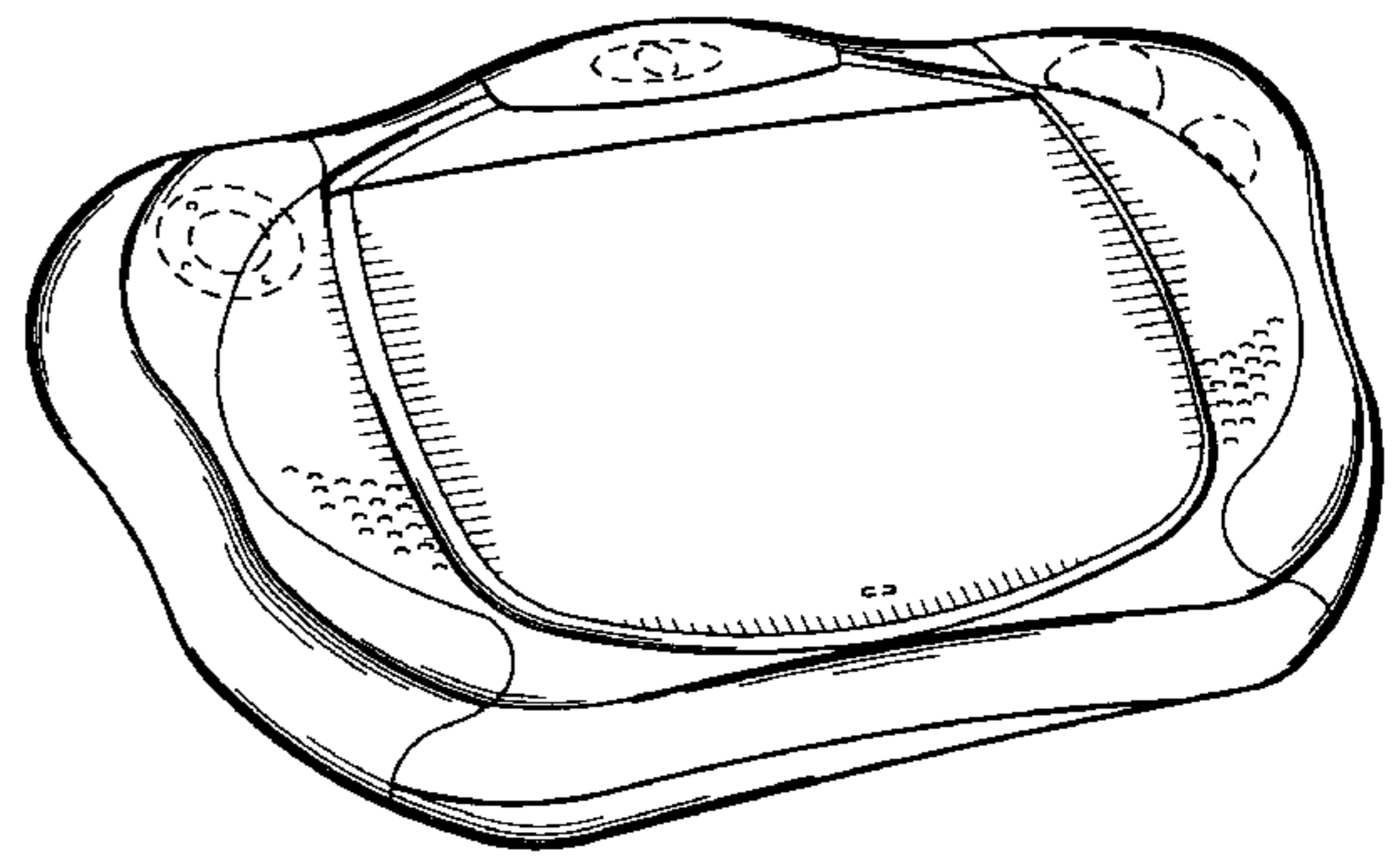
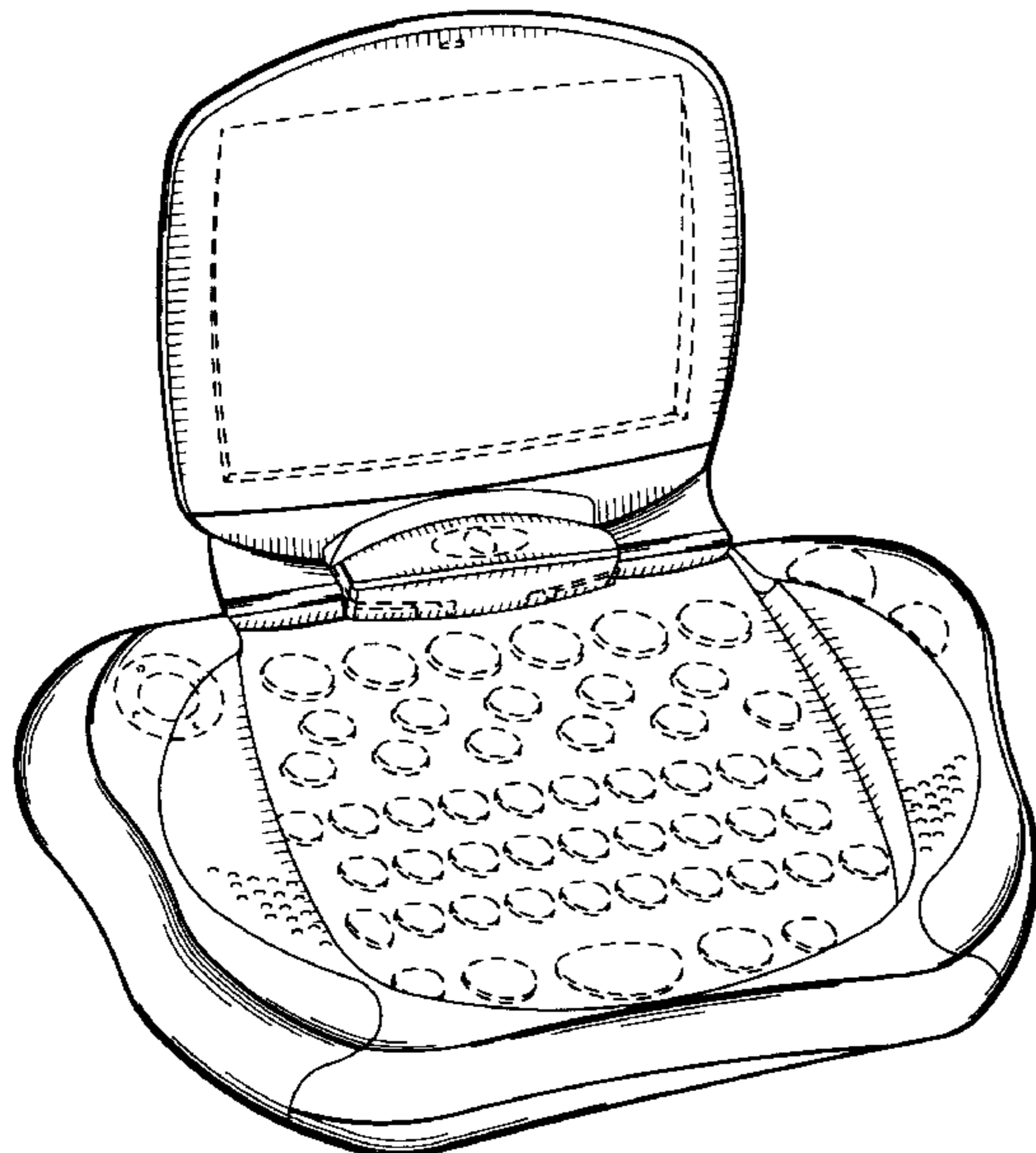
FIG. 6 is a rear elevation view of the communication device of FIG. 2;

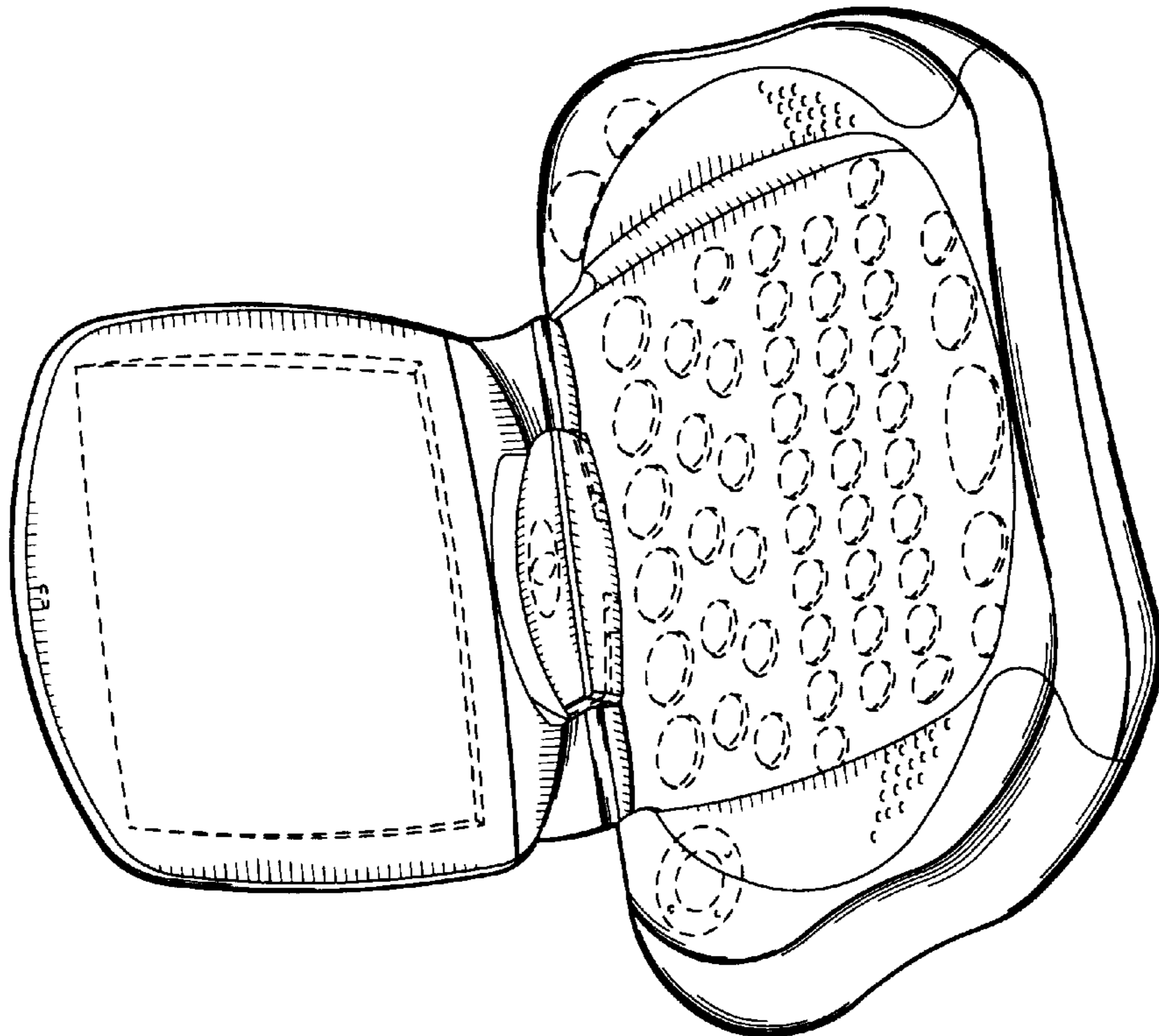
FIG. 7 is a right side elevation view of the communication device of FIG. 2; and,

FIG. 8 is a bottom plan view of the communication device of FIG. 2.

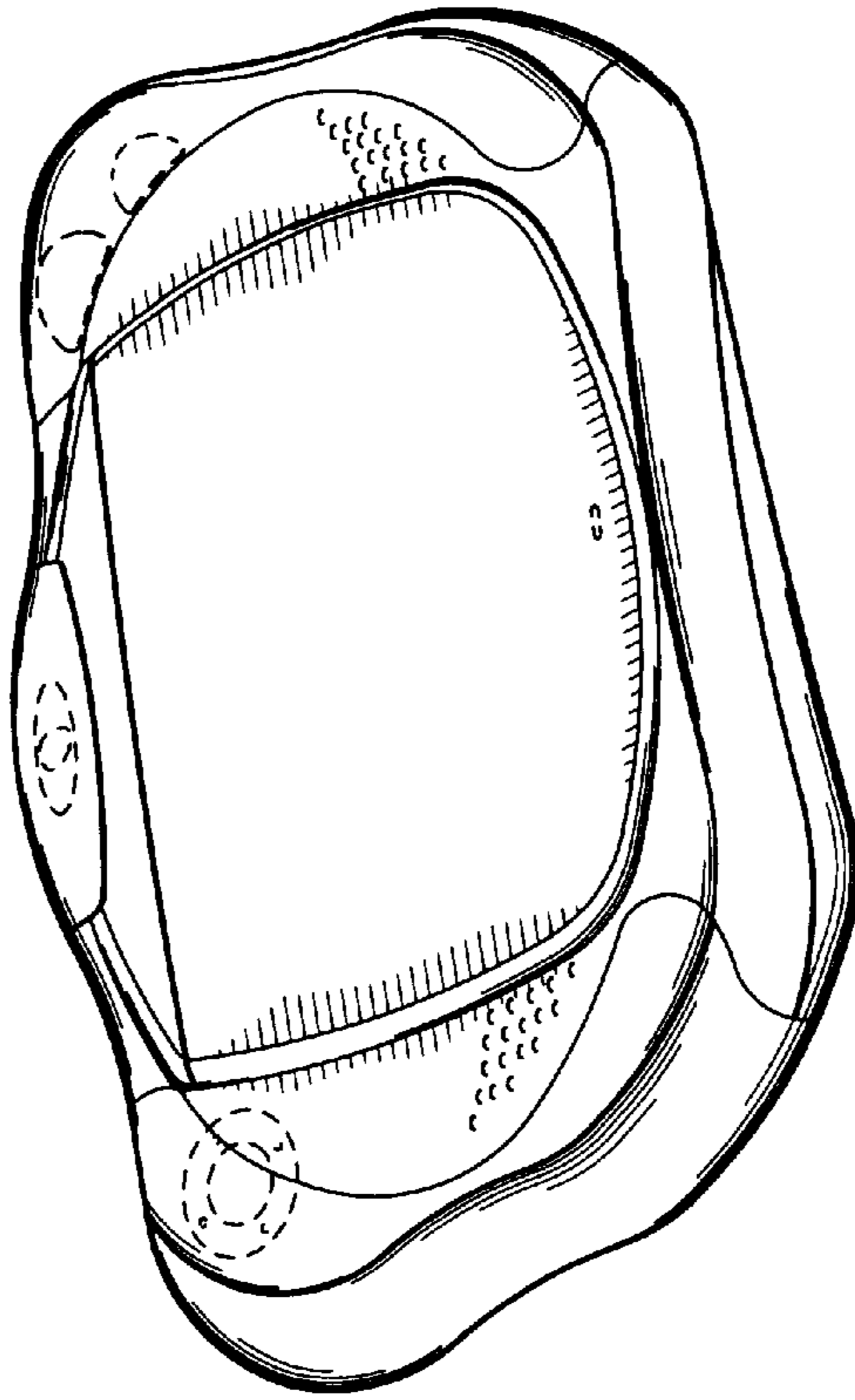
The broken line matter shown in FIGS. 1–8 is for illustrative purposes only and forms no part of the claimed design.

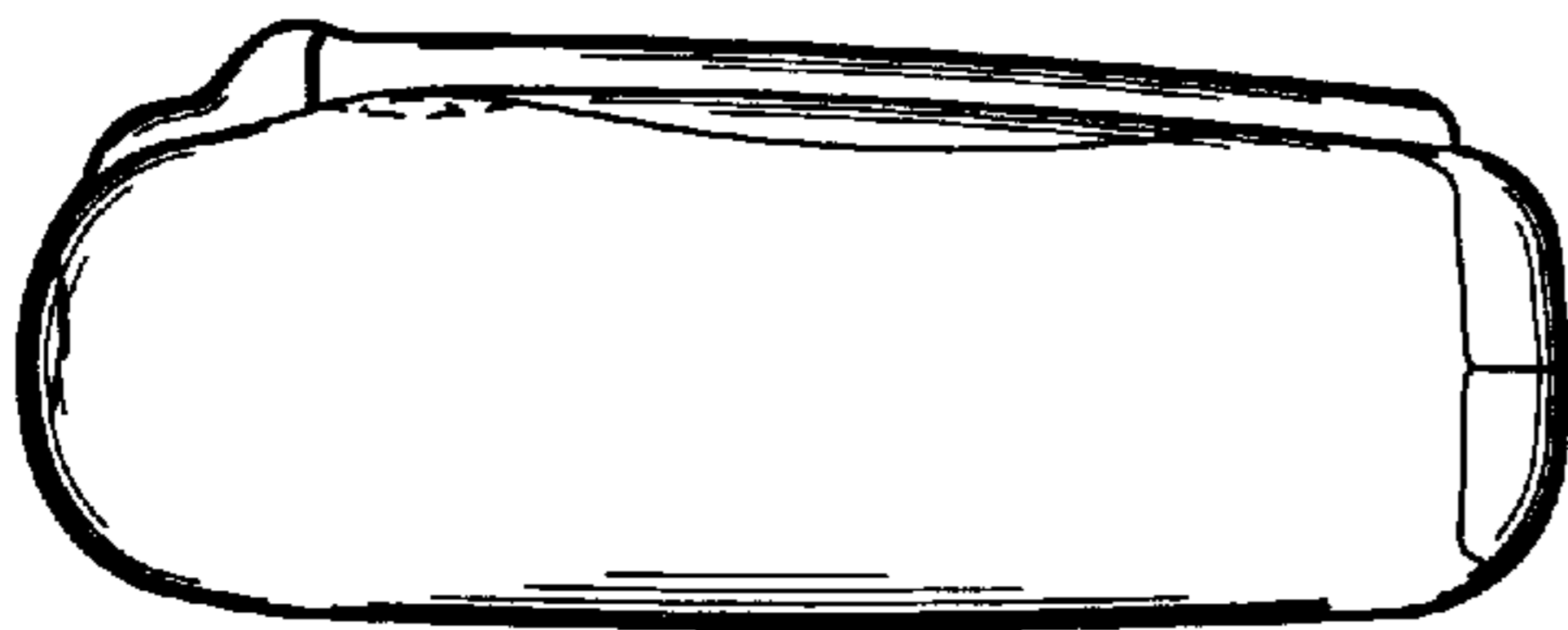




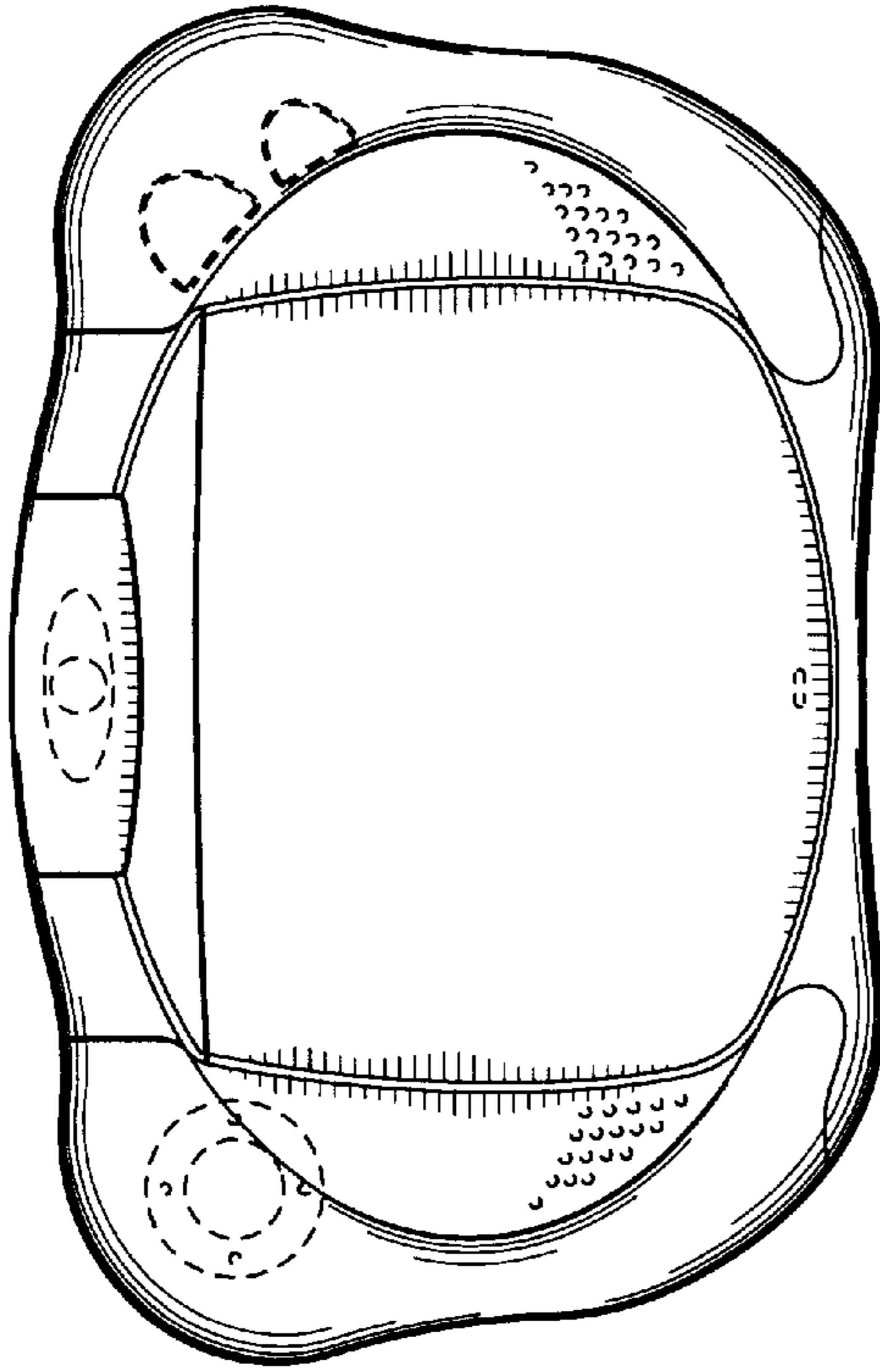

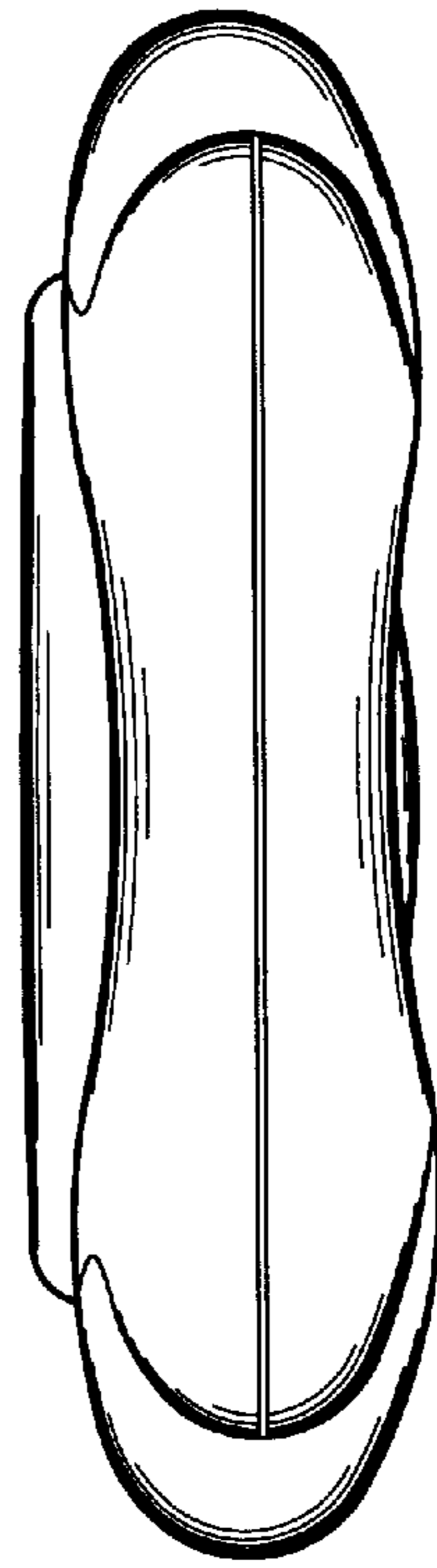

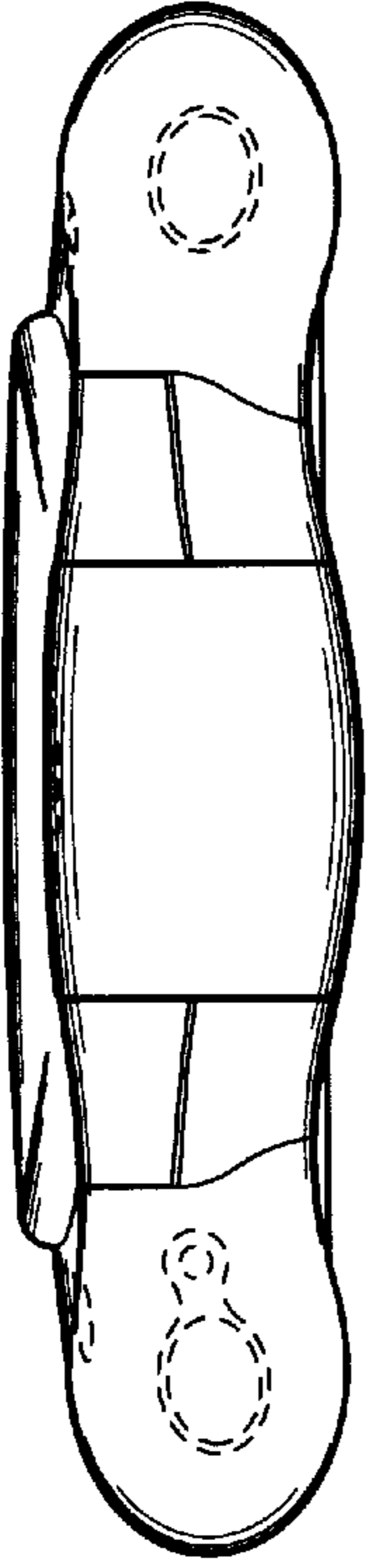

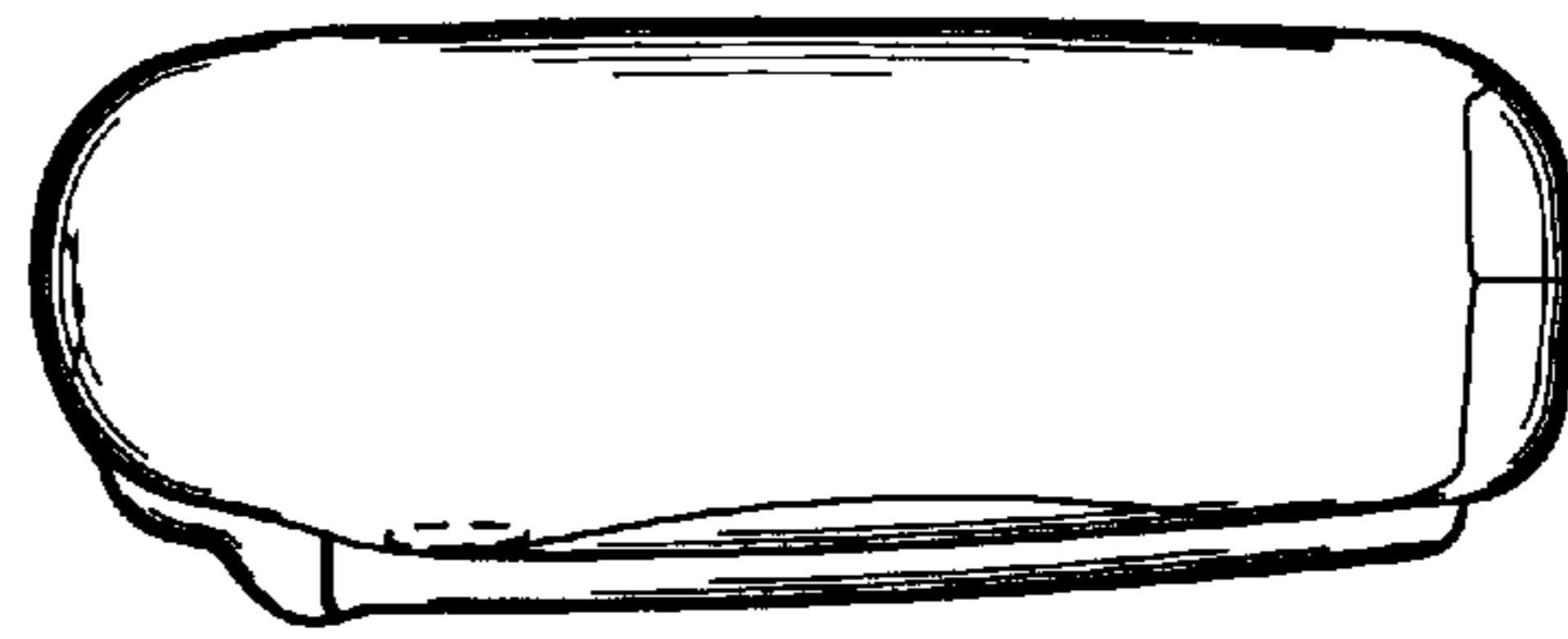

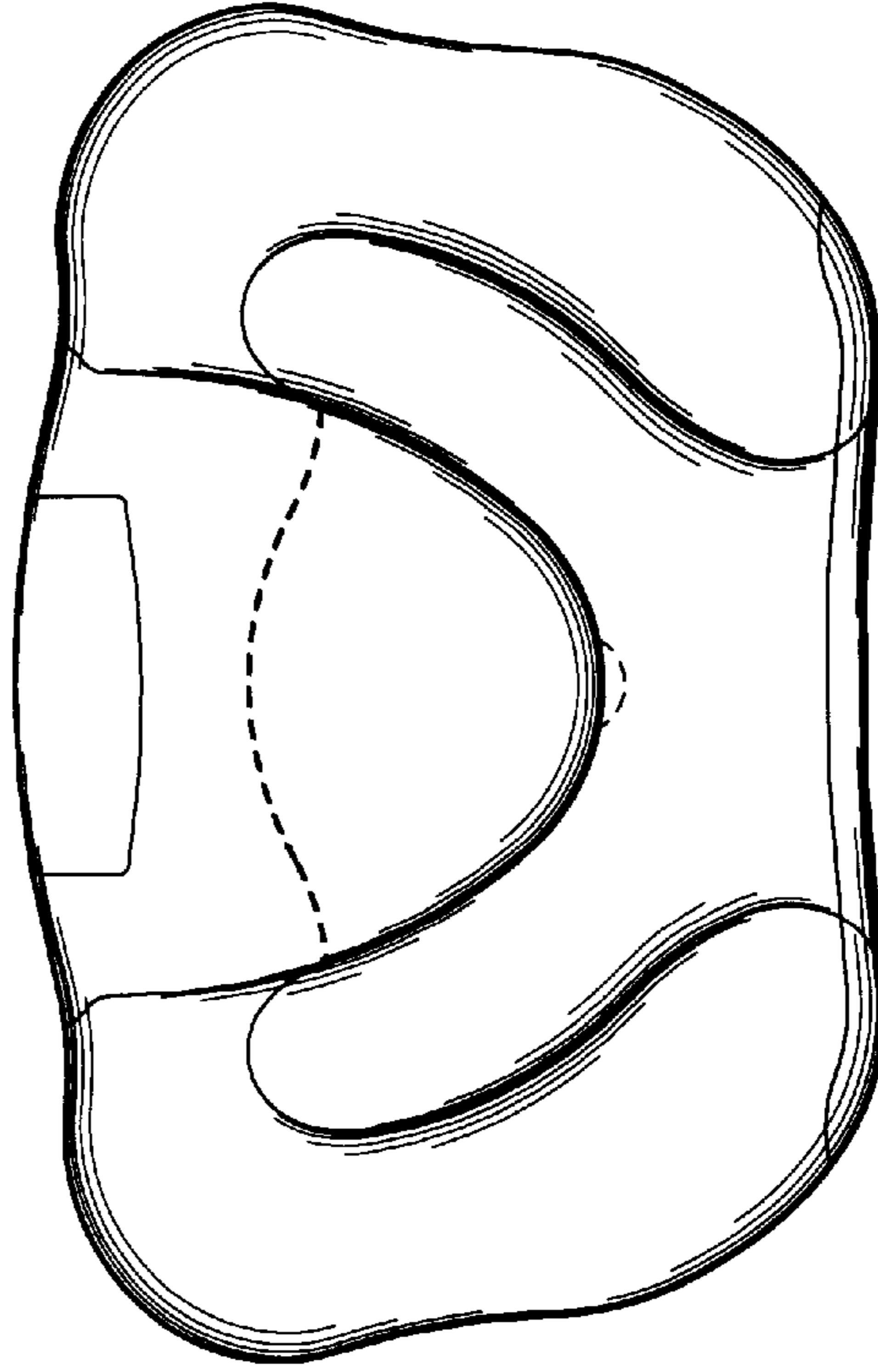
