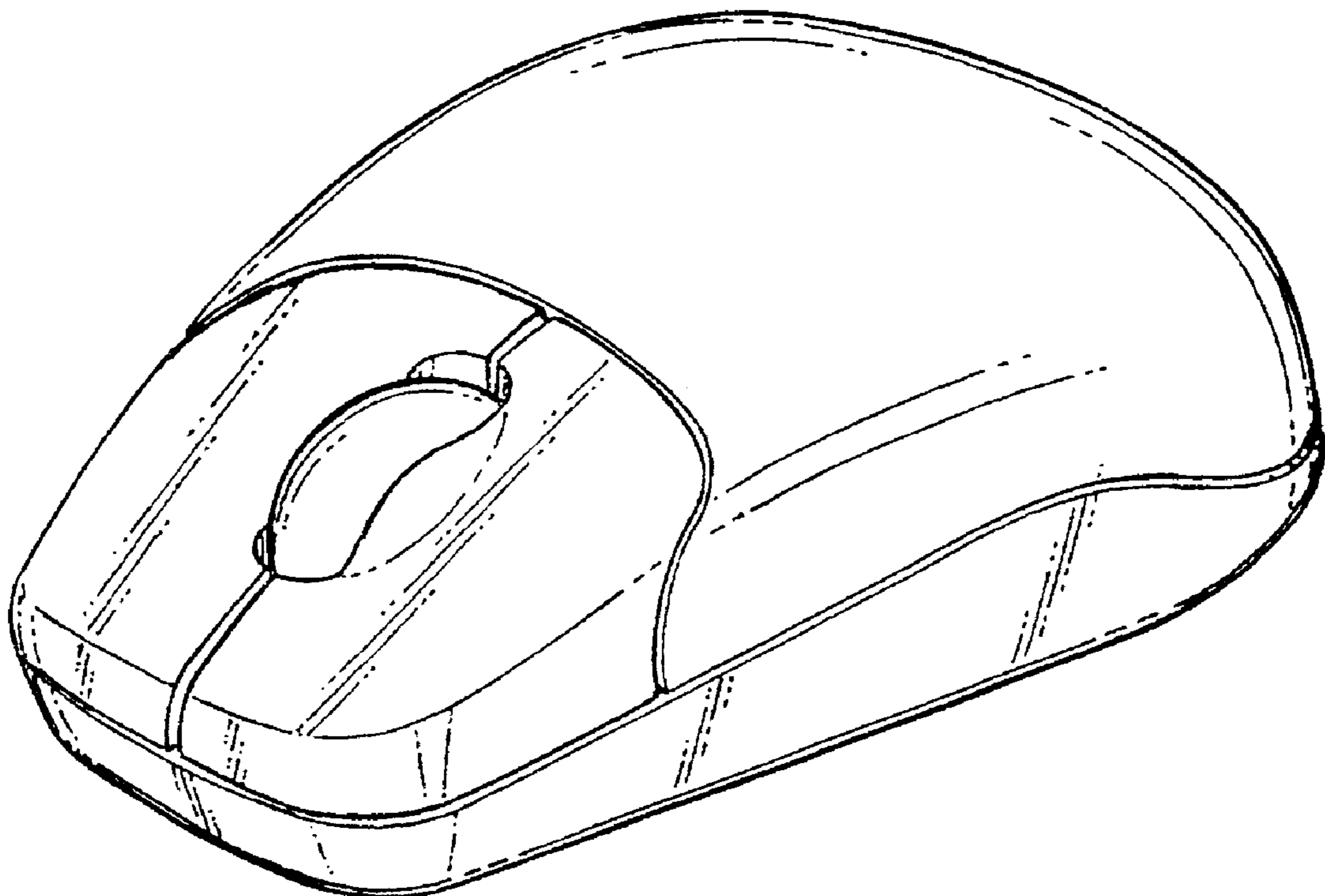

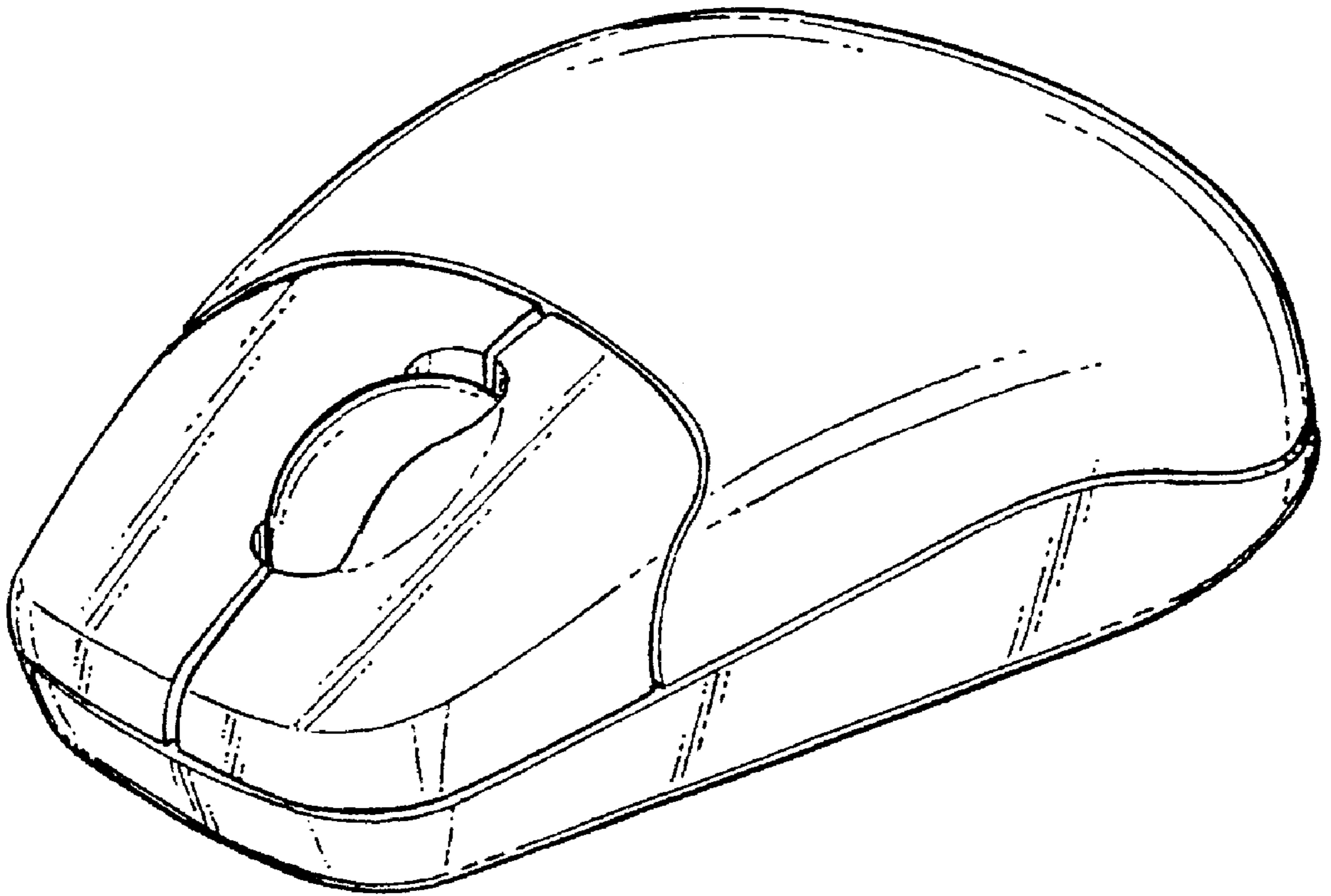
The ornamental design for computer pointing device, as
