(57) **CLAIM**

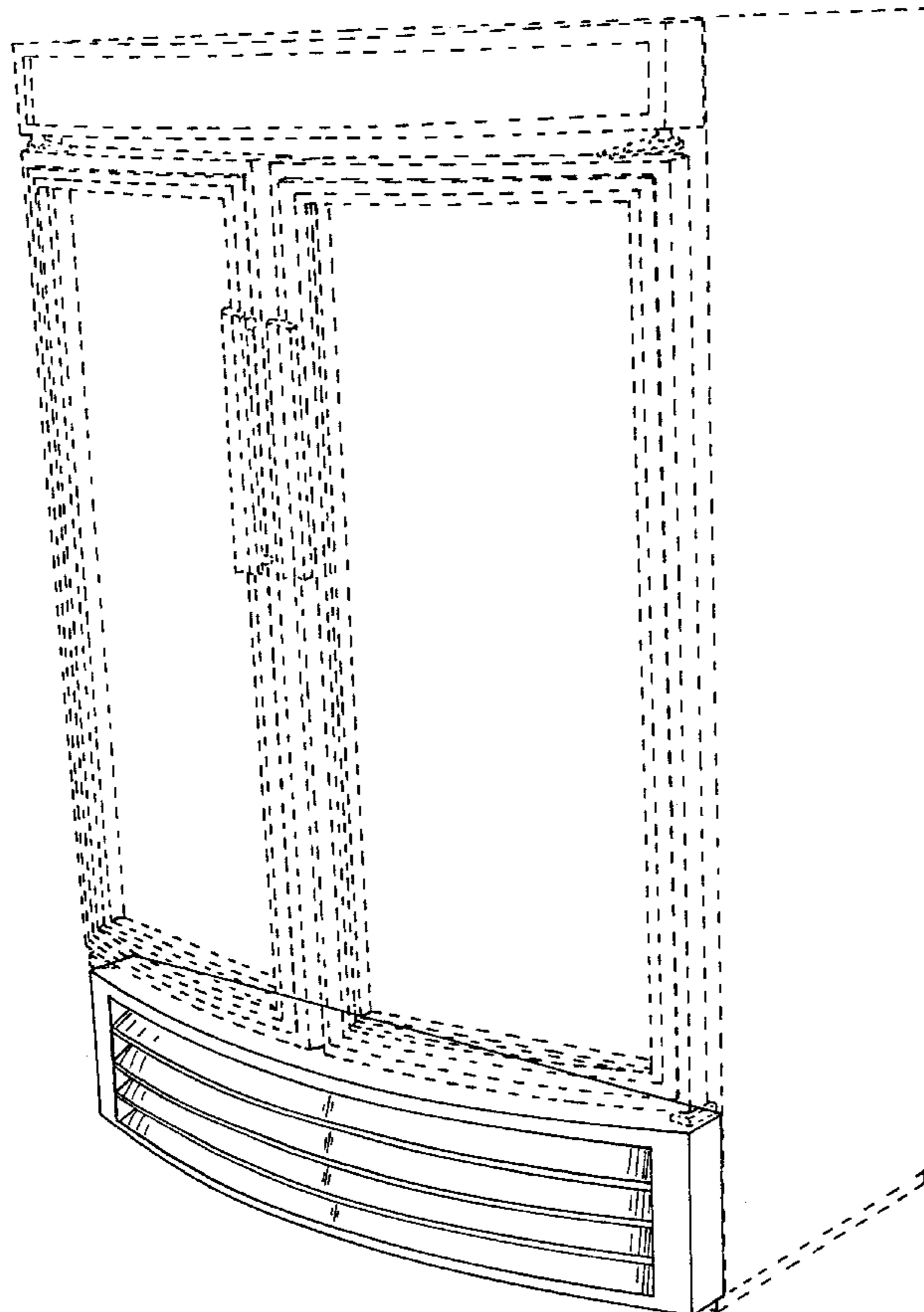
I claim the ornamental design for a double door merchandiser grill, as shown and described.

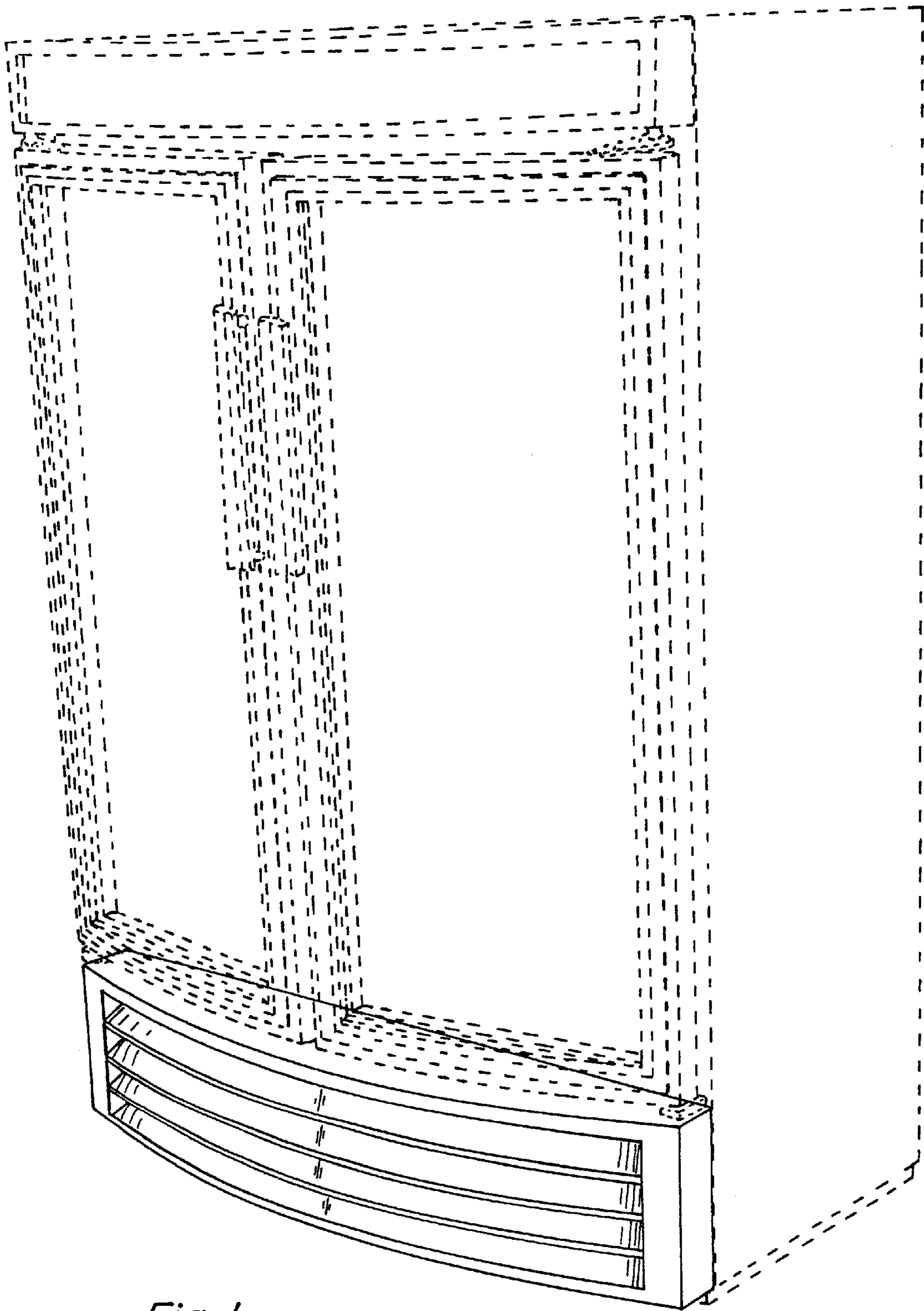
**DESCRIPTION**

 FIG. 7 is a bottom plan view of FIG. 1.

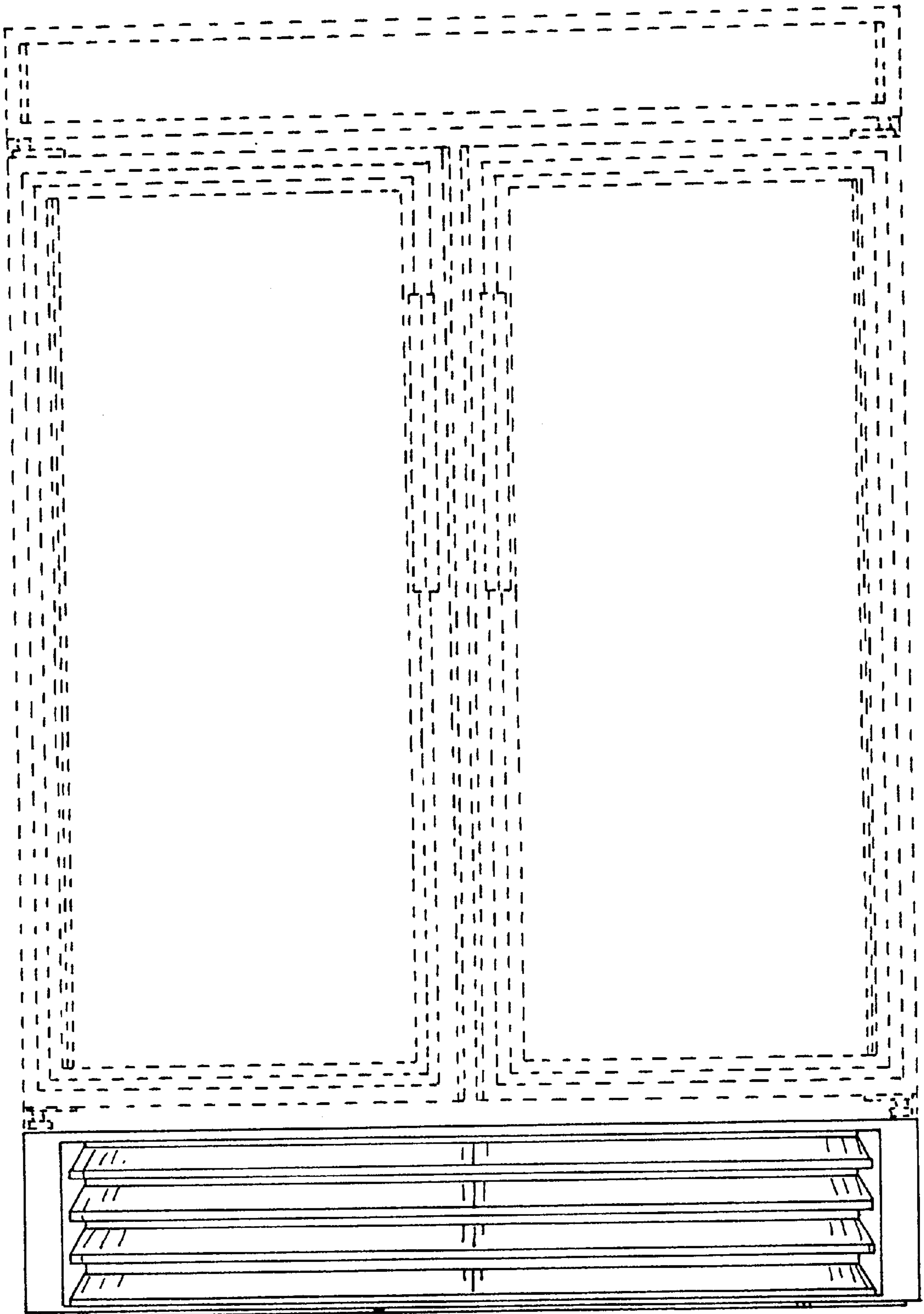

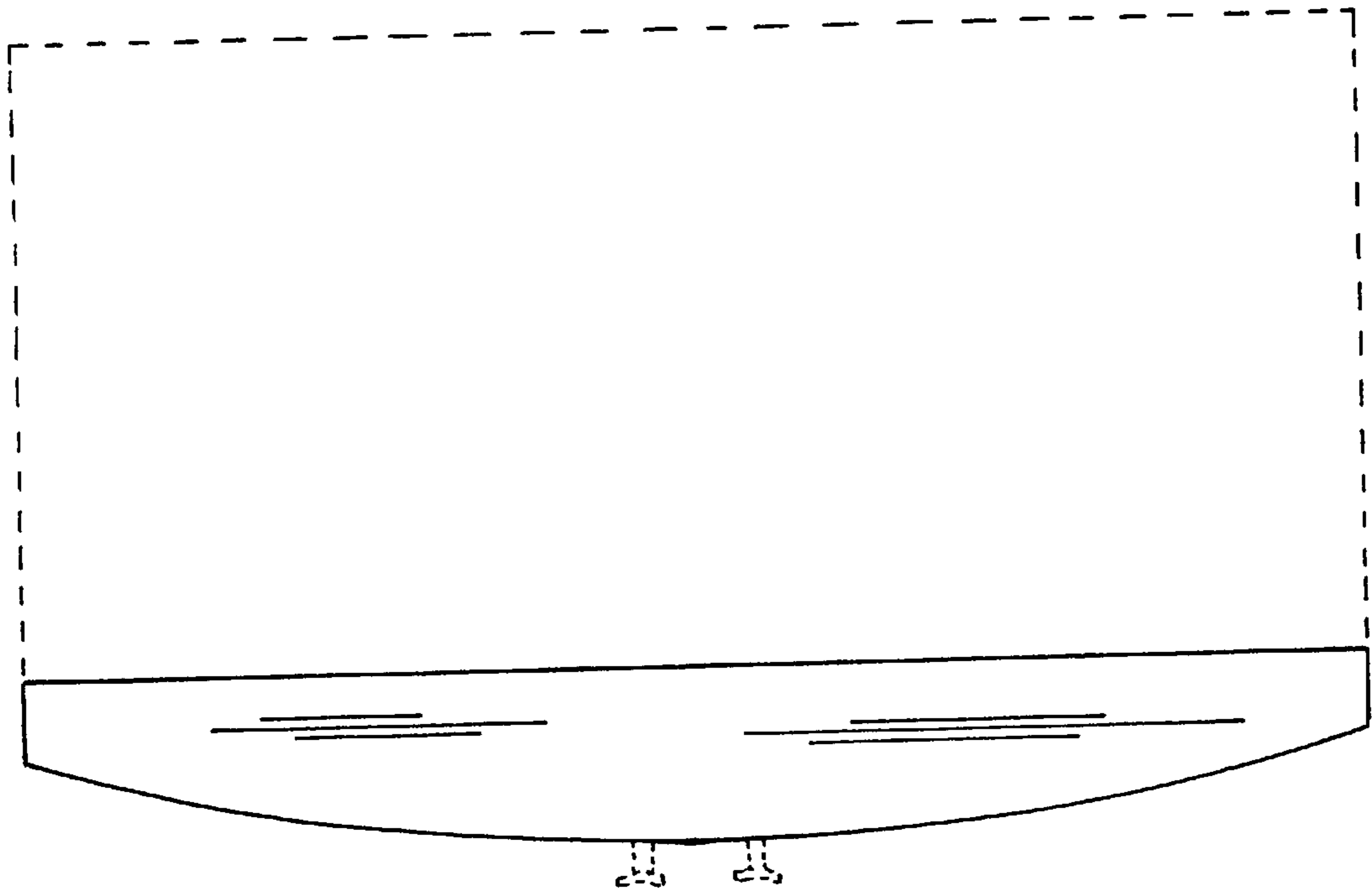




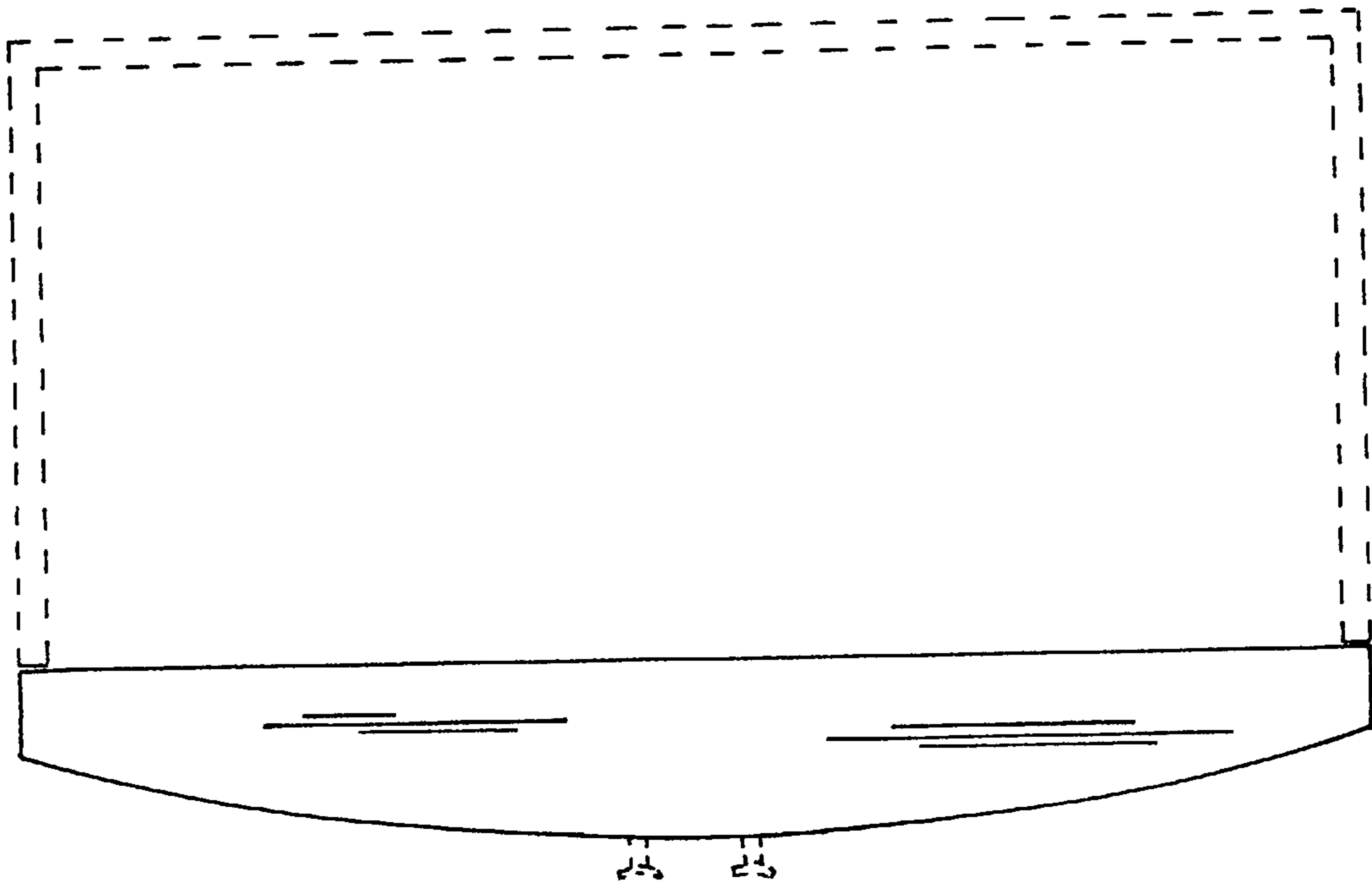

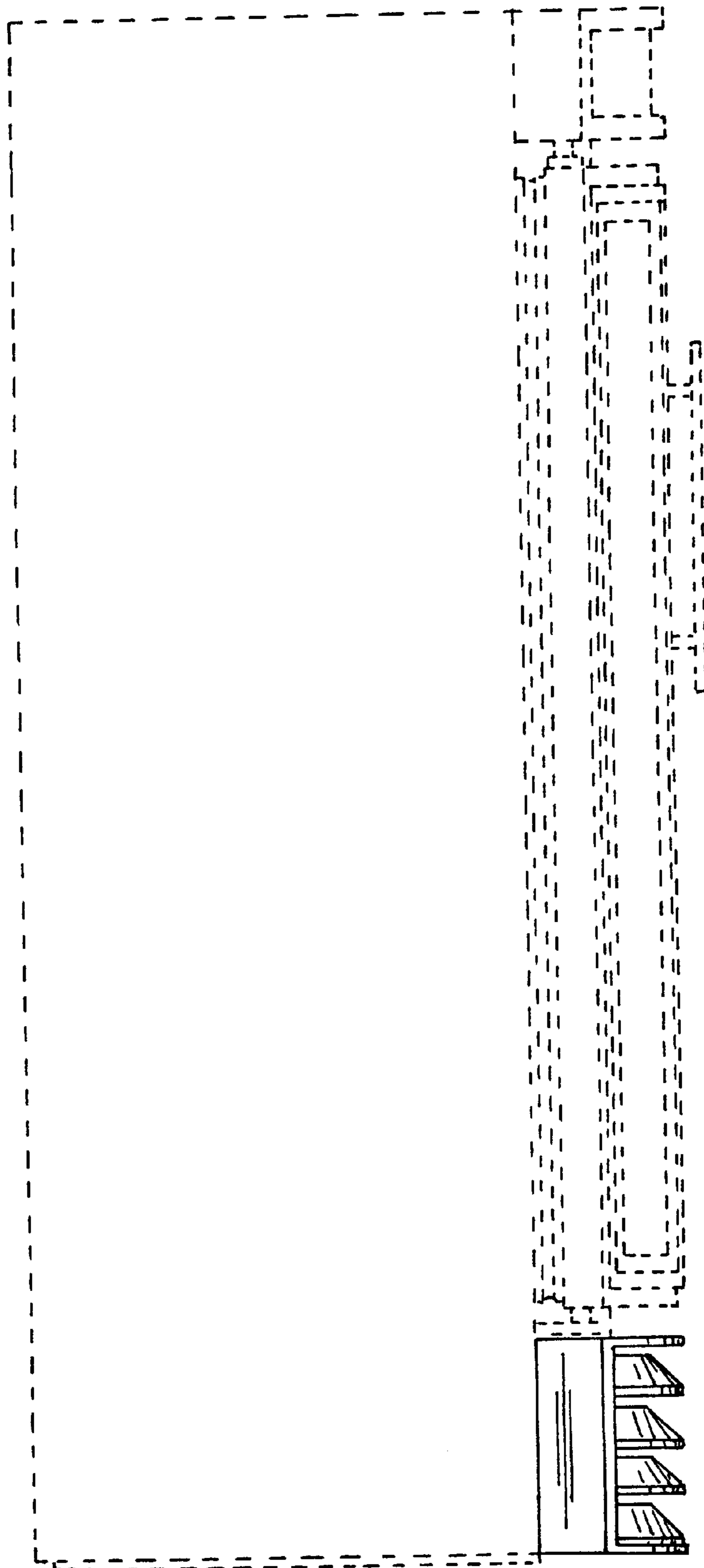

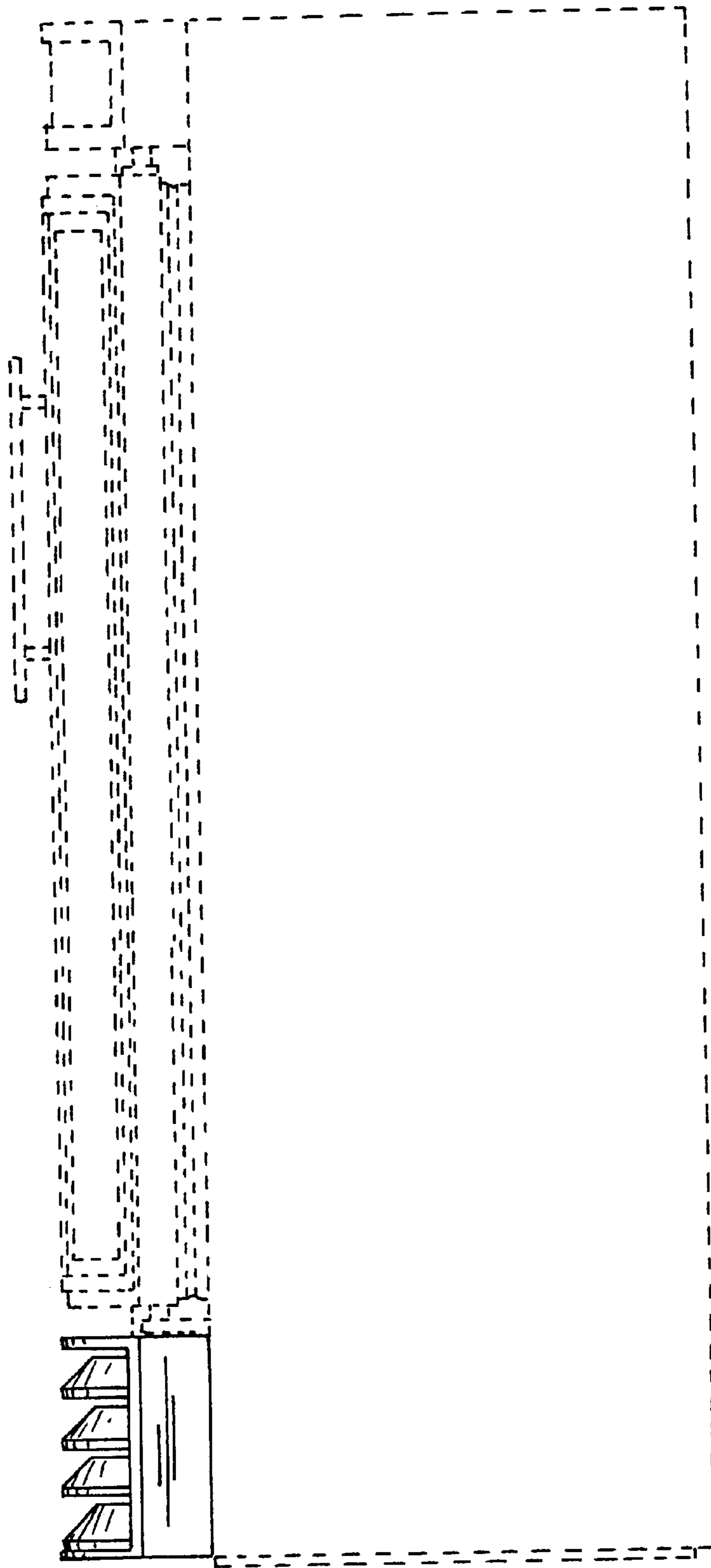

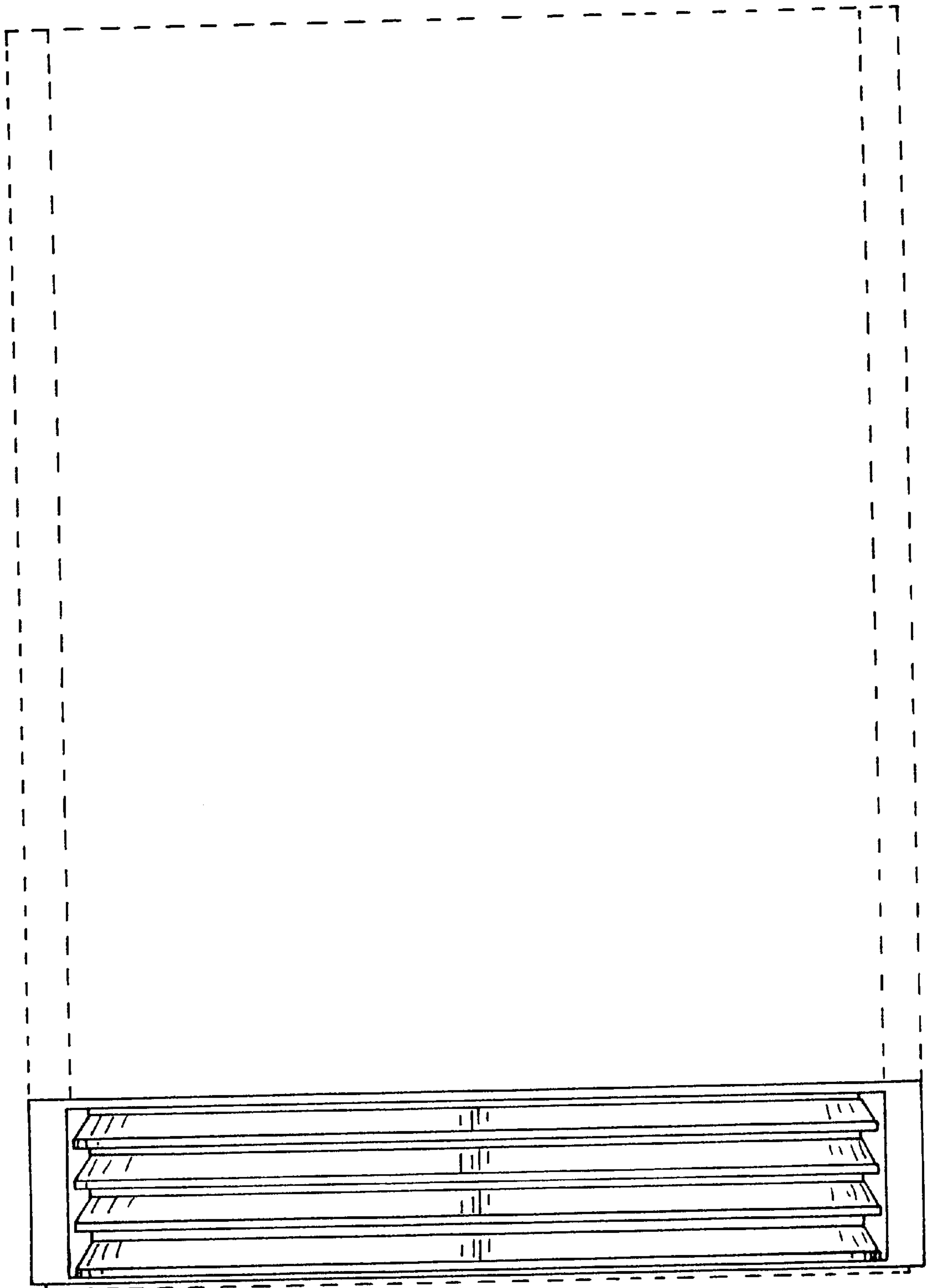
