The ornamental design for a laundry basket on wheels, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the laundry basket on wheels of the present invention, the rear view being a mirror image thereof;

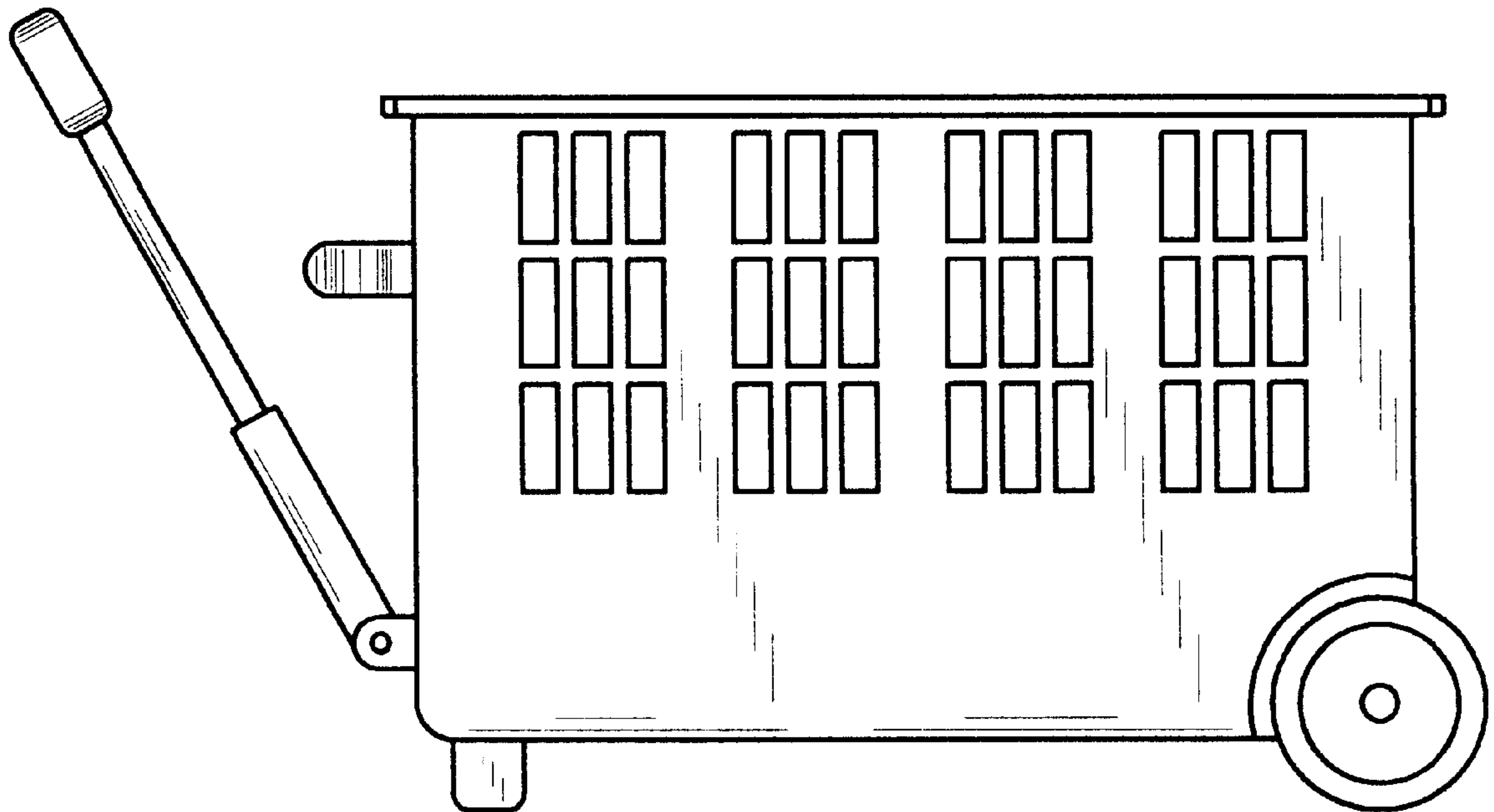
FIG. 2 is a left side elevational view of the laundry basket on wheels of FIG. 1;

FIG. 3 is a right side elevational view of the laundry basket on wheels of FIG. 1;

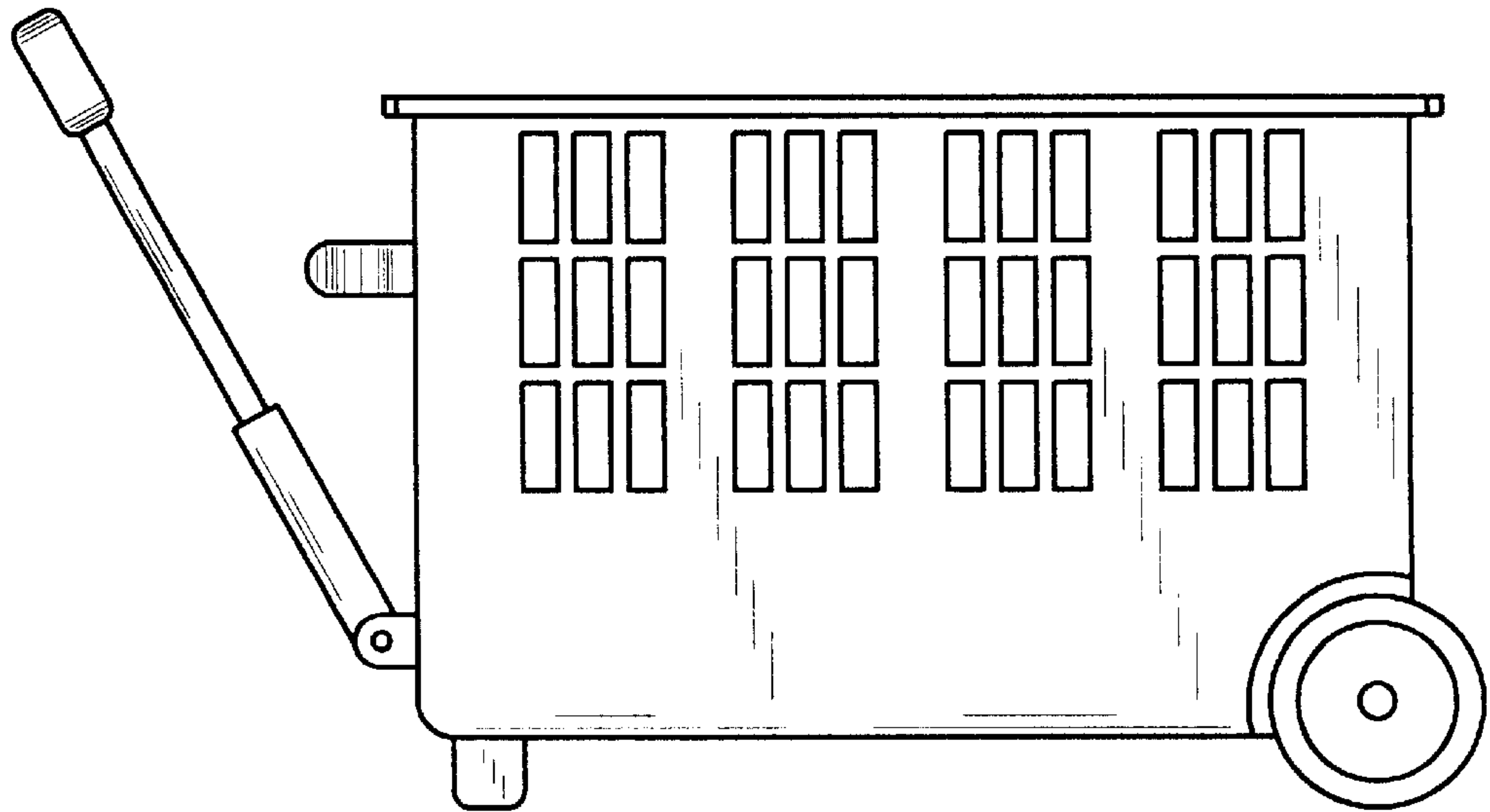

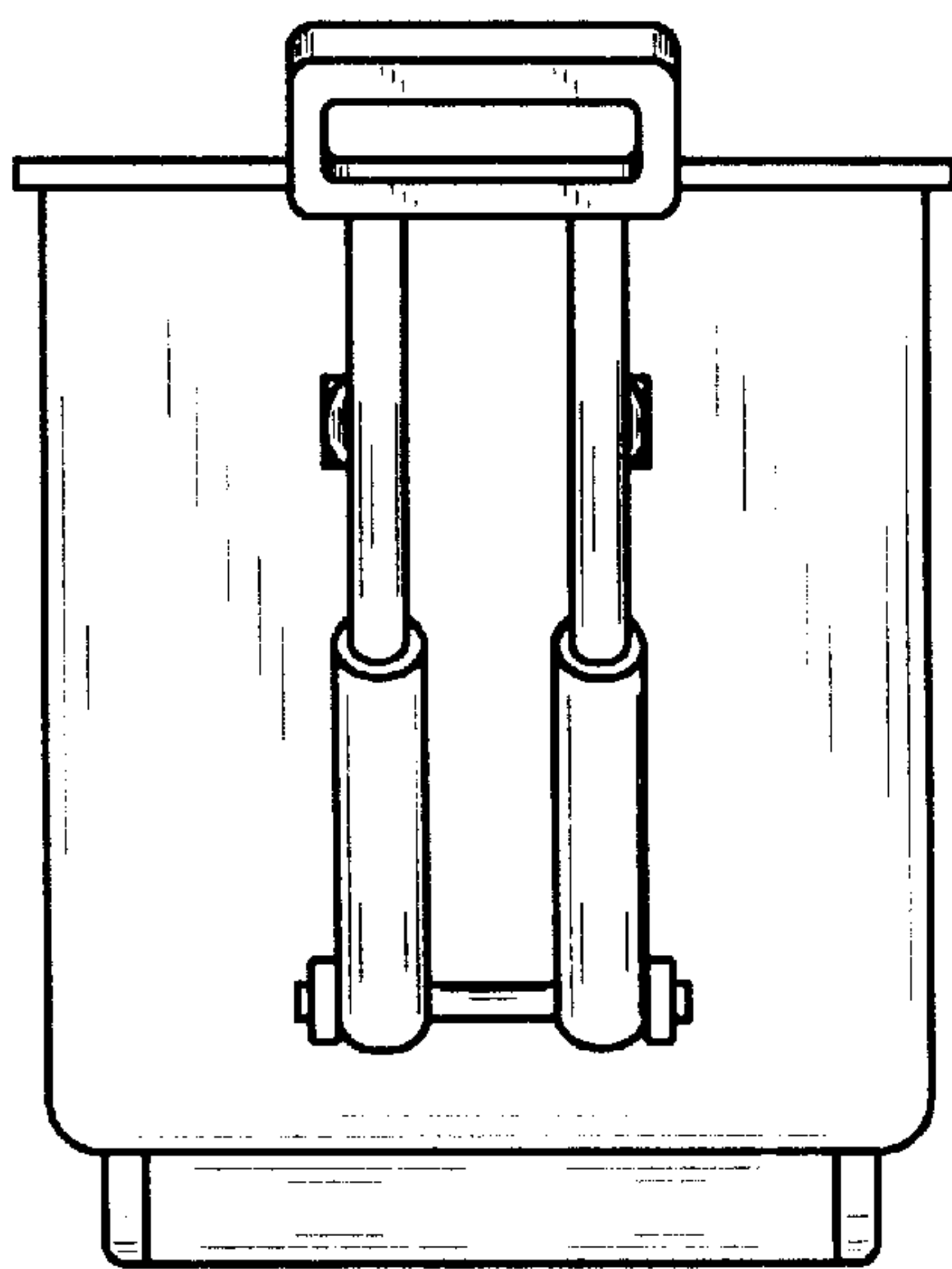

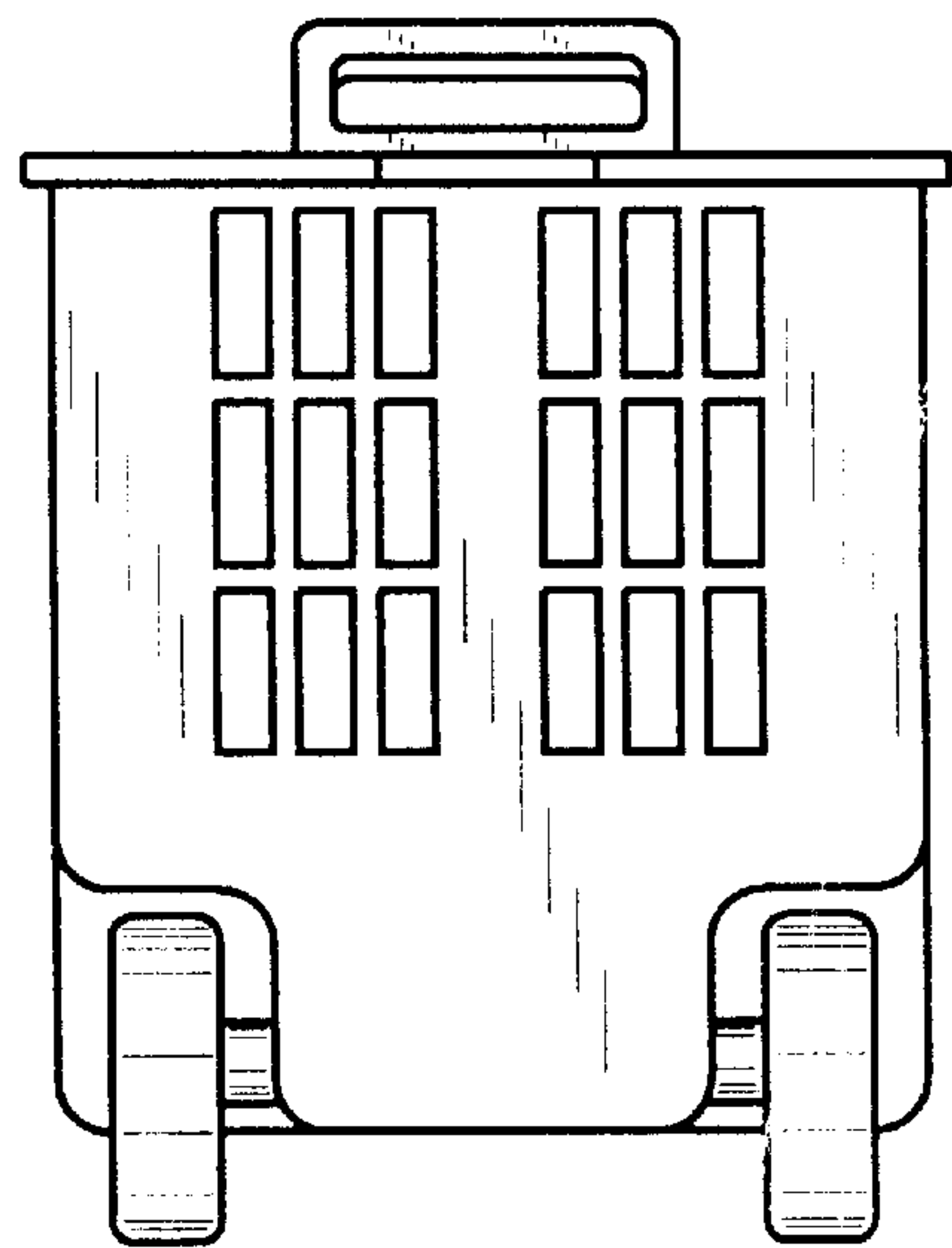

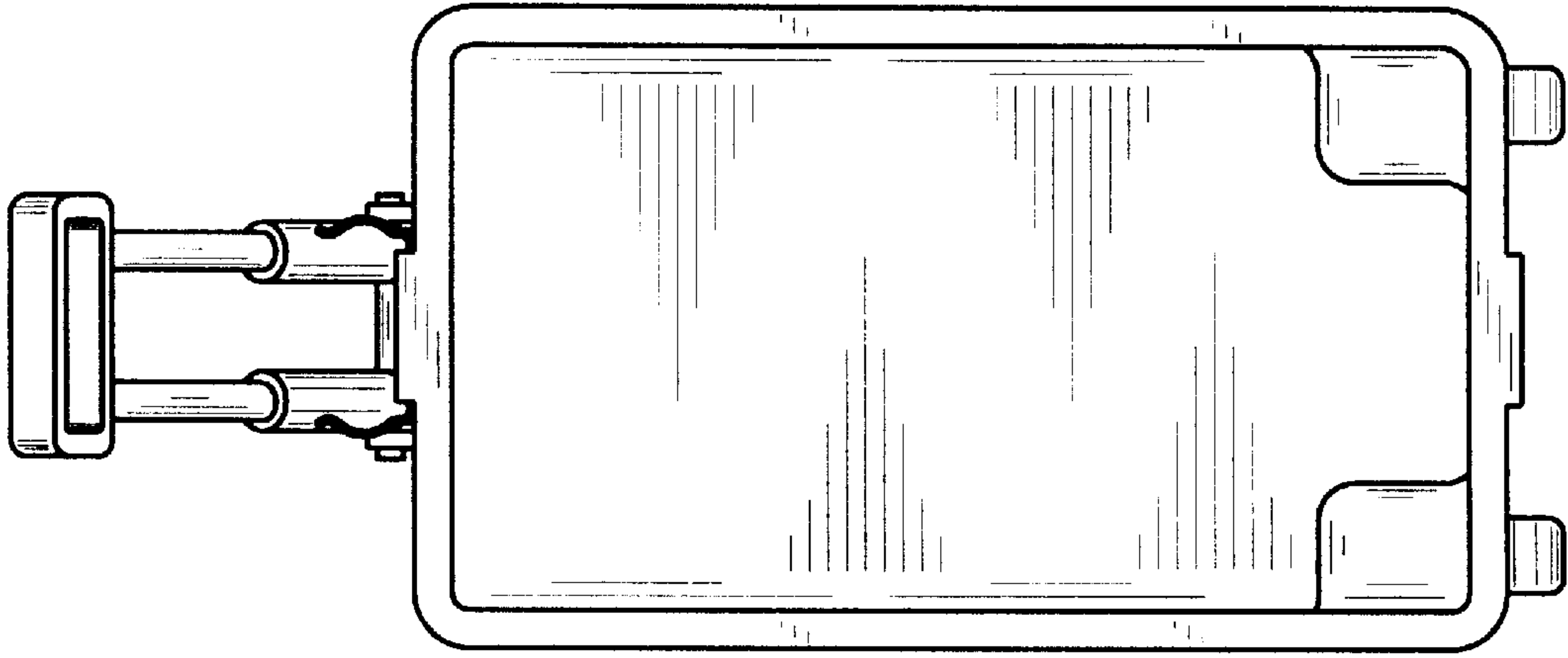

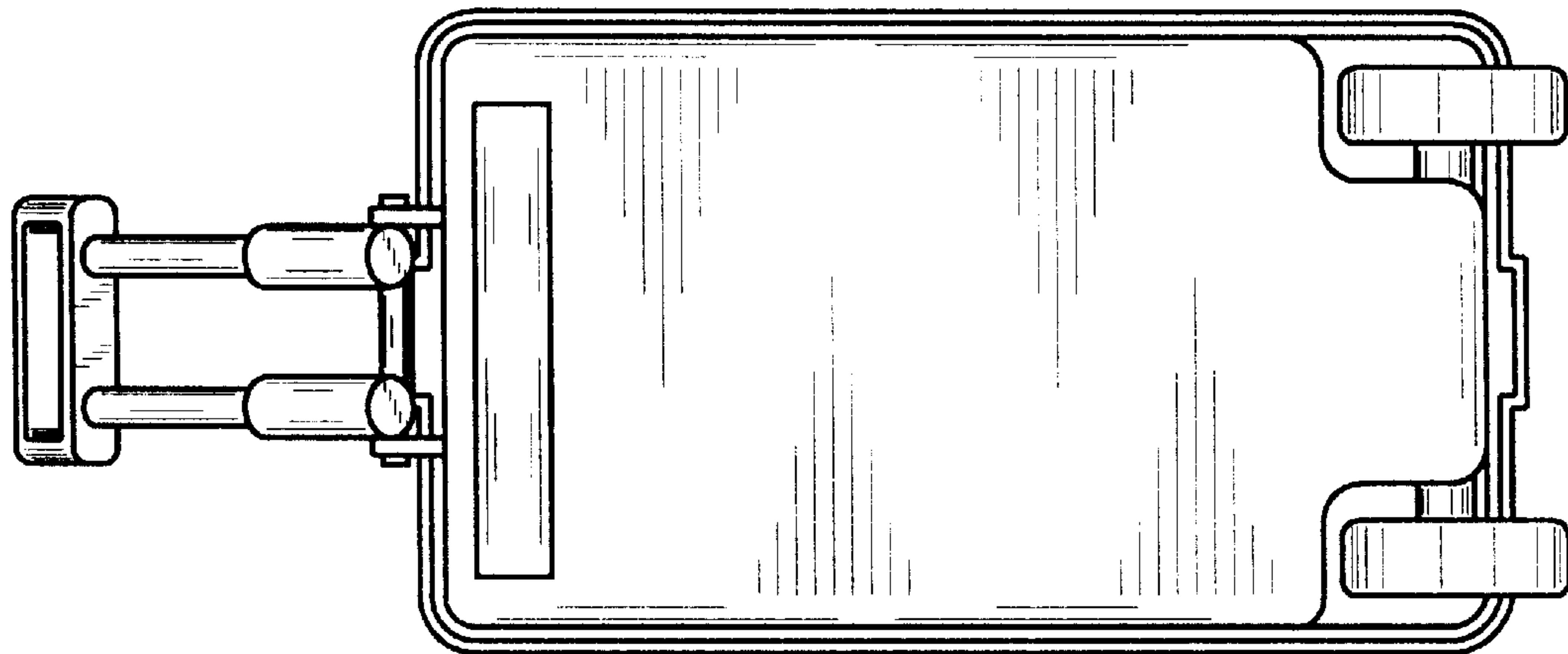
