(57) **CLAIM**

I claim the ornamental design for a waterproof floatable container, as shown and described.

**DESCRIPTION**

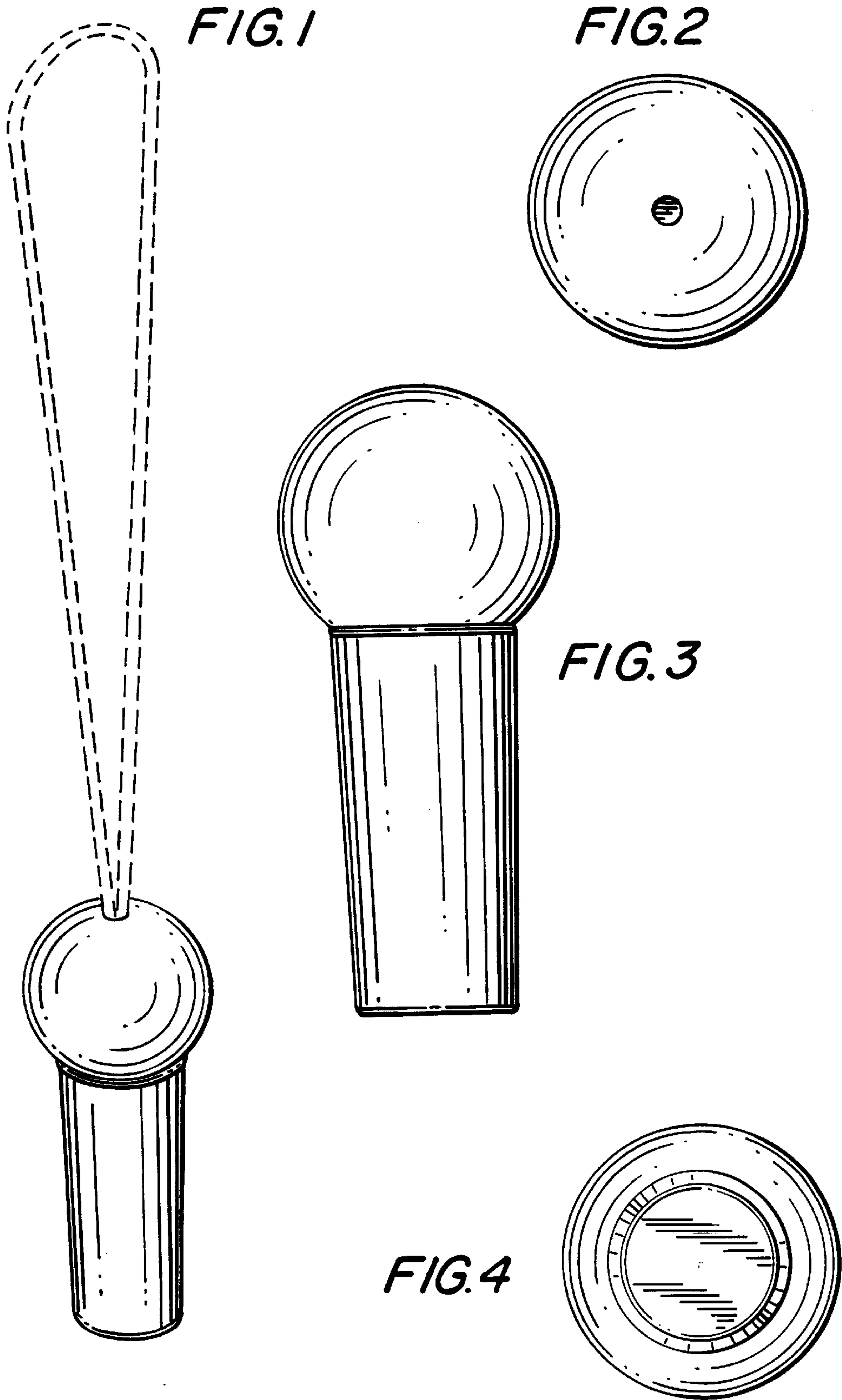

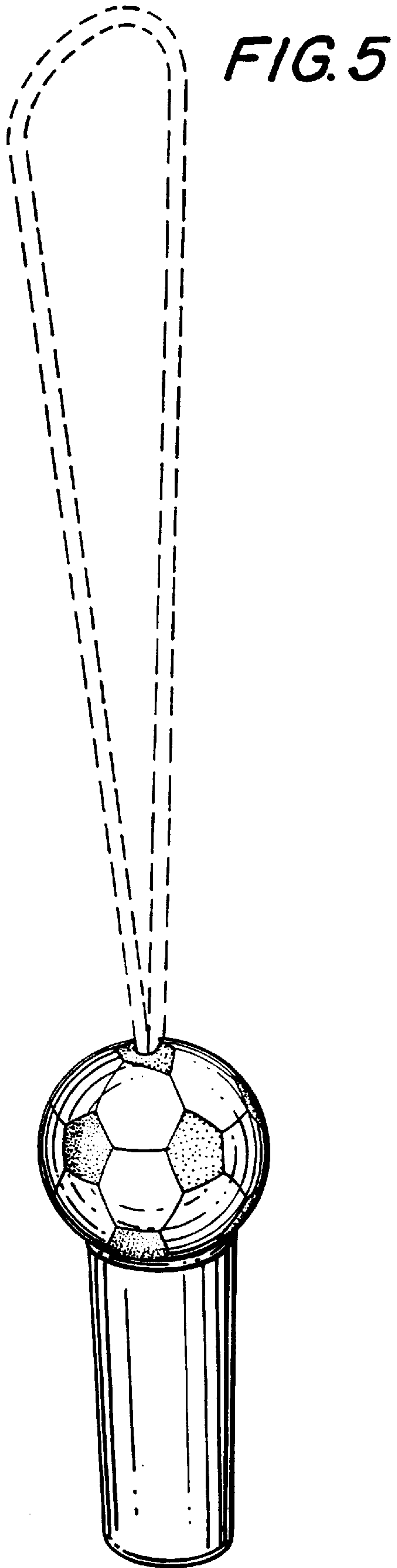

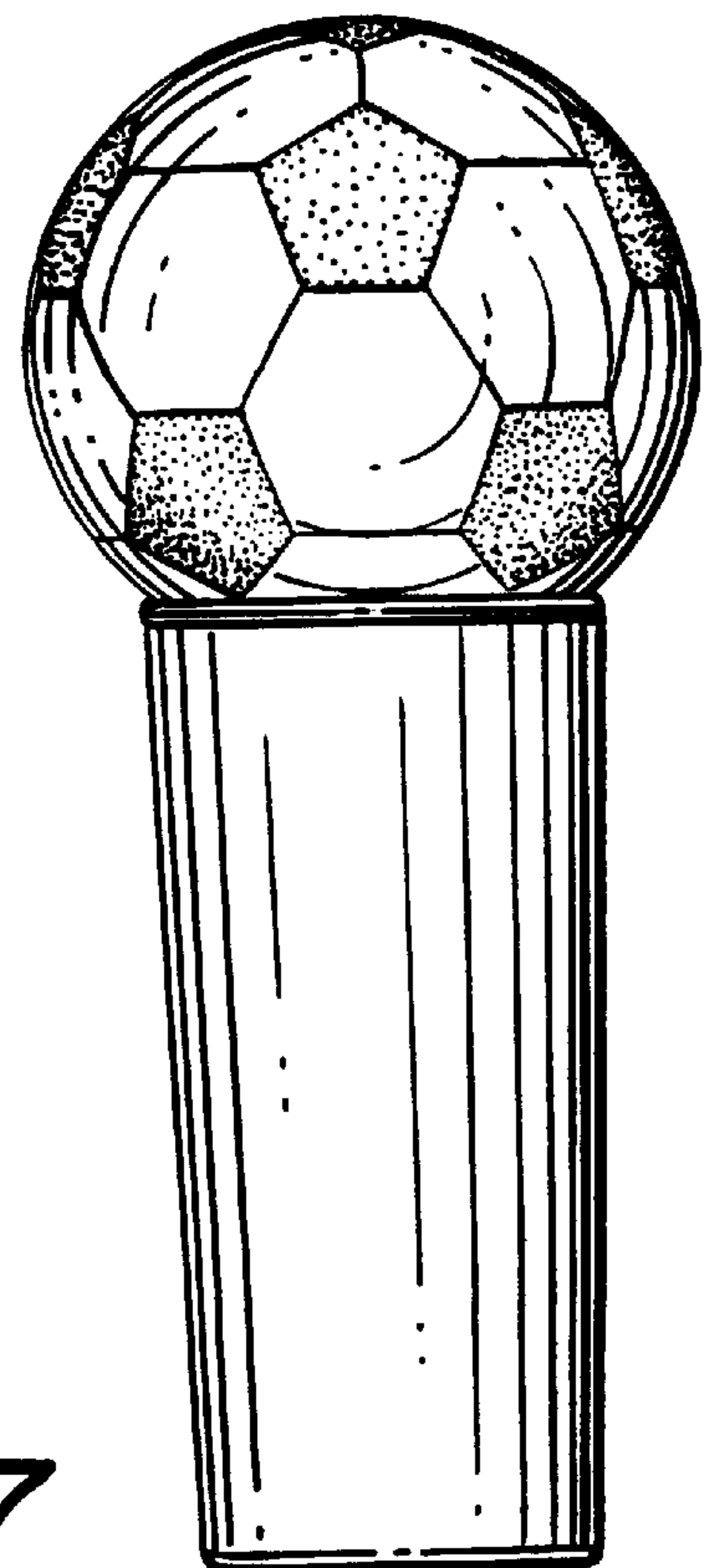

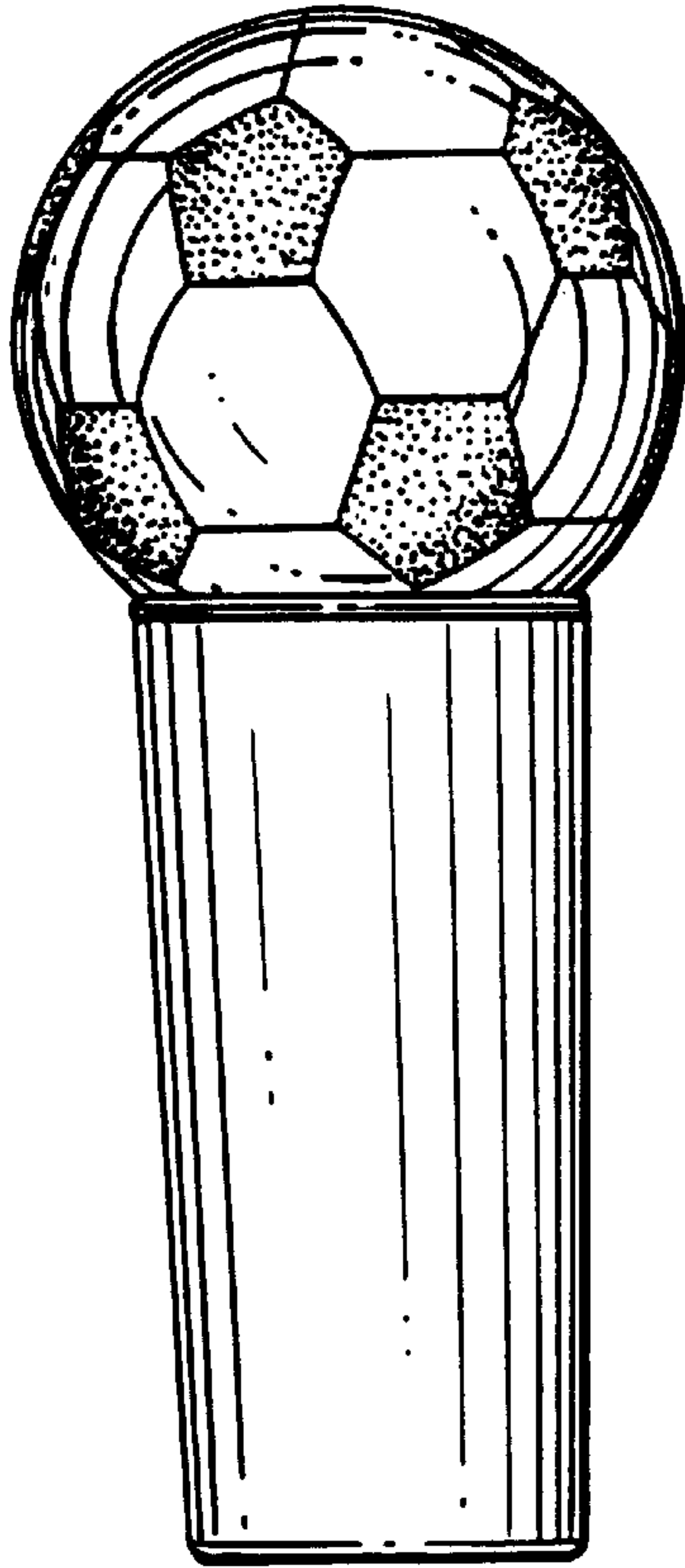

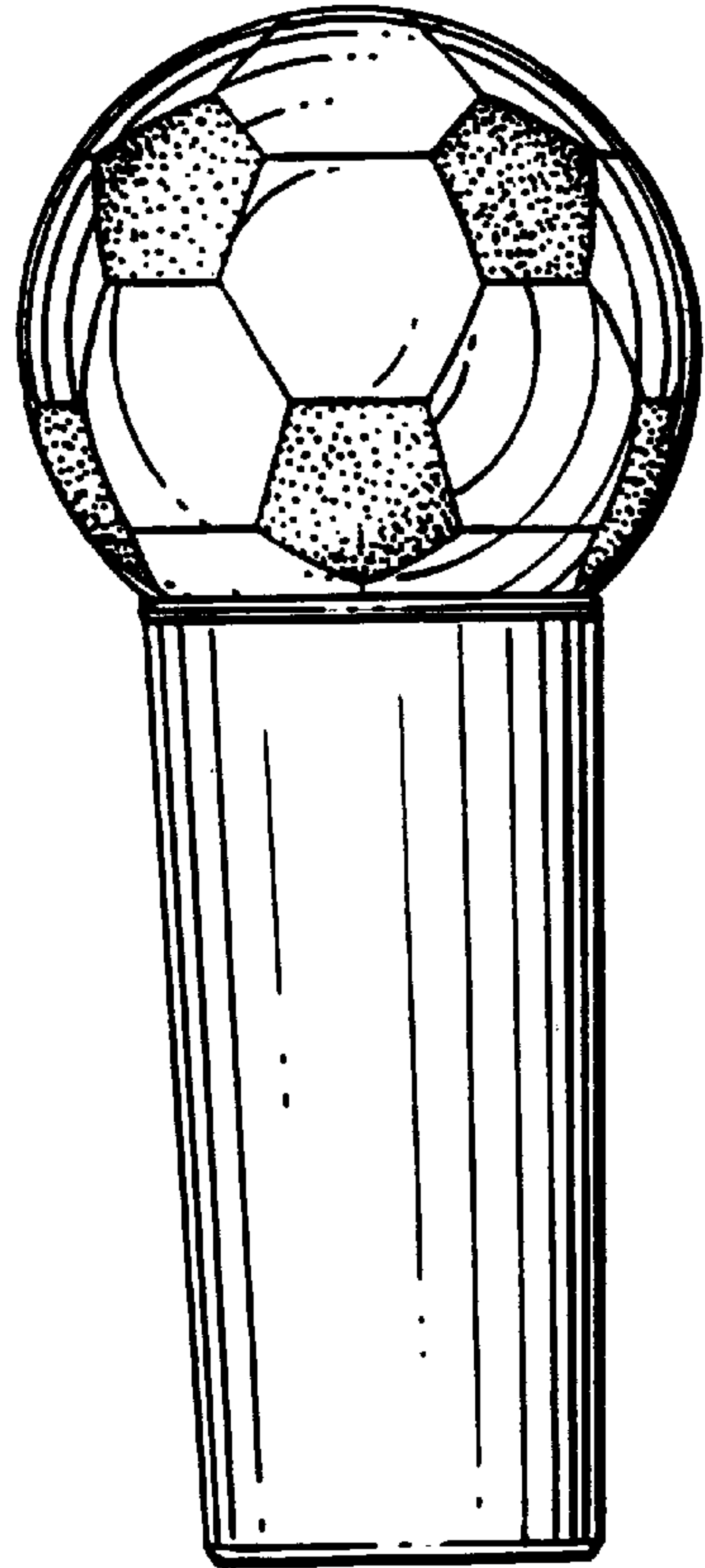

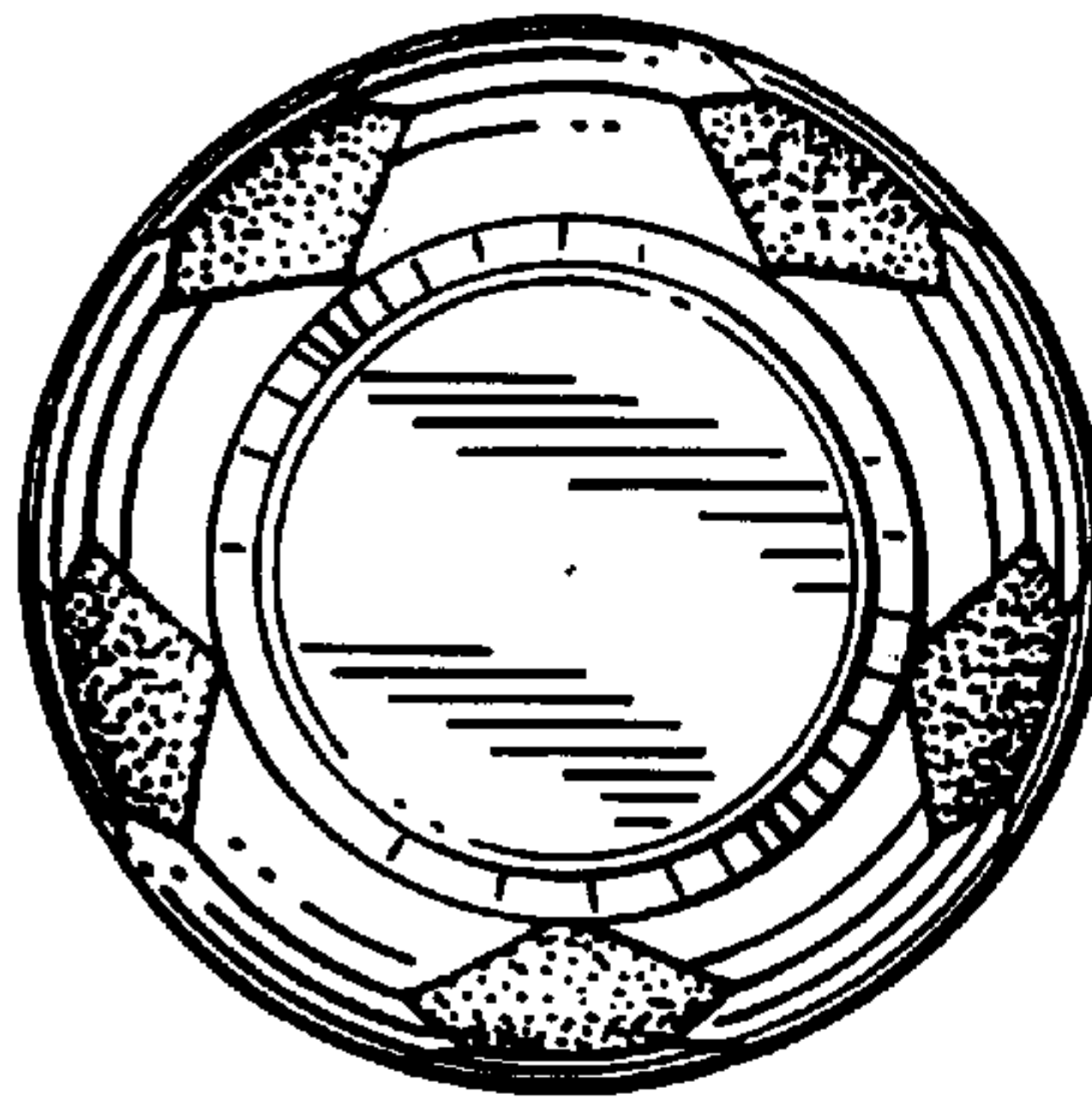

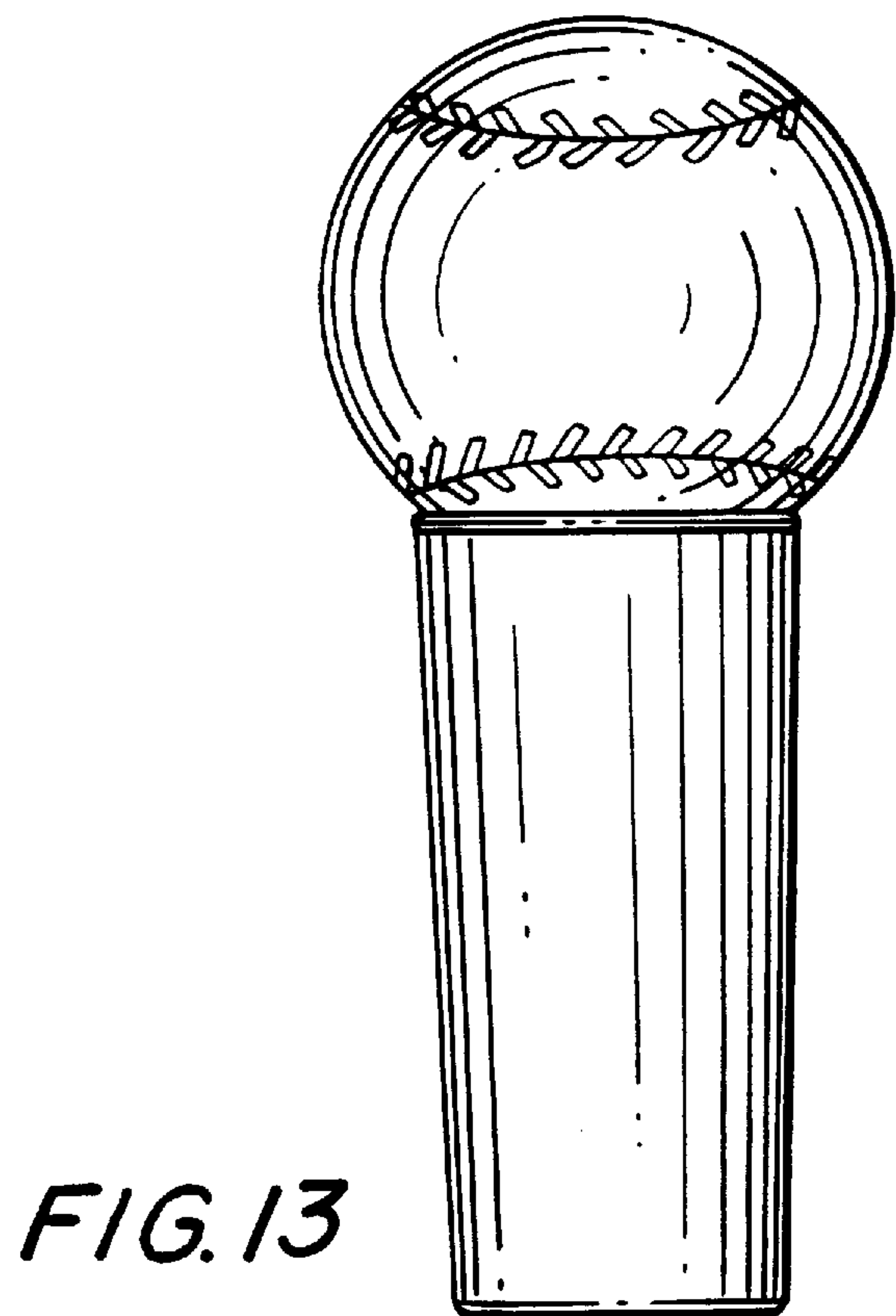
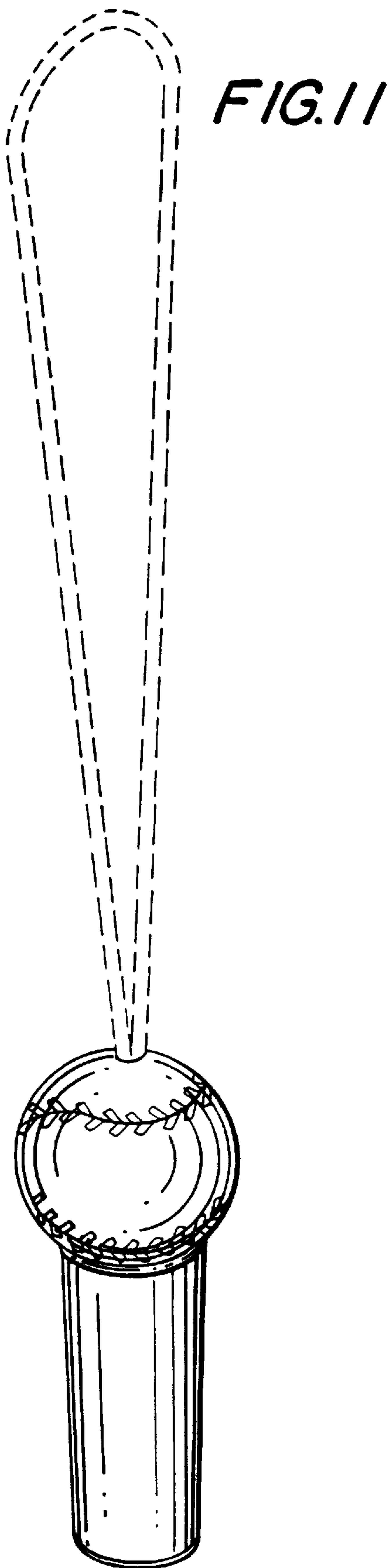

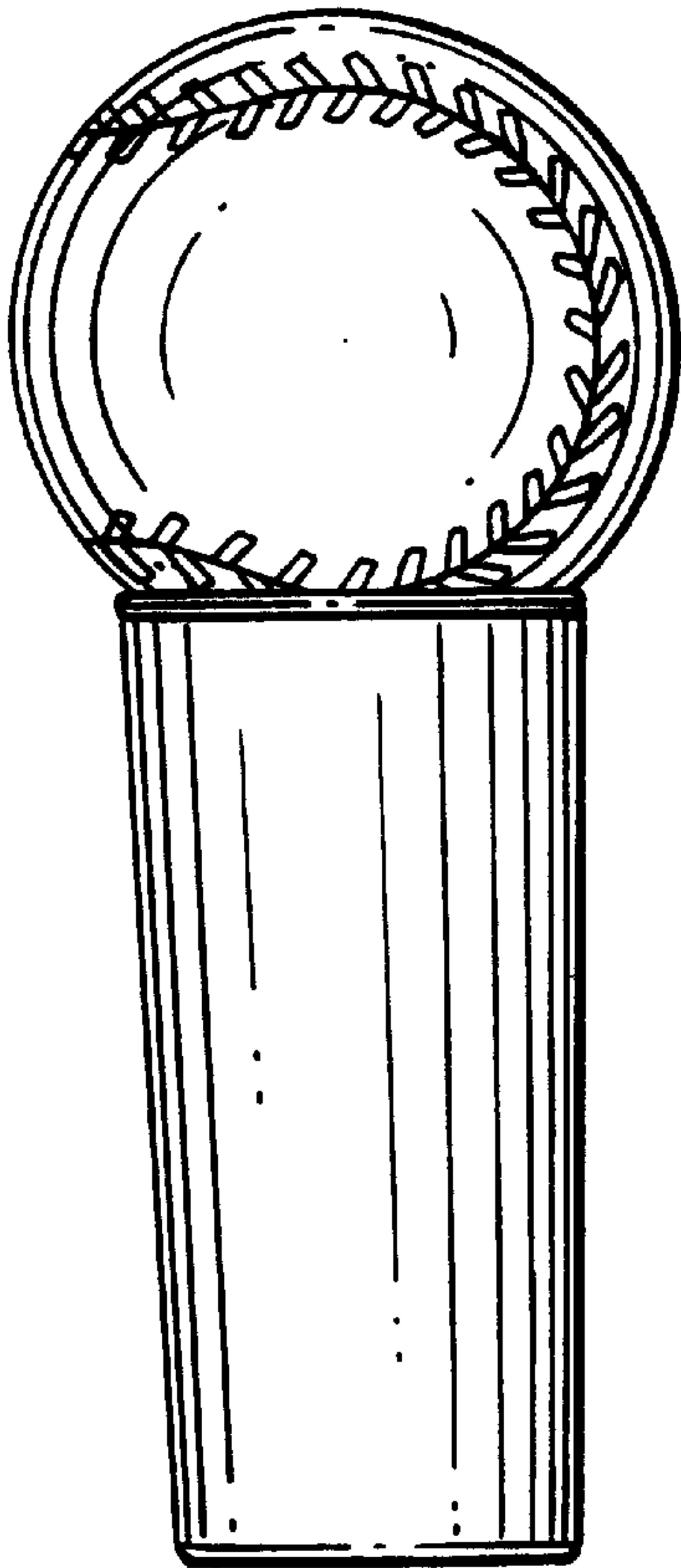

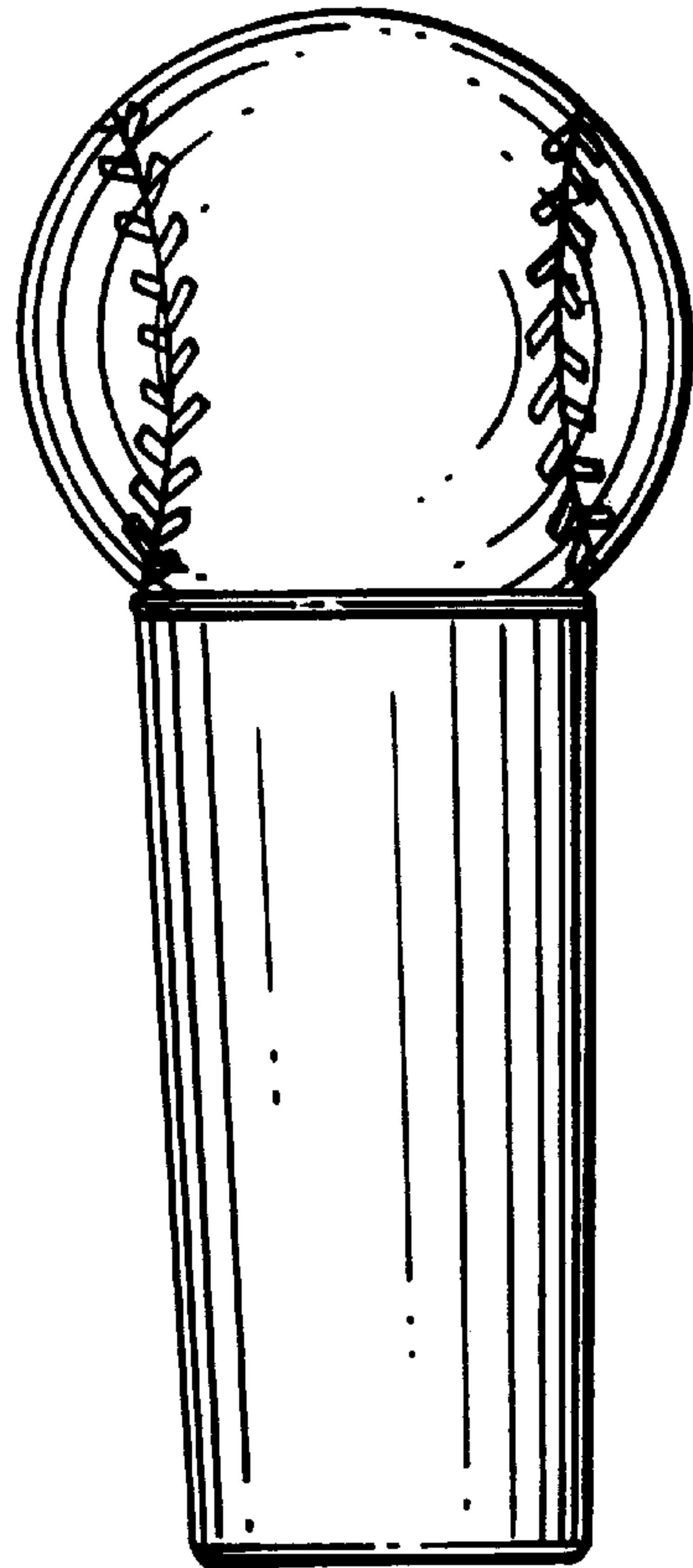




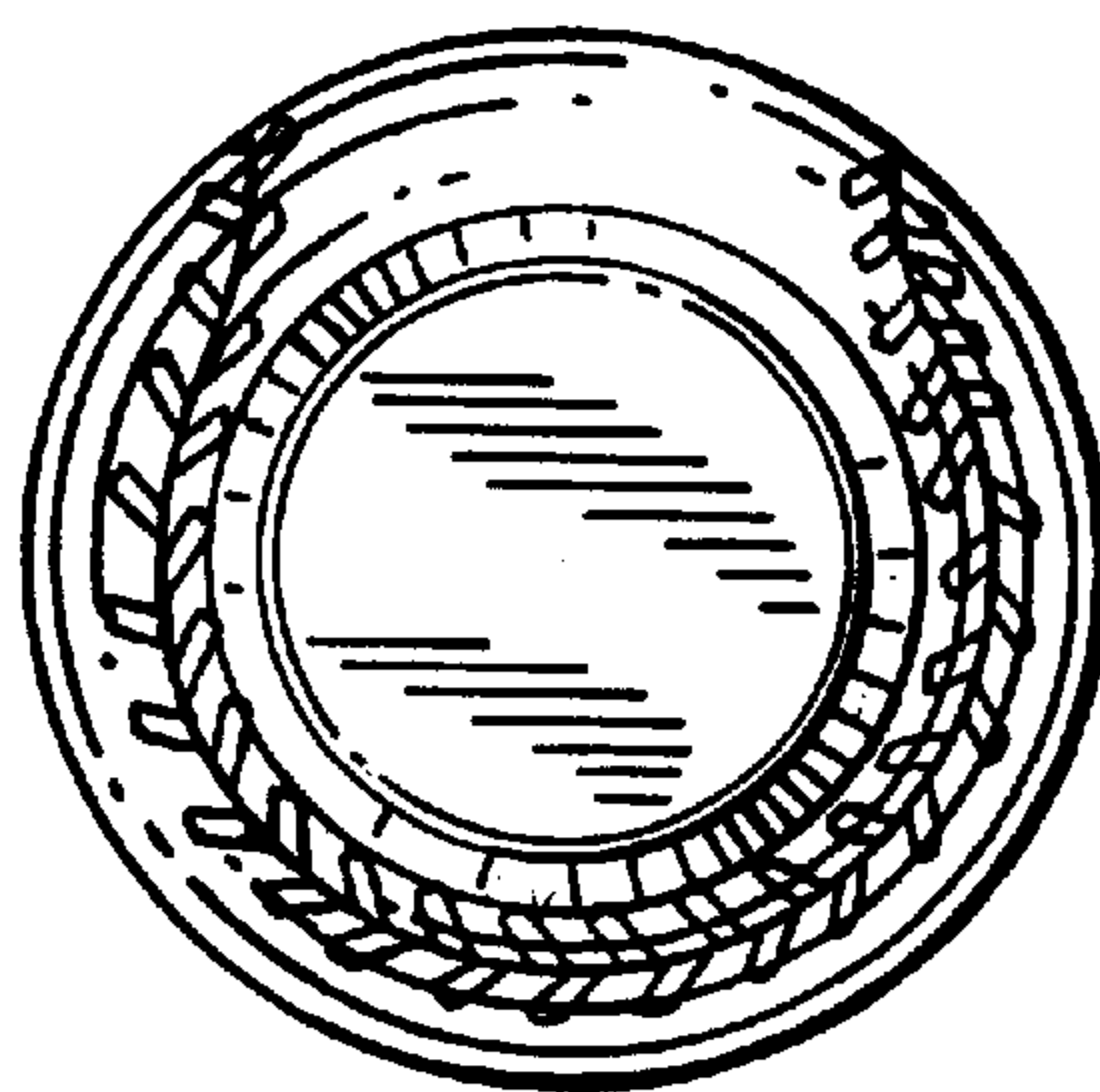

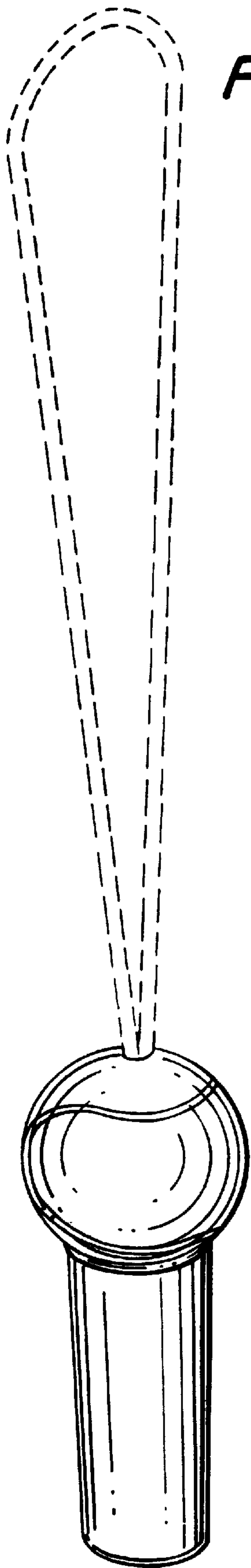

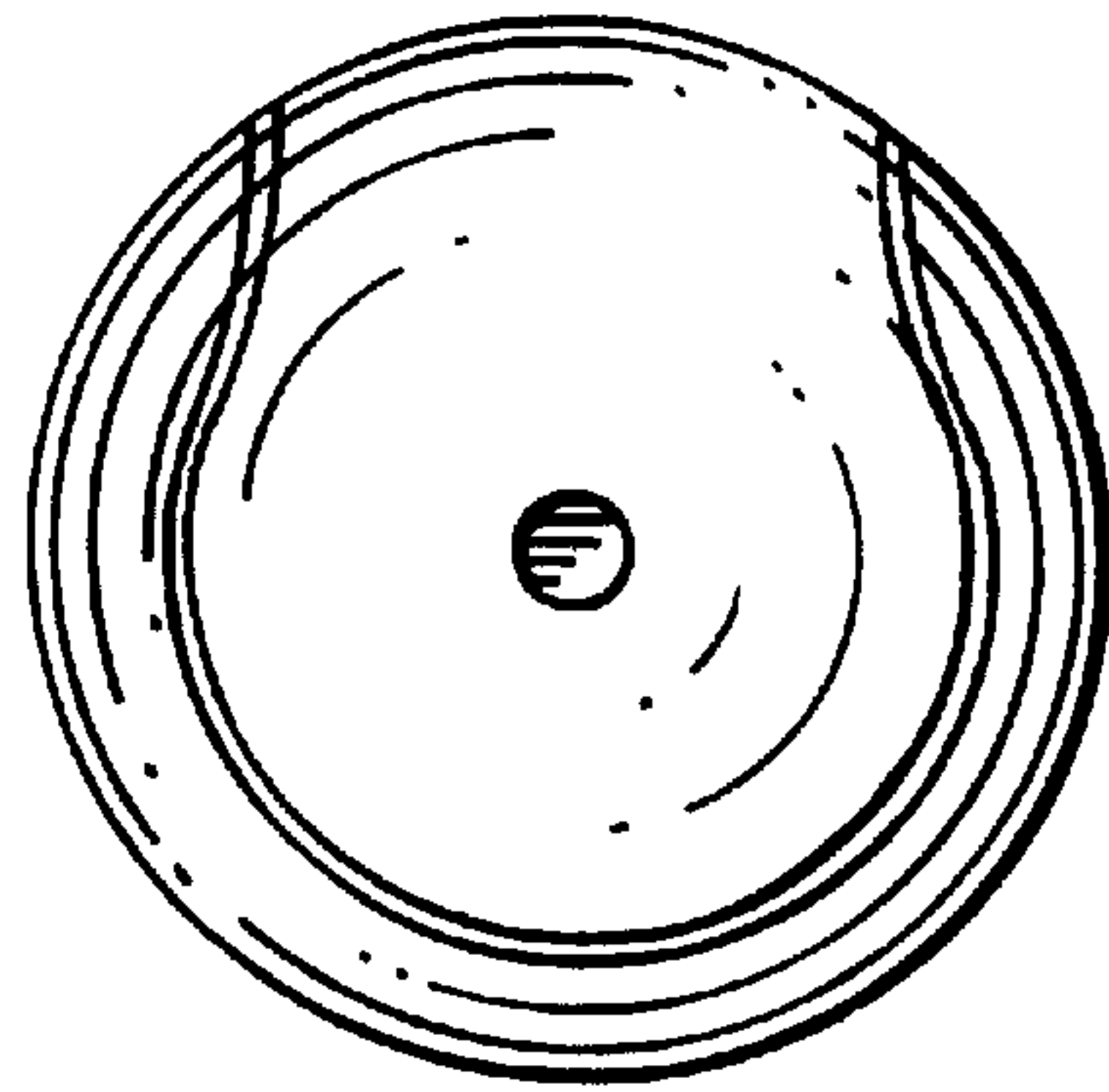

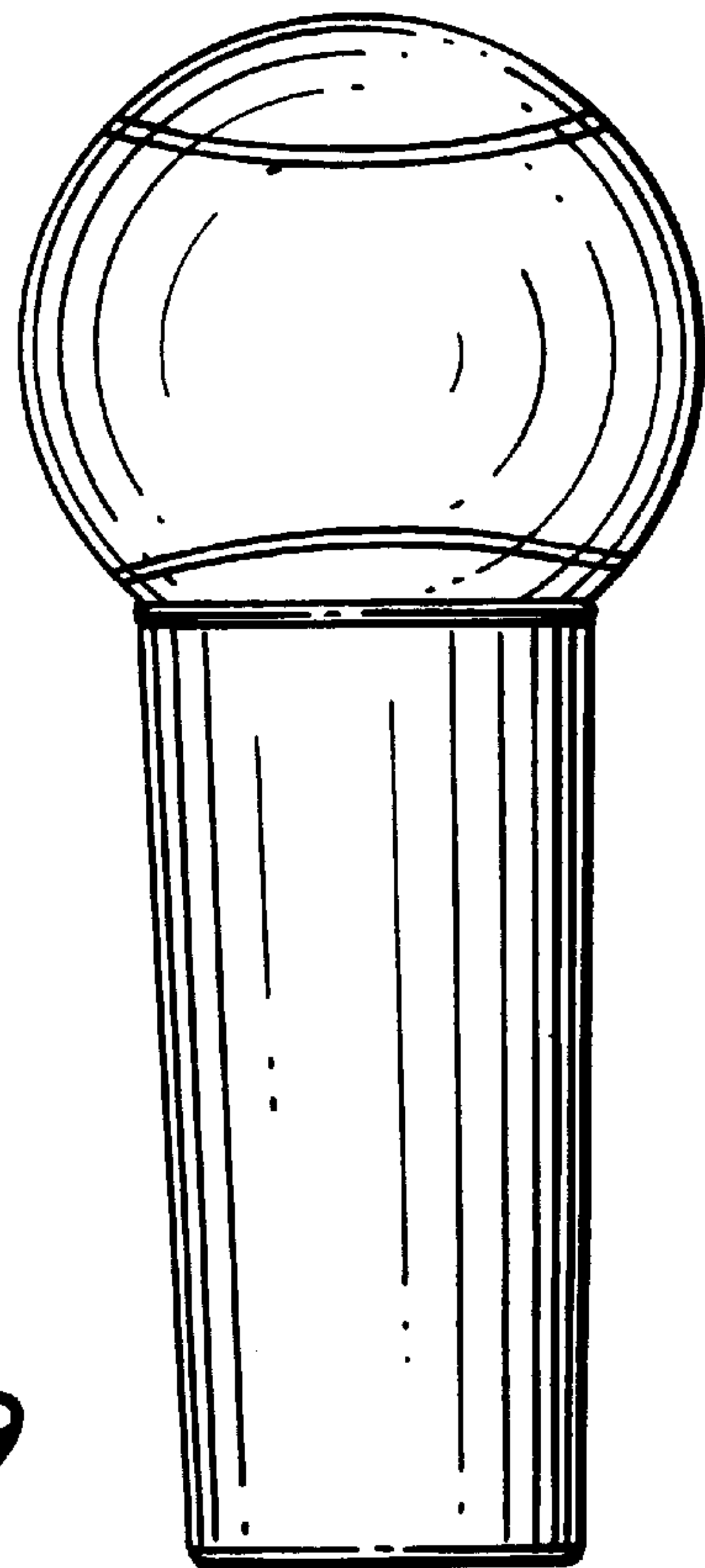

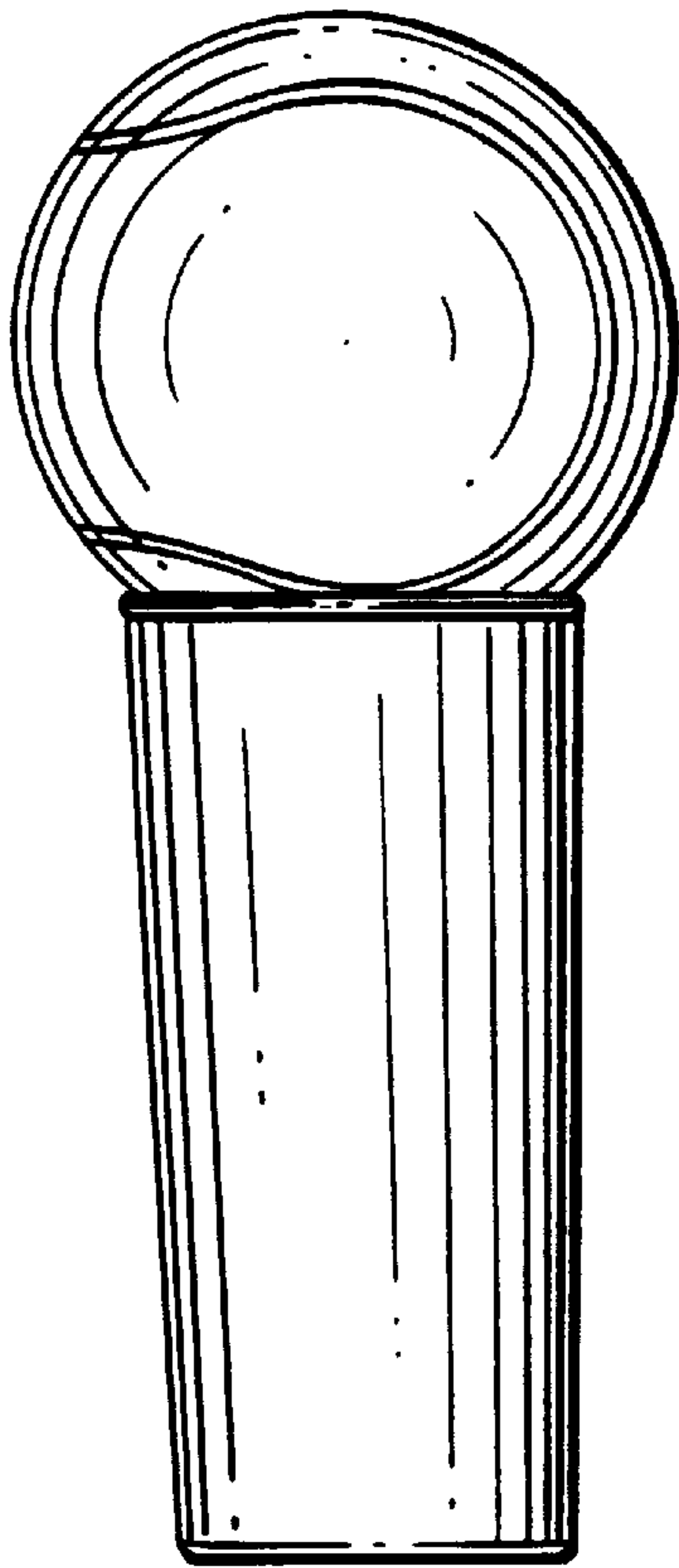

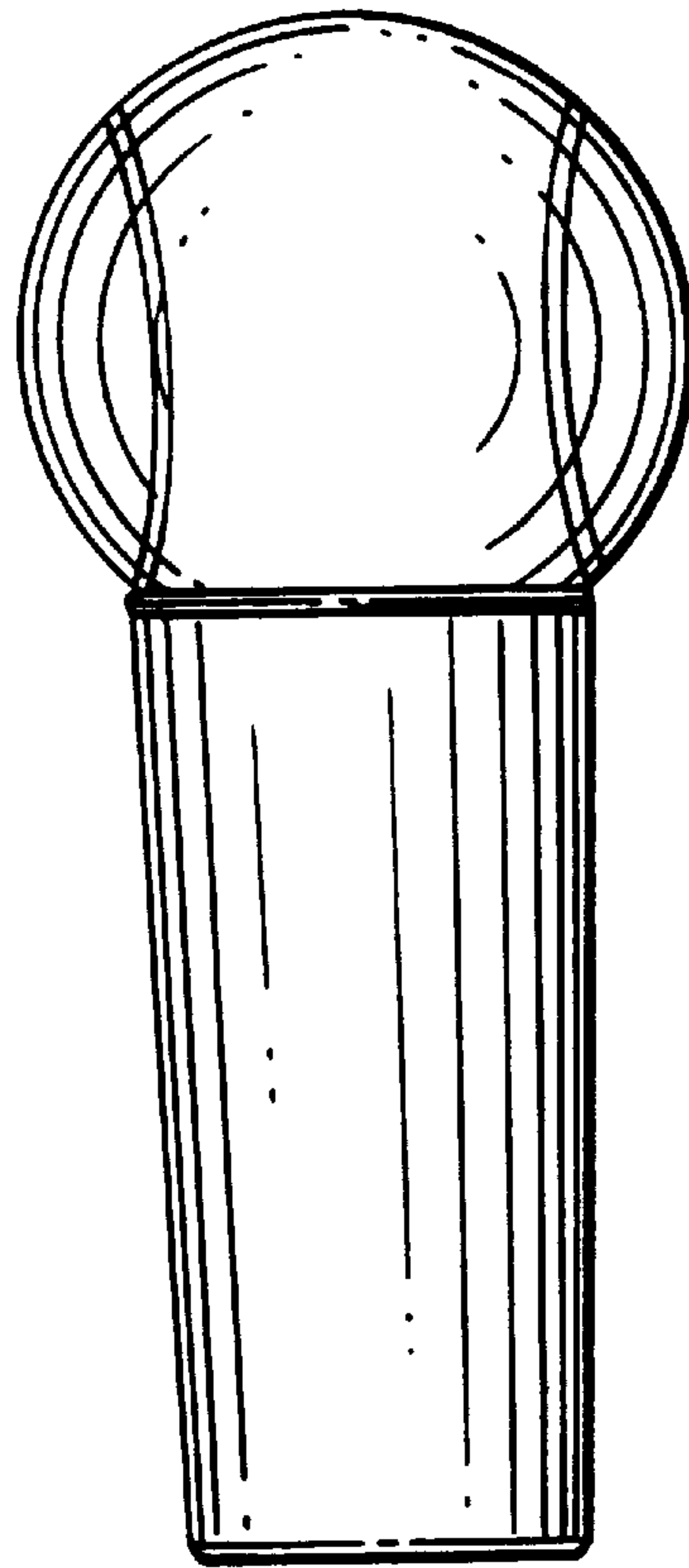

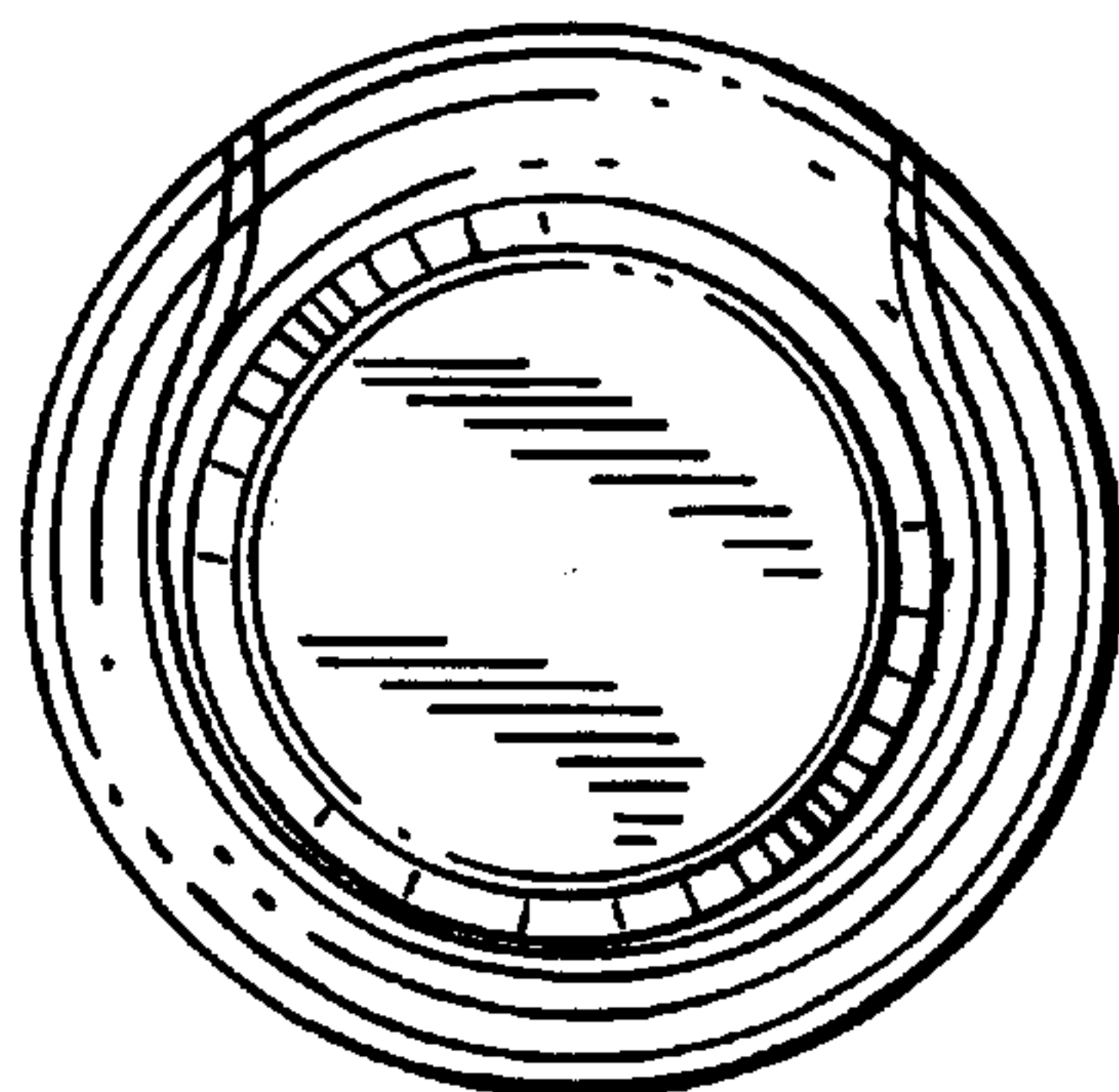

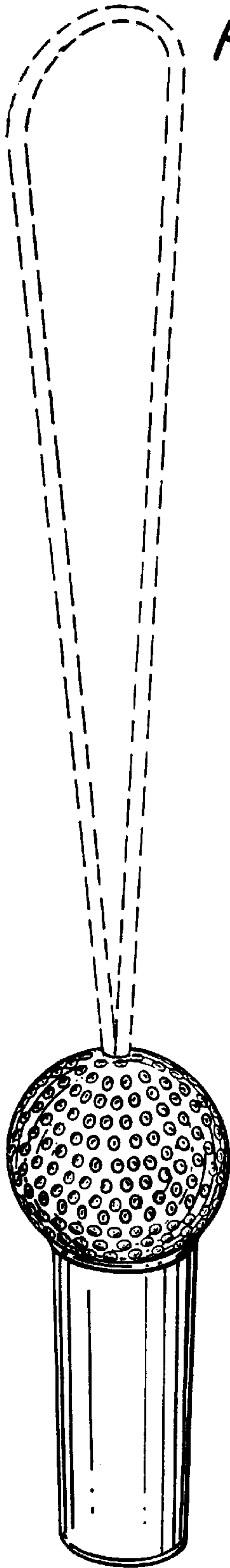

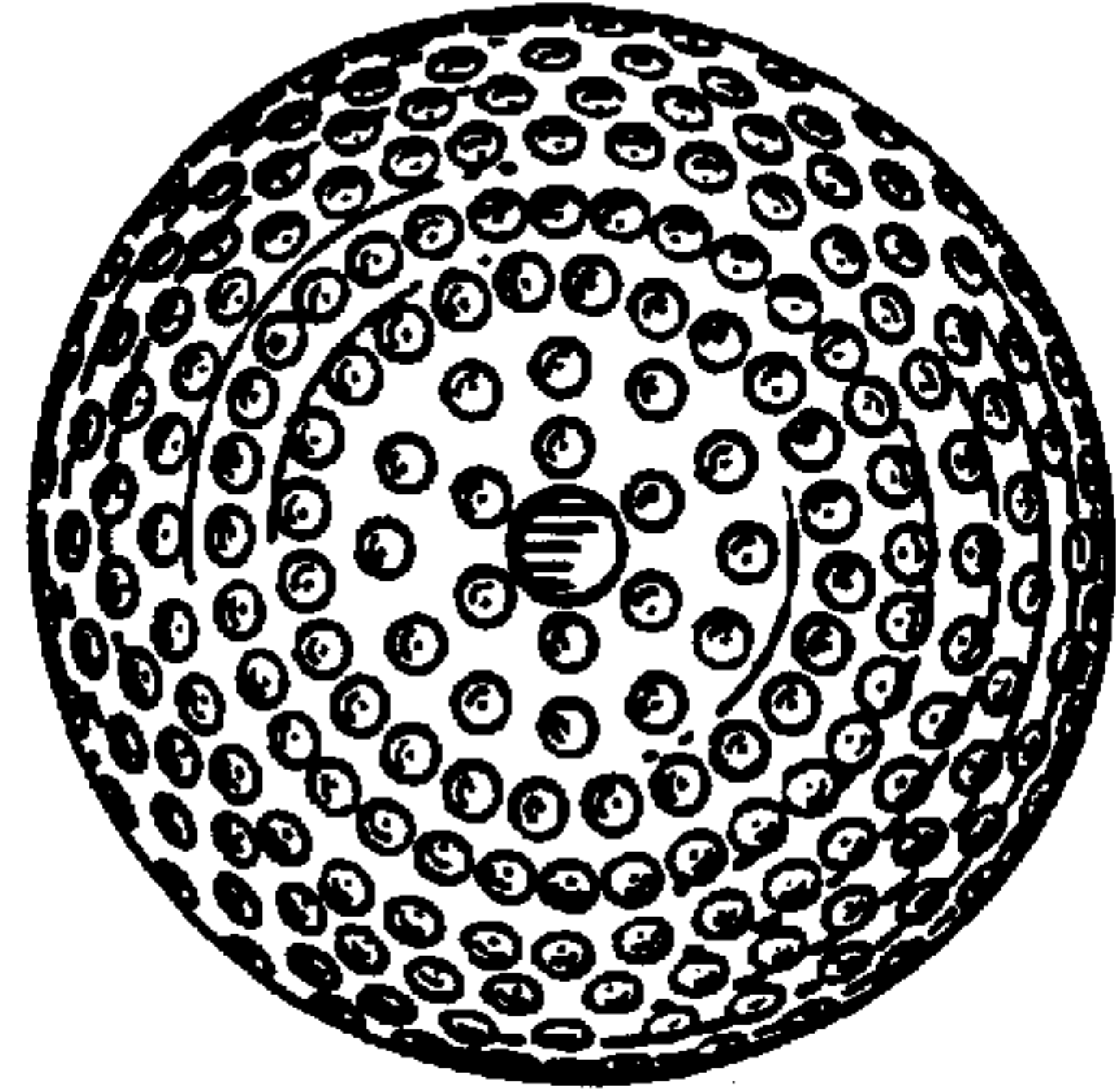

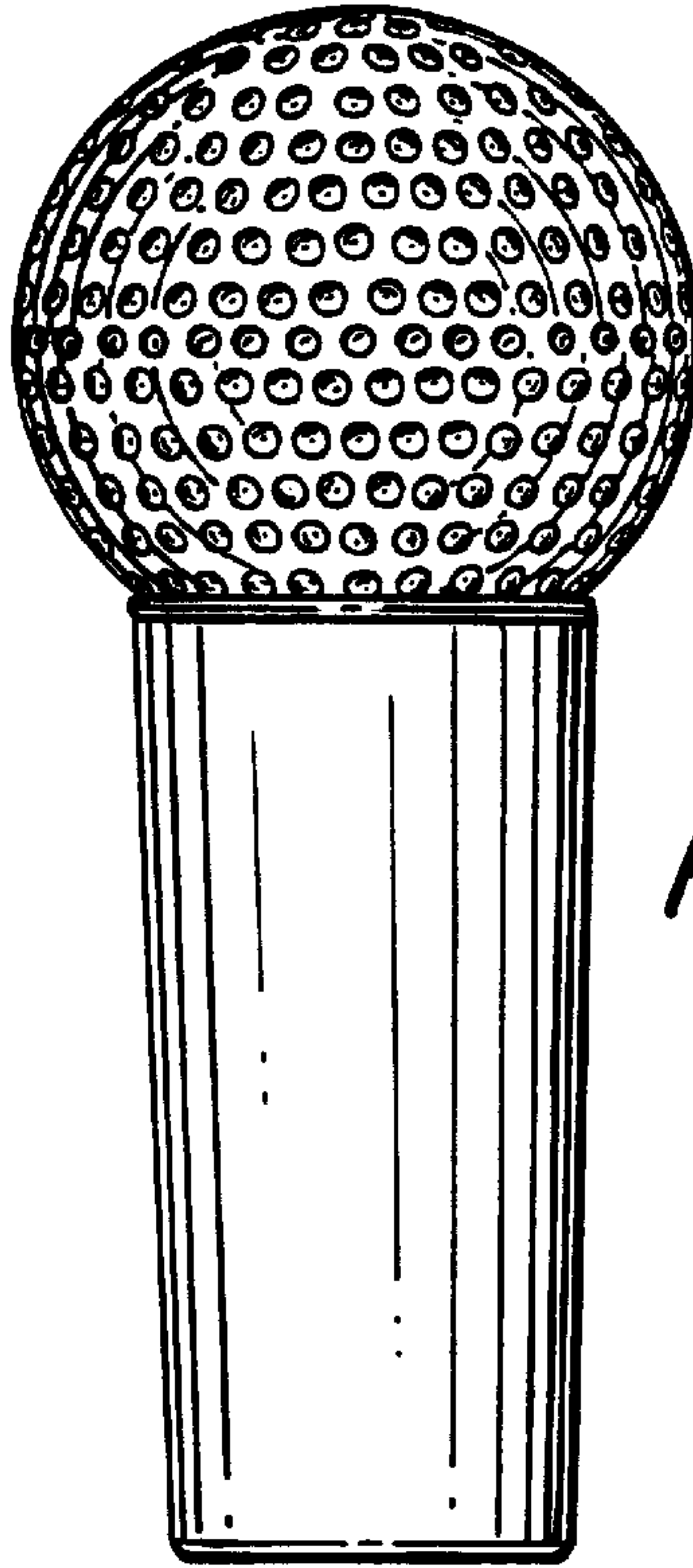

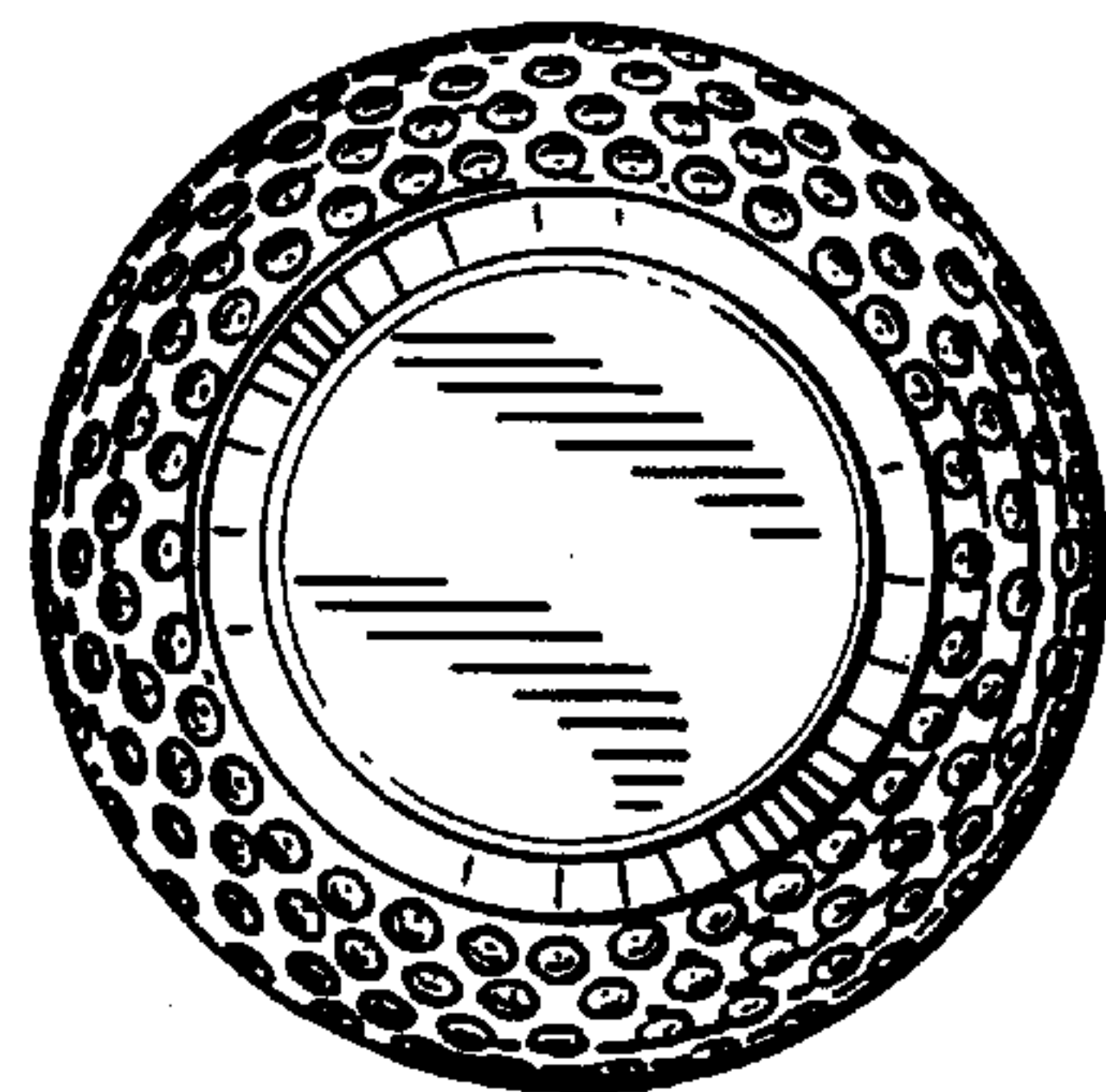
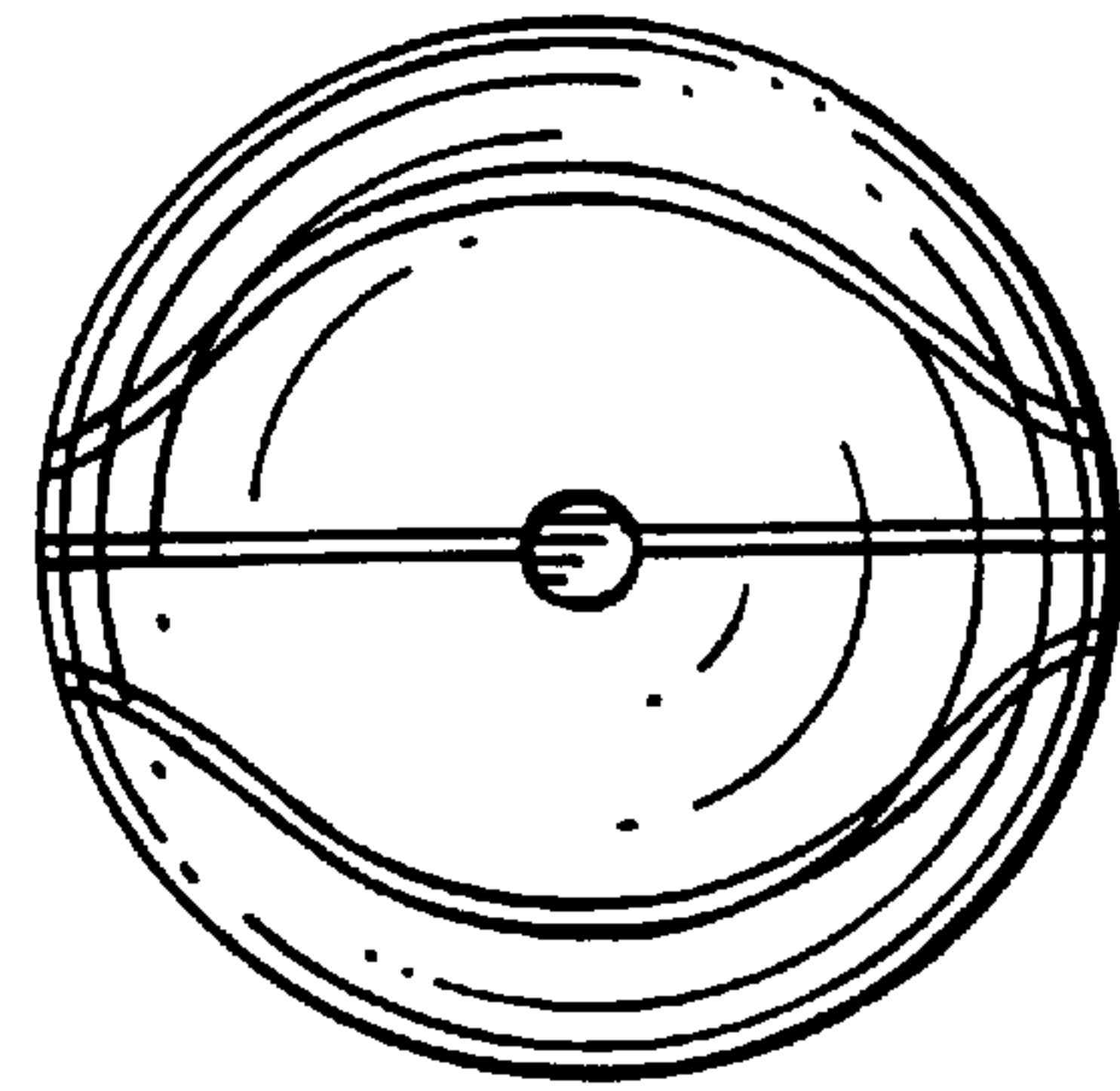
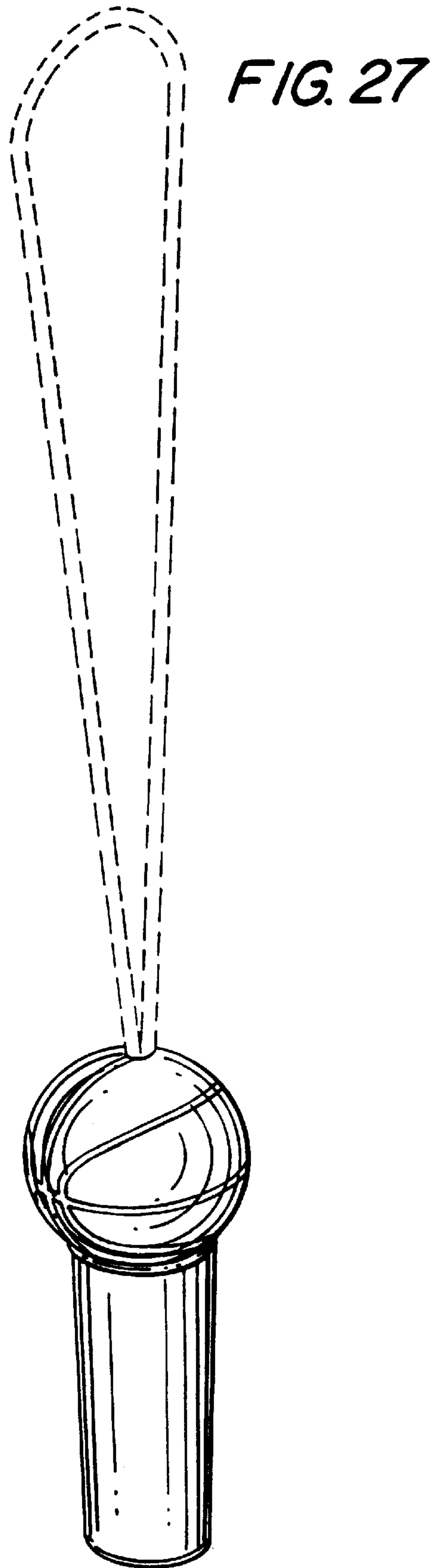
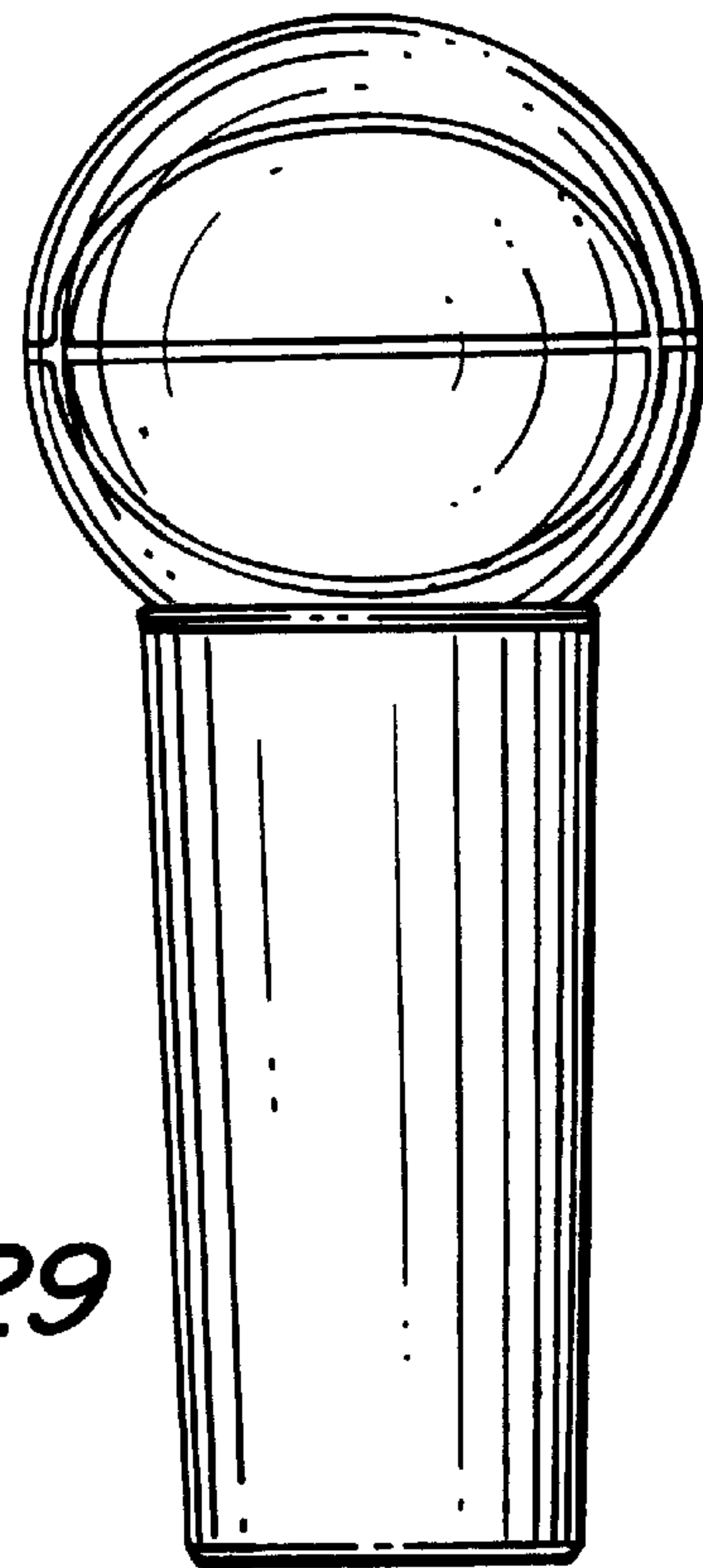

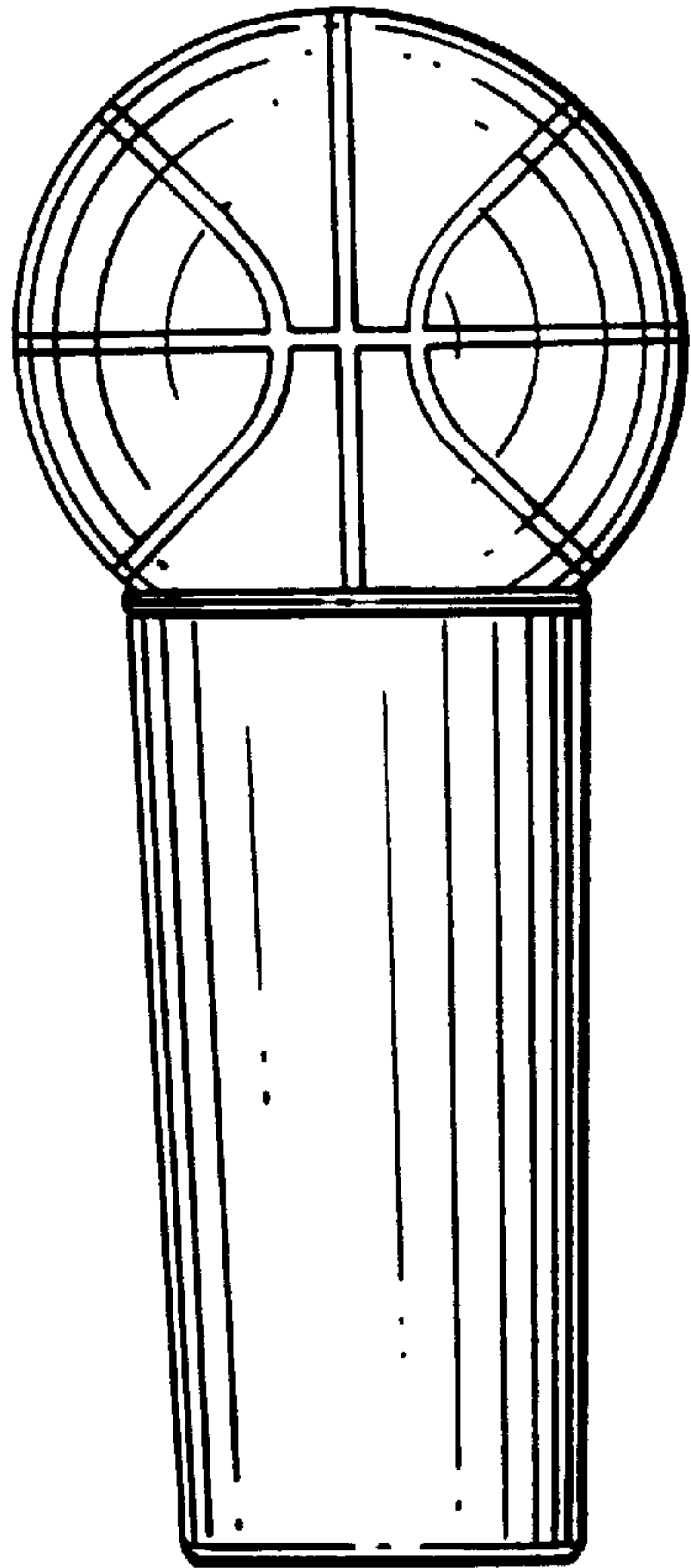

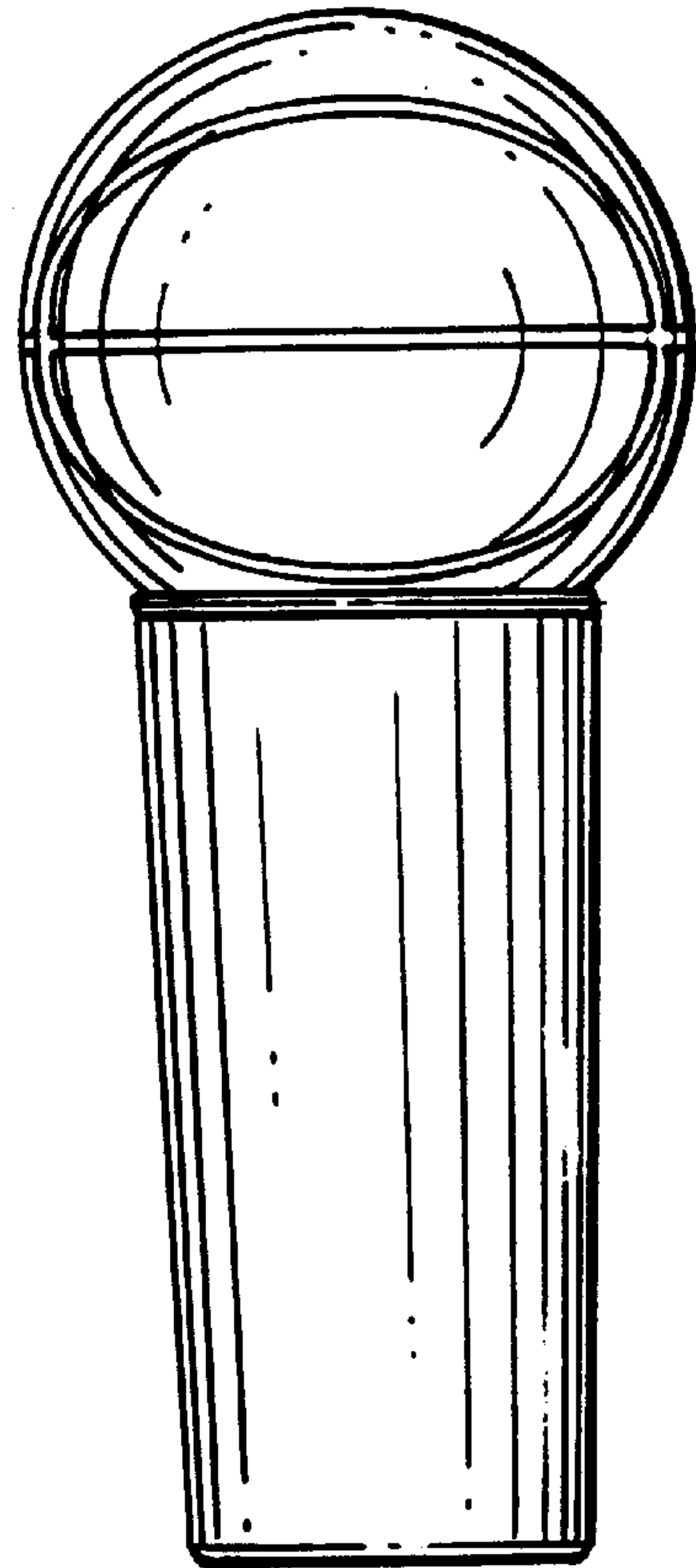

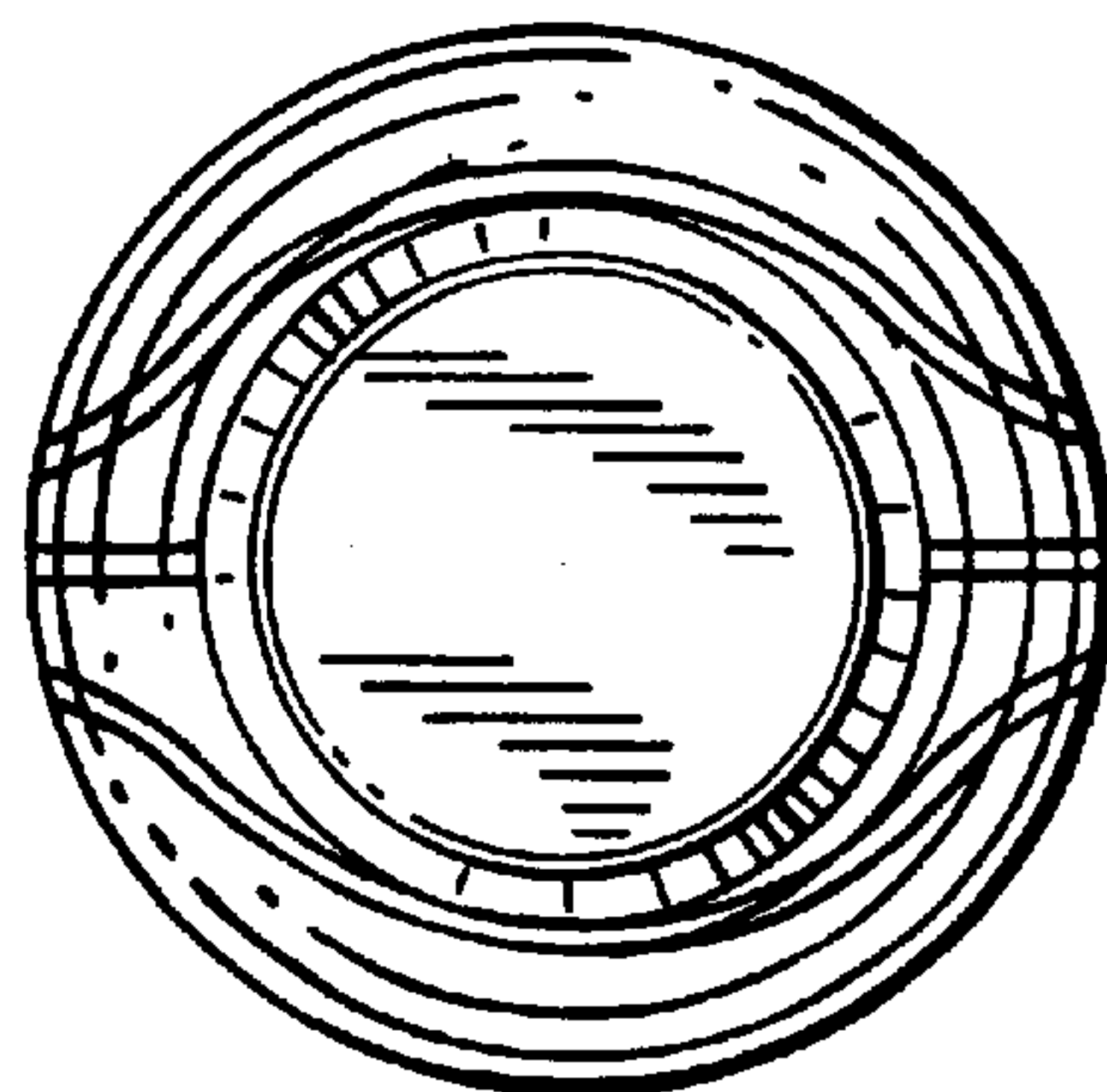

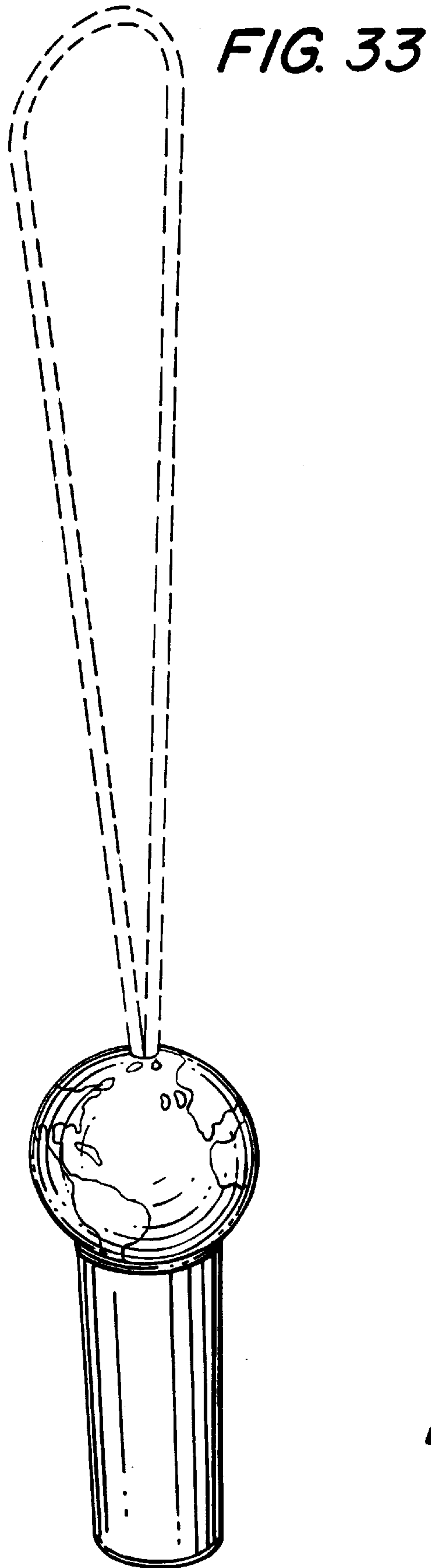

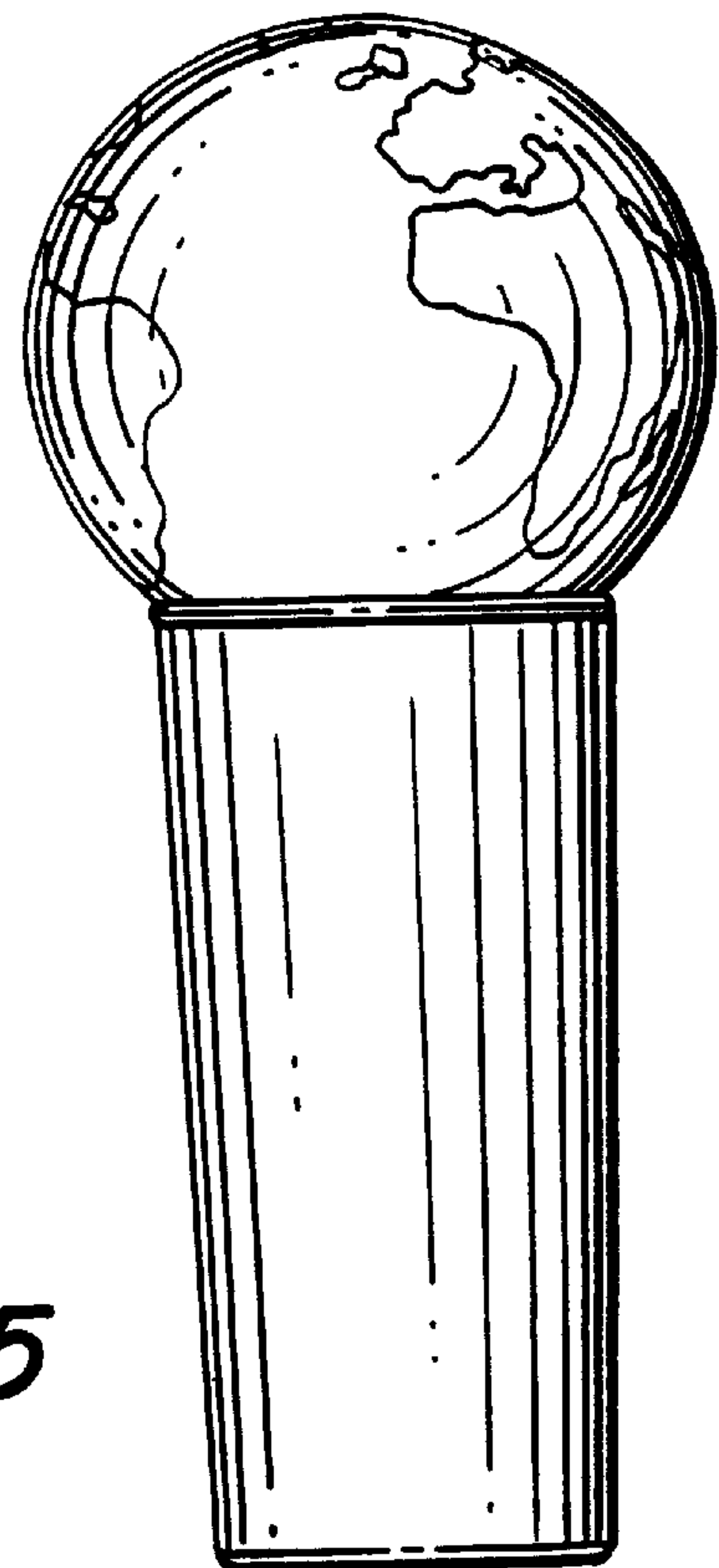

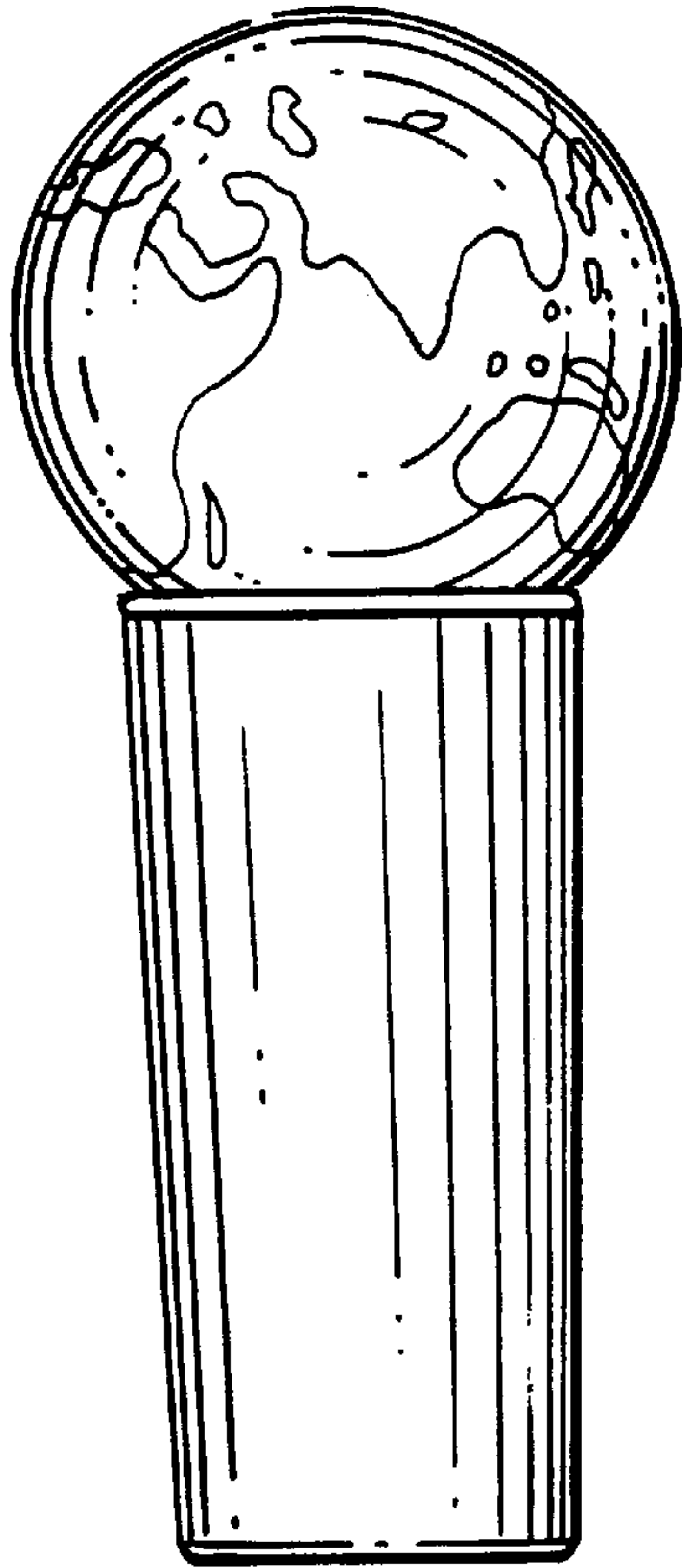

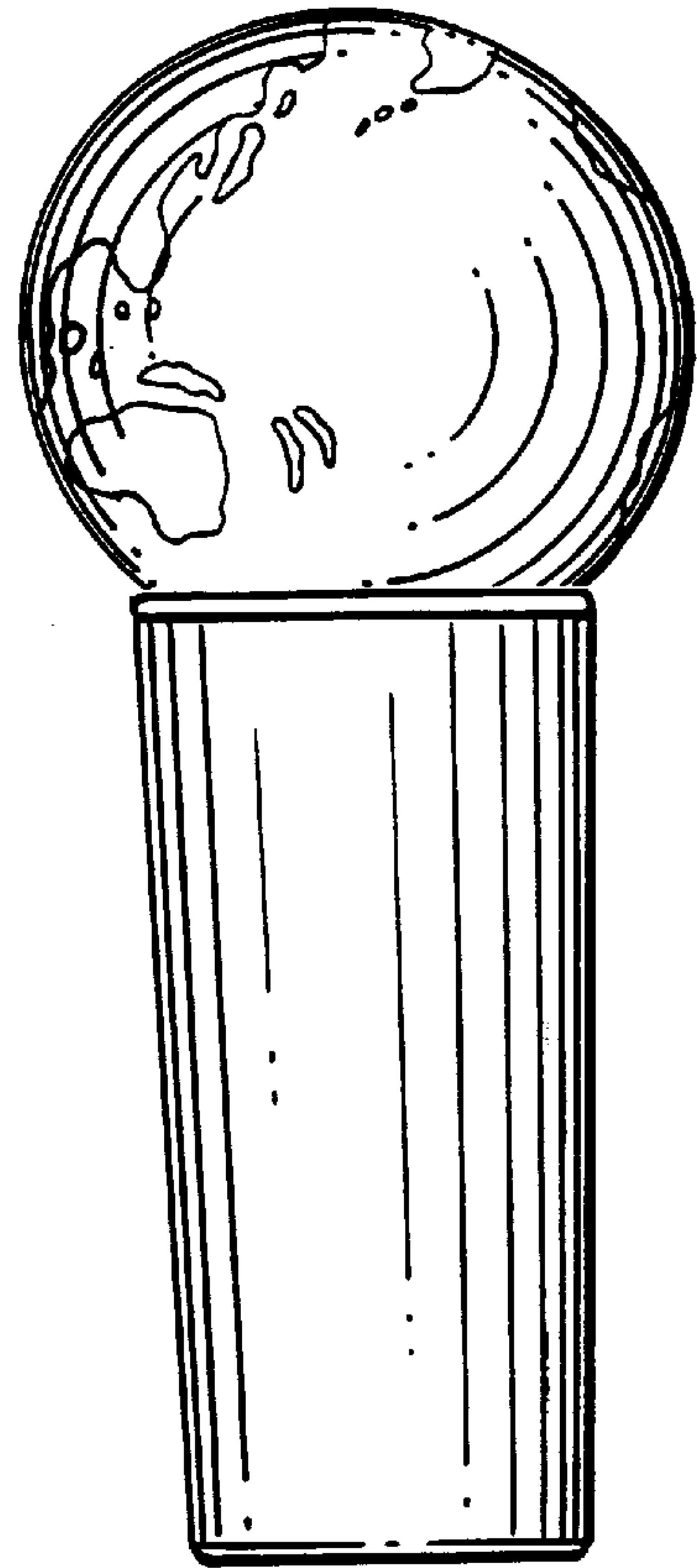
