(57) **CLAIM**

We claim the ornamental design for a beverage dispenser, as shown.

DESCRIPTION

FIG. 1 is a top front right side perspective view of a beverage dispenser showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a rear elevational view thereof; and,

FIG. 6 is a top plan view thereof;

FIG. 7 is a top, front, right side perspective view of a beverage dispenser showing a second embodiment of our new design;

FIG. 8 is a front elevational view thereof;

FIG. 9 is a left side elevational view thereof;

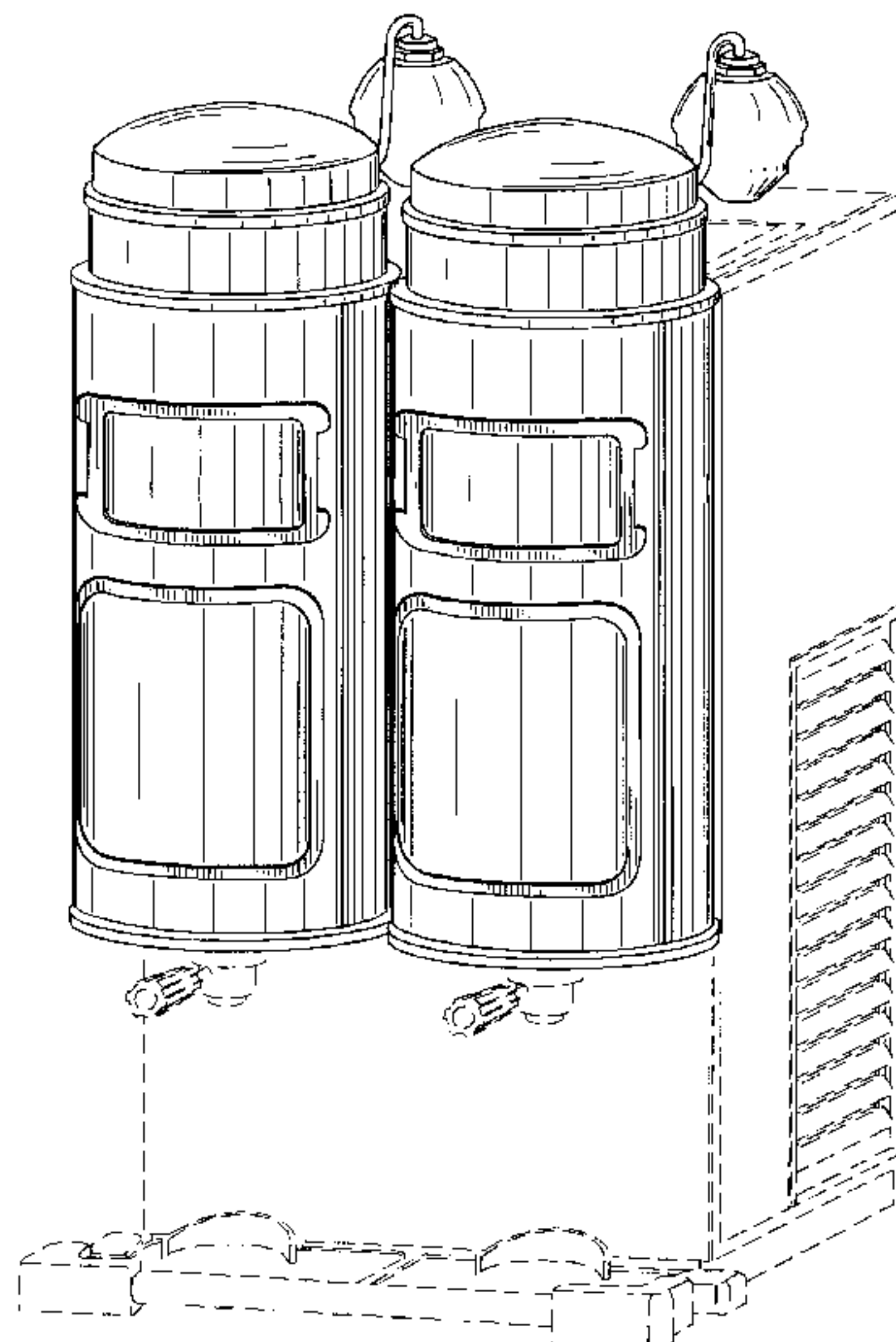
FIG. 10 is a right side elevational view thereof;

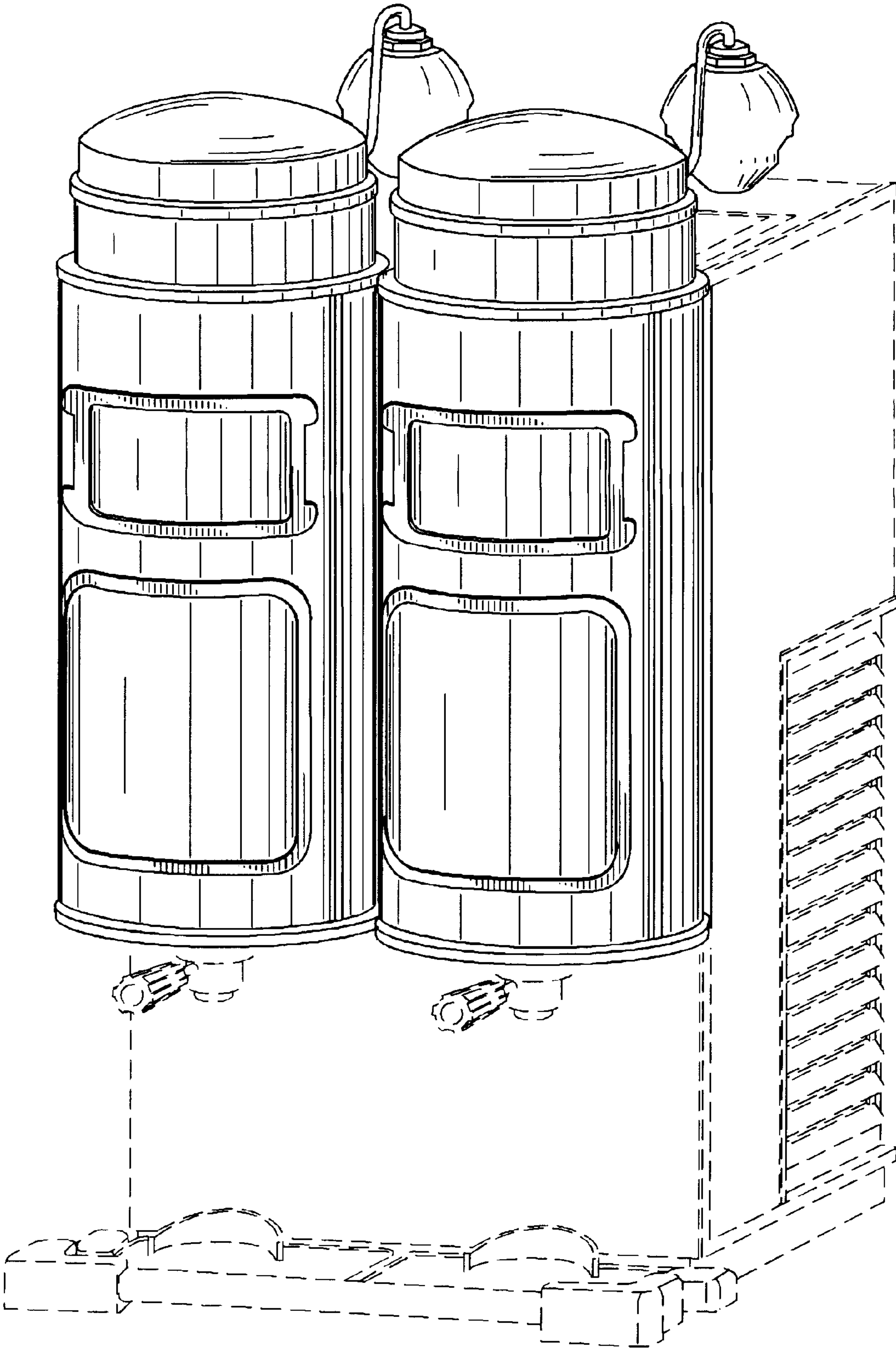

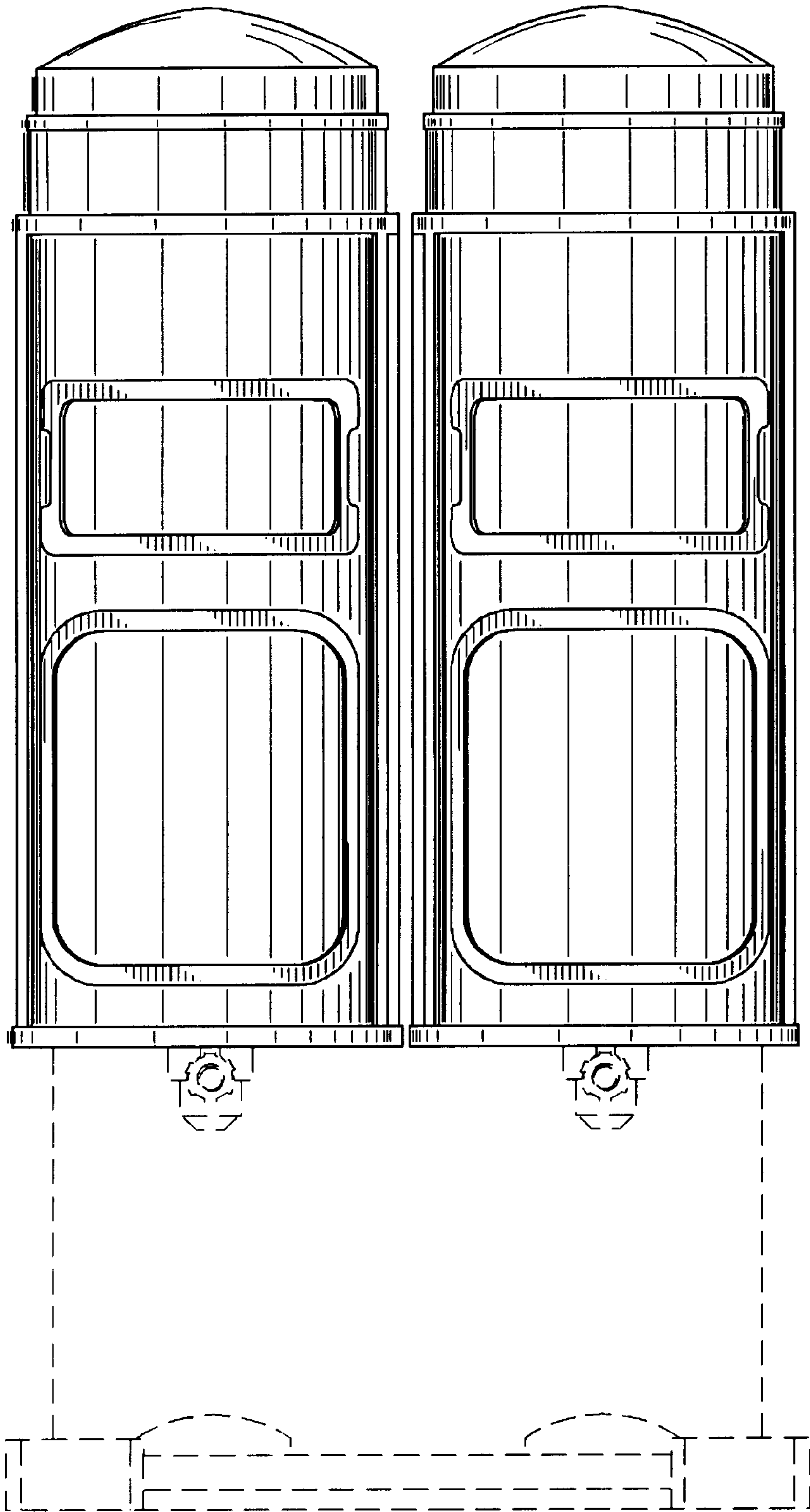

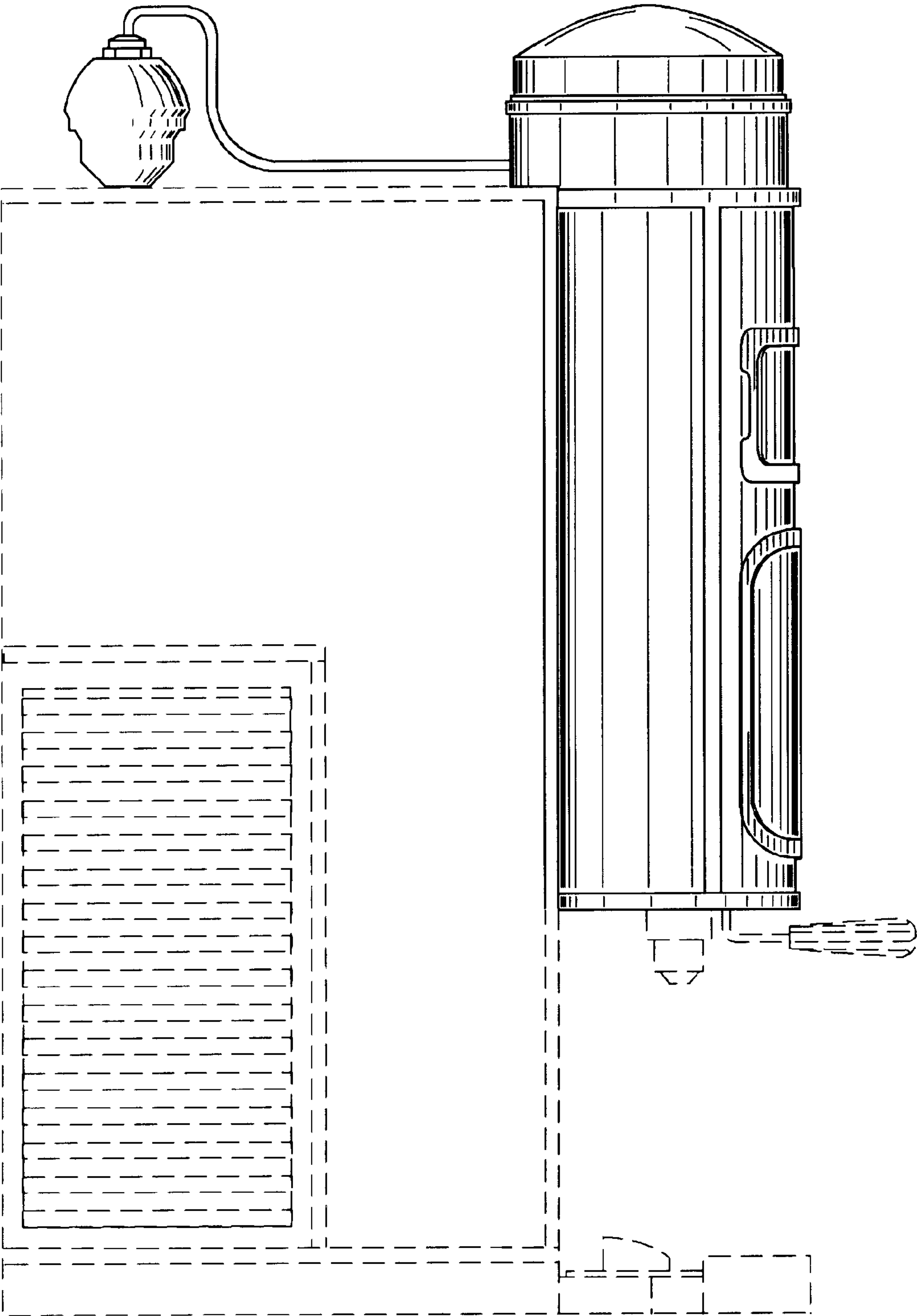

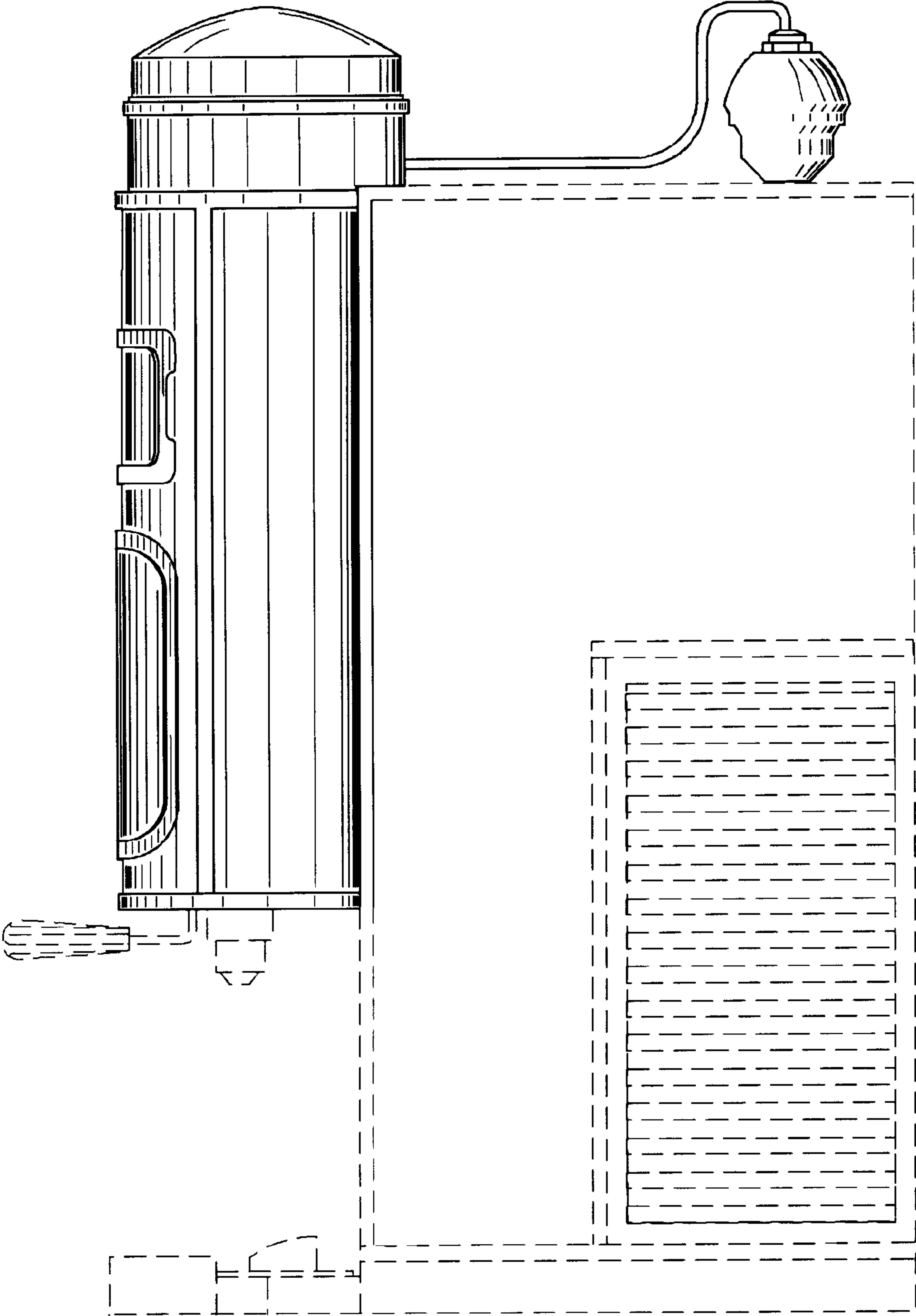

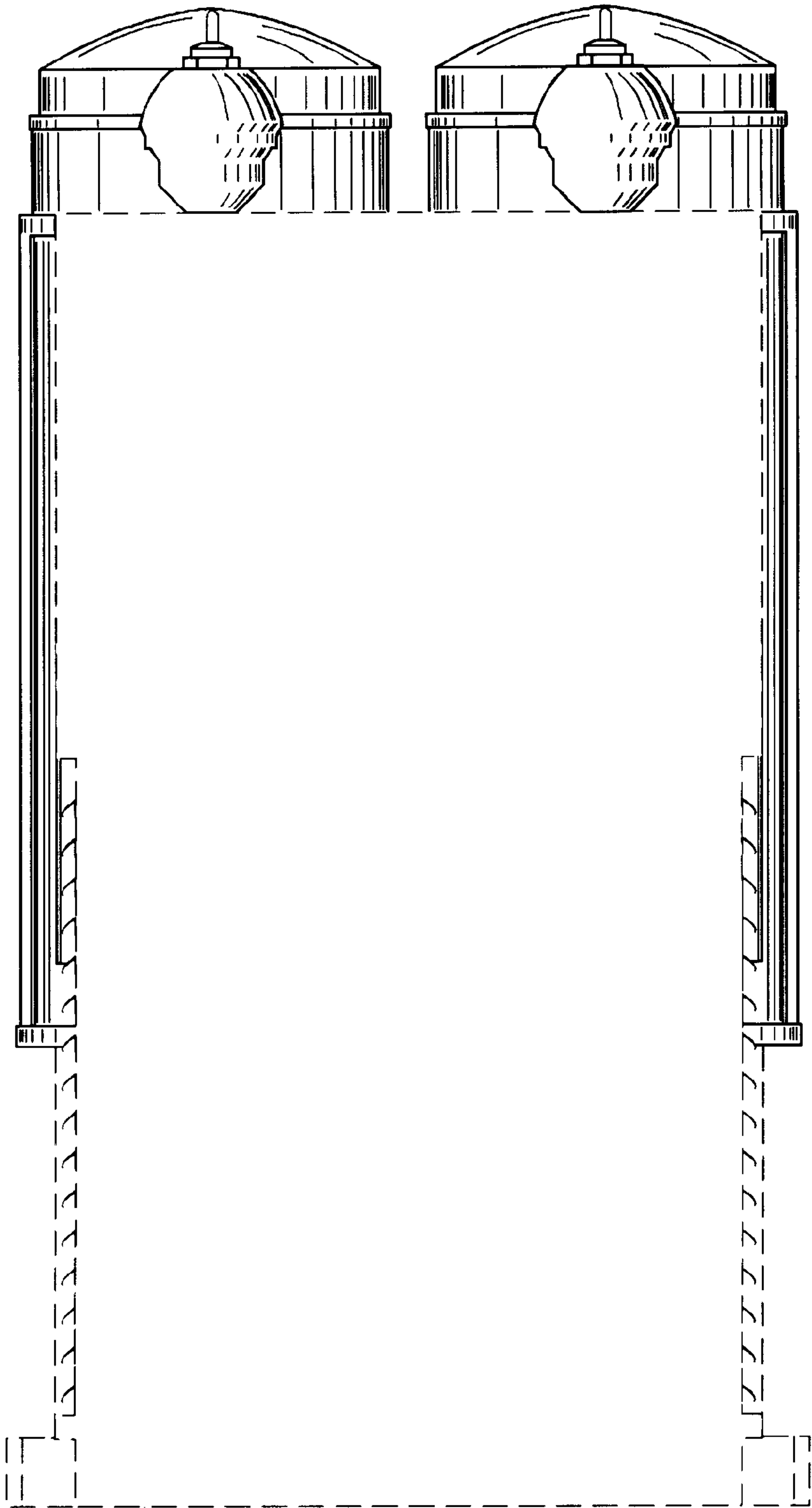

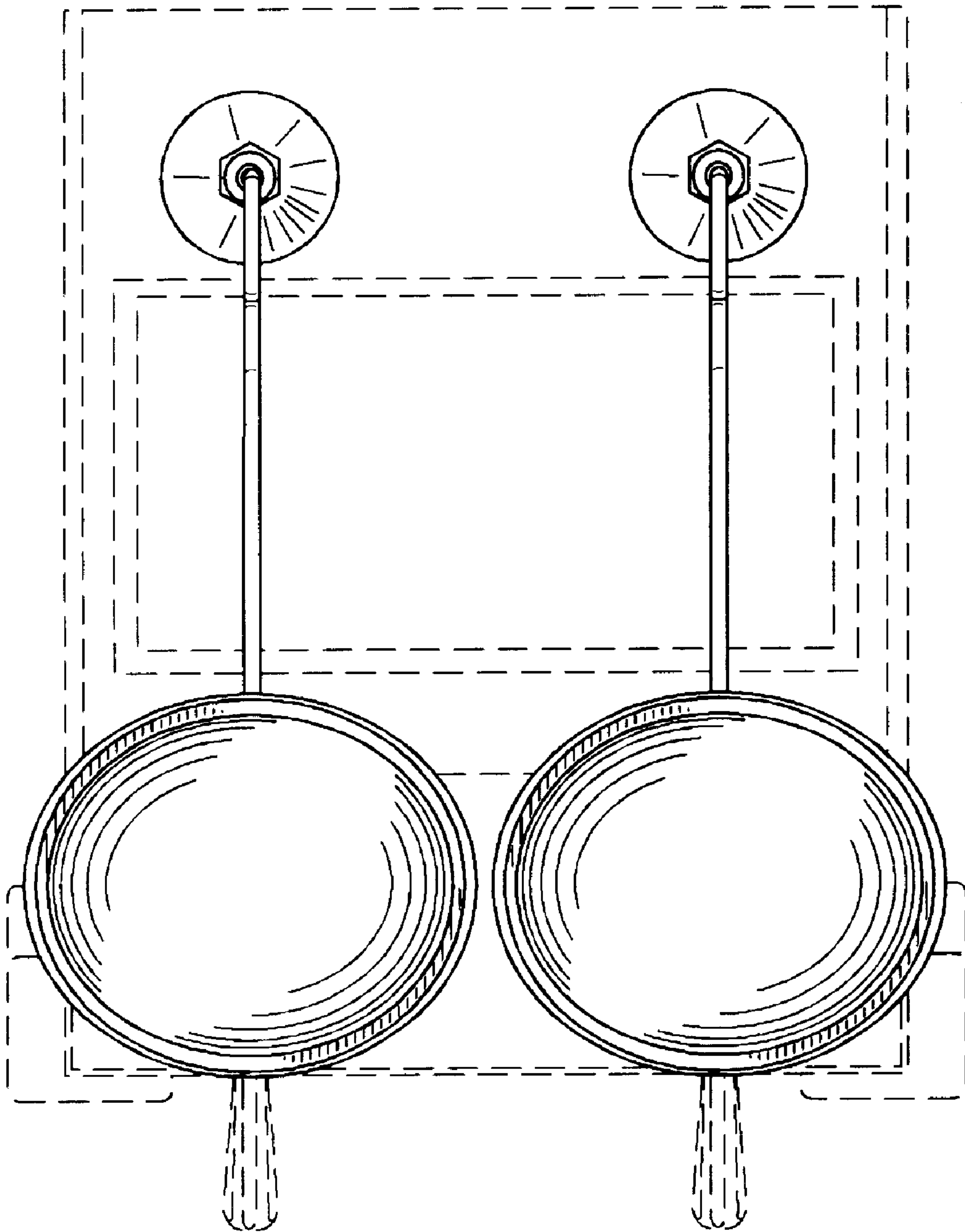

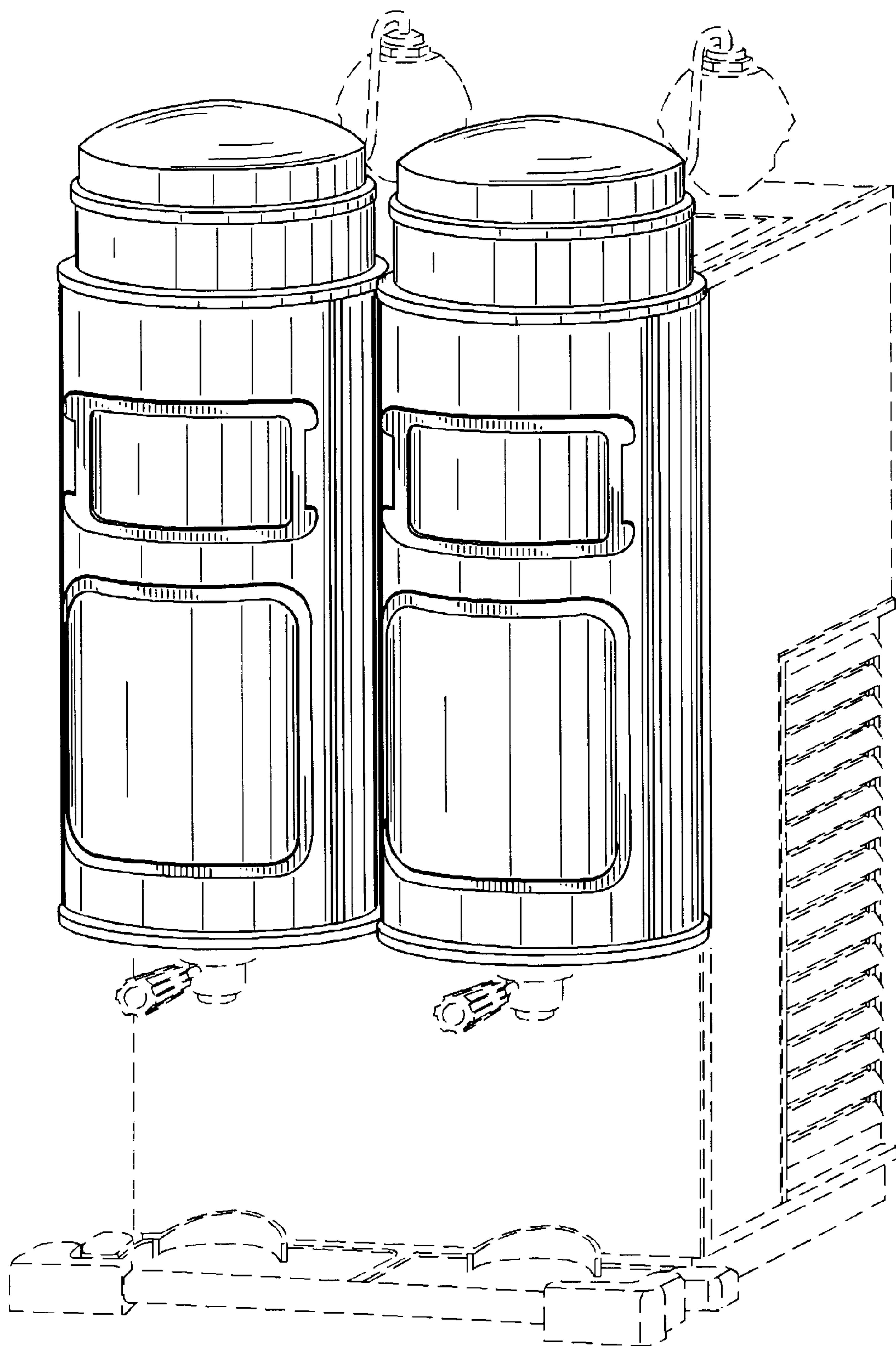

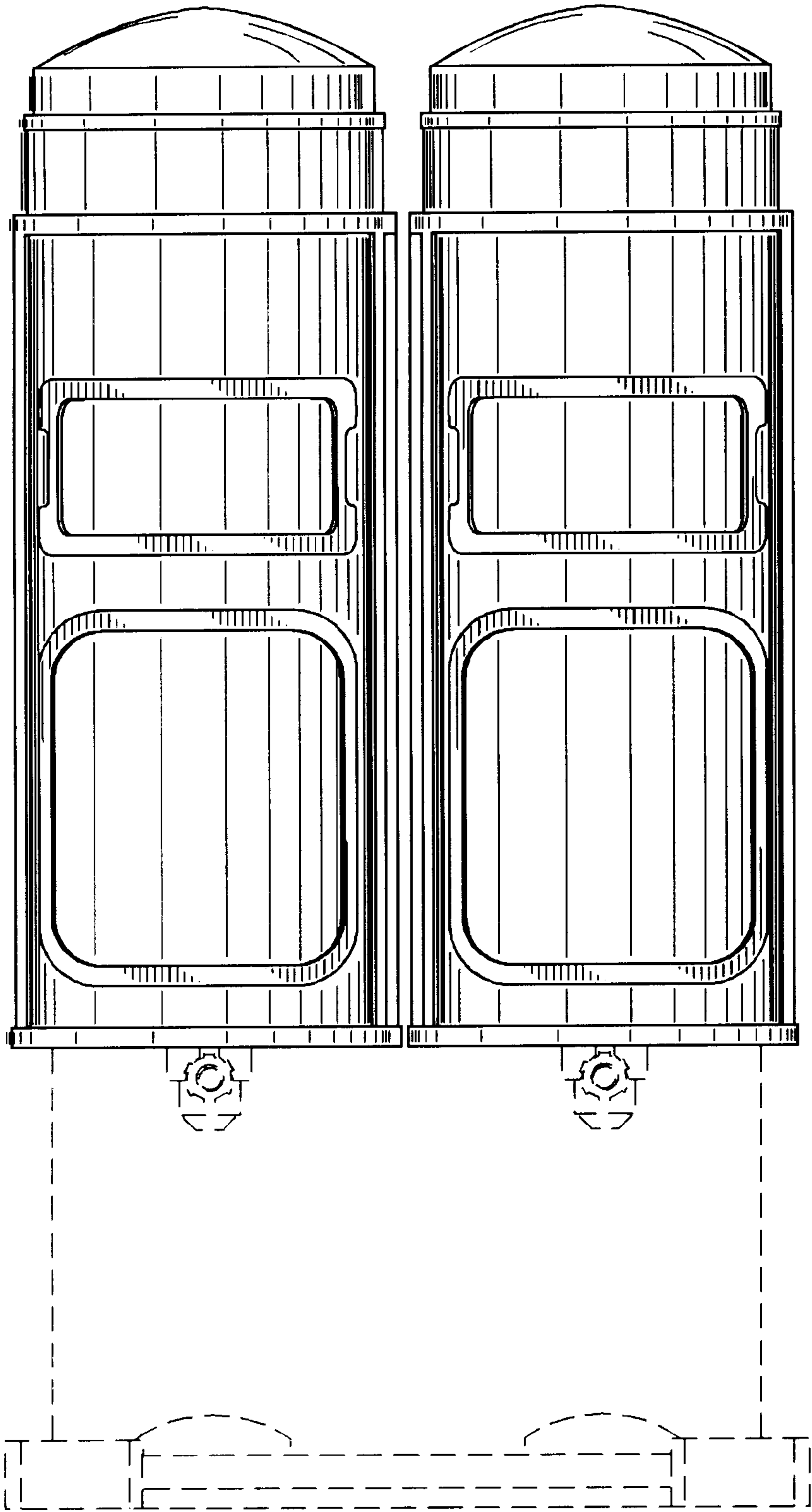

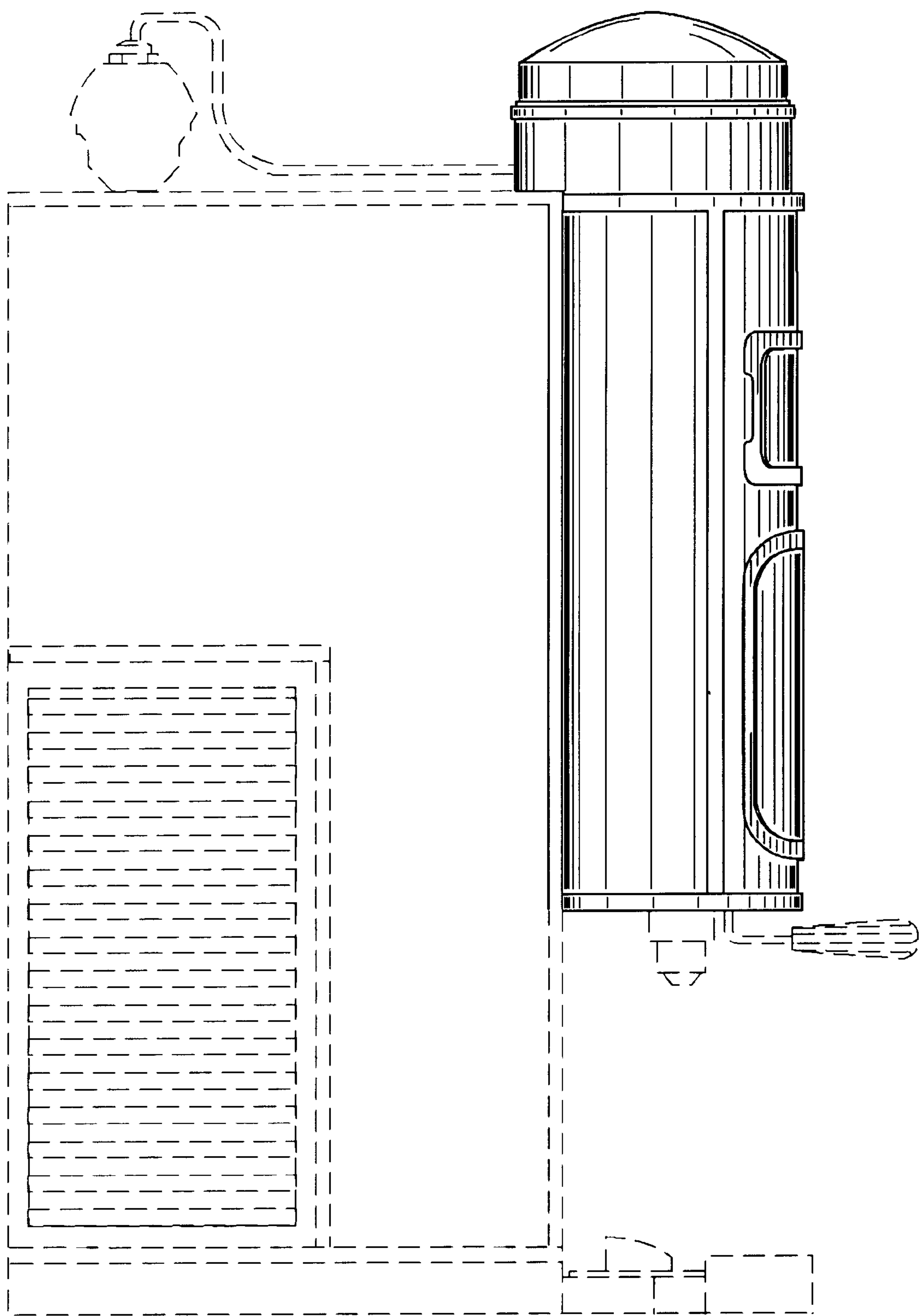

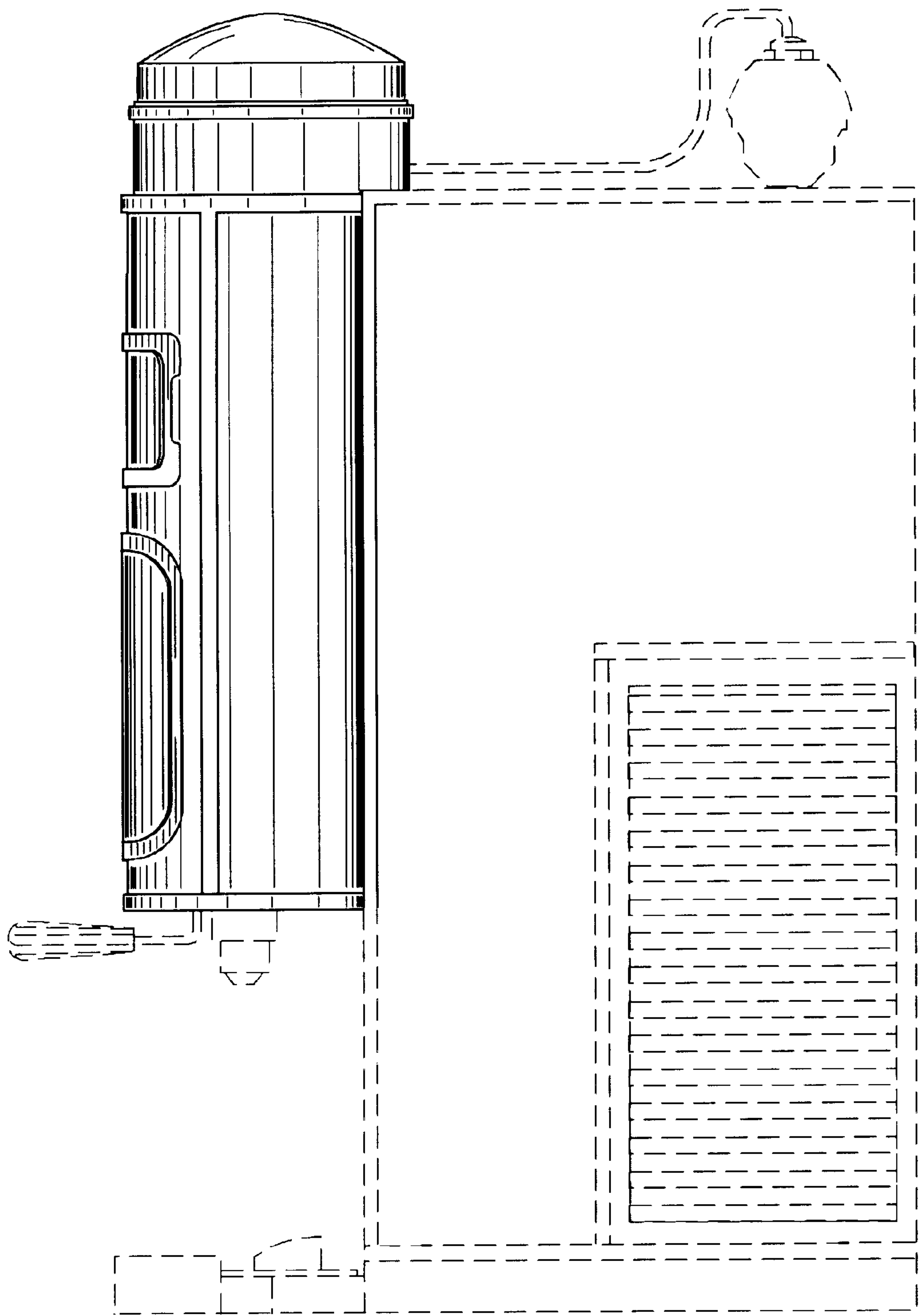

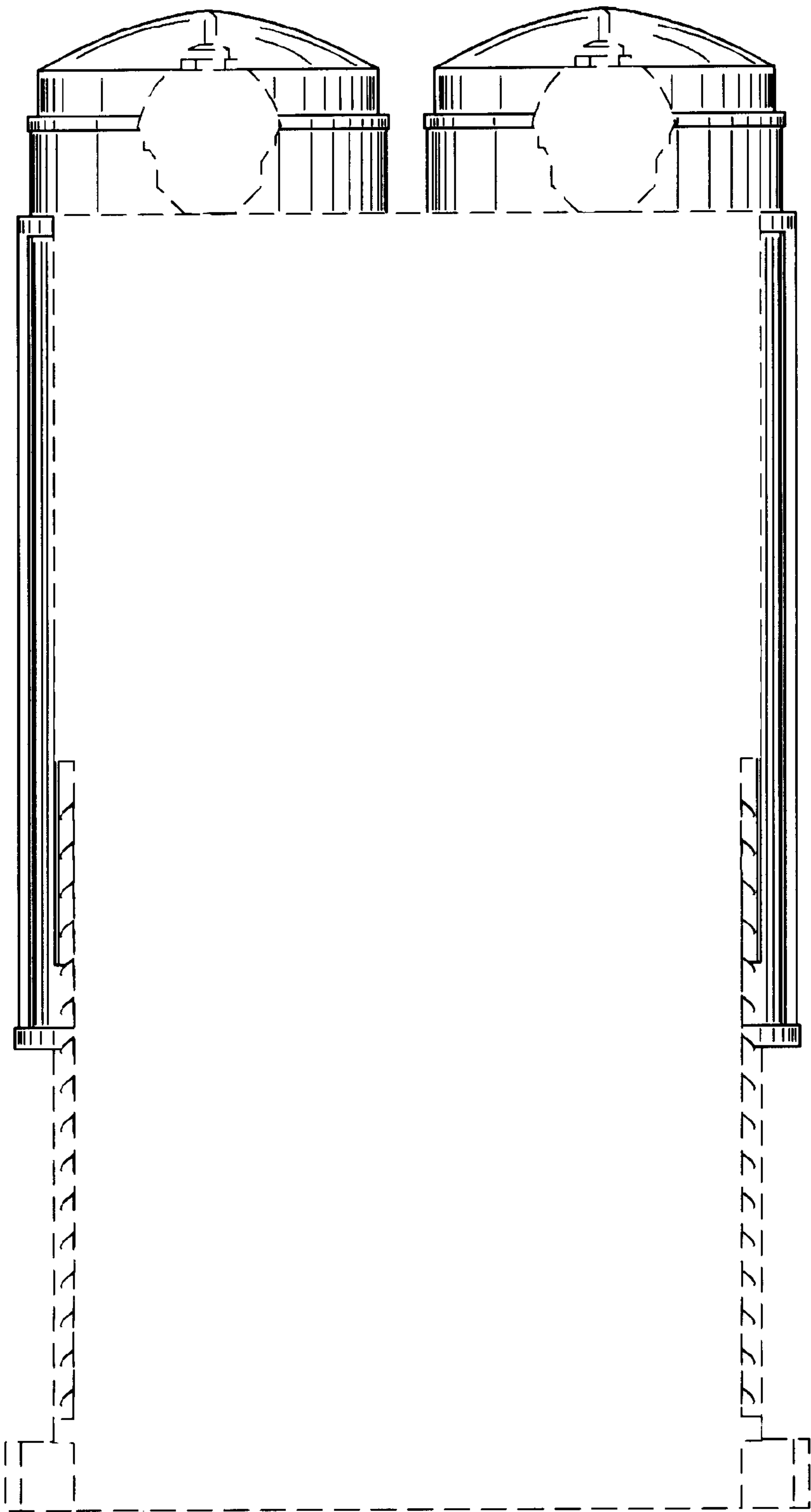

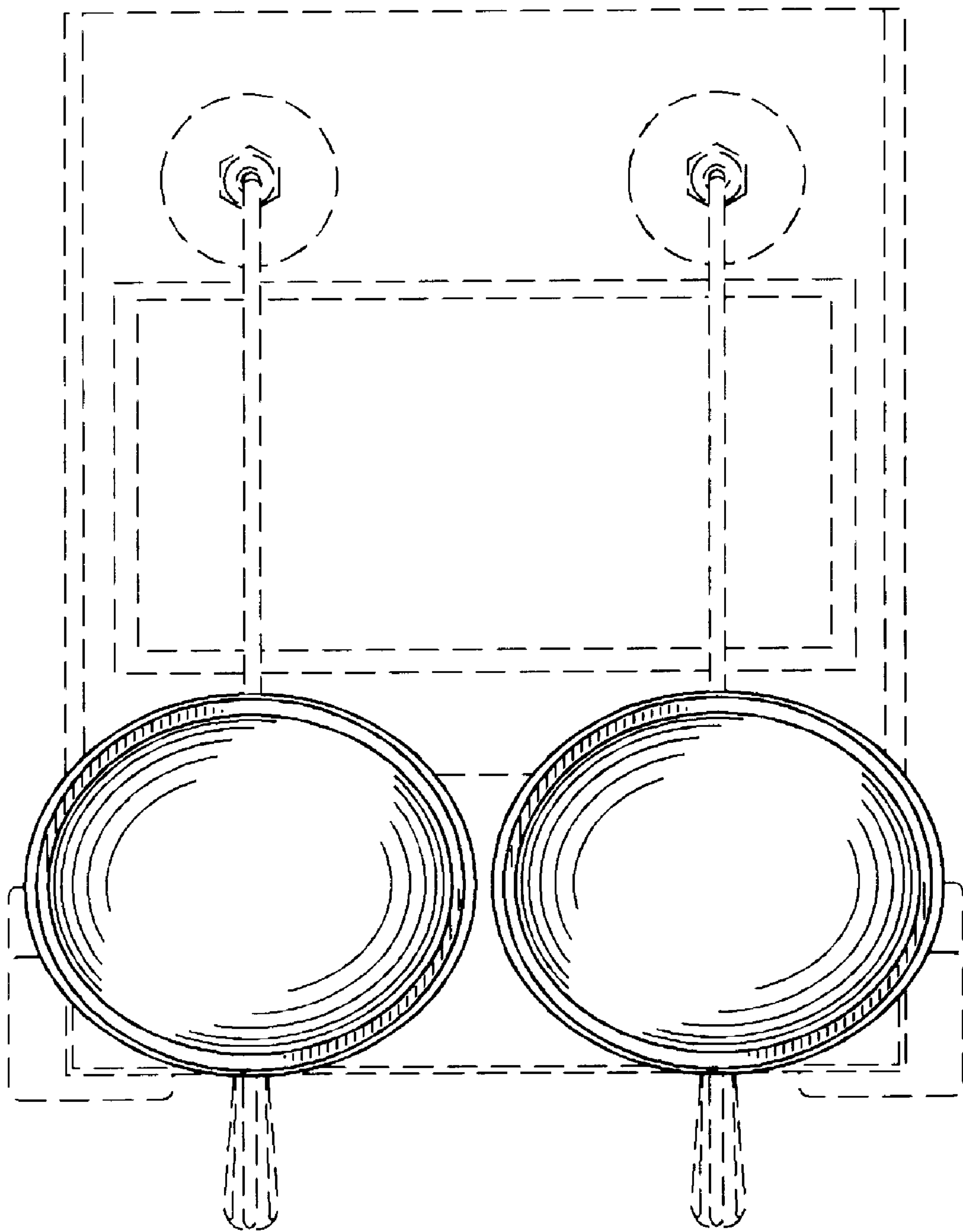
