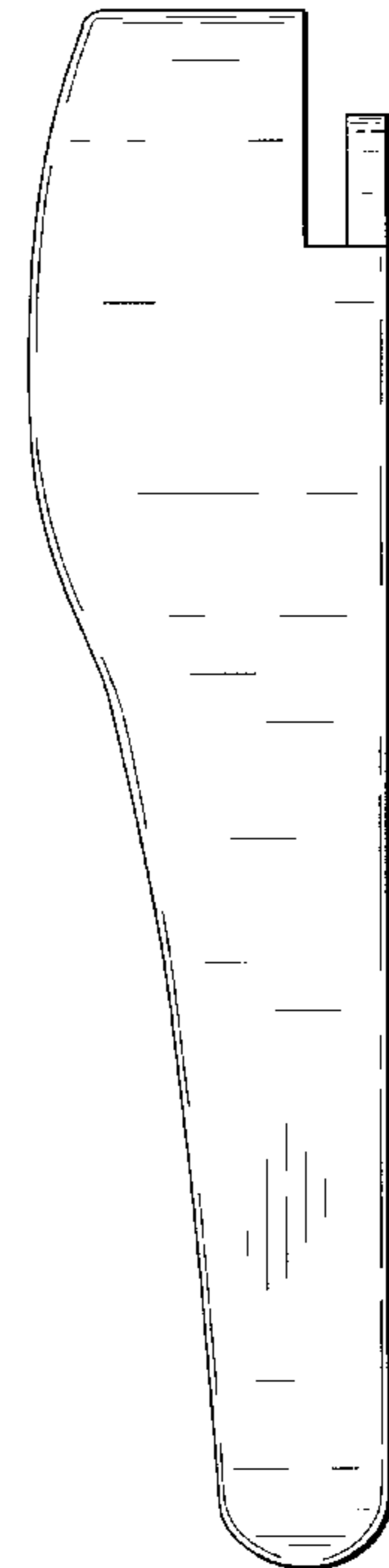
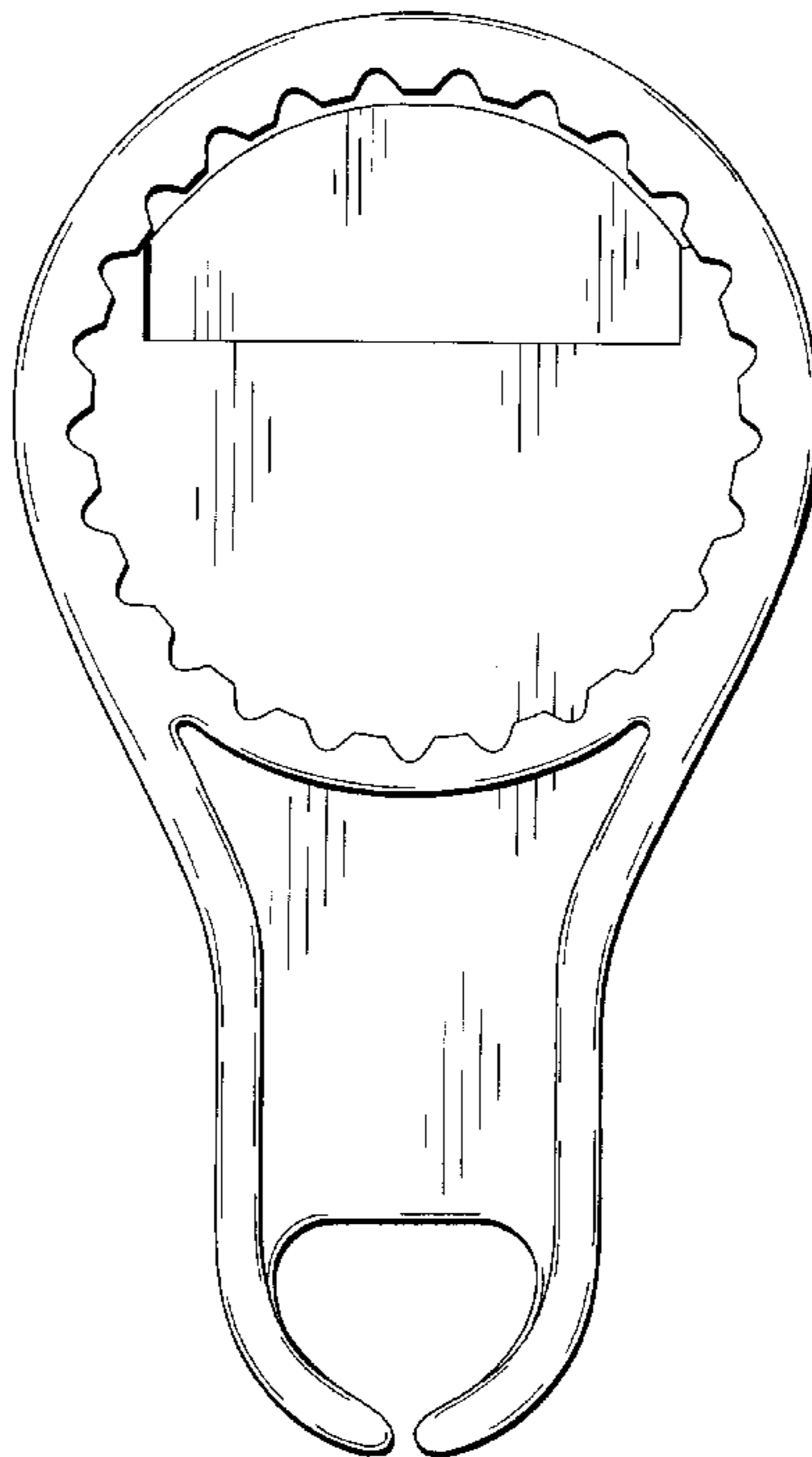
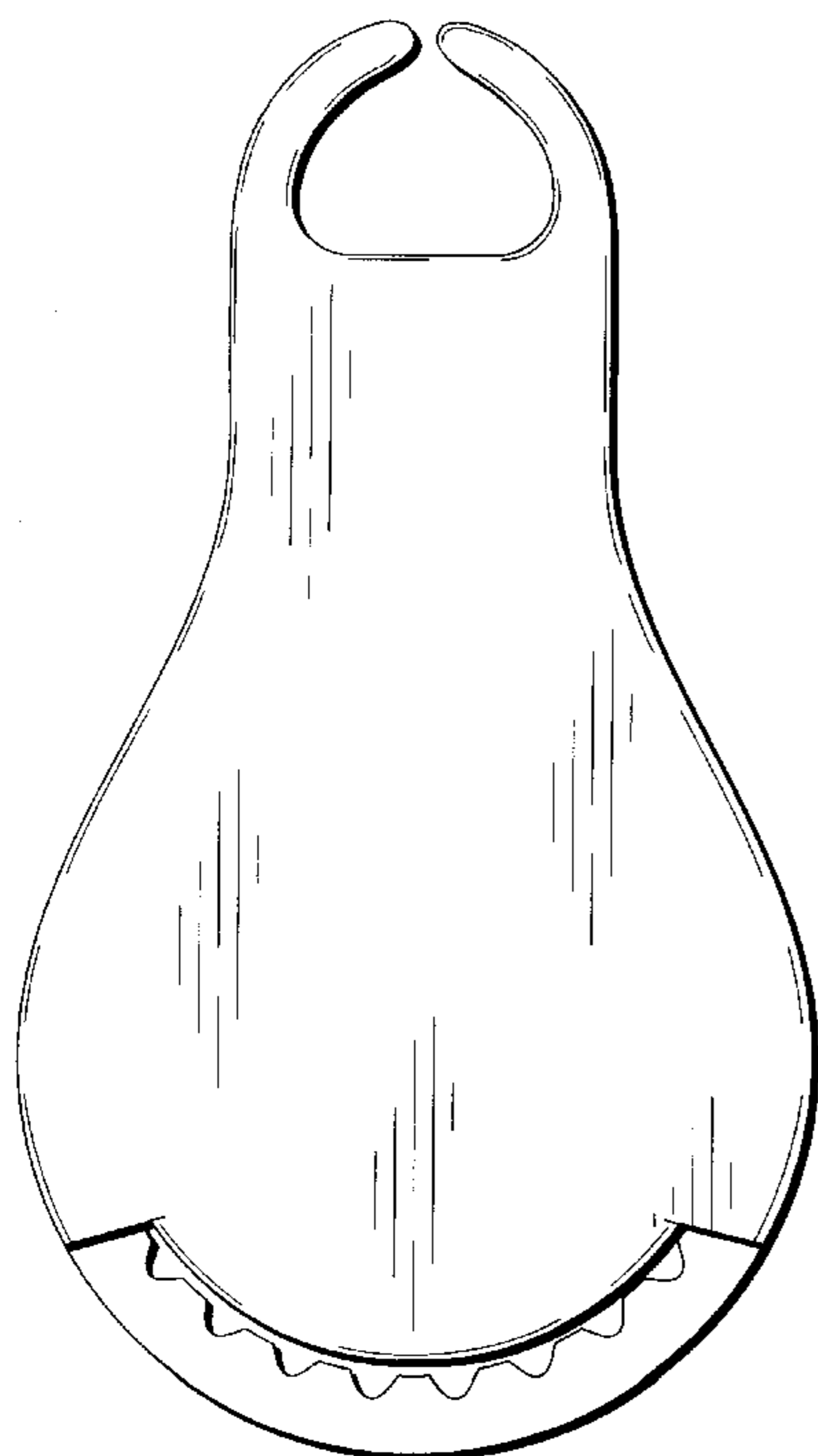

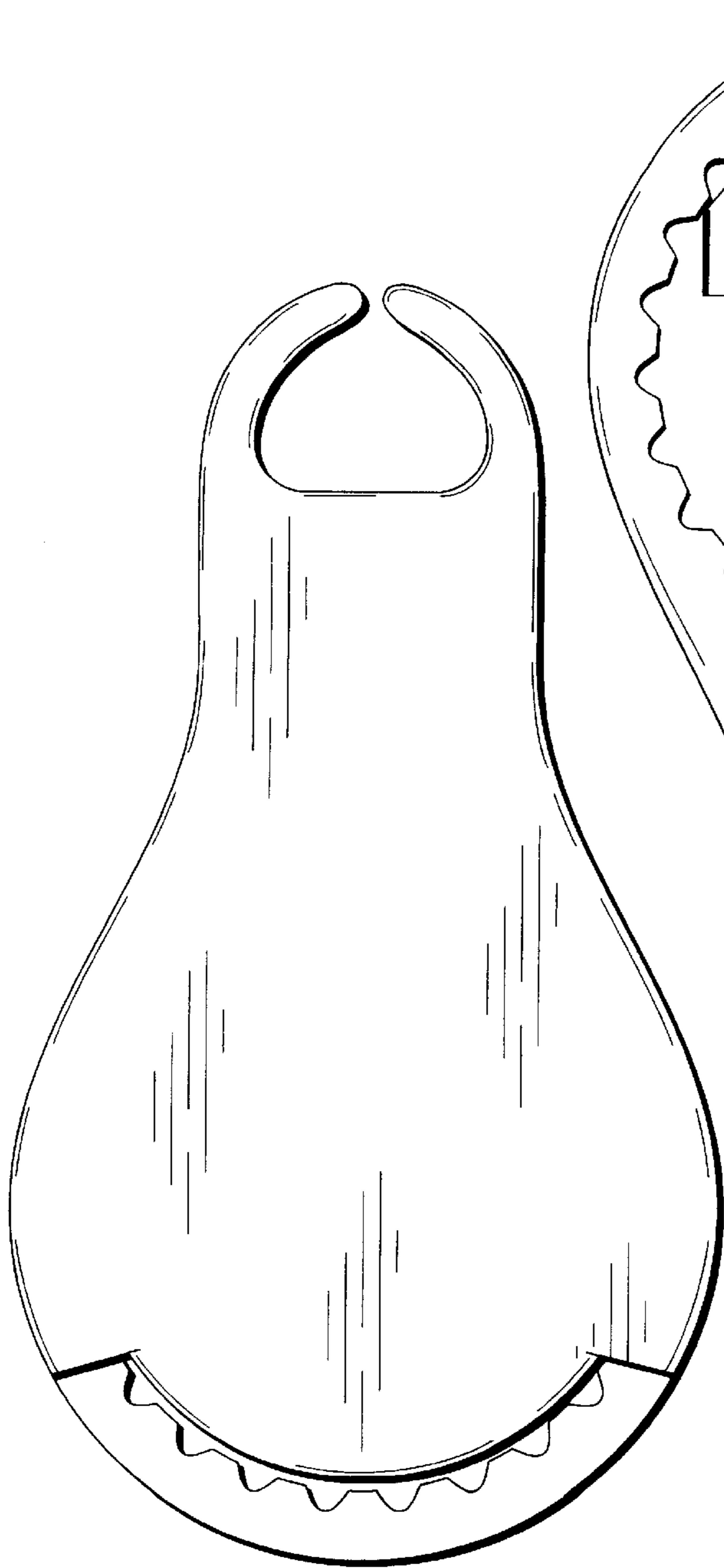
The ornamental design for a key chain bottle top and tab can opener, as shown and described.

**DESCRIPTION**

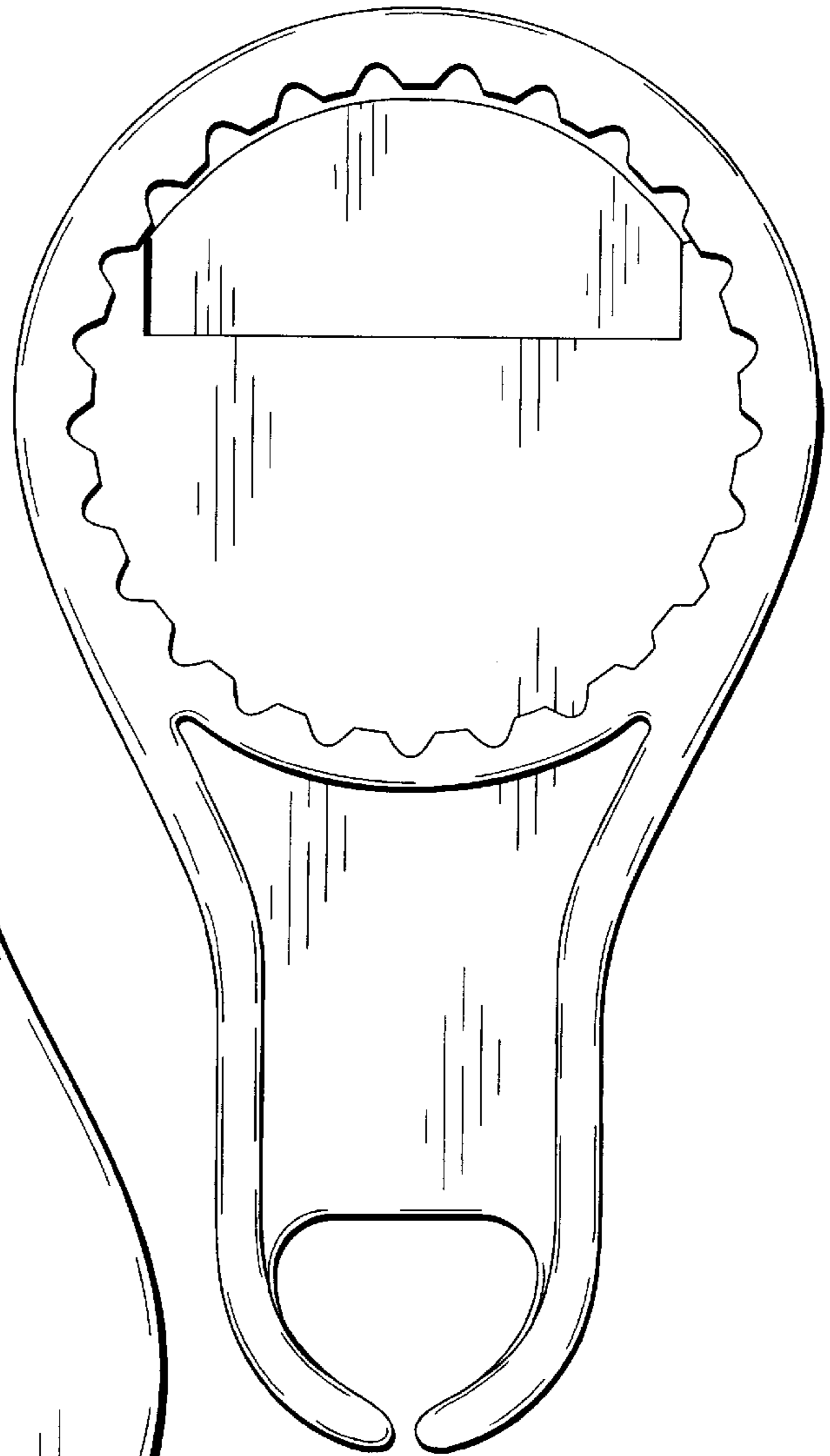
FIG. 1 is a front elevational view of a key chain bottle top and tab can opener, showing my new design;

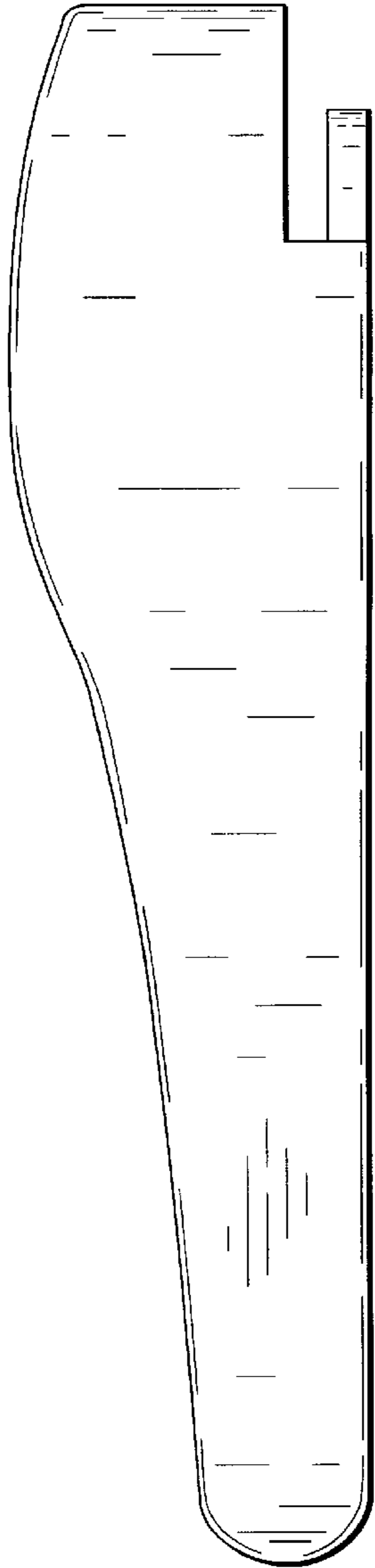




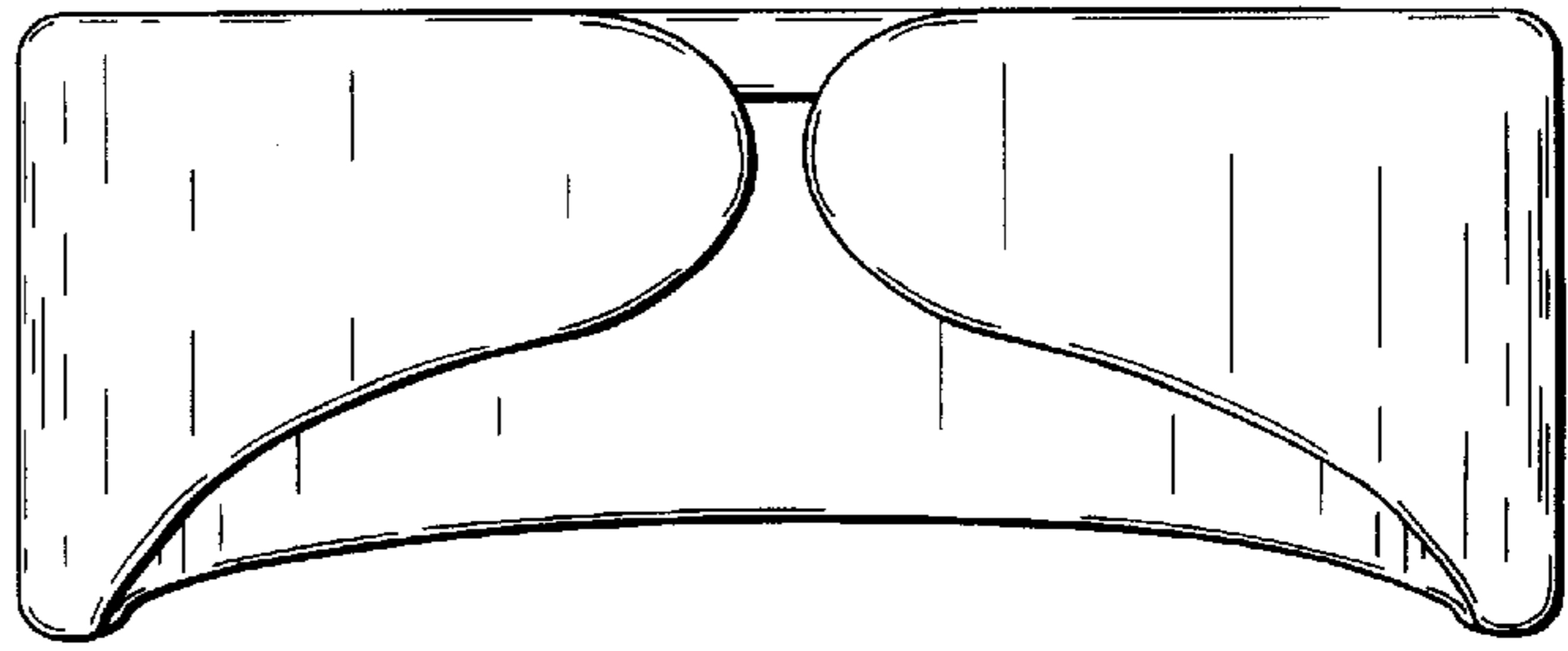

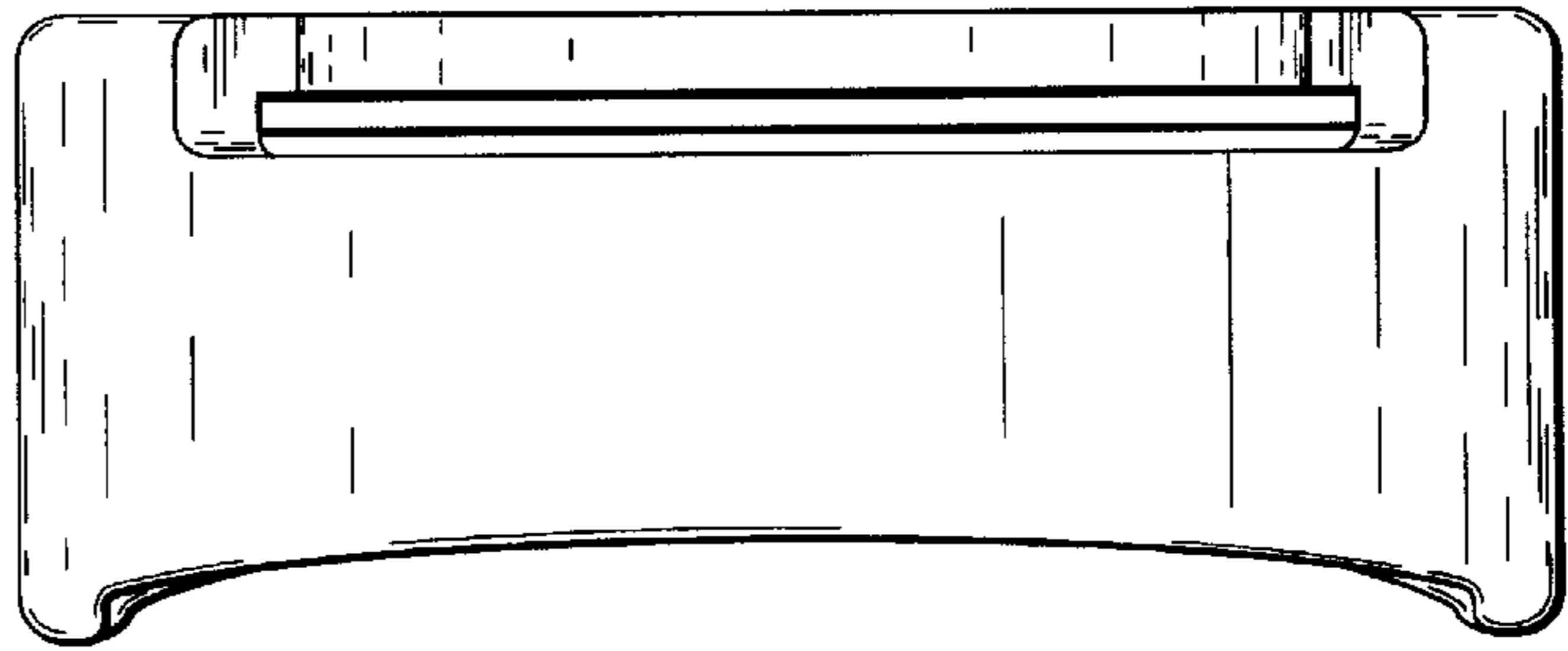
