FIG. 4 is a top view thereof, the bottom view being a mirror image;

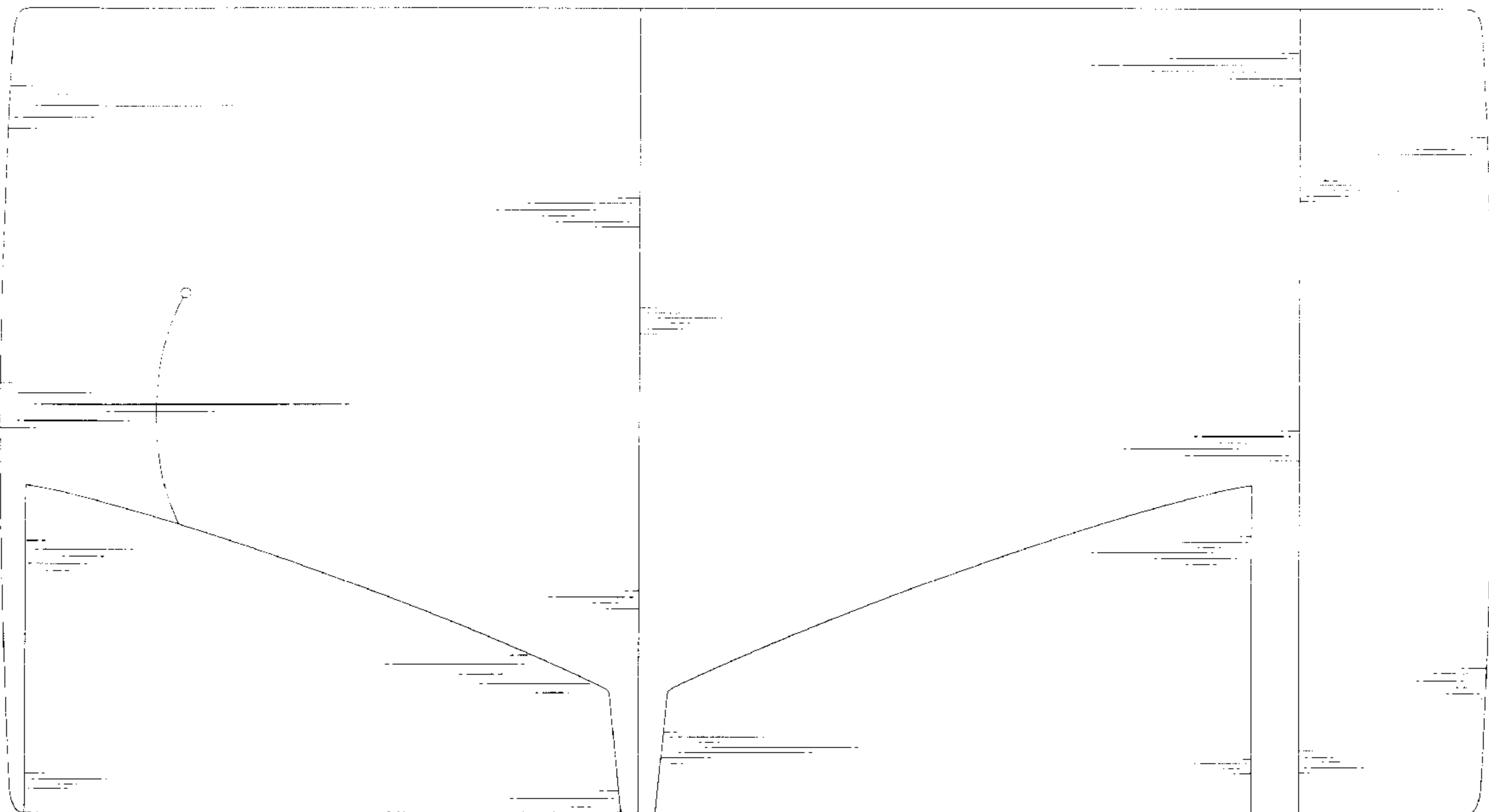
FIG. 5 is a left side view thereof;

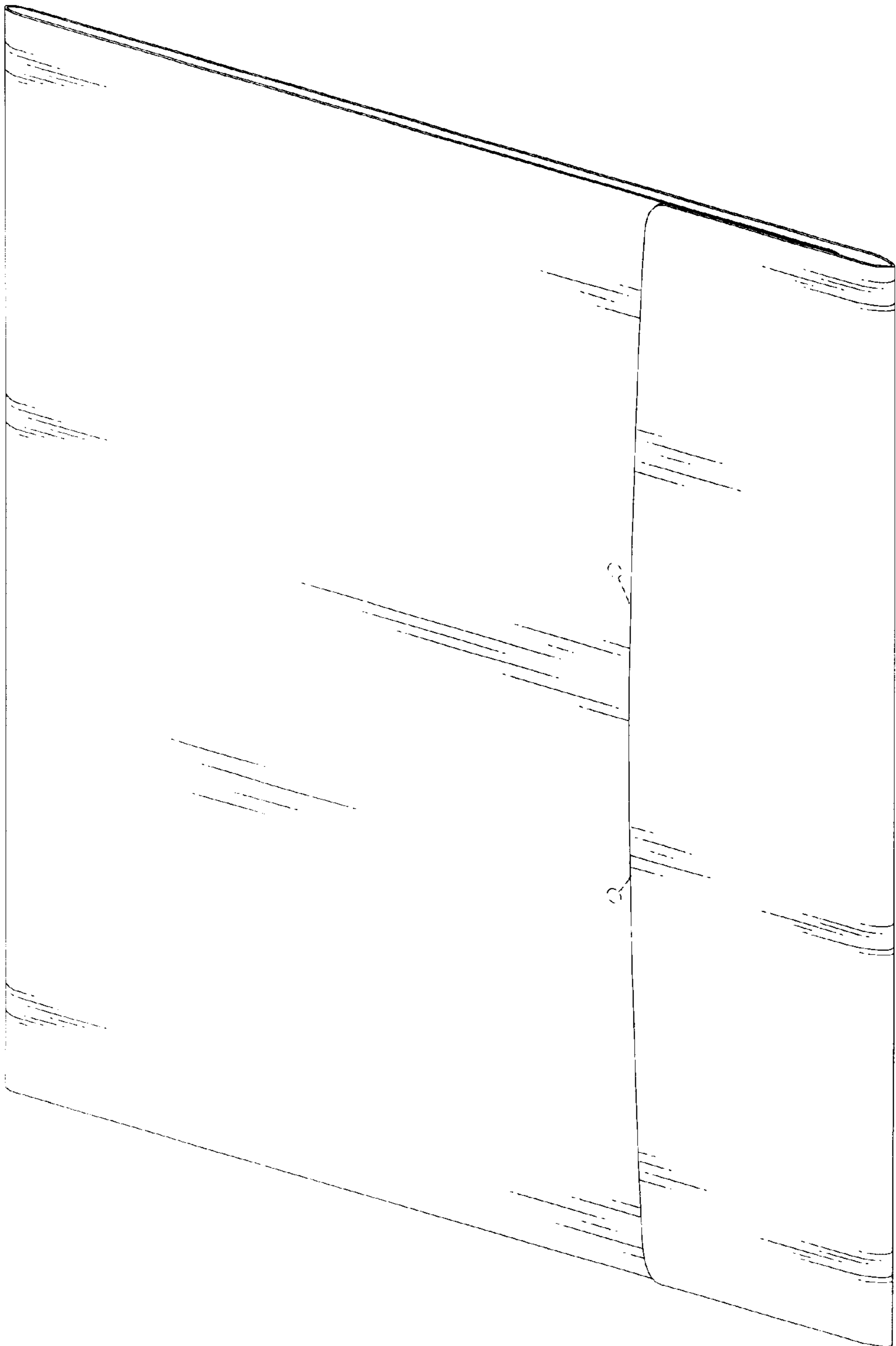
FIG. 6 is a right side view thereof; and,

FIG. 7 is an inside view thereof in an open position.

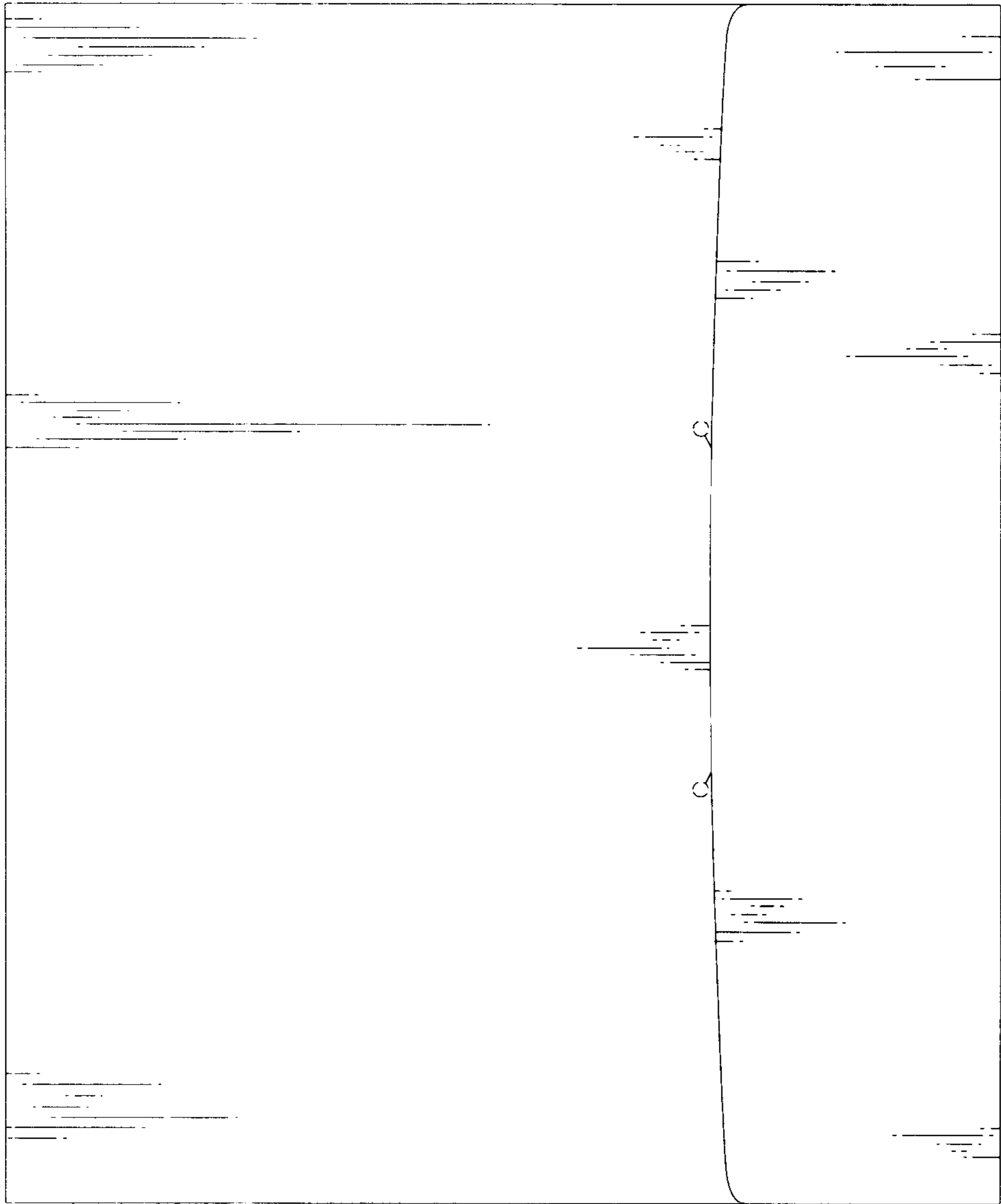

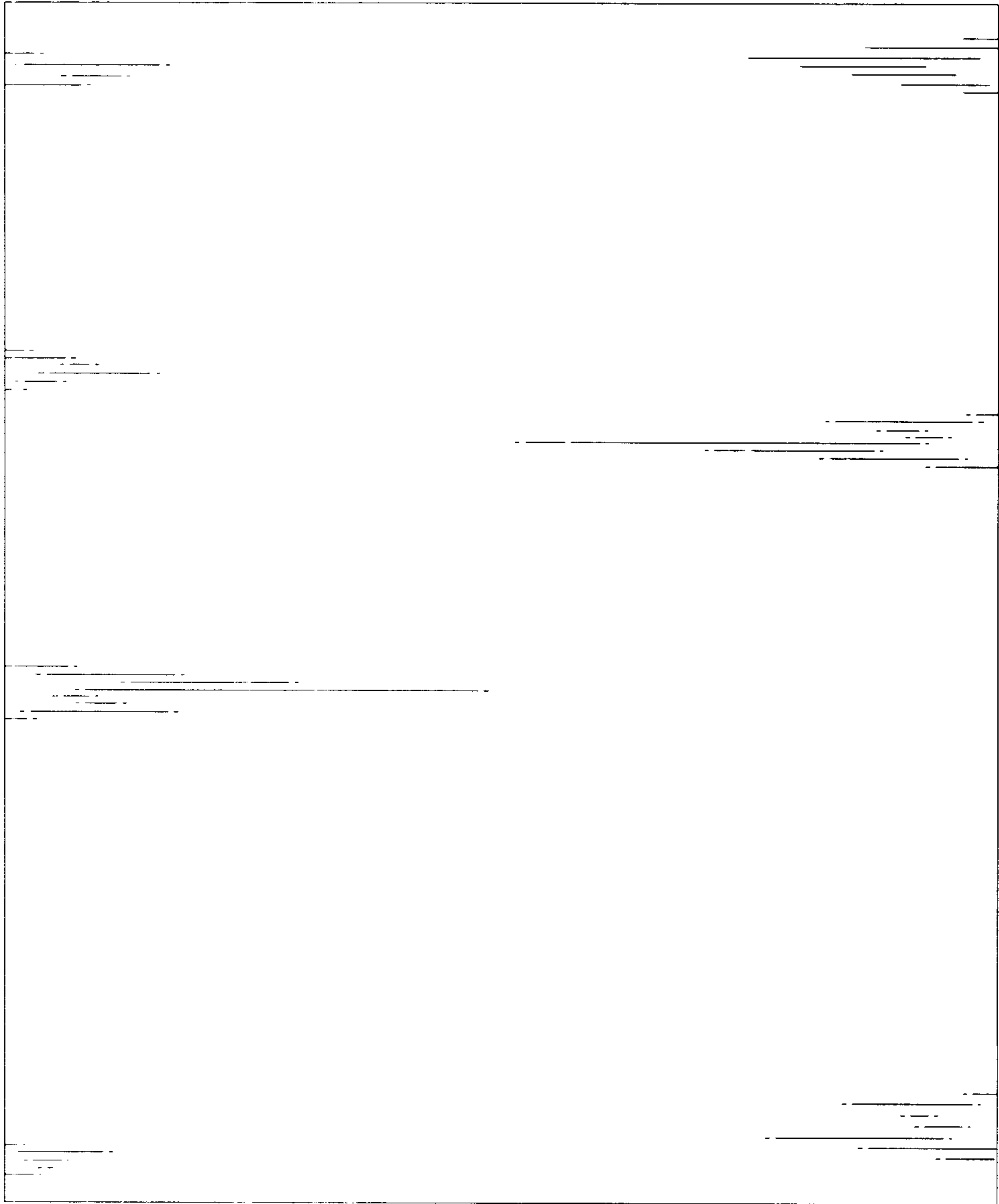




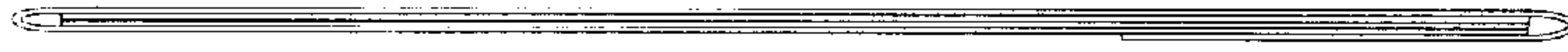

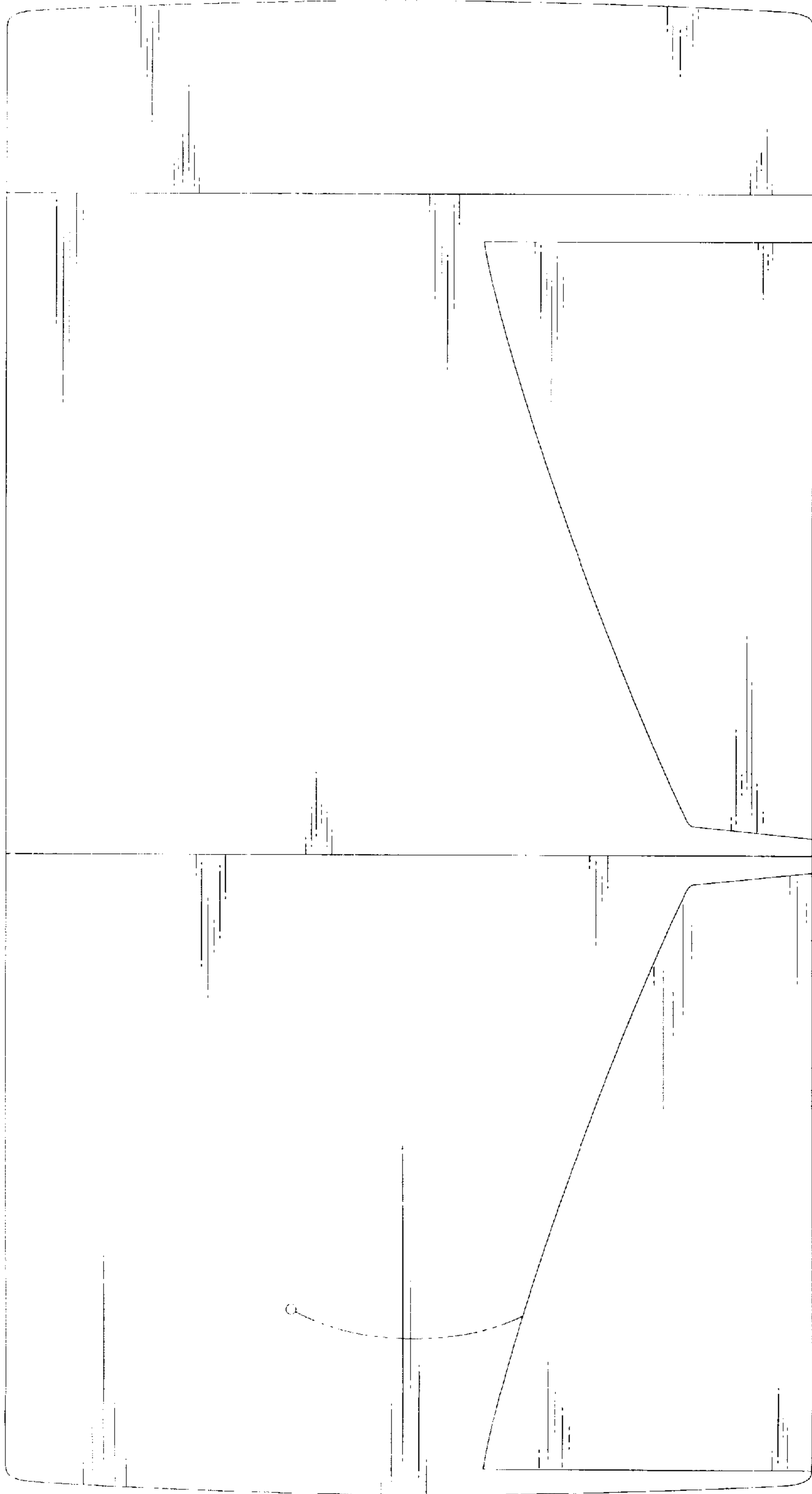
