Jakubowski and George A. Xanthos. FIG. 1 is a front elevation view of a front label for camera, showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a left-side elevation view thereof; FIG. 5 is a right-side elevation view thereof; and, FIG. 6 is a perspective view thereof, the broken line showing of a camera is for illustrative purposes only and forms no part of the claimed design.

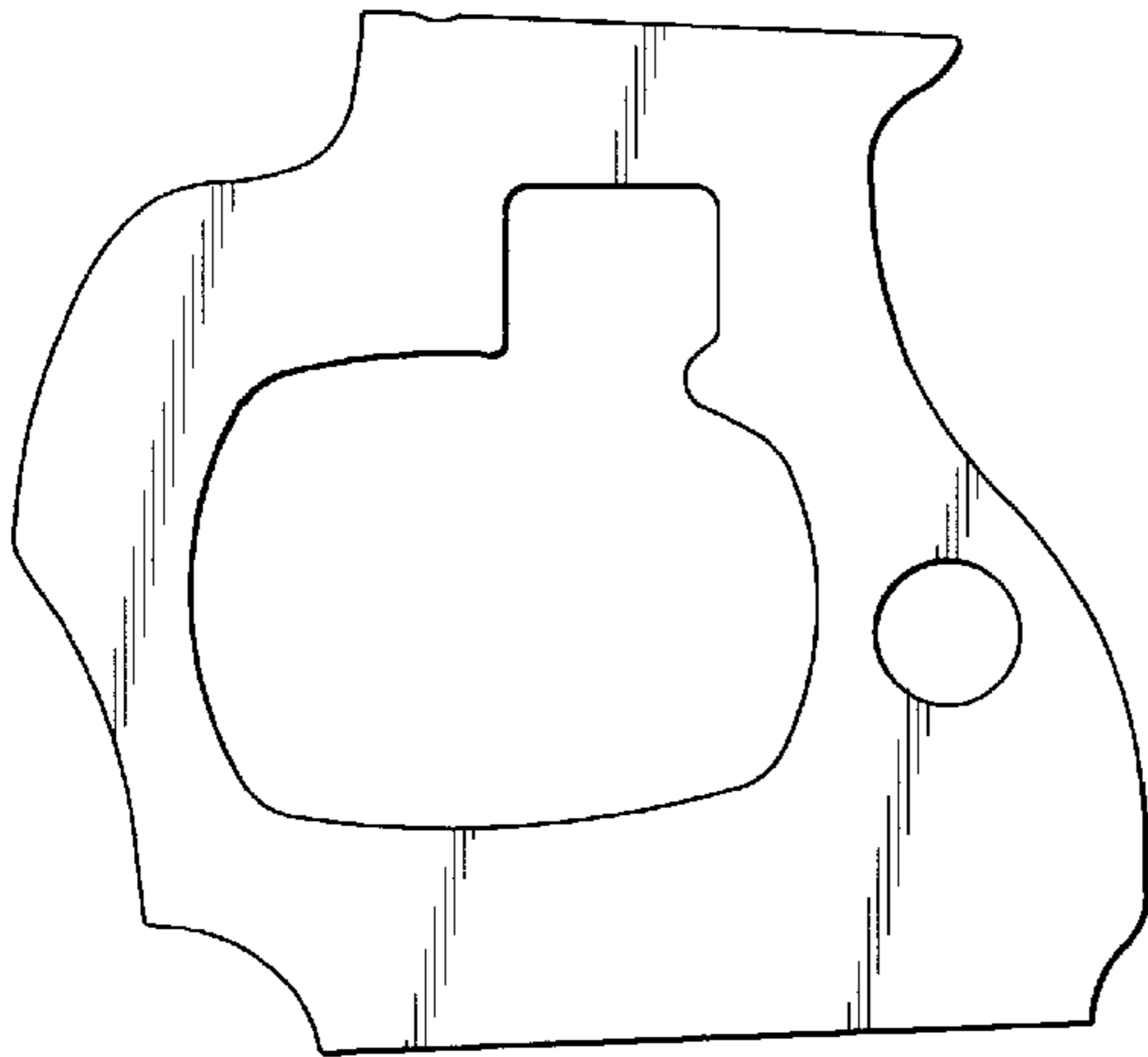

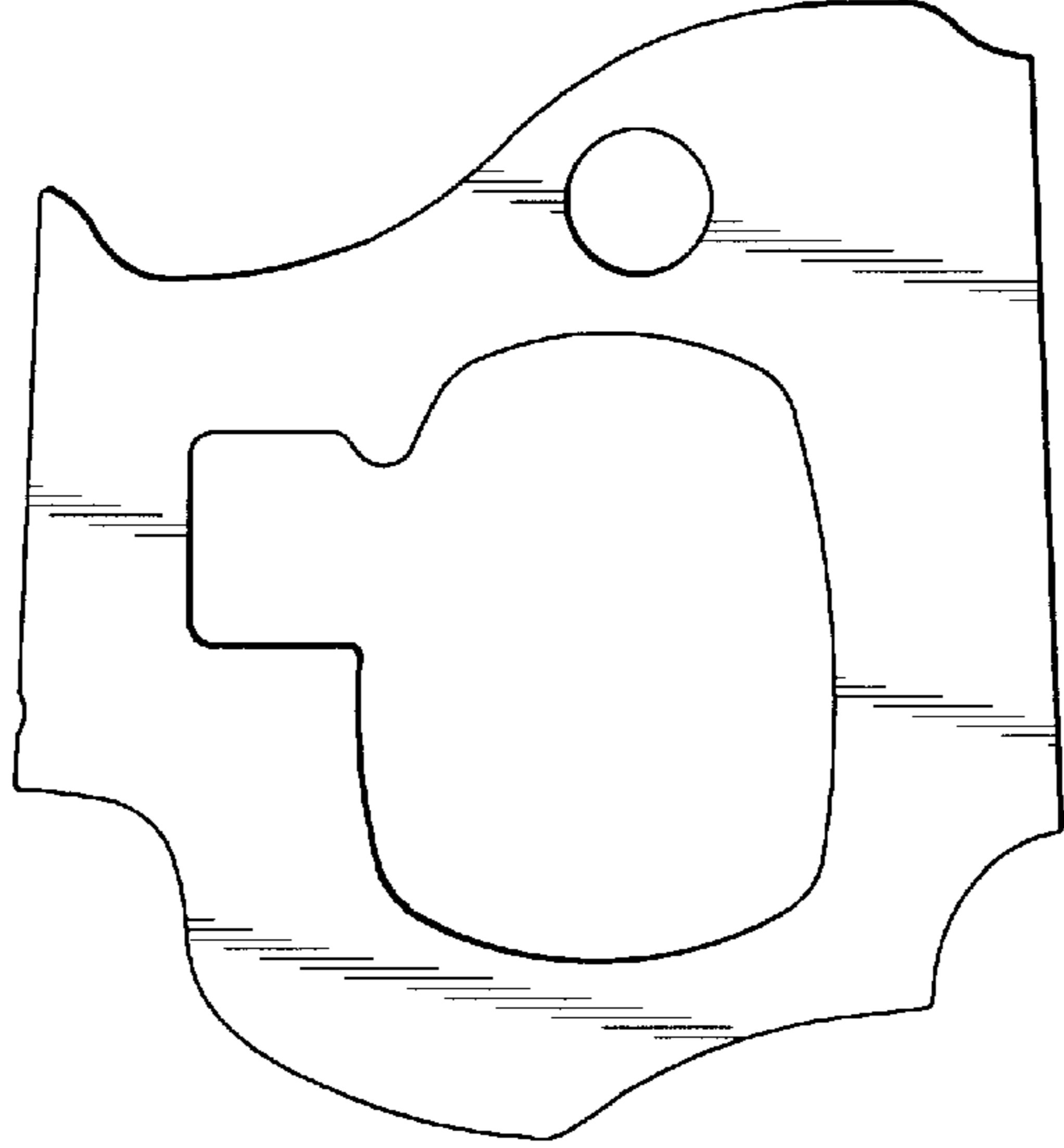

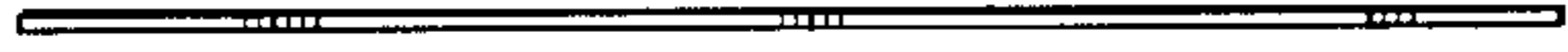

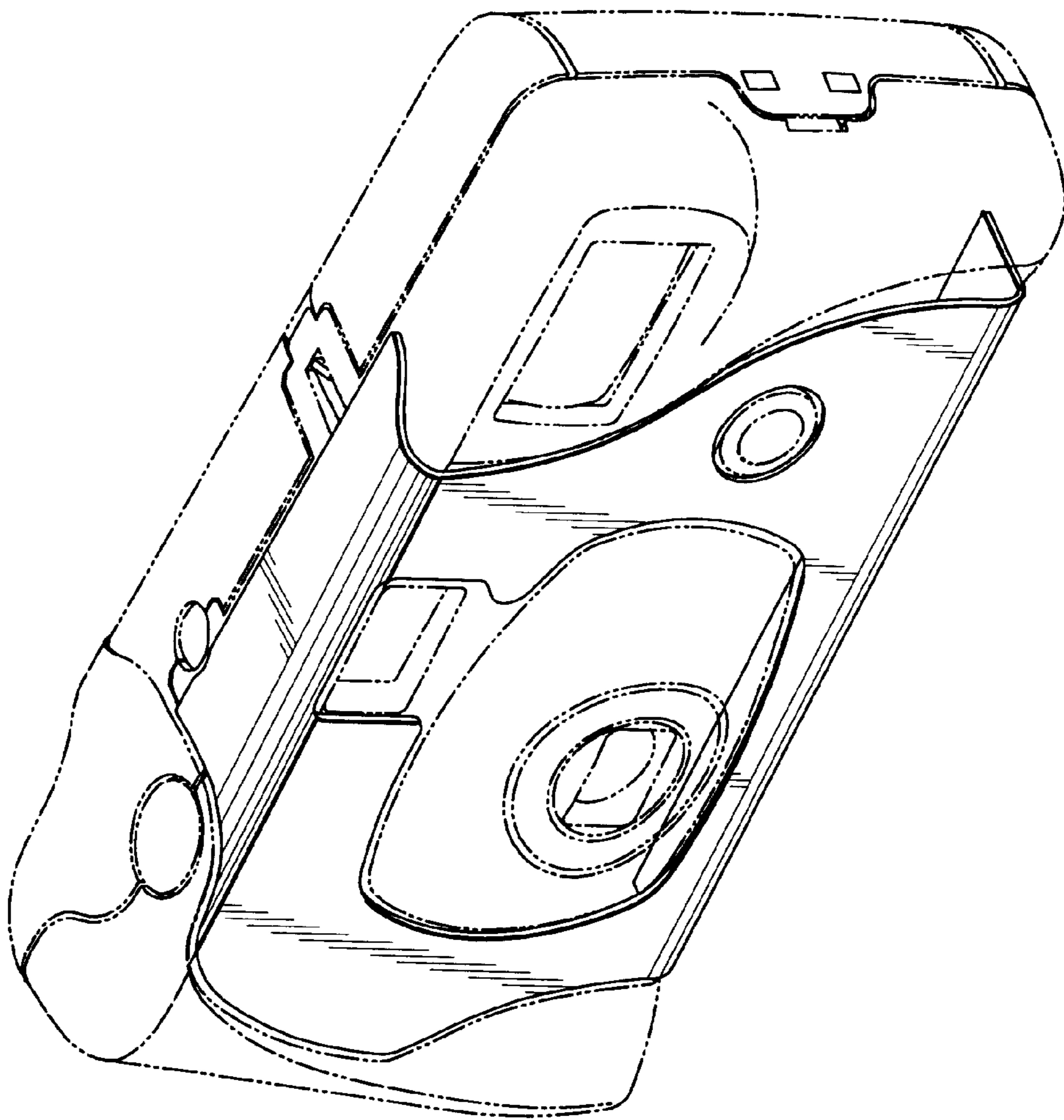
