view being substantially identical thereto, reversed.

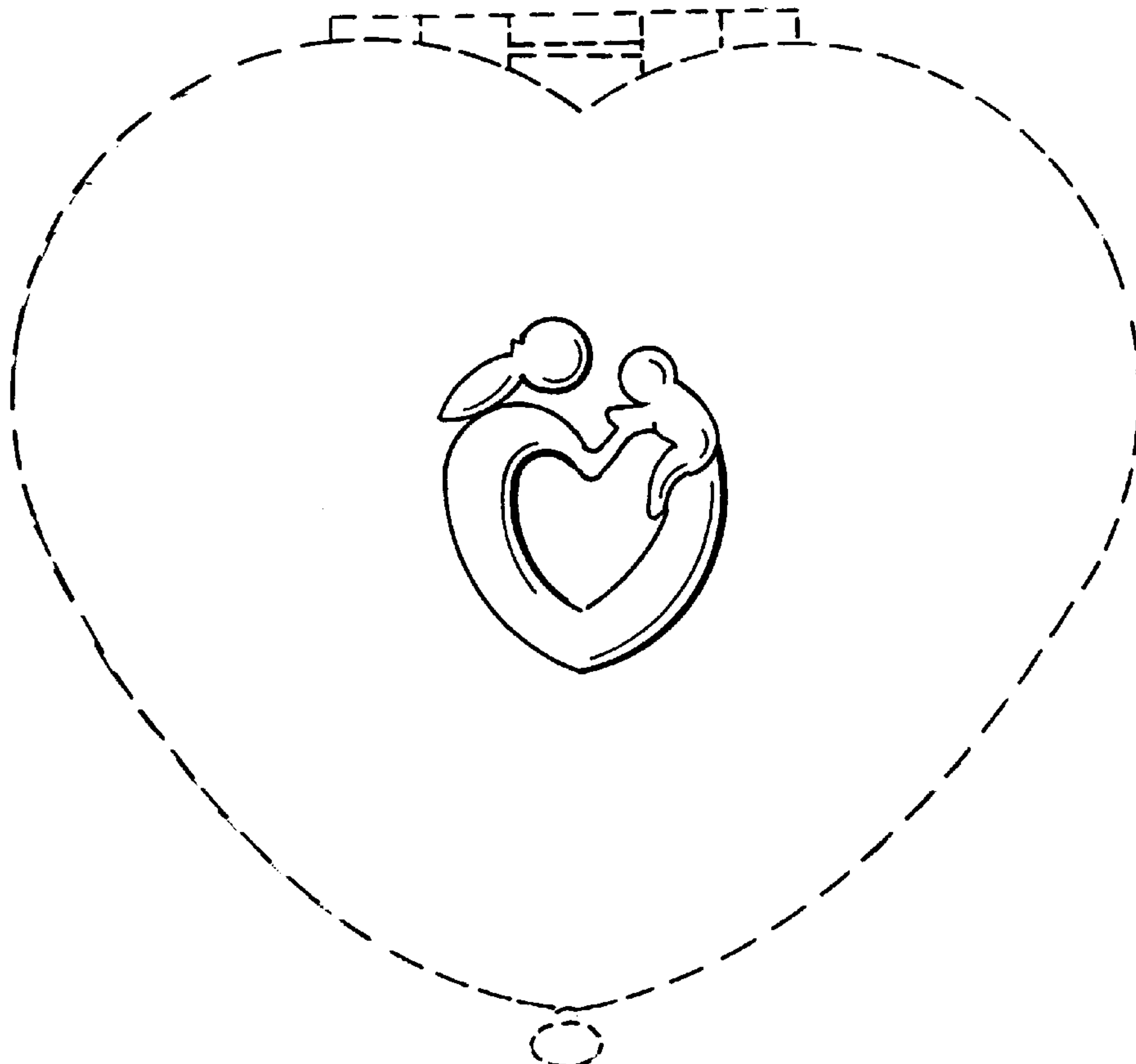

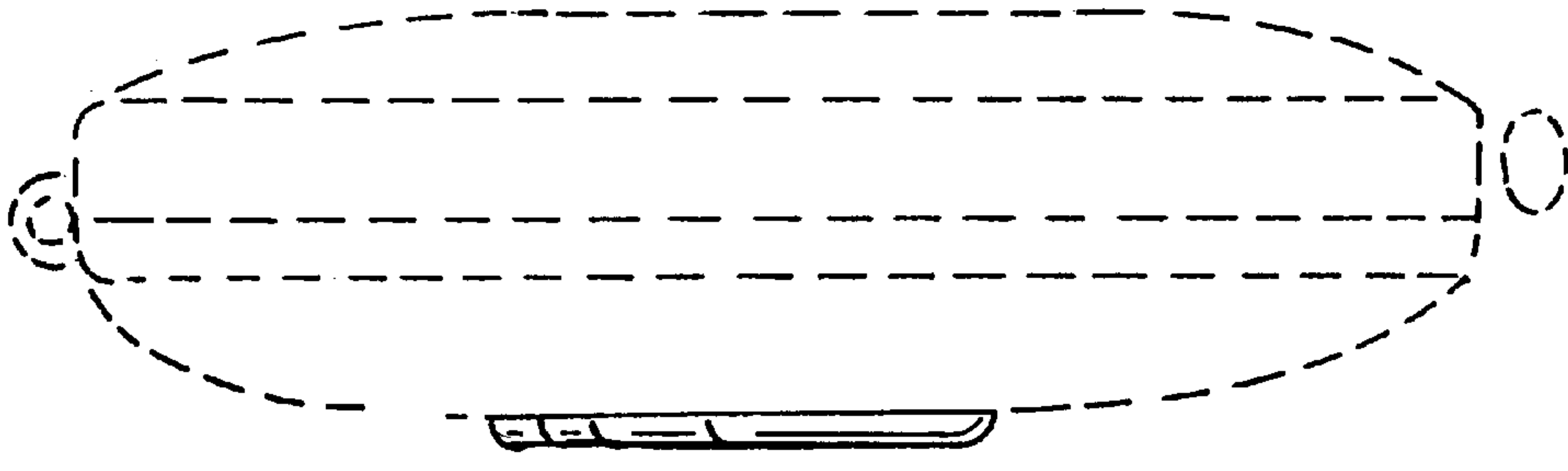

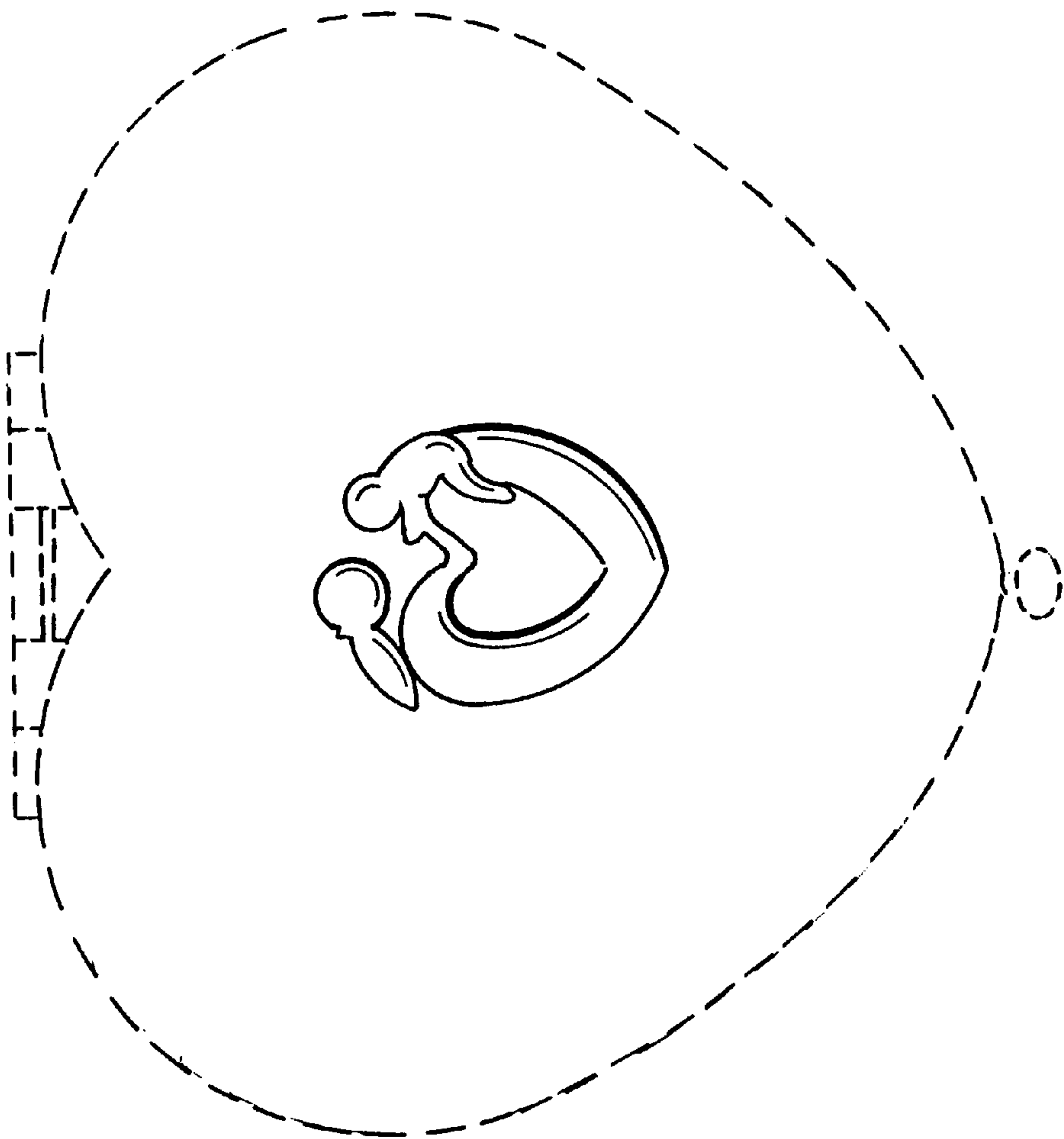
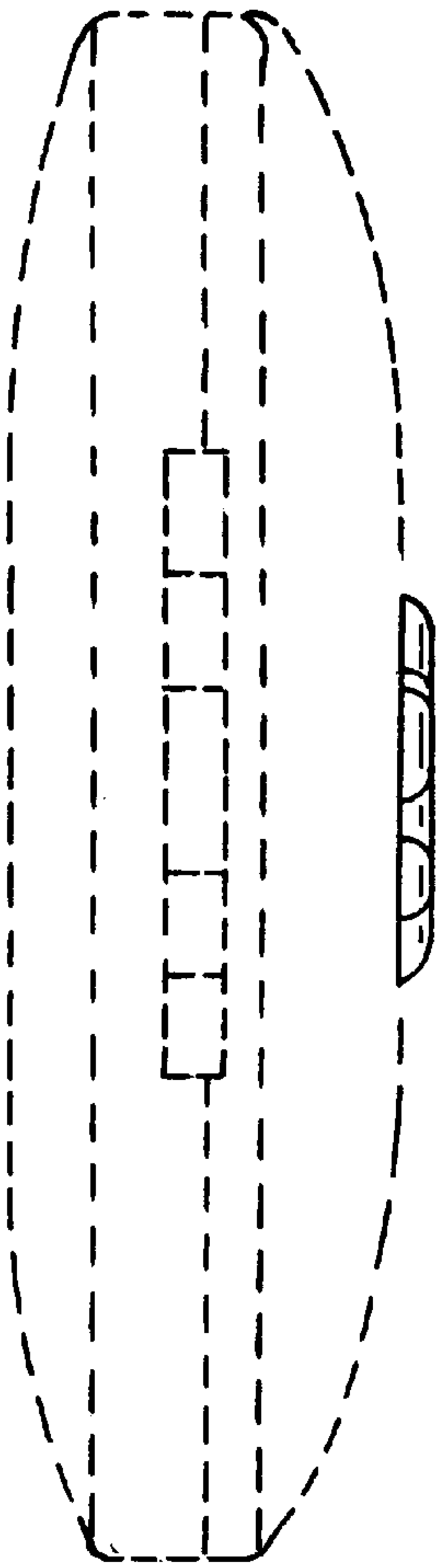
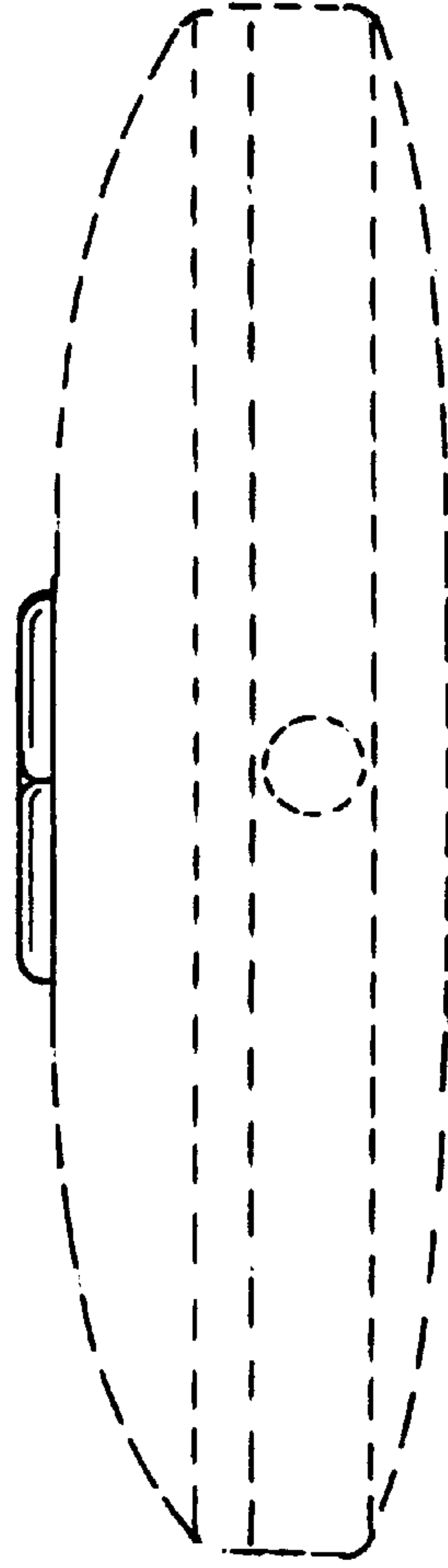


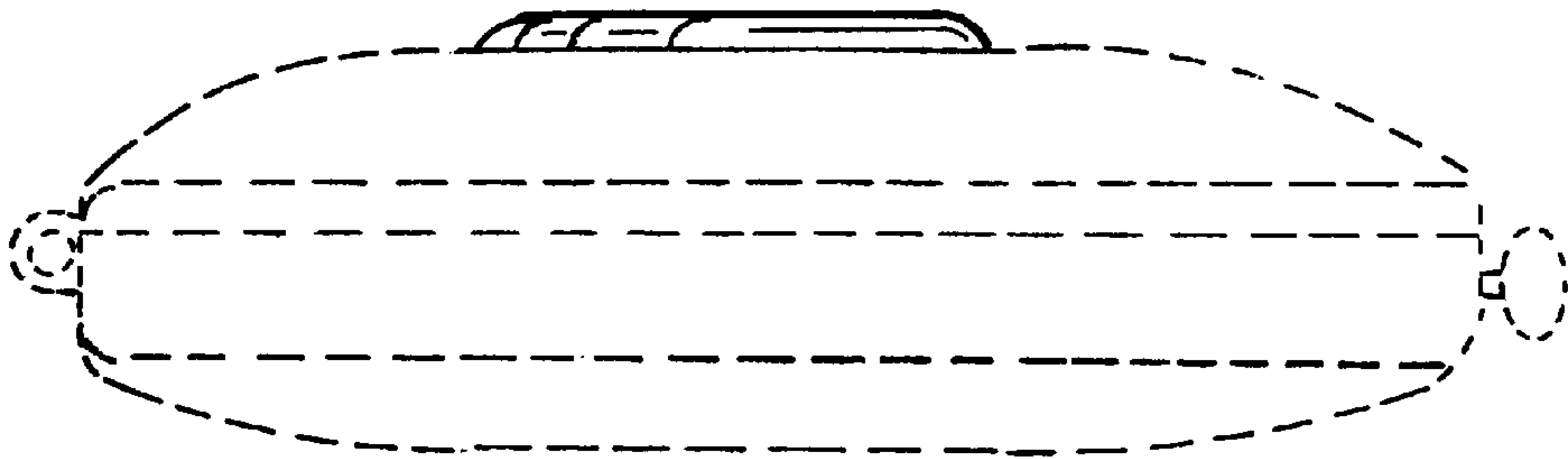
