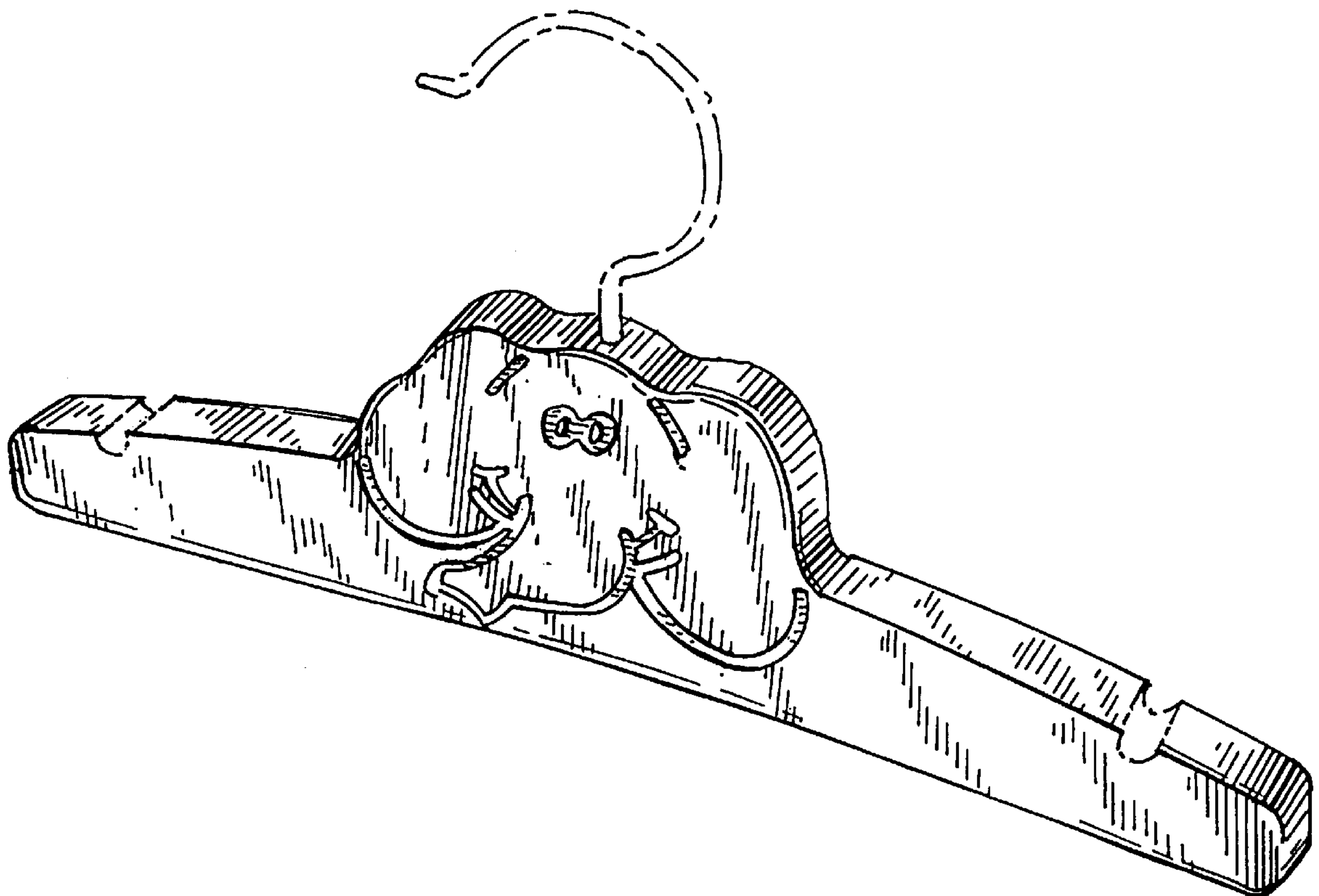
(57) **CLAIM**

The ornamental design for a hanger, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hanger showing our new design;  
 FIG. 2 is a top view of the hanger shown in FIG. 1;  
 FIG. 3 is a front elevational view of the hanger shown in FIG. 1;  
 FIG. 4 is a view of the hanger taken from the left side of FIG. 1;  
 FIG. 5 is a view of the hanger taken from the right side of FIG. 1;  
 FIG. 6 is a rear elevational view of the hanger shown in FIG. 1; and,  
 FIG. 7 is a bottom view of the hanger shown in FIG. 1.  
 The broken lines within the upper surface of the horizontal shoulder supports represent the bounds of the design but form no part thereof and the broken line showing of the hook is for illustrative purposes only also forming no part of the claimed design.

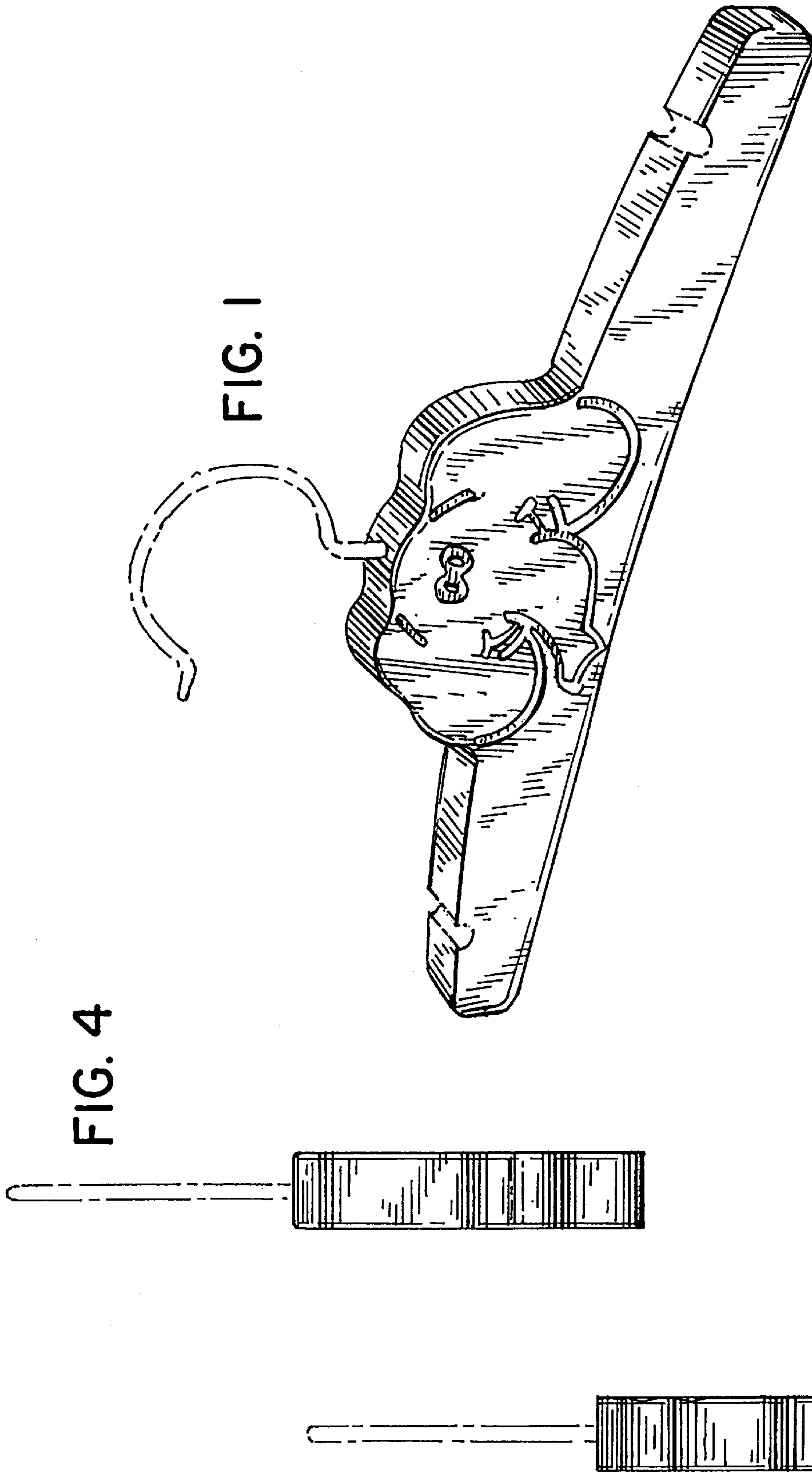

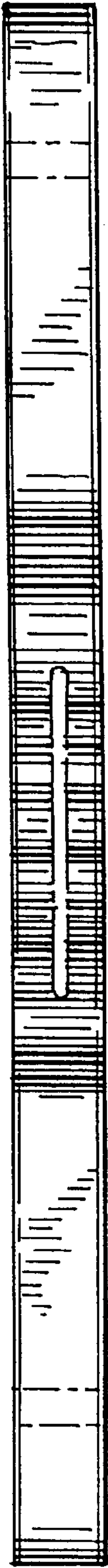

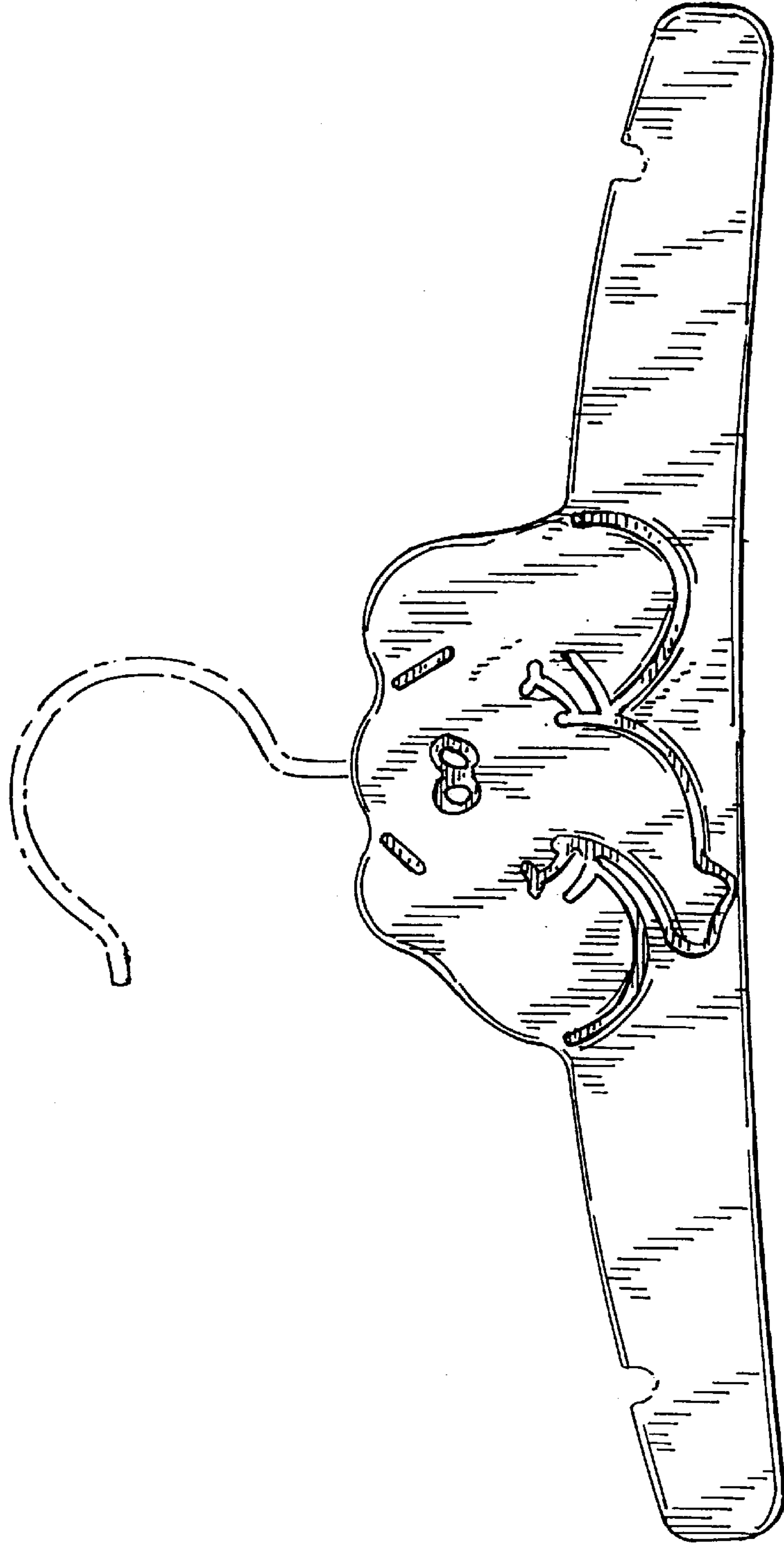

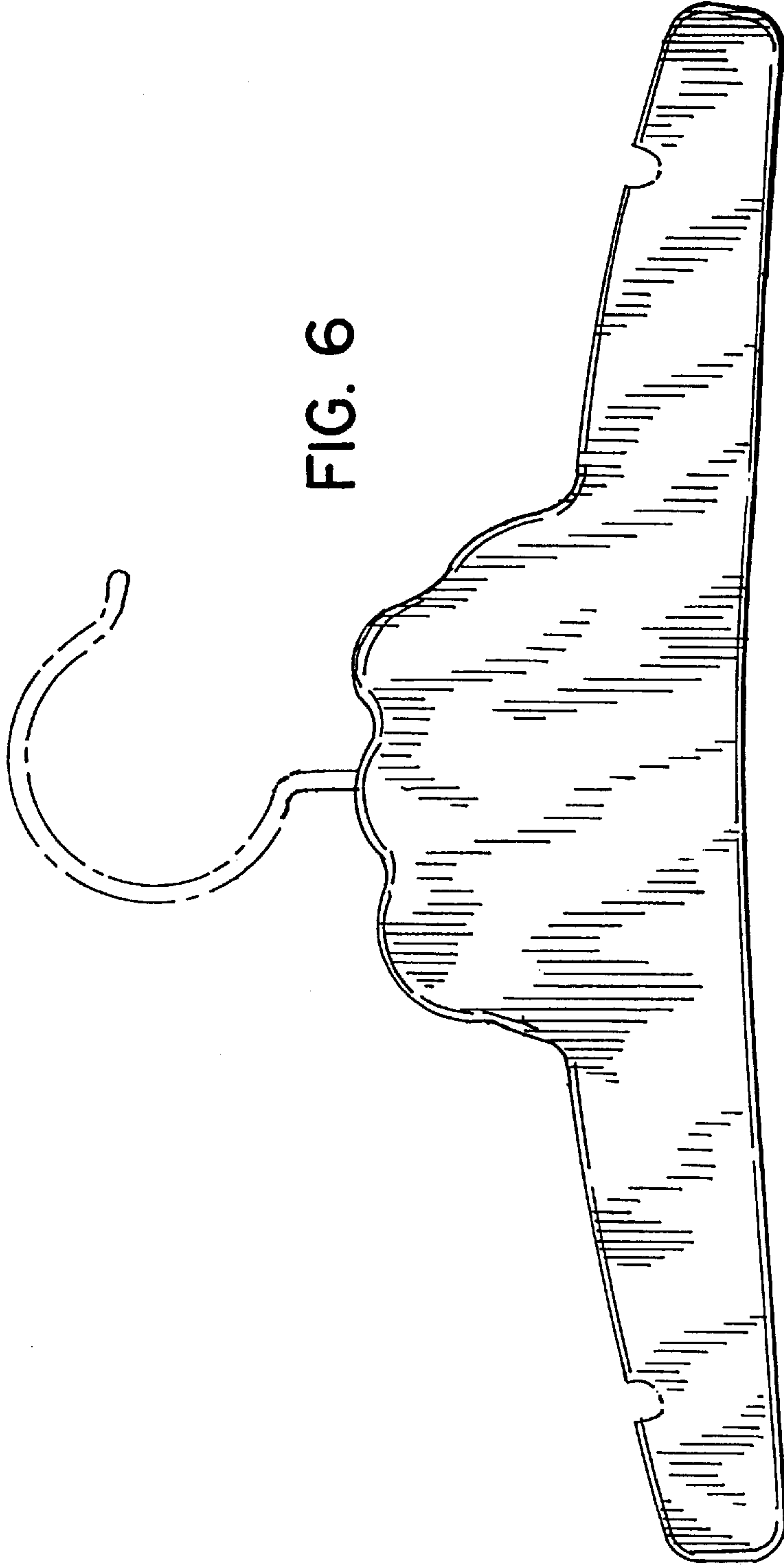

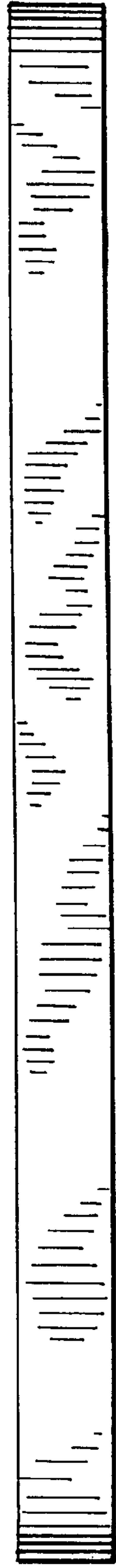
