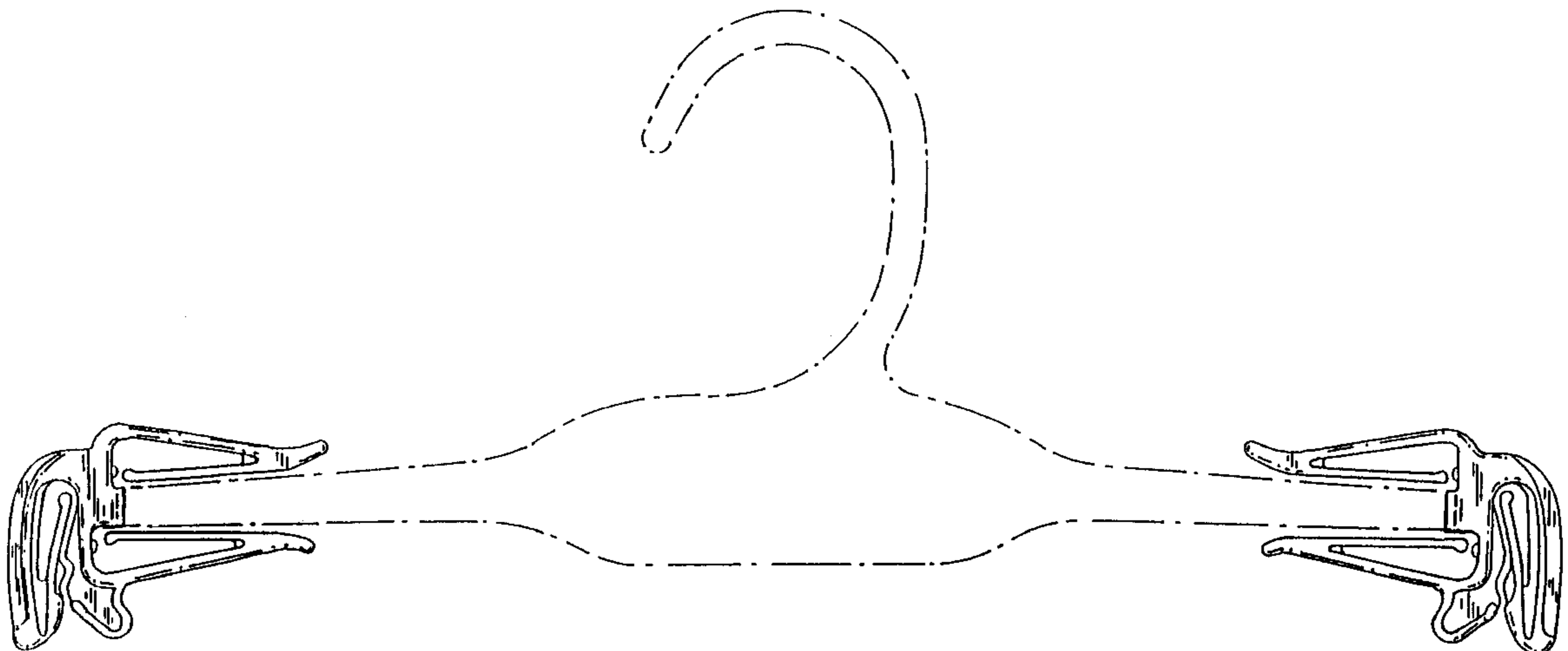
CLAIM

(57) The ornamental design for a clip for a garment hanger, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a clip for a garment hanger showing my new design, the portions of the garment hanger shown in phantom lines are for illustrative purposes only and form no part of the claimed design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a right side elevational thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof.

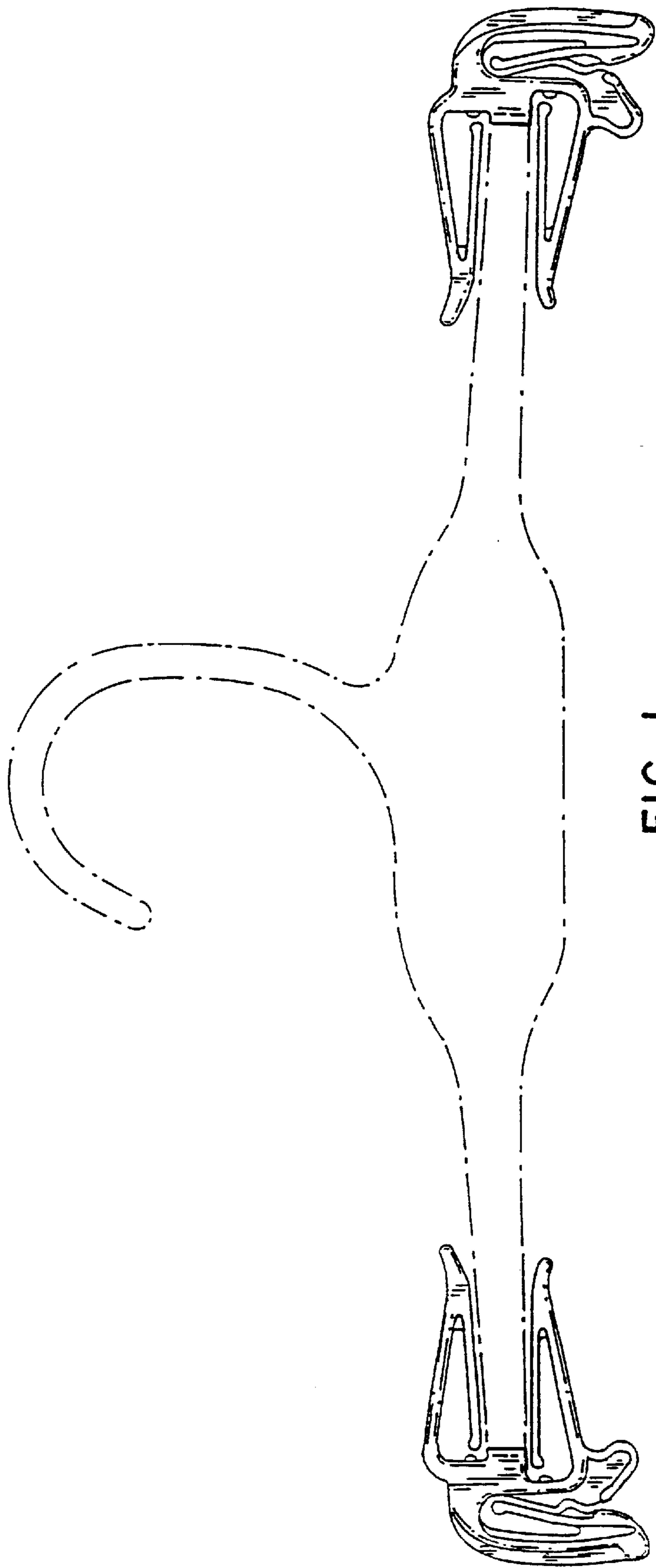

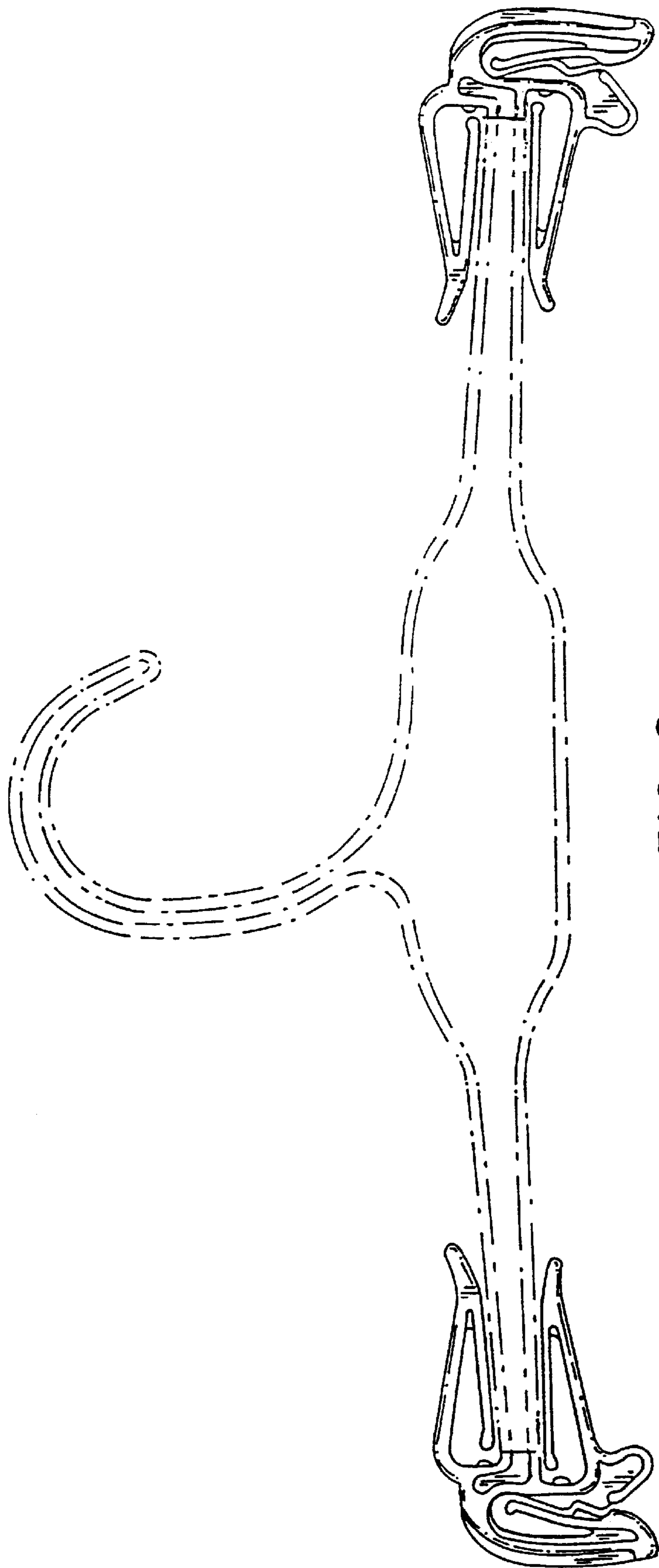

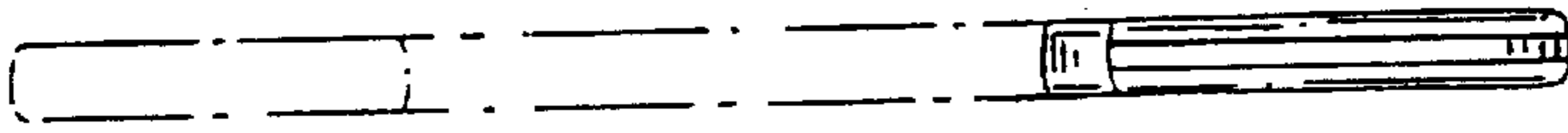

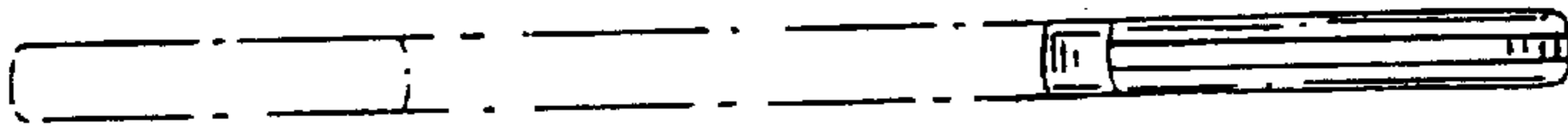

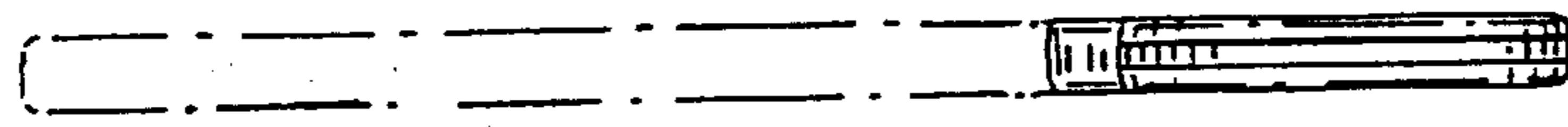

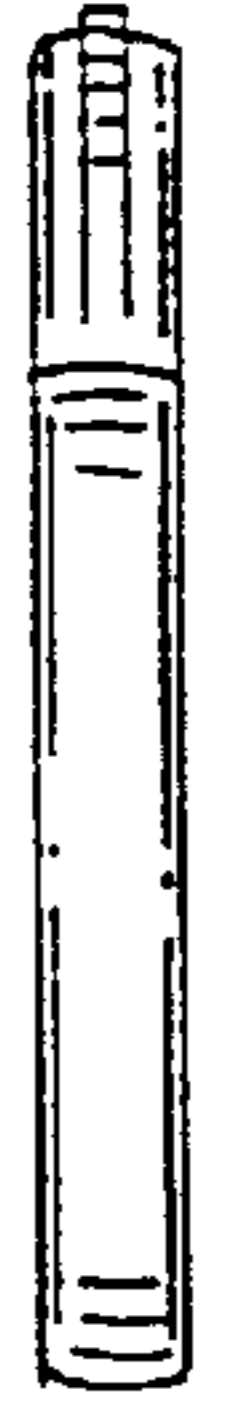
