(57) **CLAIM**

The ornamental design for a handle for cookware, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of the handle for cookware of the present invention;

FIG. 2 is a bottom plan view of the handle of FIG. 1;

FIG. 3 is a cross-sectional view of the handle of FIGS. 1 and 2 taken along section line III—III of FIG. 2;

FIG. 4 is a cross-sectional view of the handle of FIGS. 1 and 2 taken along section line IV—IV of FIG. 2;

FIG. 5 is a cross-sectional view of the handle of FIGS. 1 and 2 taken along section line V—V of FIG. 2;

FIG. 6 is a side view of the handle for cookware as shown in FIGS. 1 and 2;

FIG. 7 is an opposite side view of the handle shown in FIG. 6;

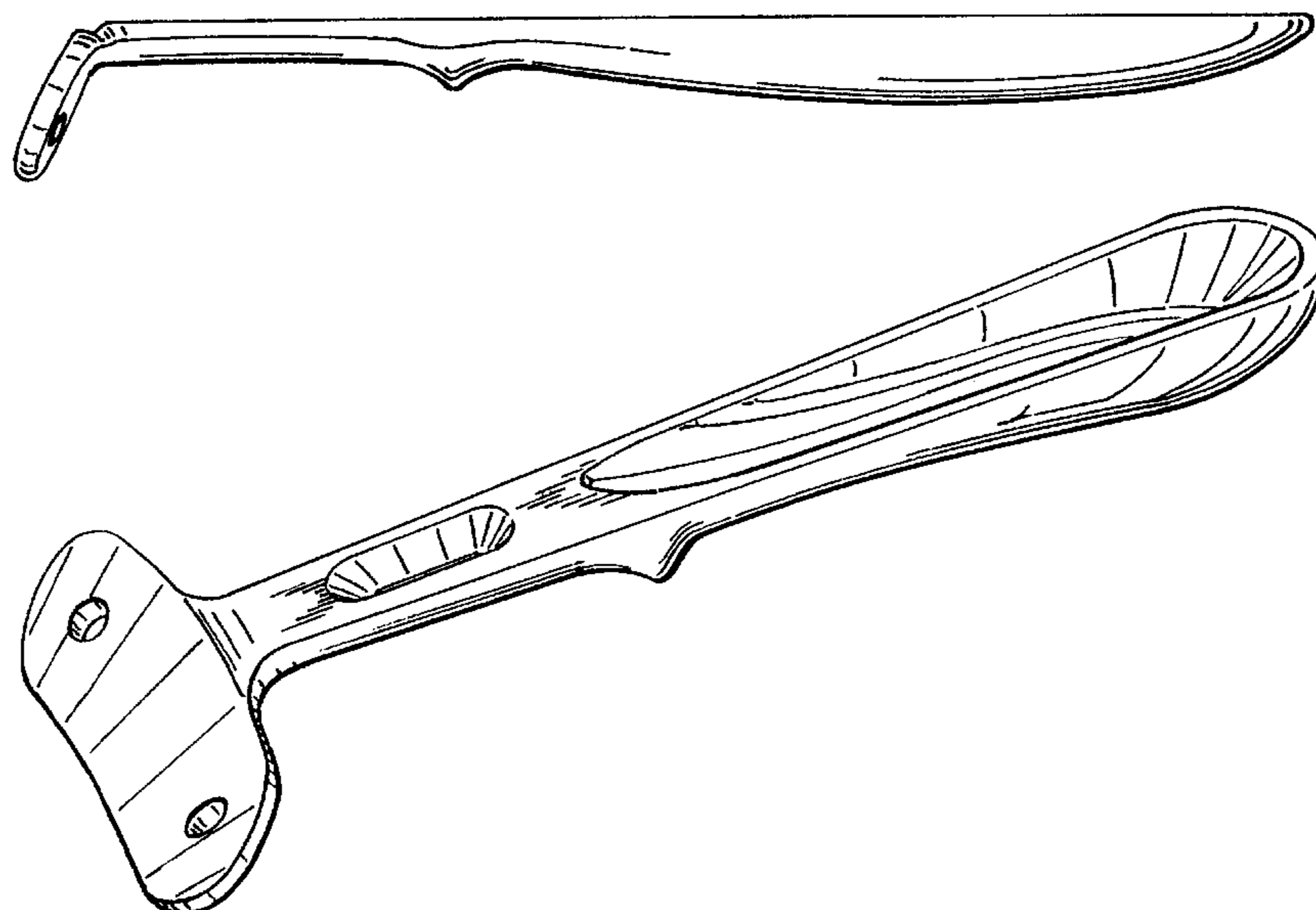
FIG. 8 is an end view of the handle shown in FIGS. 1 and 2;

FIG. 9 is an opposite end view of the handle shown in FIG. 8; and,

FIG. 10 is a top perspective view of the handle shown in FIGS. 1 and 2.

As shown in the appended drawings, the ornamental design of my invention is directed to a handle for cookware, such as a pot, or like cooking vessel.

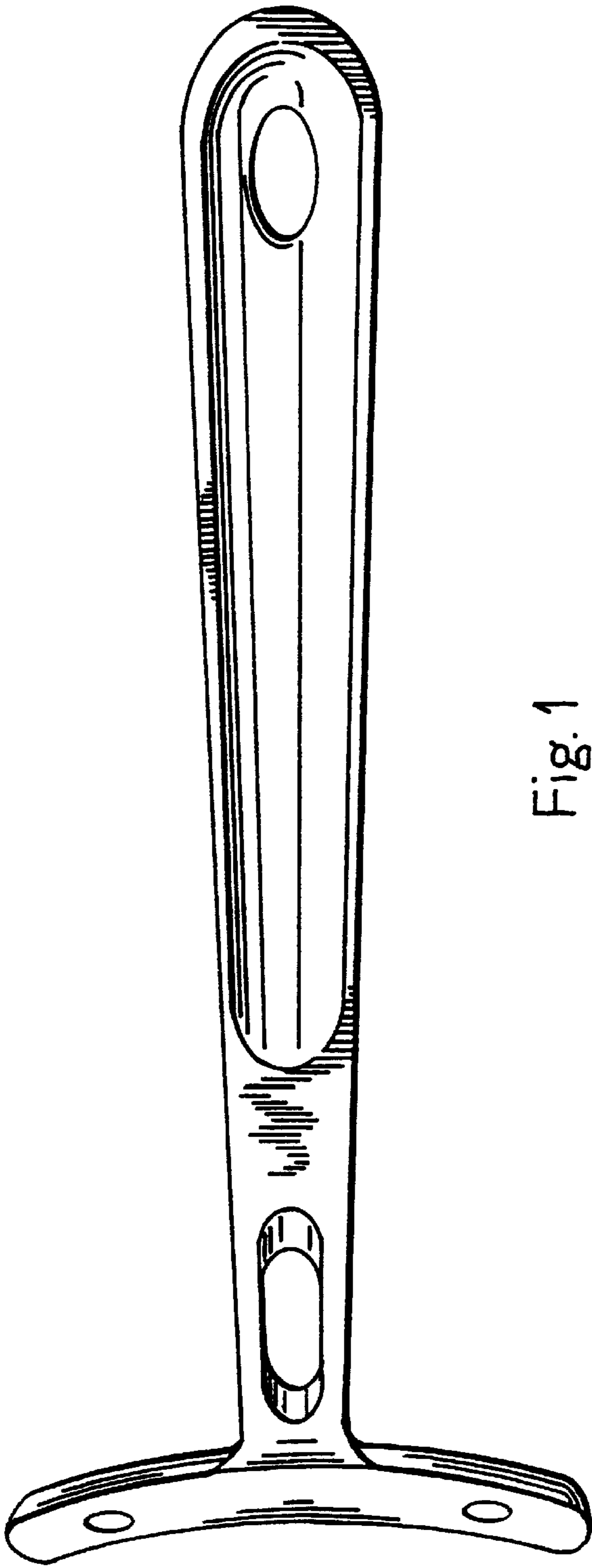

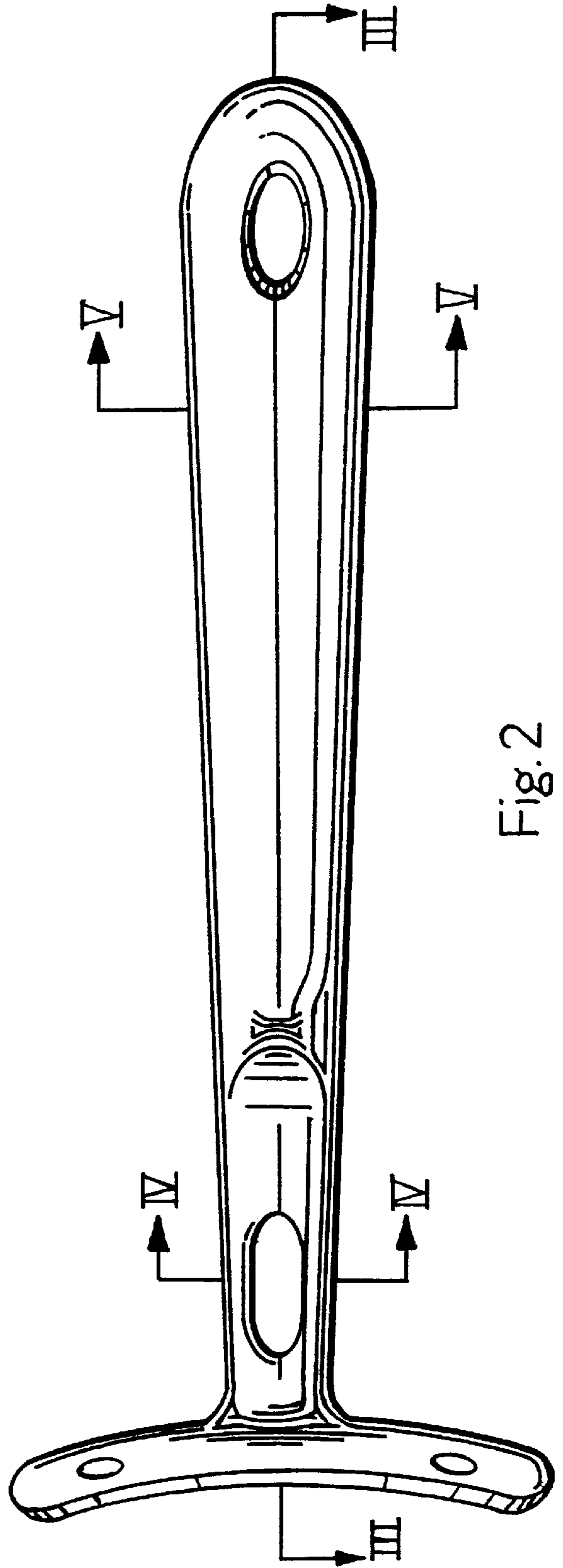

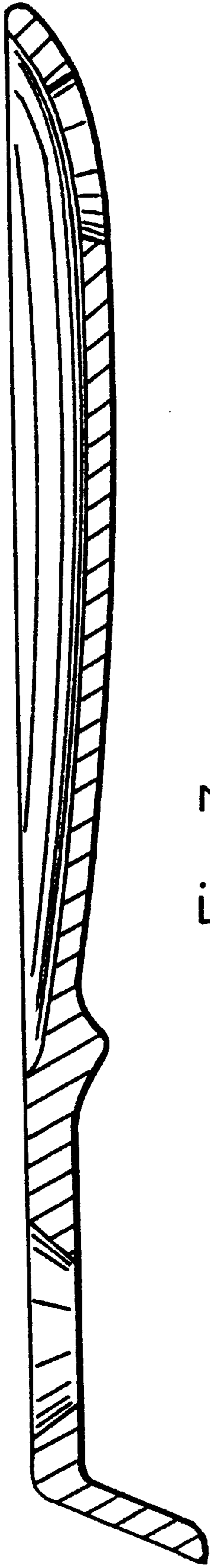

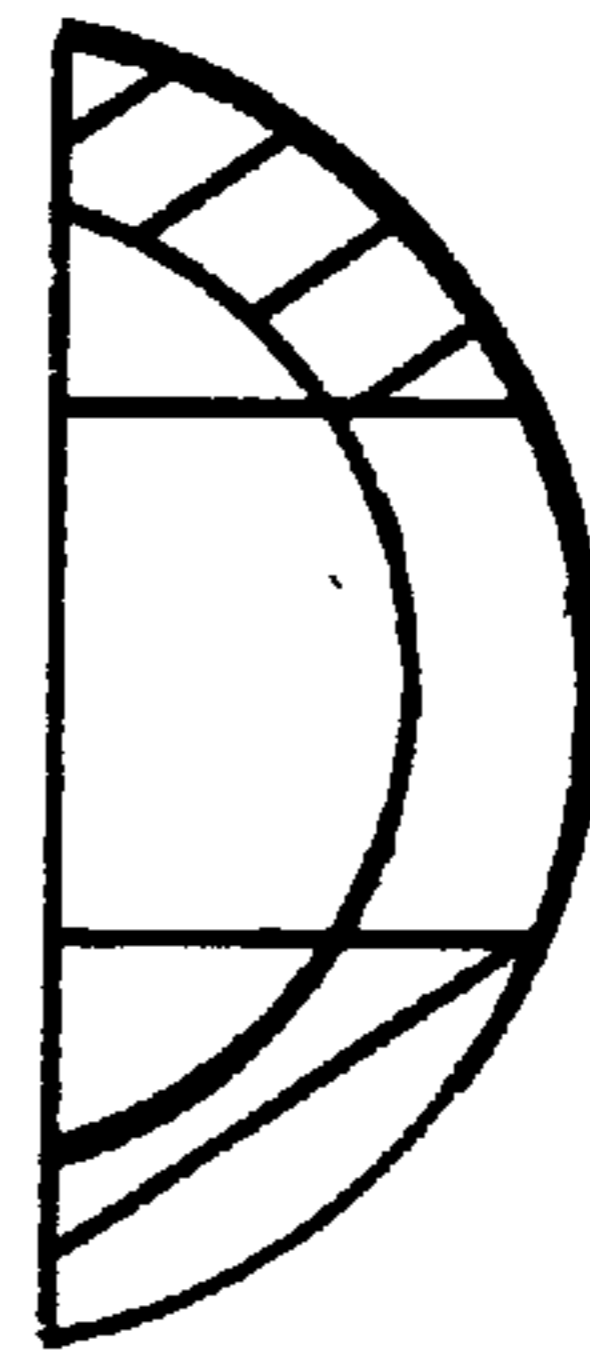

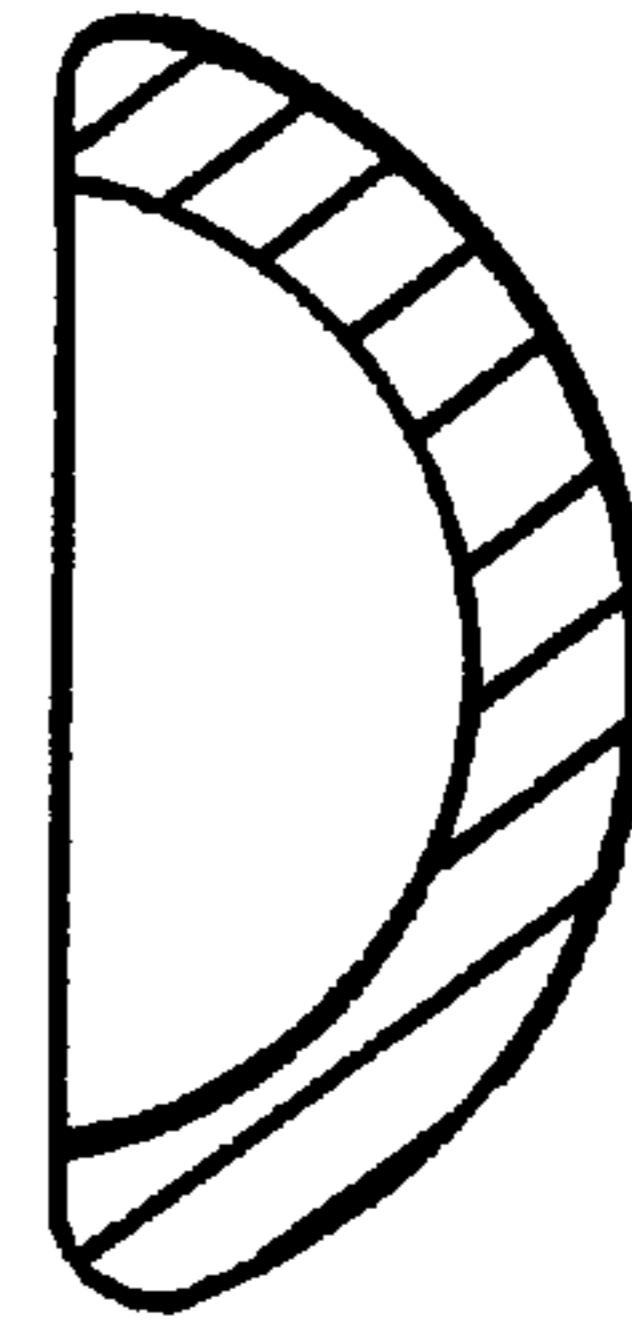

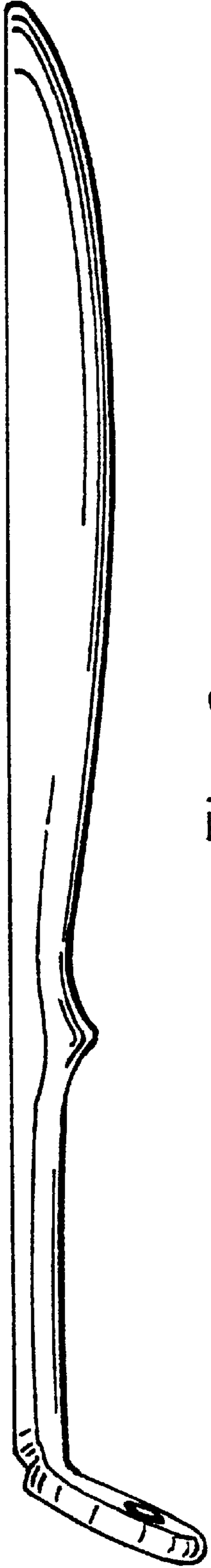

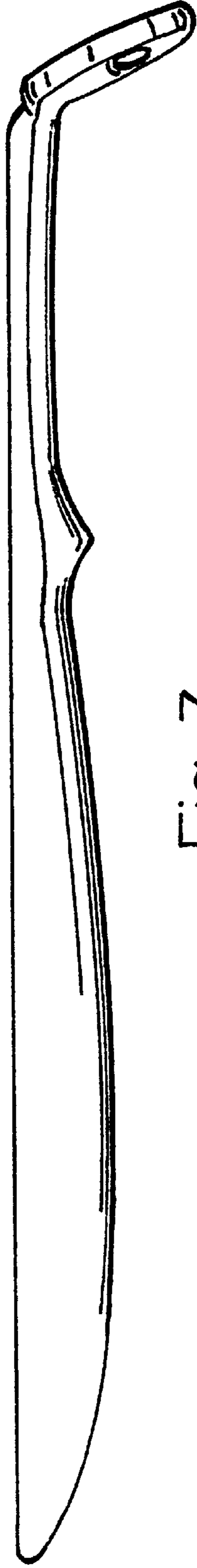

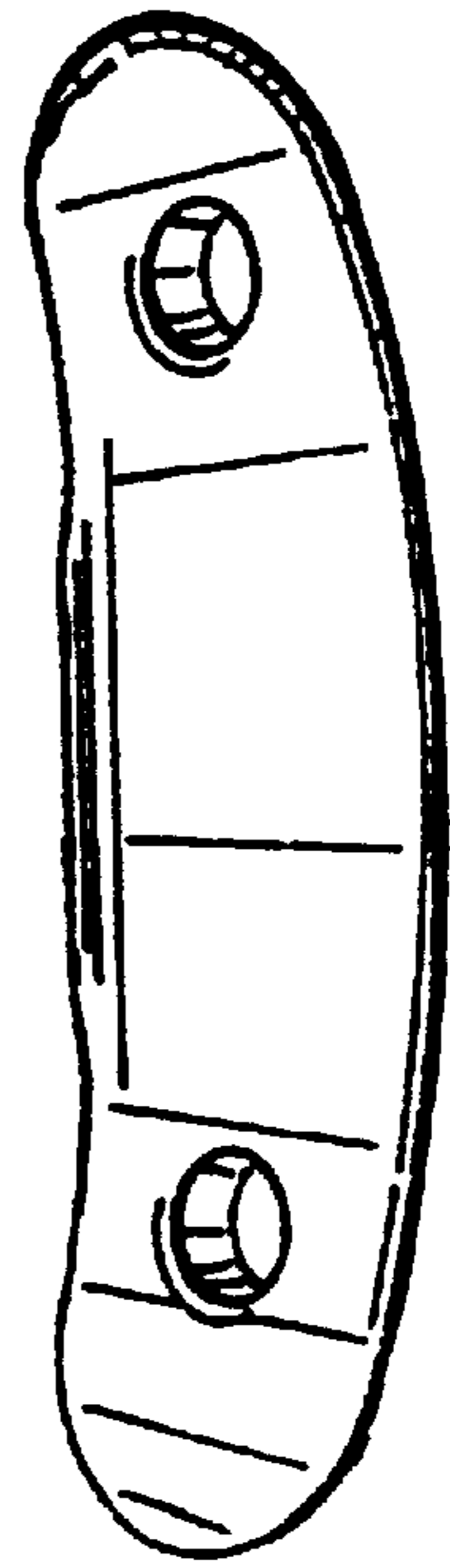

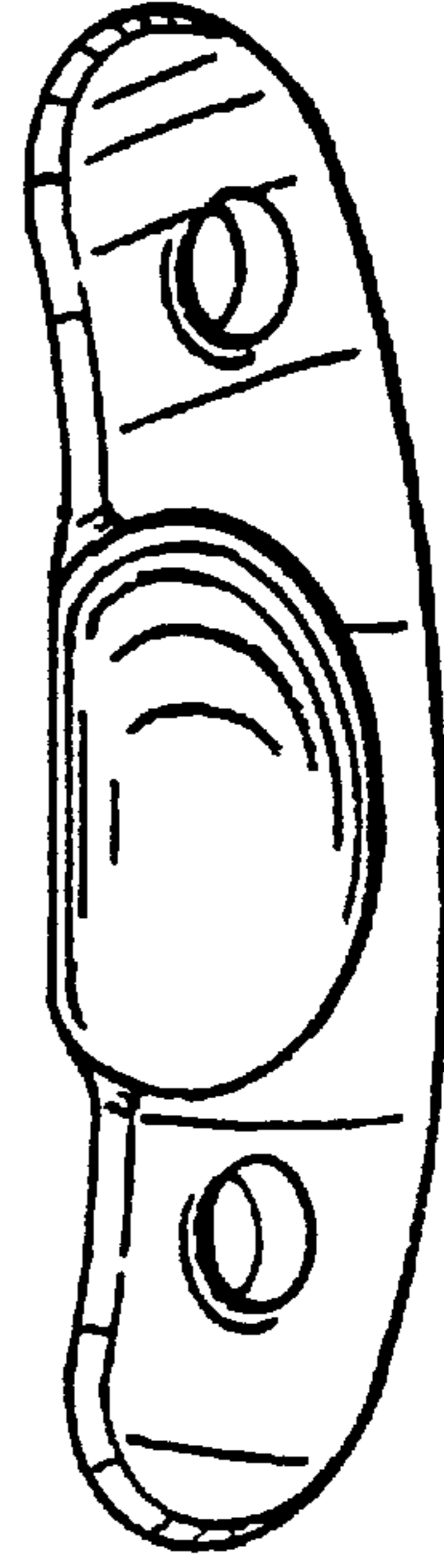

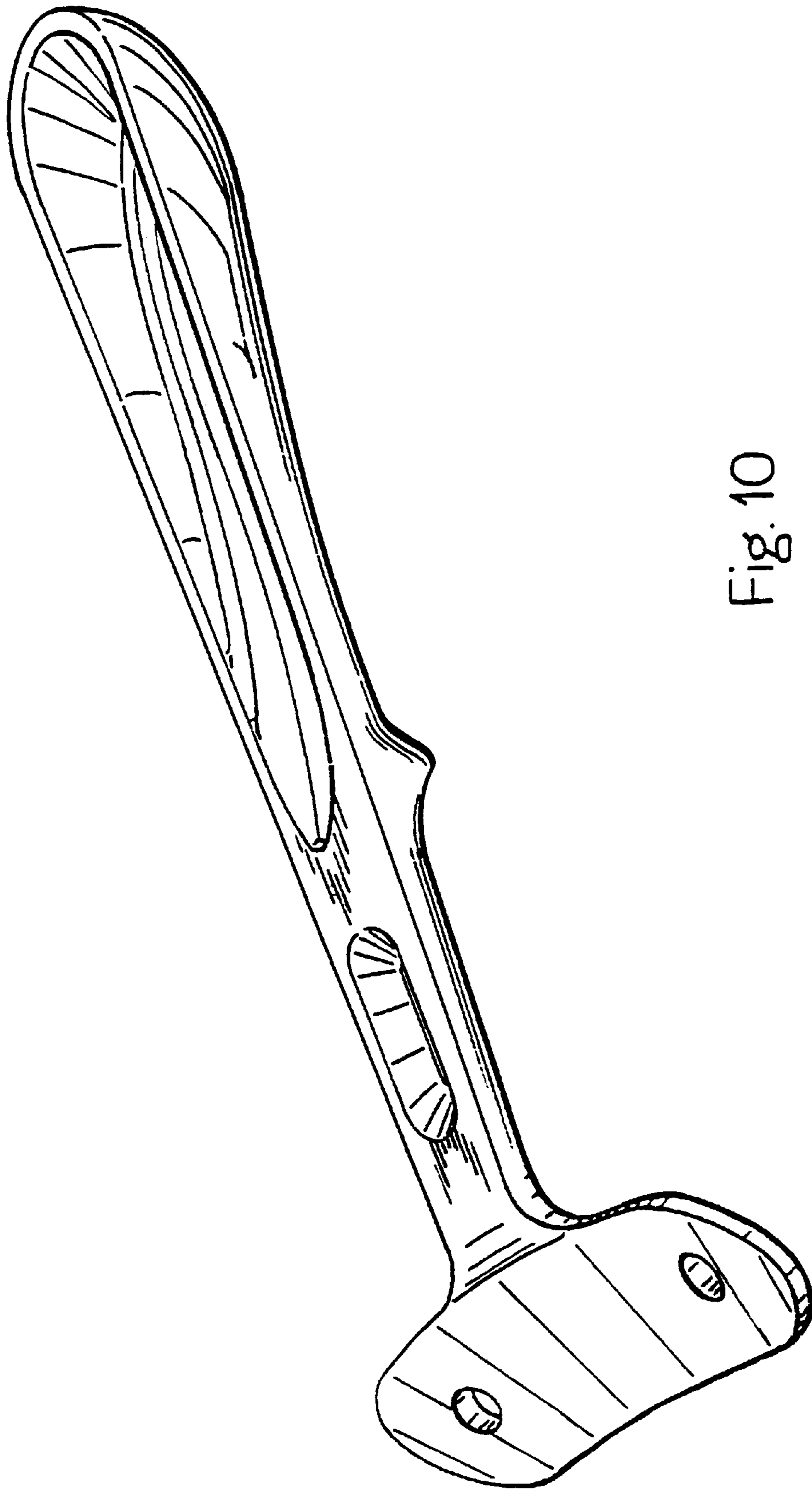
