(57) **CLAIM**

The ornamental design for a configuration for a container, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of an opaque container embodying the invention.

FIG. 2 is a first elevational view of the container of FIG. 1.

FIG. 3 is a bottom view of the container of FIG. 1.

FIG. 4 is a second elevational view of the container of FIG. 1 at a position at a right angle to the view of FIG. 2.

FIG. 5 is a plan or top view of the container of FIG. 1.

FIG. 6 is a bottom perspective view of a translucent container embodying the invention.

FIG. 7 is a first elevational view of the container of FIG. 6.

FIG. 8 is a bottom view of the container of FIG. 6.

FIG. 9 is a second elevational view of the container of FIG. 6 at a position at a right angle to the view of FIG. 7.

FIG. 10 is a plan or top view of the container of FIG. 6; and,

FIG. 11 is an elevational view of a container embodying the invention but which also indicates the possible presence of a threaded portion and screw cap.

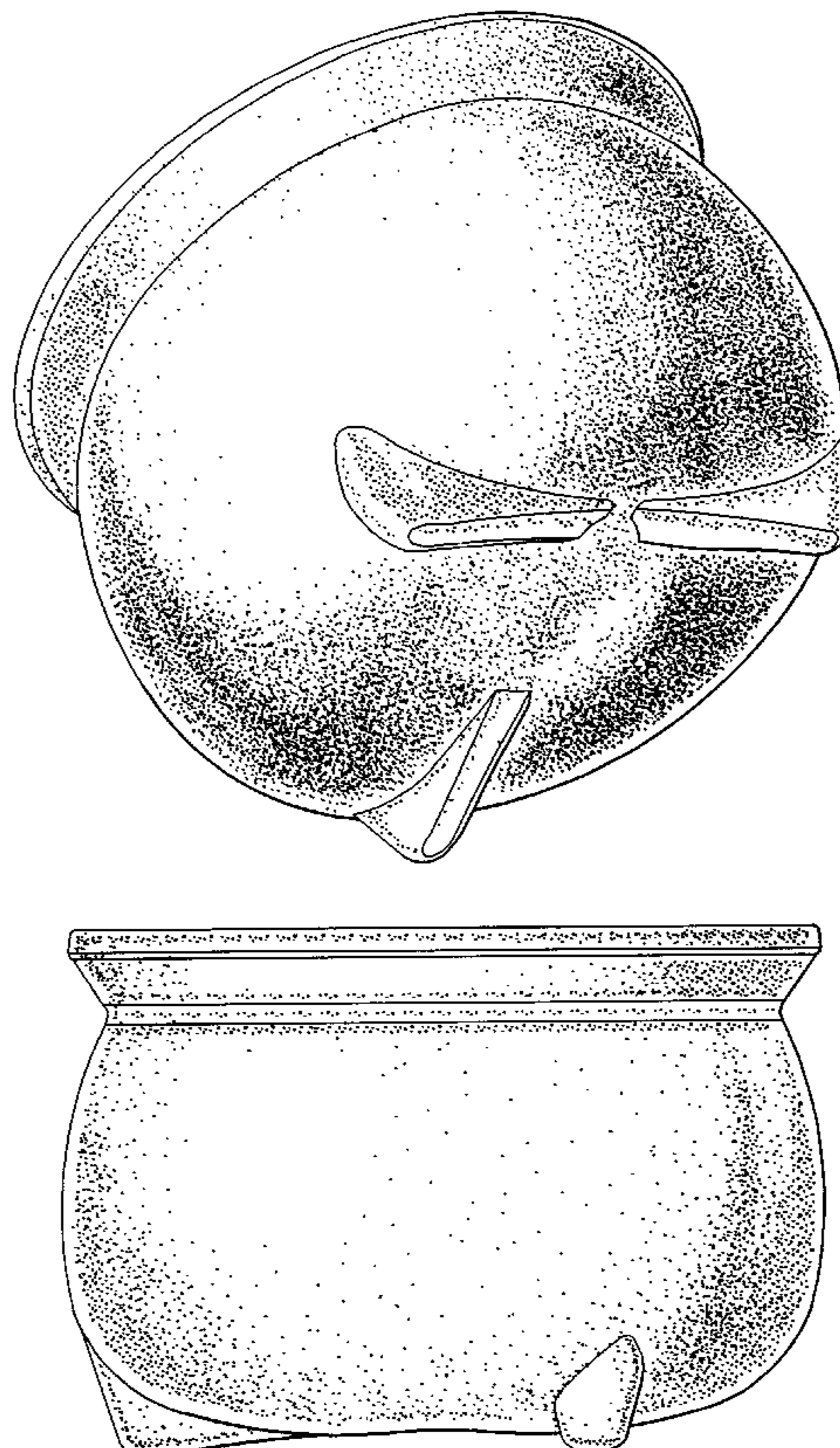

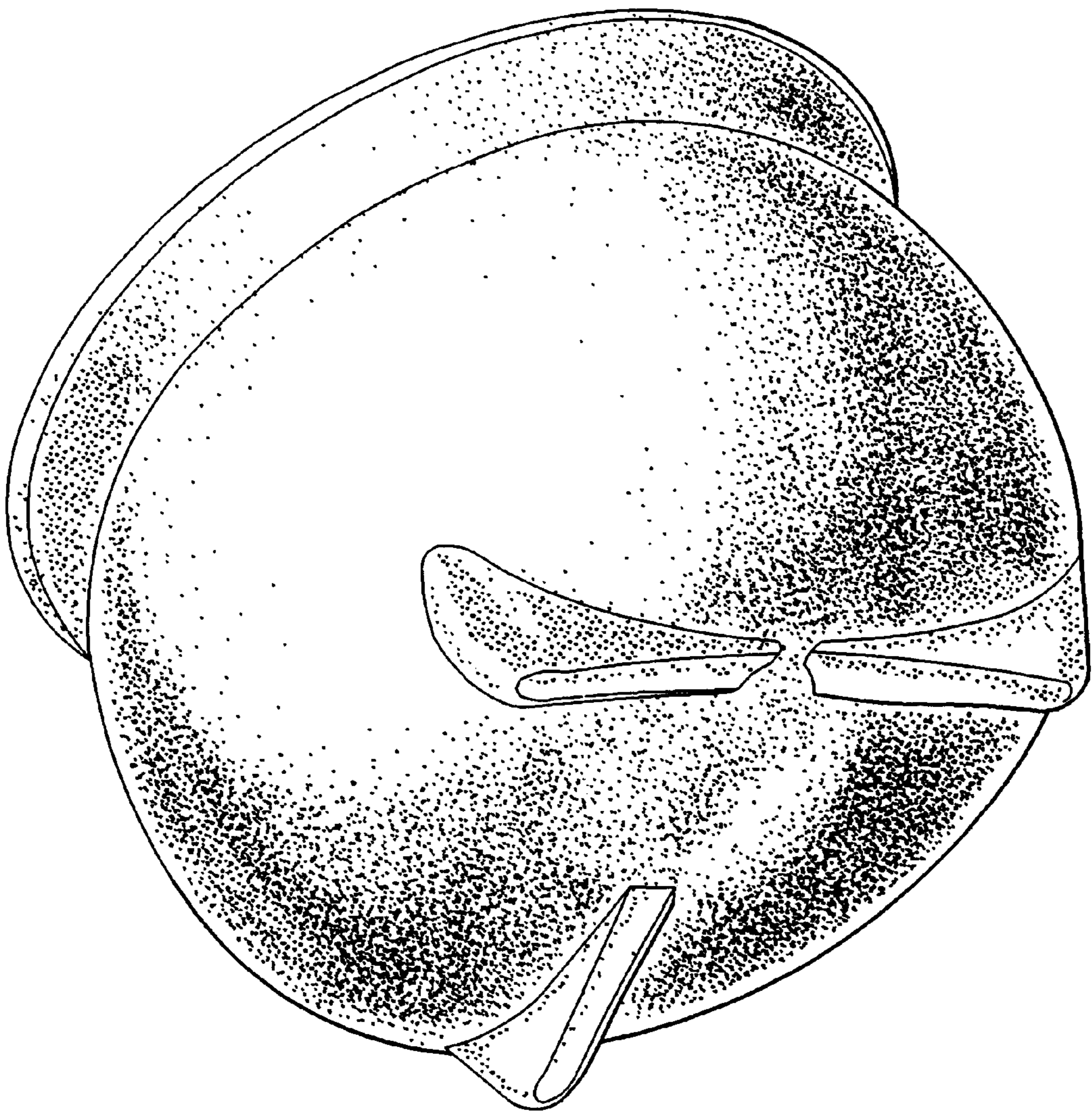

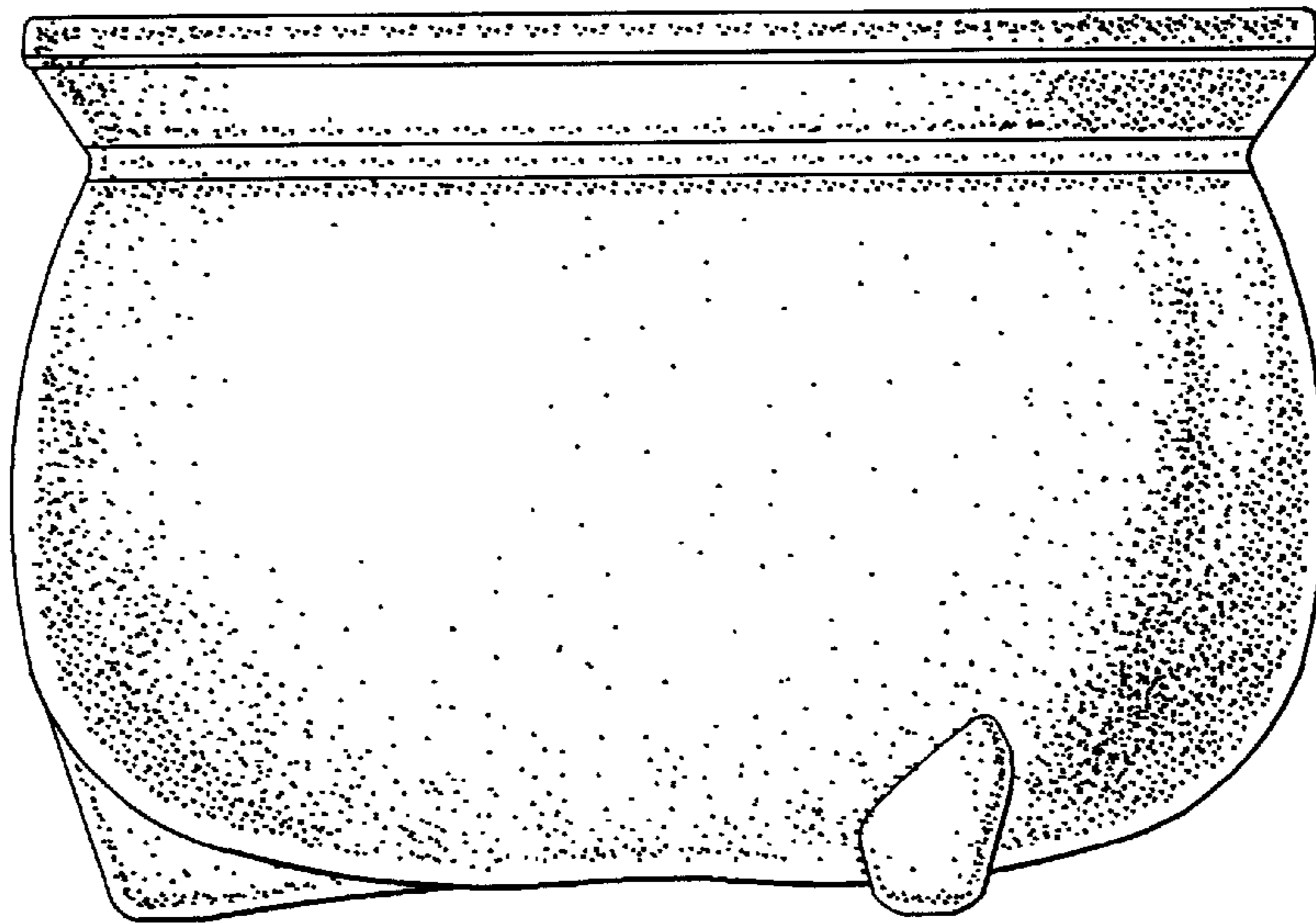

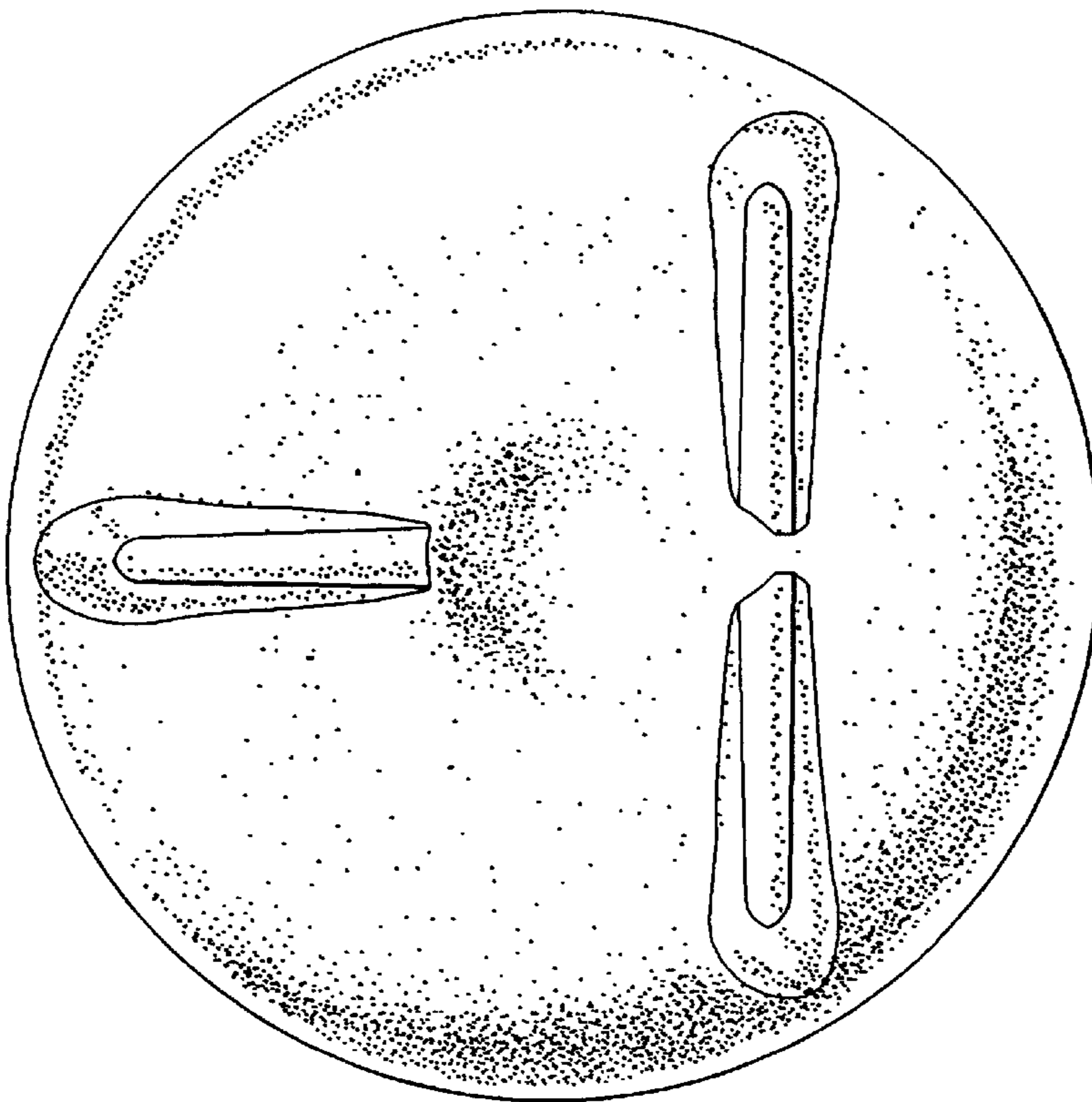

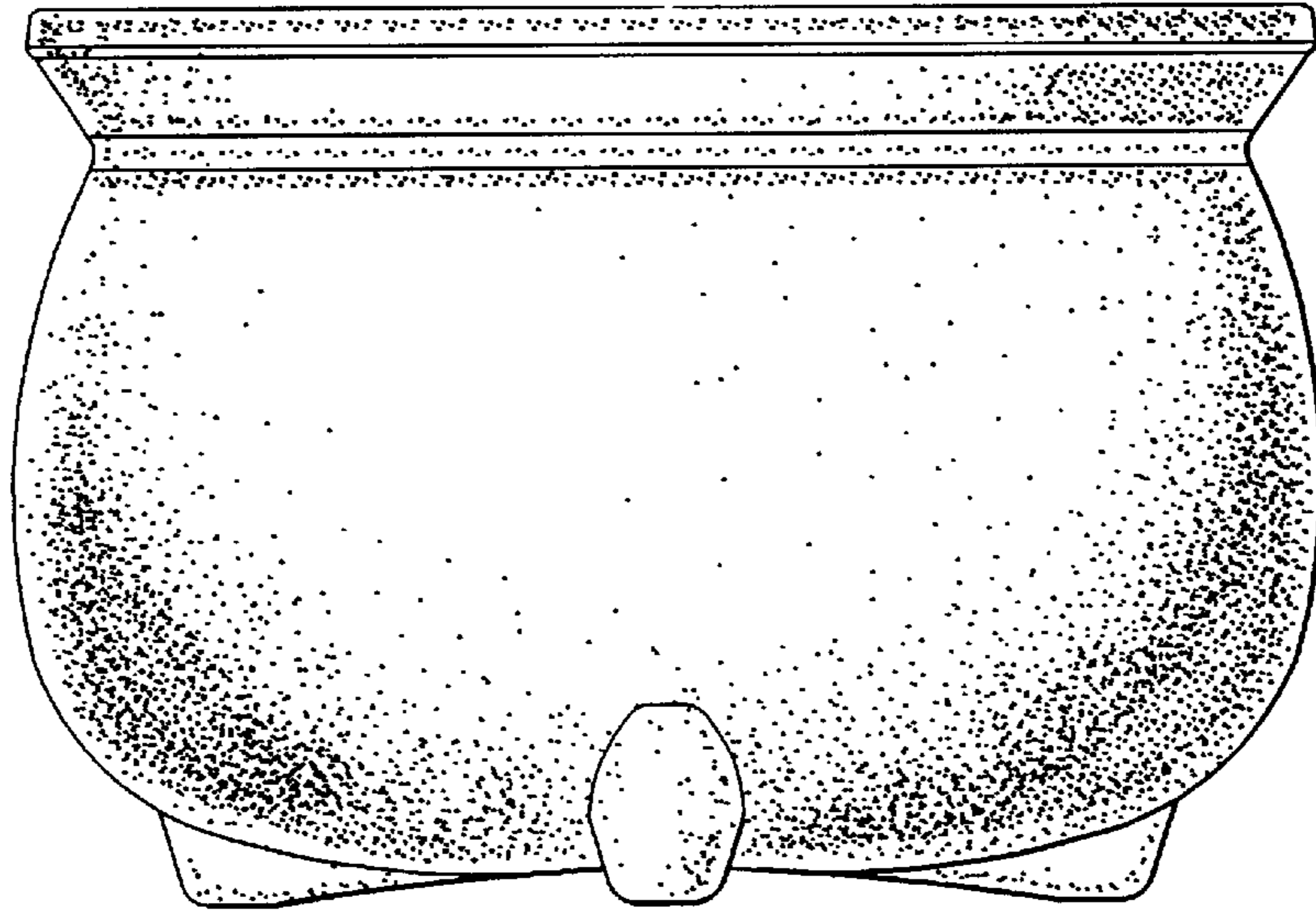

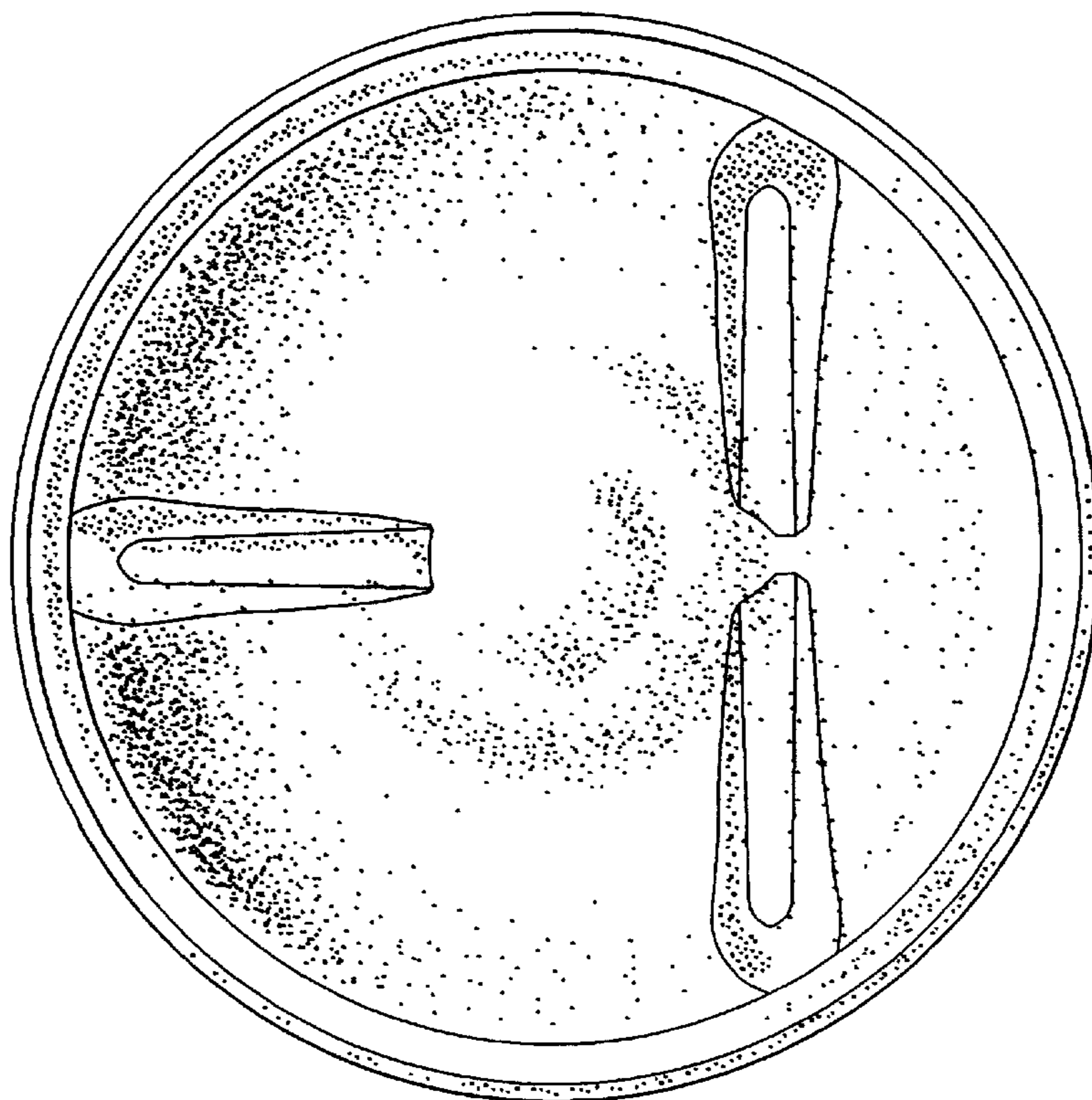

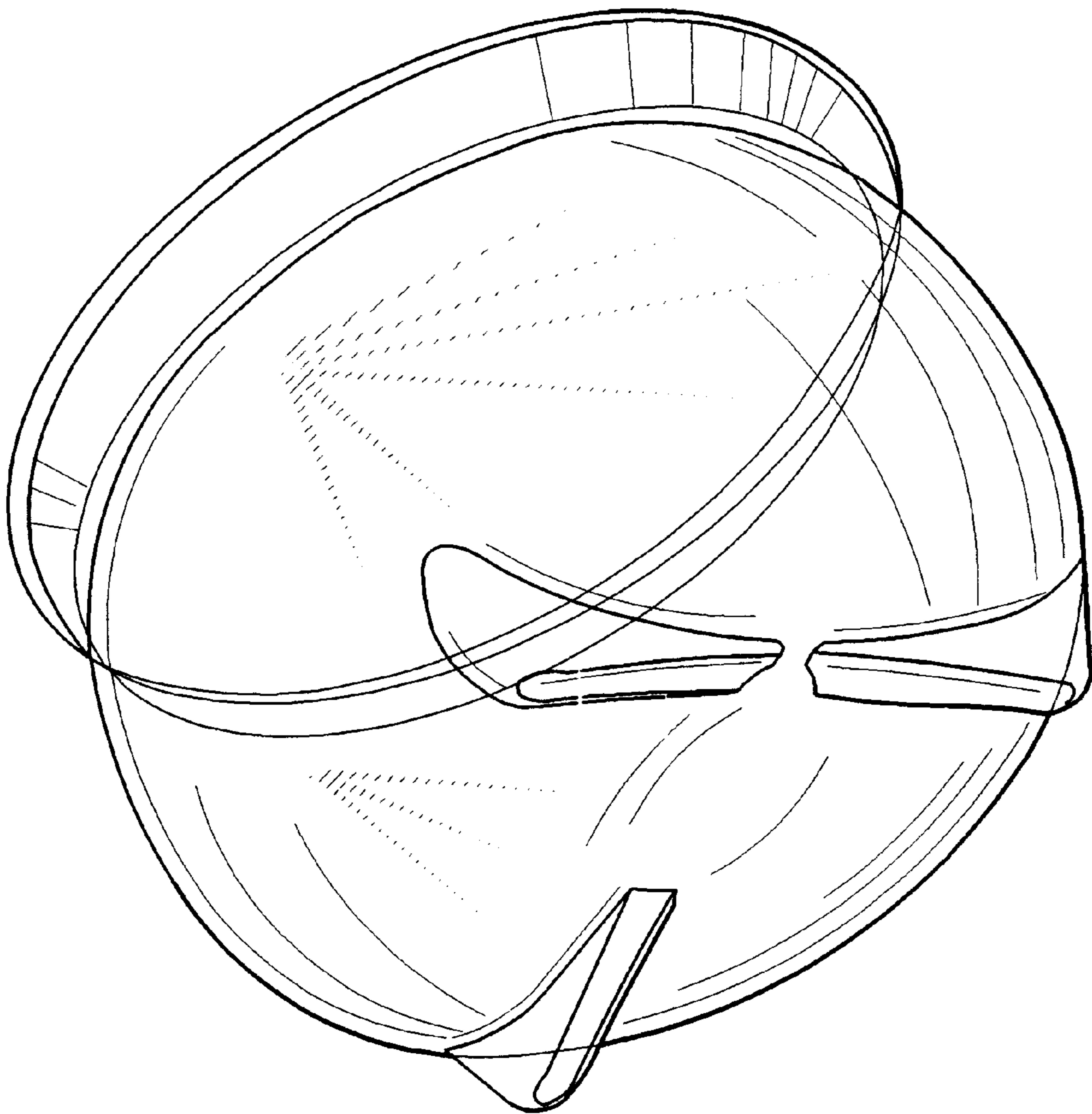

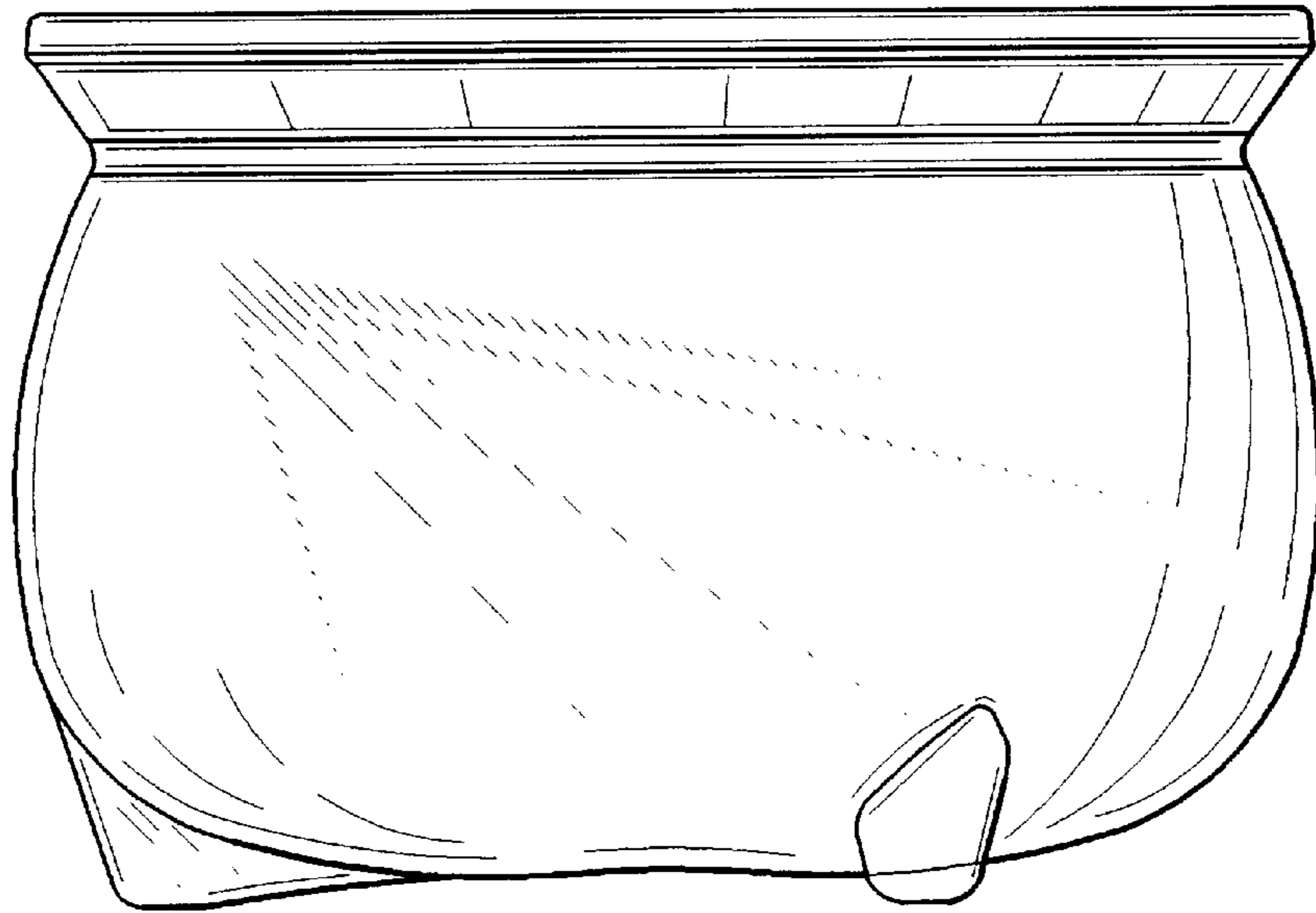

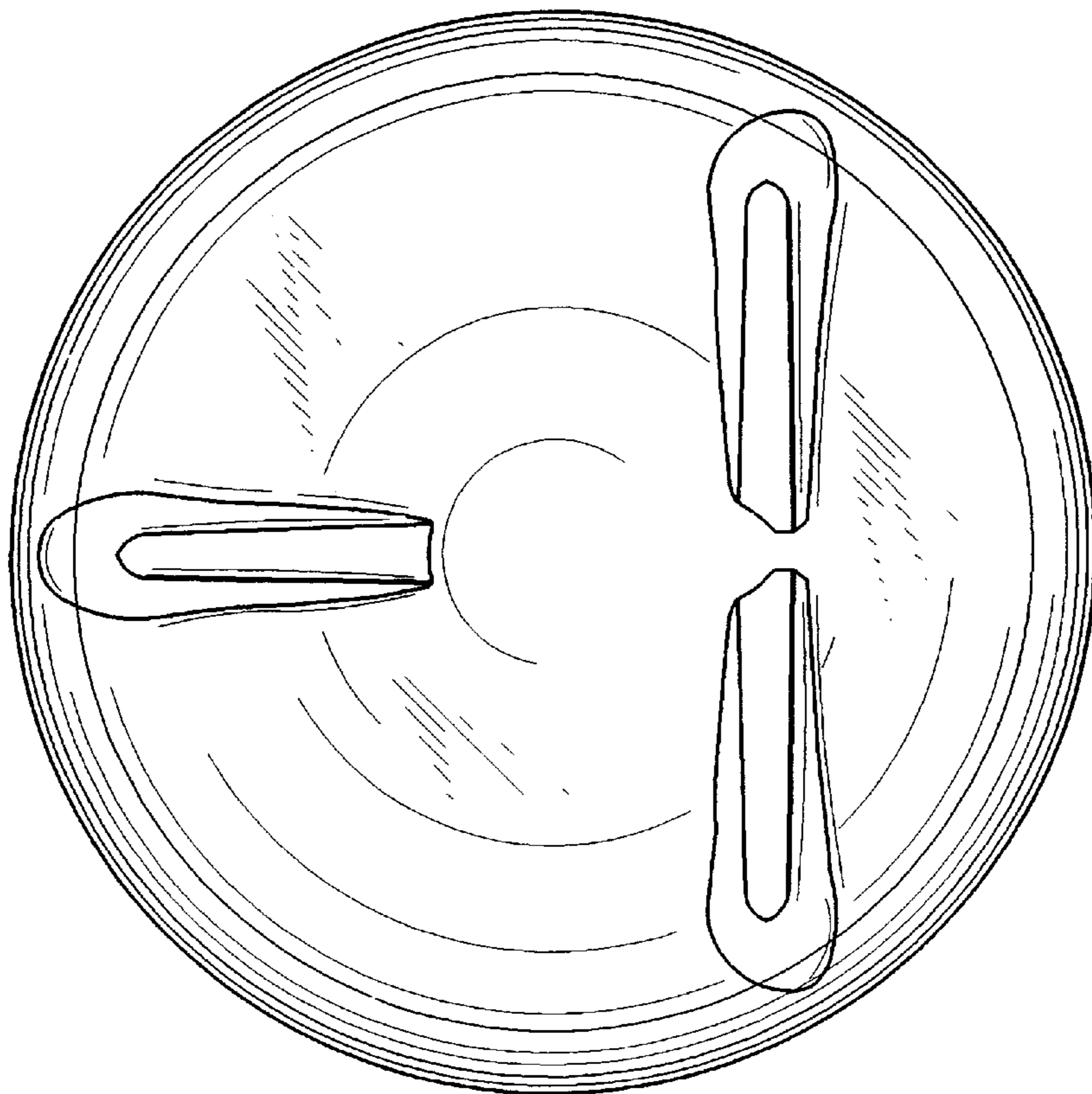

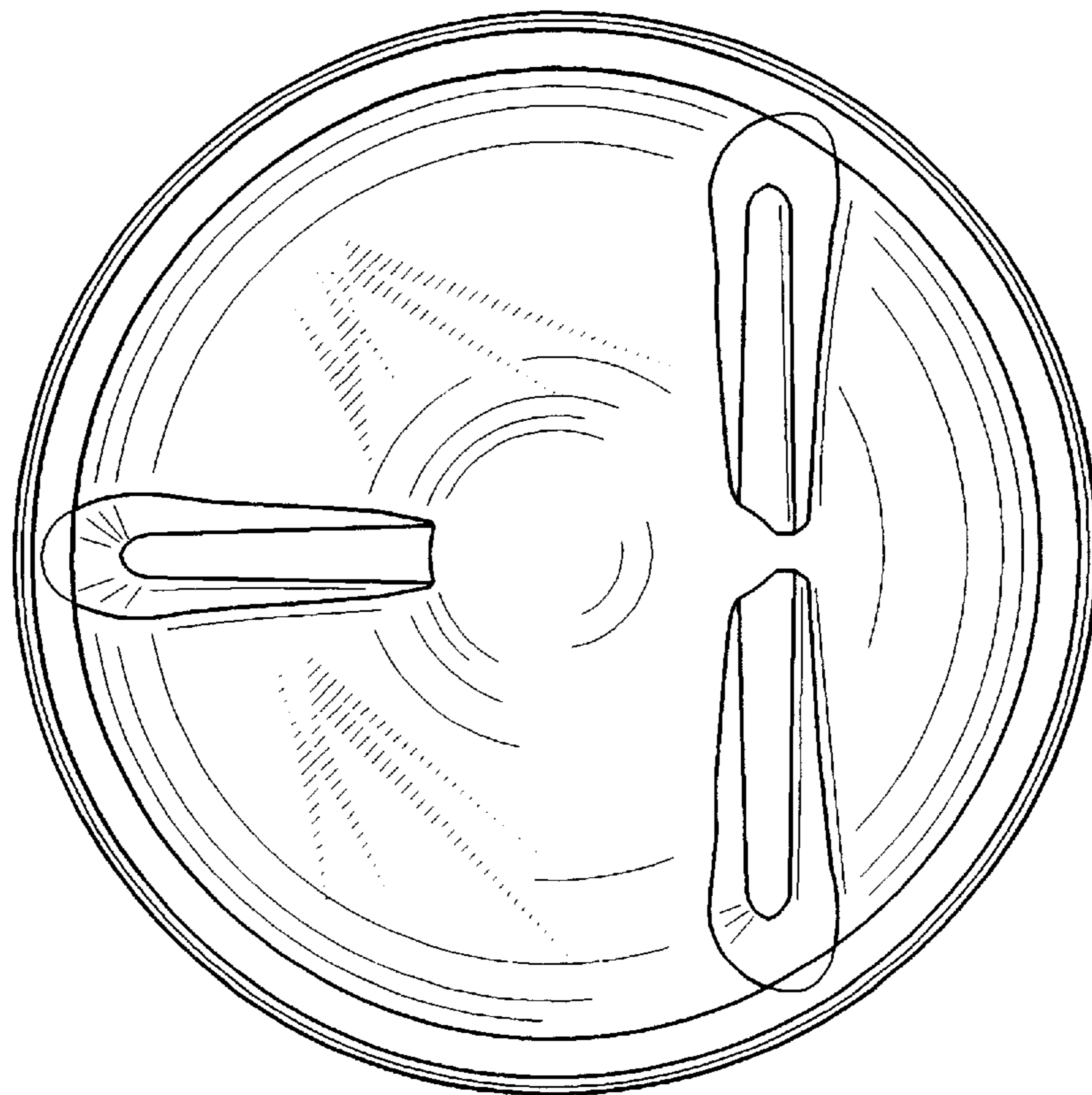
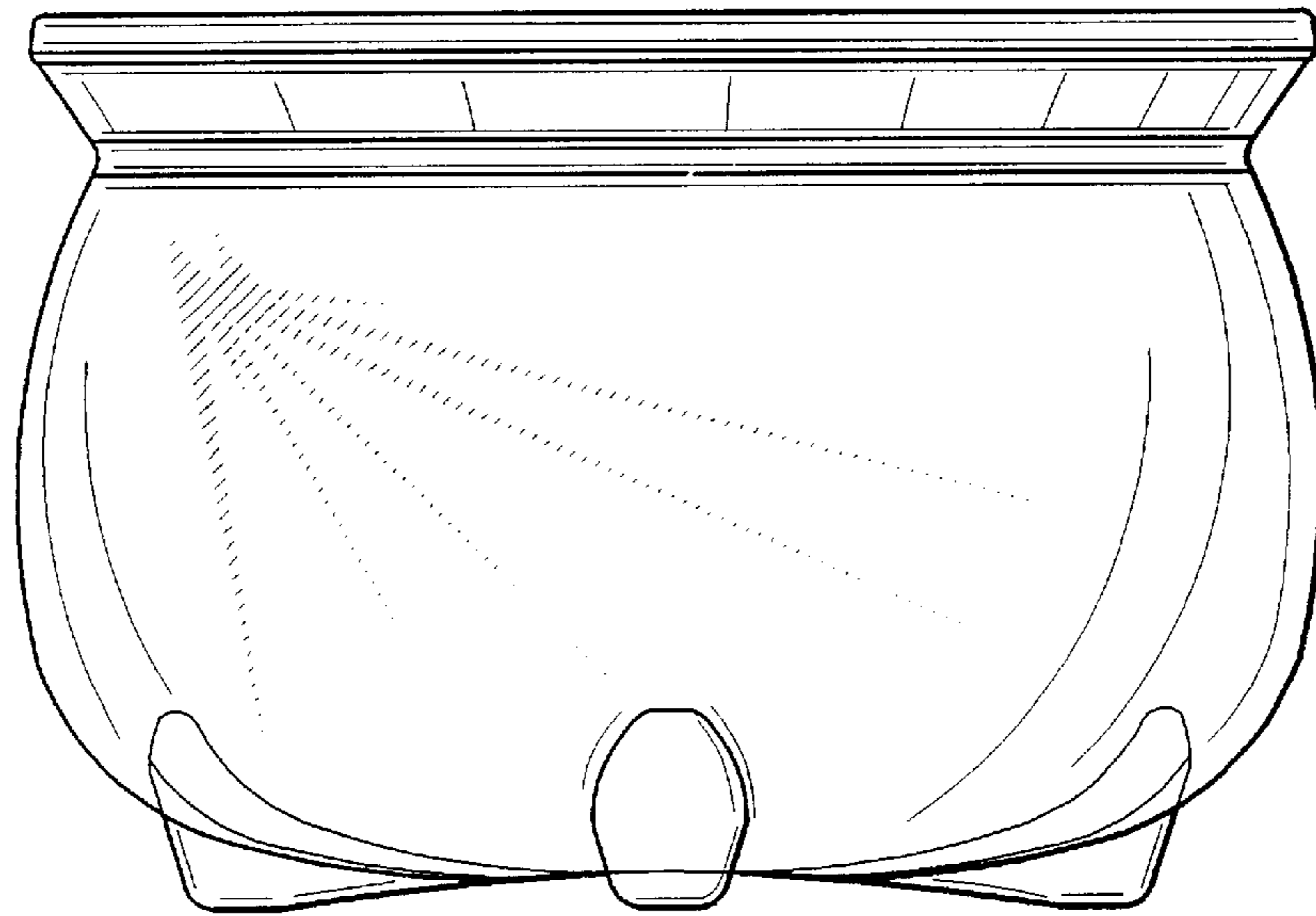
