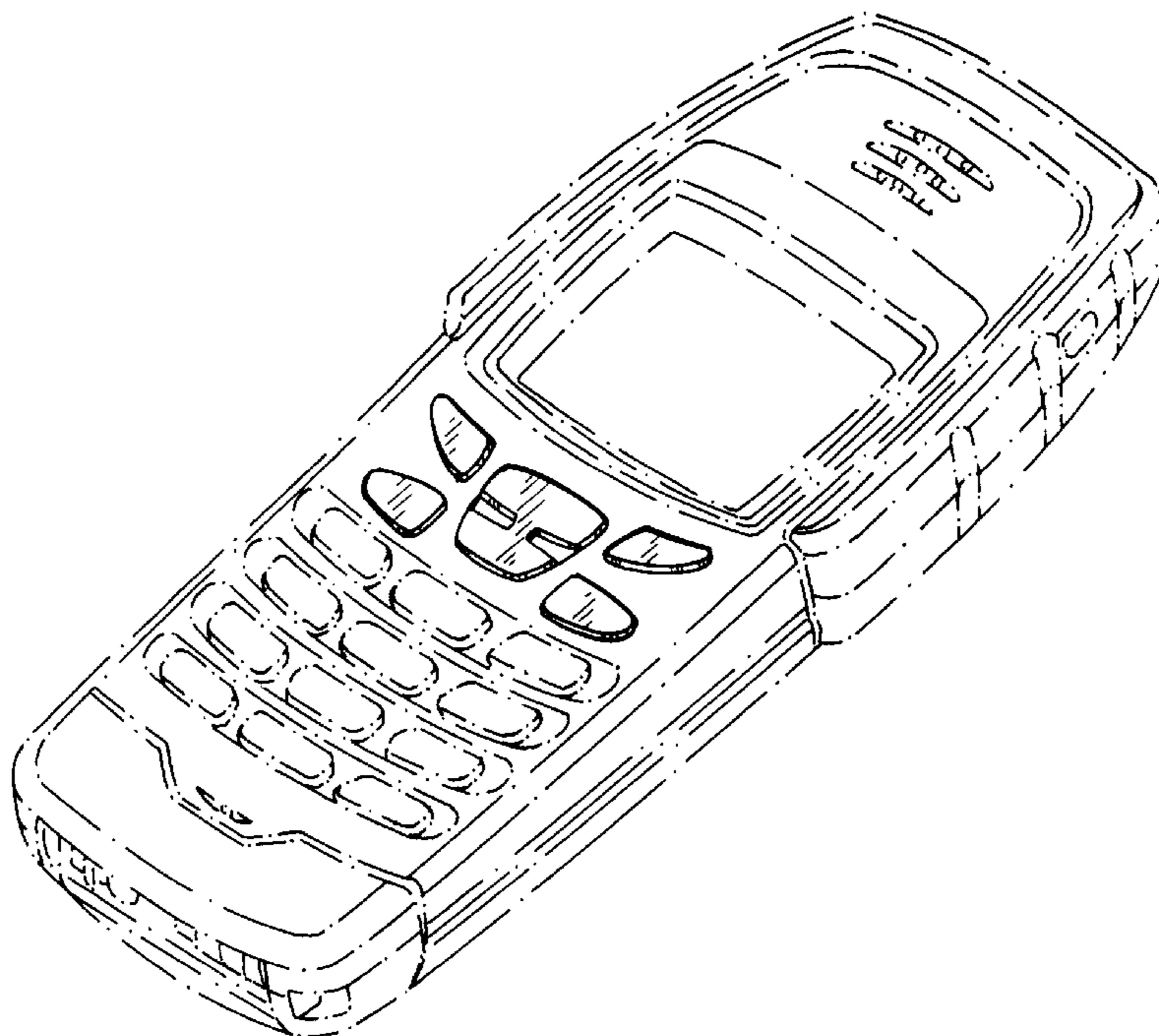
The ornamental design for a key array for telephone handset, as shown and described.

**DESCRIPTION**

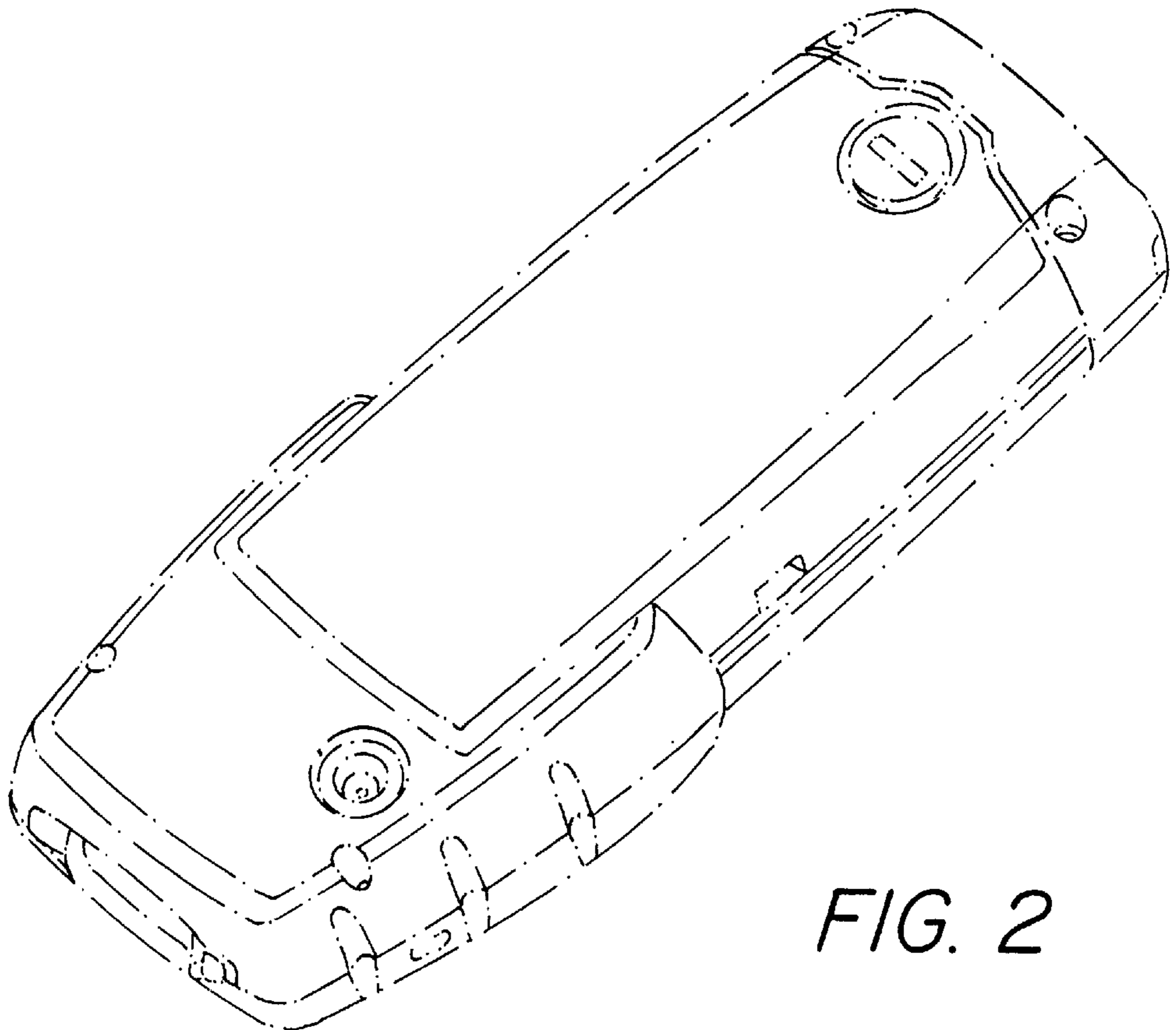
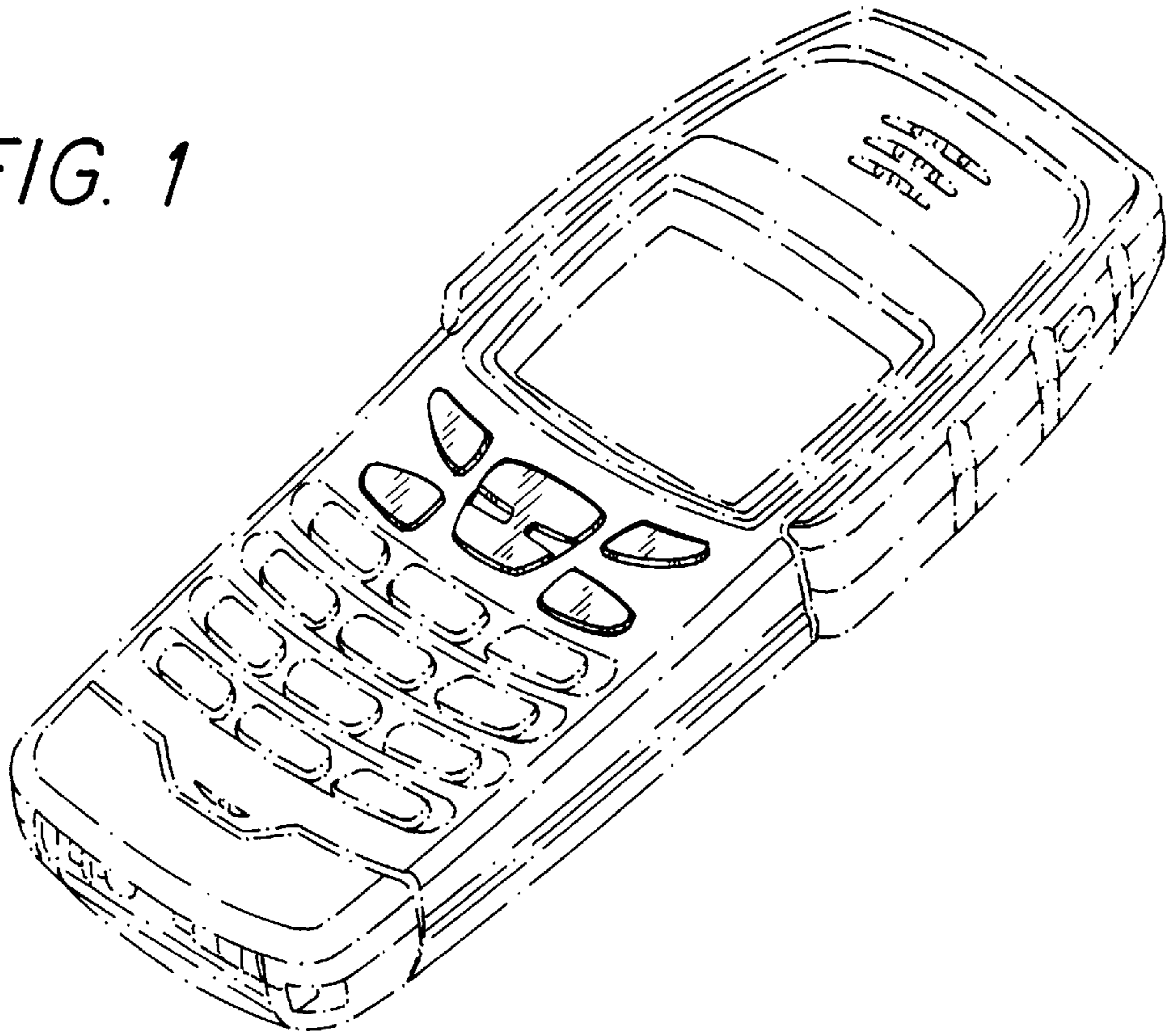

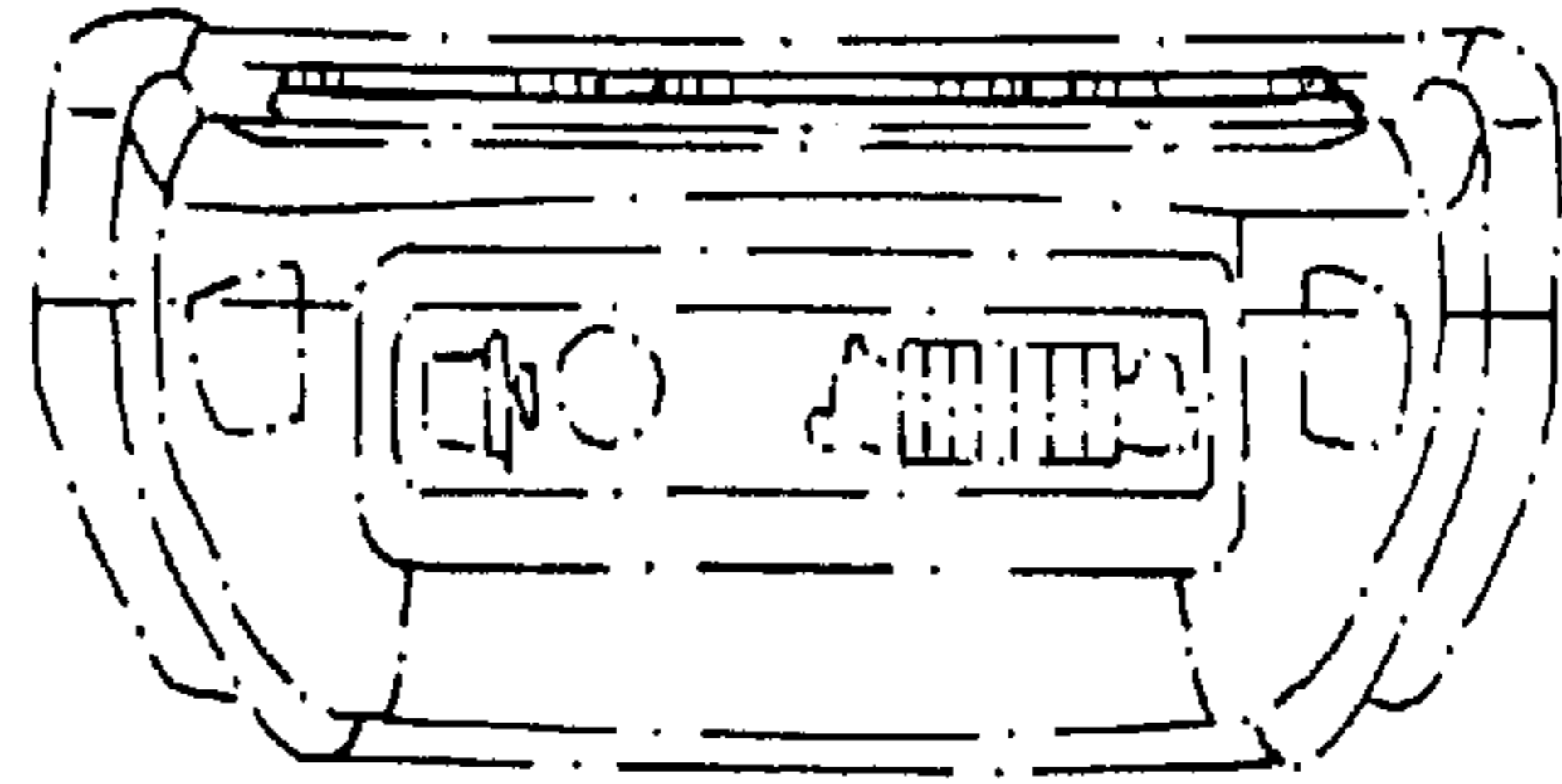

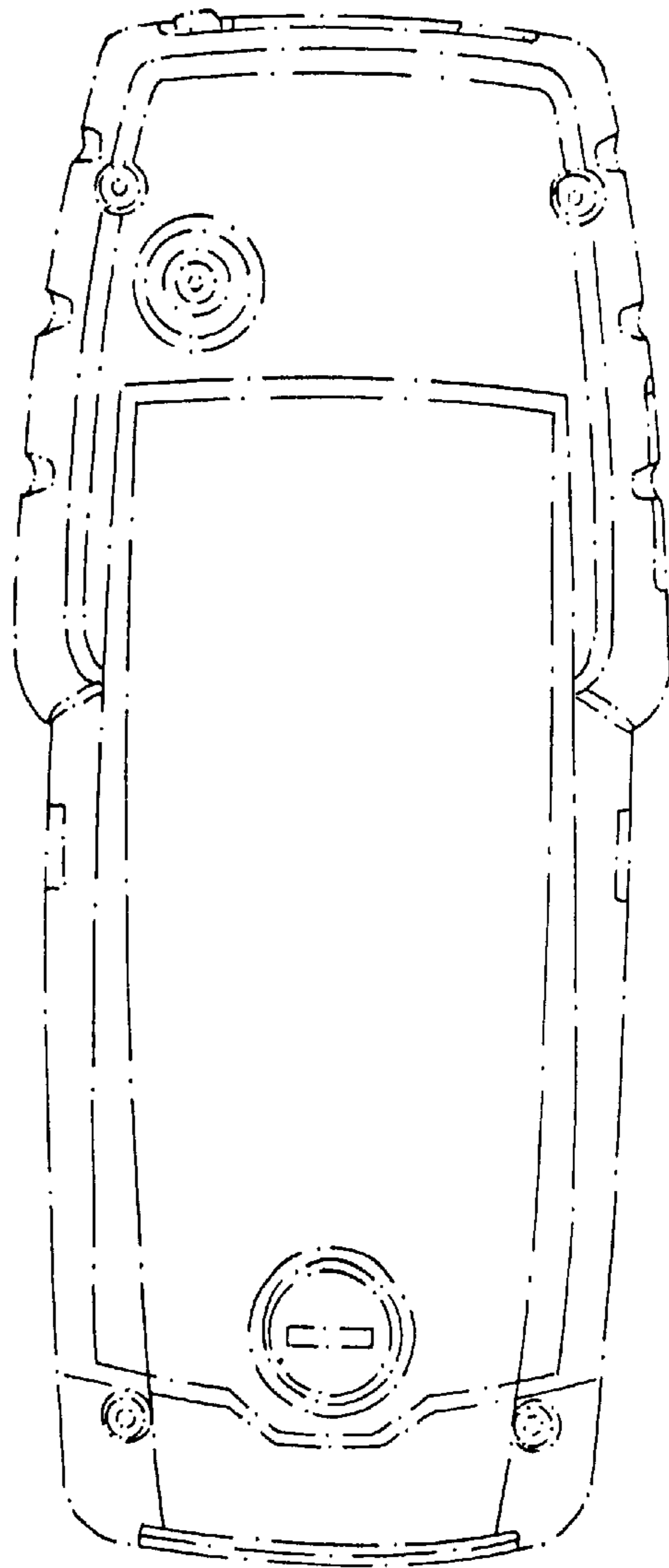

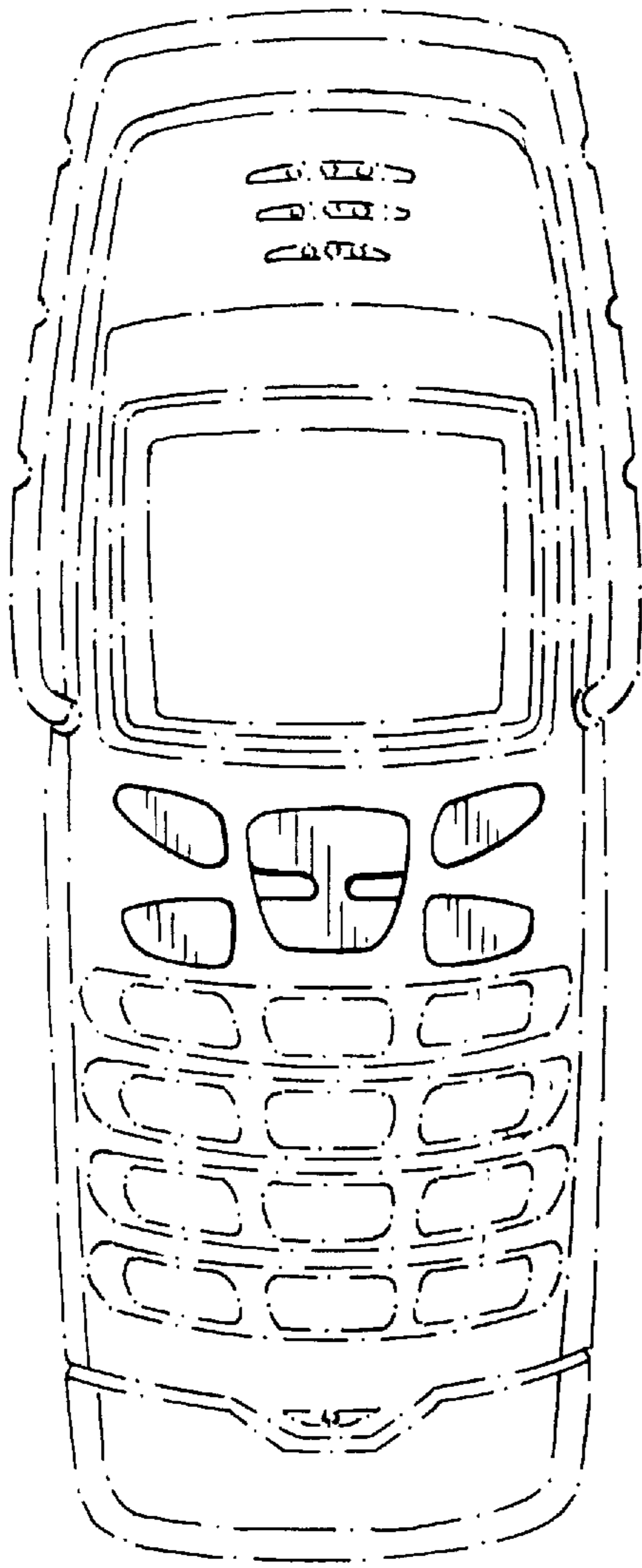

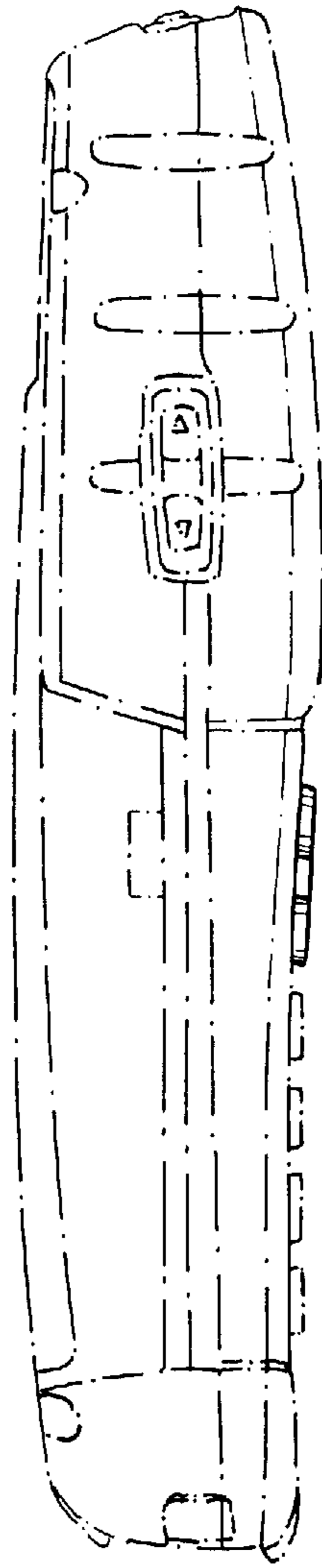
