**DESCRIPTION**

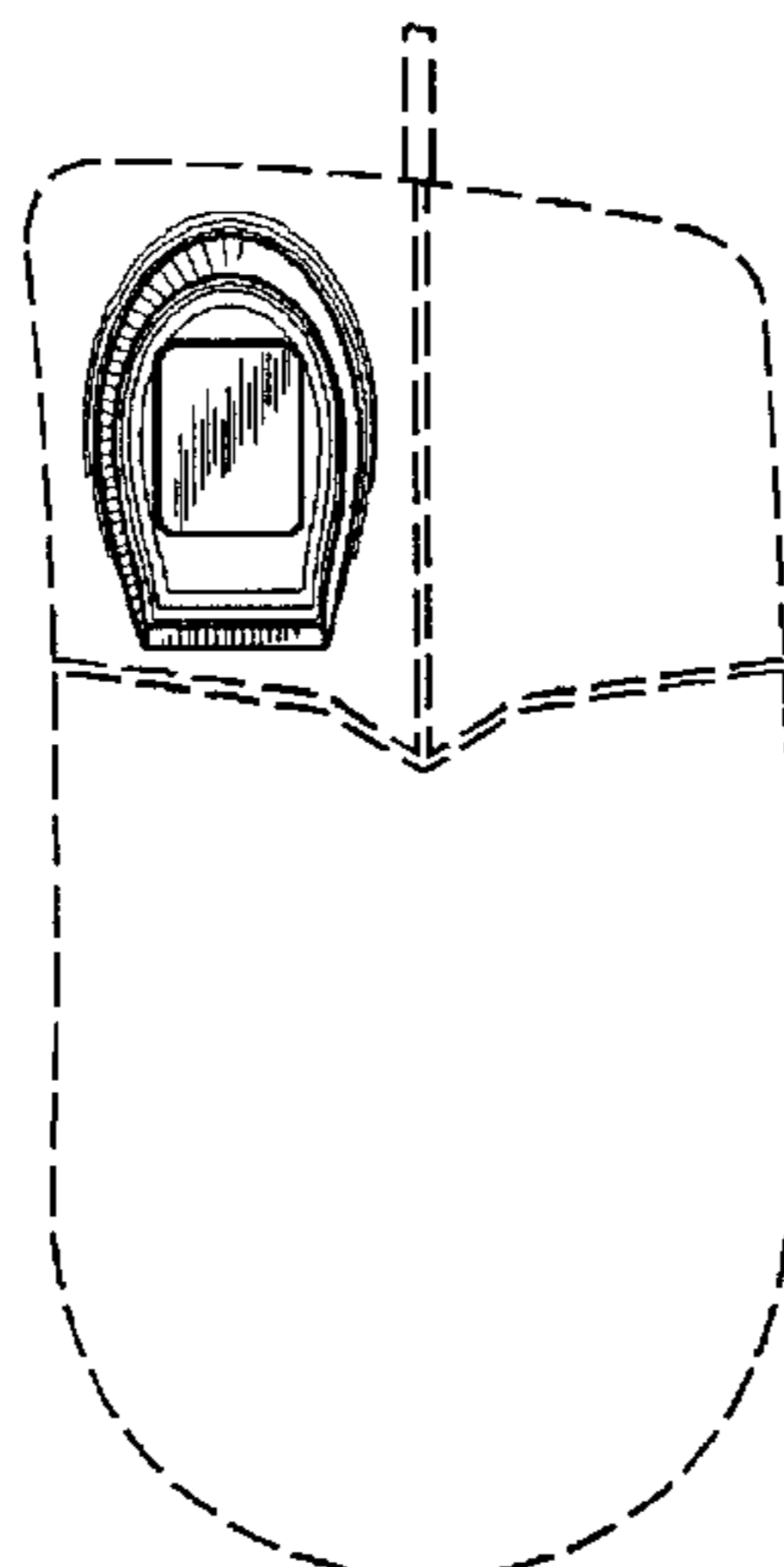

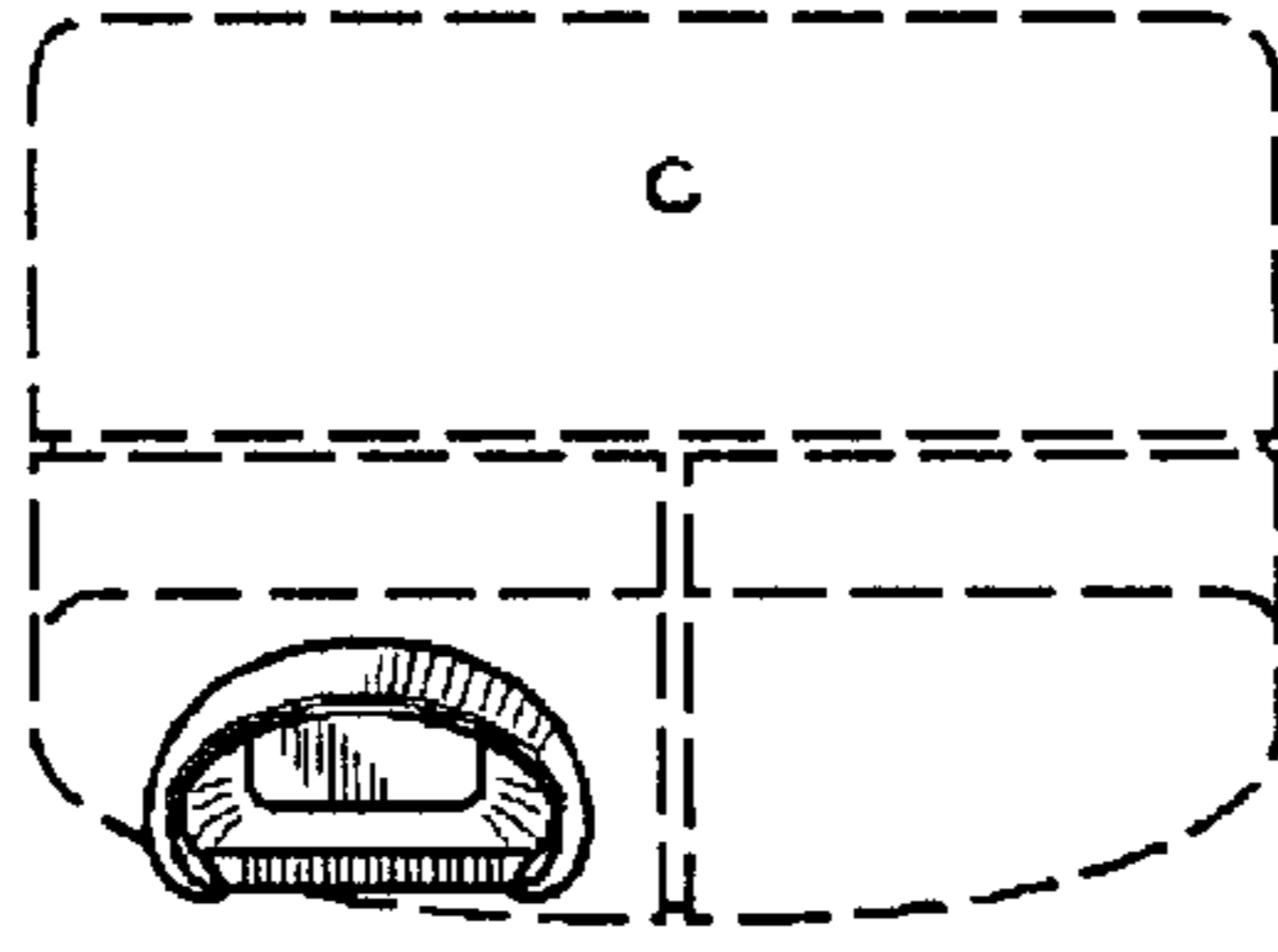

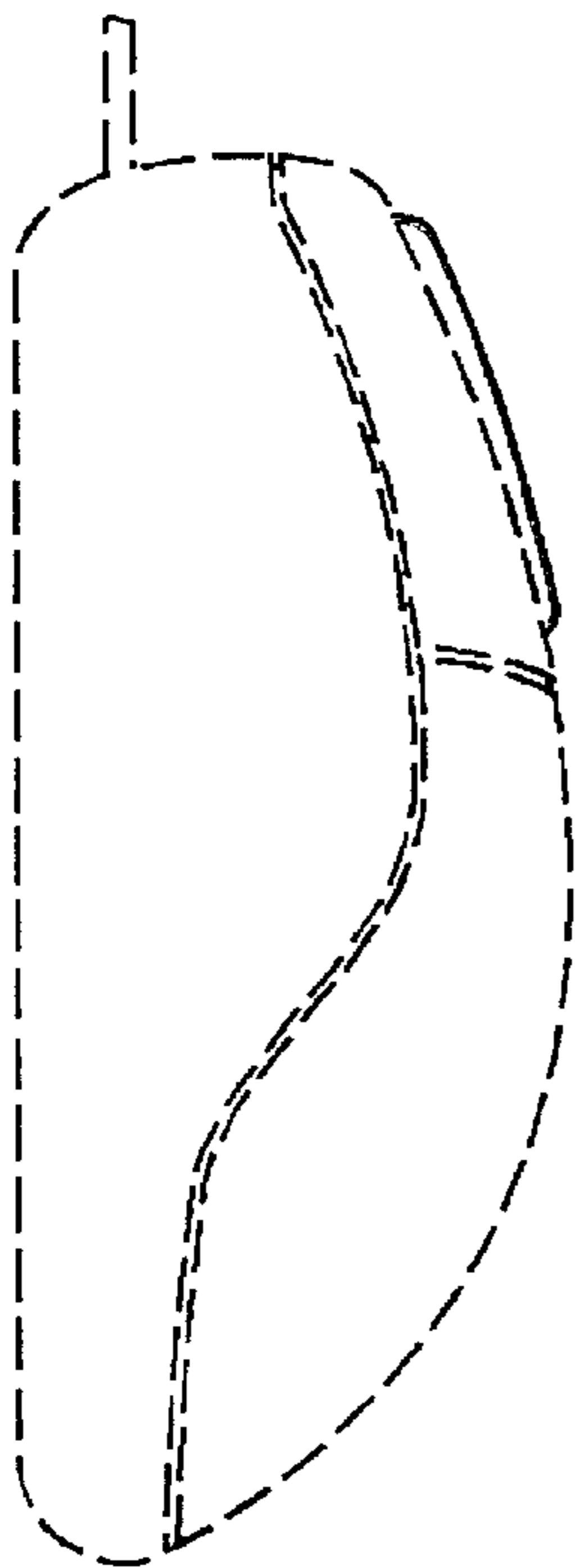

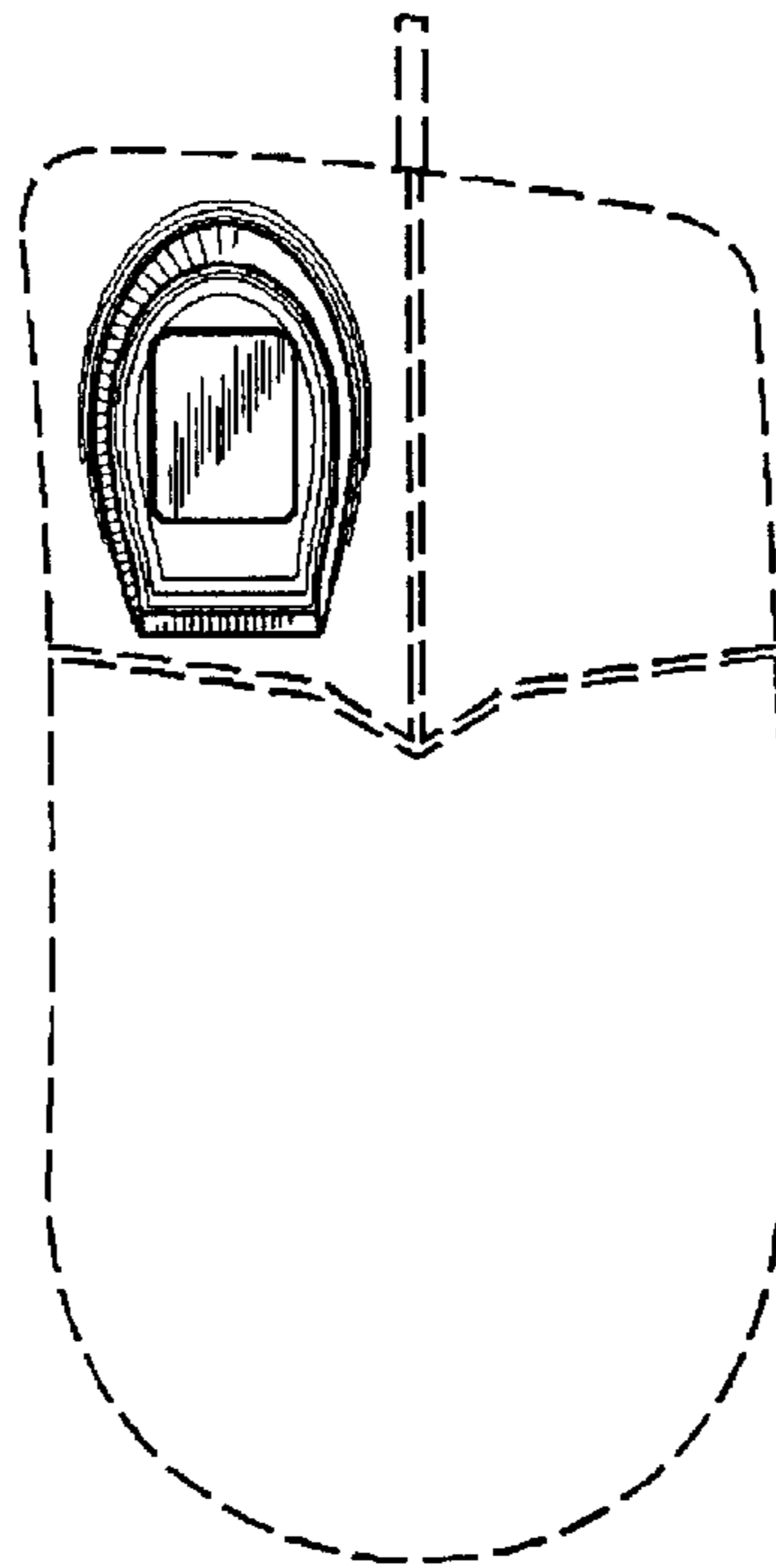

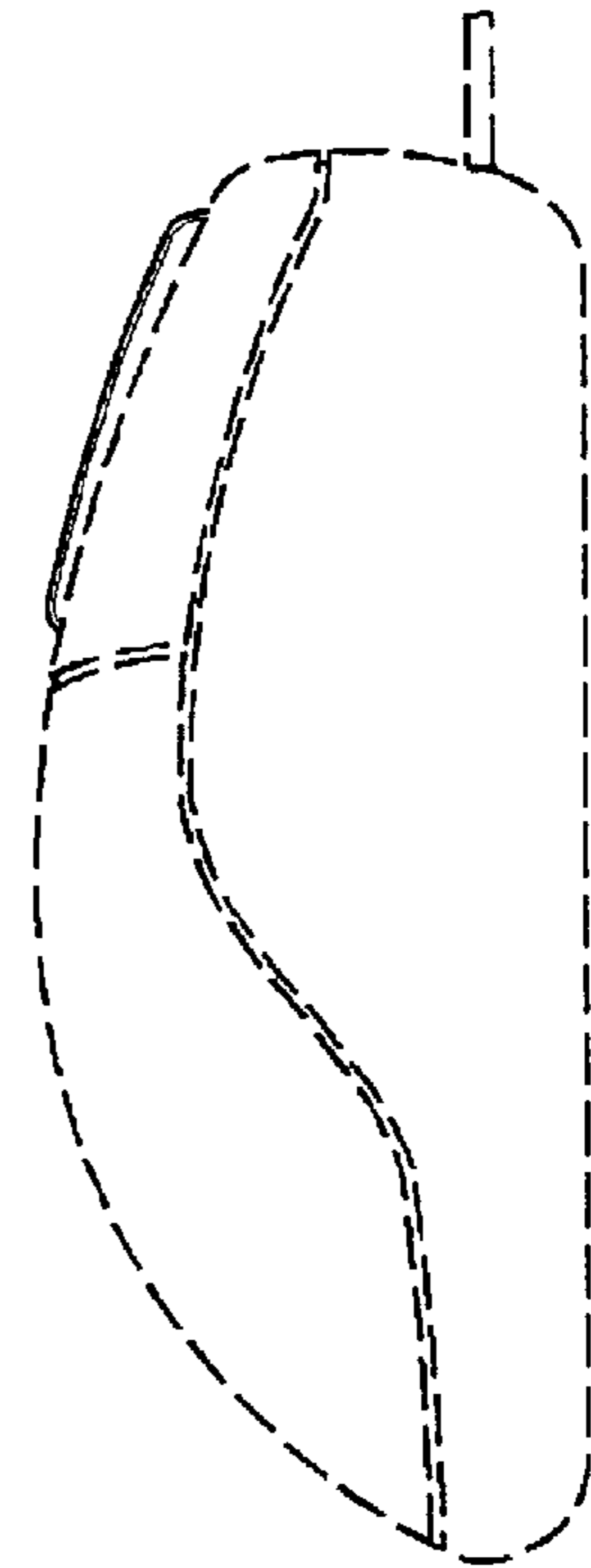

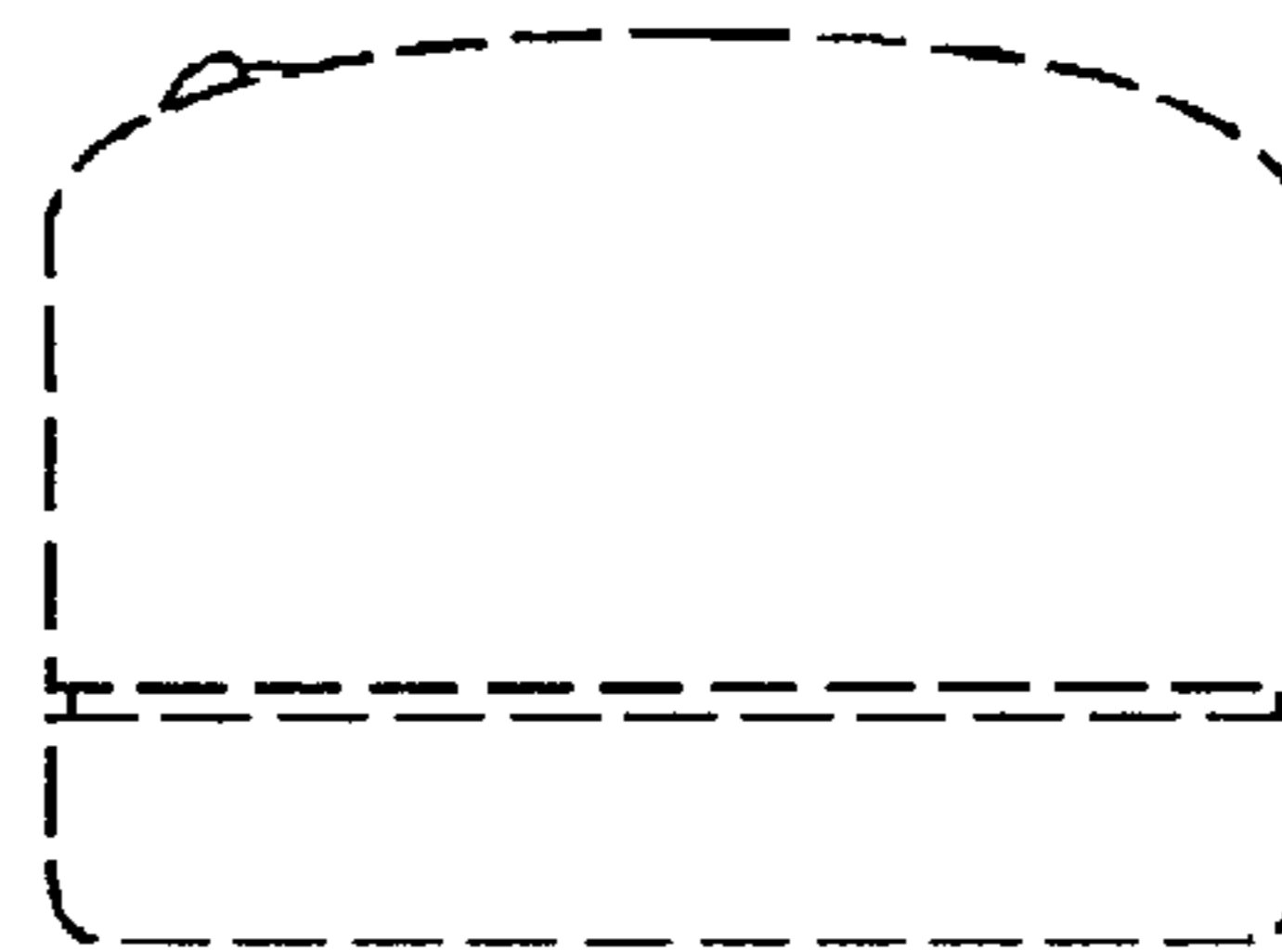

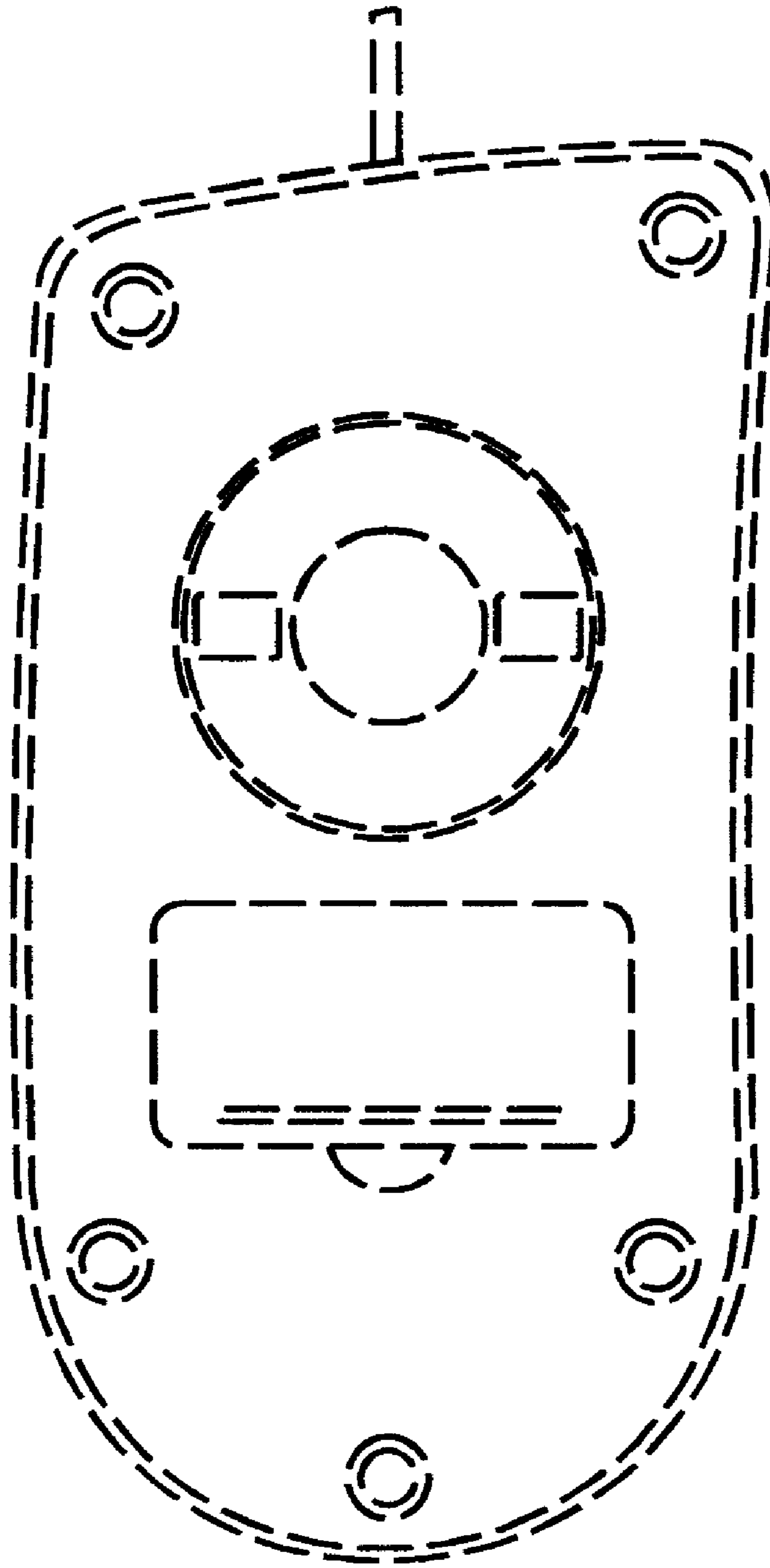

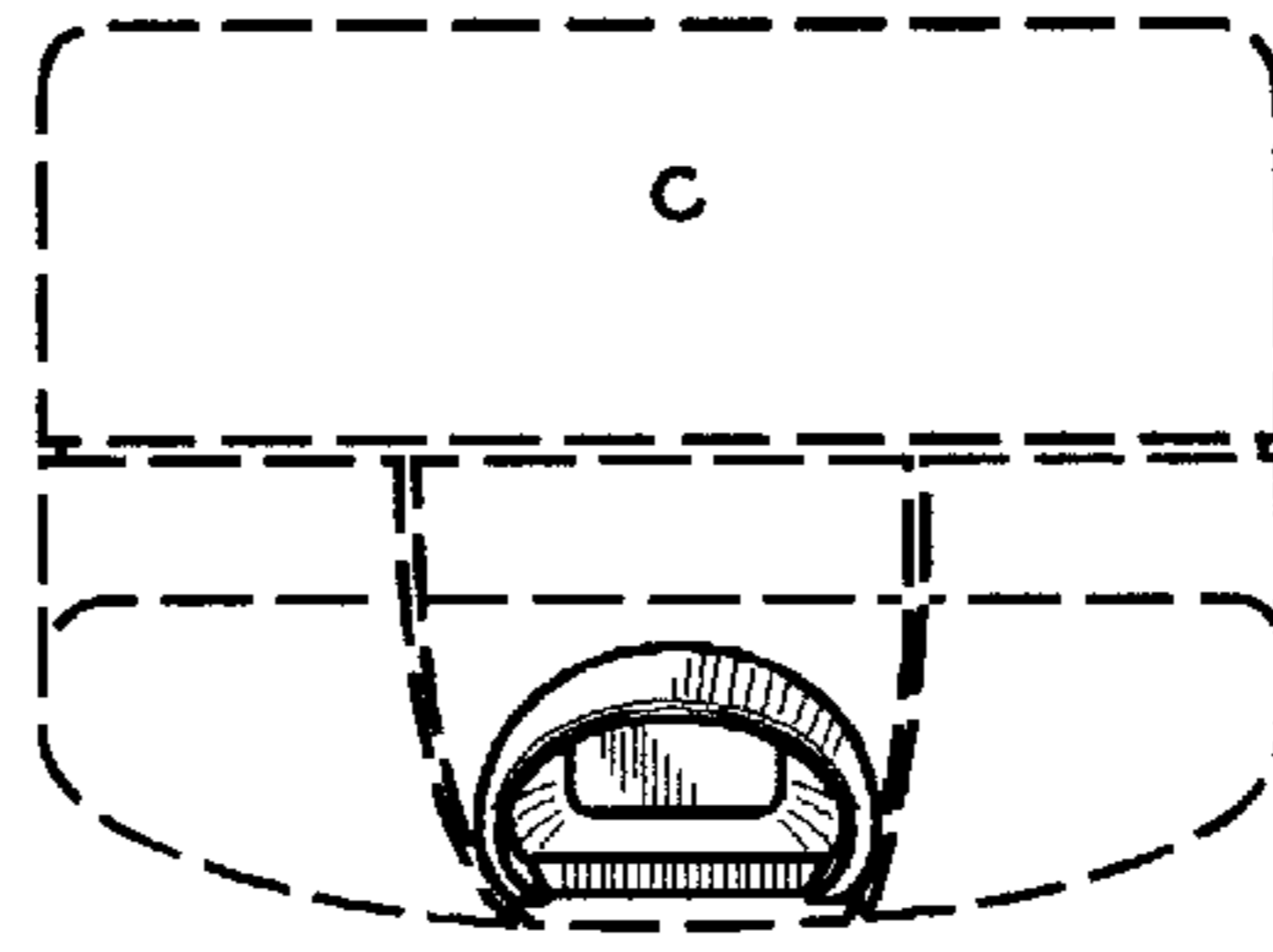

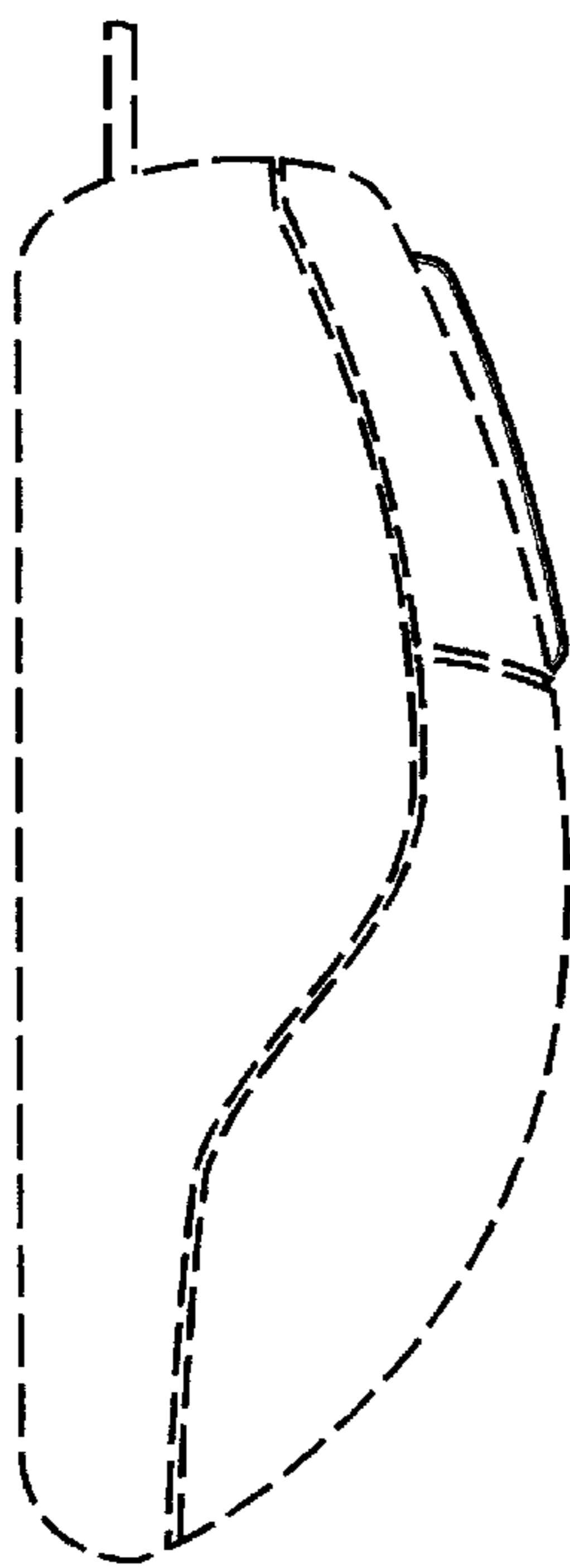

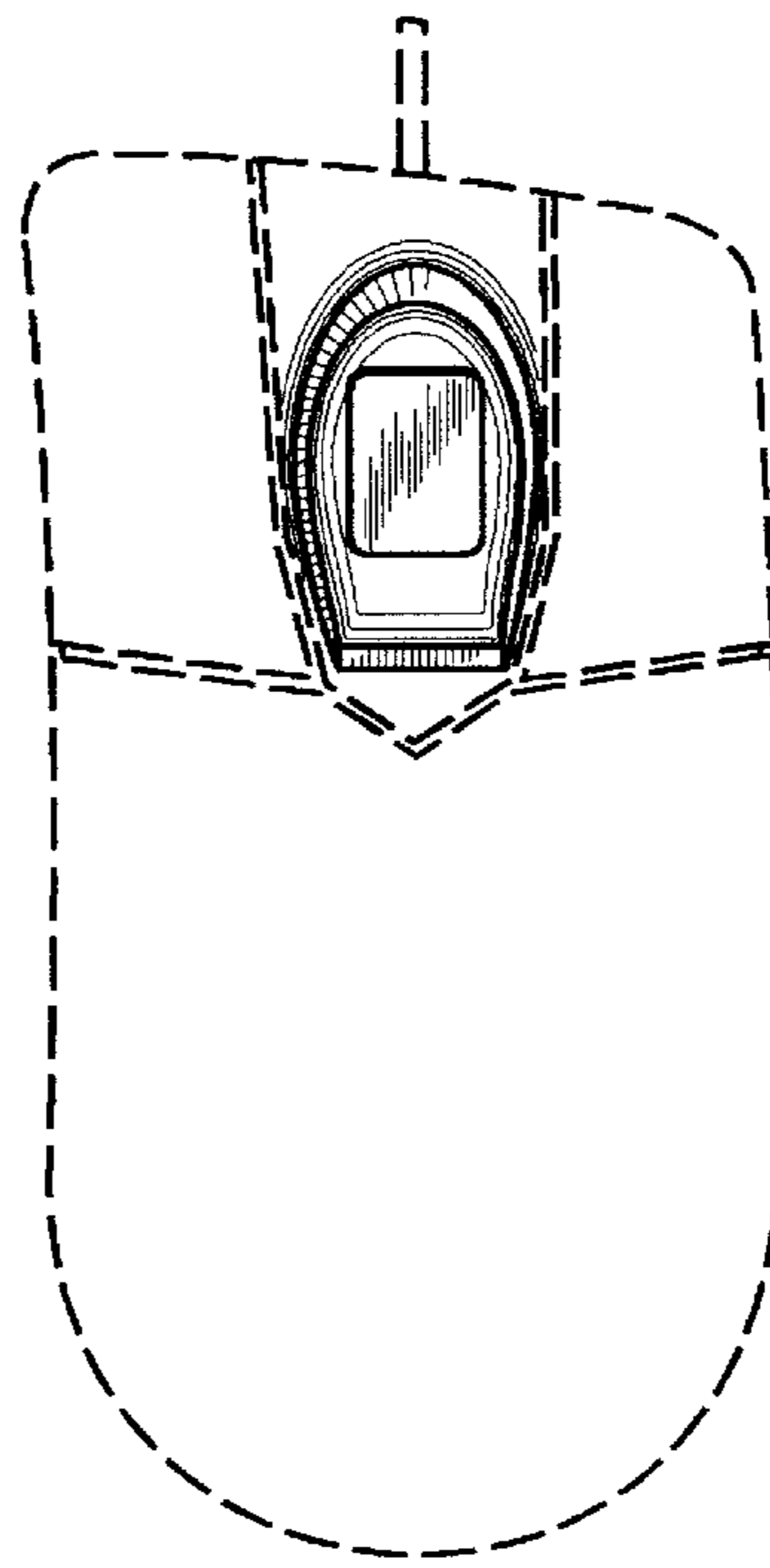

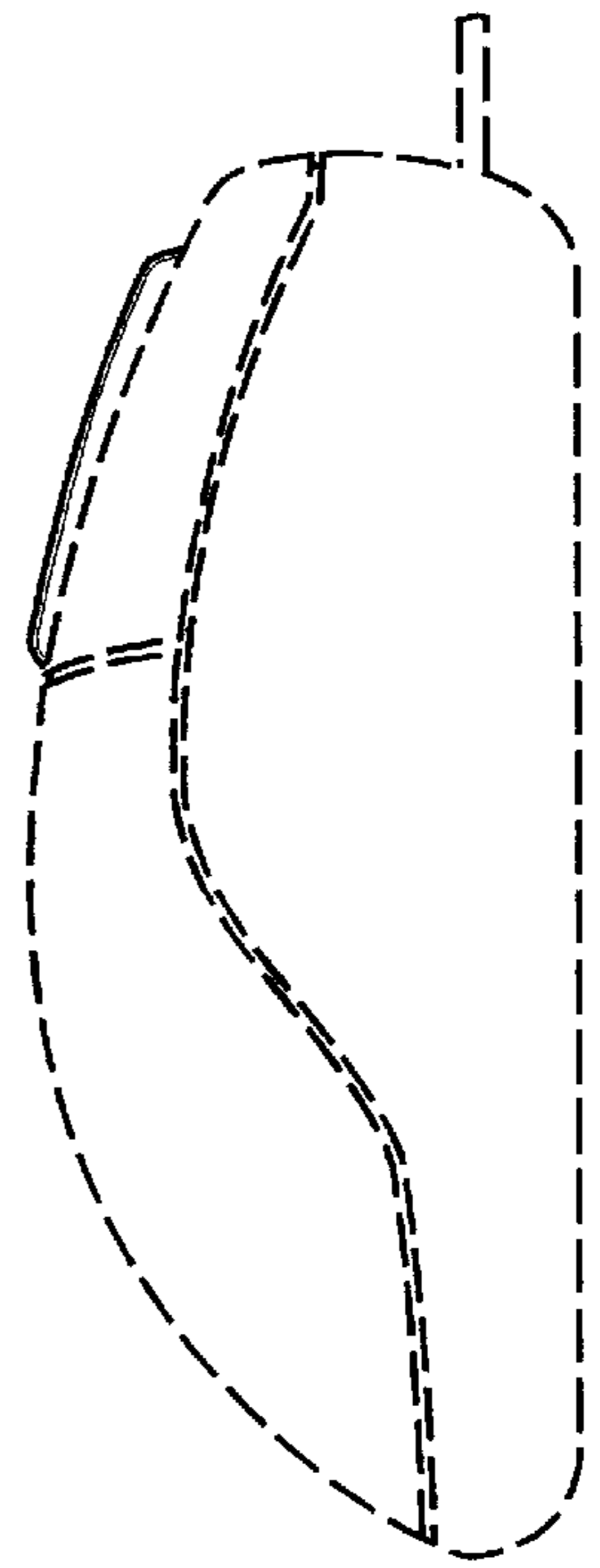

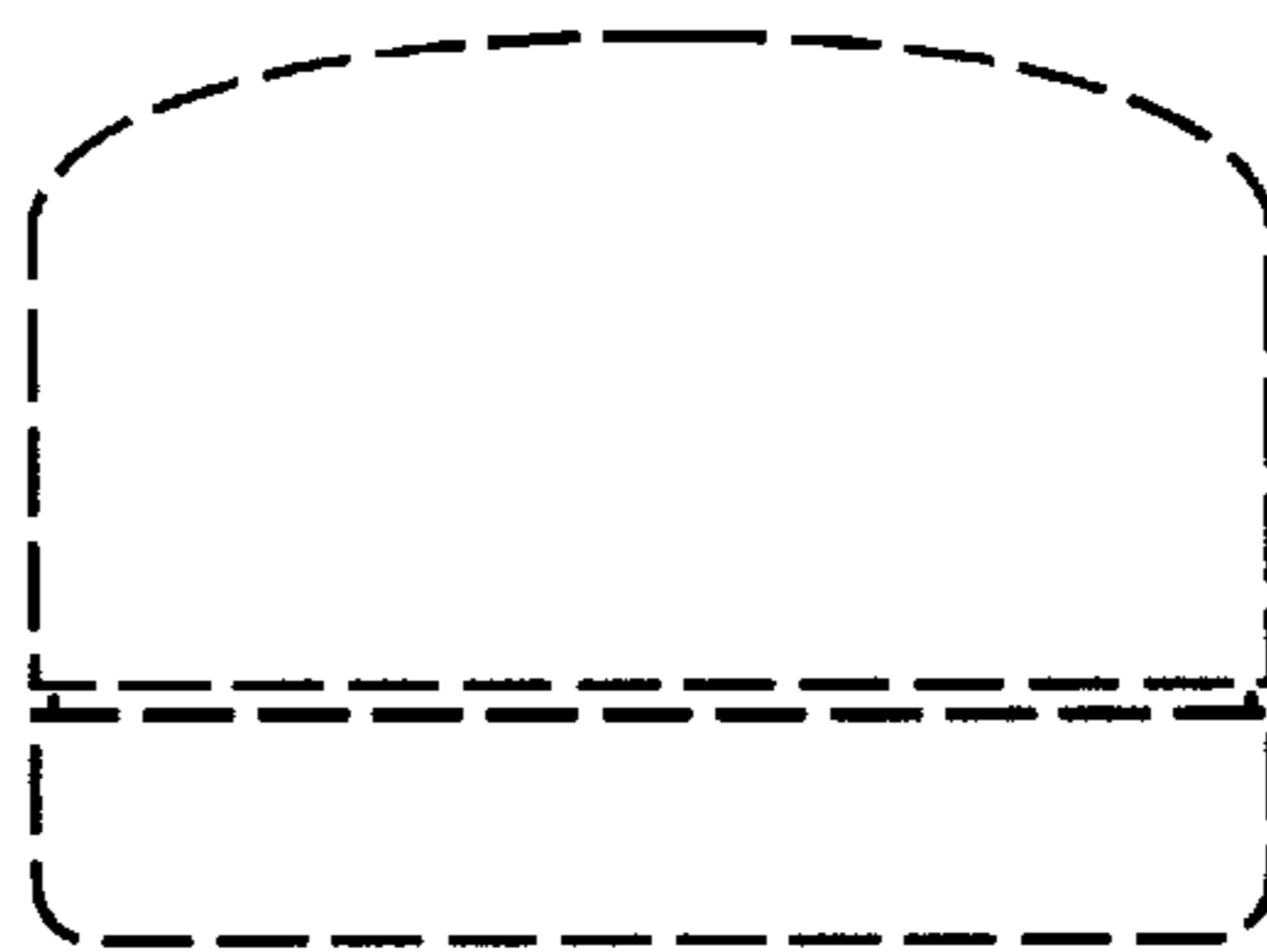

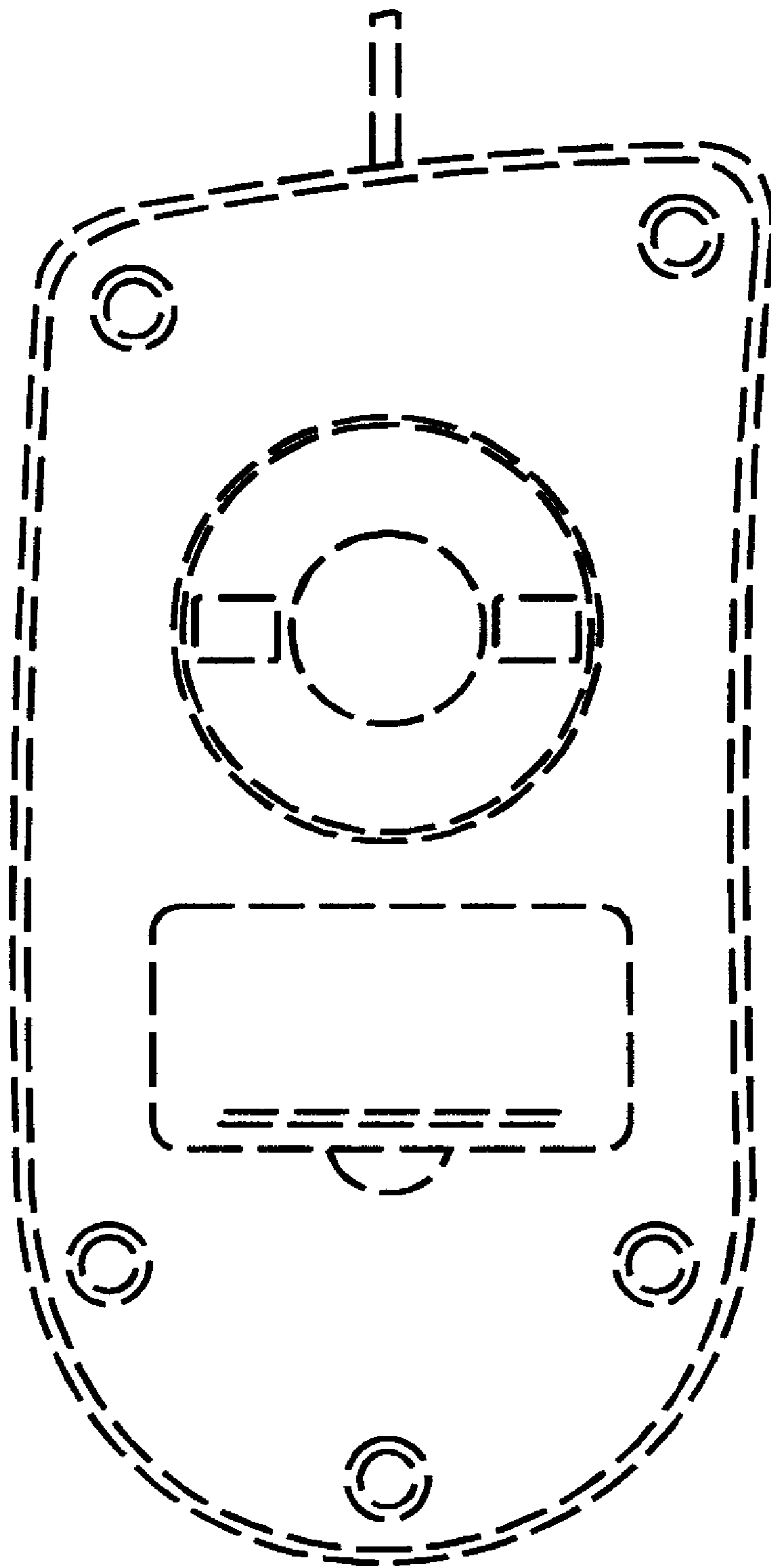

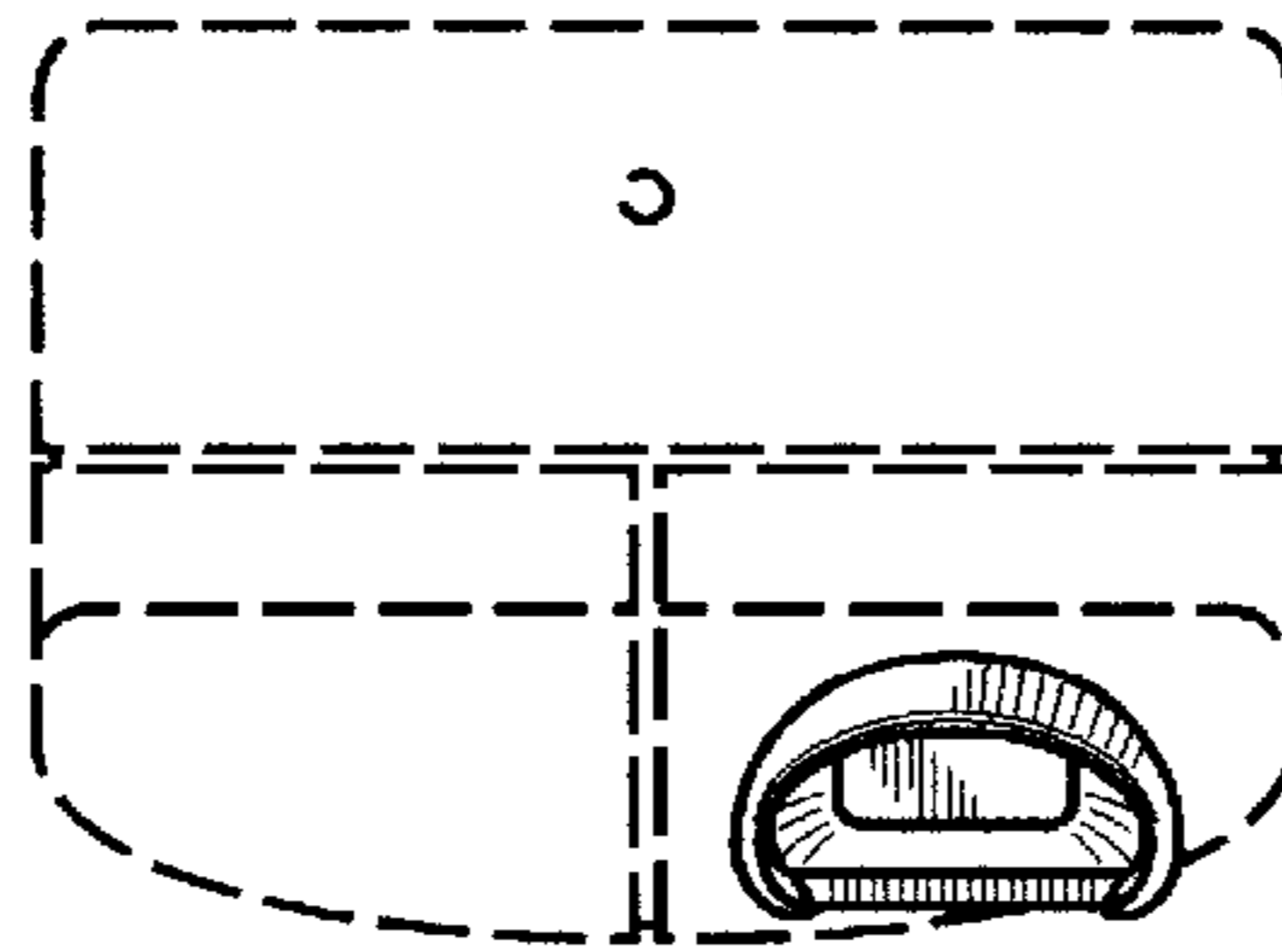

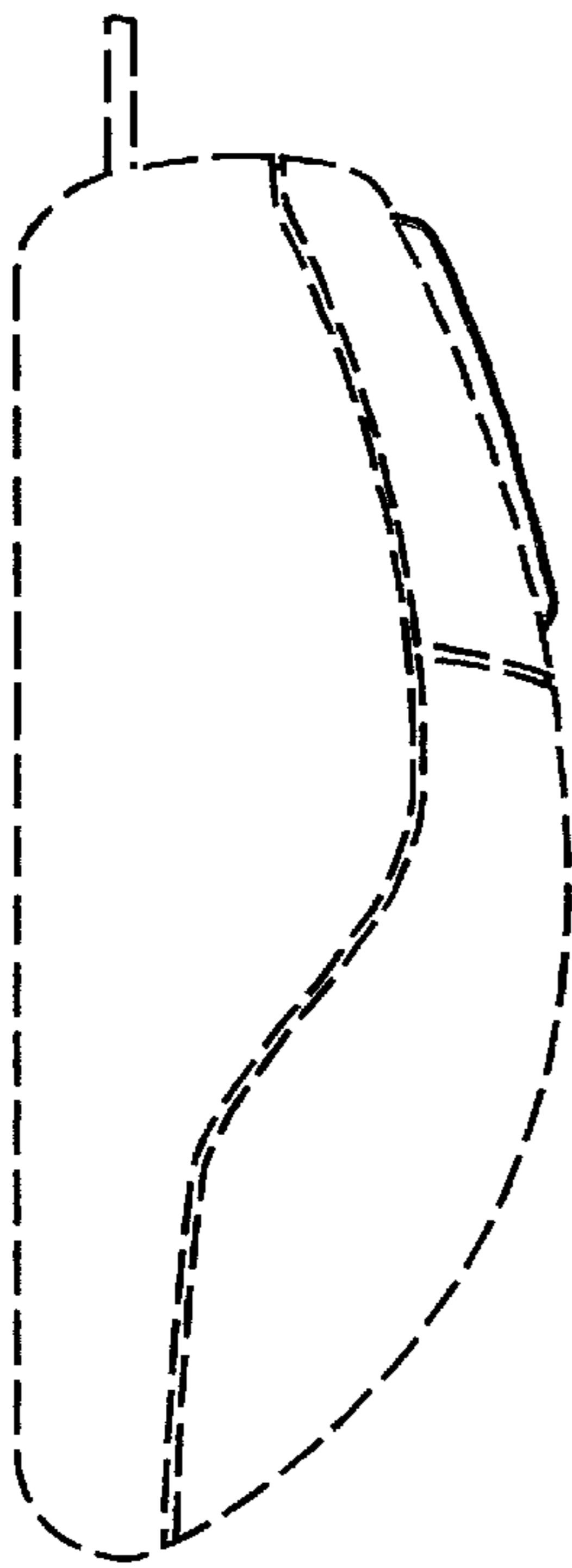

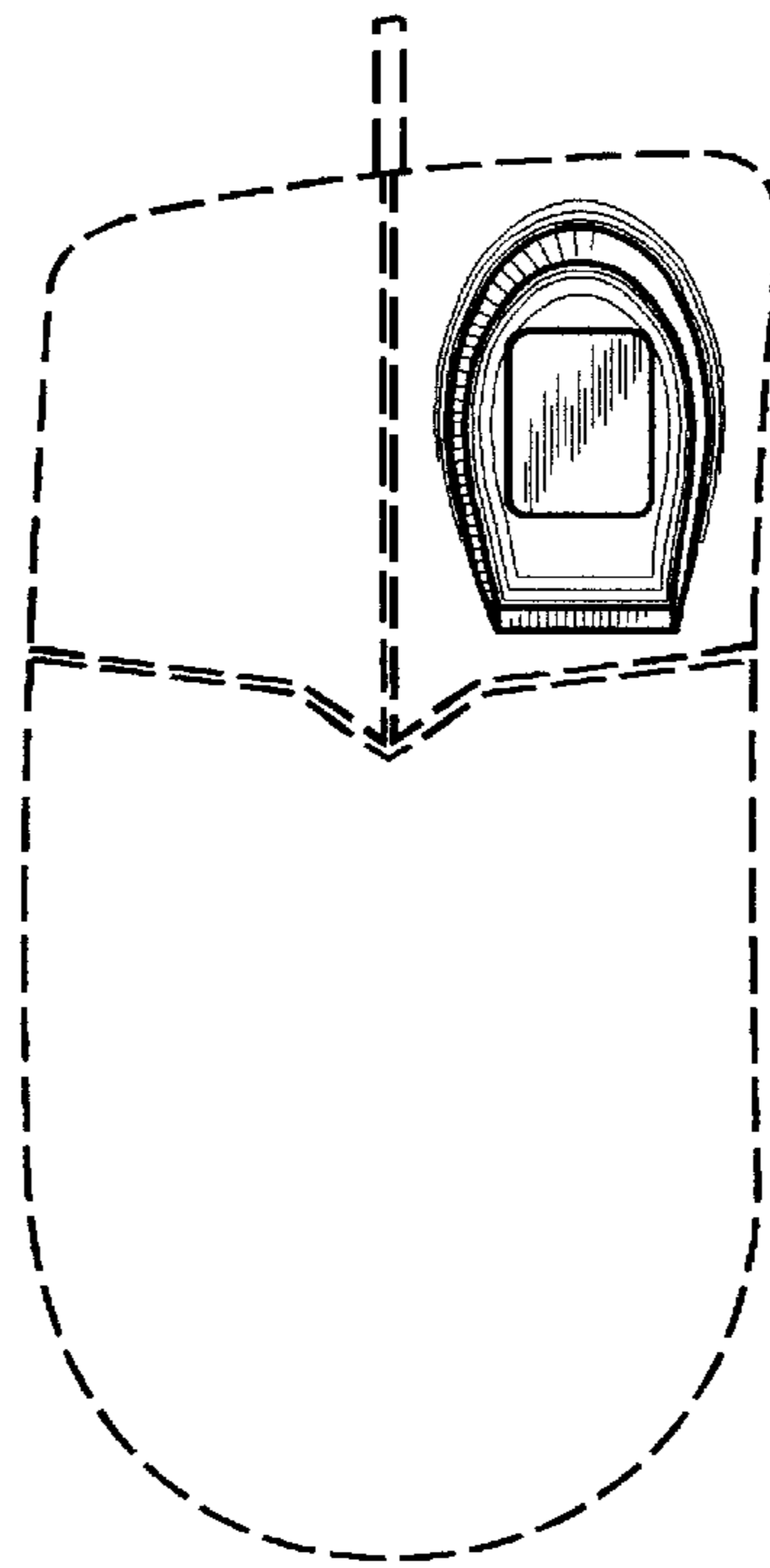

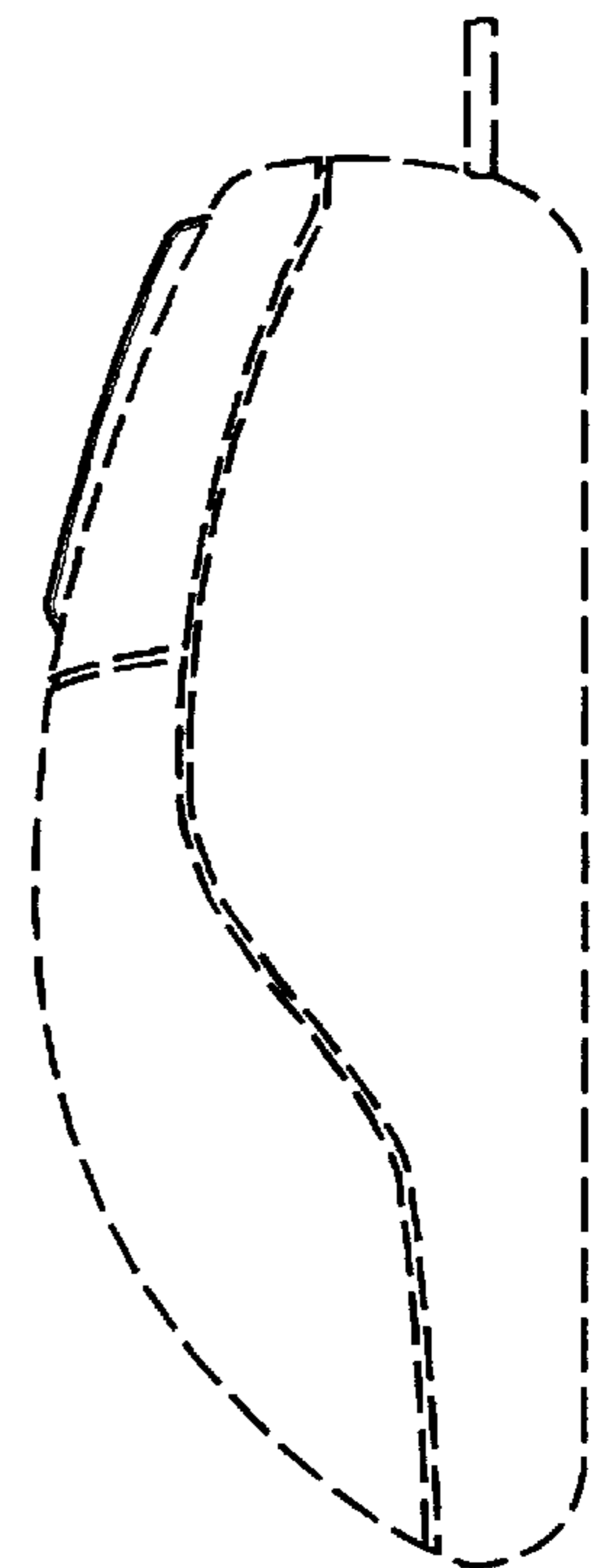

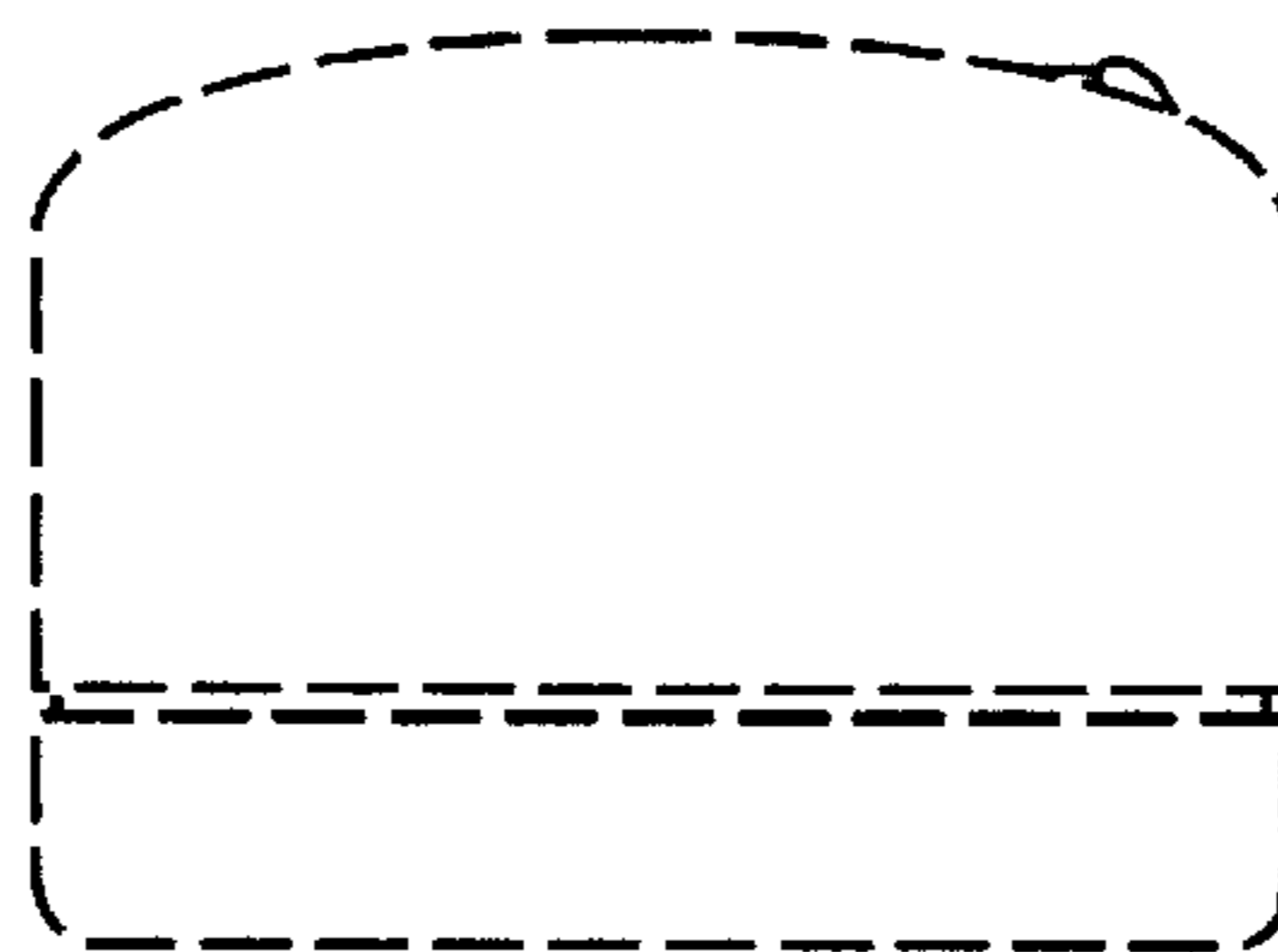

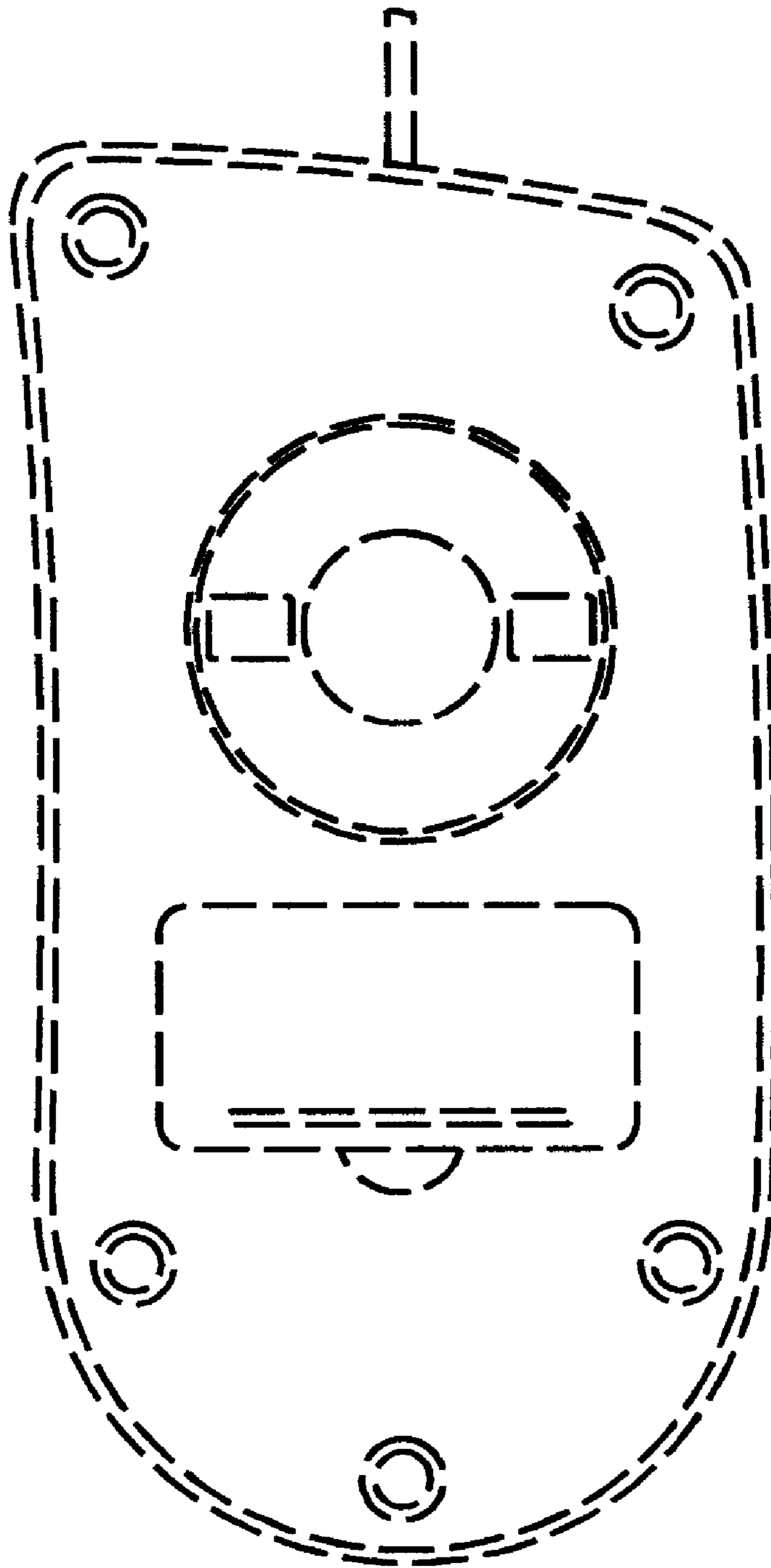
