What is claimed is the ornamental design for a display panel
with a computer icon, as shown and described.

DESCRIPTION

FIG. 1 is a perspective-front view of a display panel with a
computer icon;

FIG. 6 is a front view of a fifth embodiment thereof;

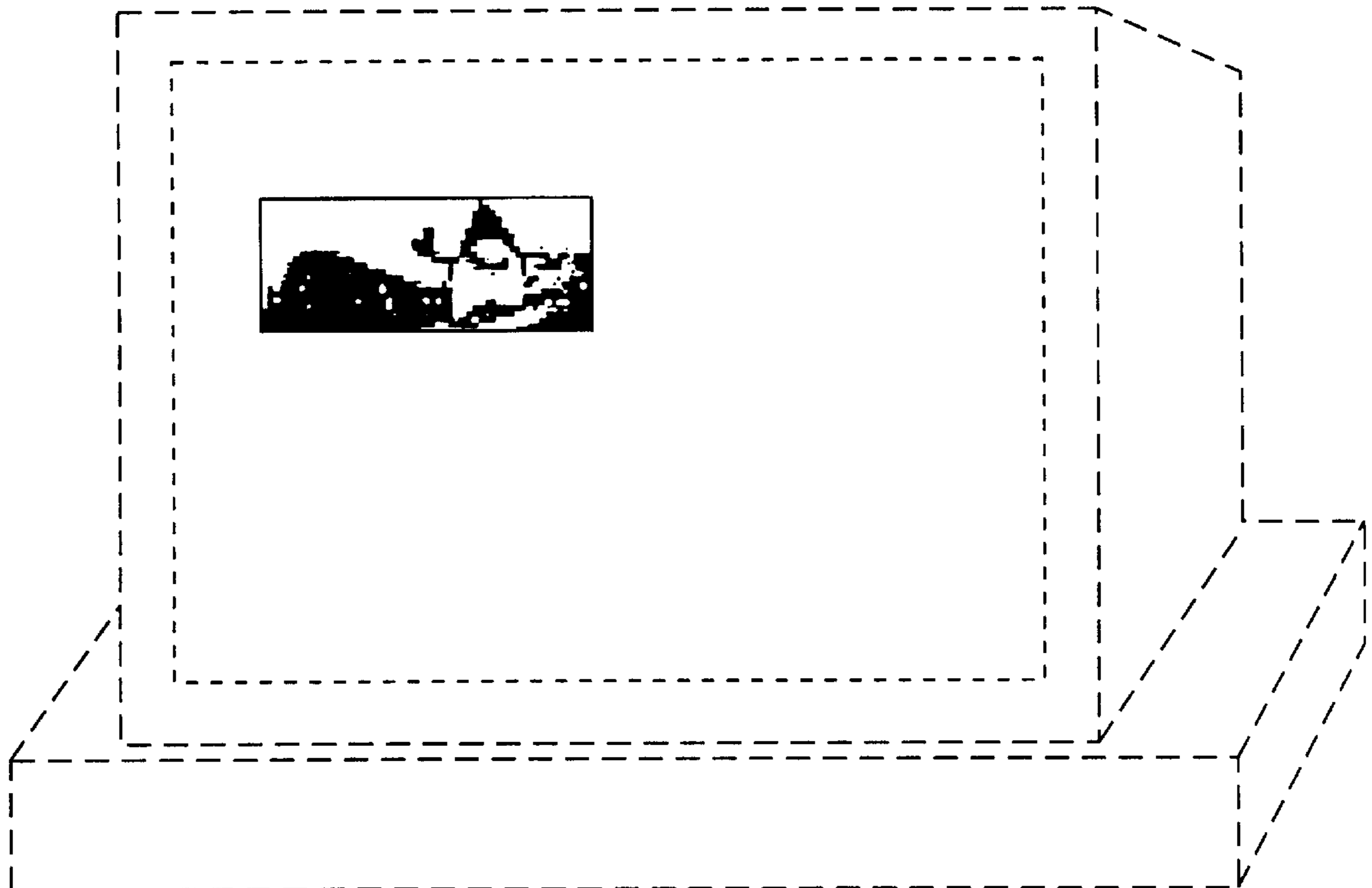
FIG. 7 is a front view of a sixth embodiment thereof; and,

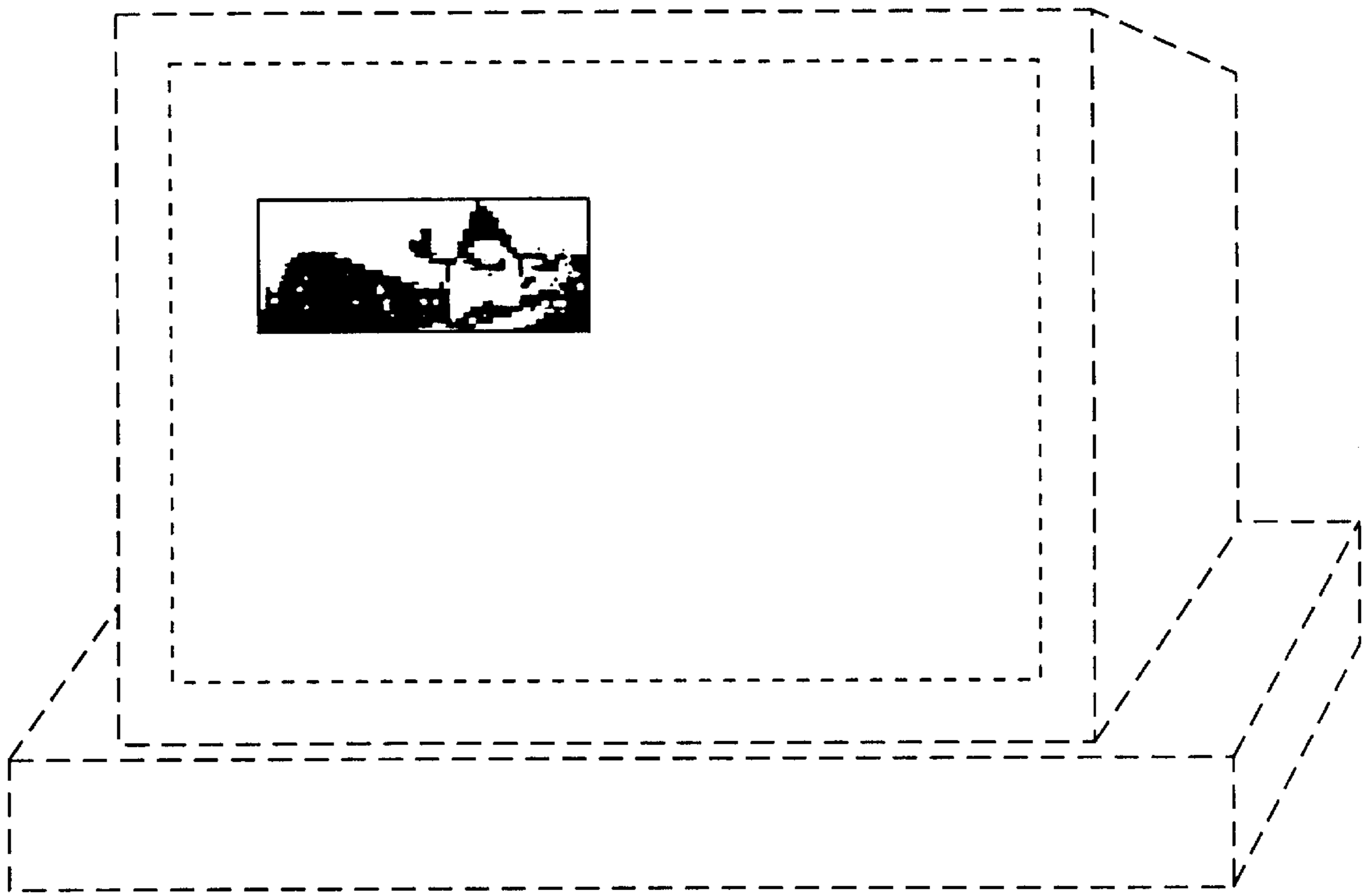

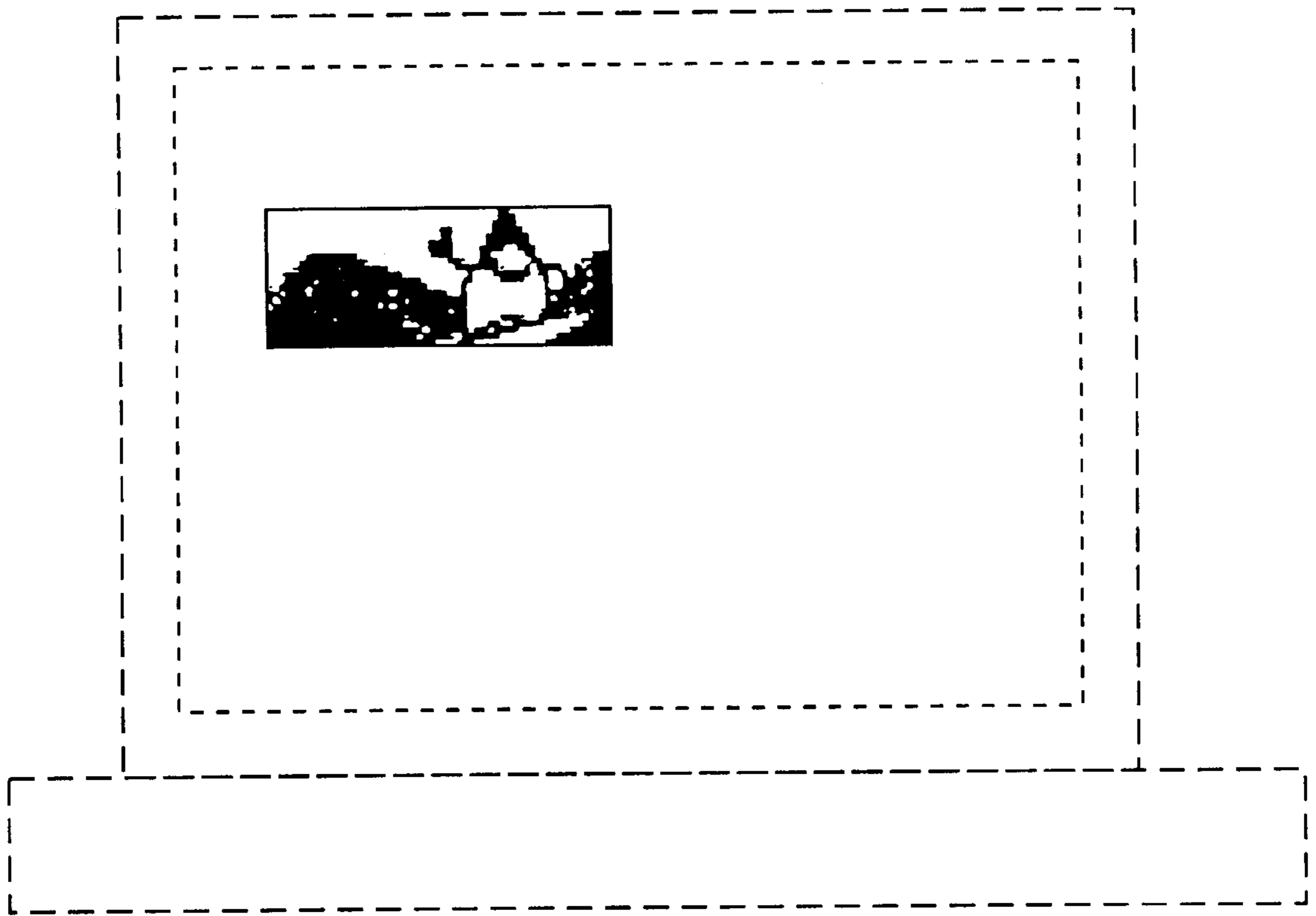

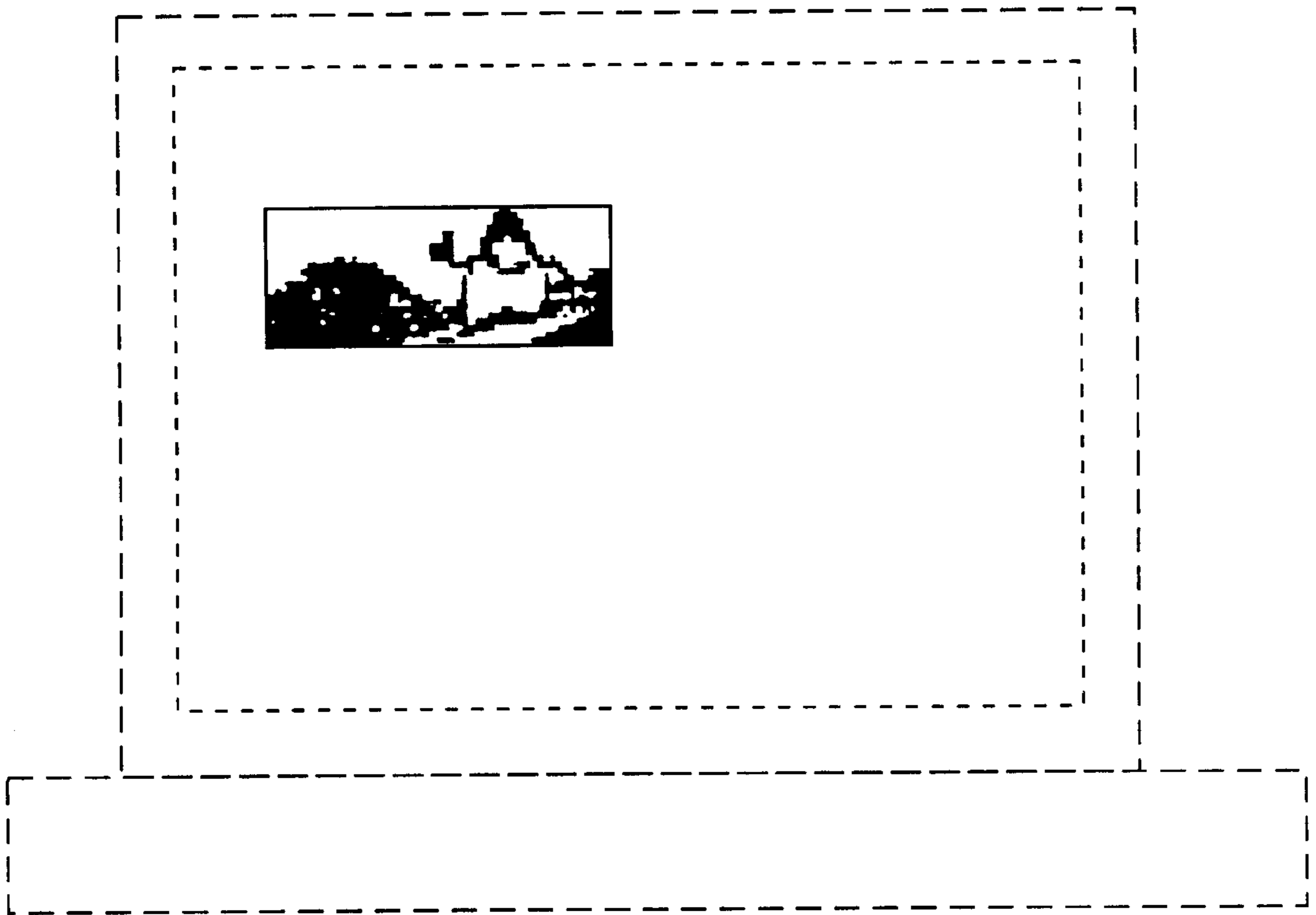

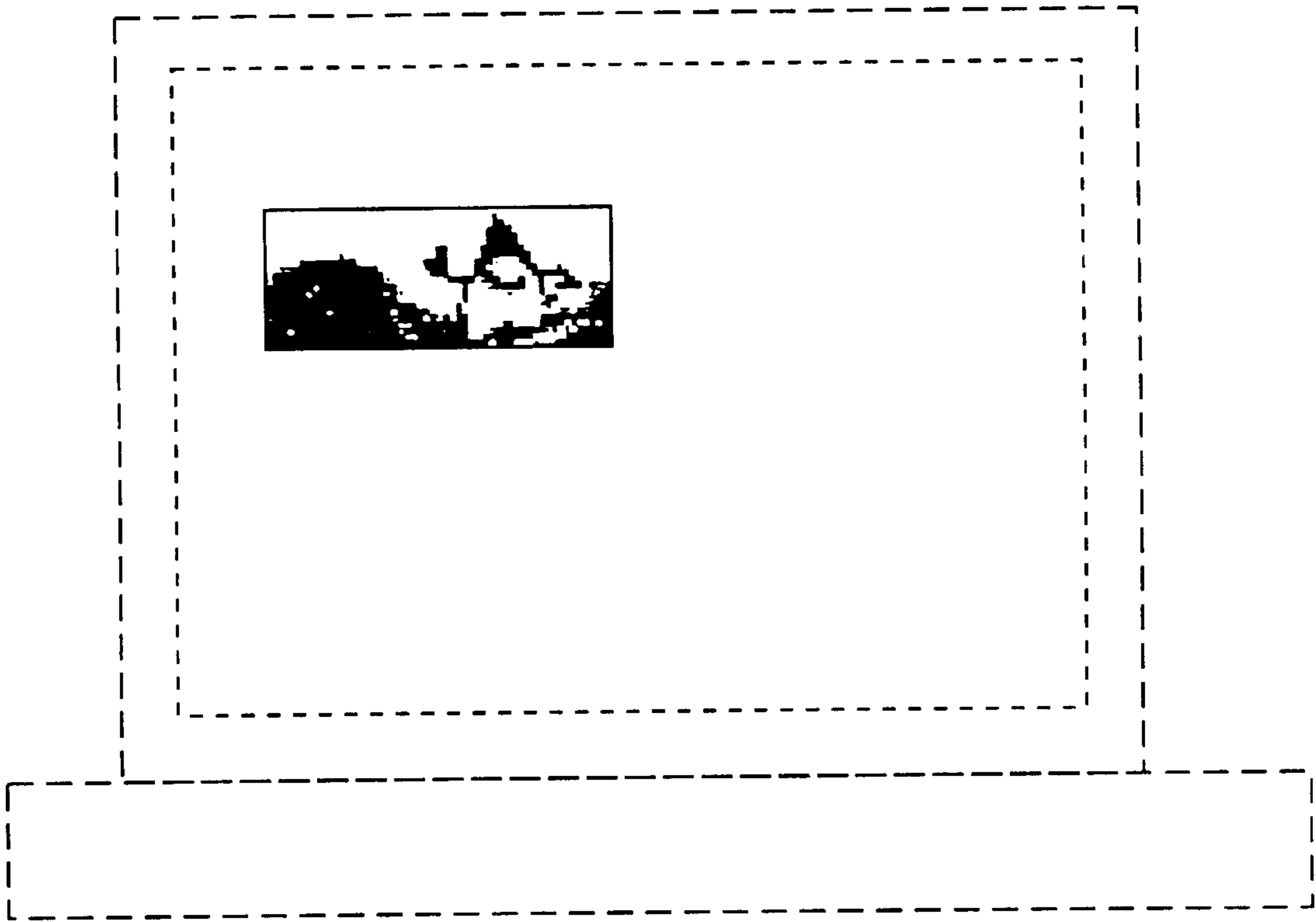

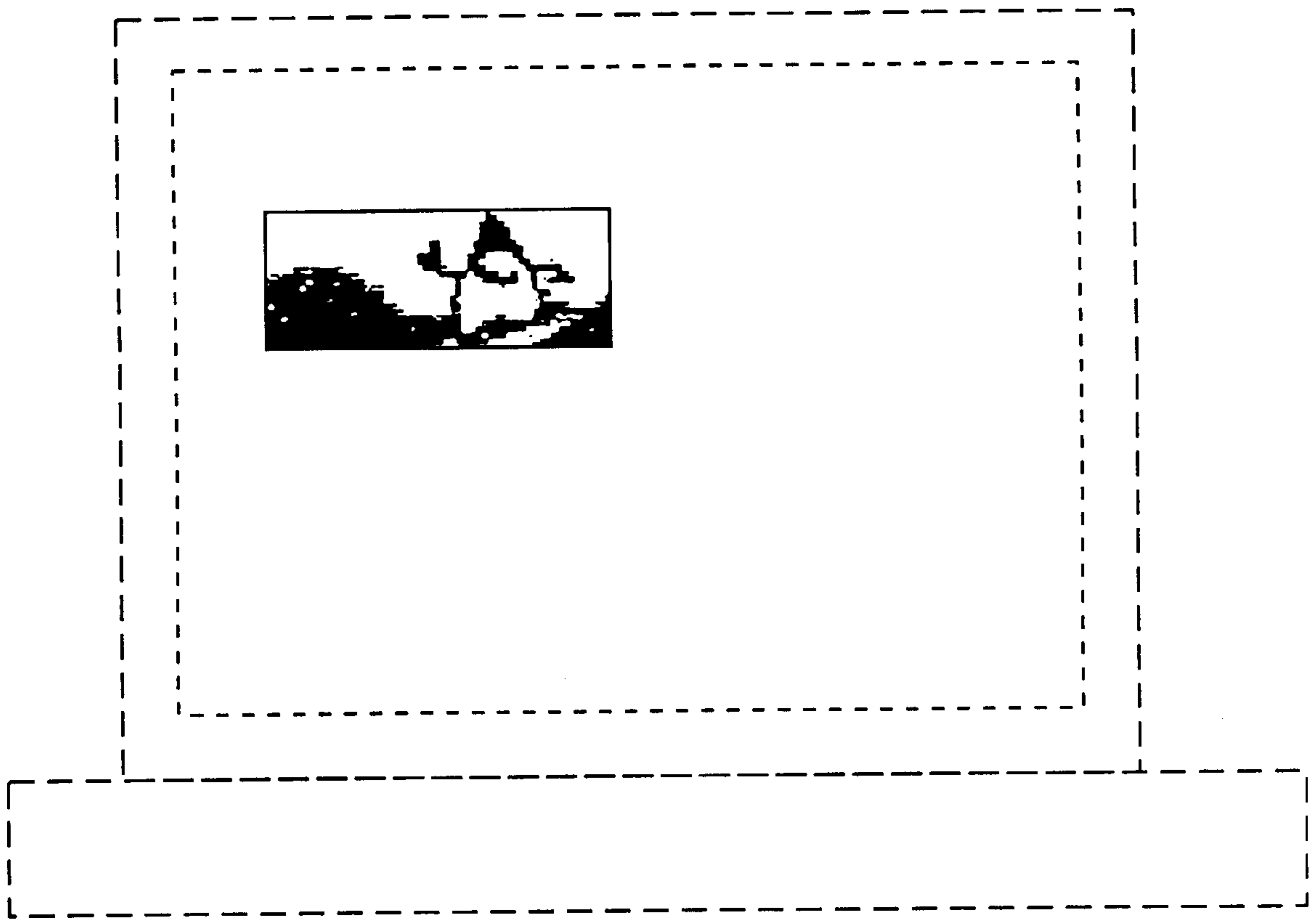

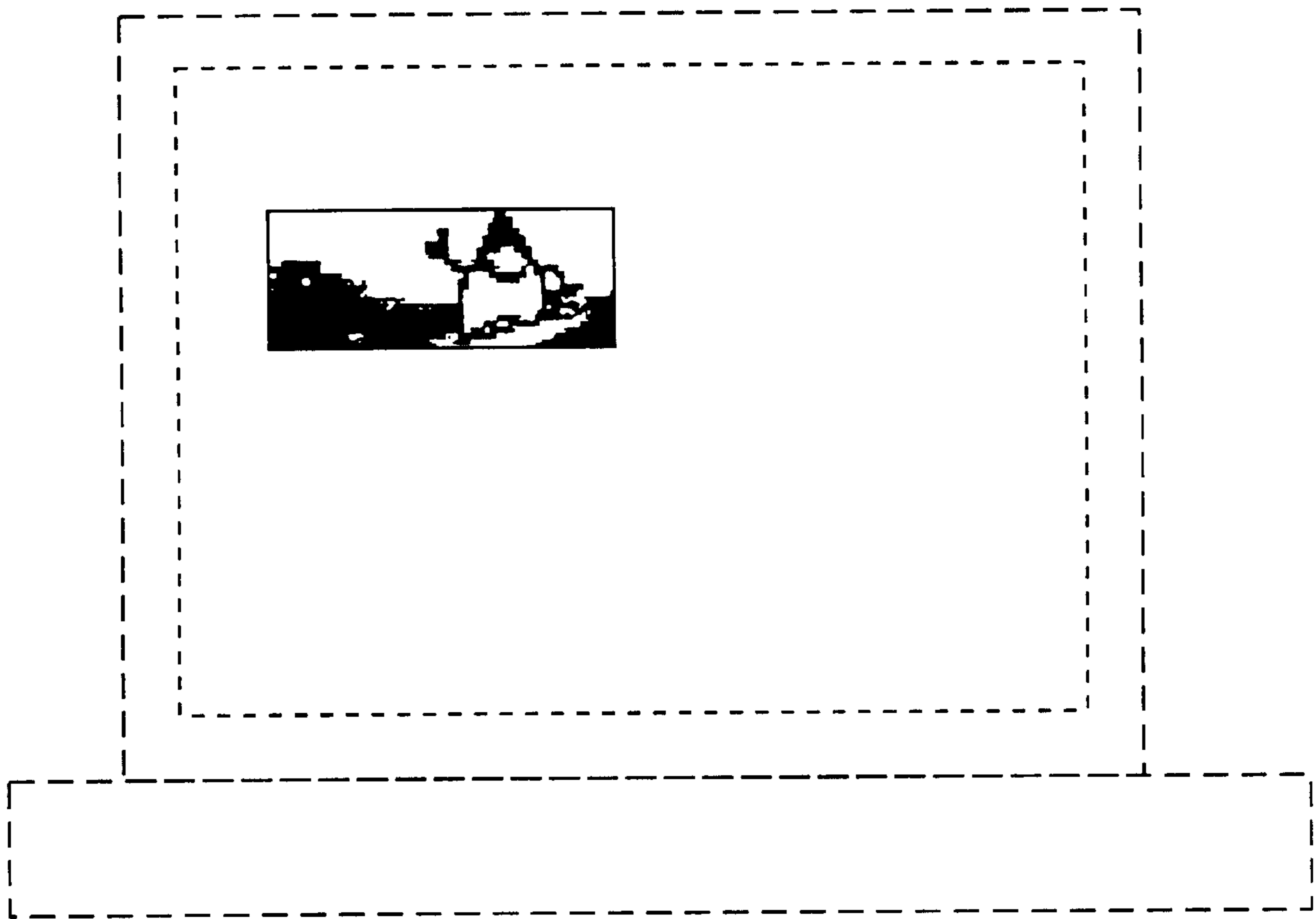

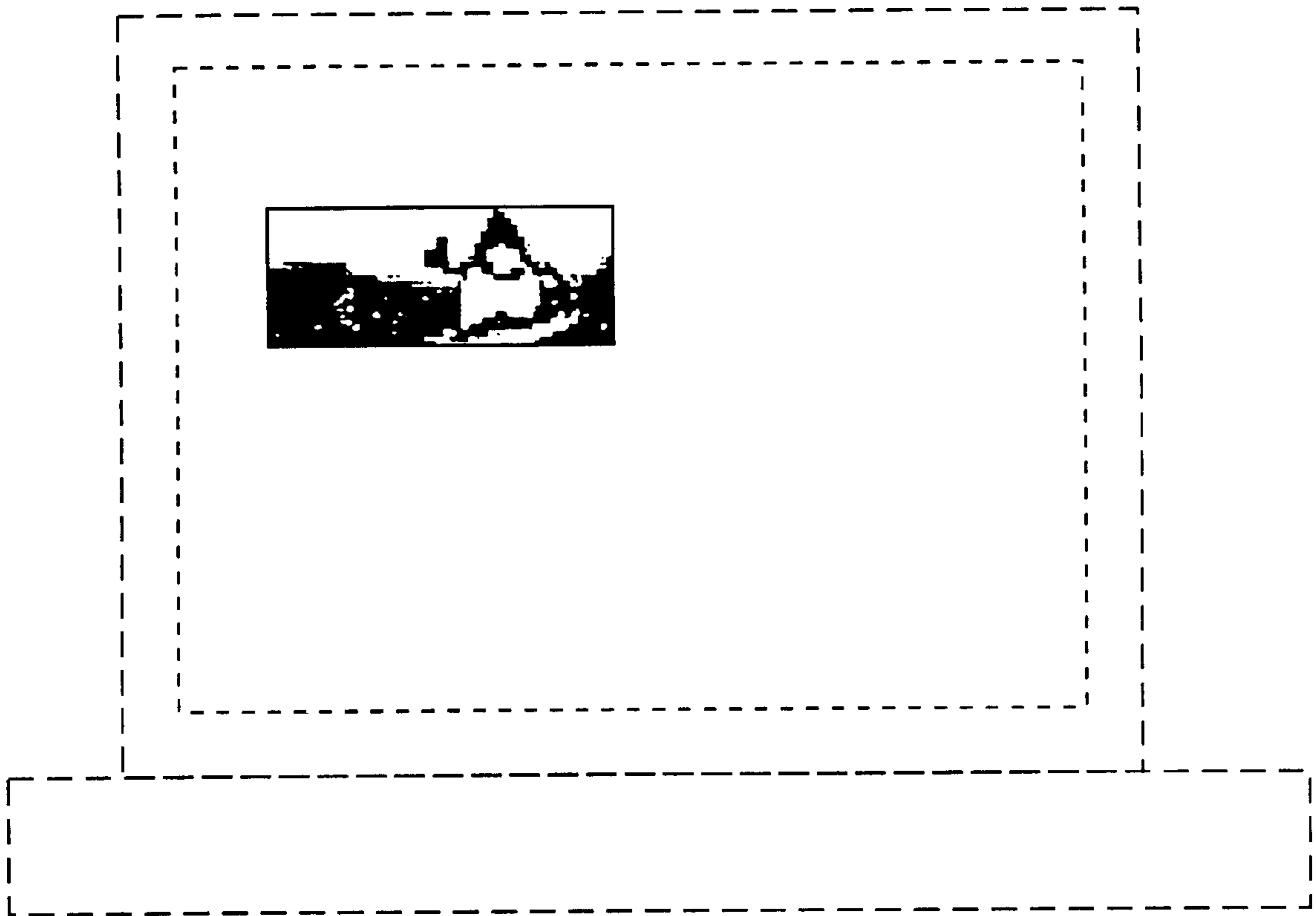

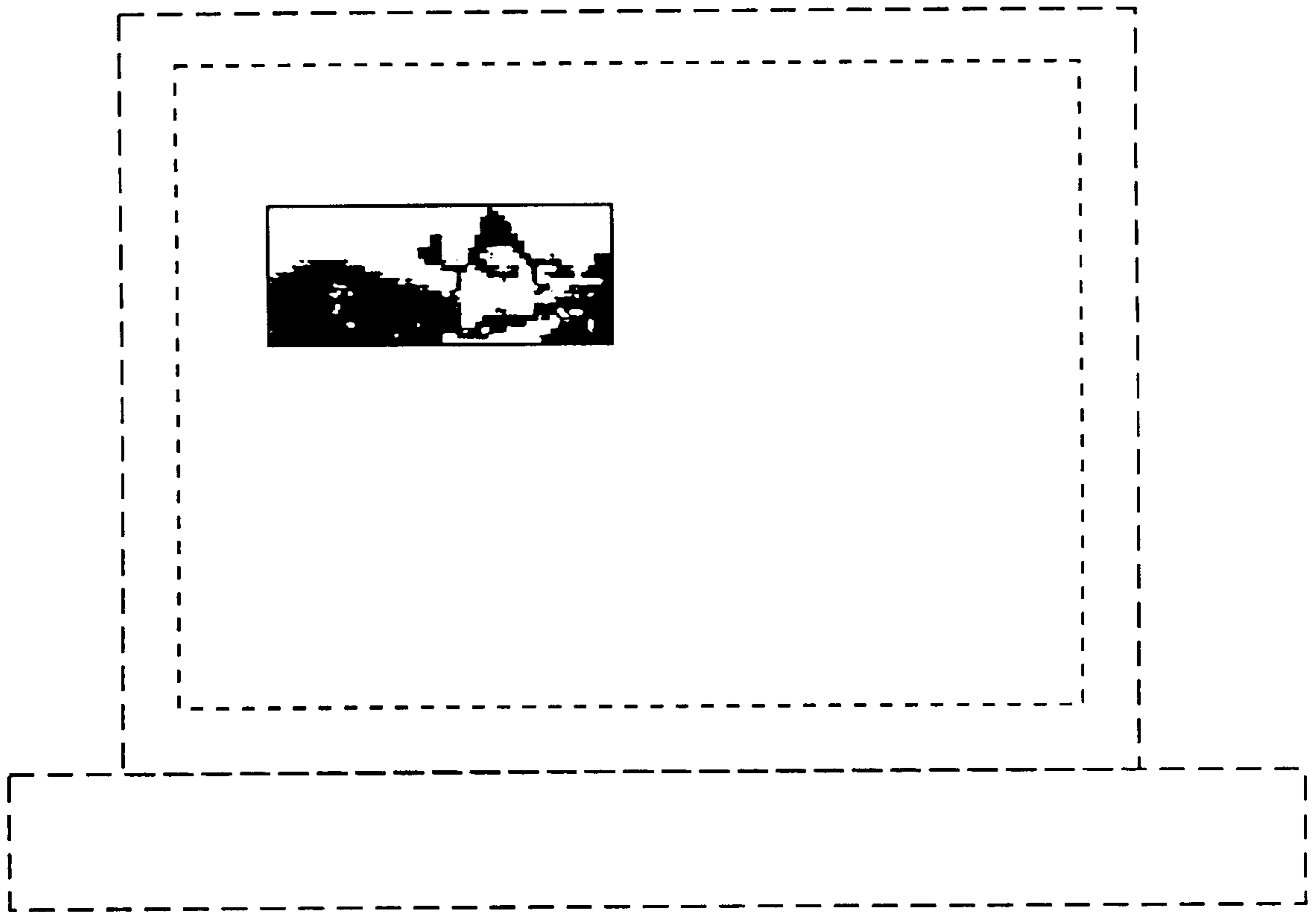
