FIG. 1 is a top, left and front perspective view of a vertically-oriented digital camera body with top-centered shutter button, the broken lines are shown to illustrate environment only and form no part of the claimed design; FIG. 2 is a top, right, and front perspective view thereof; FIG. 3 is a front end view thereof; FIG. 4 is a rear end view thereof; FIG. 5 is a bottom, left, and front perspective view thereof; and, FIG. 6 is a top, left, and front perspective view showing a first modified form of our new design, the sole difference being minor lateral displacement of the shutter button to one side (or the other) of the camera body.

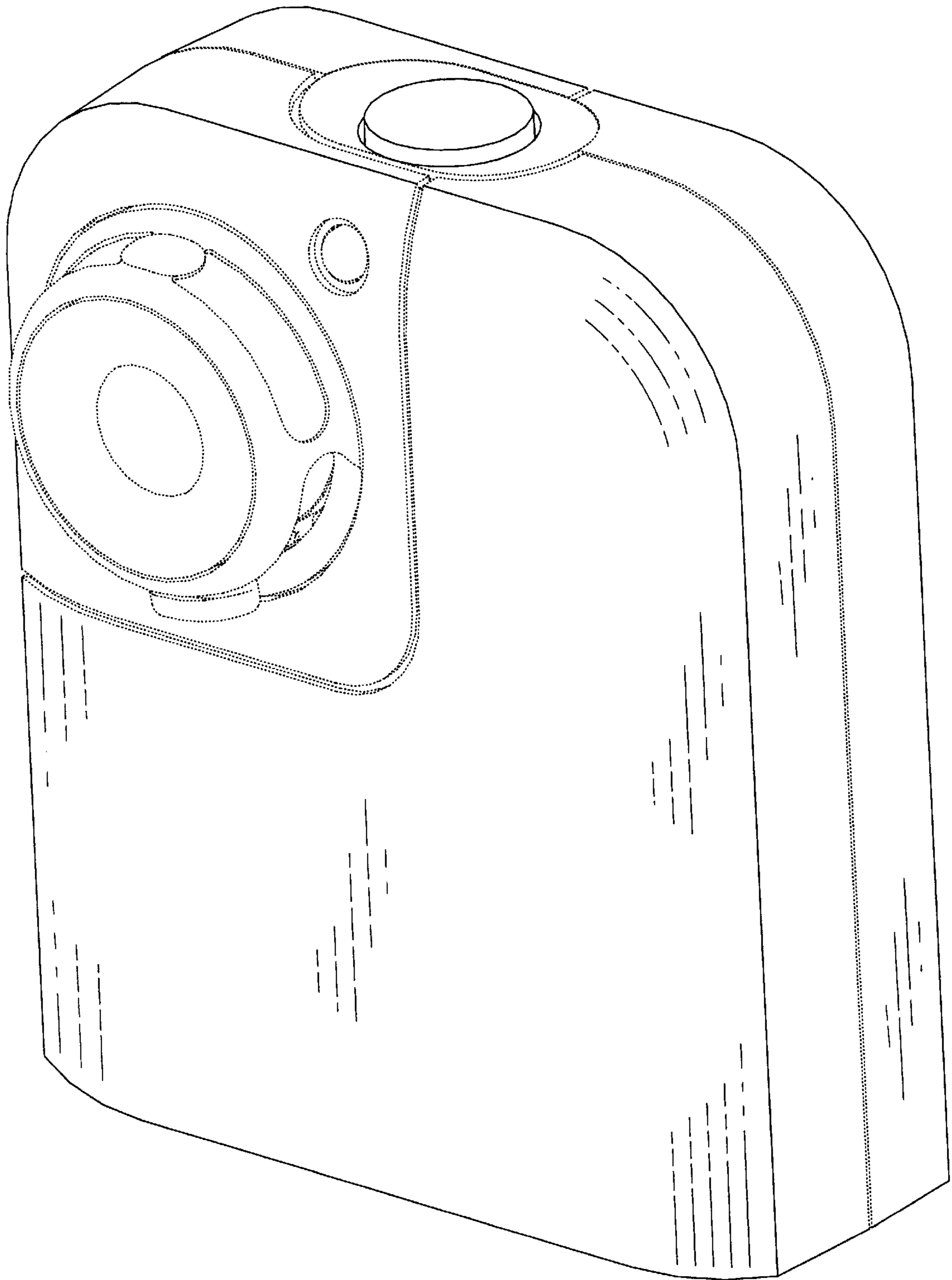

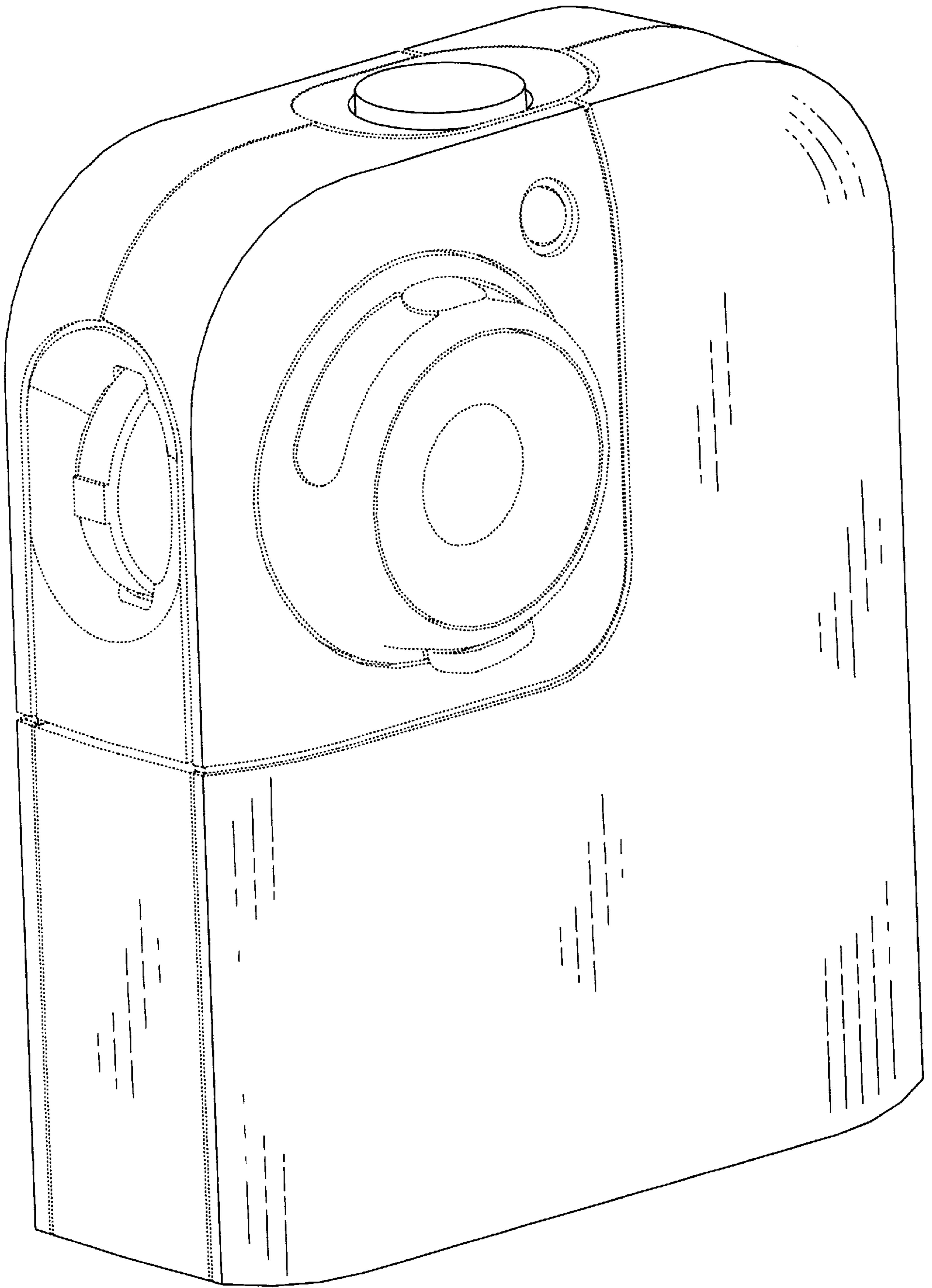

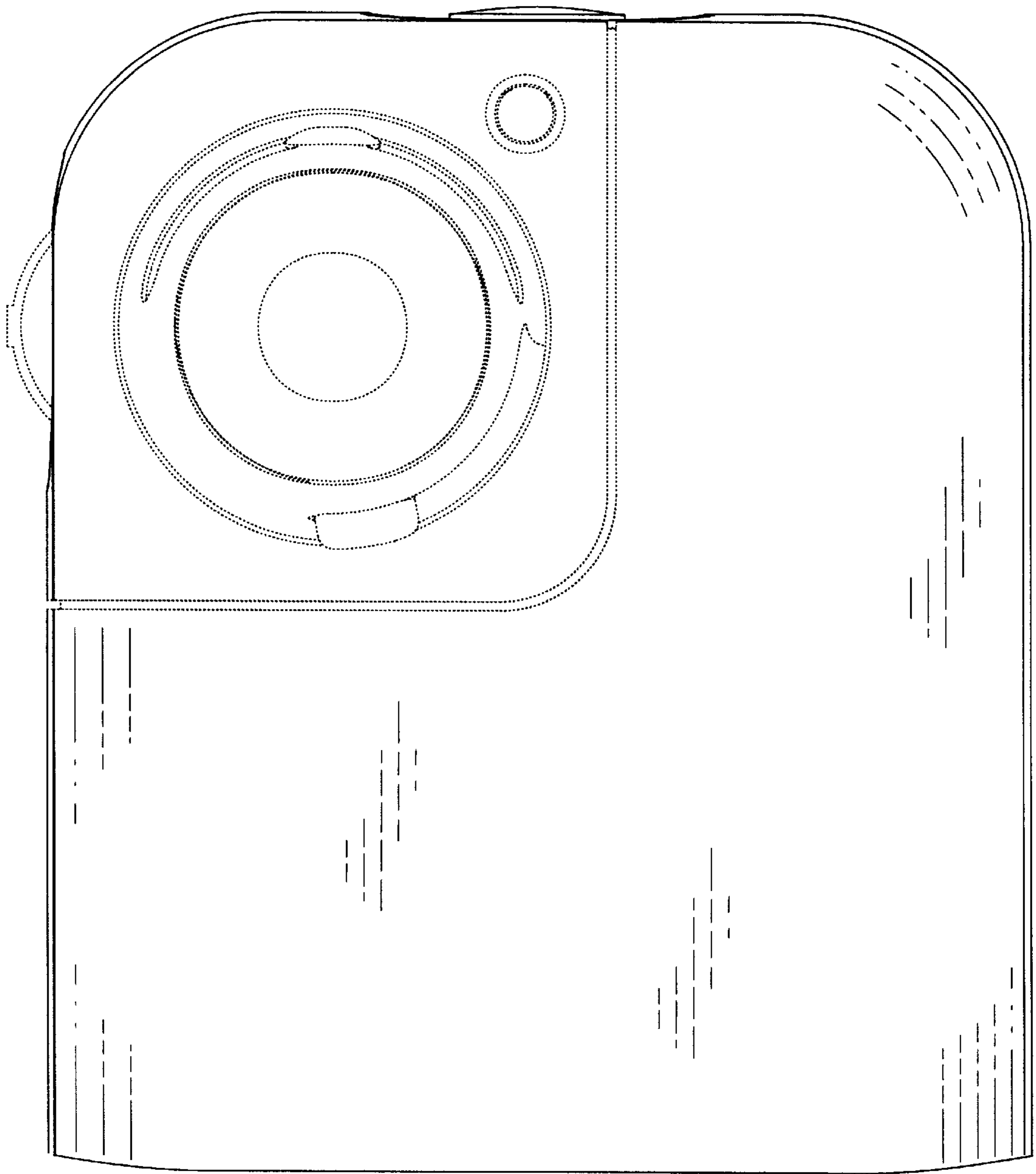

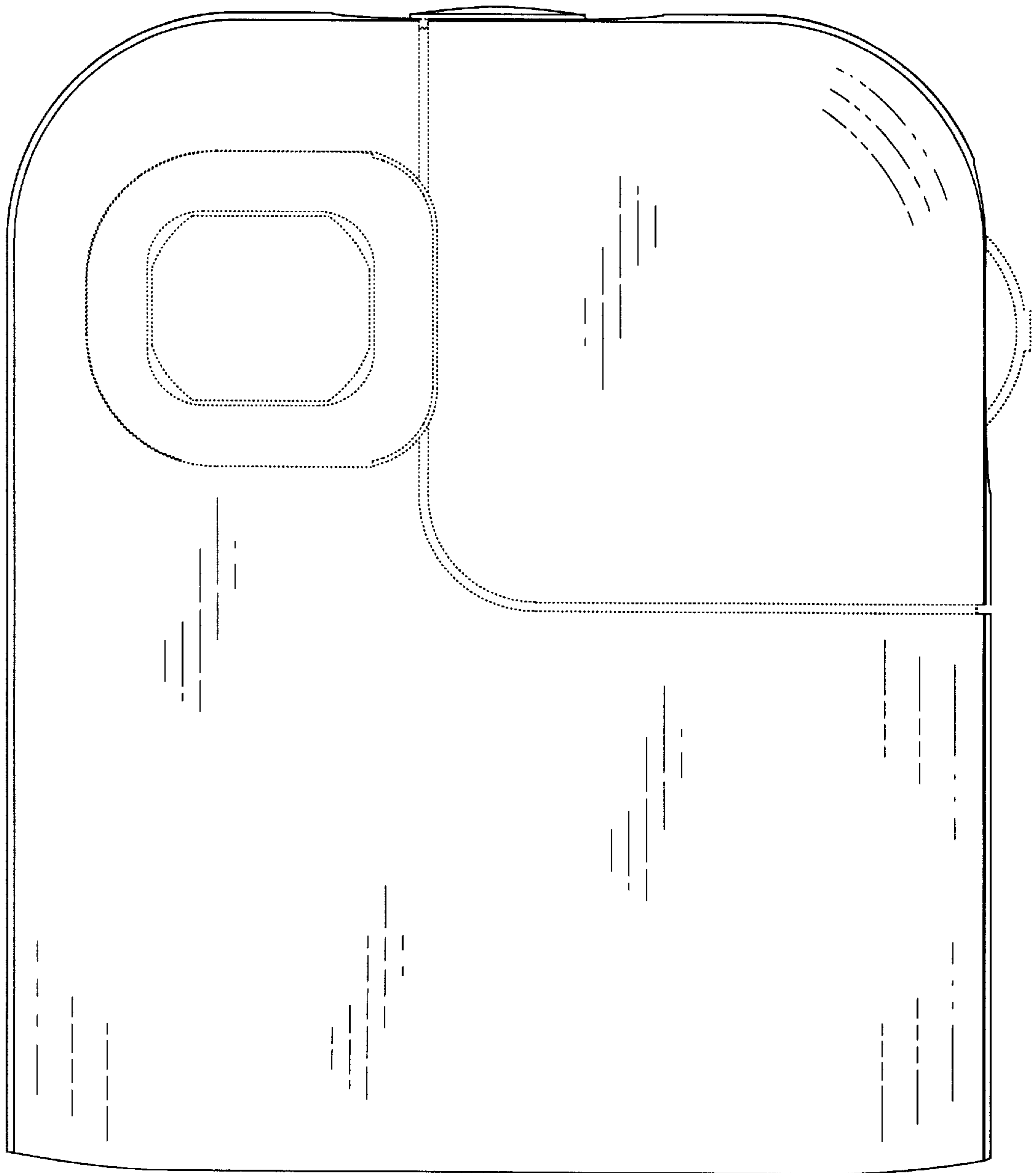

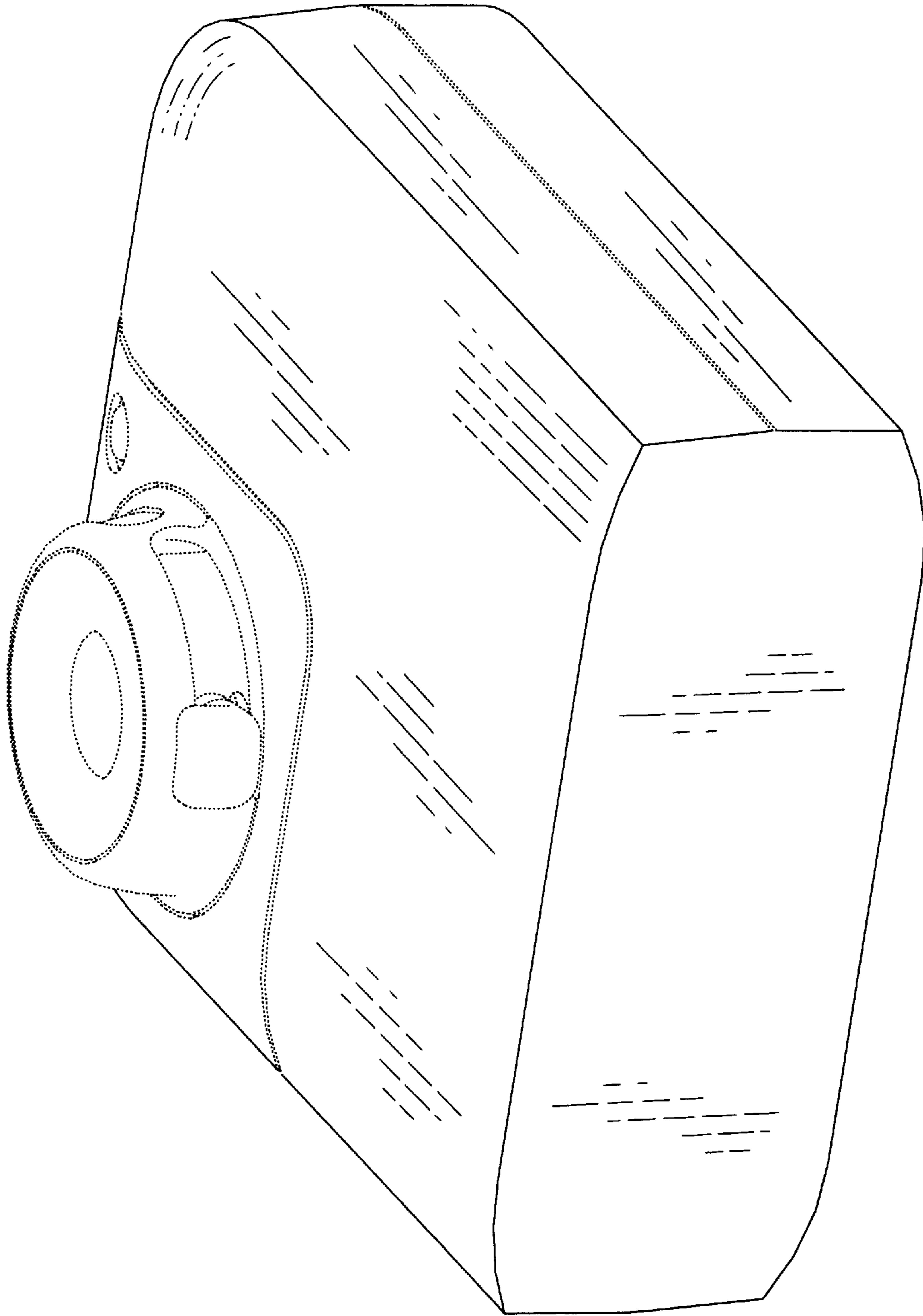

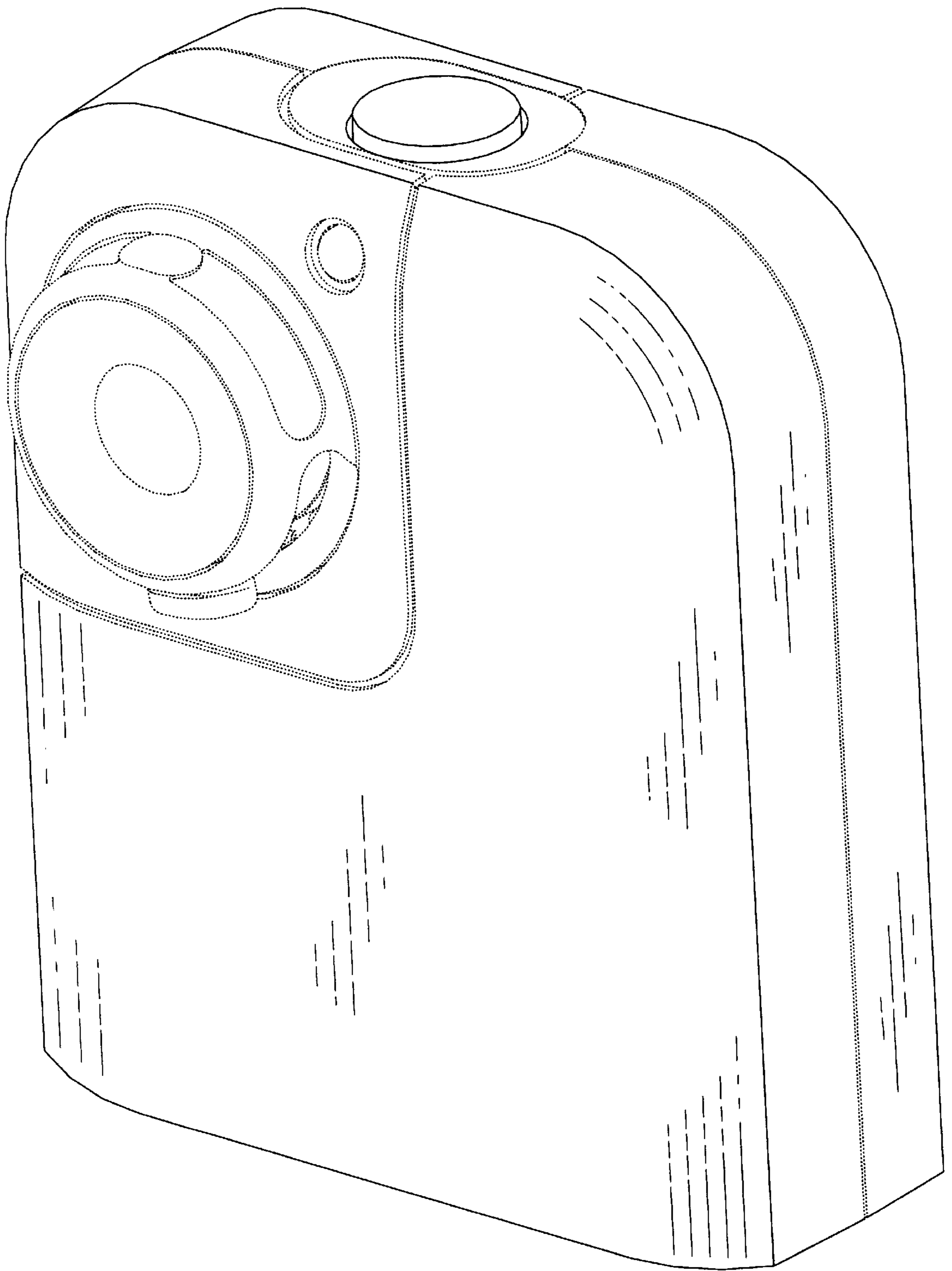
