DESCRIPTION

FIG. 1 is a top plan view with environment in dotted lines; FIG. 2 is a cross section taken along line 2—2 in FIG. 1 with environment in dotted lines;

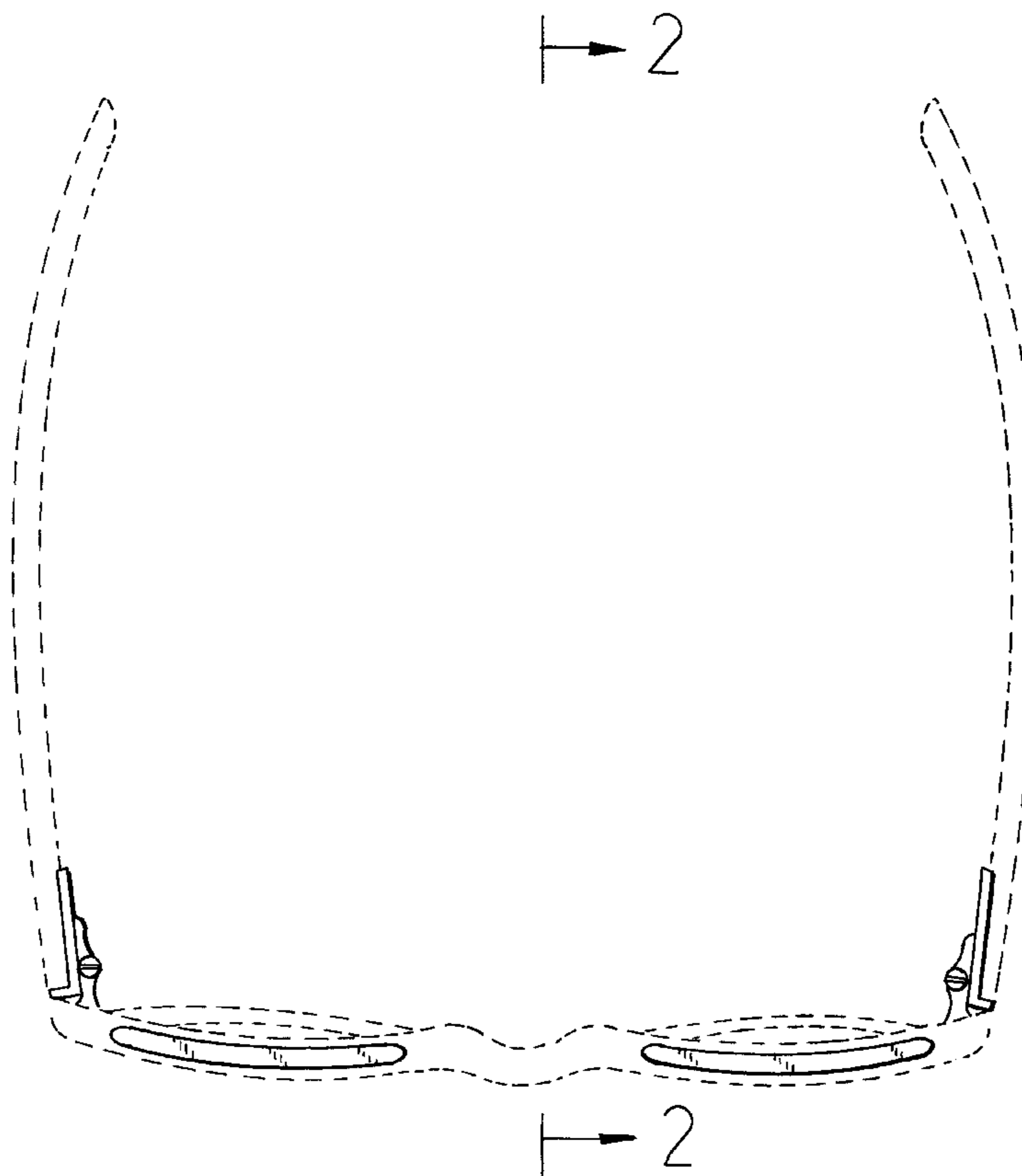
FIG. 3 is a side elevational view with environment in dotted lines;

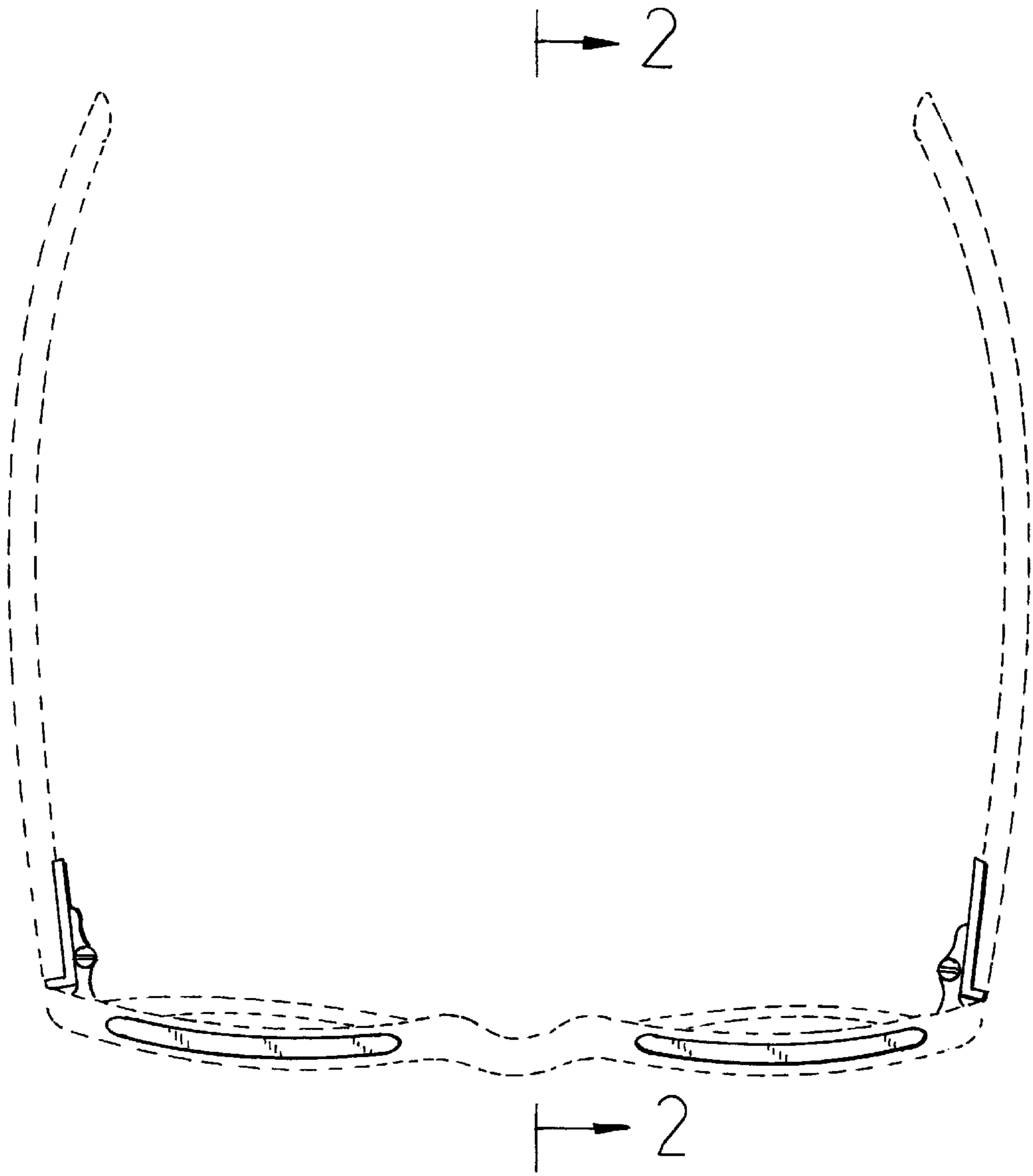

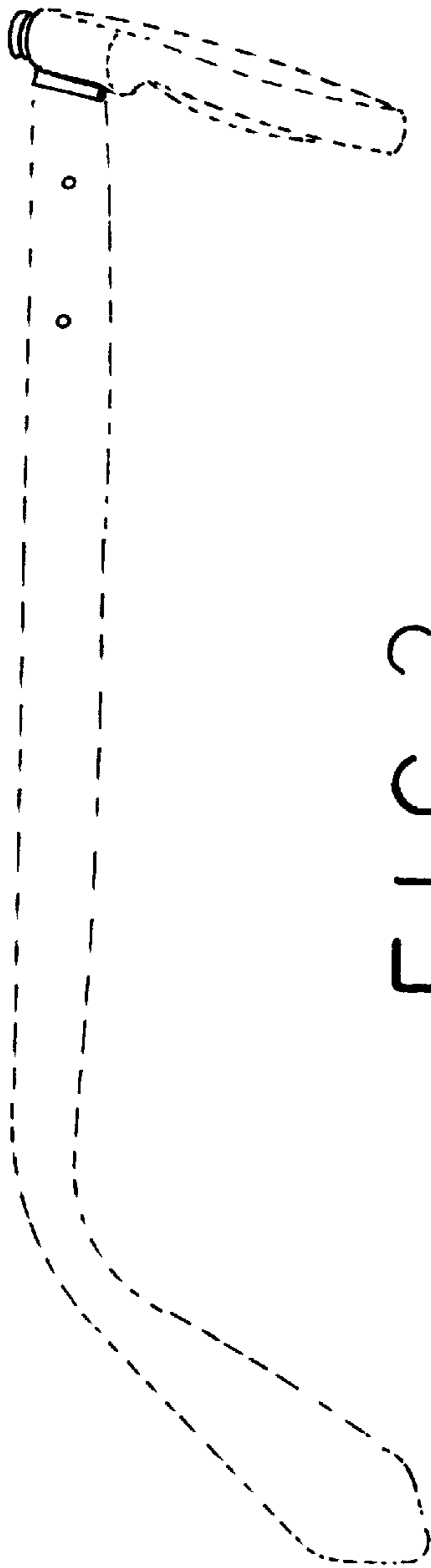

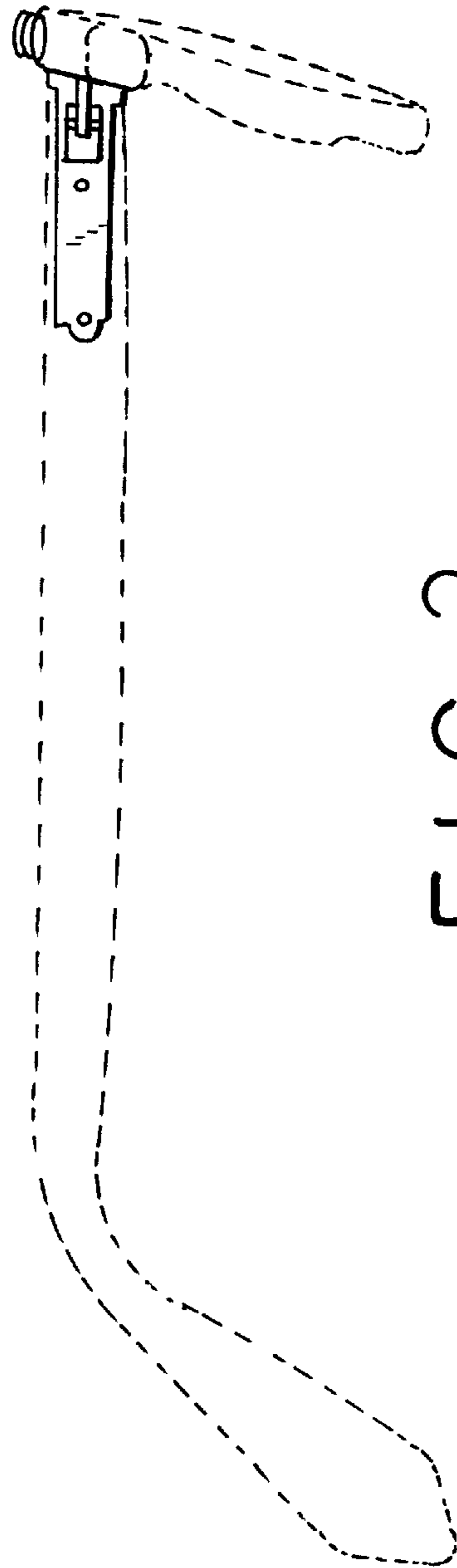

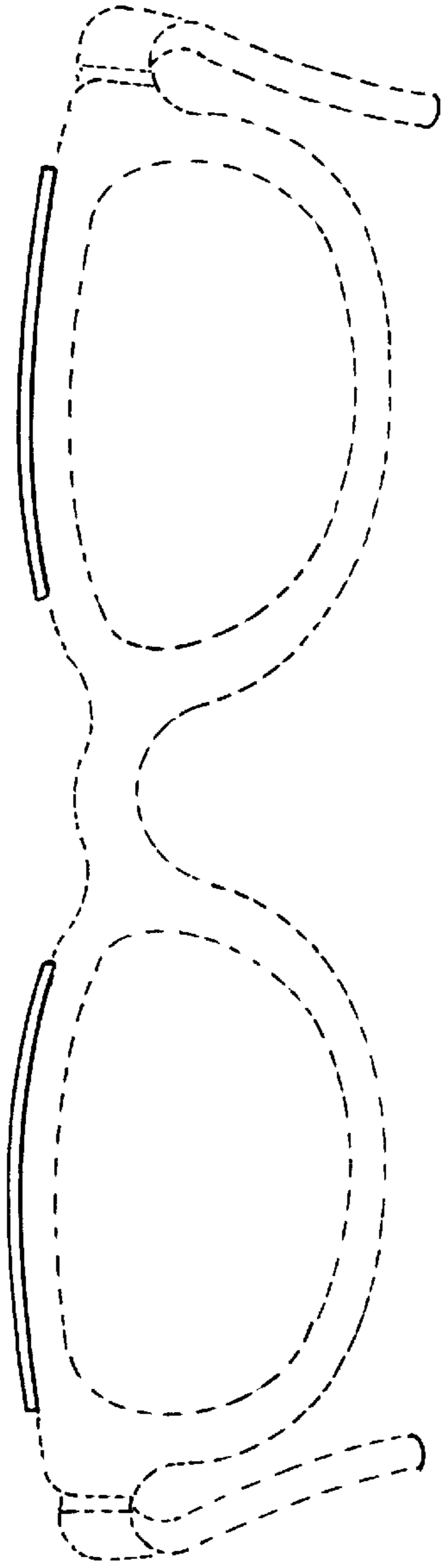

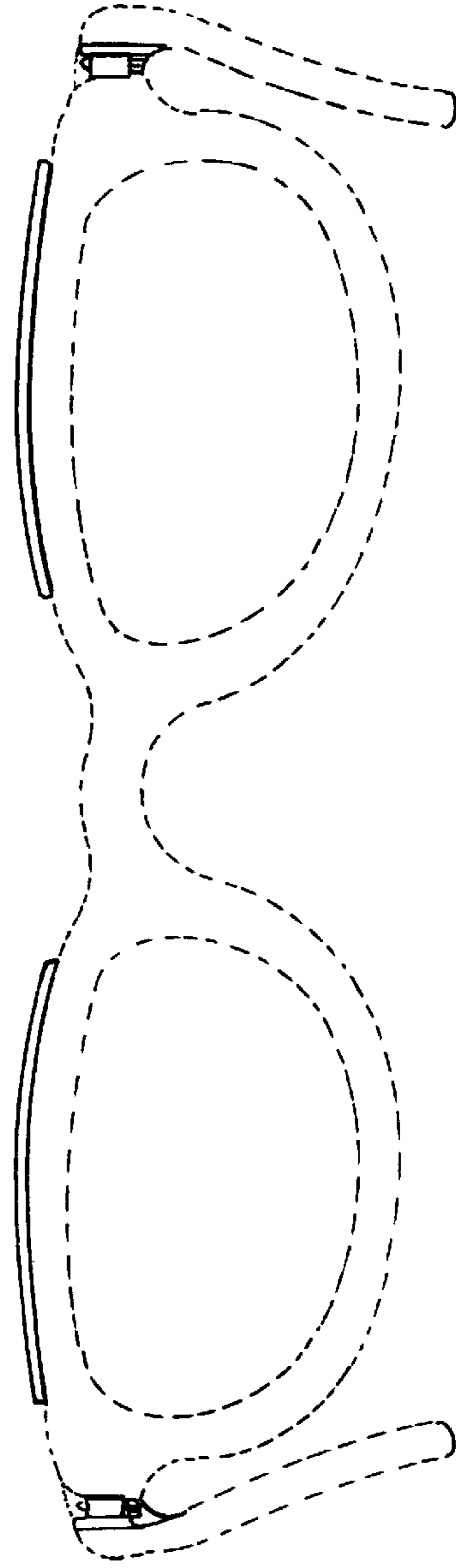

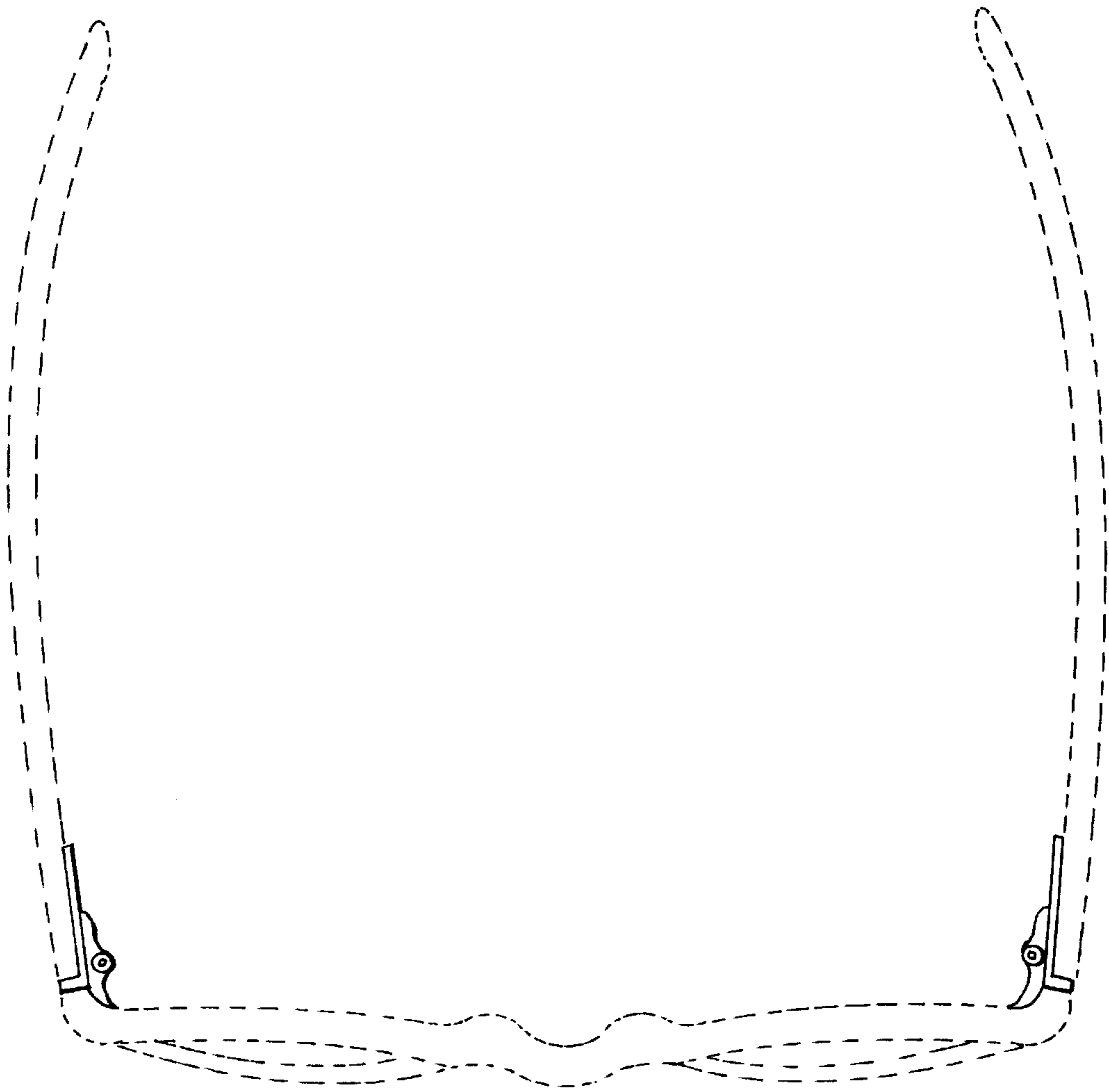
