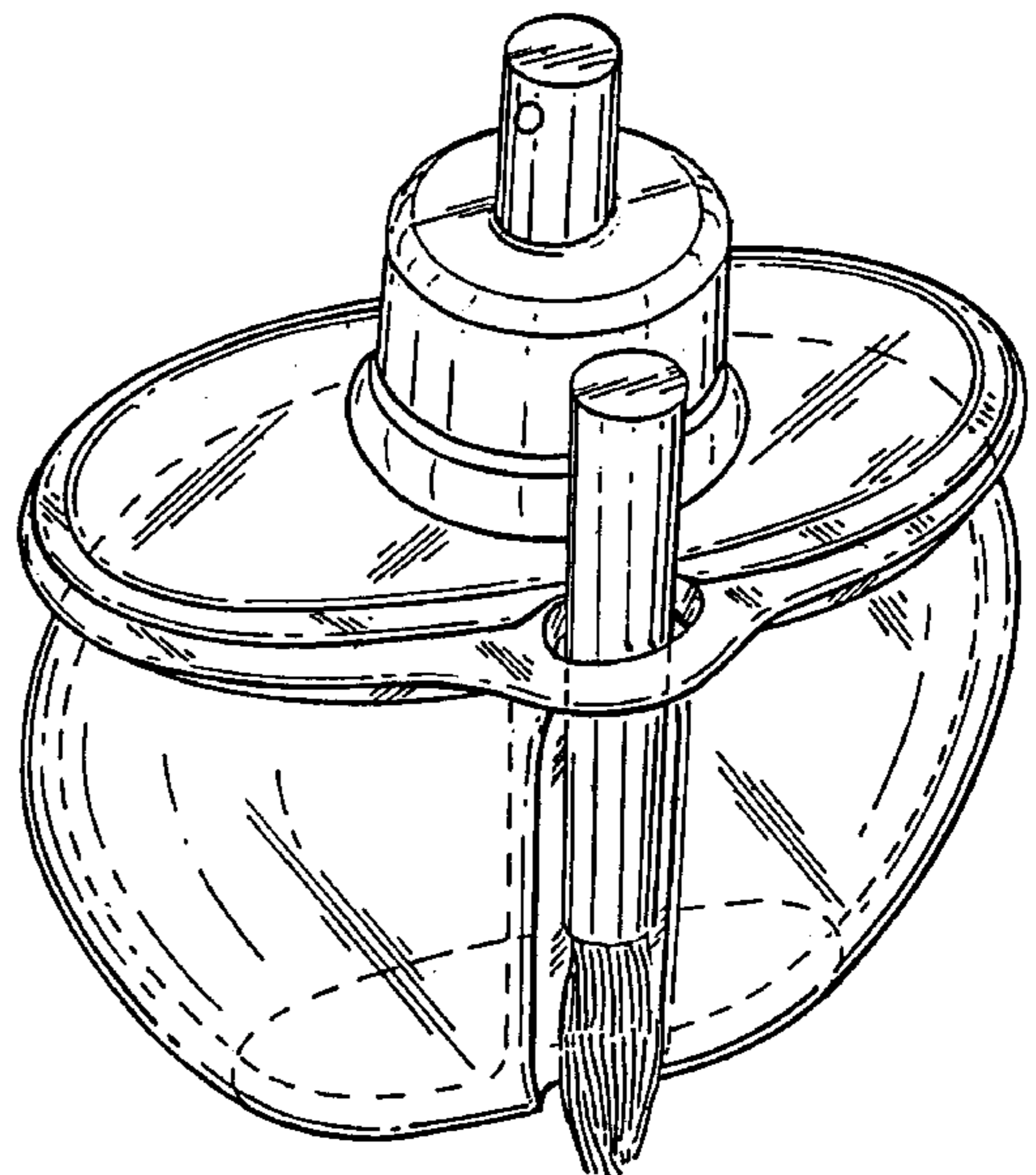
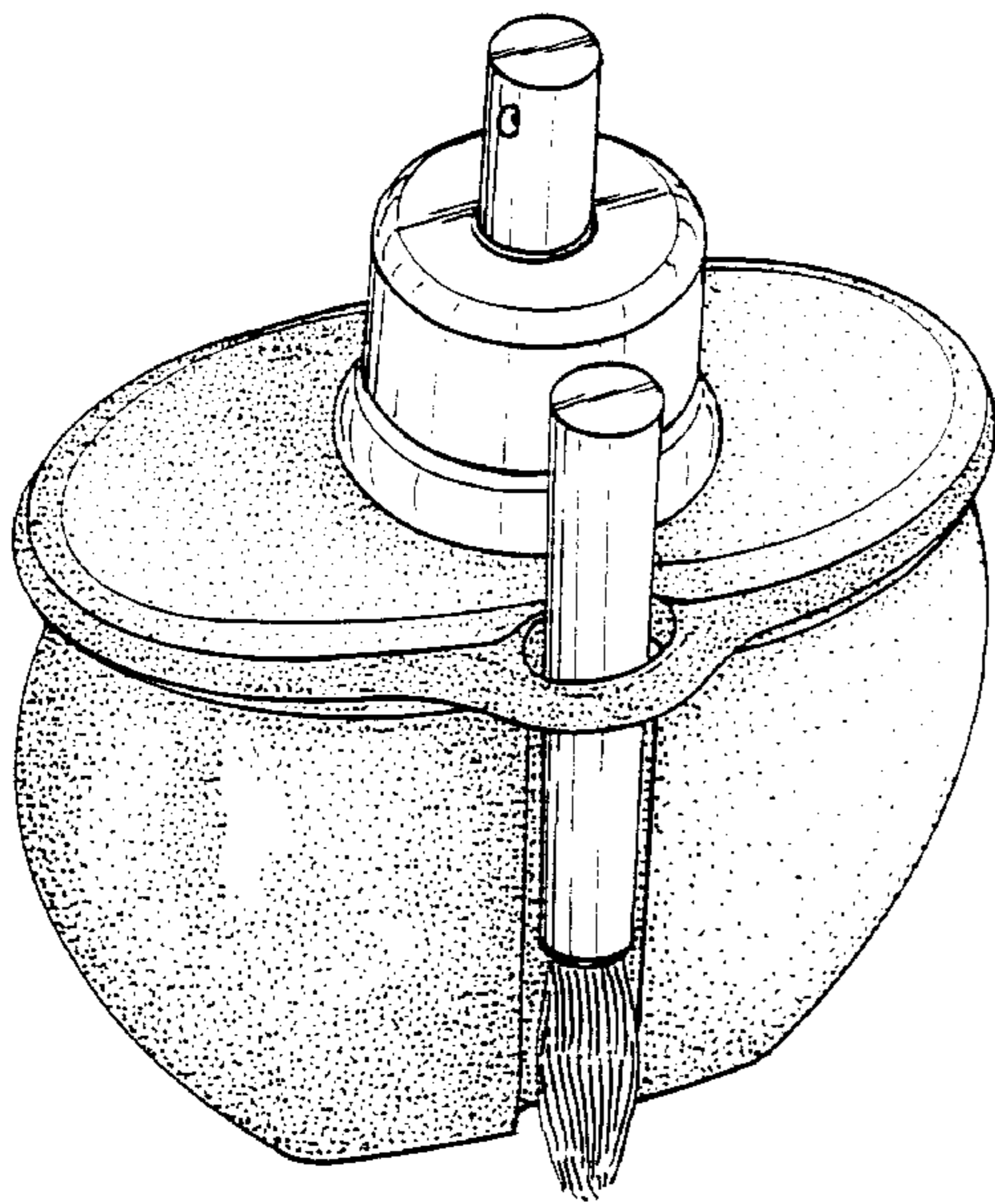
(57) **CLAIM**

I claim the ornamental design for cosmetic container, as shown and described.

DESCRIPTION

FIG. 1 is perspective view of a cosmetic container showing my new design;
 FIG. 2 is a first side view of the container of FIG. 1;
 FIG. 3 is a second side view of the container of FIG. 1;
 FIGS. 4 and 5 are side views taken from opposite sides with respect to FIGS. 2 and 3 respectively;
 FIG. 6 is a top plan view of the container of FIG. 1;
 FIG. 7 is a bottom plan view of the container of FIG. 1.
 FIG. 8 is a perspective view of a second embodiment of the cosmetic container of FIG. 1 in which a portion is transparent;
 FIG. 9 is a first side view of the container of FIG. 8;
 FIG. 10 is a second side view of the container of FIG. 8;
 FIGS. 11 and 12 are side views taken from opposite sides of the respective FIGS. 9 and 10, respectively;
 FIG. 13 is a top plan view of the container of FIG. 8; and,
 FIG. 14 is a bottom plan view of the container of FIG. 8.
 Broken line disclosure in FIGS. 8–14 is for illustrative purposes only and forms no part of the claimed design.

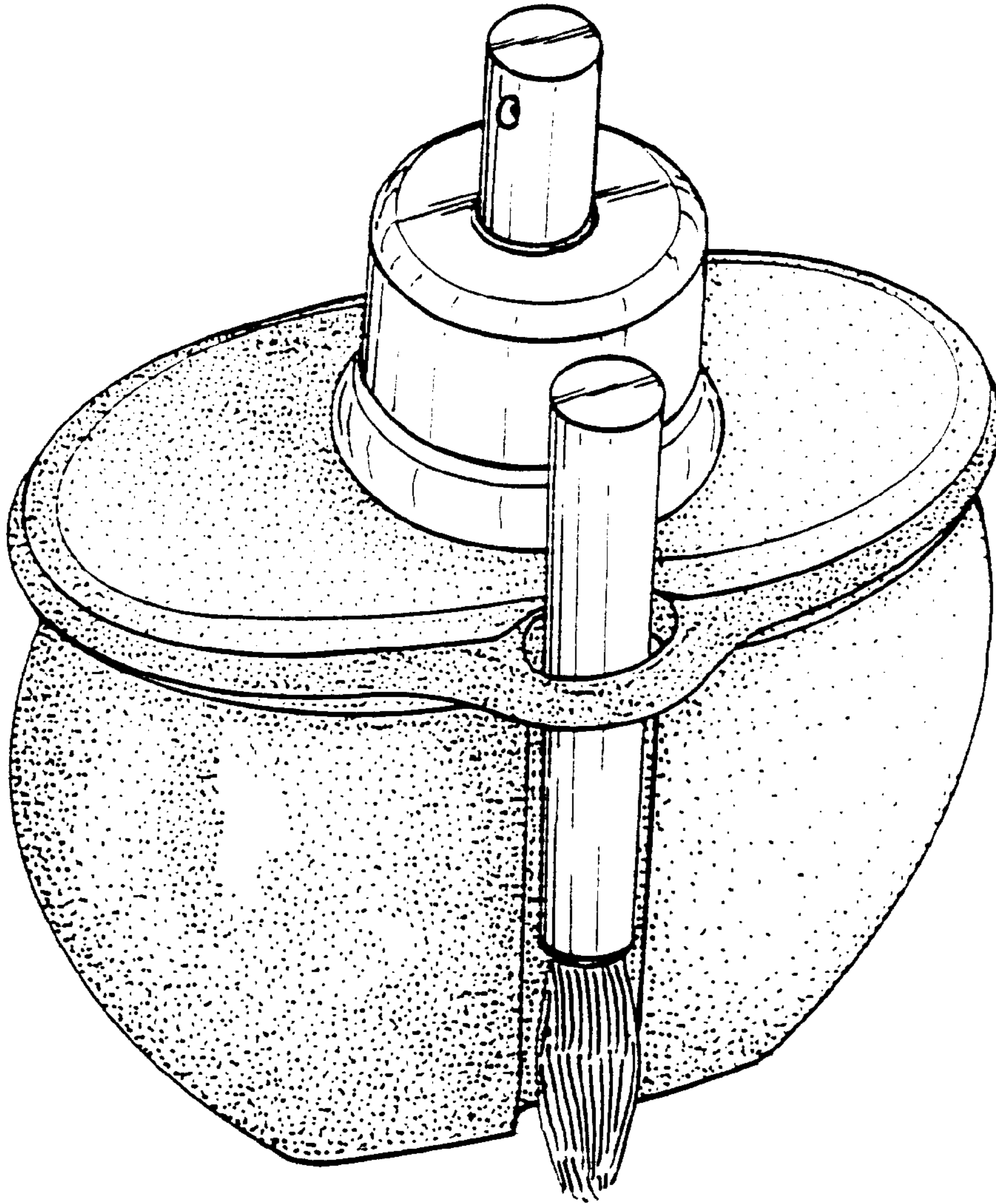

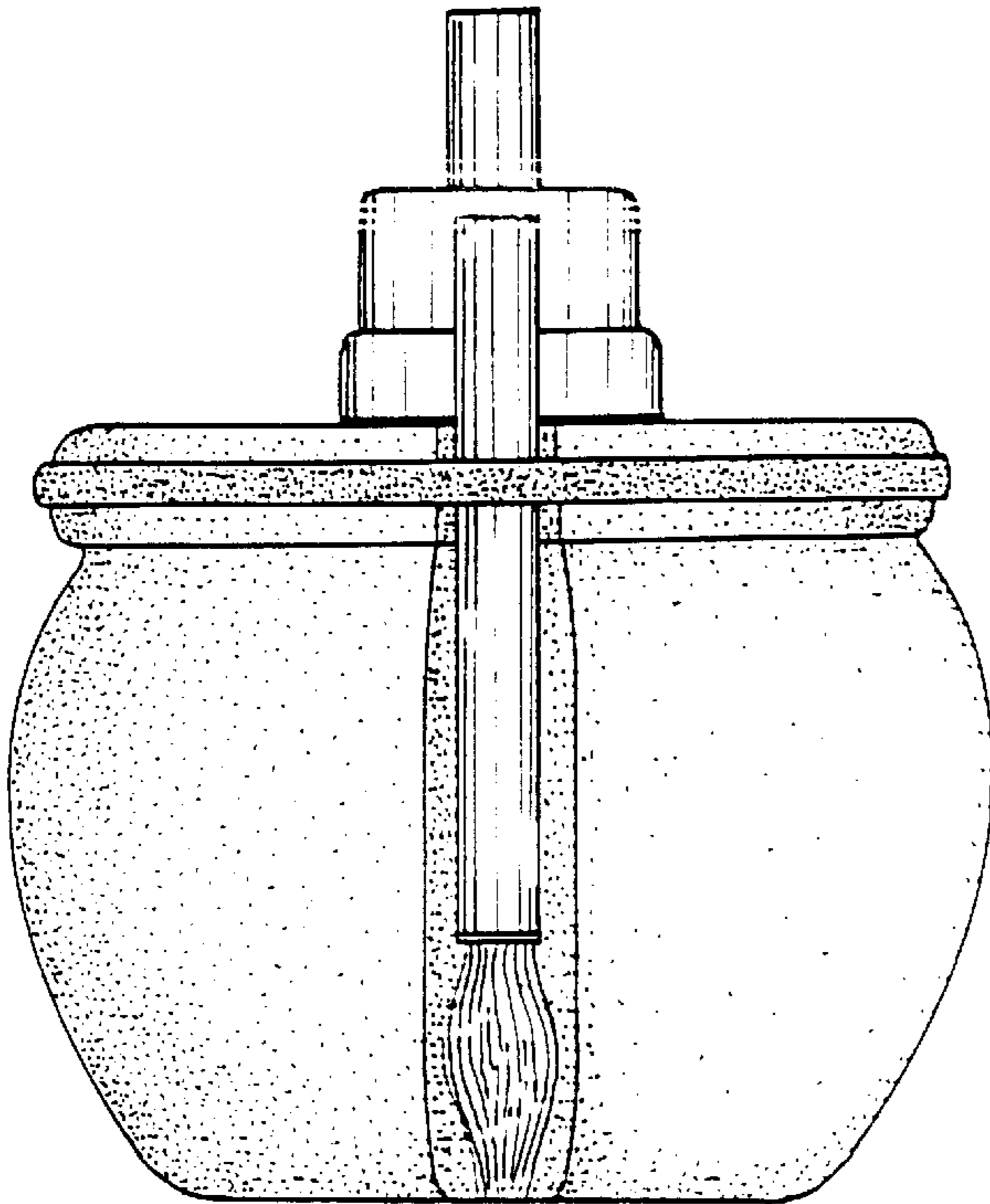

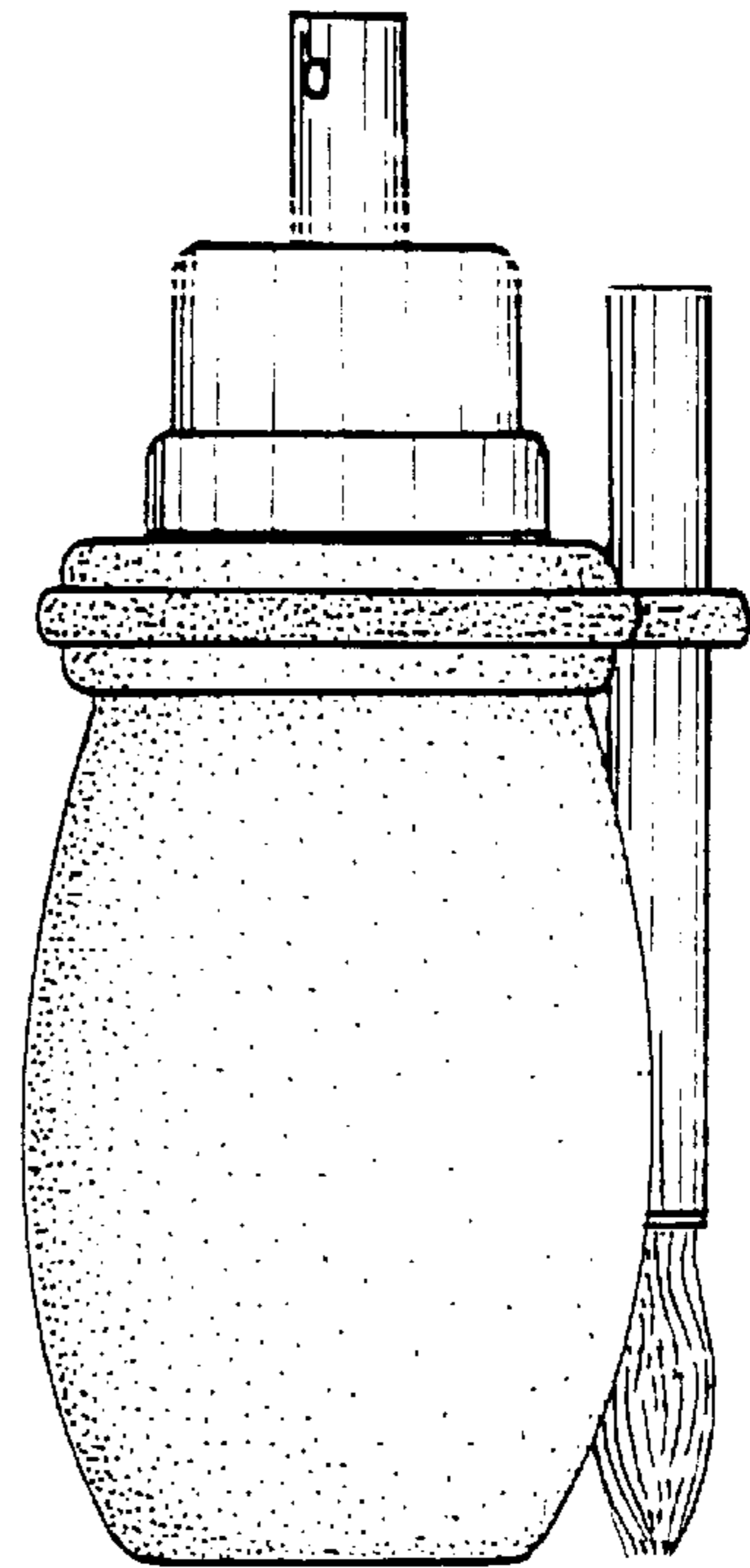

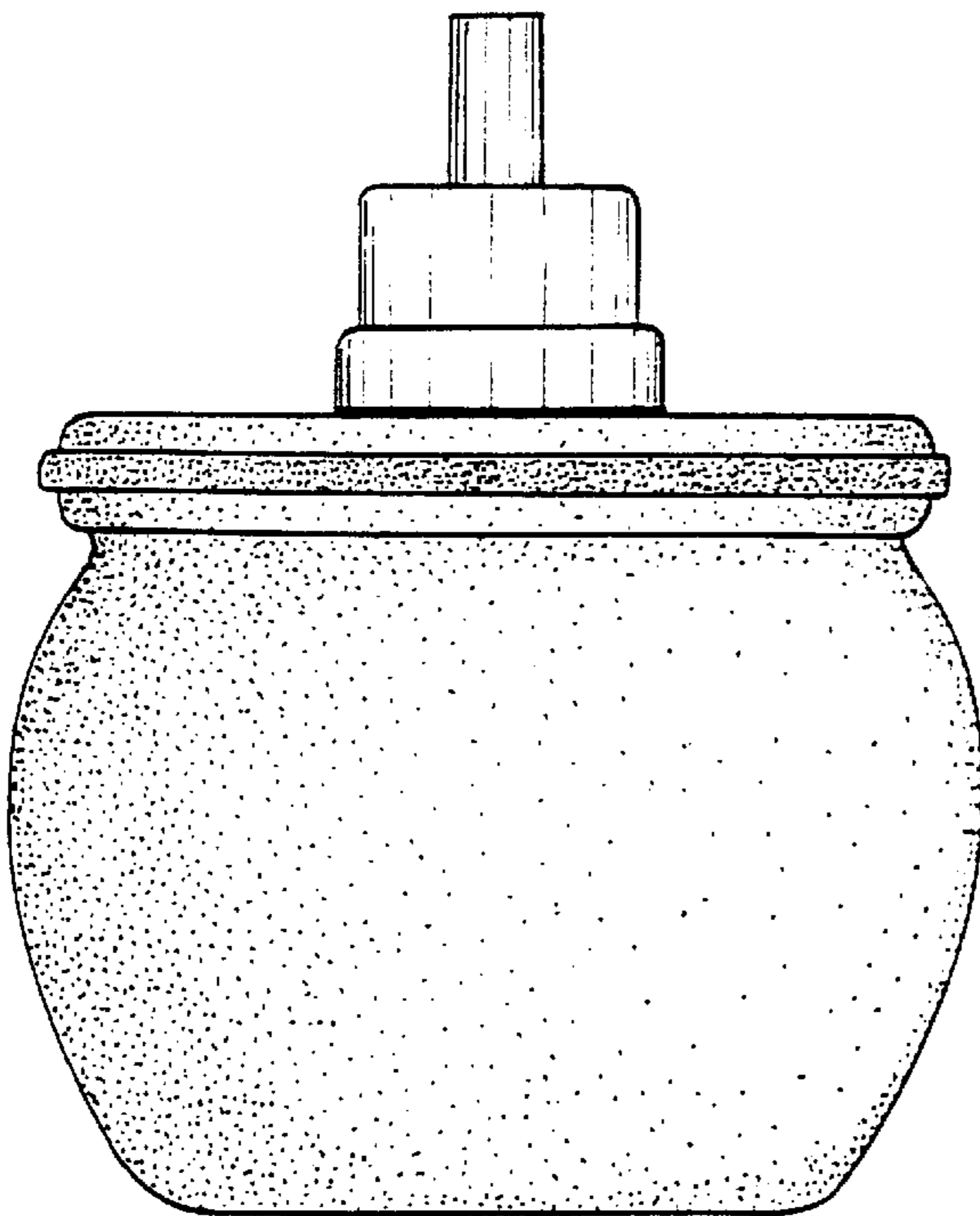

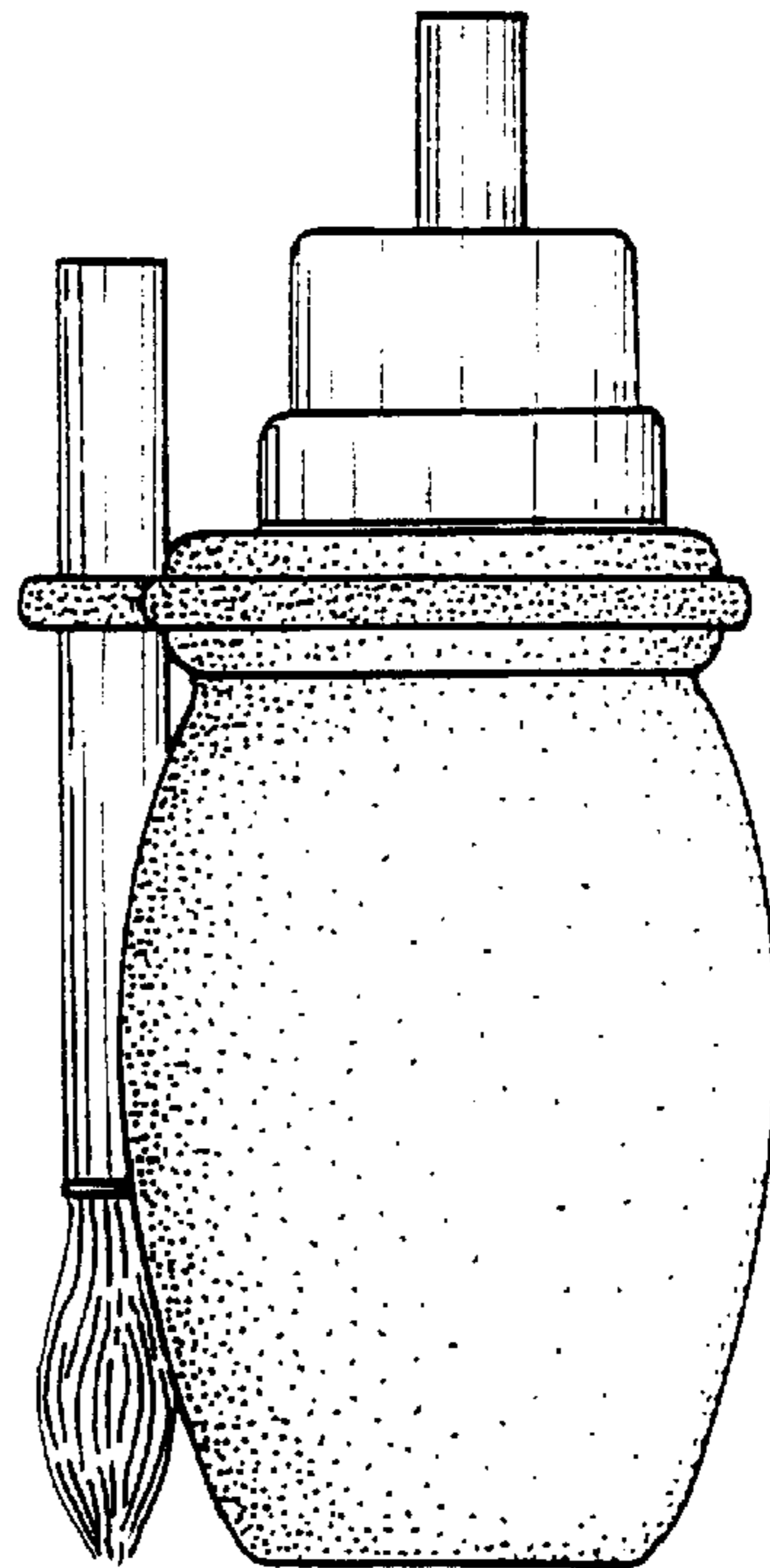

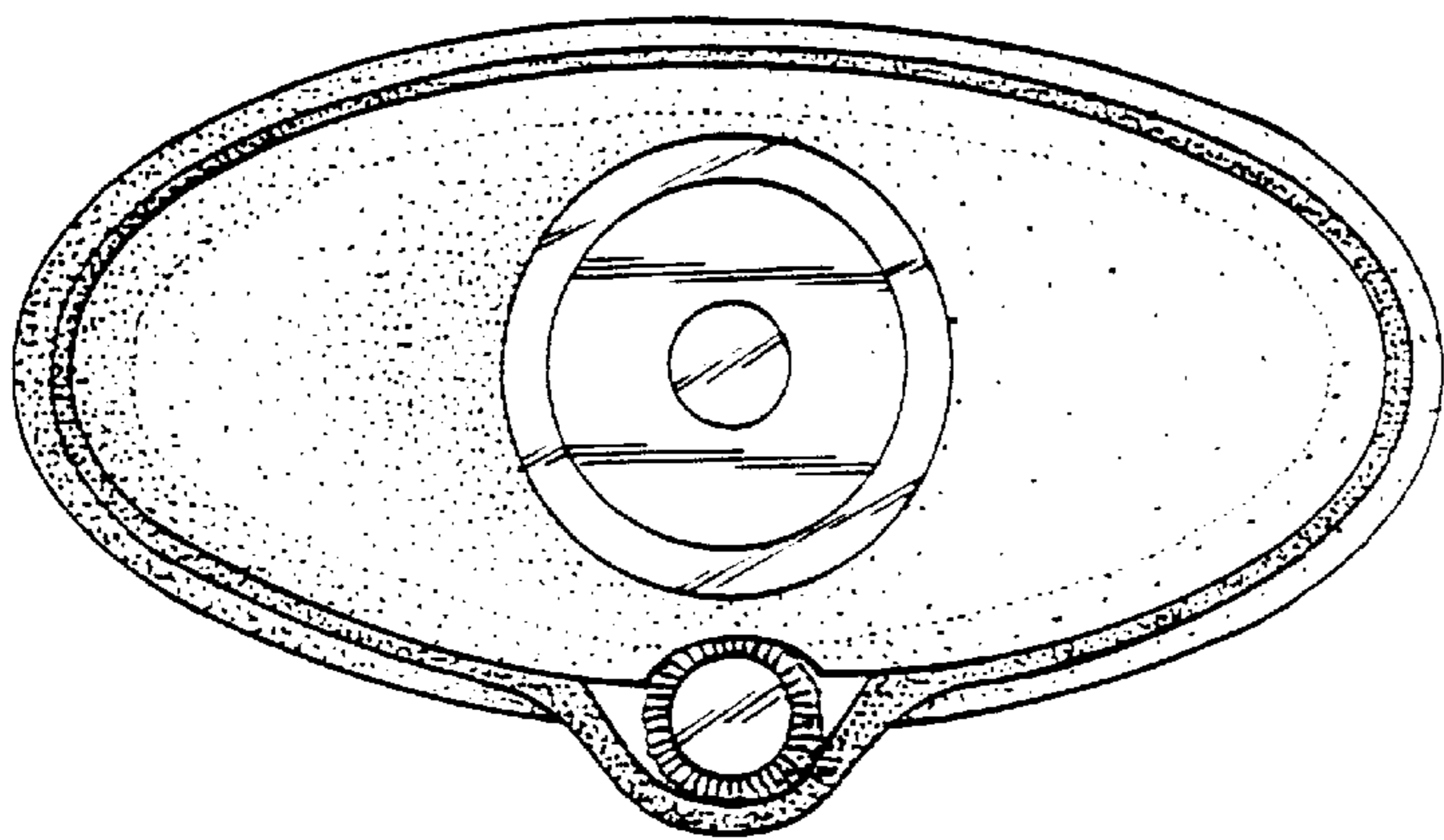

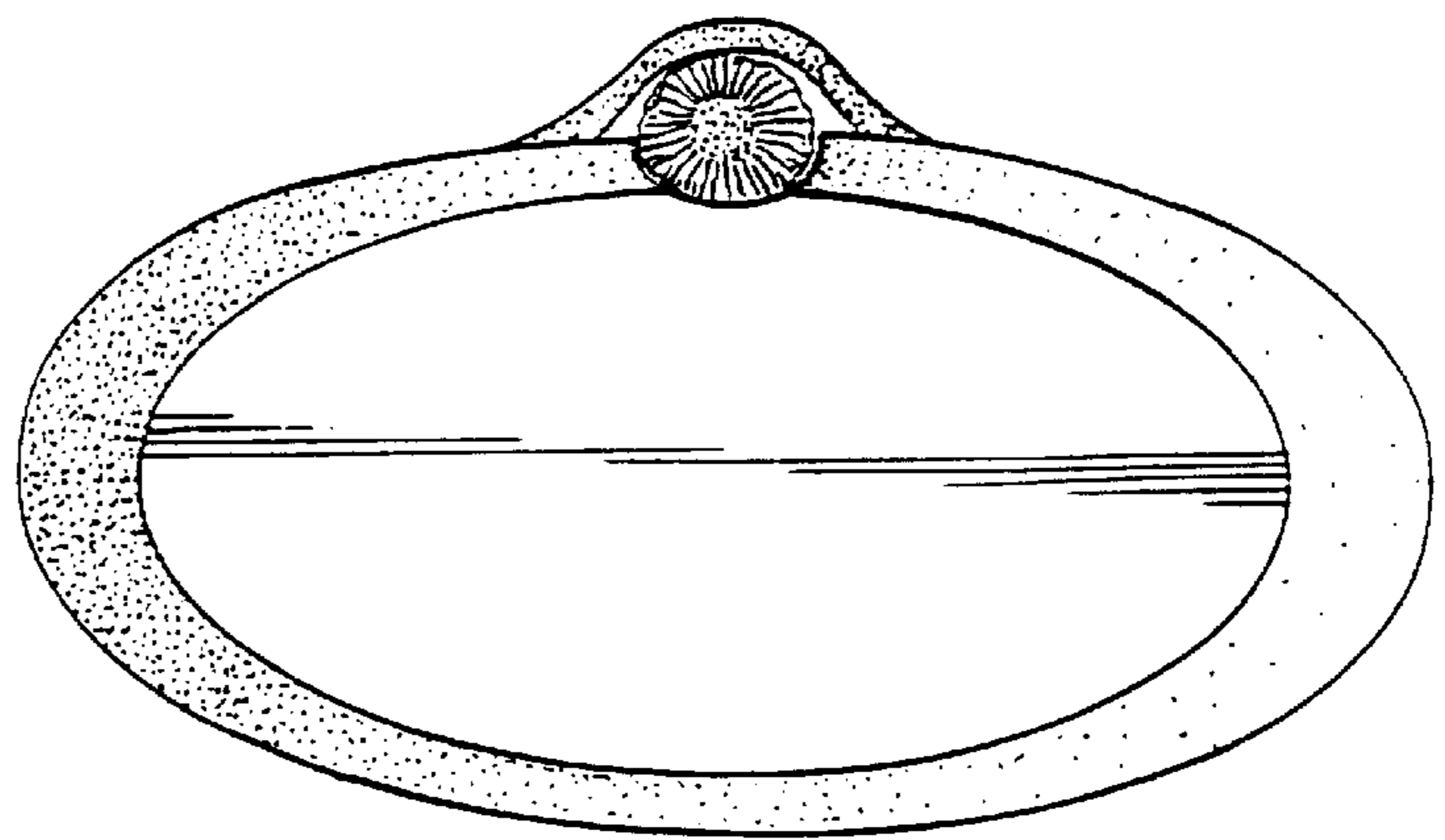

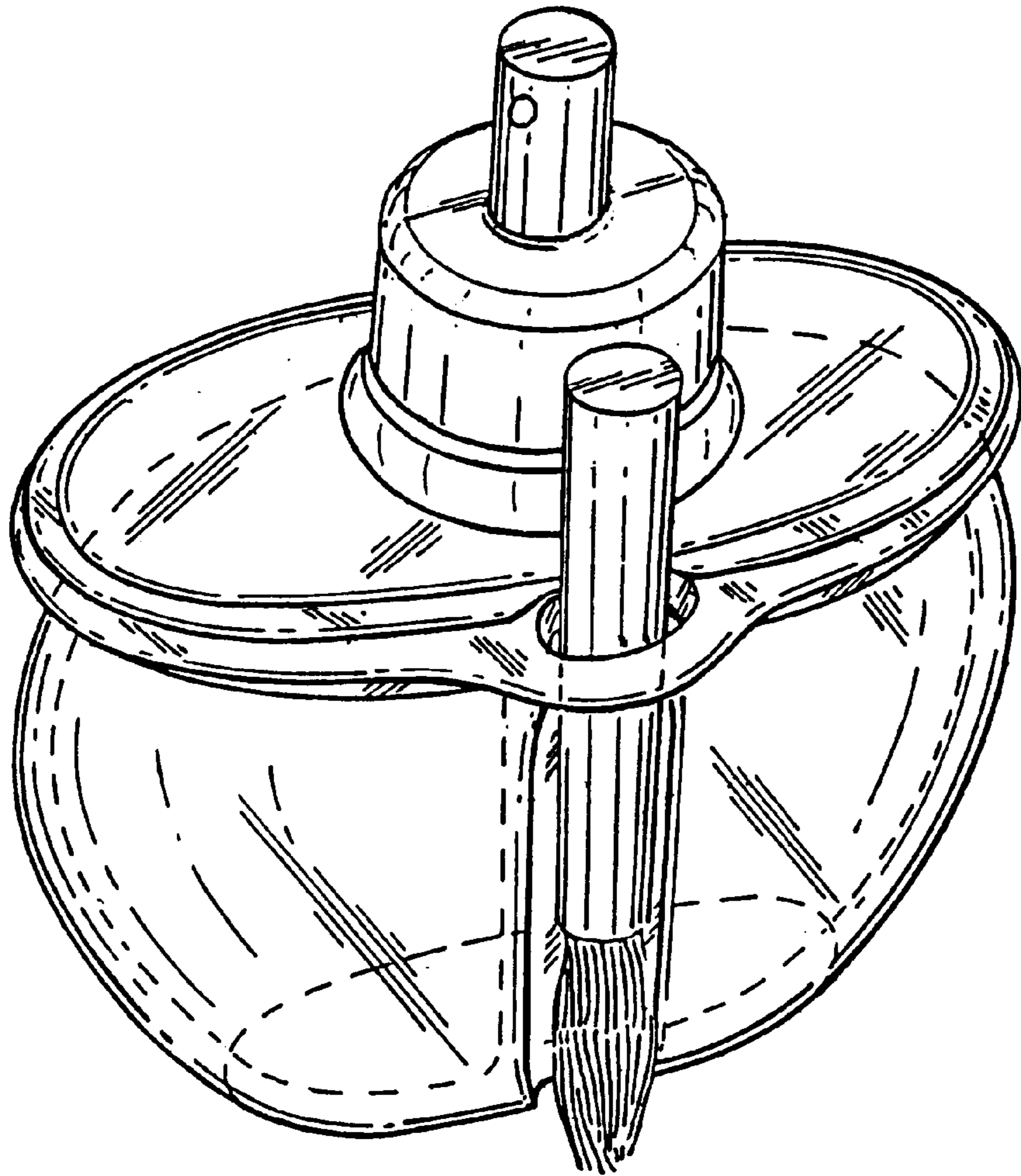

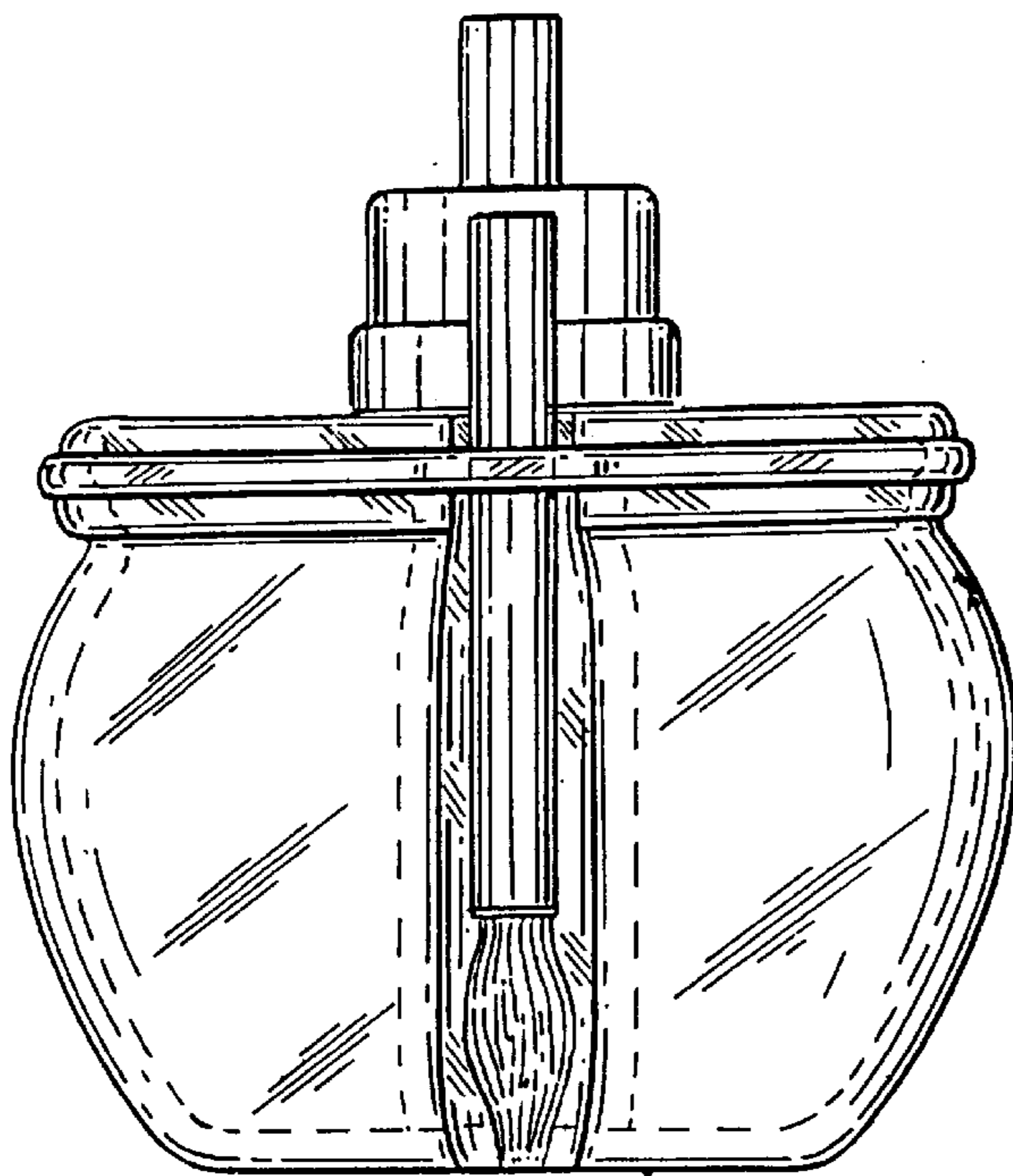

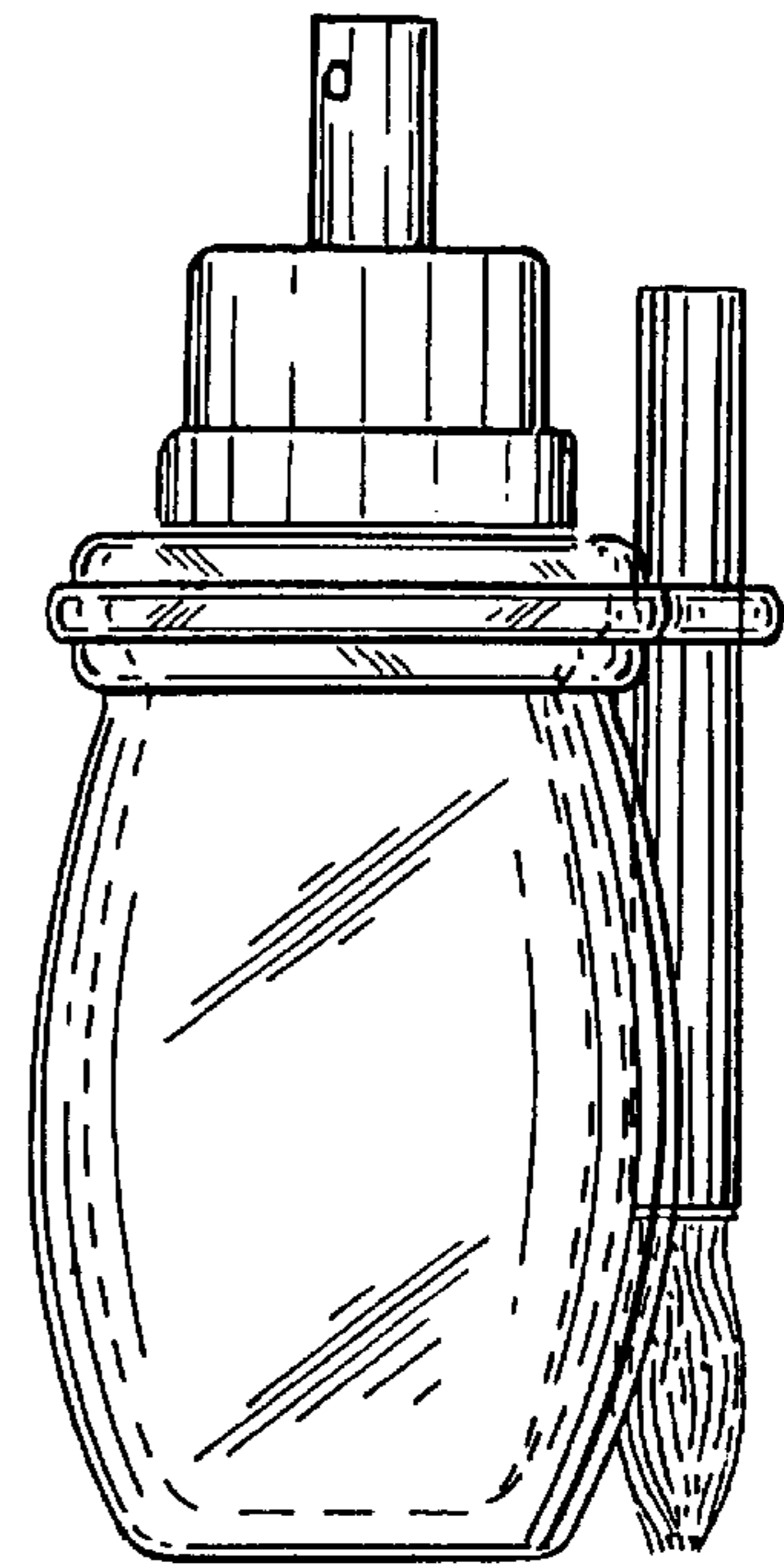

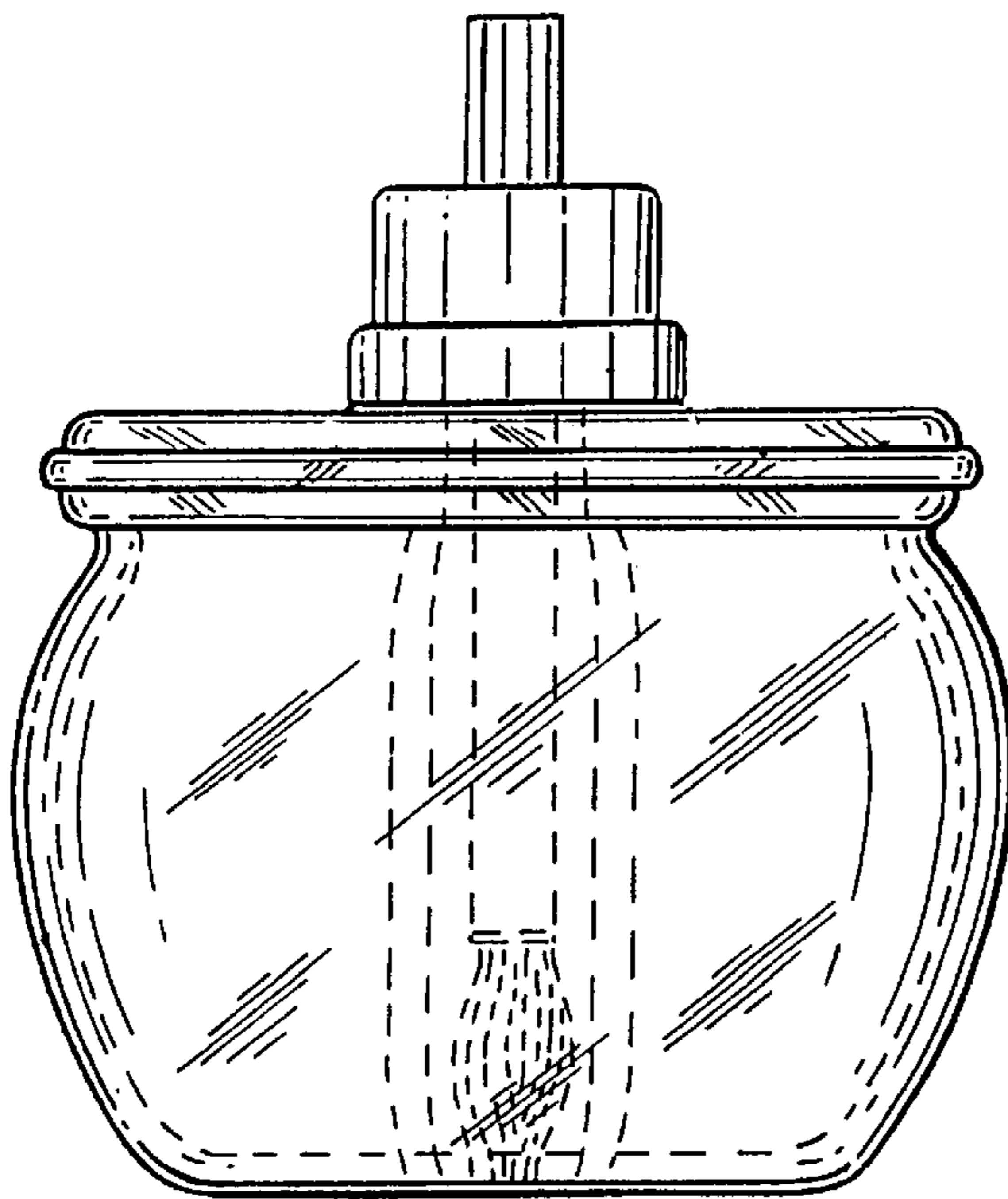

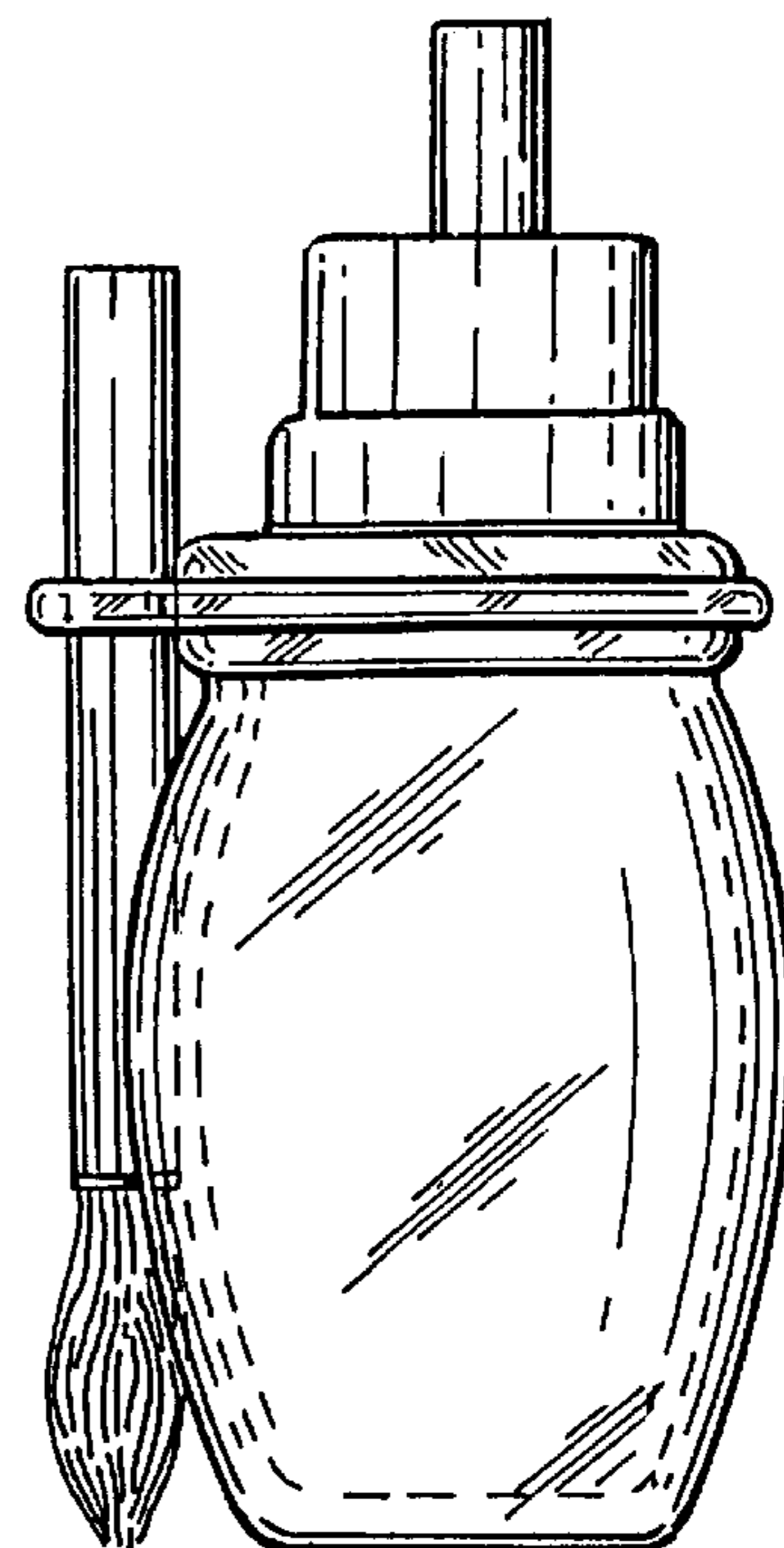

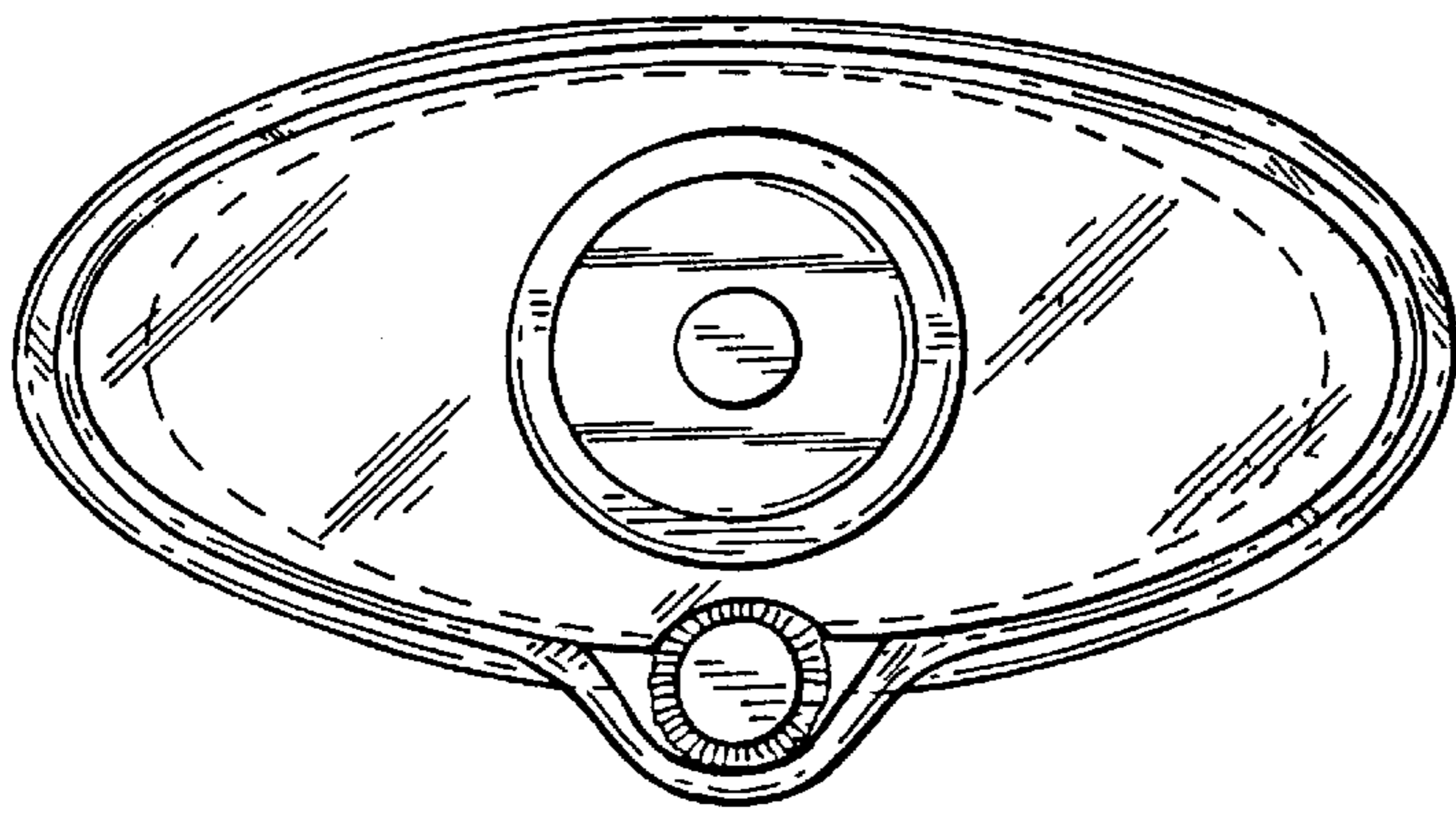

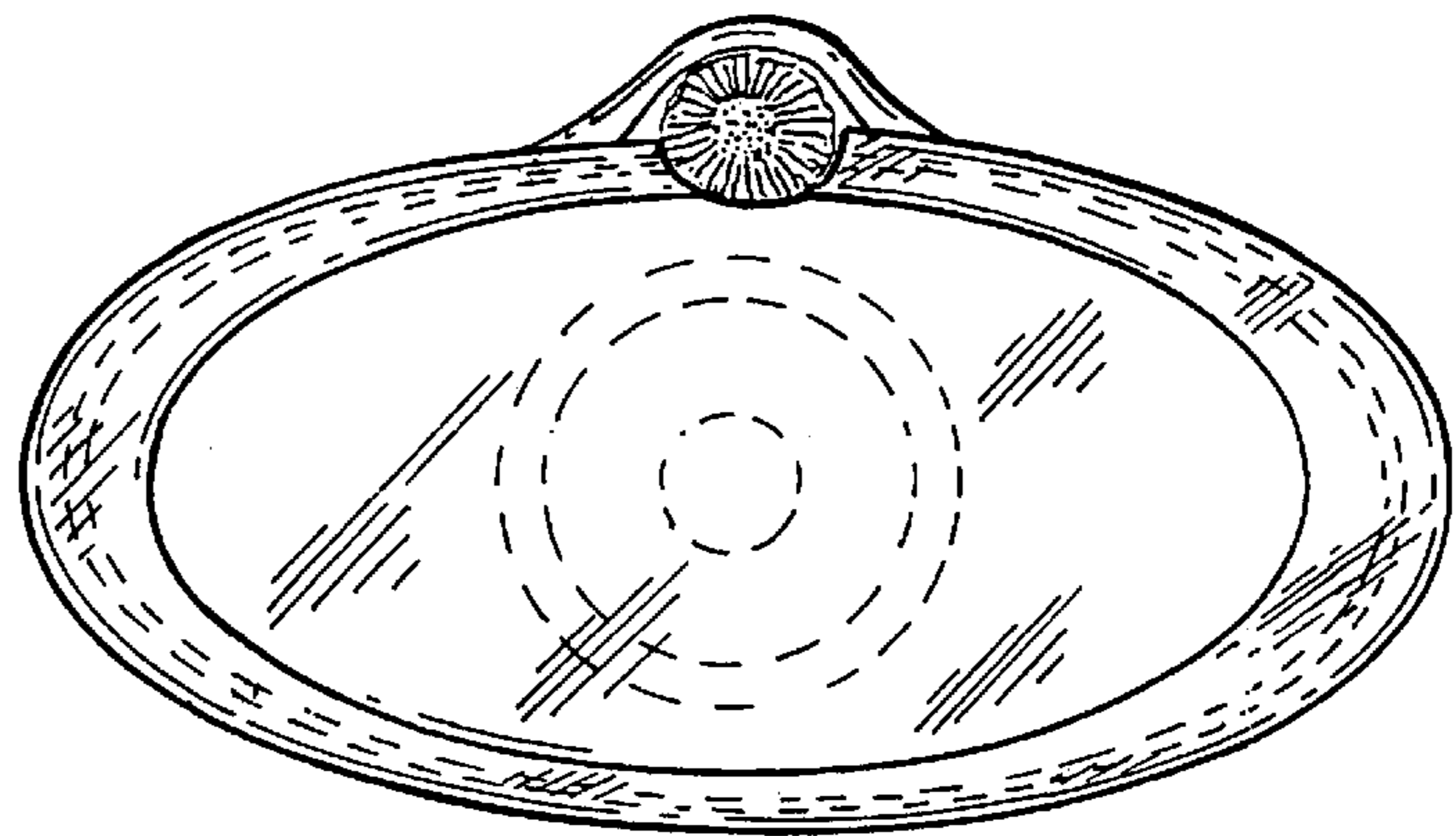
