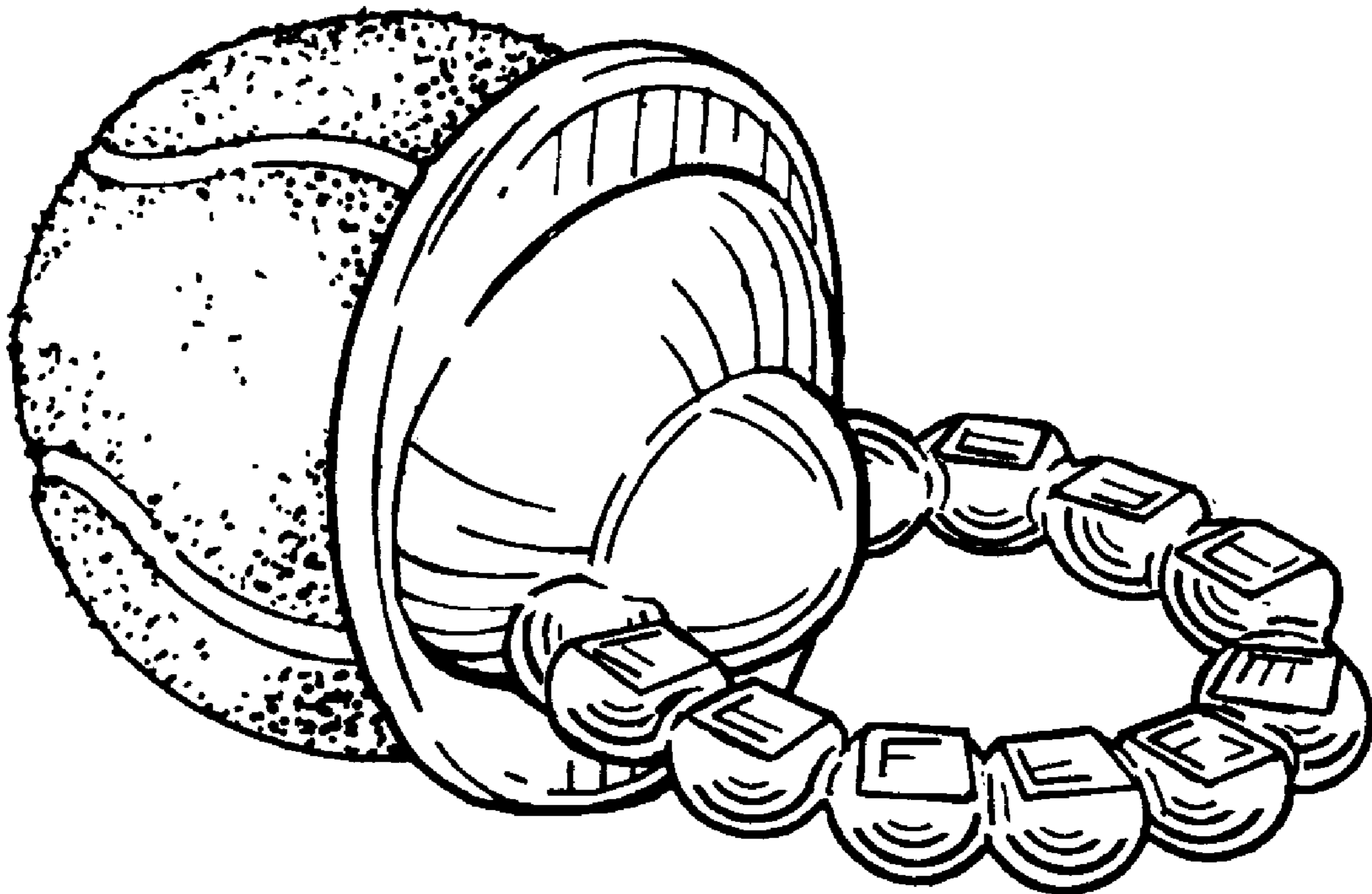
The ornamental design for a toy pacifier for dogs, as shown and described.

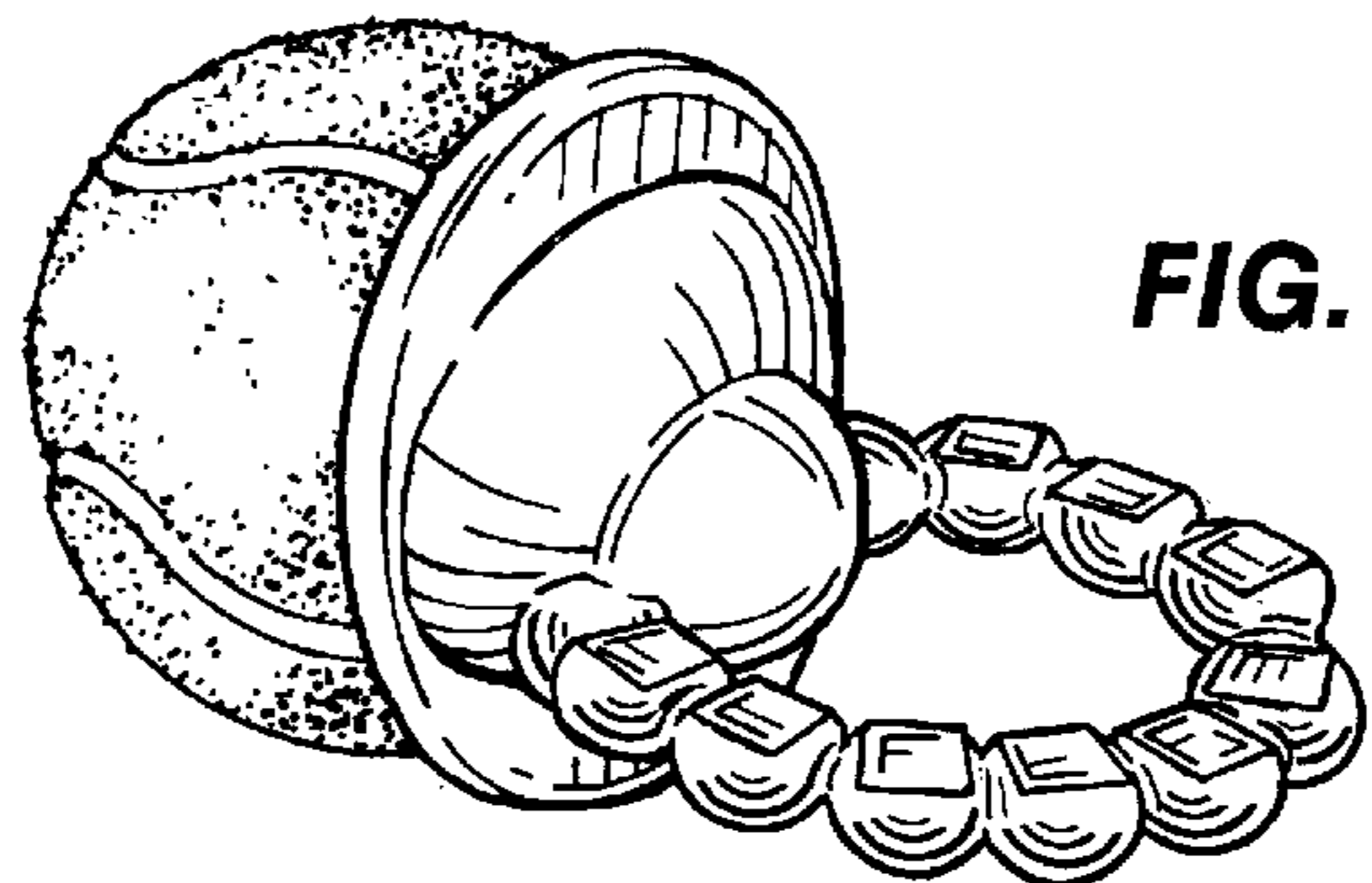

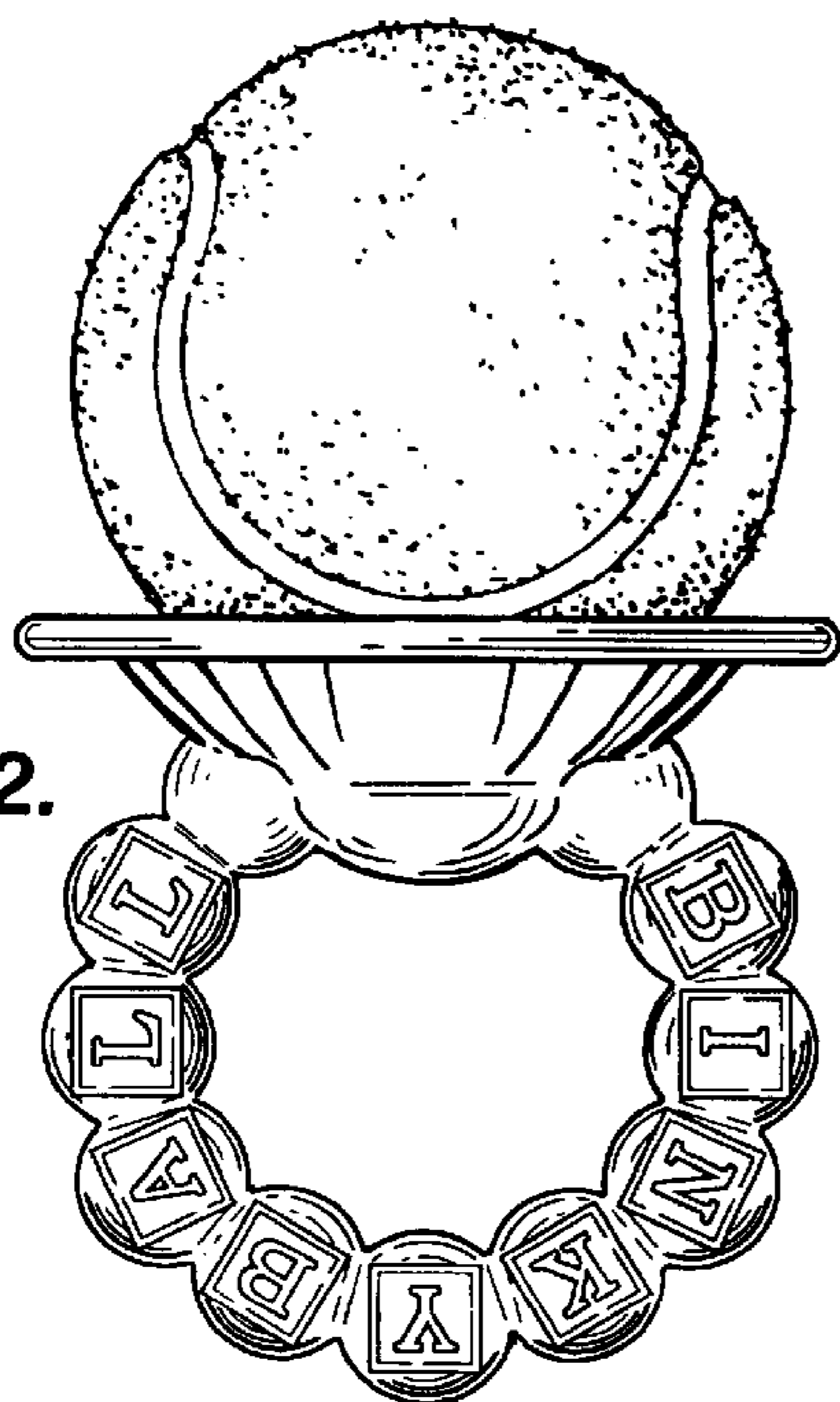

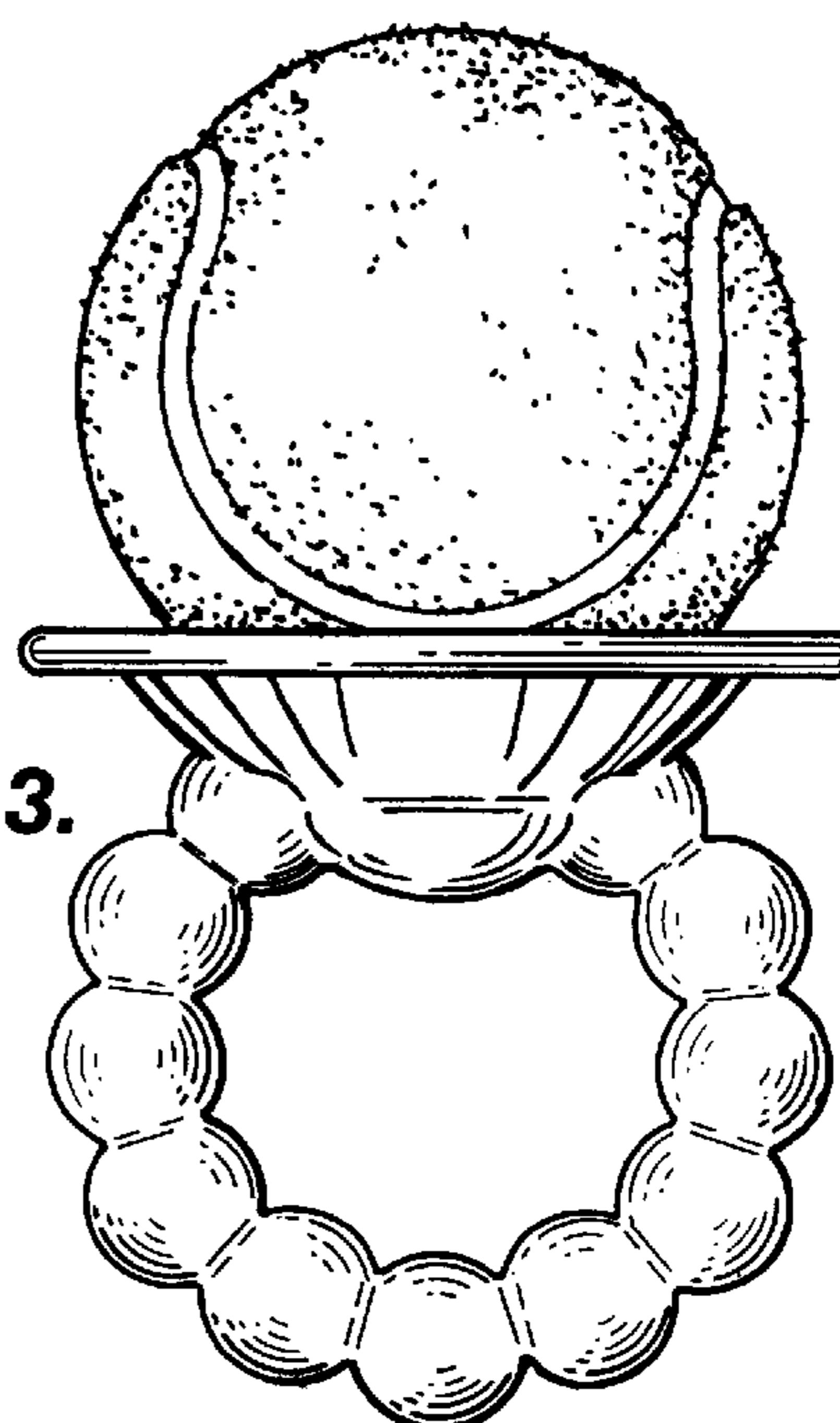

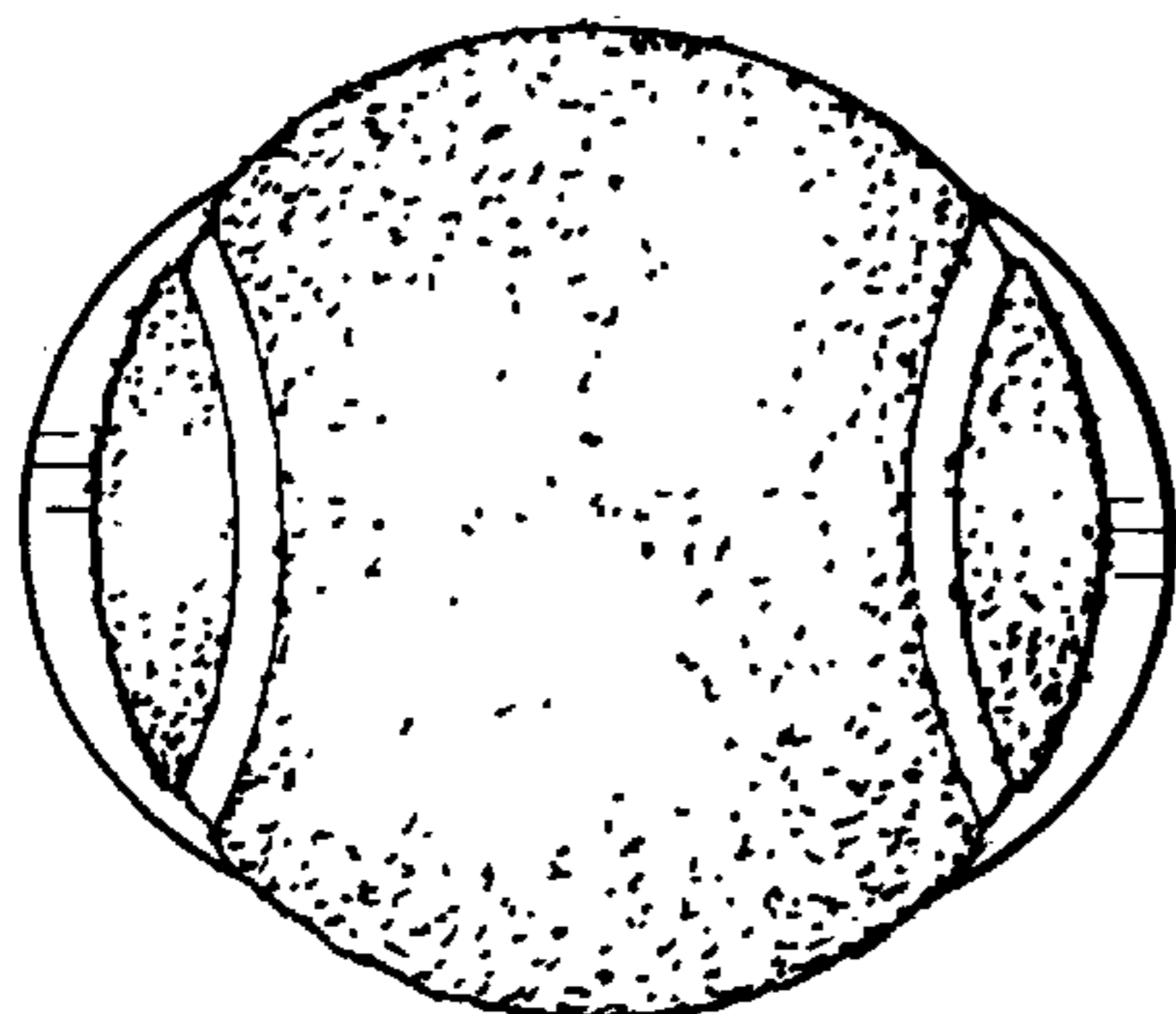

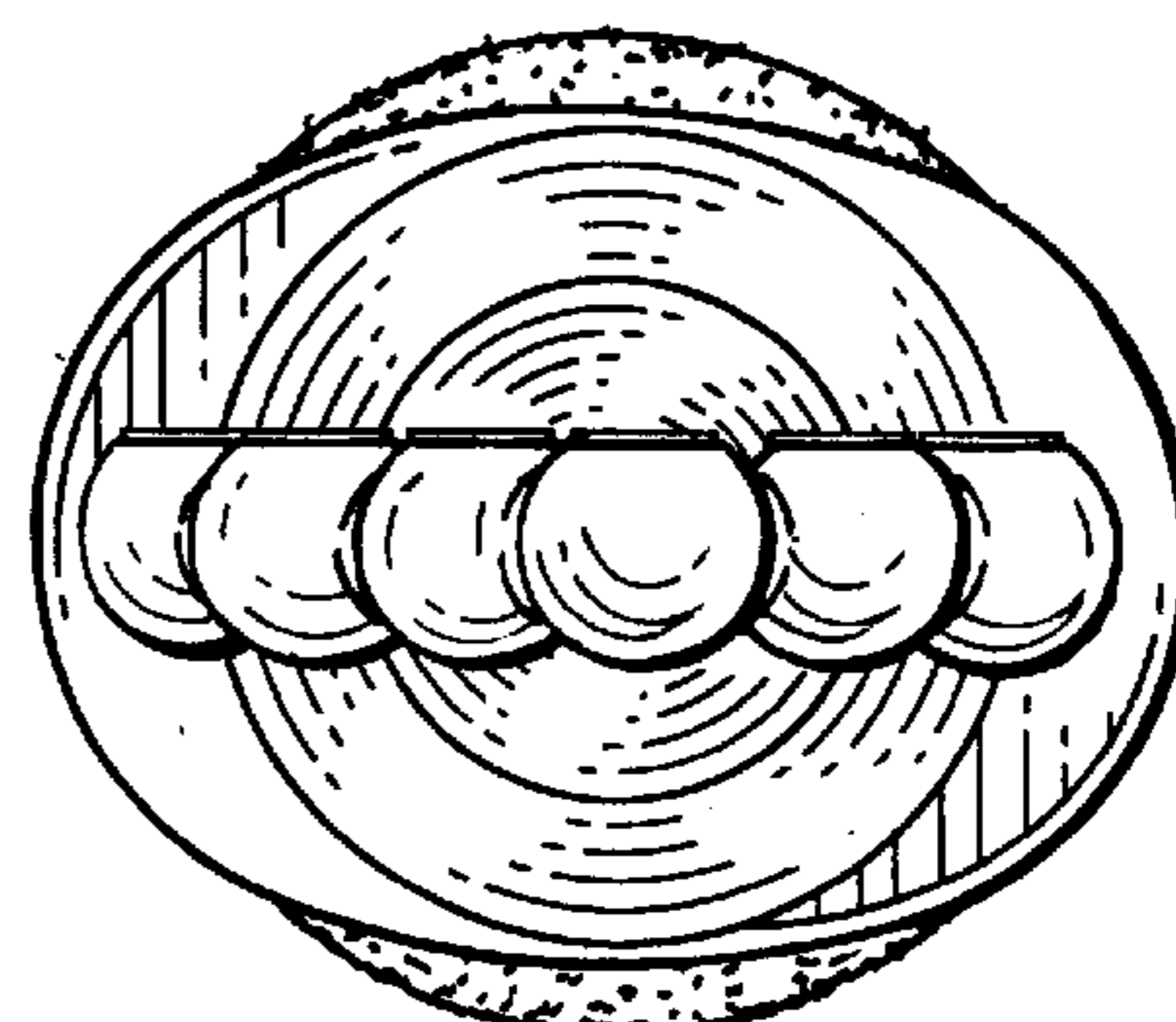

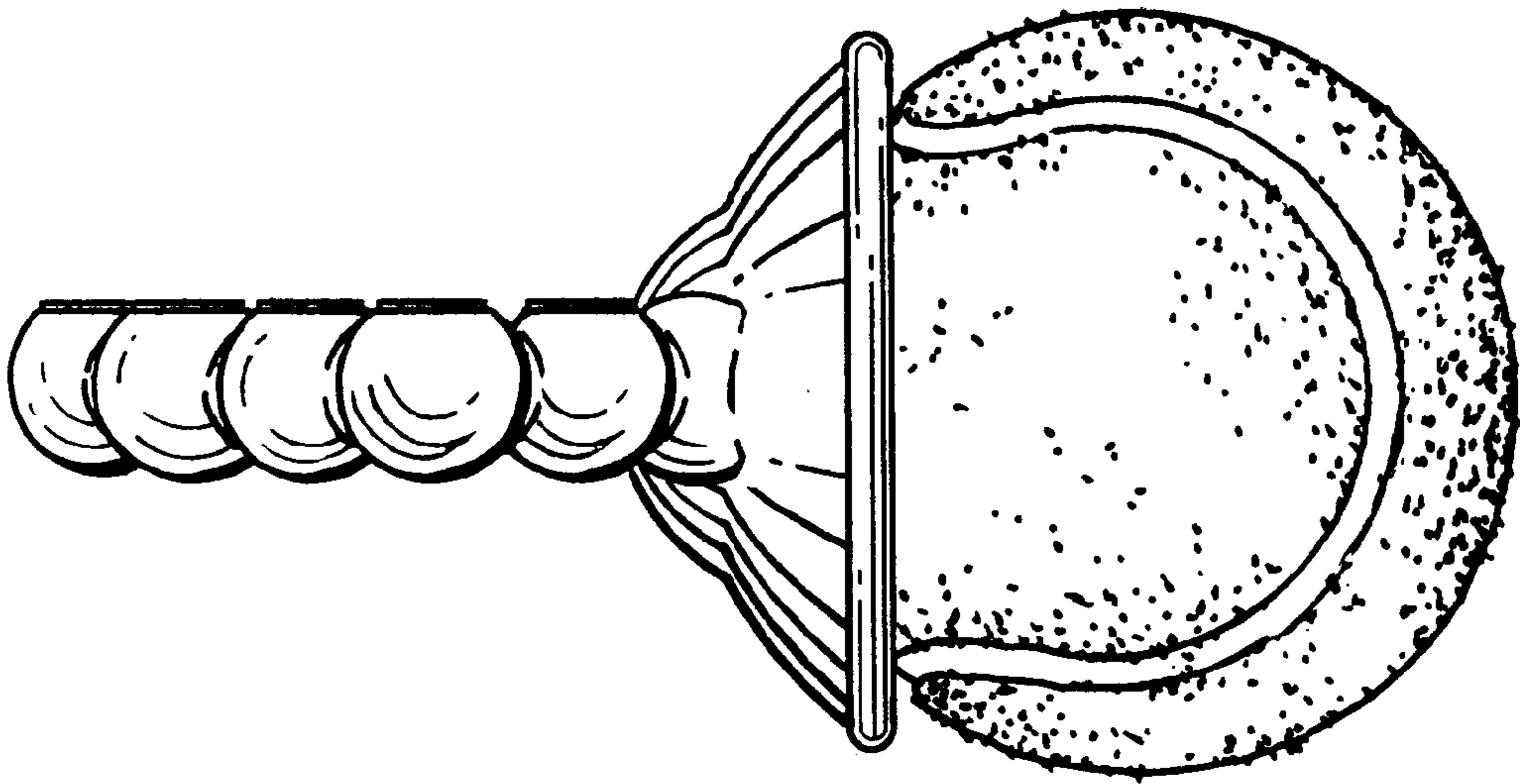

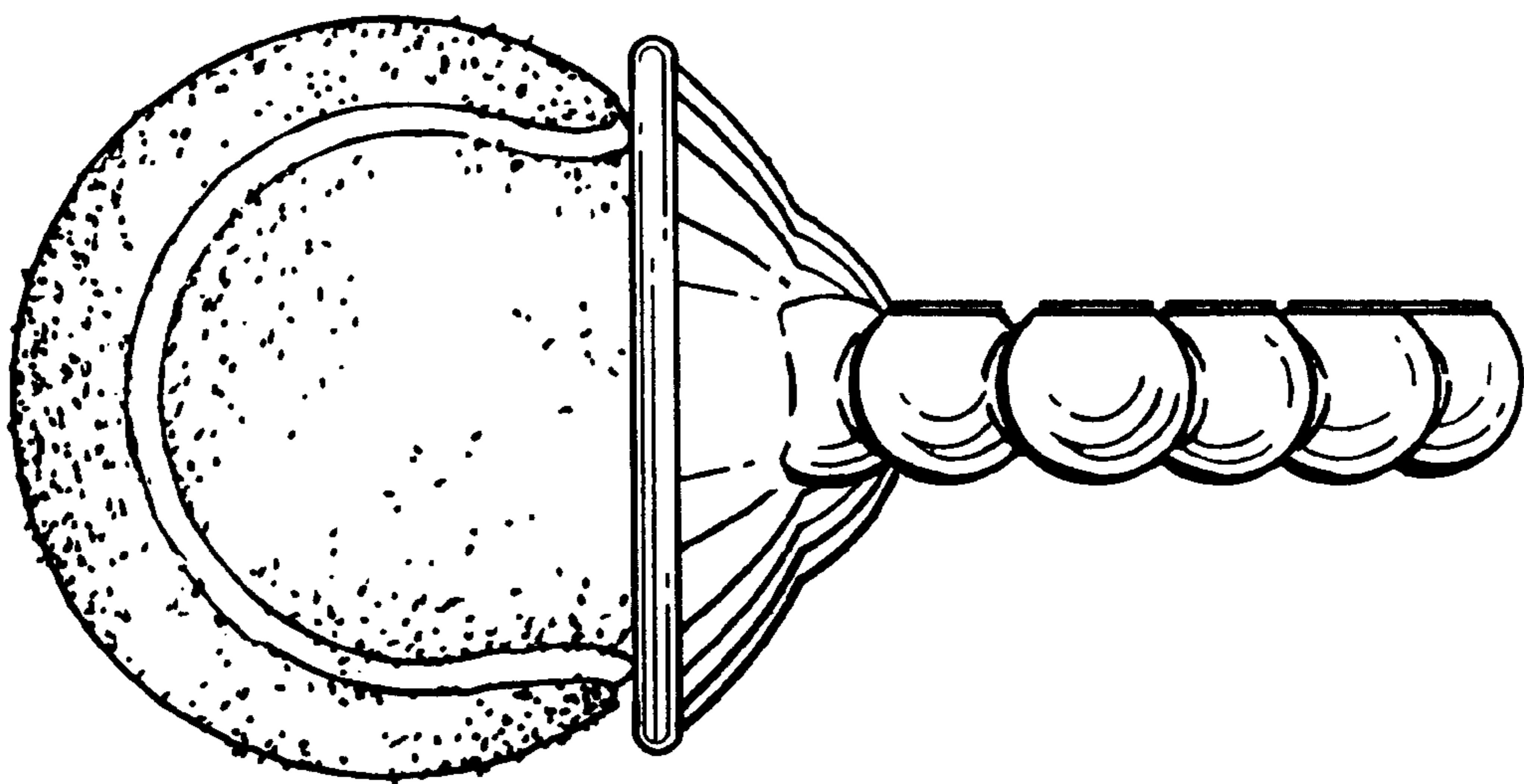
