(57) **CLAIM**

The ornamental design for a waffle bar, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the waffle bar.

FIG. 2 is a top view of the waffle bar of FIG. 1 which is the same as the bottom view.

FIG. 3 is a left side view of the waffle bar of FIG. 1 which is the same as the right side view; and,

FIG. 4 is a front view of the waffle bar of FIG. 1, which is the same as the back view.

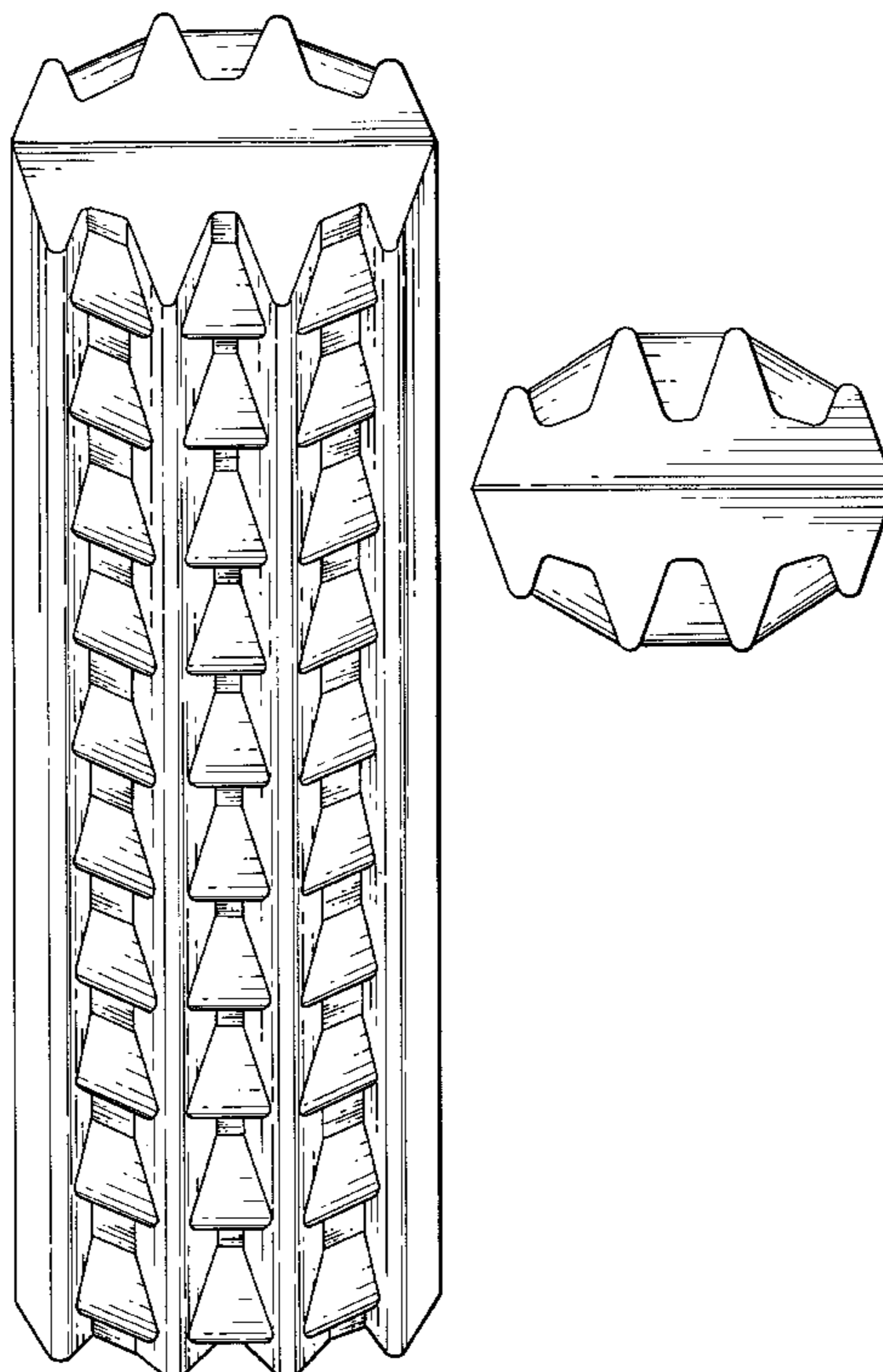

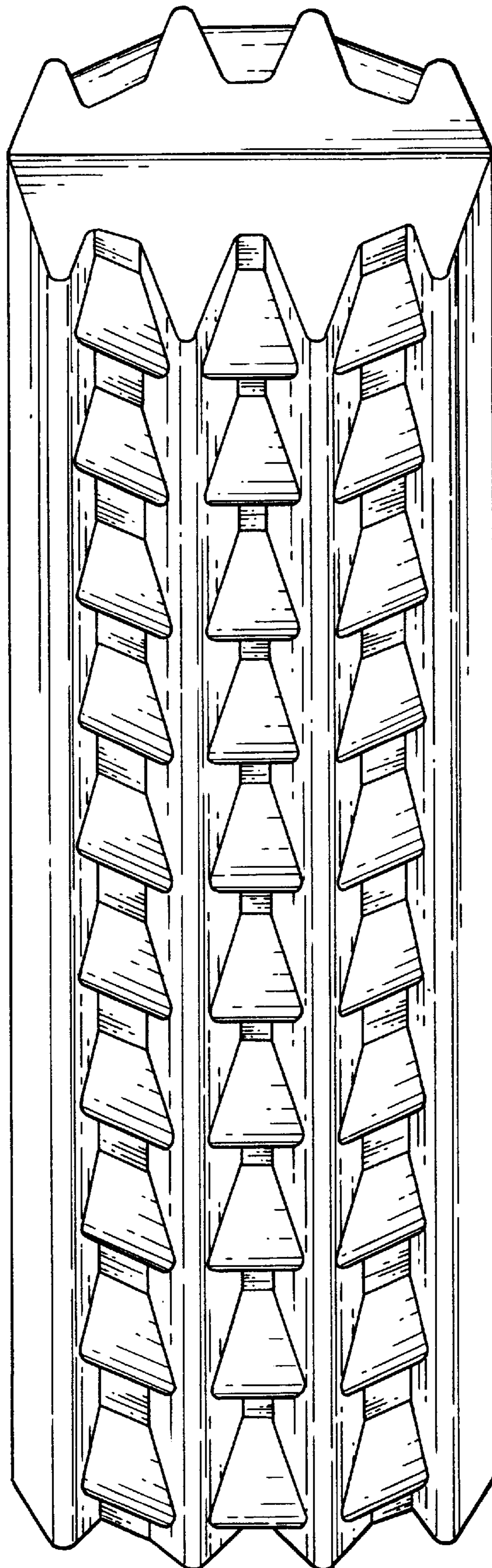

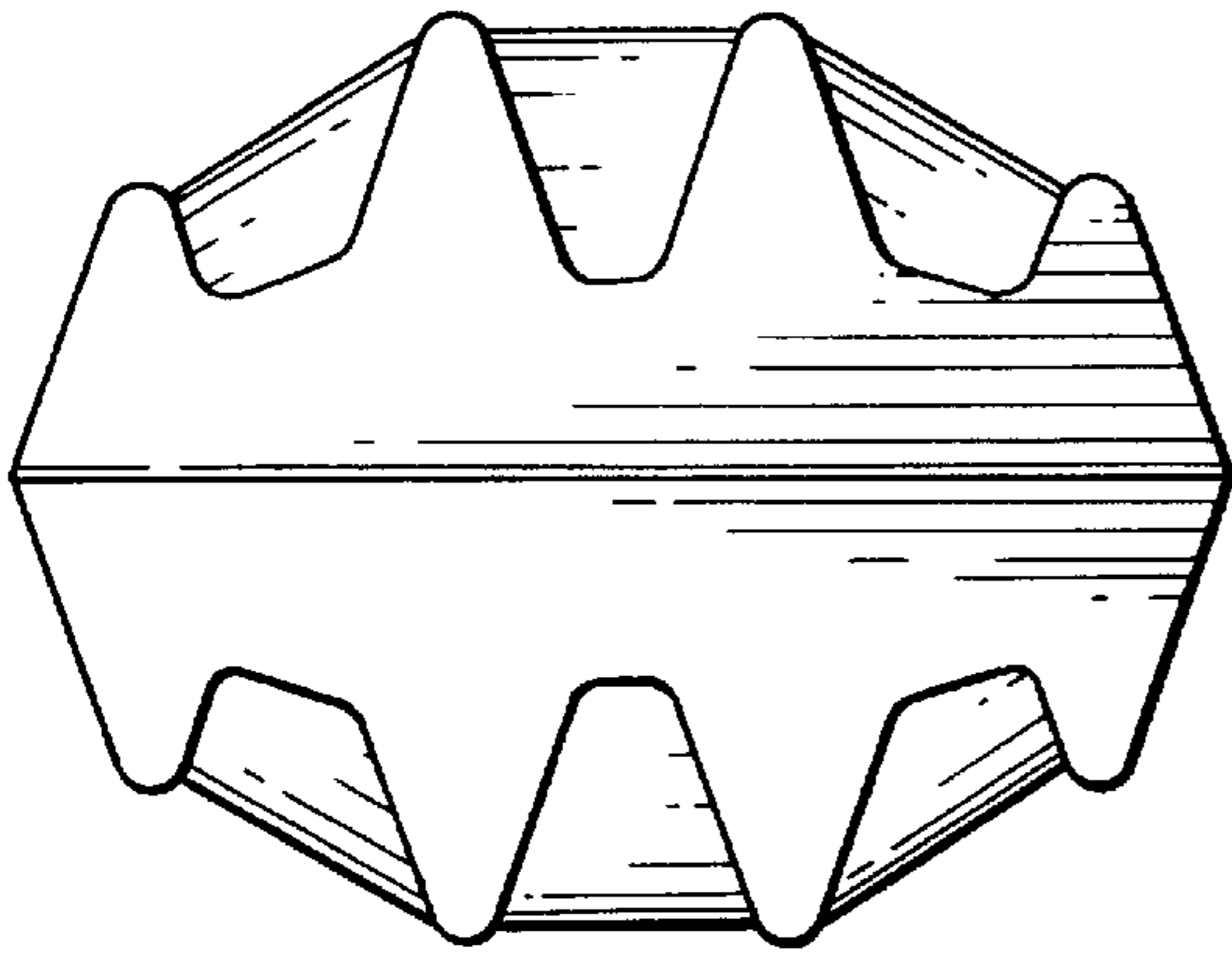

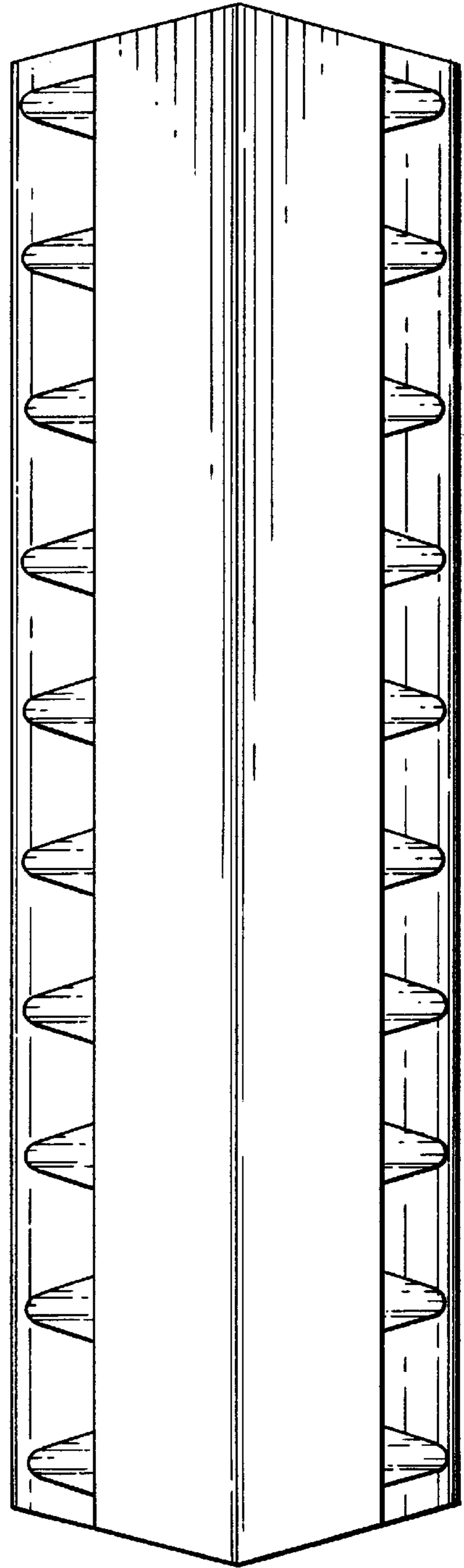
