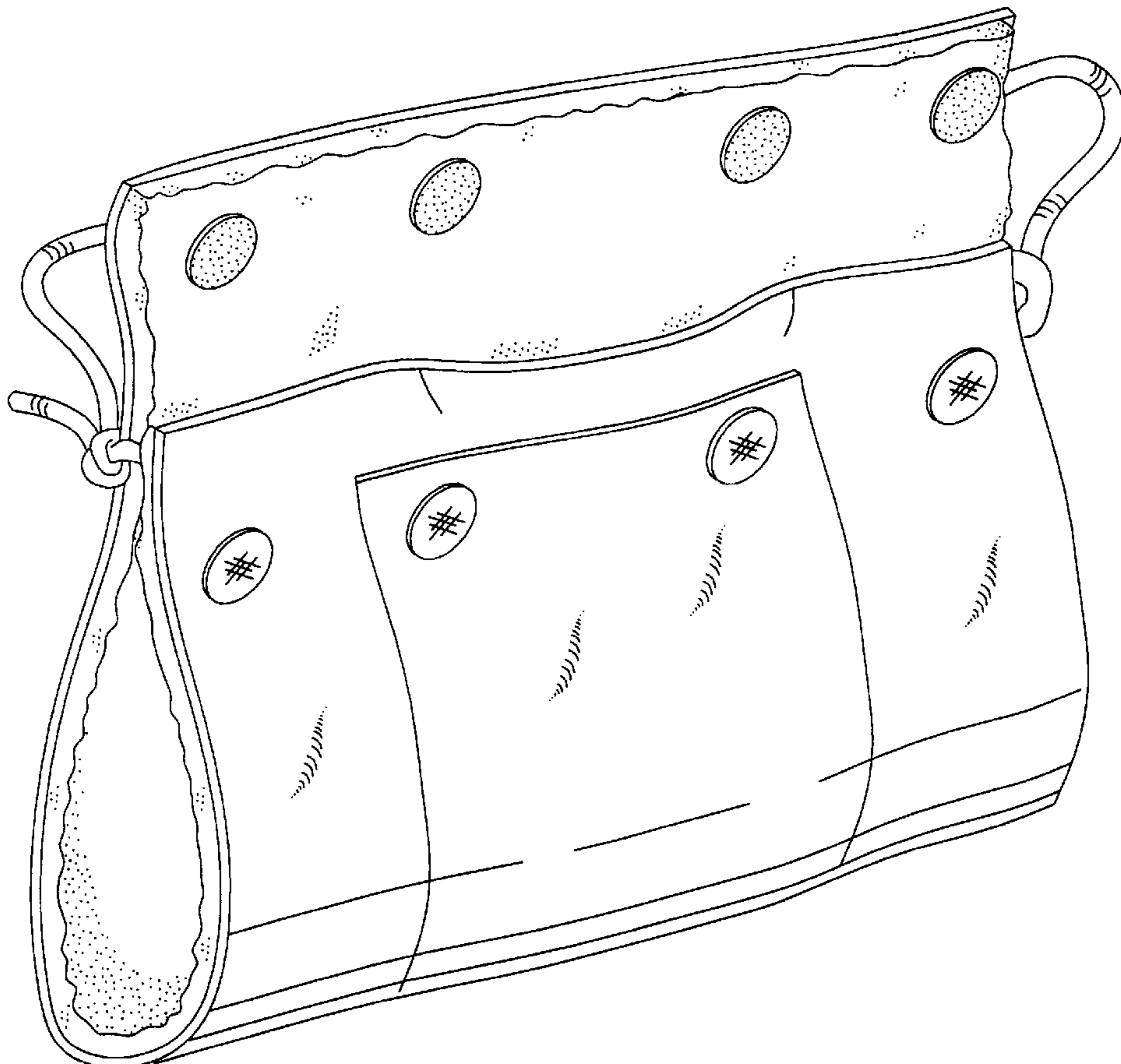
(57) **CLAIM**

The ornamental design for a muff with pouch for handwarming device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a muff with pouch for handwarming device showing my new design;  
 FIG. 2 is a rear elevation view thereof;  
 FIG. 3 is a side elevation view thereof;  
 FIG. 4 is an opposite side elevation view thereof;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a front perspective view showing the top flap in an open position thereof; and,  
 FIG. 8 is a rear perspective view showing the rear flap in an open position.

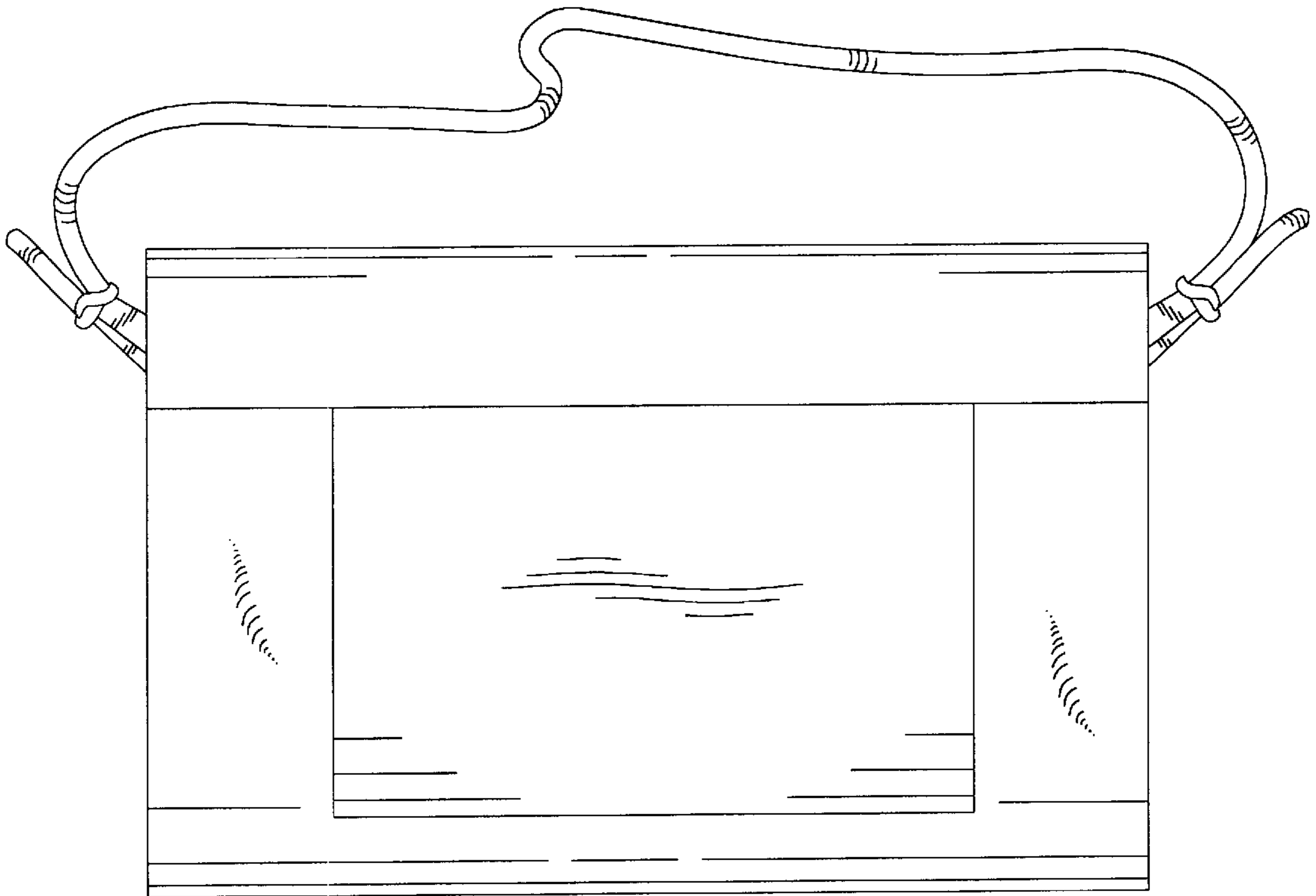

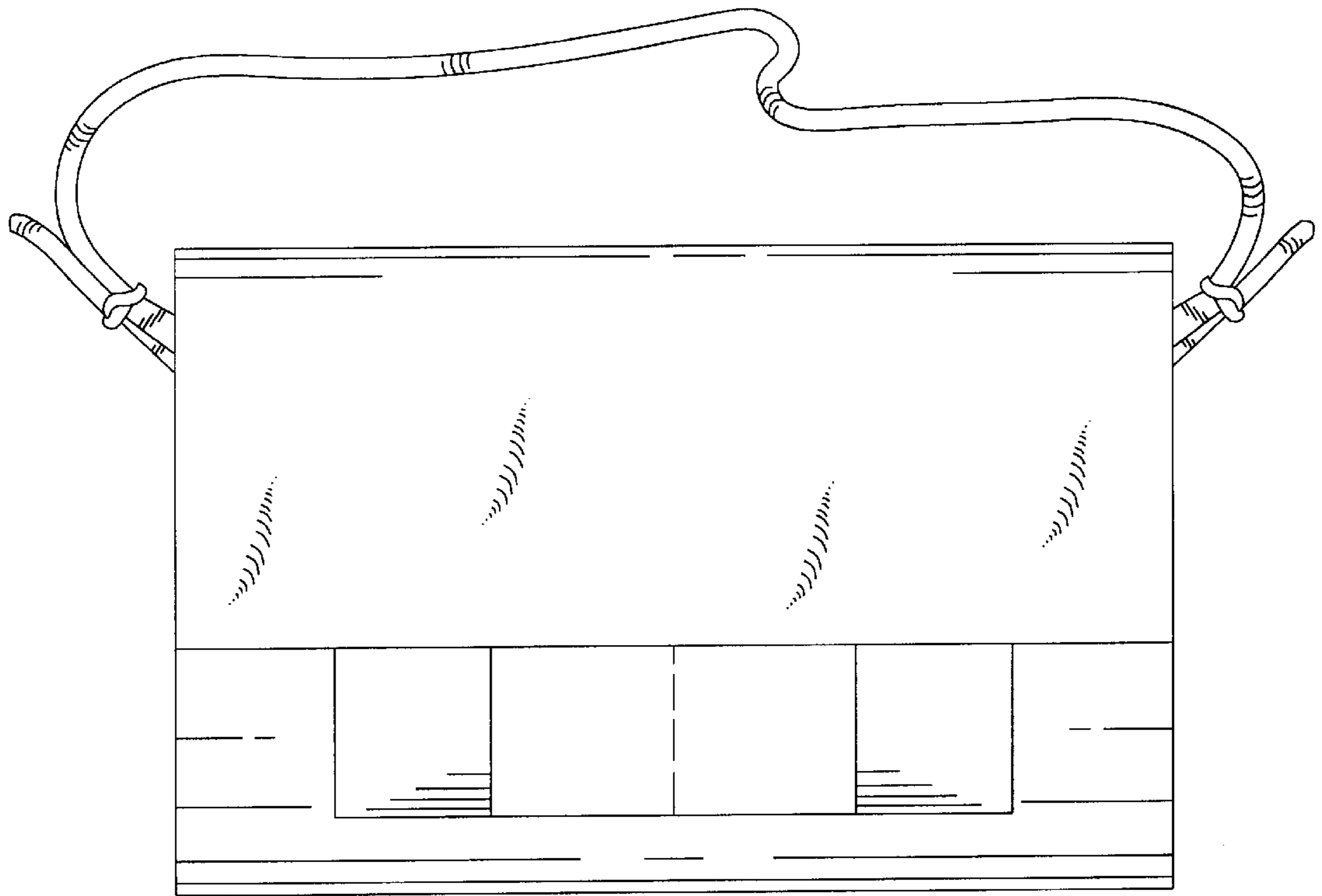
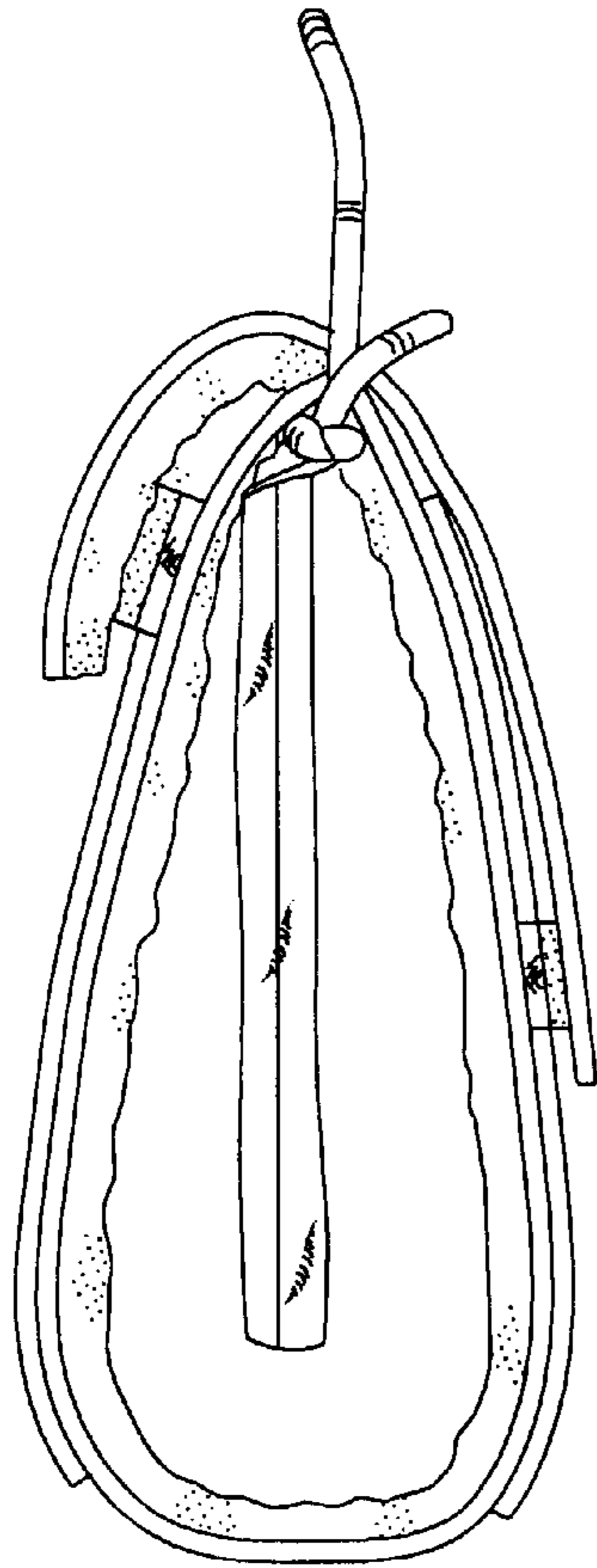
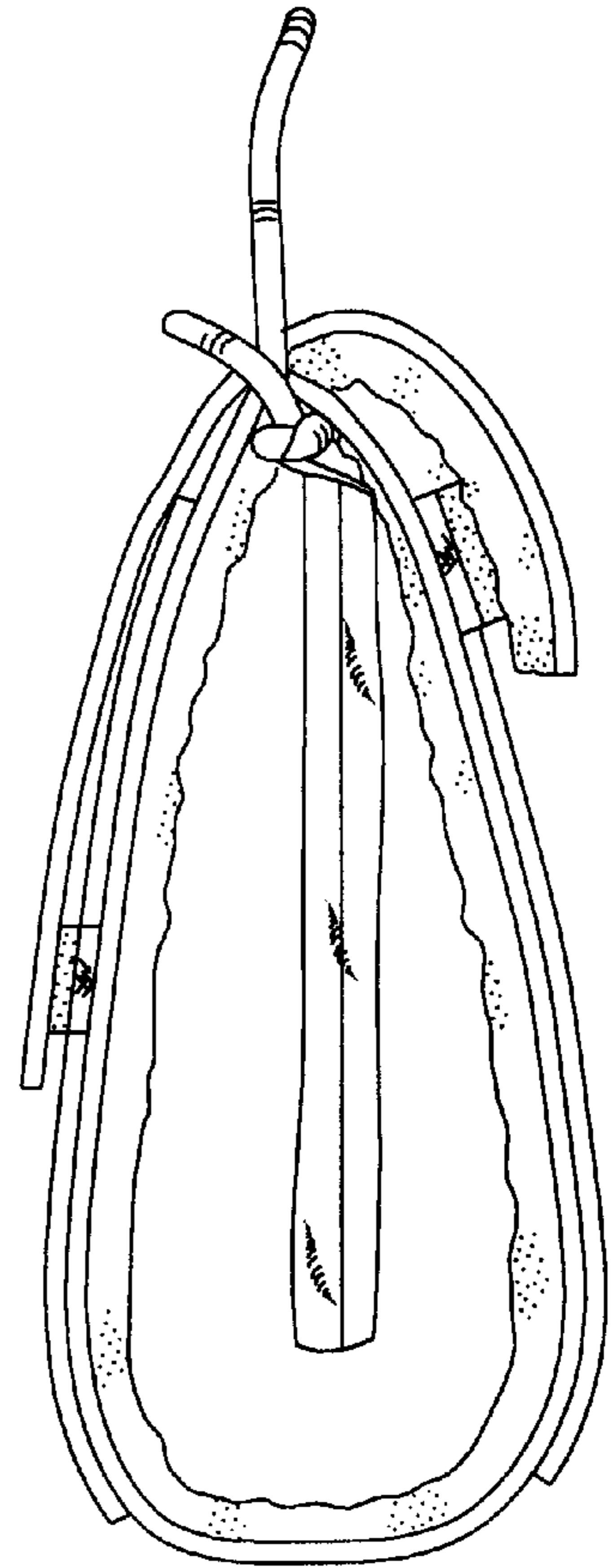


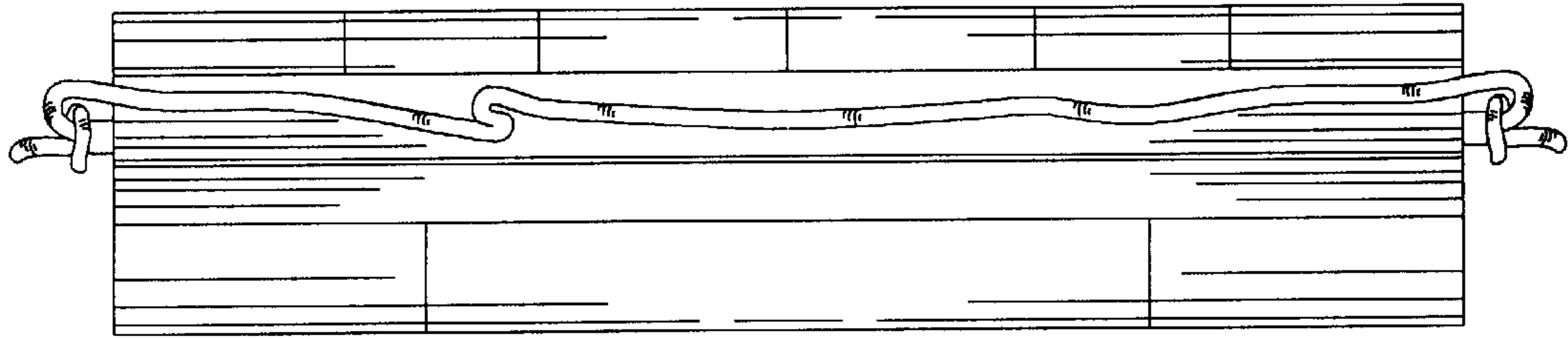

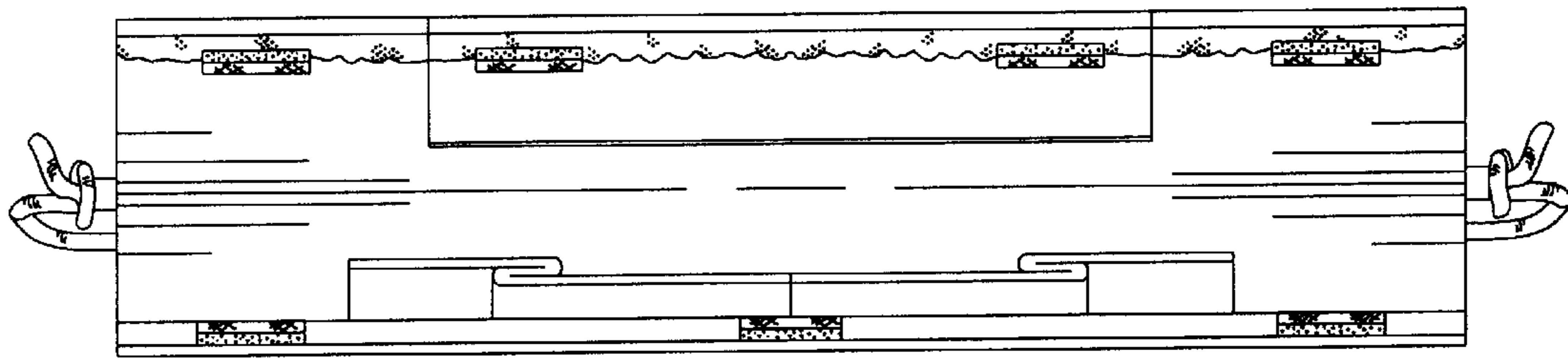

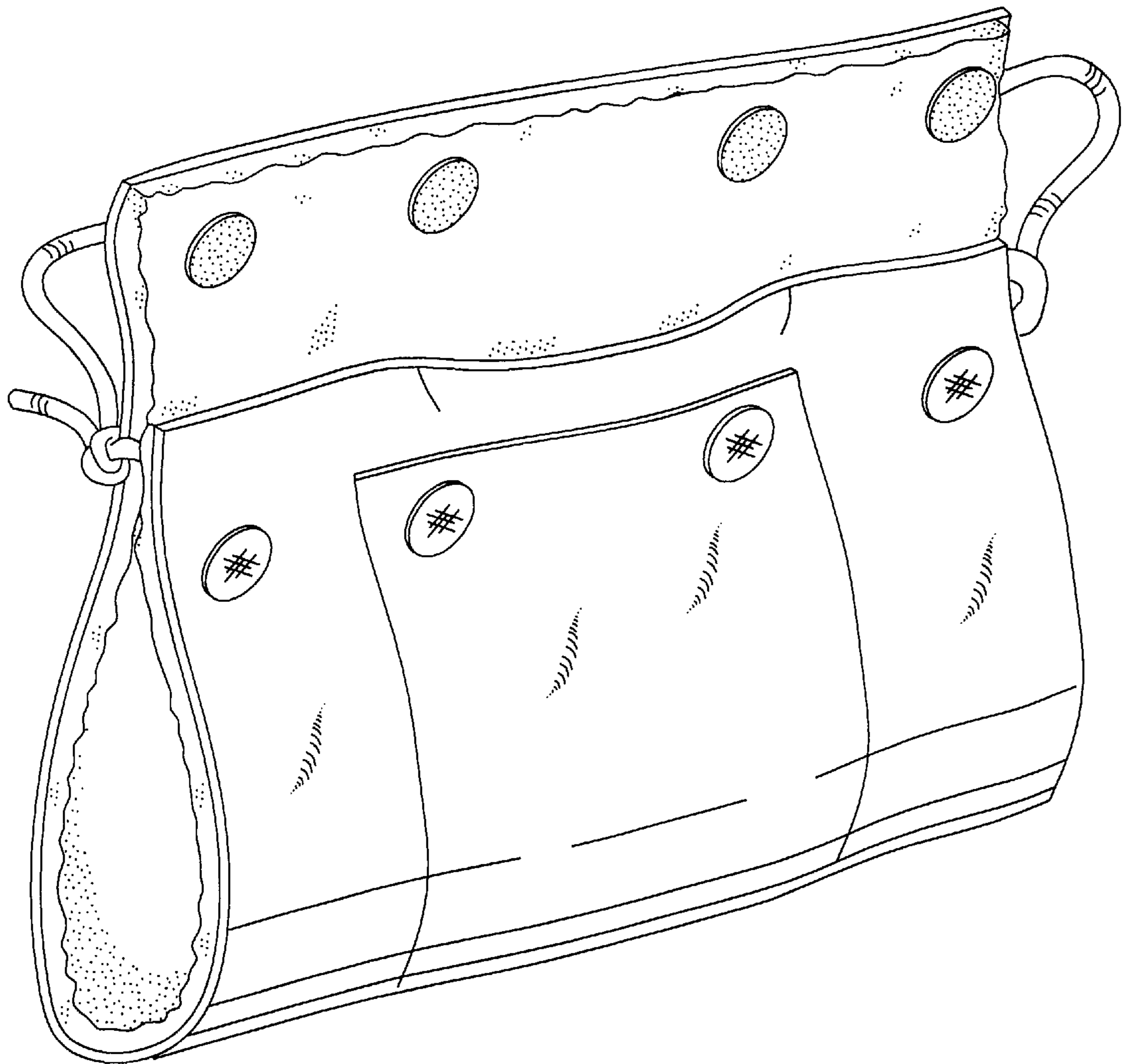

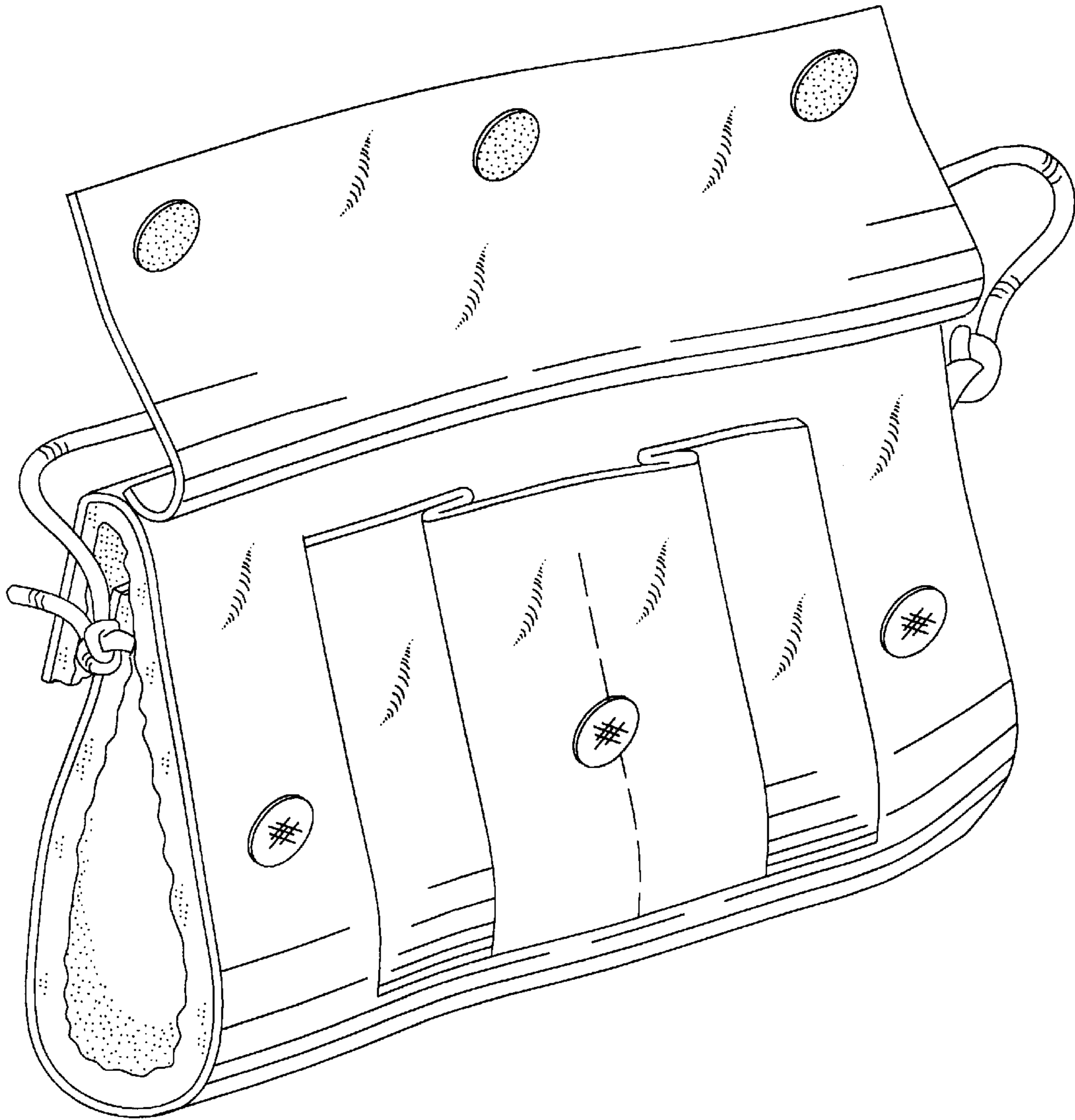
