(57) **CLAIM**

The ornamental design for a transportable and compactible sleep mat and cot cover for children, as shown and described.

DESCRIPTION

FIG. 1 is a left side, top and front perspective view of the transportable and compactible sleep mat and cot cover for children showing my new design and showing the sleep mat in its compacted and closed state;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 10 is a top plan view thereof;

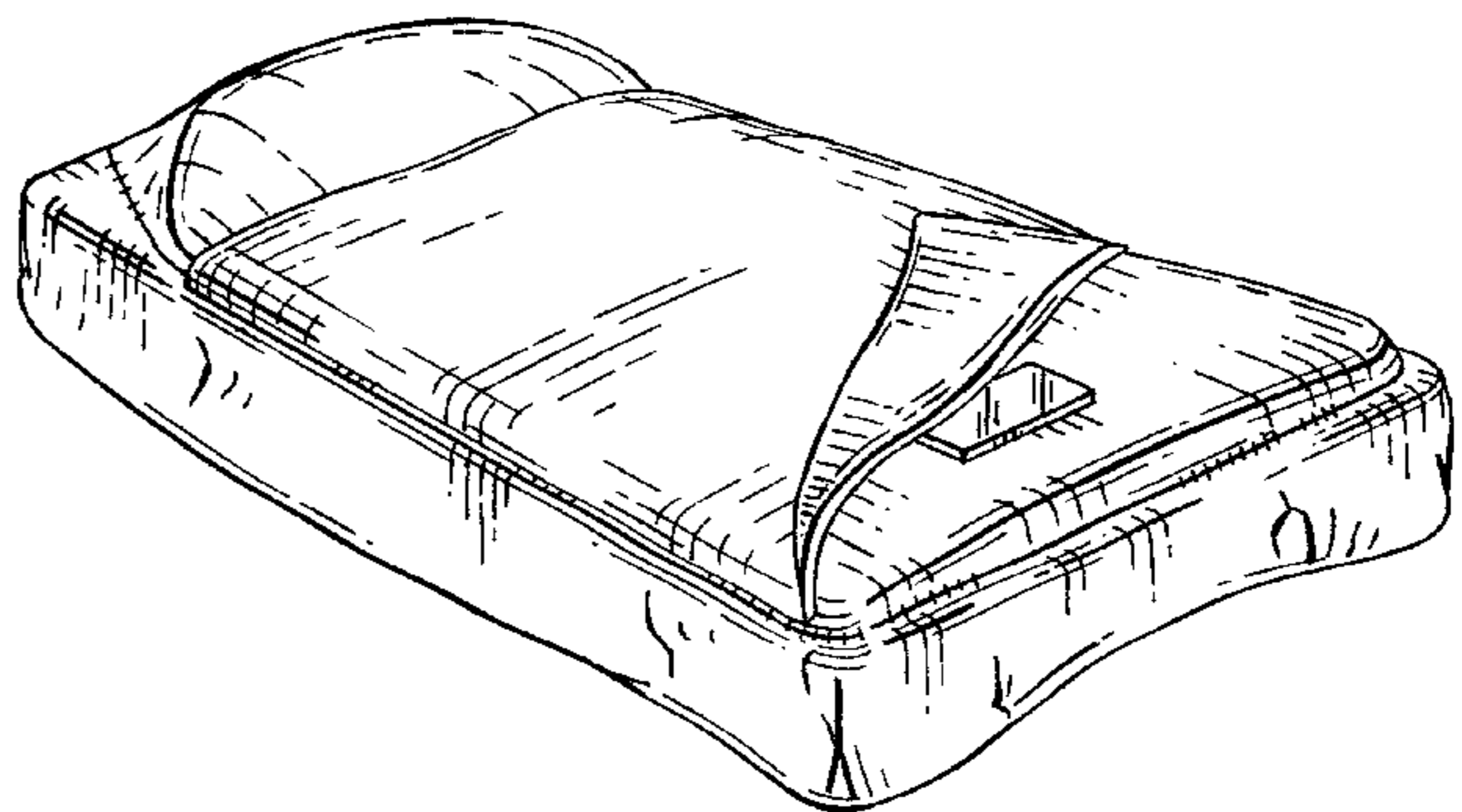
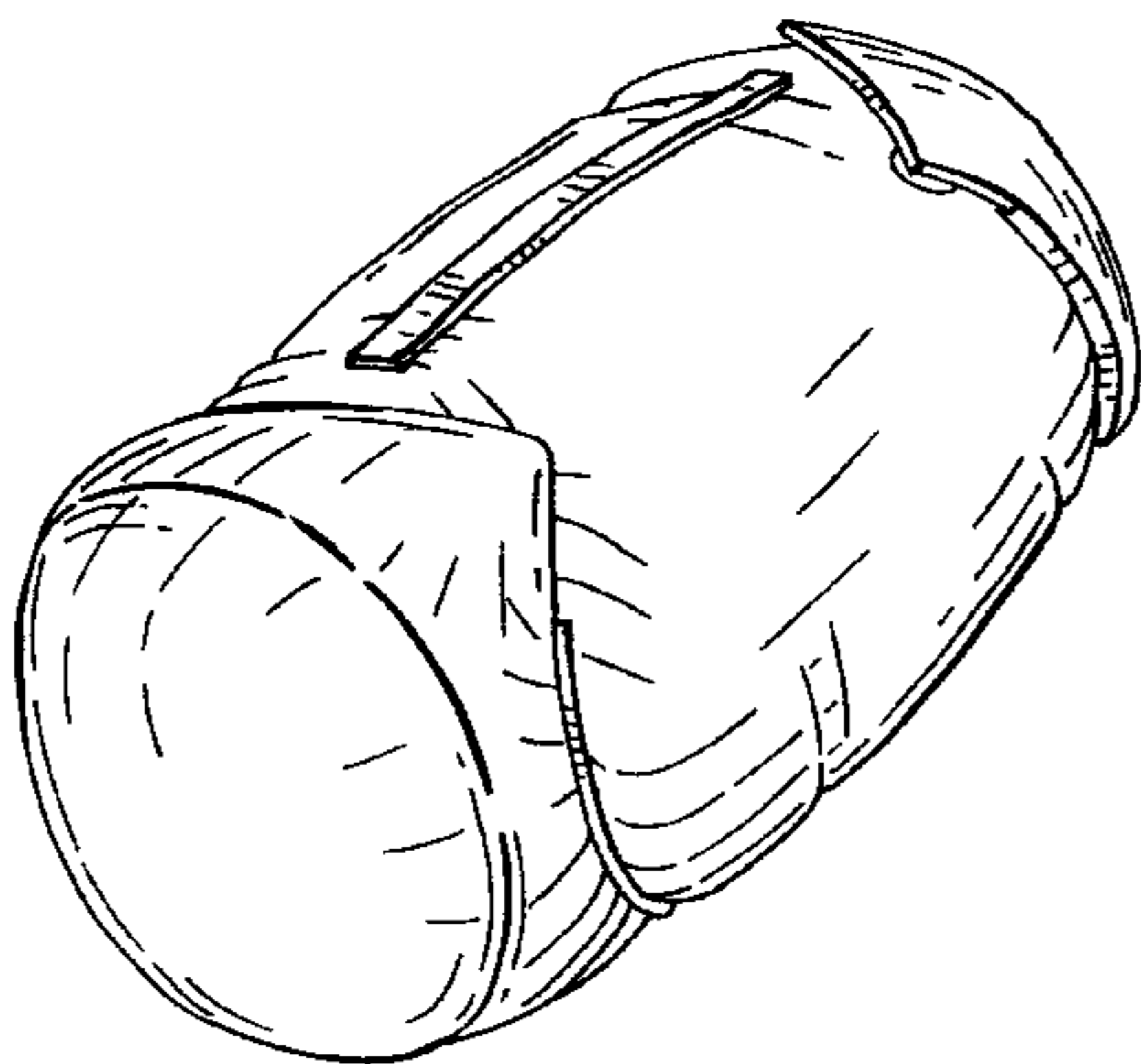
FIG. 11 is a right side elevational view thereof;

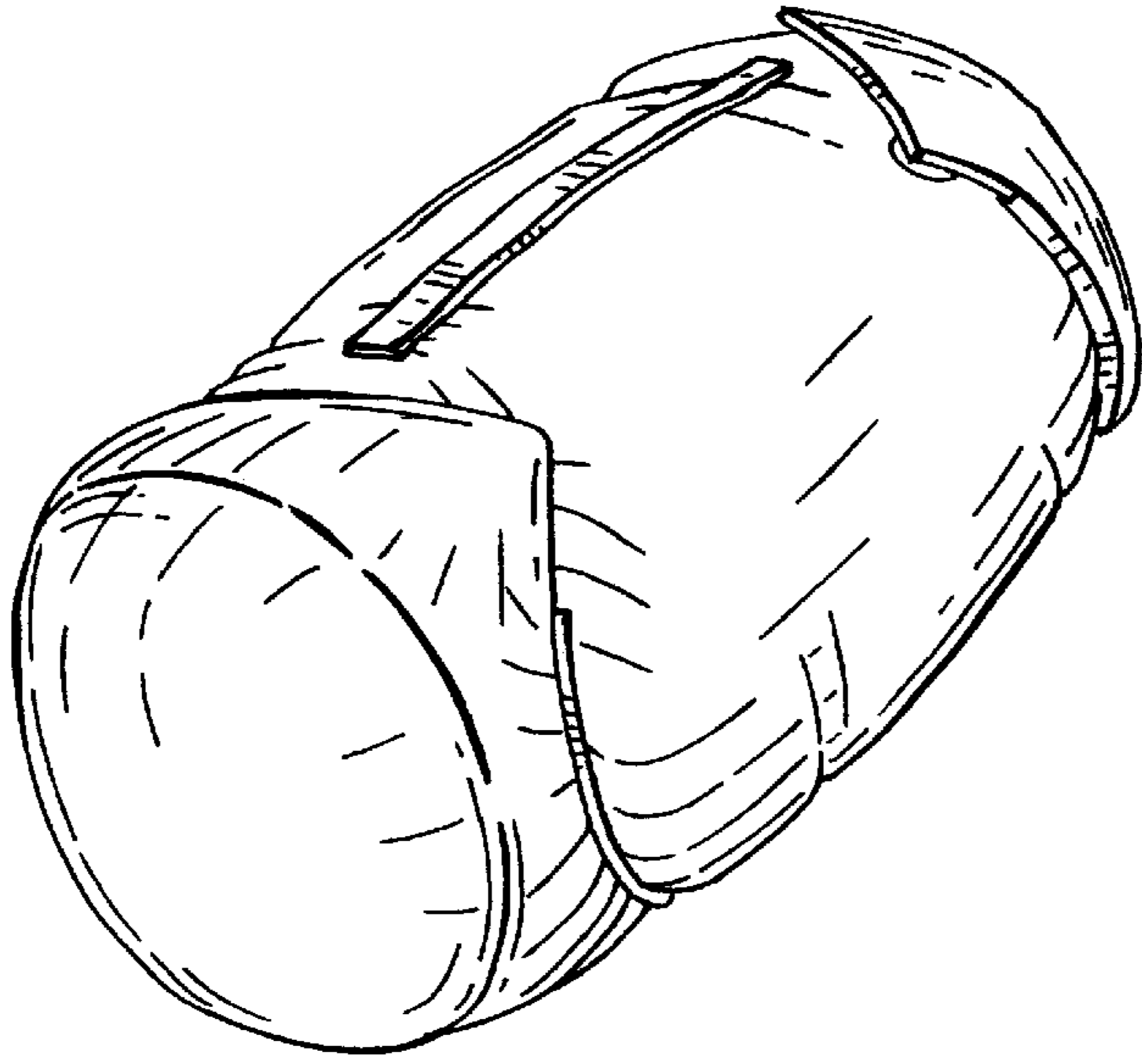

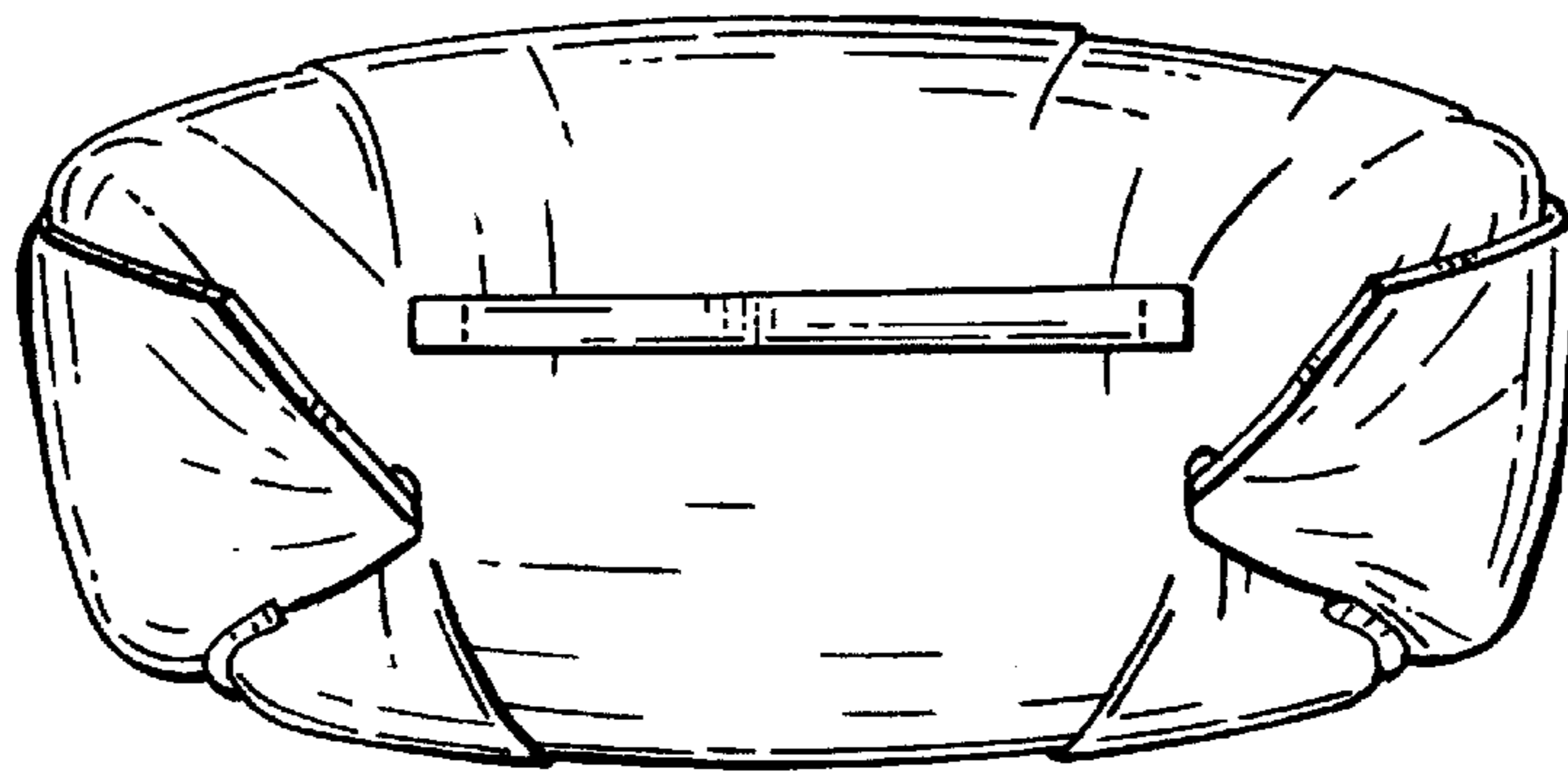

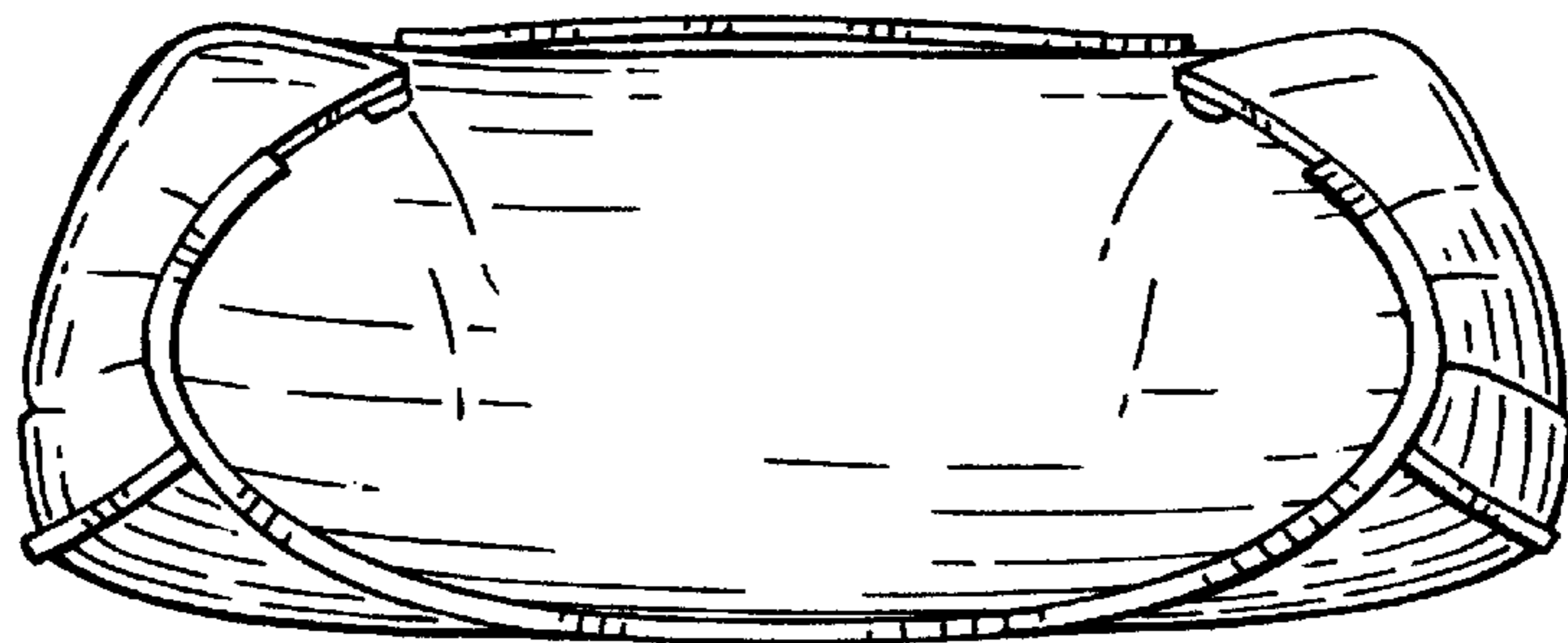

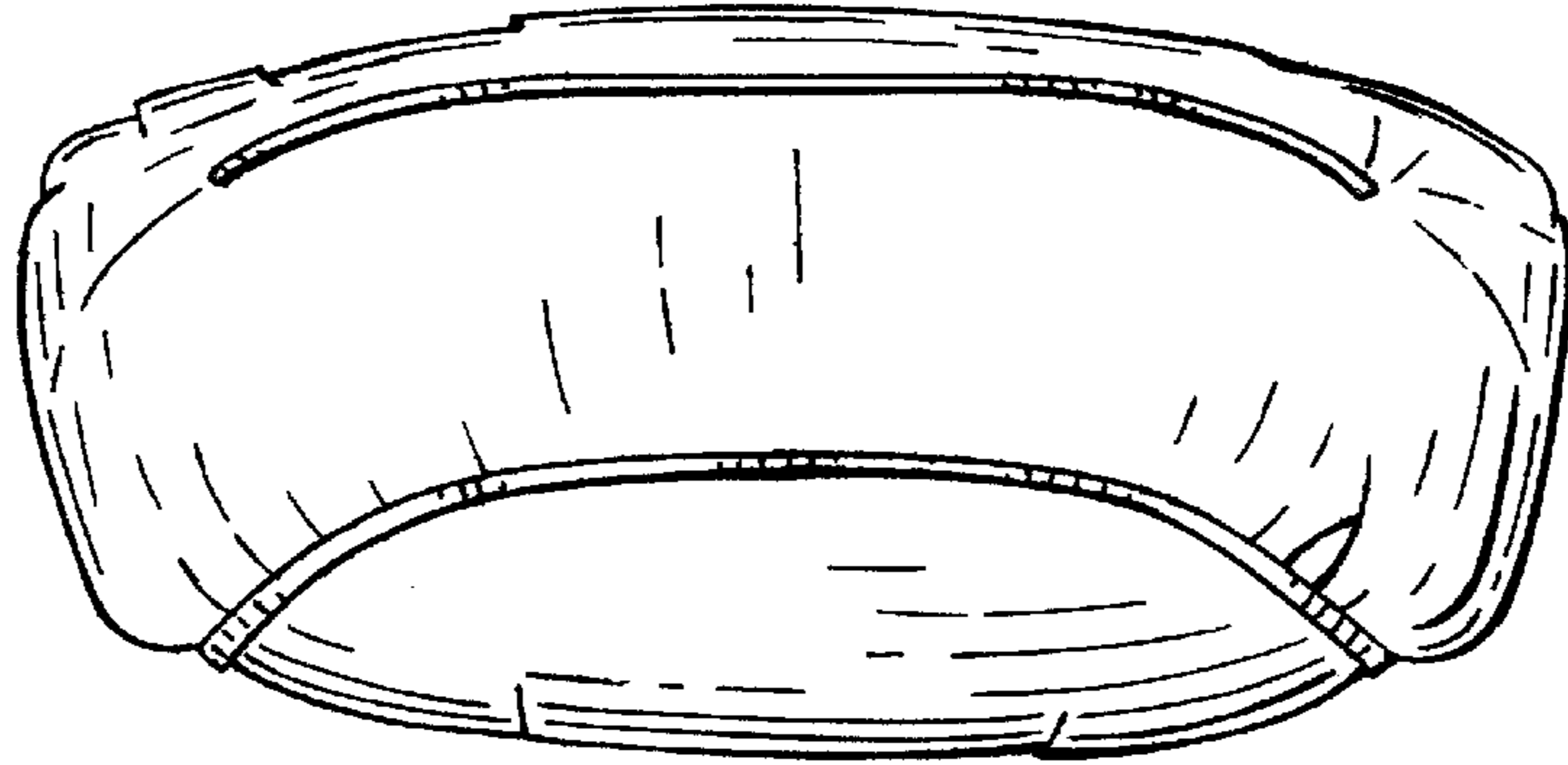

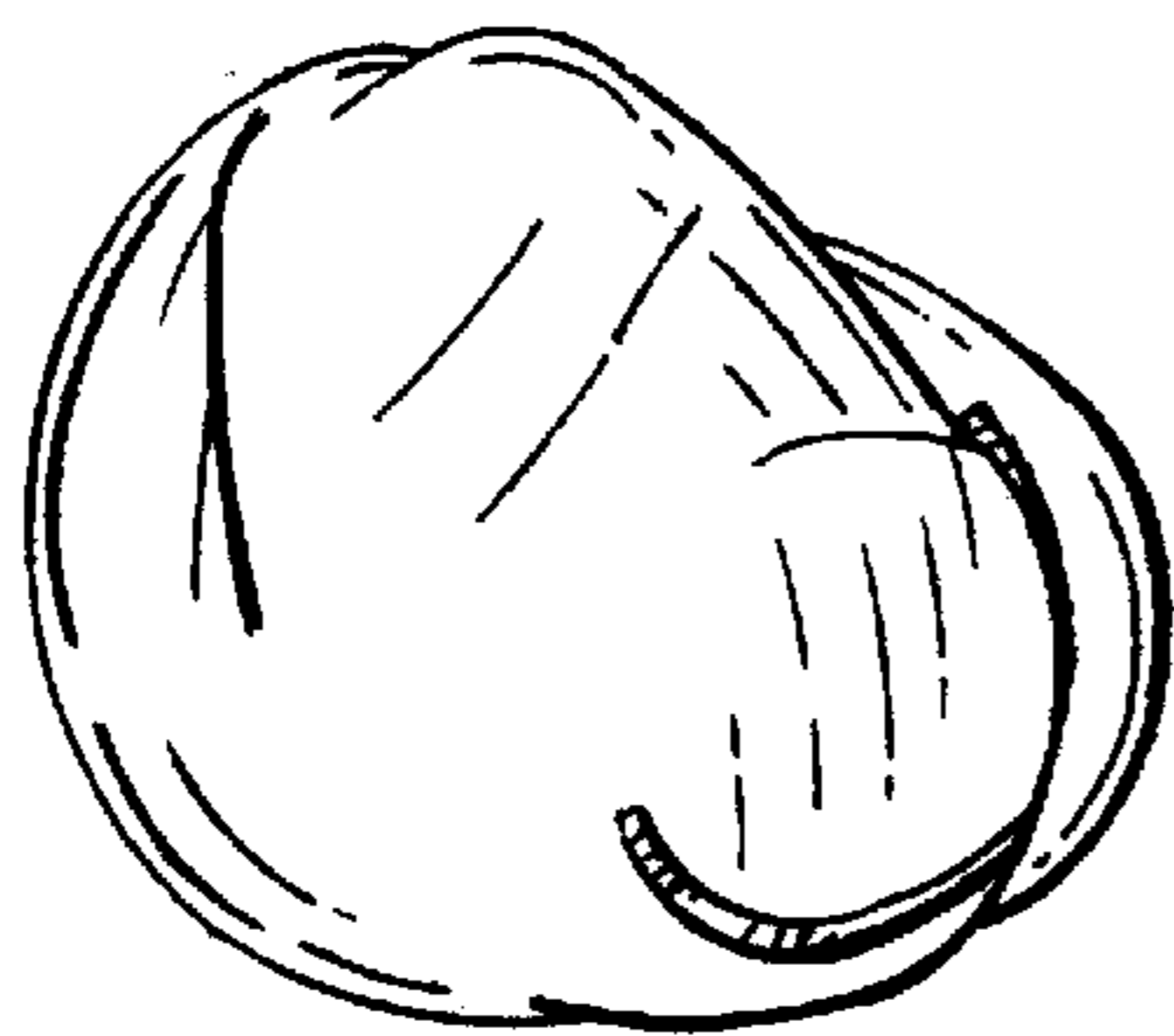
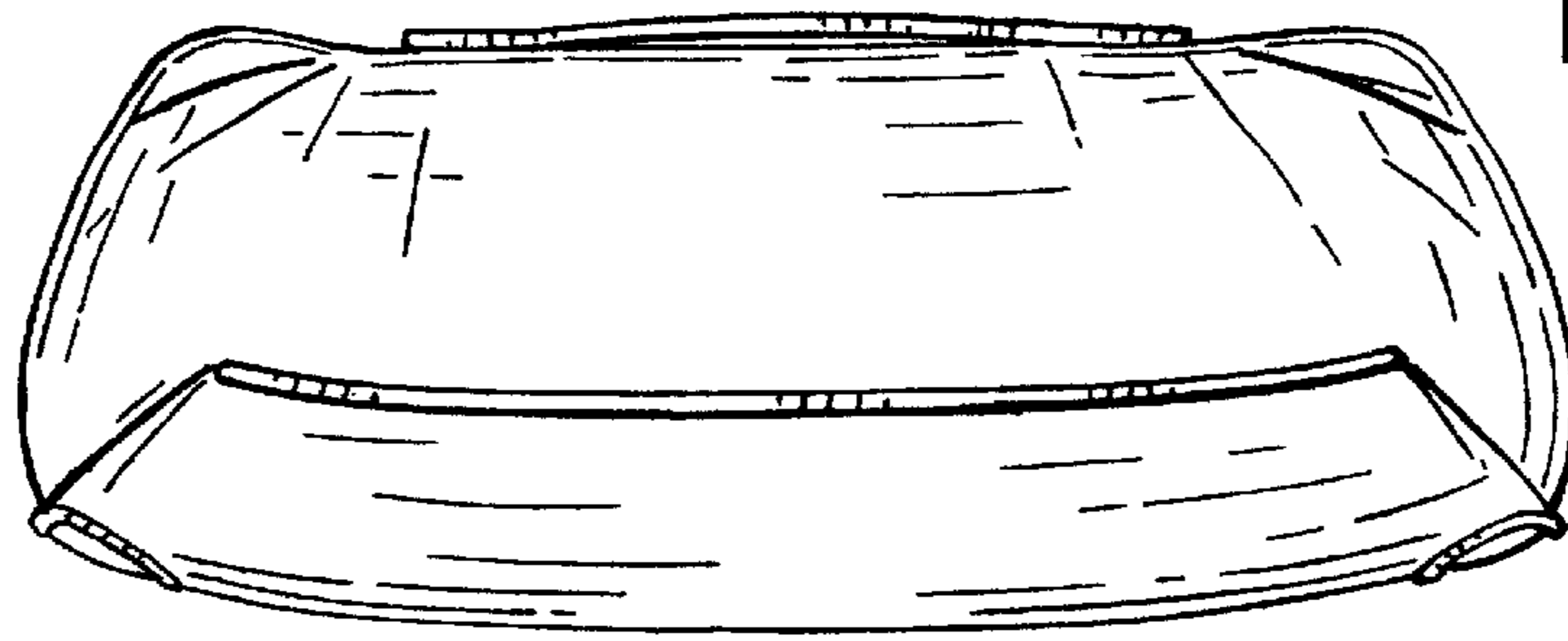

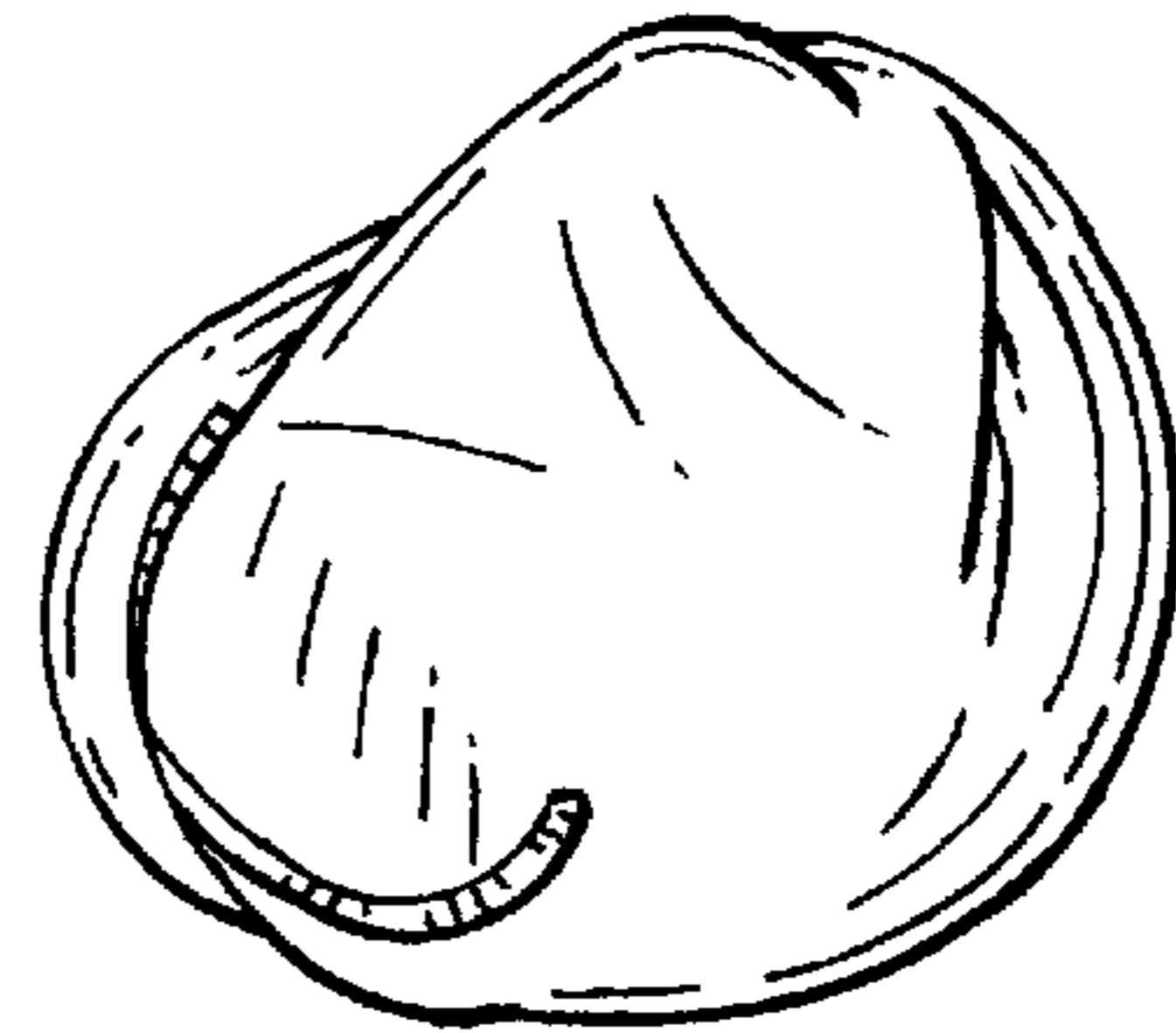

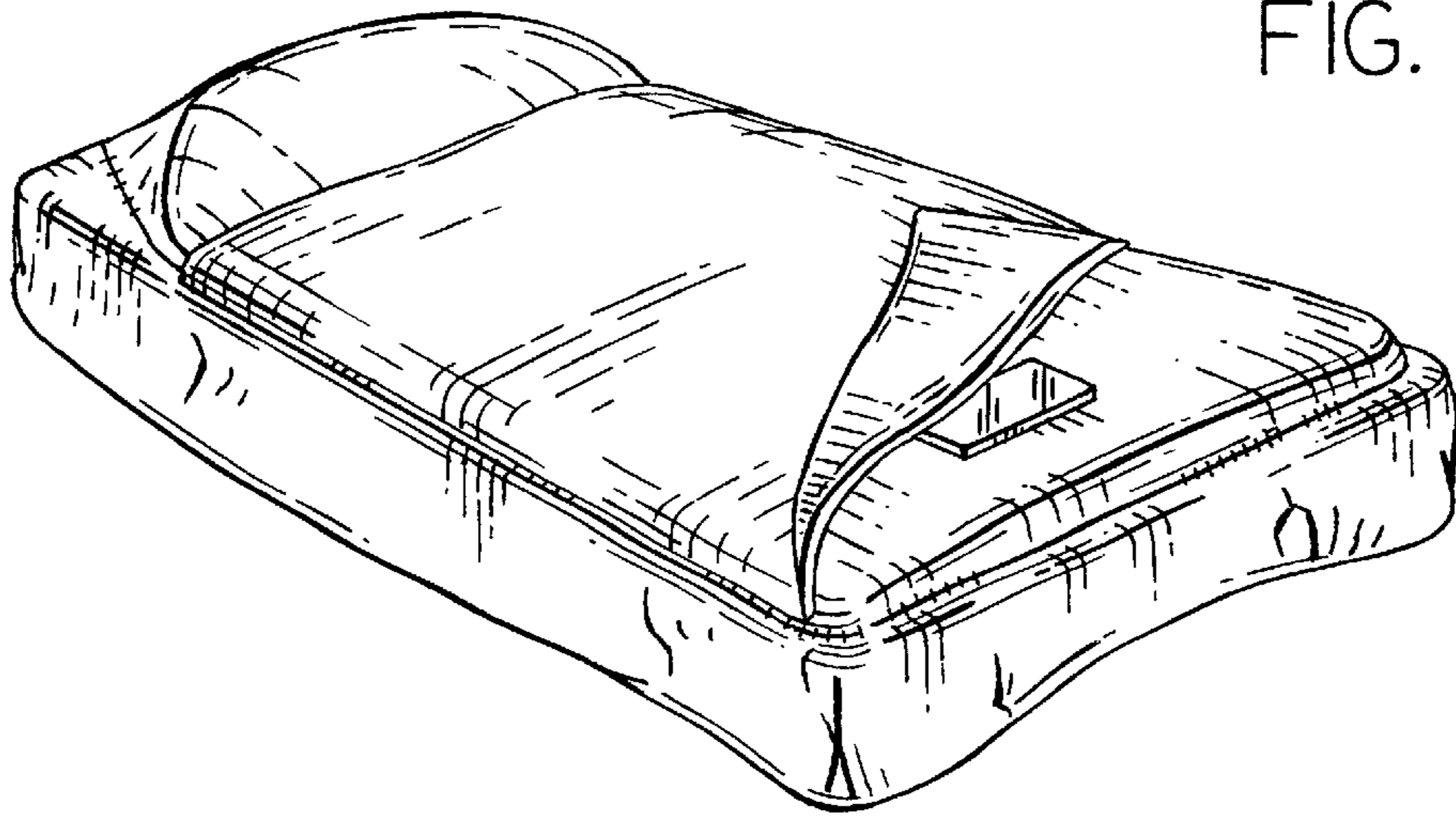

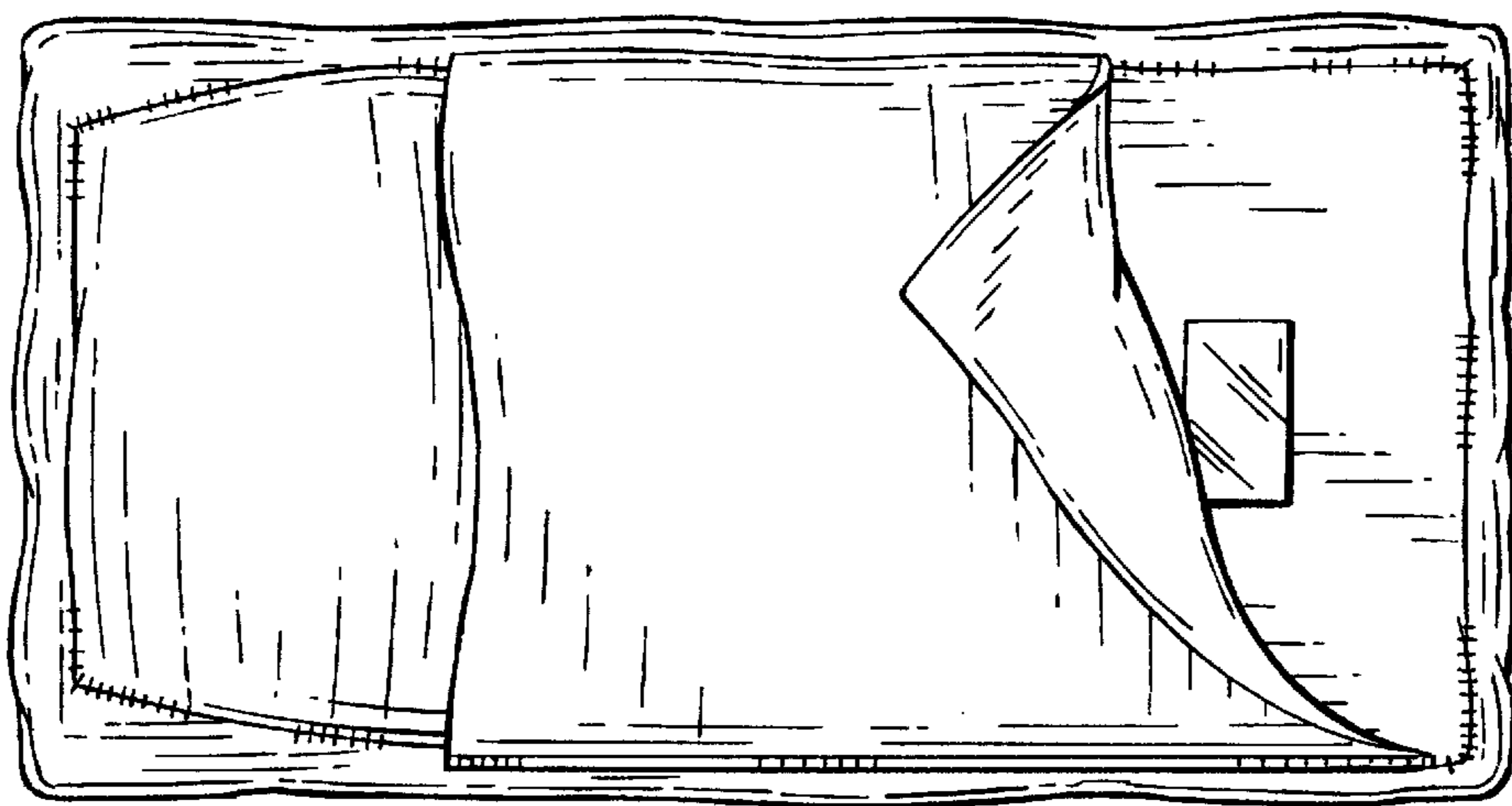
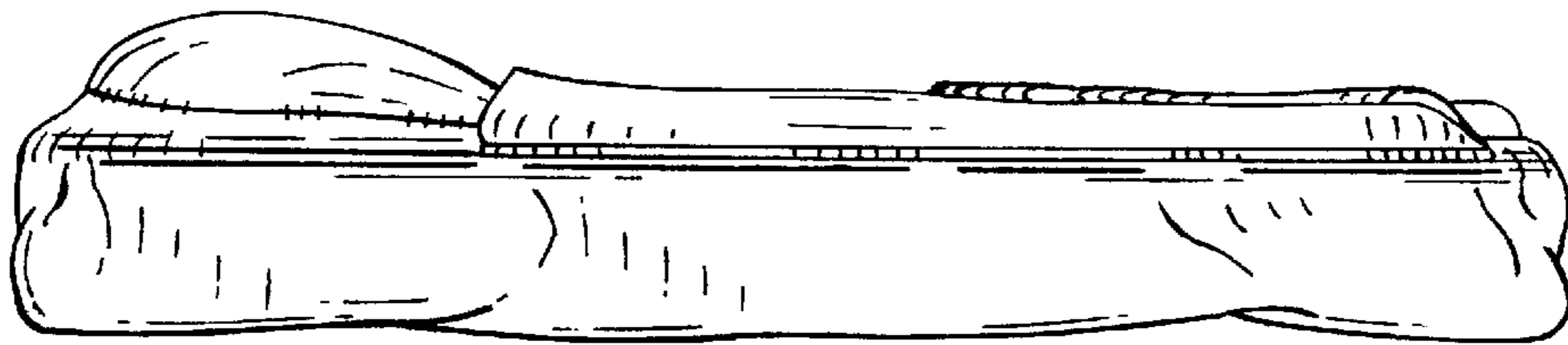

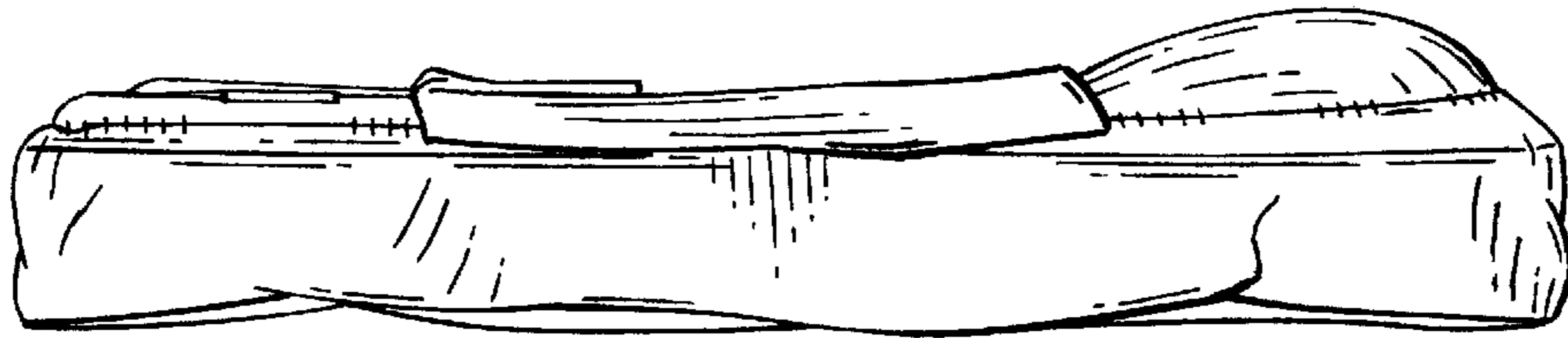

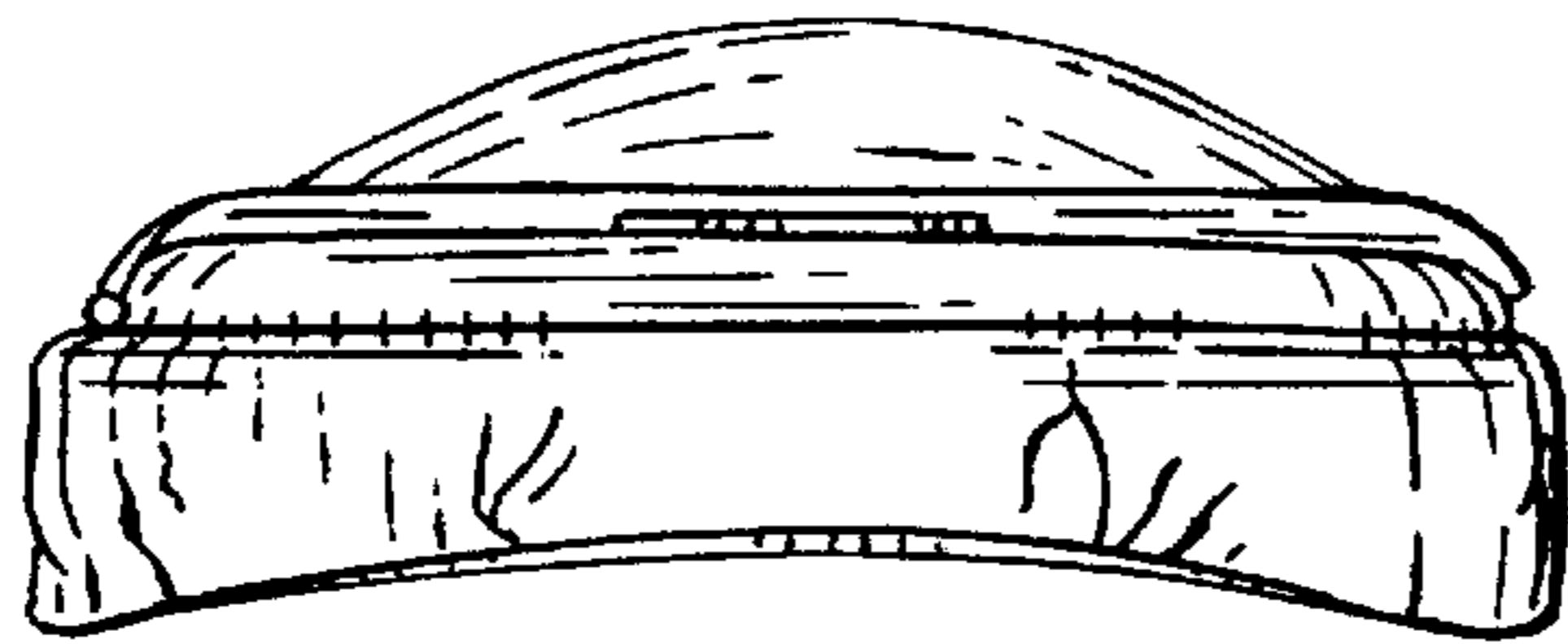
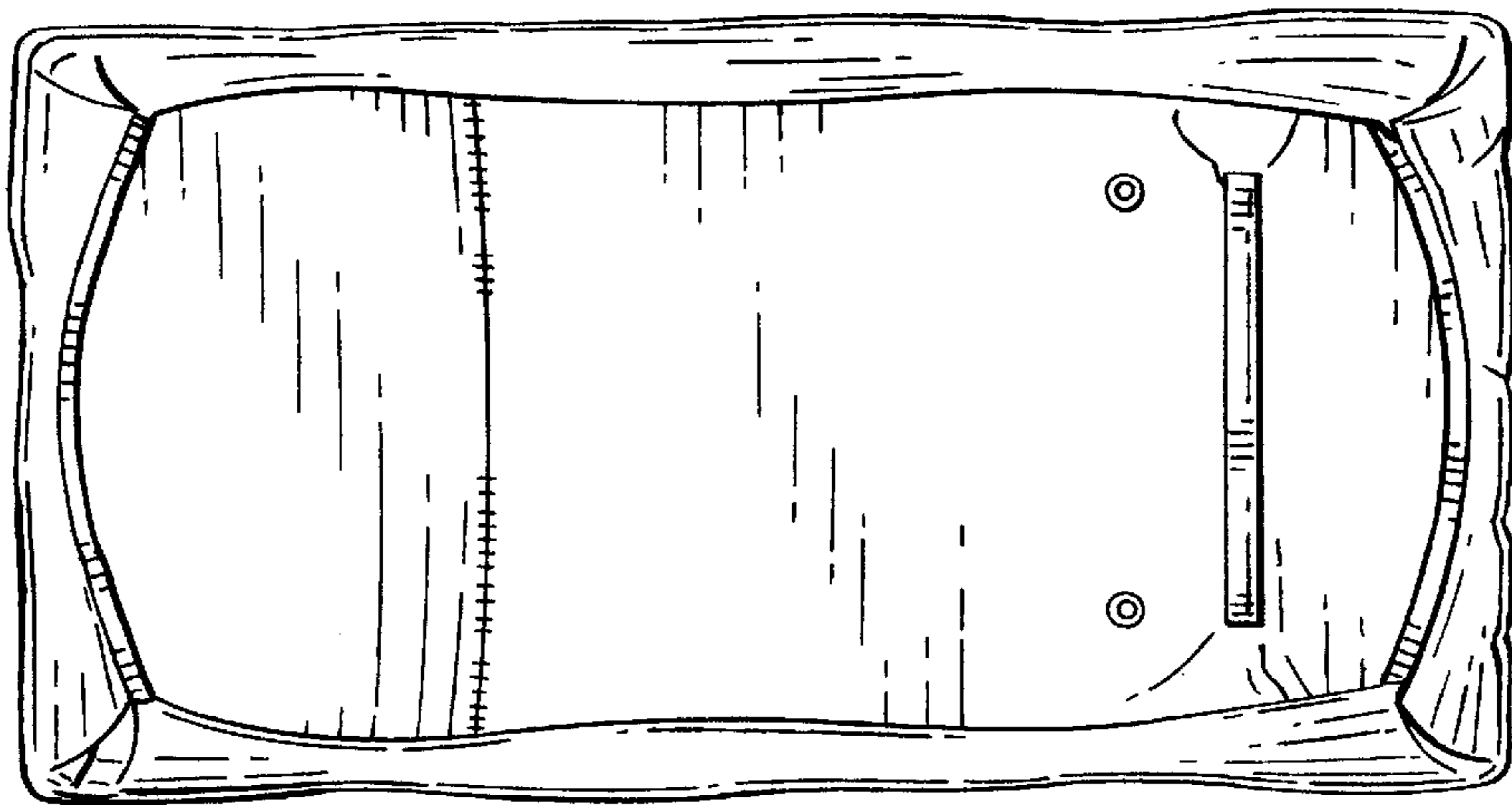

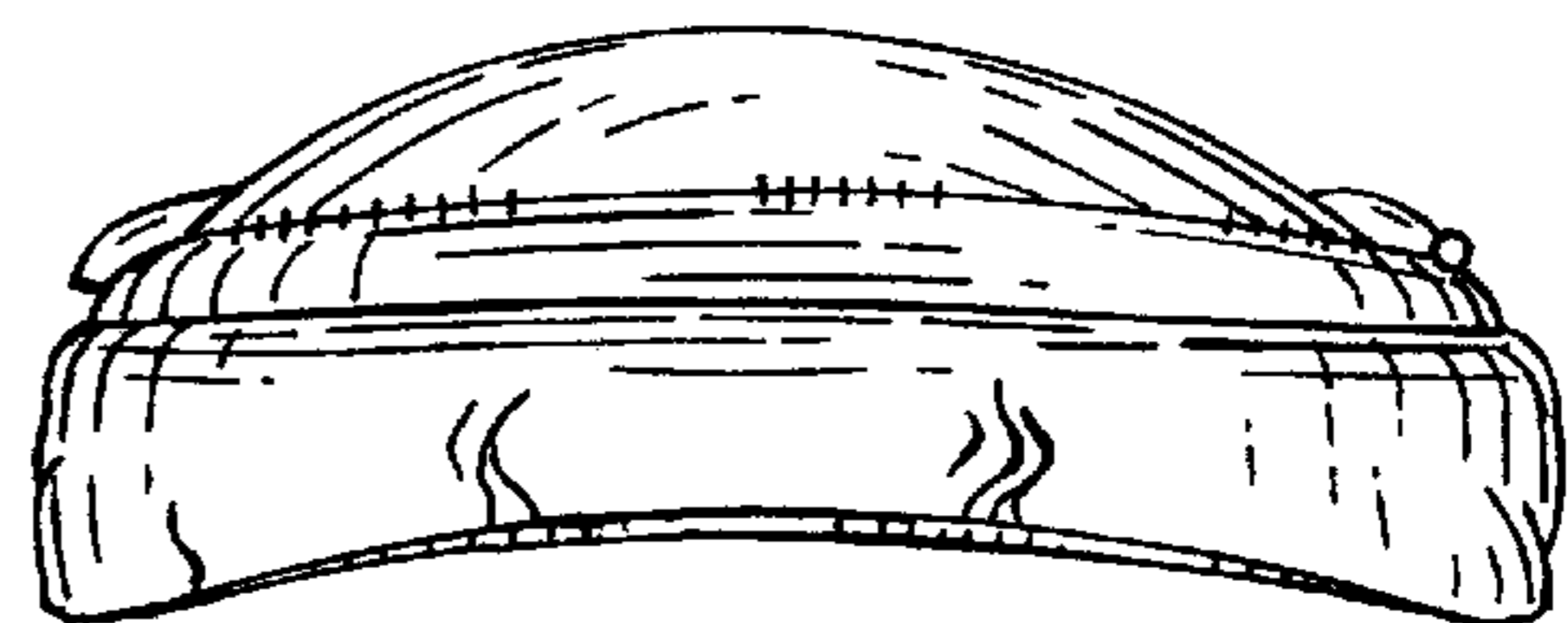
