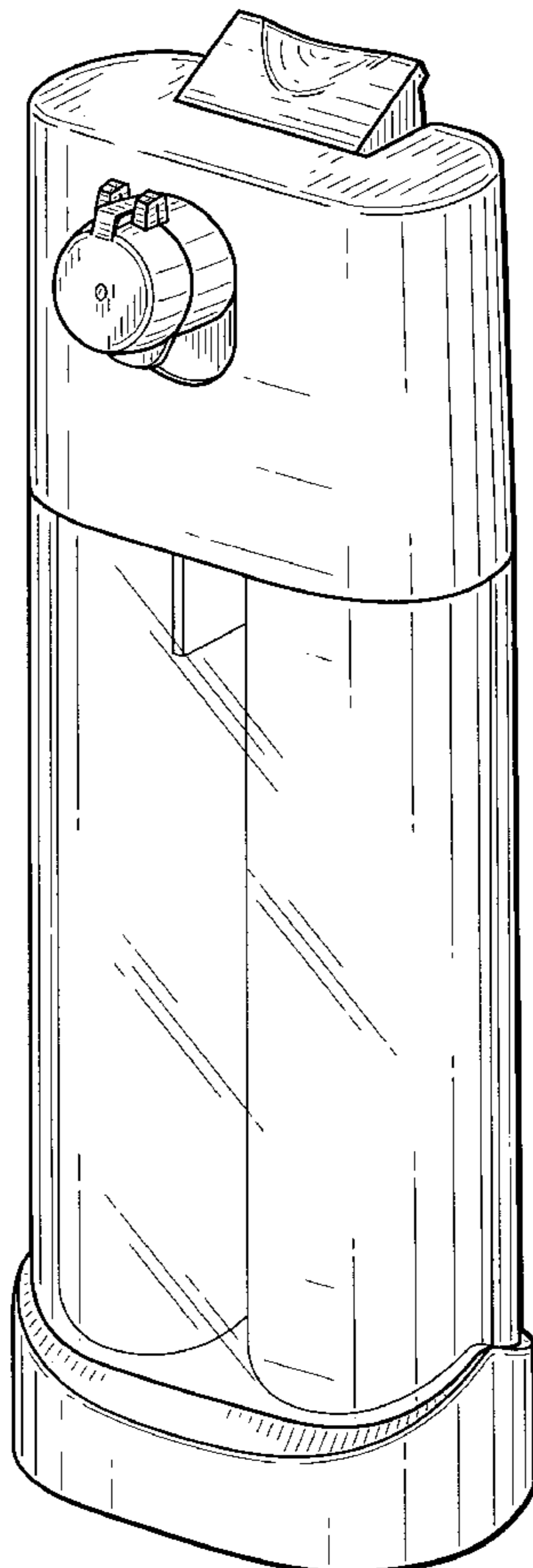
(57) **CLAIM**

The ornamental design for a dispensing container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a dispensing container, showing the top, right side and front of our new design; FIG. 2 is a front view of the dispensing container; FIG. 3 is a back view of the dispensing container; FIG. 4 is a left side view of the dispensing container, the right side being a mirror image thereof; and, FIG. 5 is a top view of the dispensing container.

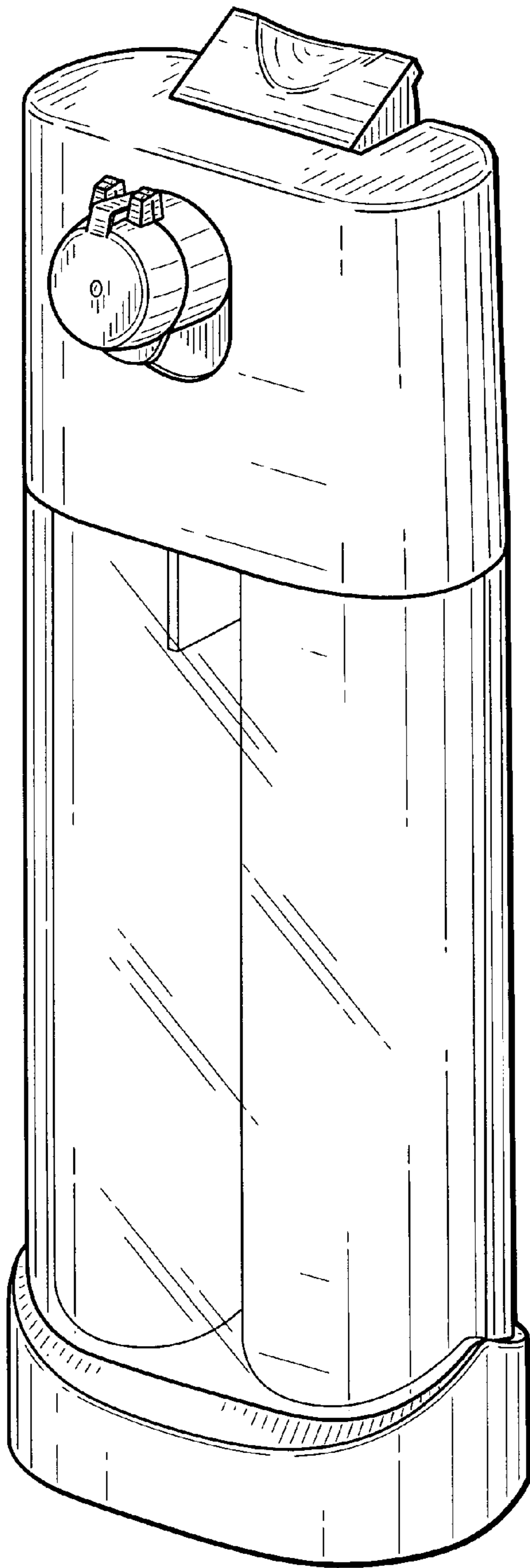

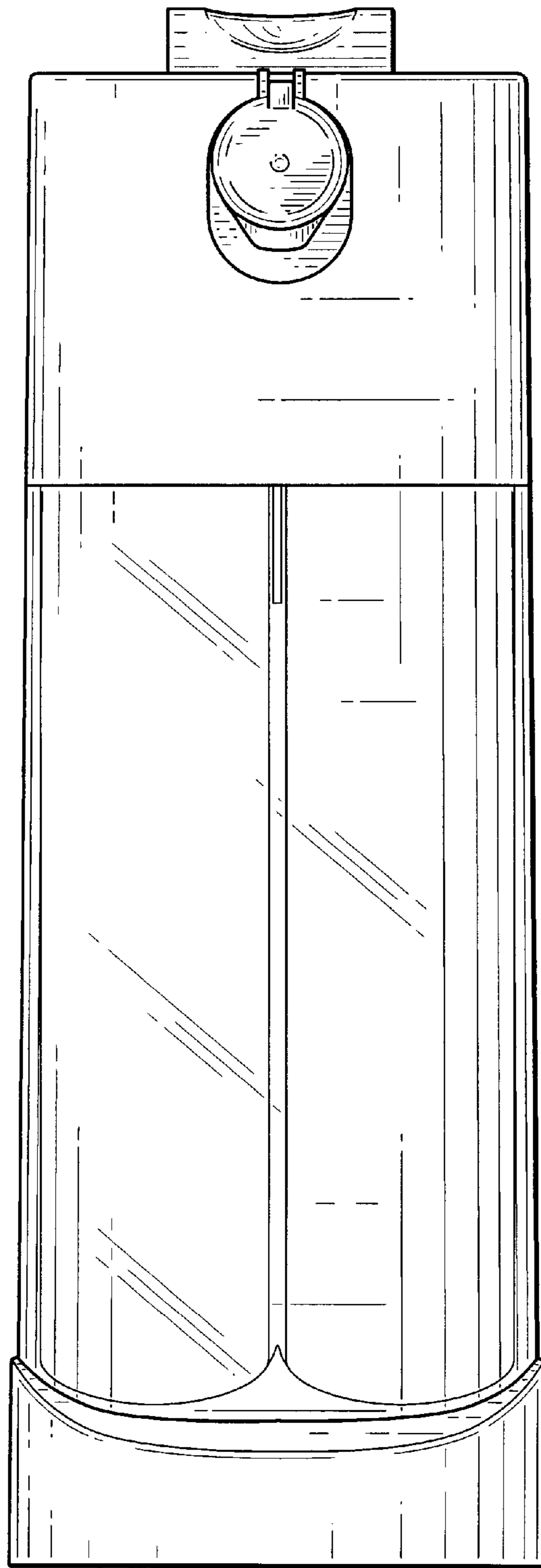

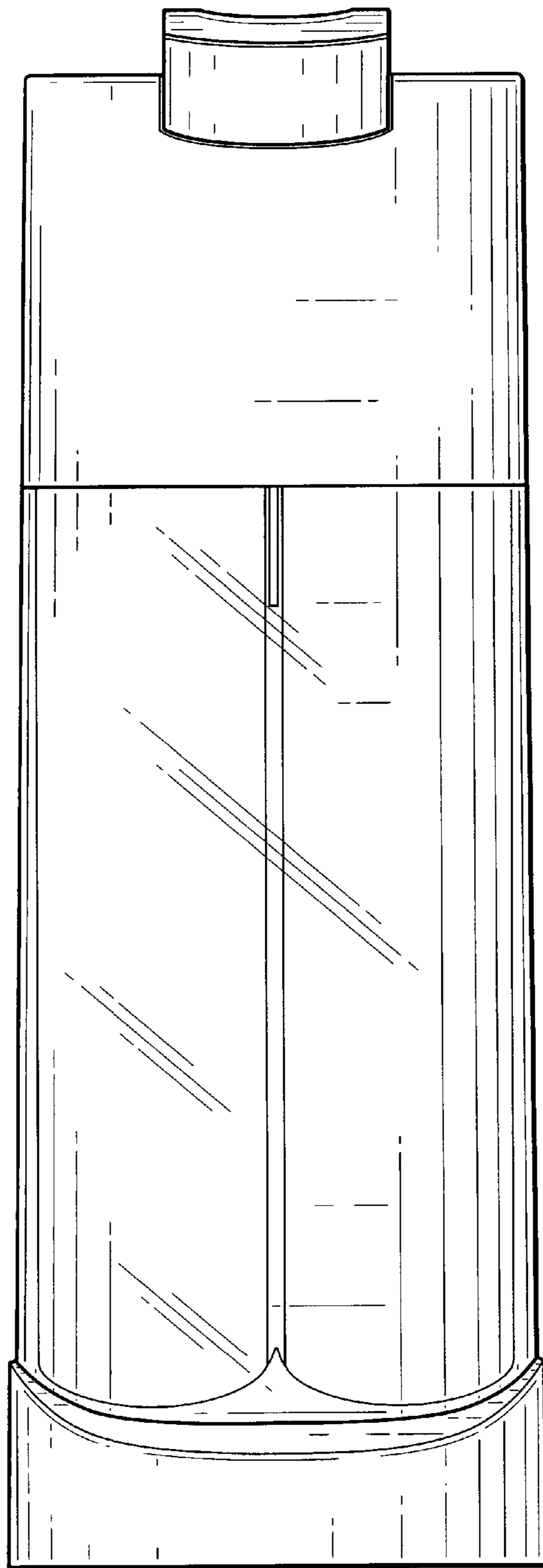

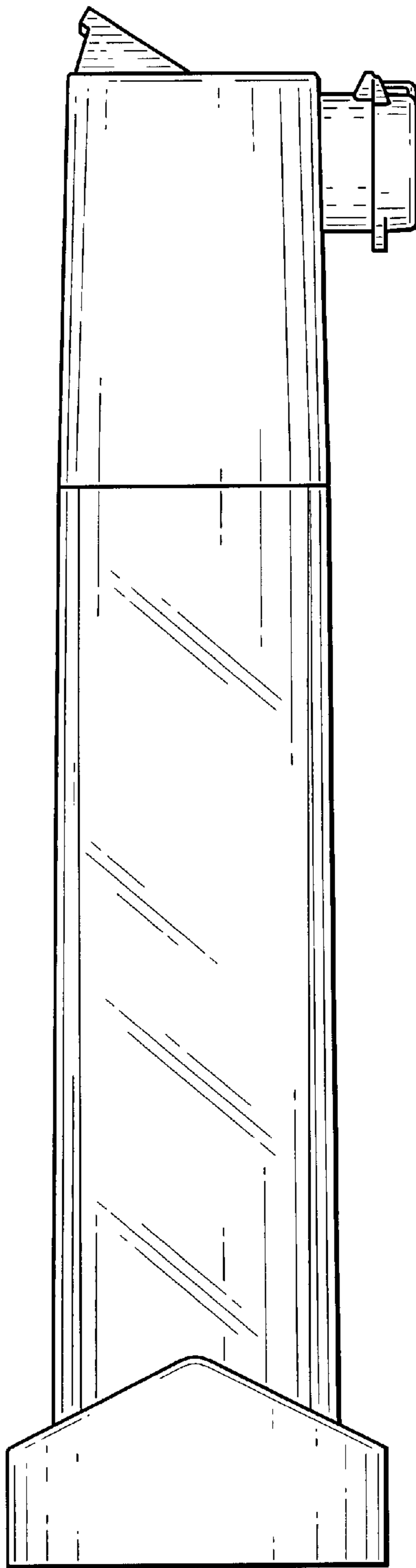

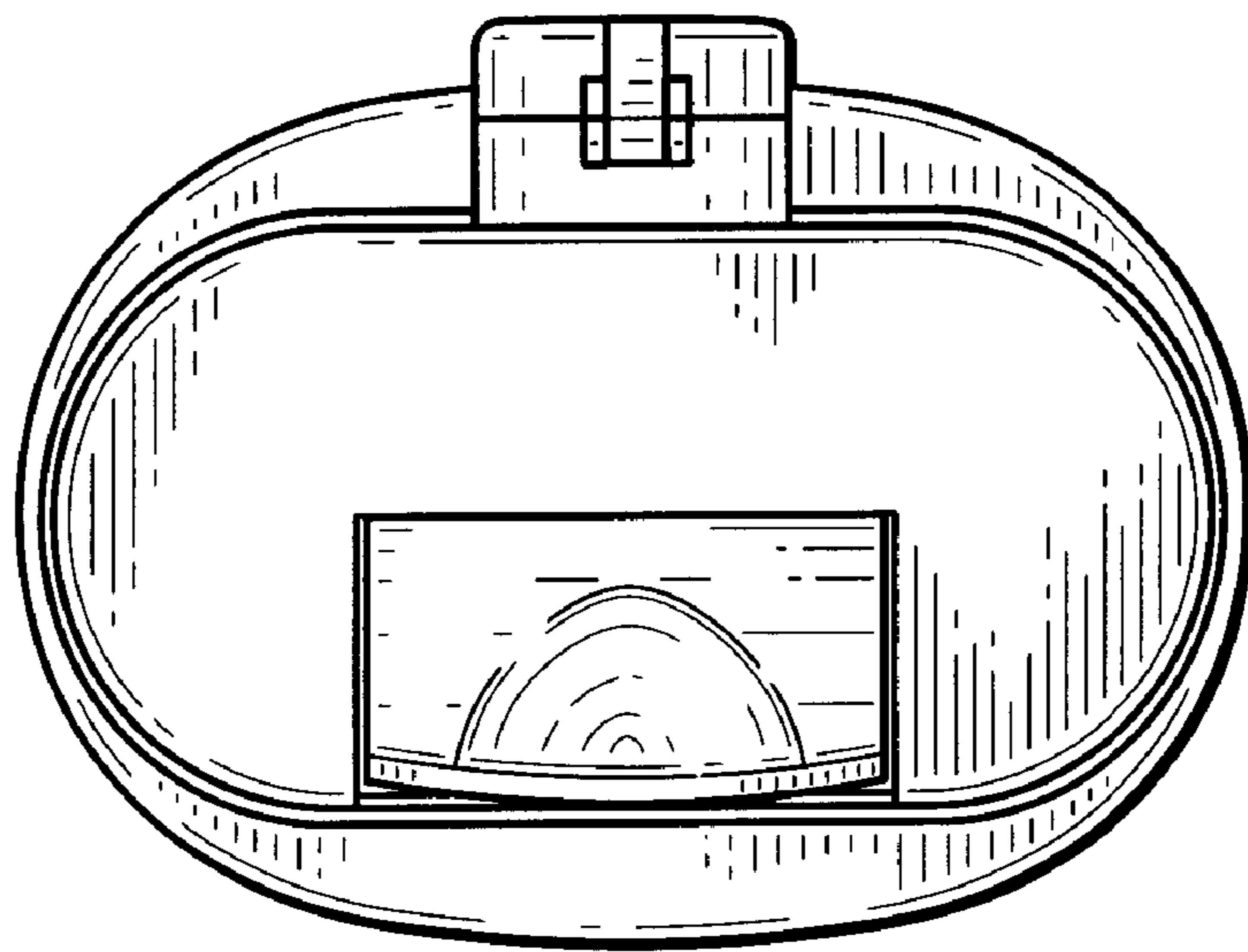
