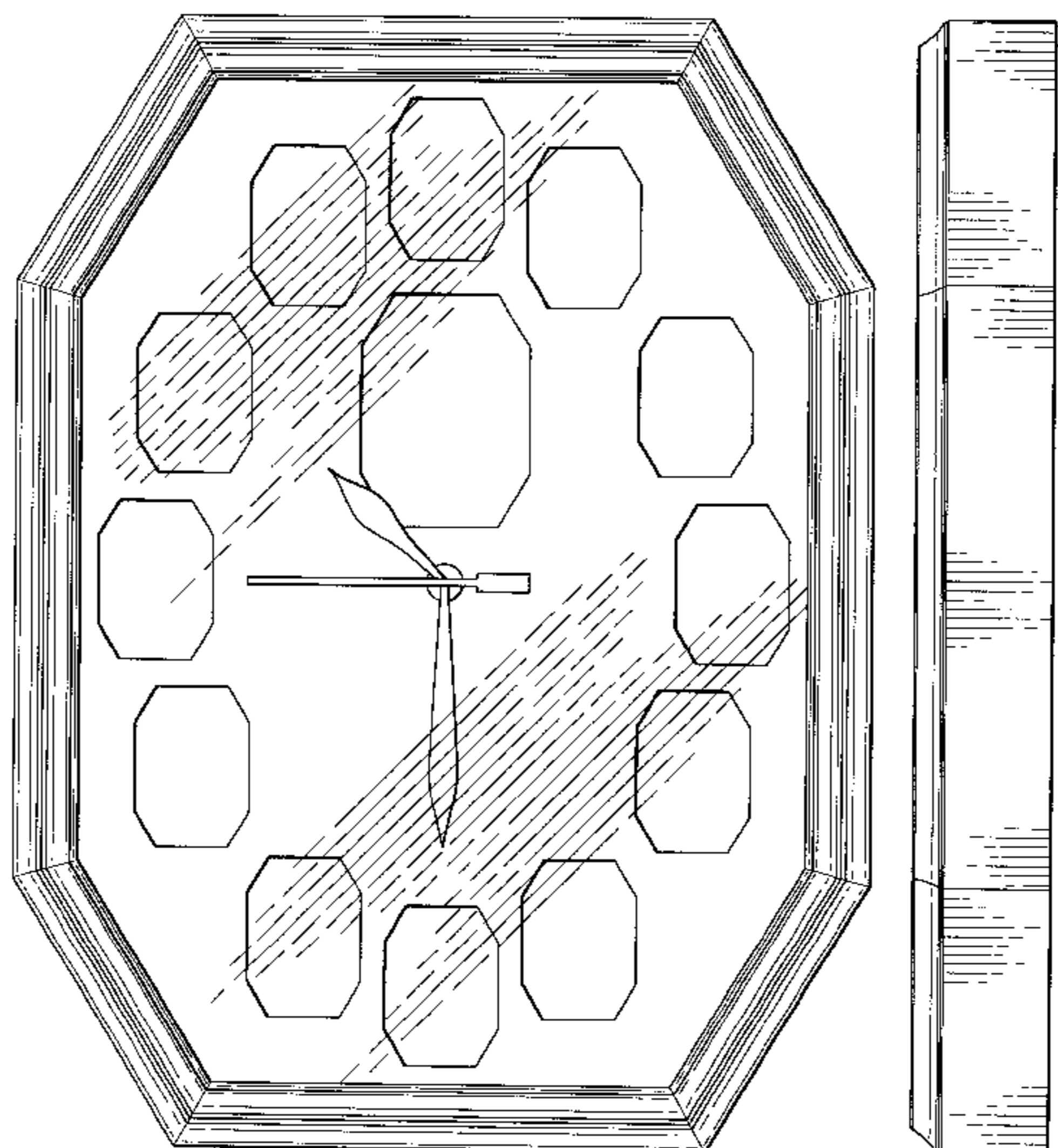
(57) **CLAIM**

The ornamental design for a clock for photographs, as shown and described.

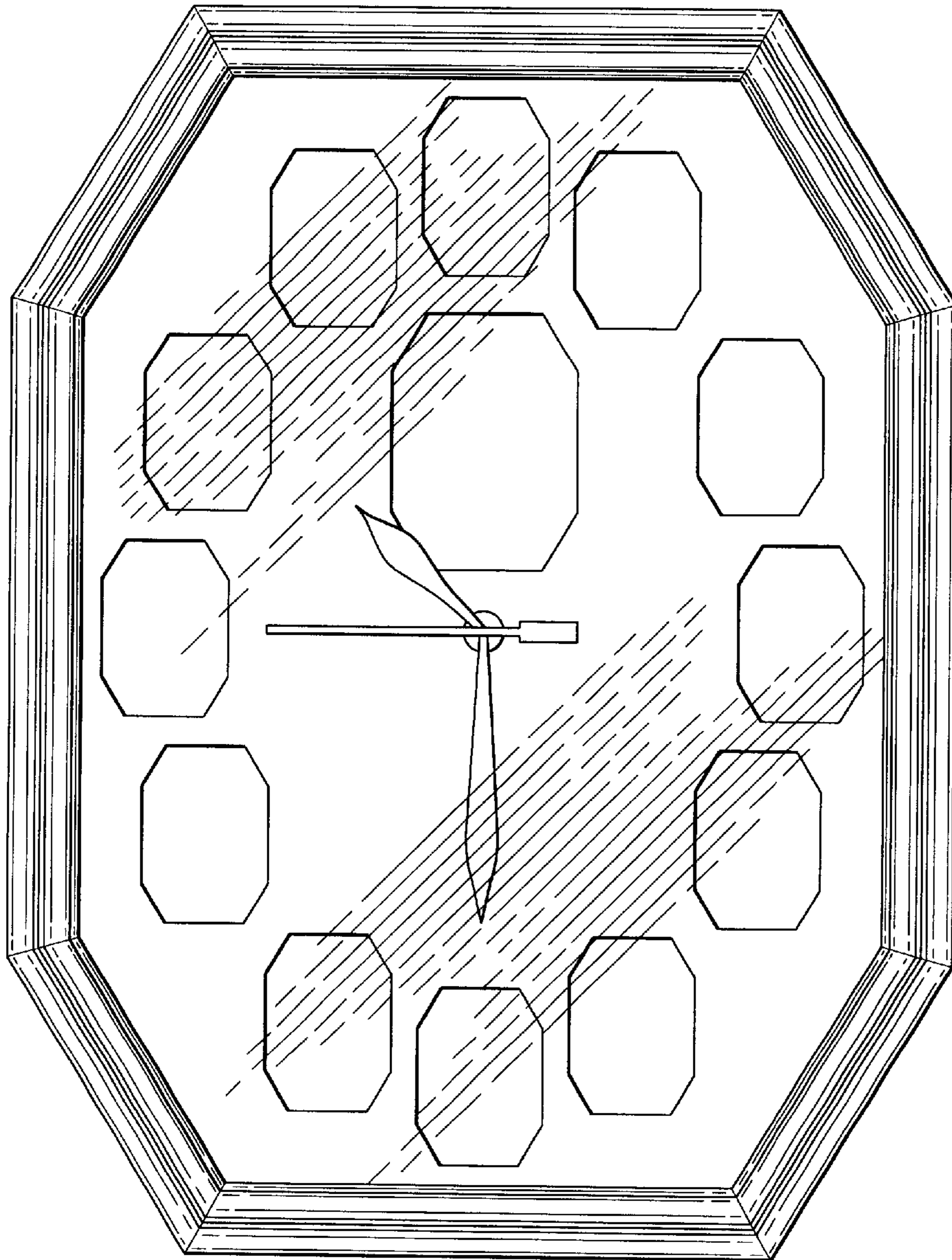
**DESCRIPTION**

FIG. 5 is a bottom view of the clock of FIG. 1.

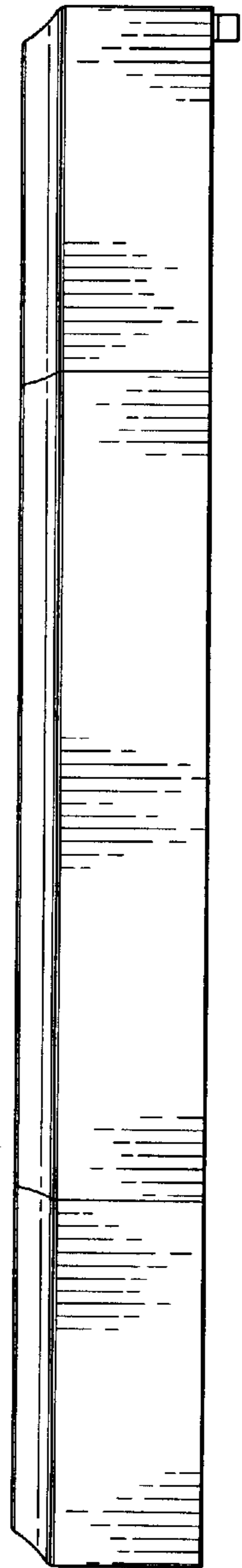

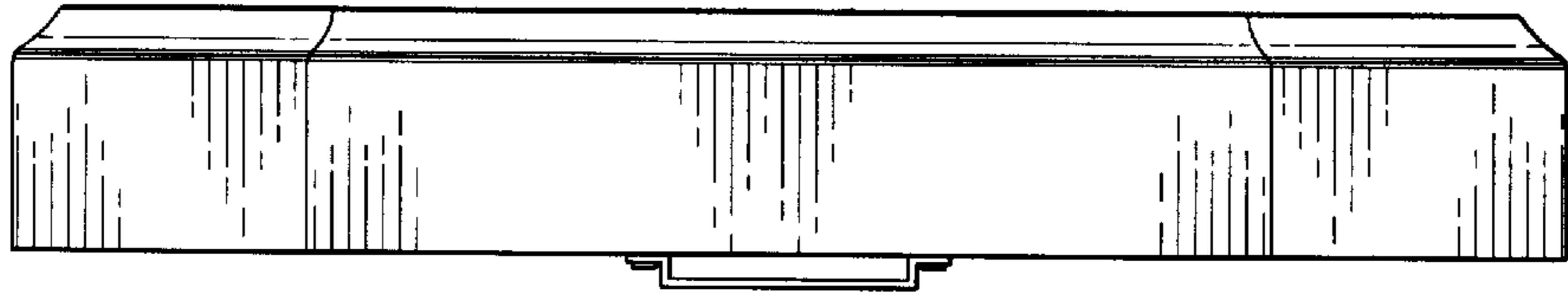

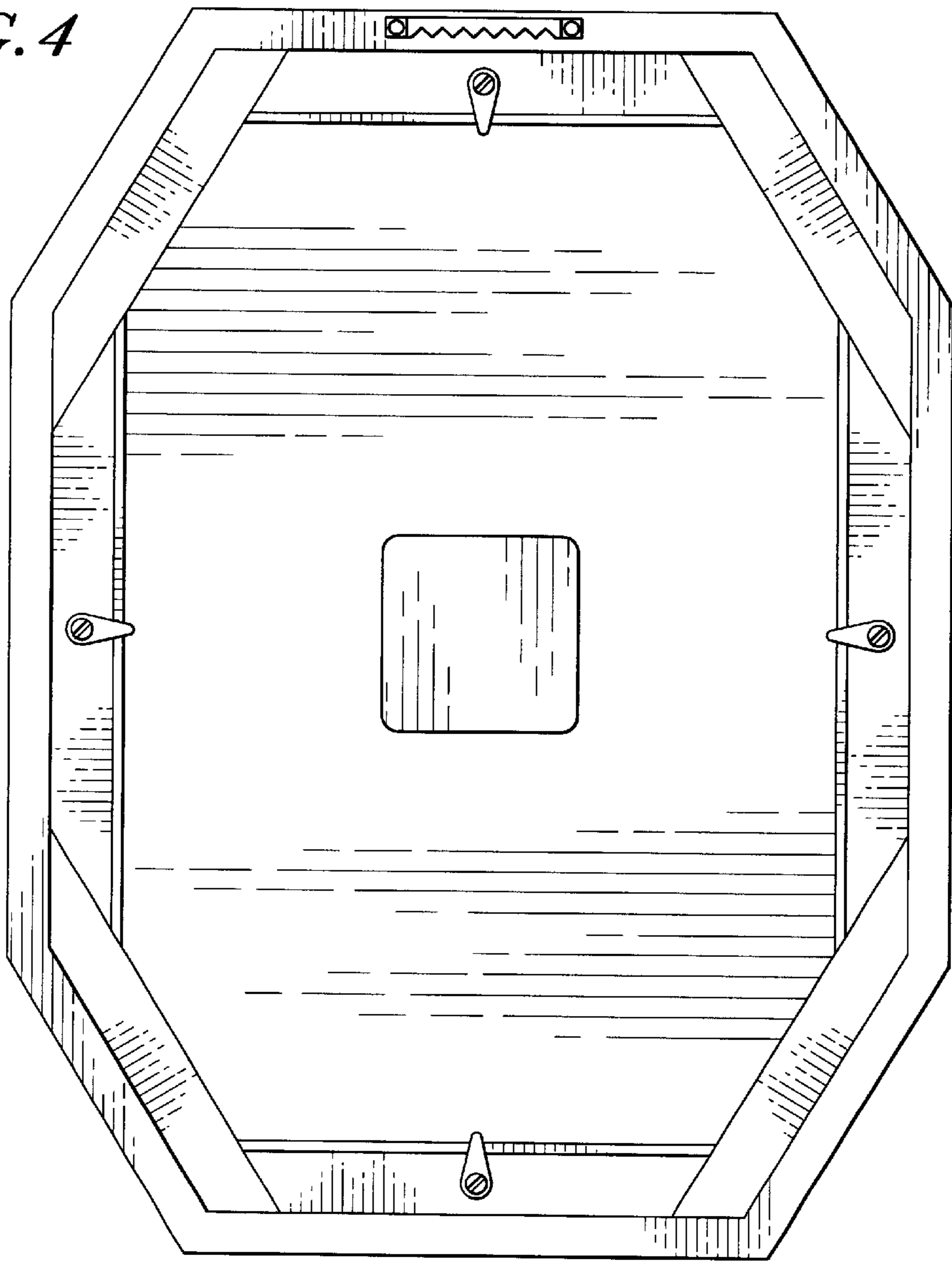
