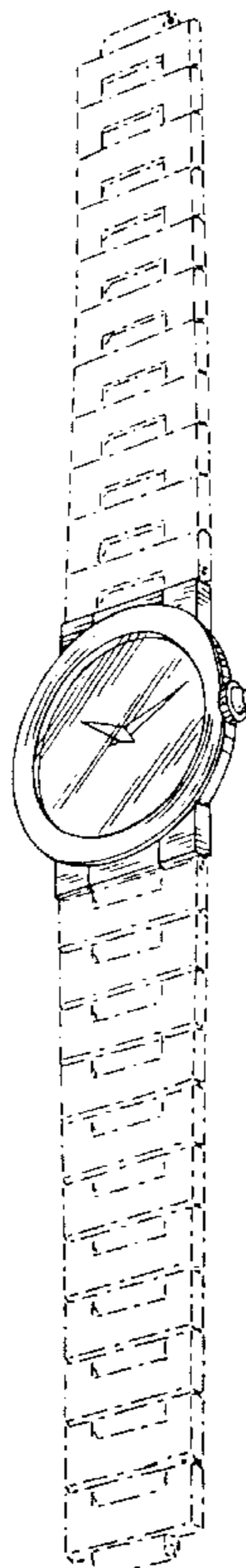
(57) **CLAIM**

I claim the ornamental design for the watch with bracelet, as shown and described.

**DESCRIPTION**

- FIG. 1 is a front perspective view of a watch showing my new design;
- FIG. 2 is a front elevational view thereof;
- FIG. 3 is a rear elevational view thereof;
- FIG. 4 is a right side elevational view thereof;
- FIG. 5 is a left side elevational view thereof;
- FIG. 6 is a top plan view thereof; and,
- FIG. 7 is a bottom plan view thereof.

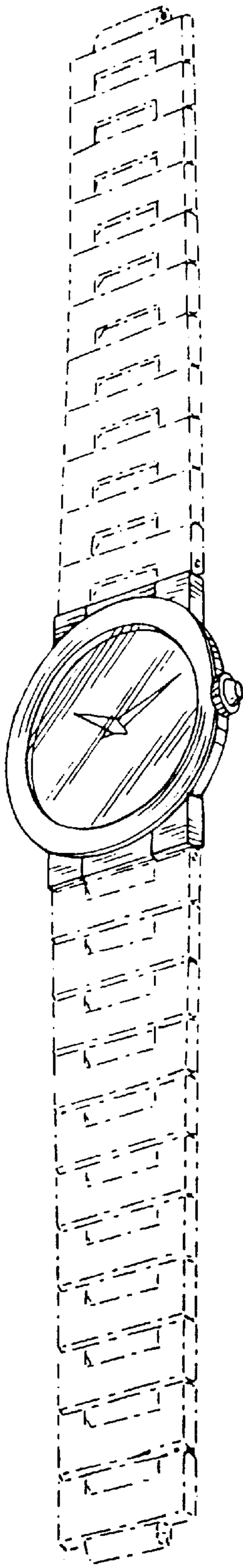

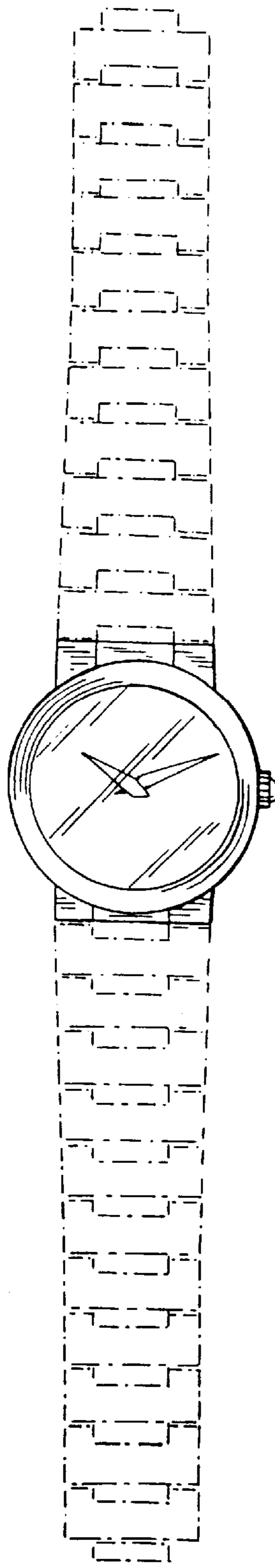

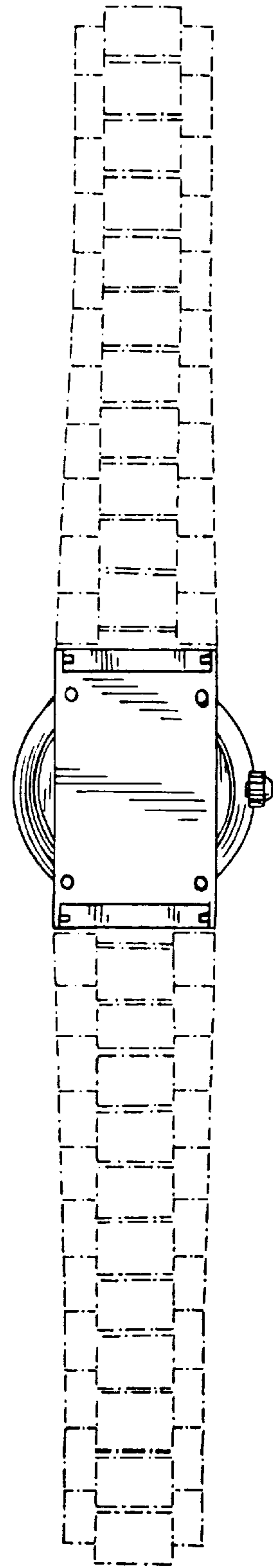

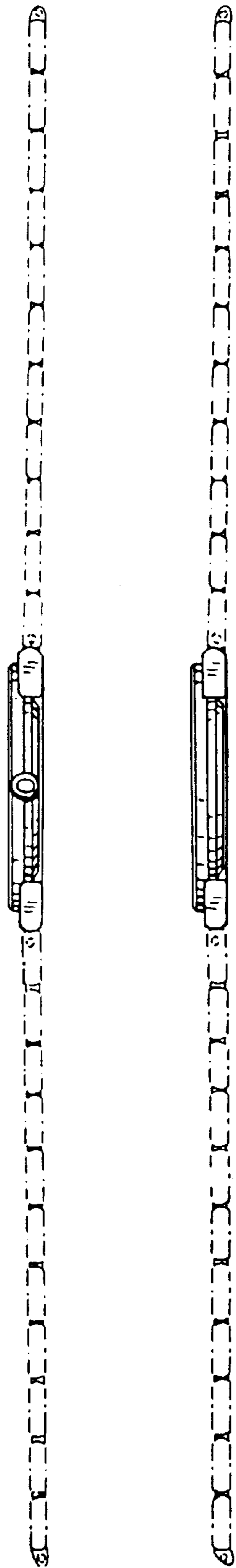
