(57) **CLAIM**

The ornamental design for an auxiliary foot pad for vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an auxiliary foot pad for vehicle showing my new design taken generally from the front;

FIG. 2 is a perspective view thereof taken generally from the opposite of FIG. 1;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a side elevational view thereof, taken generally from the left of FIG. 3;

FIG. 6 is a side elevational view thereof, taken generally from the opposite side of FIG. 5;

FIG. 7 is a top plan view thereof; and,

FIG. 8 is a bottom plan view thereof.

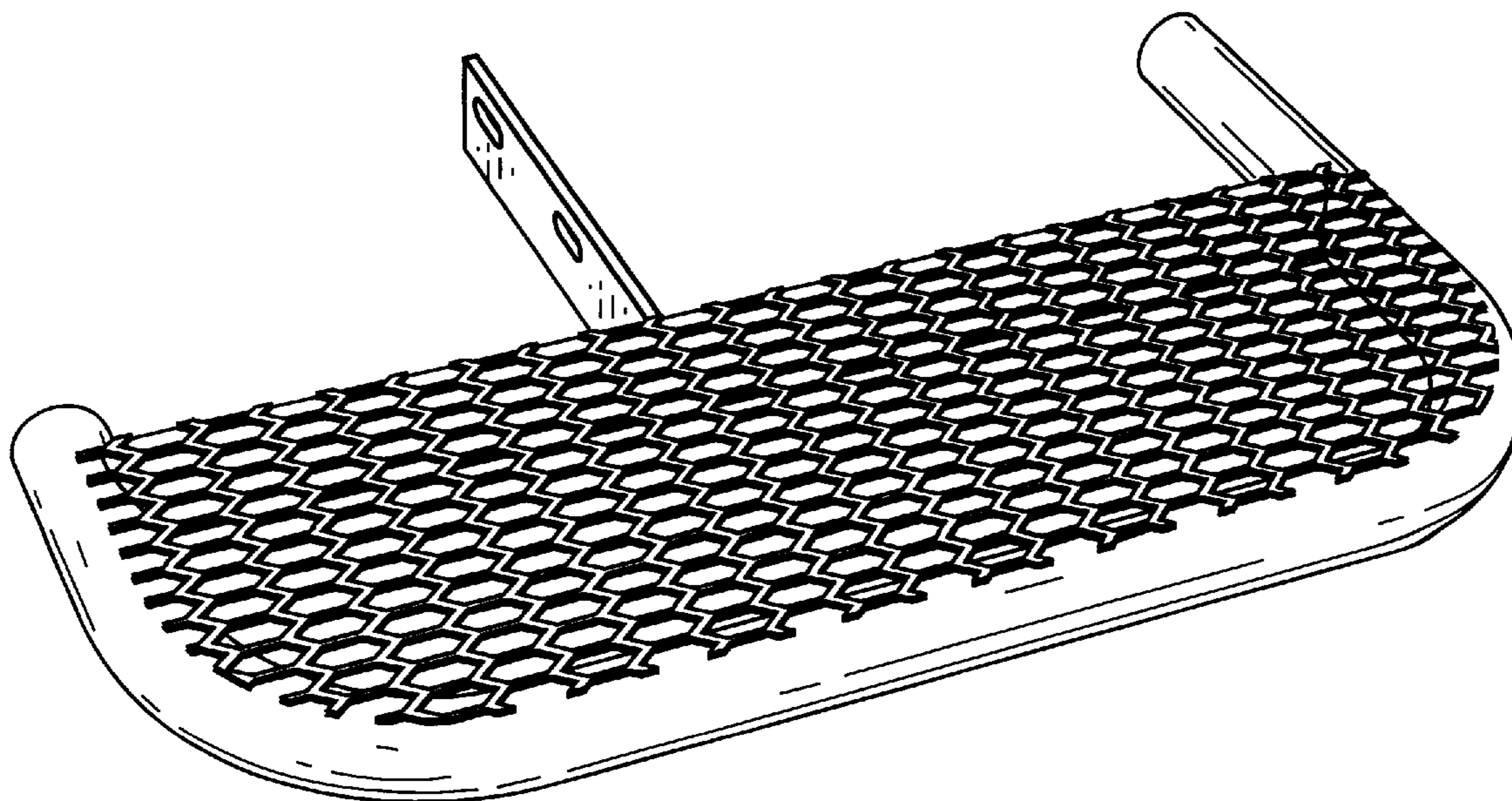

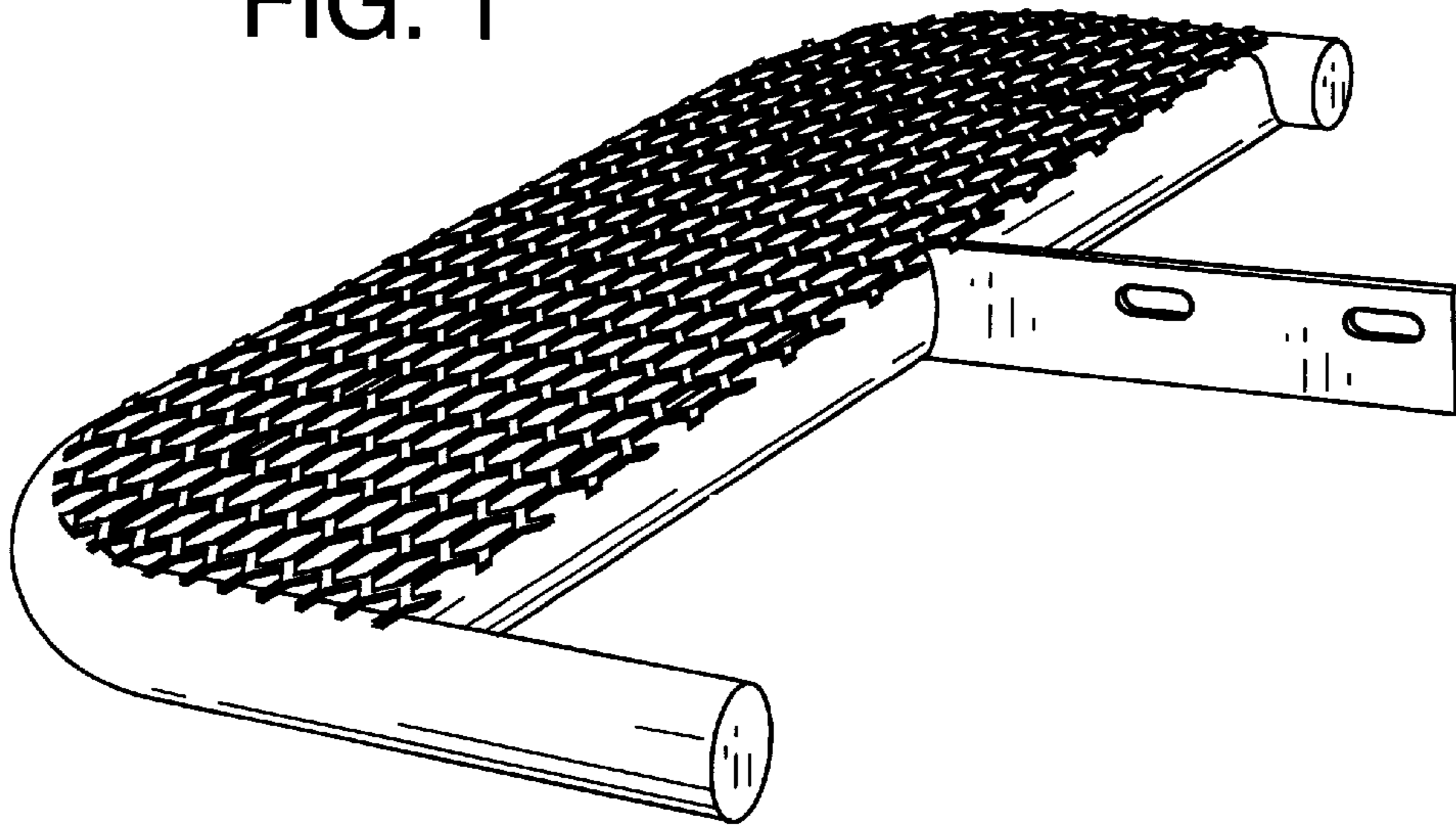

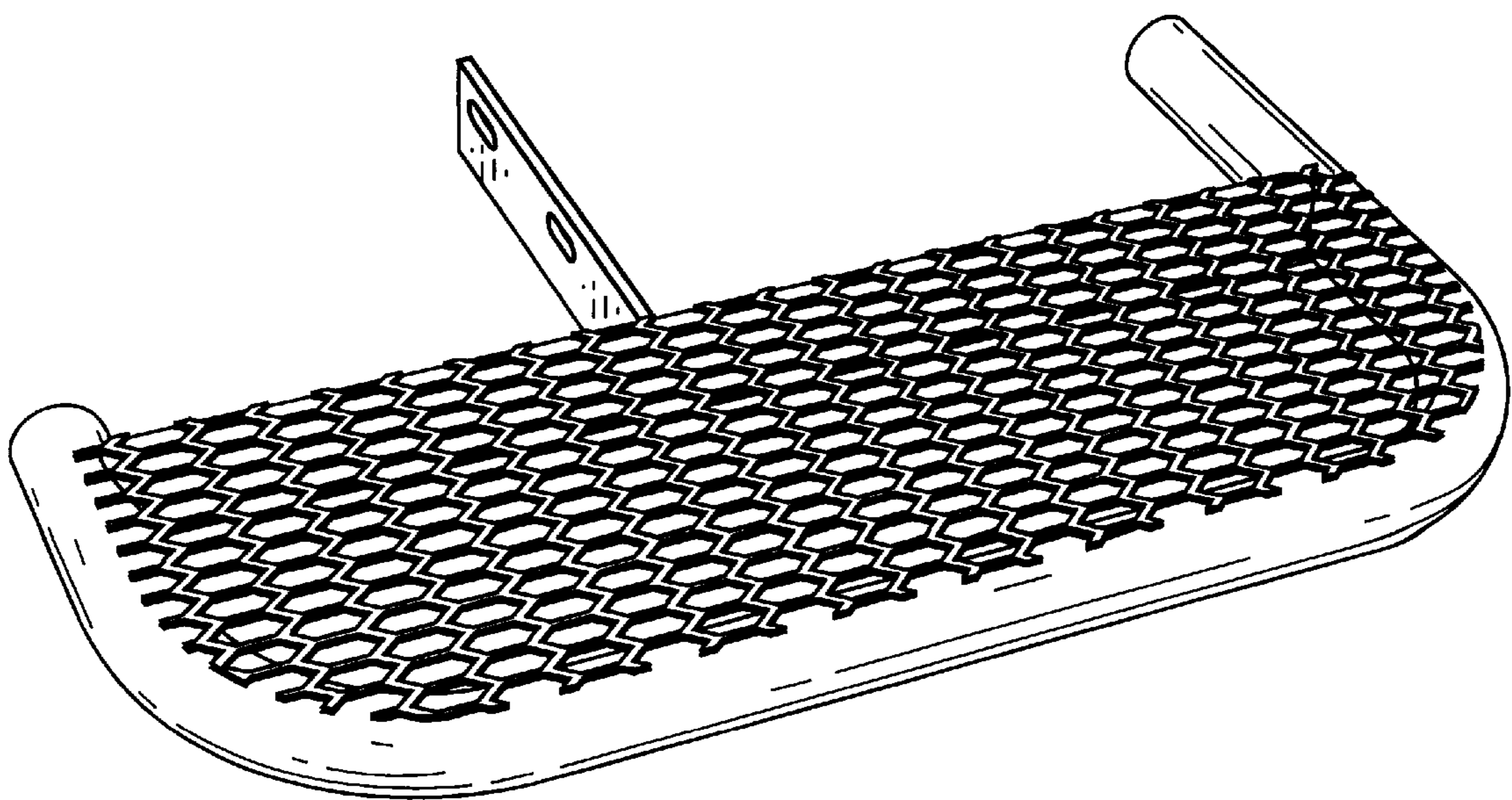

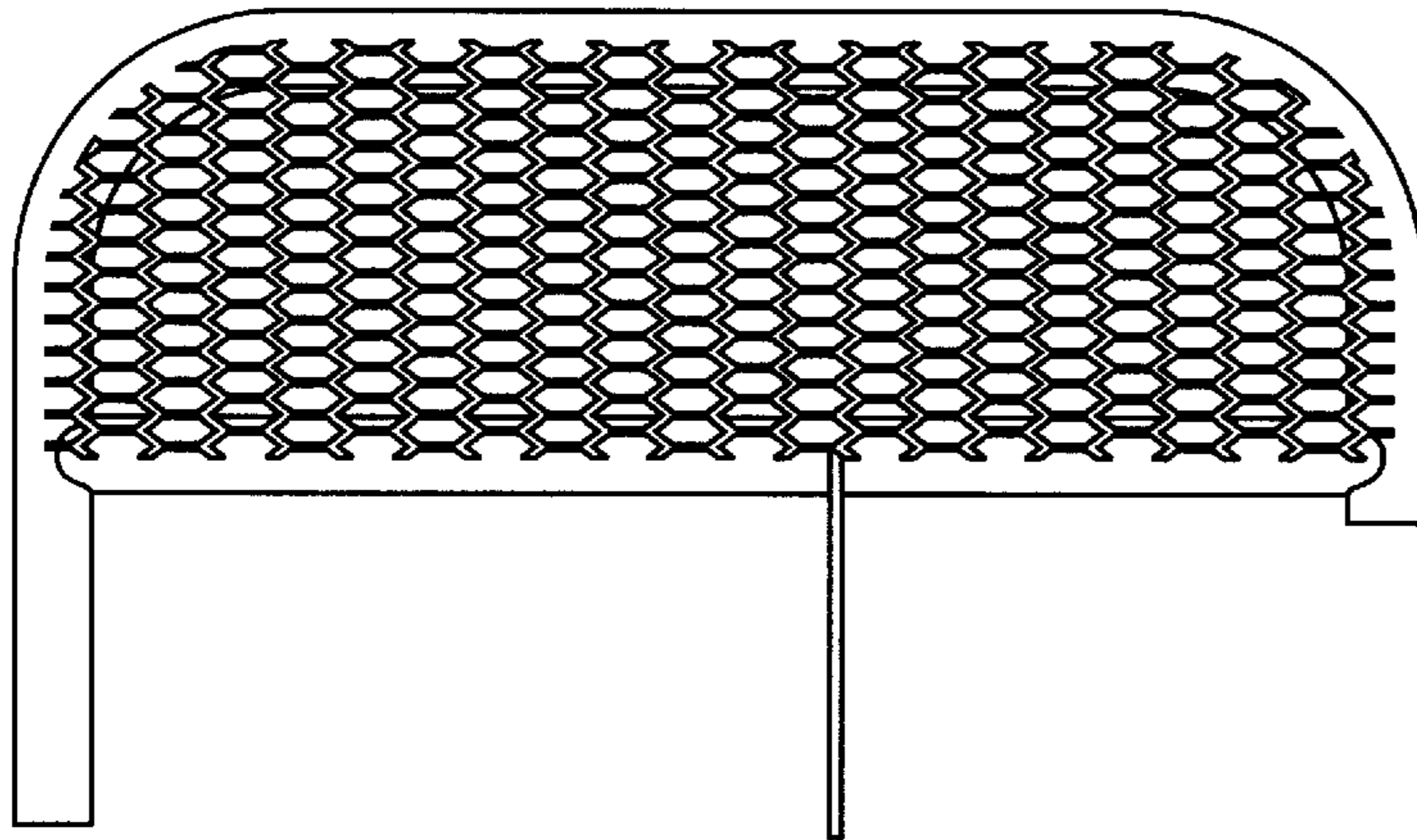

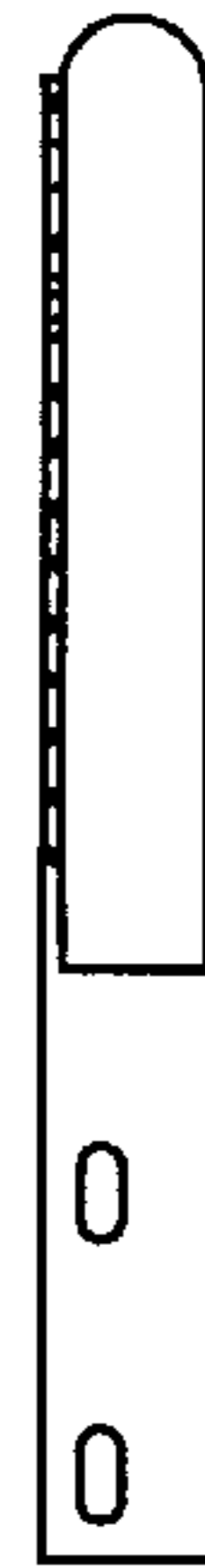

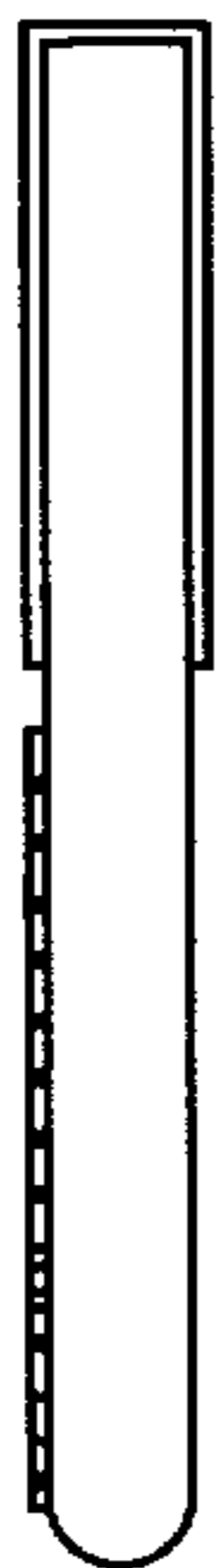
