(57) **CLAIM**

The ornamental design for a writing instrument and stand, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a writing instrument and stand in accordance with our new design;
 FIG. 2 is a perspective view of the stand of FIG. 1 shown separately for ease of illustration;
 FIG. 3 is a perspective view of the writing instrument of FIG. 1 shown separately for ease of illustration;
 FIG. 4 is a top plan view of the stand shown in FIG. 2;
 FIG. 5 is a front elevational view of the stand shown in FIG. 2, with the right side elevational view, left side elevational view and rear elevational view being identical thereto;
 FIG. 6 is a bottom plan view of the stand shown in FIG. 2;
 FIG. 7 is a left side elevational view of the writing instrument shown in FIG. 3, with the right side elevational view being a mirror image thereof;
 FIG. 8 is a top plan view of the writing instrument shown in FIG. 3;
 FIG. 9 is a front elevational view of the writing instrument shown in FIG. 3;
 FIG. 10 is a bottom plan view of the writing instrument shown in FIG. 3; and,
 FIG. 11 is a rear elevational view of the writing instrument shown in FIG. 3.

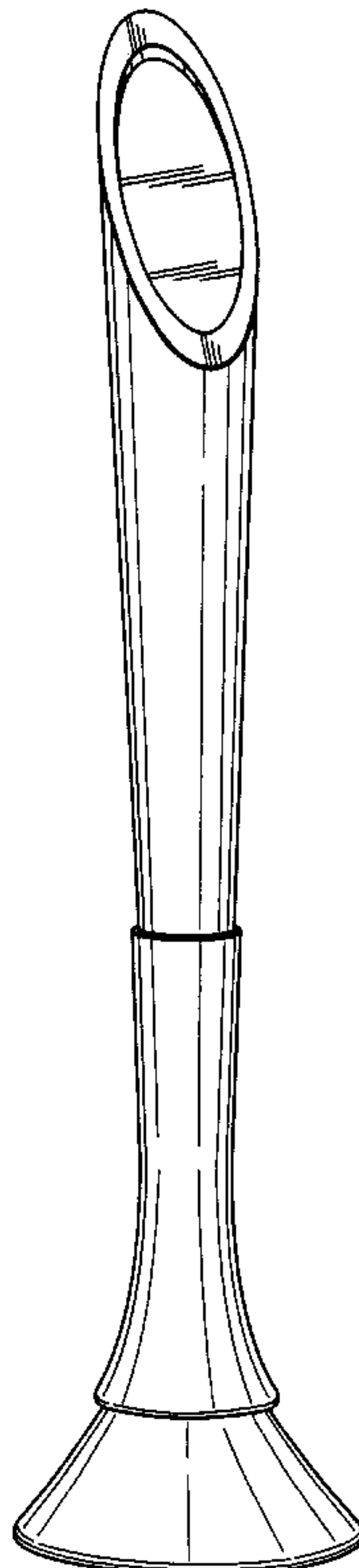

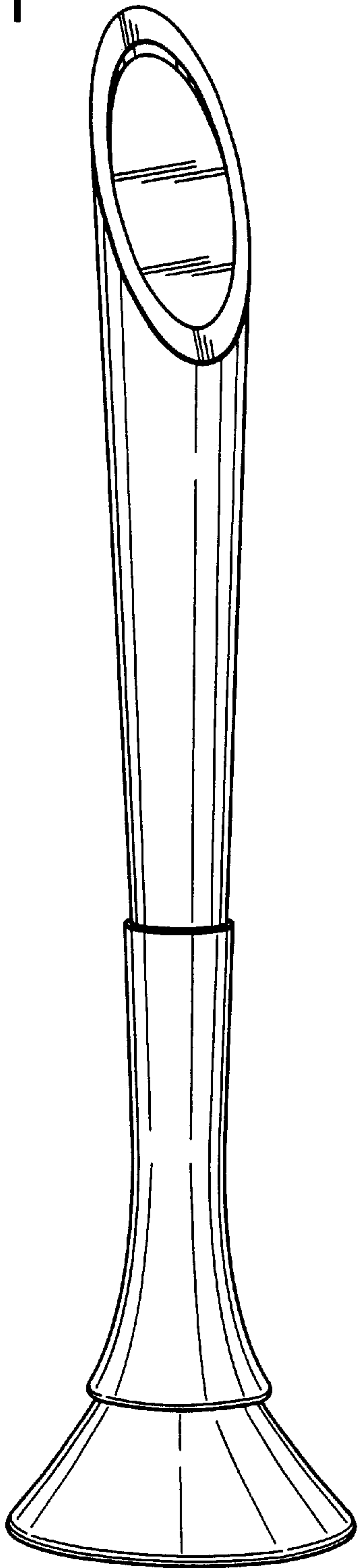

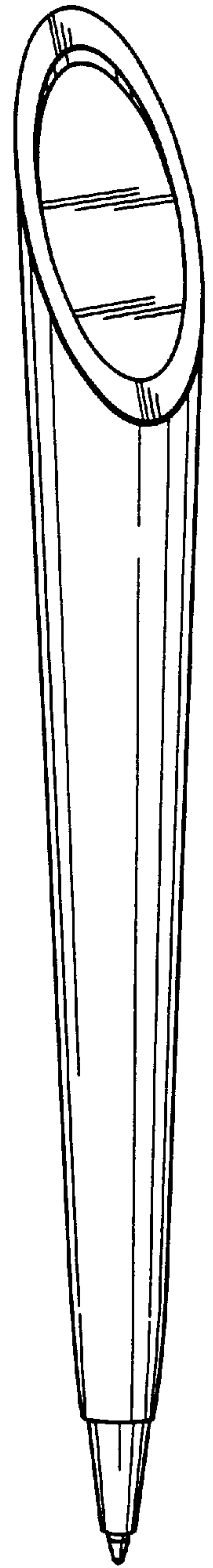

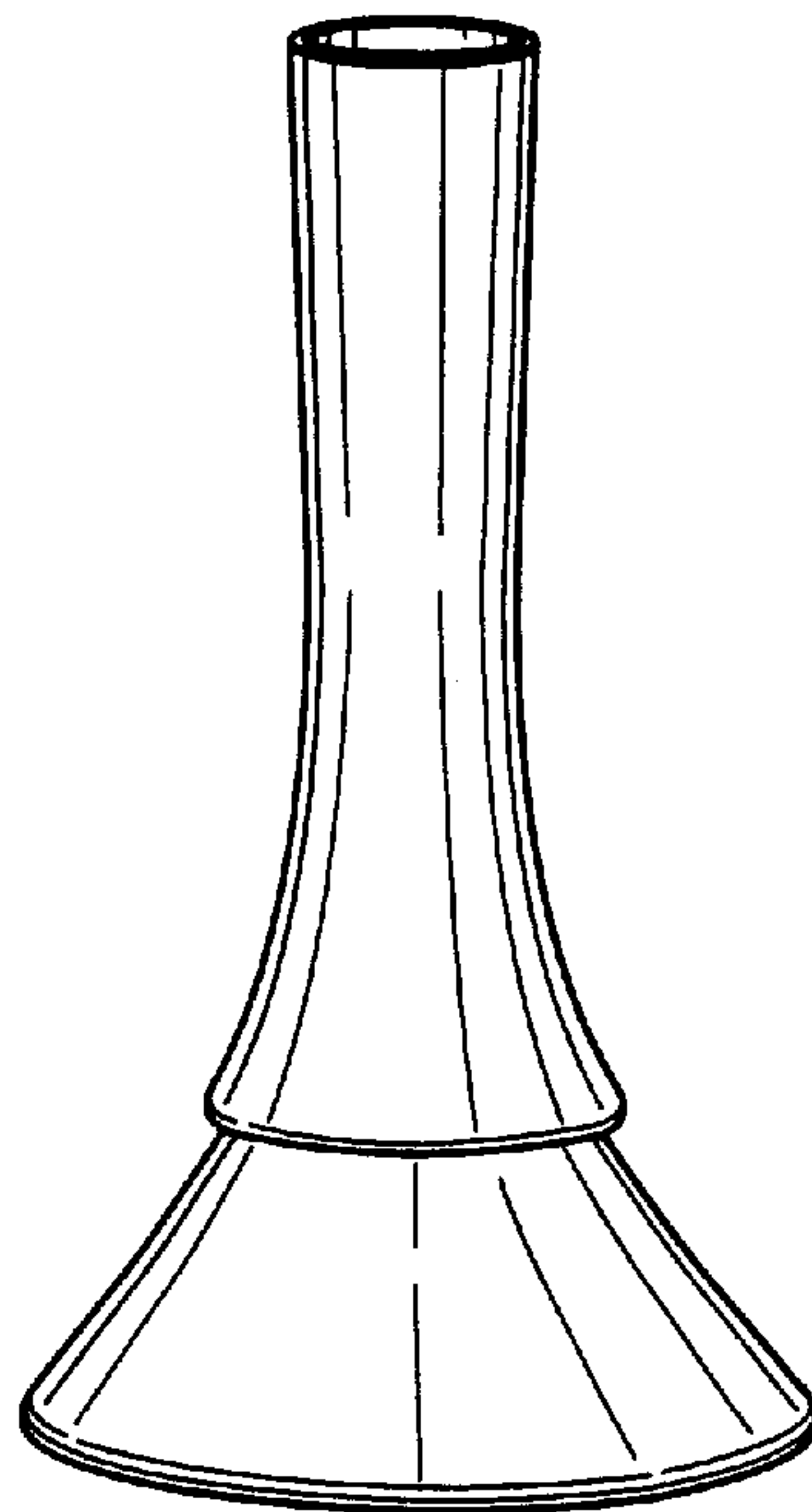

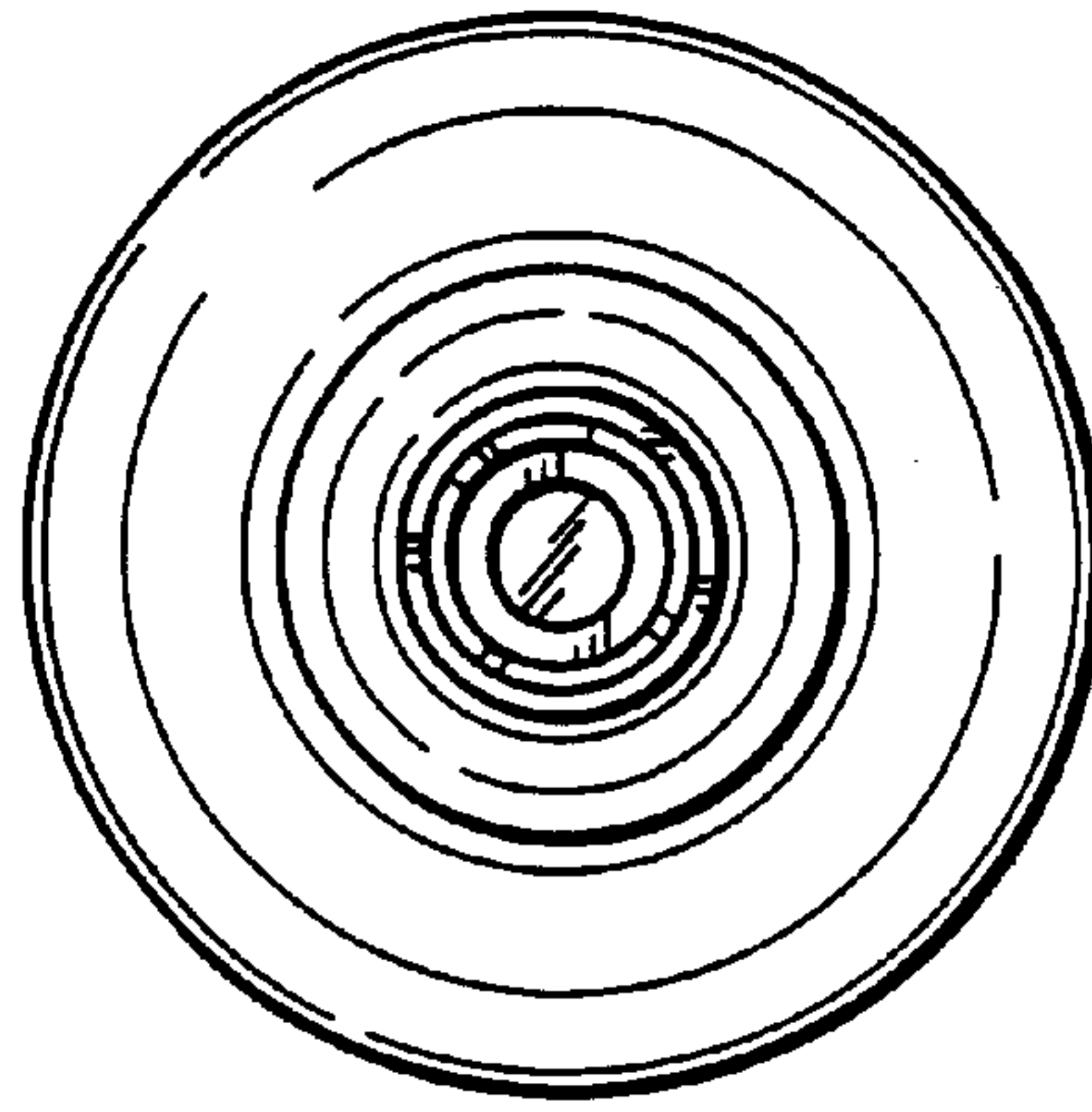

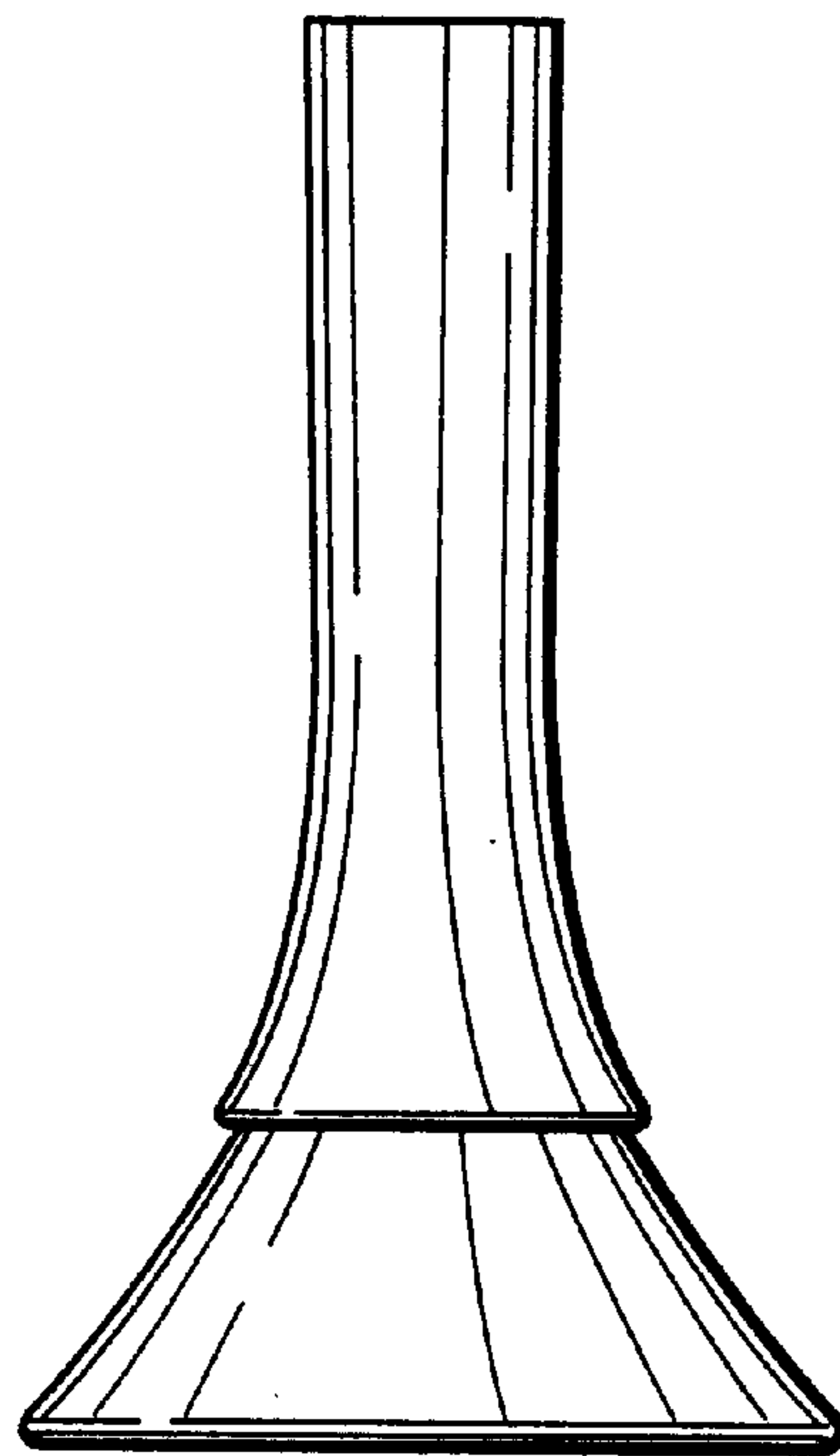

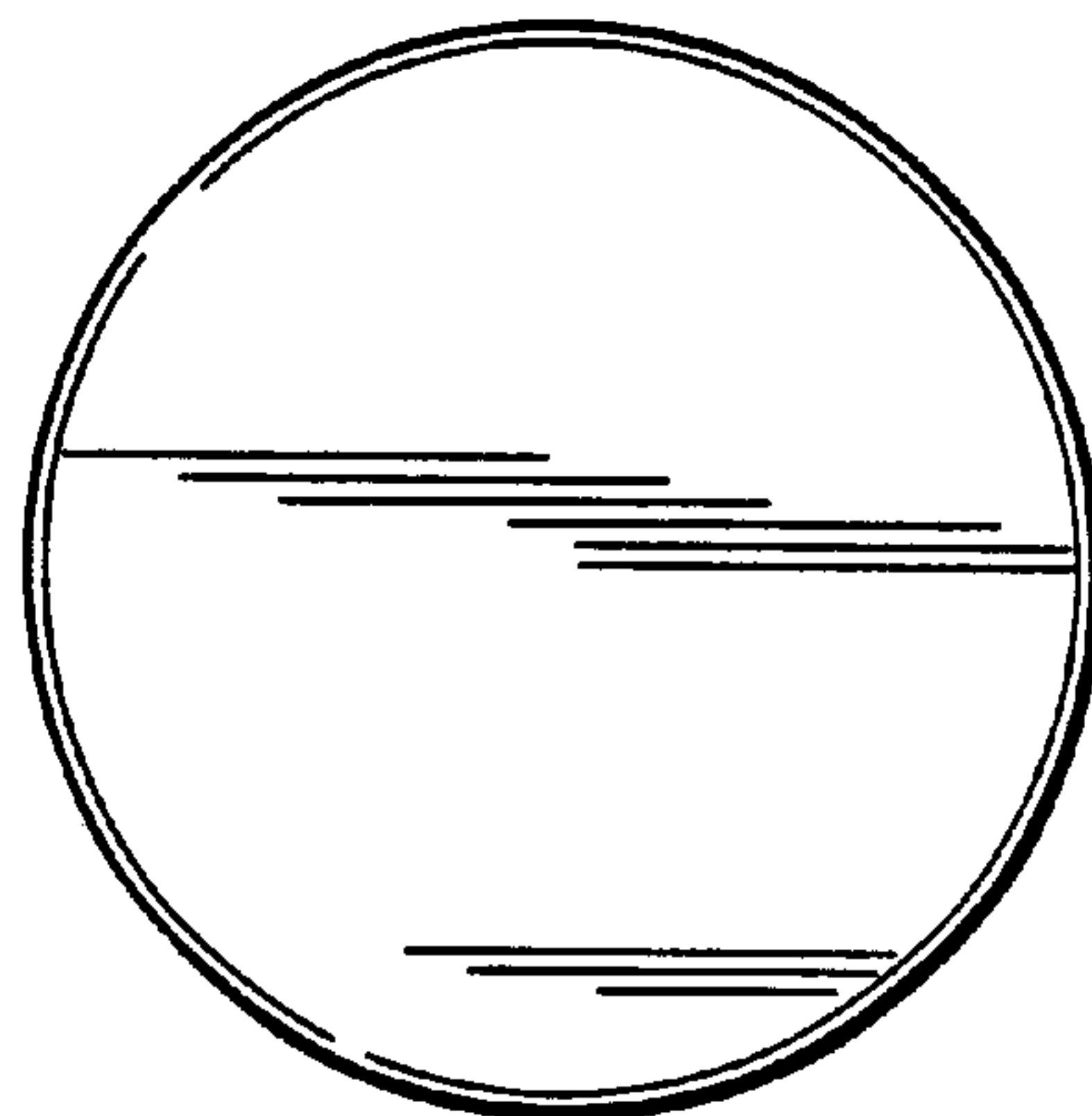

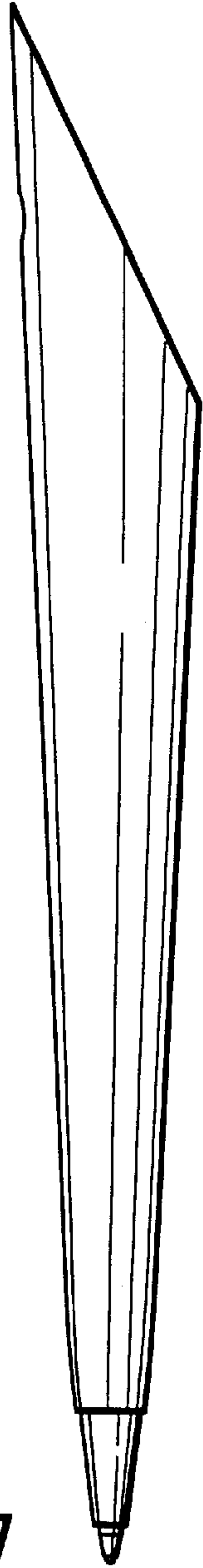
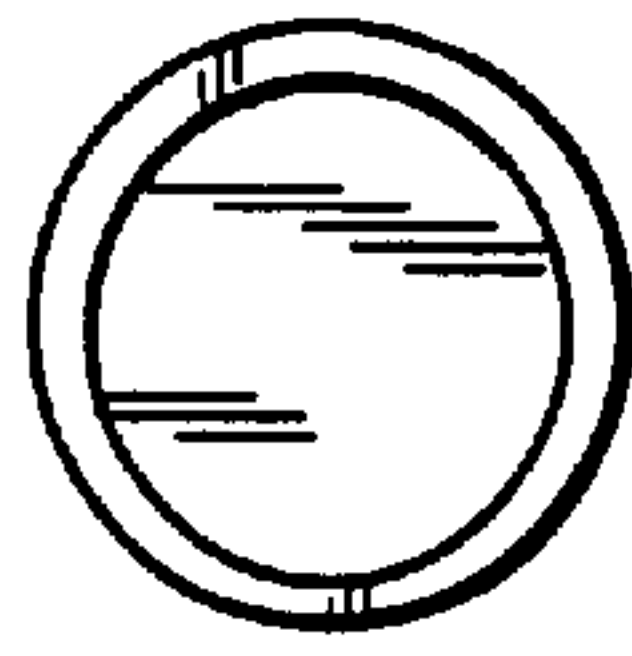

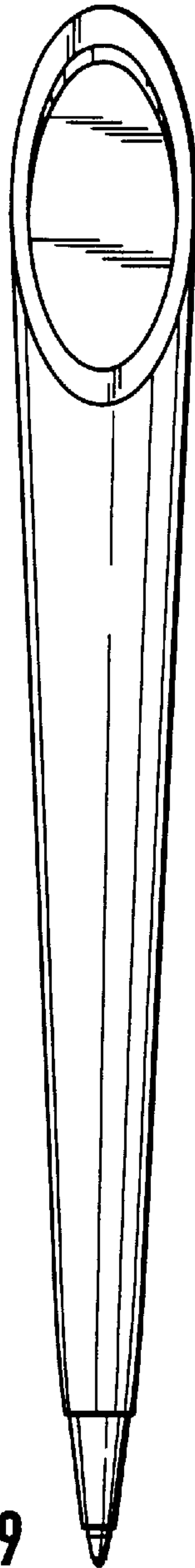

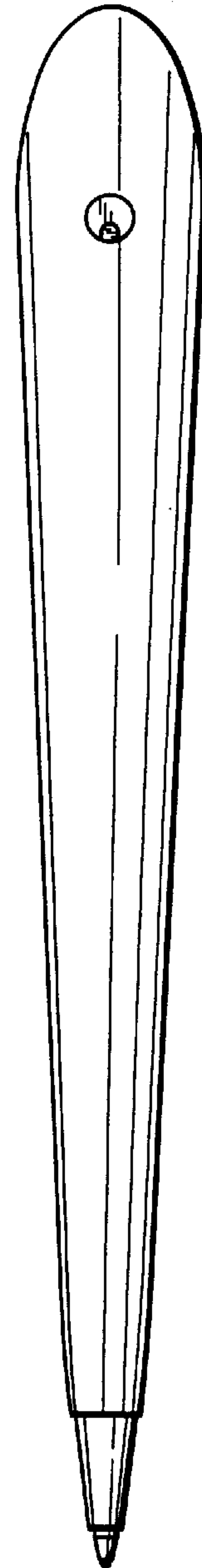
