The ornamental design for a magnetic pen holder, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the magnetic pen holder of the present invention;

FIG. 2 is a rear elevational view of the magnetic pen holder of FIG. 1;

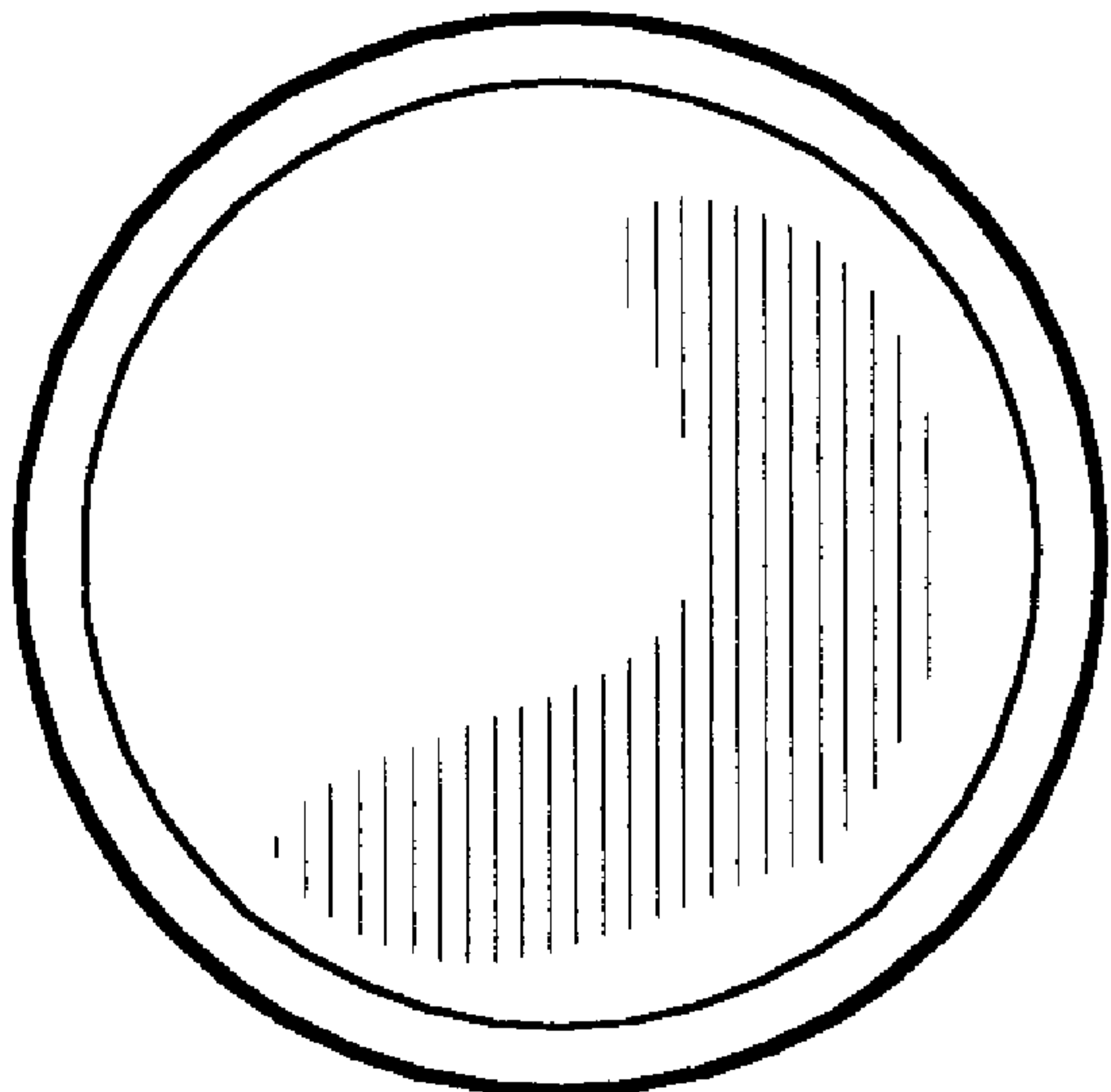
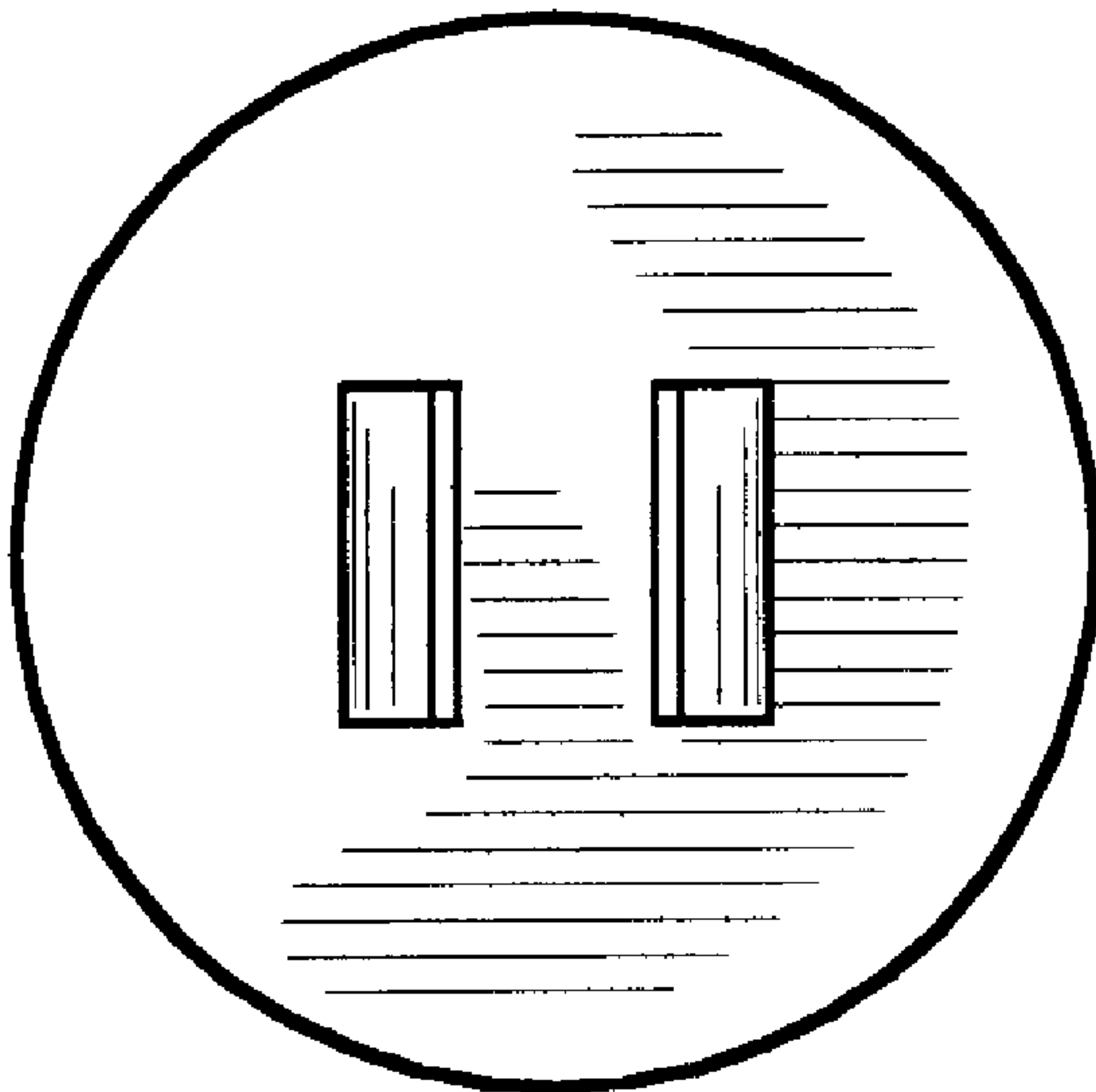
FIG. 3 is a left side elevational view of the magnetic pen holder of FIG. 1; the right view being a mirror image thereof;

FIG. 4 is a top plan view of the magnetic pen holder of FIG. 1; the bottom view being a mirror image thereof; and,

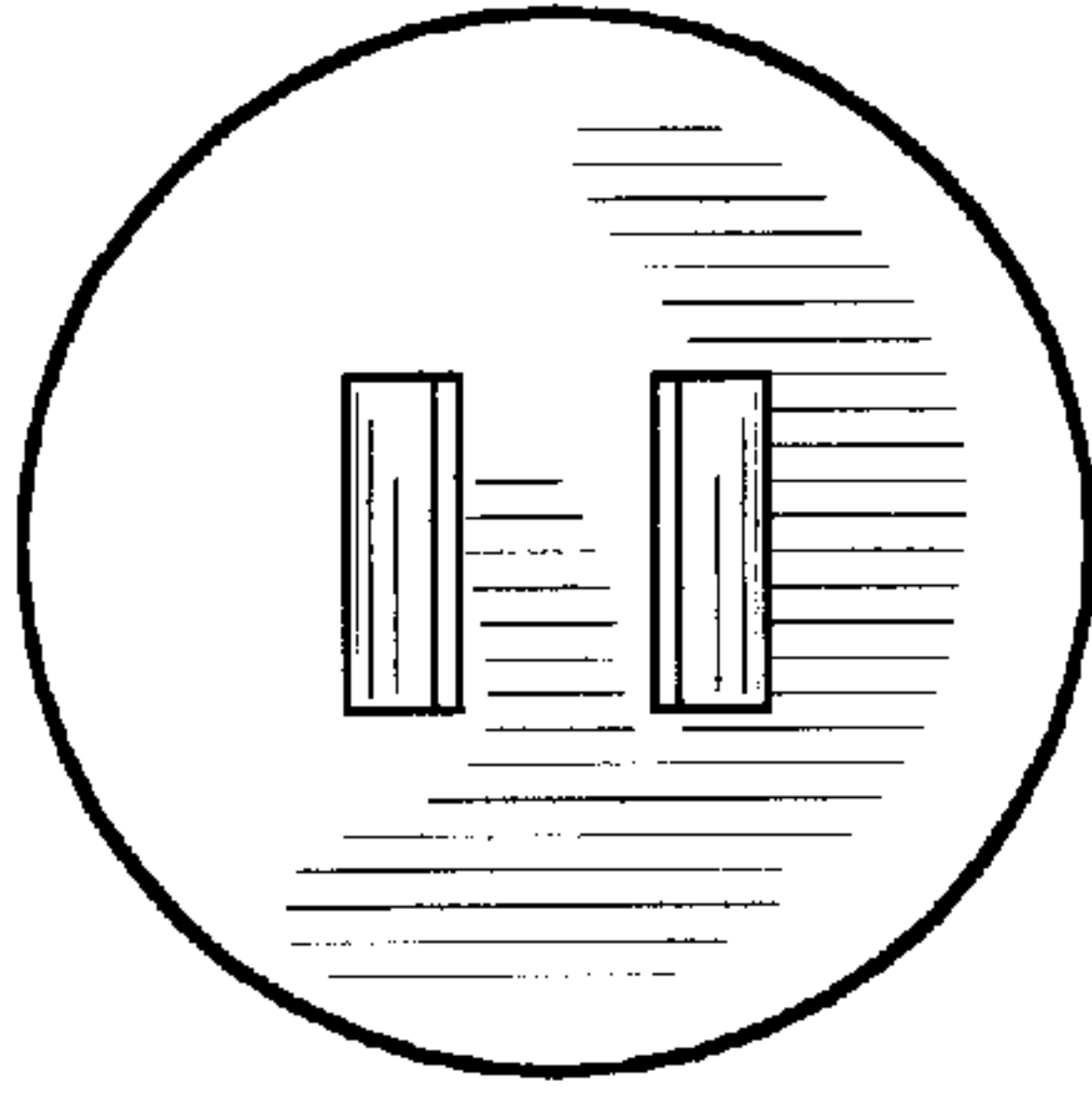

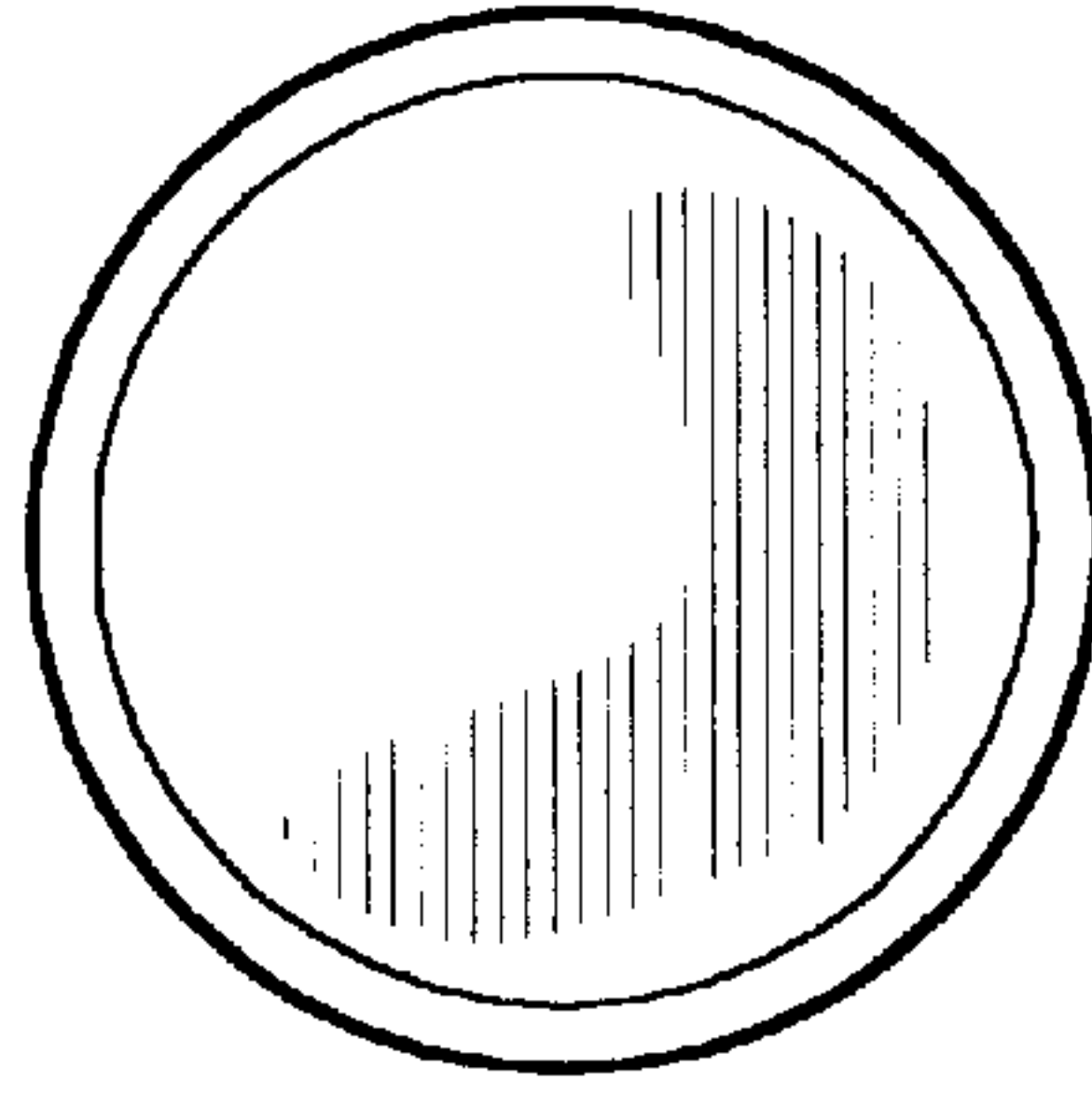

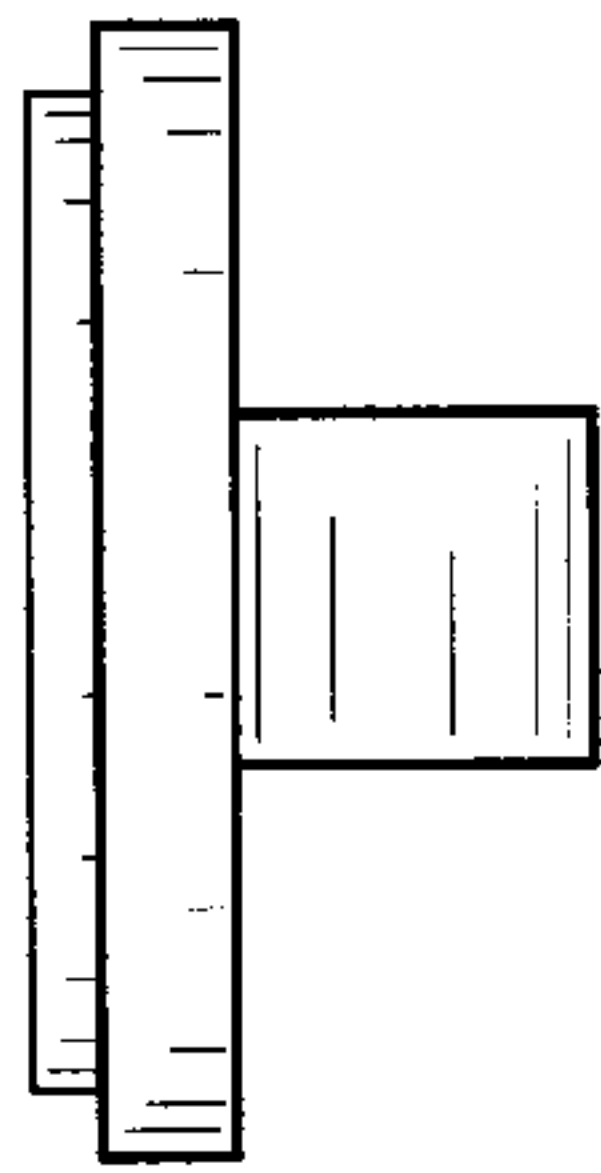

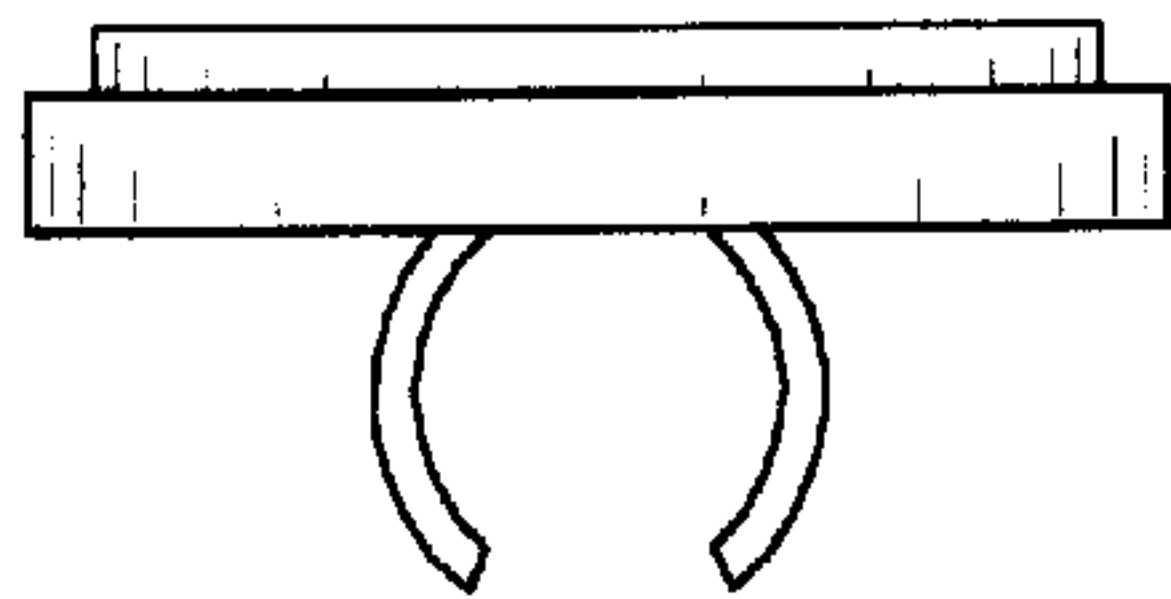

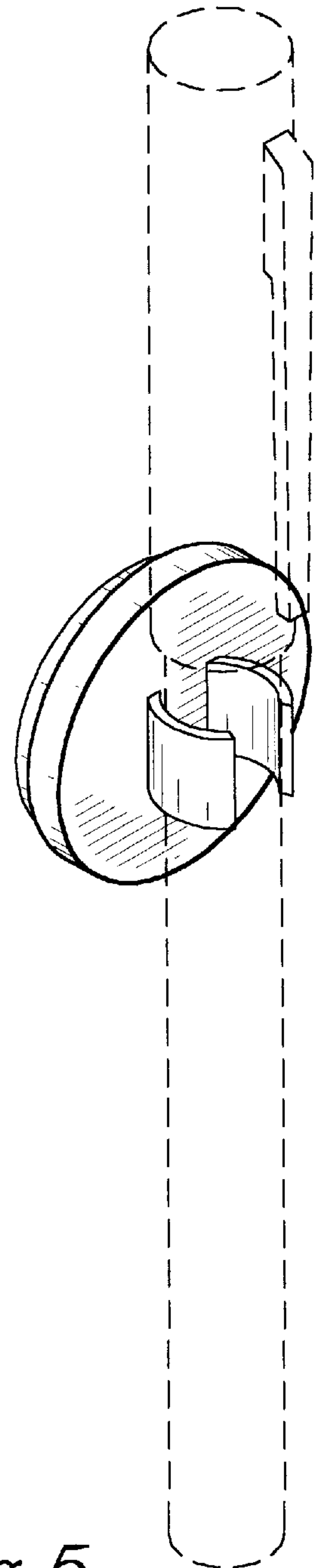
