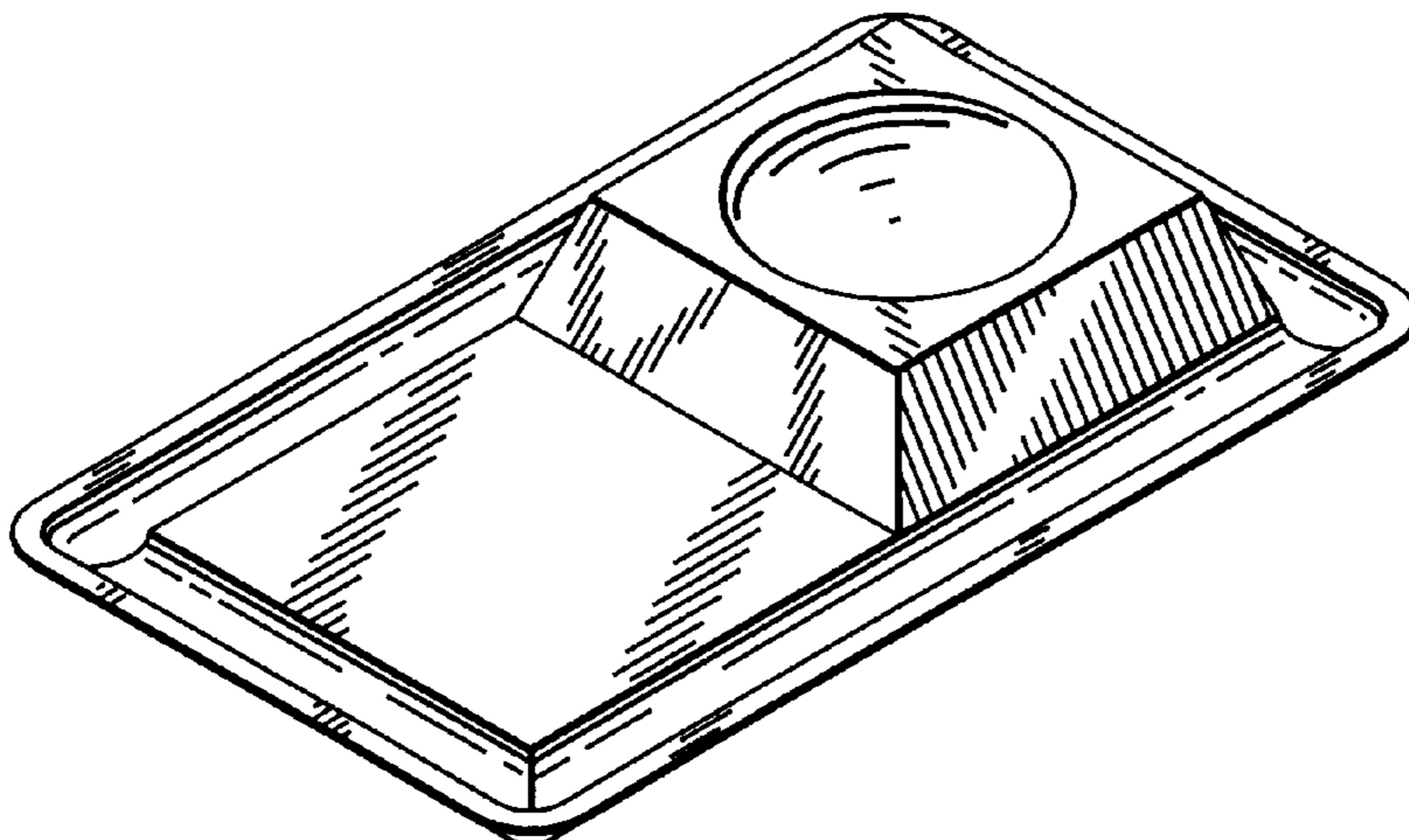
(57) **CLAIM**

The ornamental design for a dental dispensing tray, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a dental dispensing tray showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a left side elevational view thereof, the right side being a mirror image of that shown;
 FIG. 4 is a top plan view thereof; and,
 FIG. 5 is a bottom view thereof.

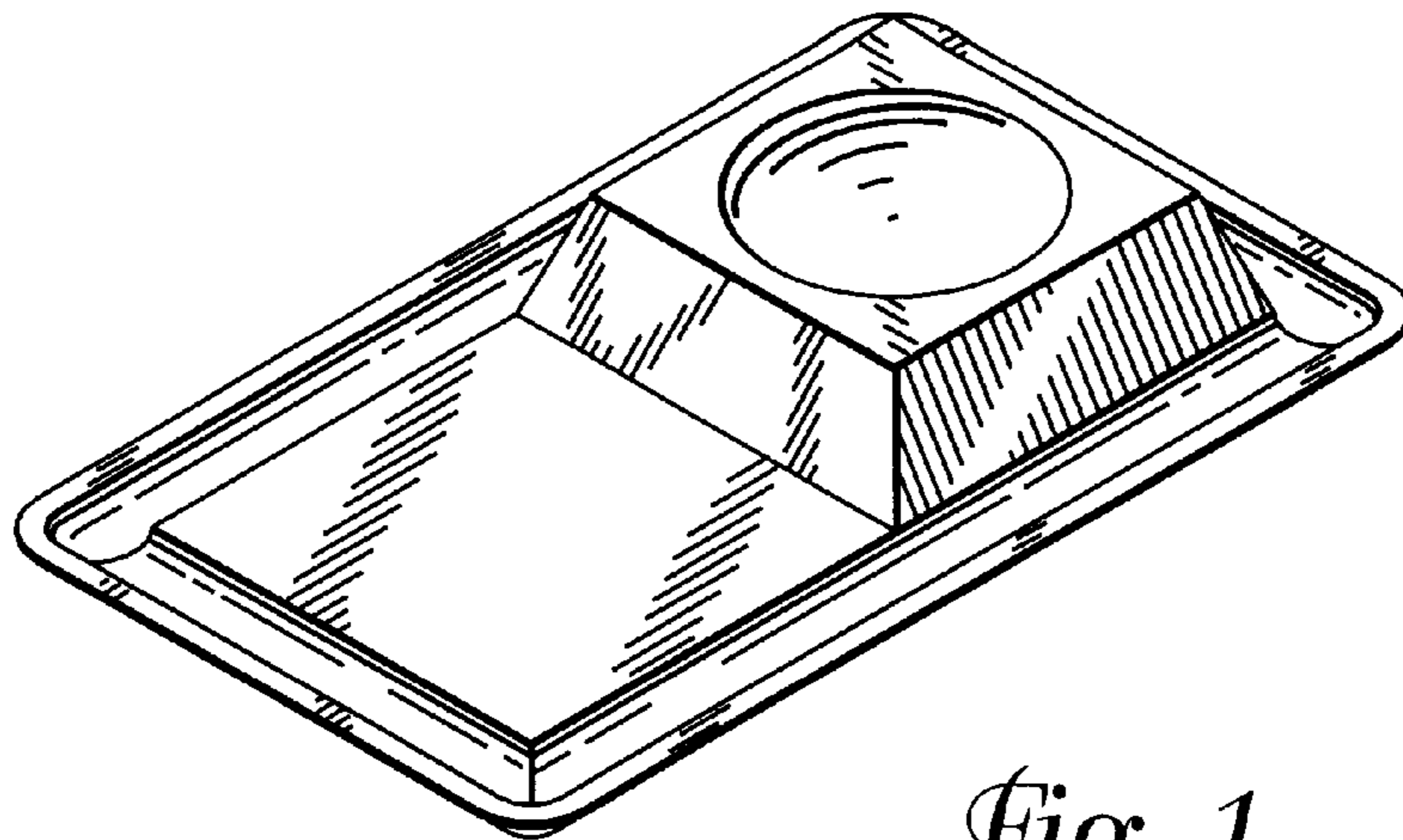

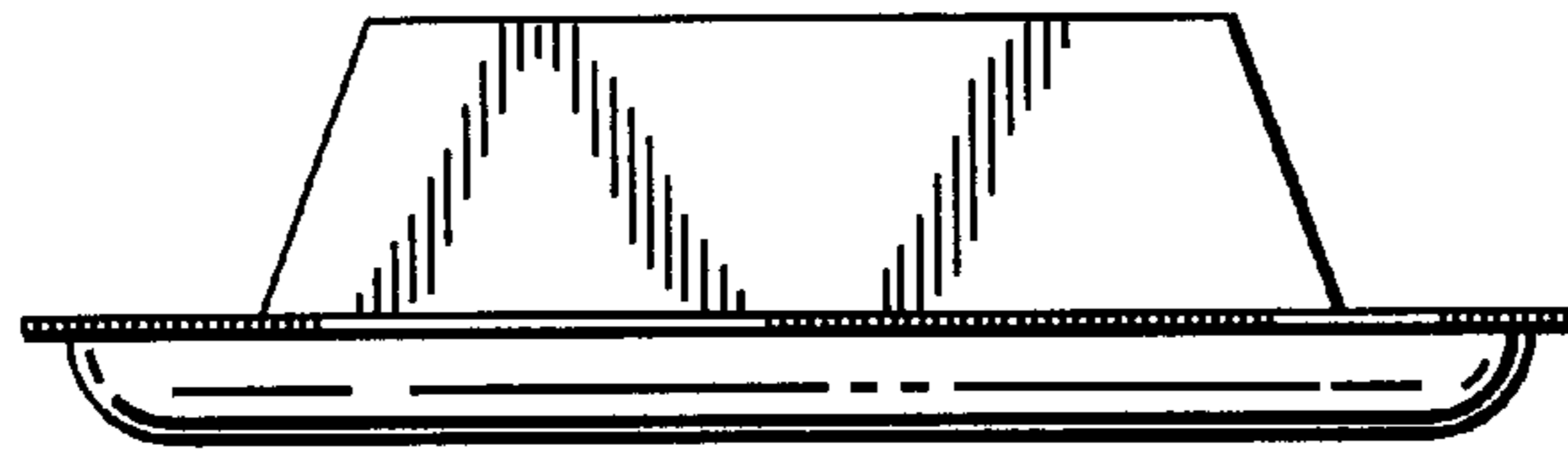

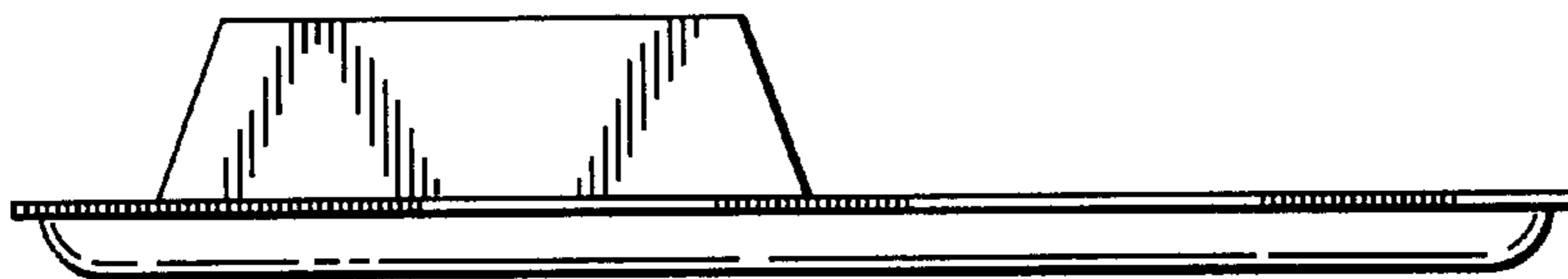

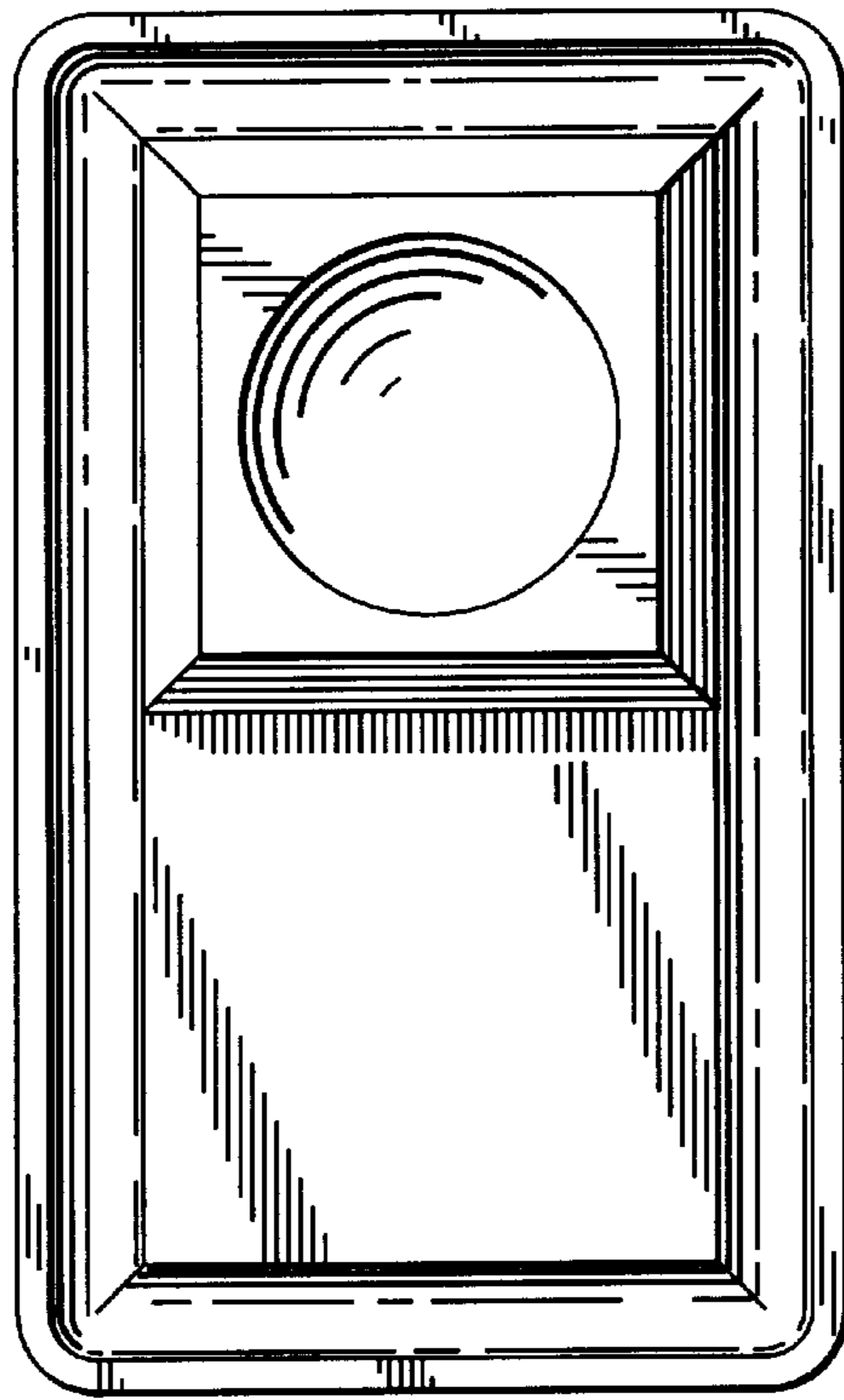
