**DESCRIPTION**

FIG. 9 is a side view thereof;

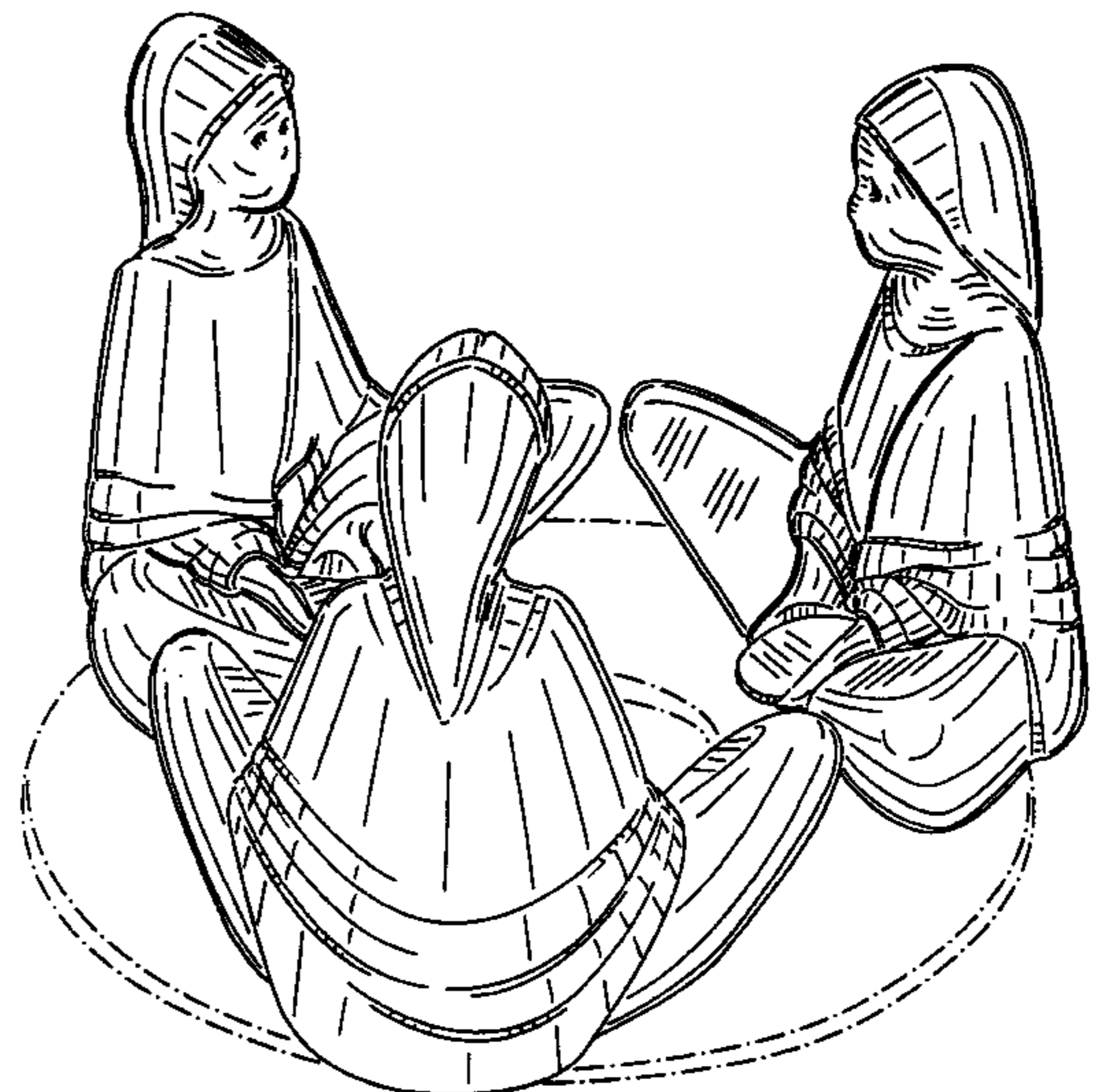
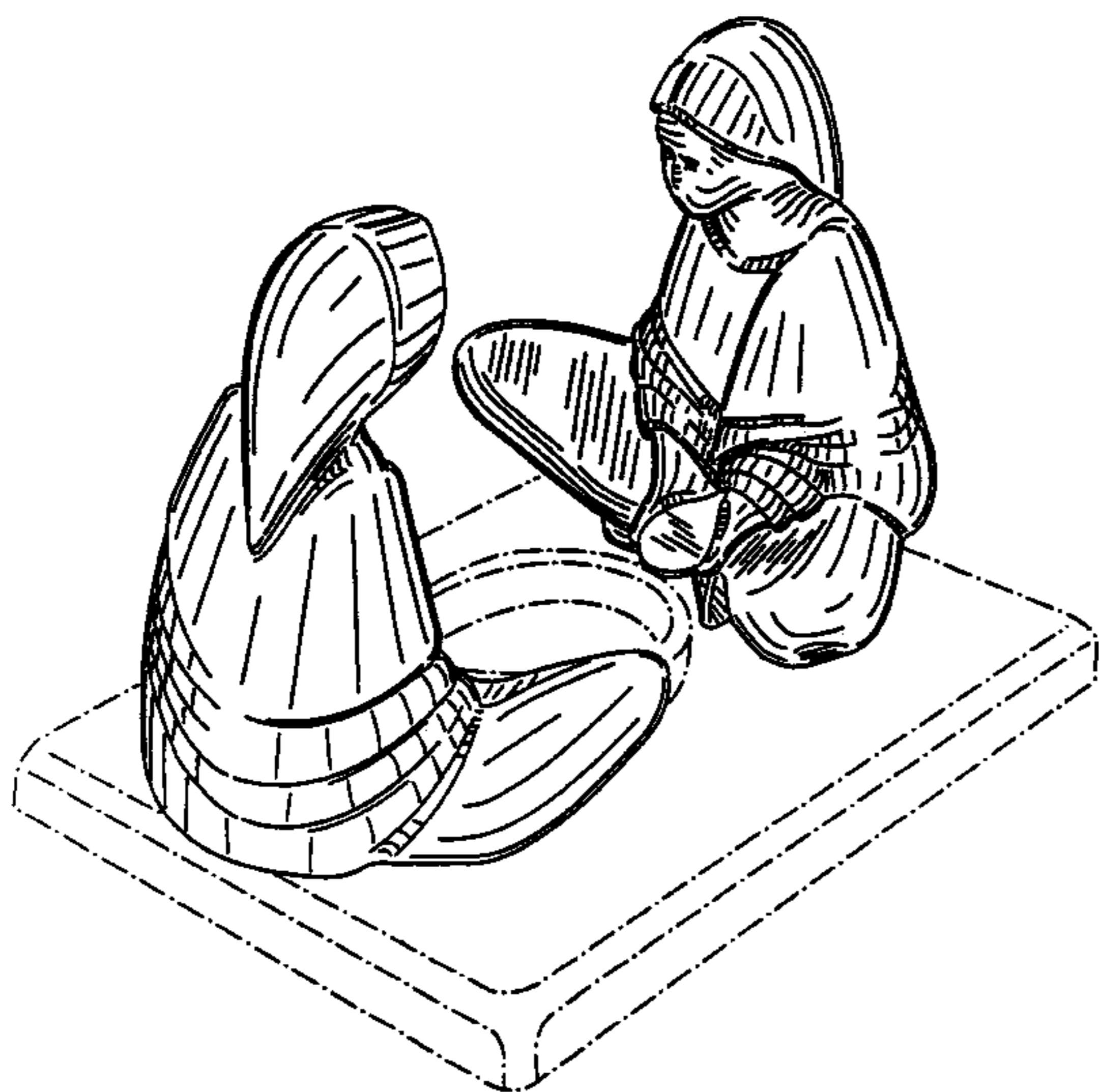
FIG. 10 is a top perspective view of a fourth variant of the candle holder in accordance with the present invention;

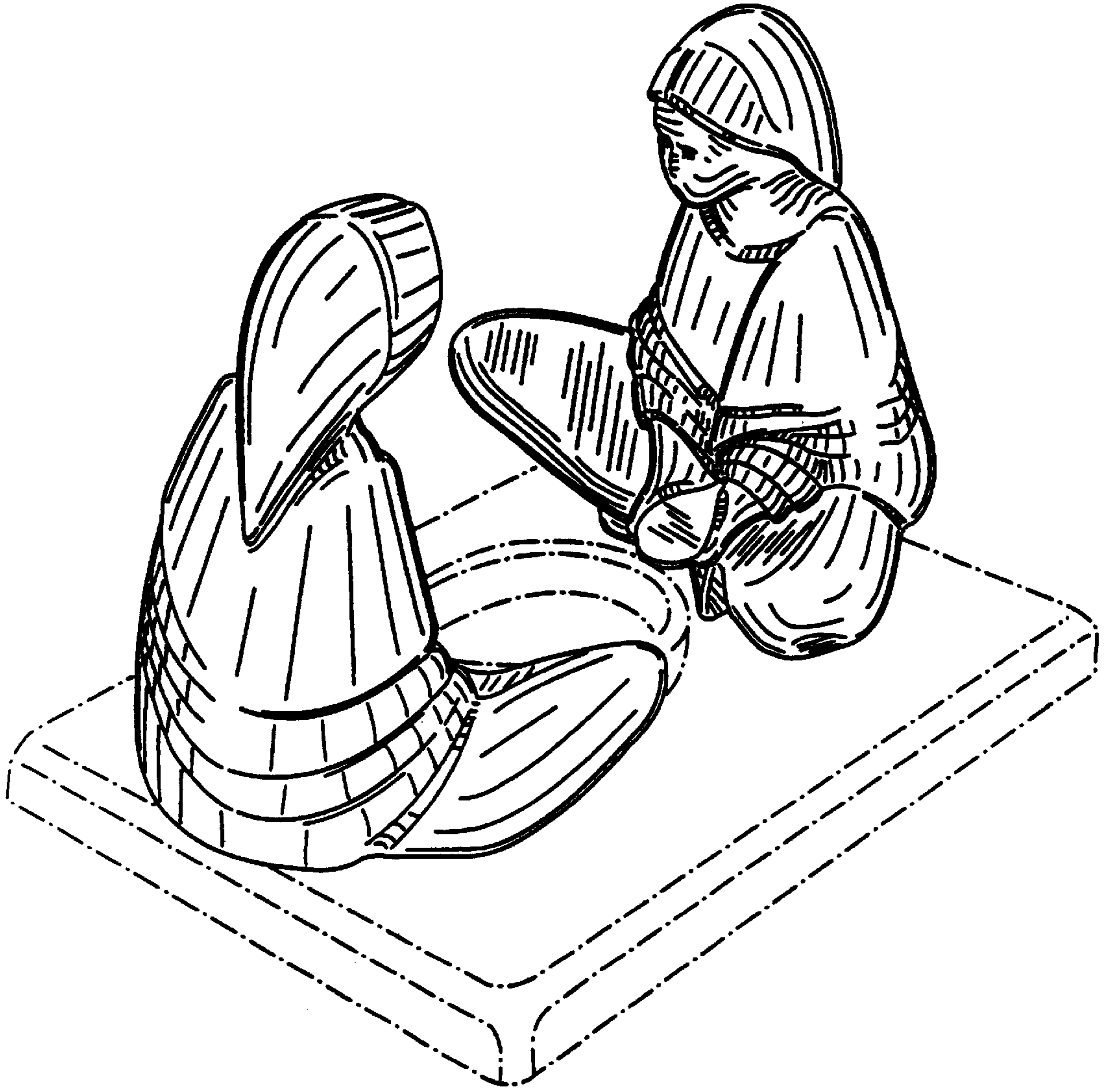

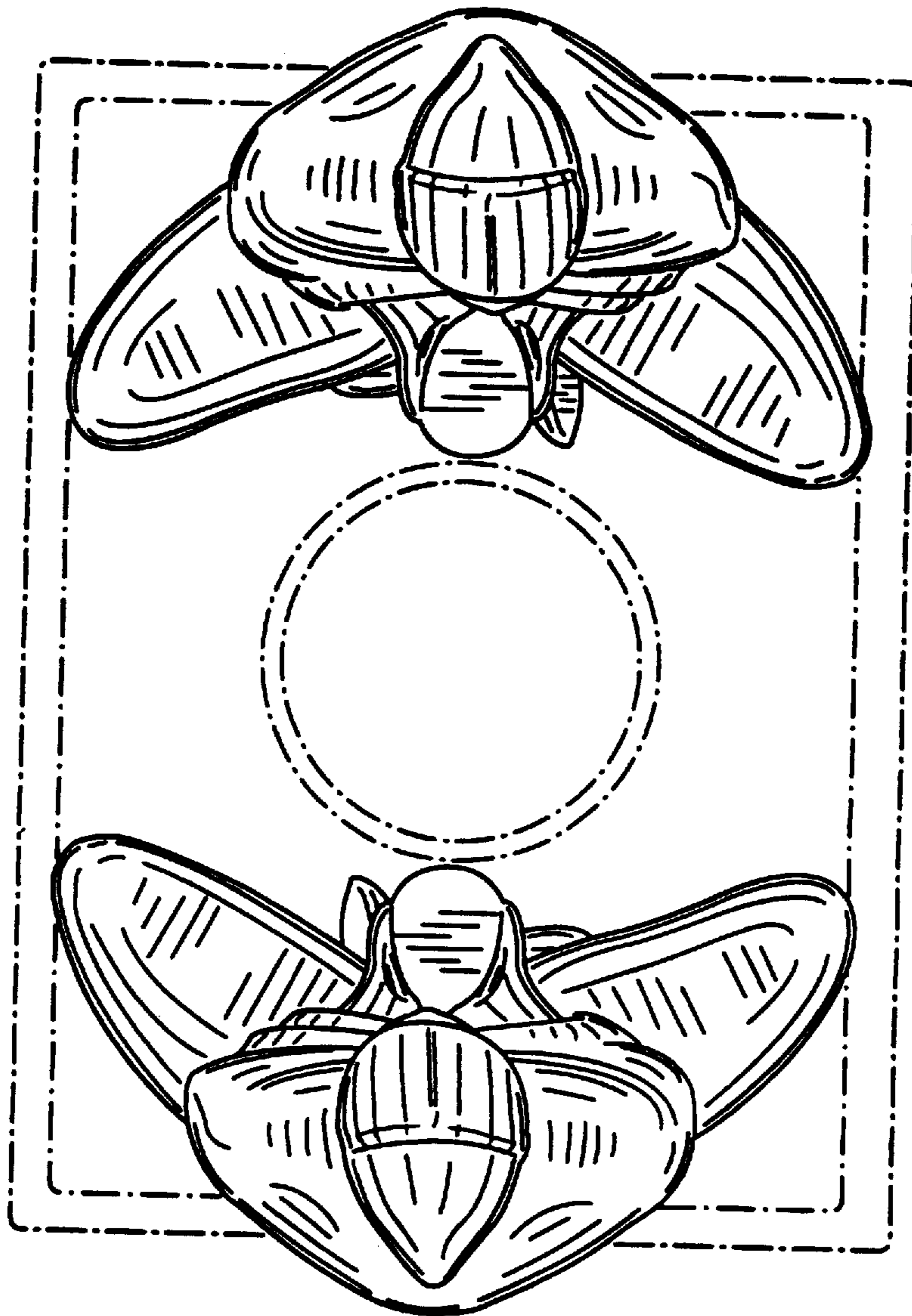
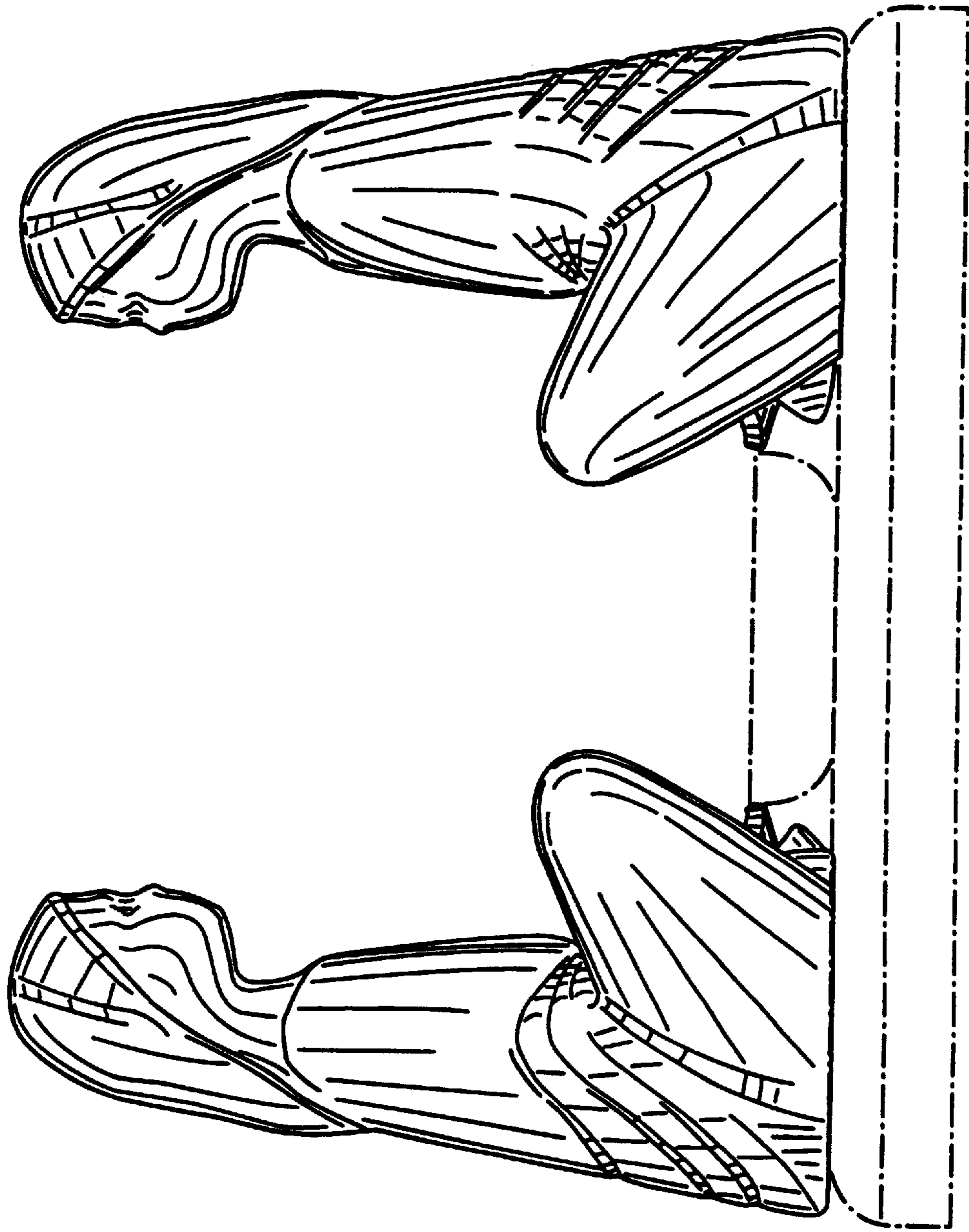

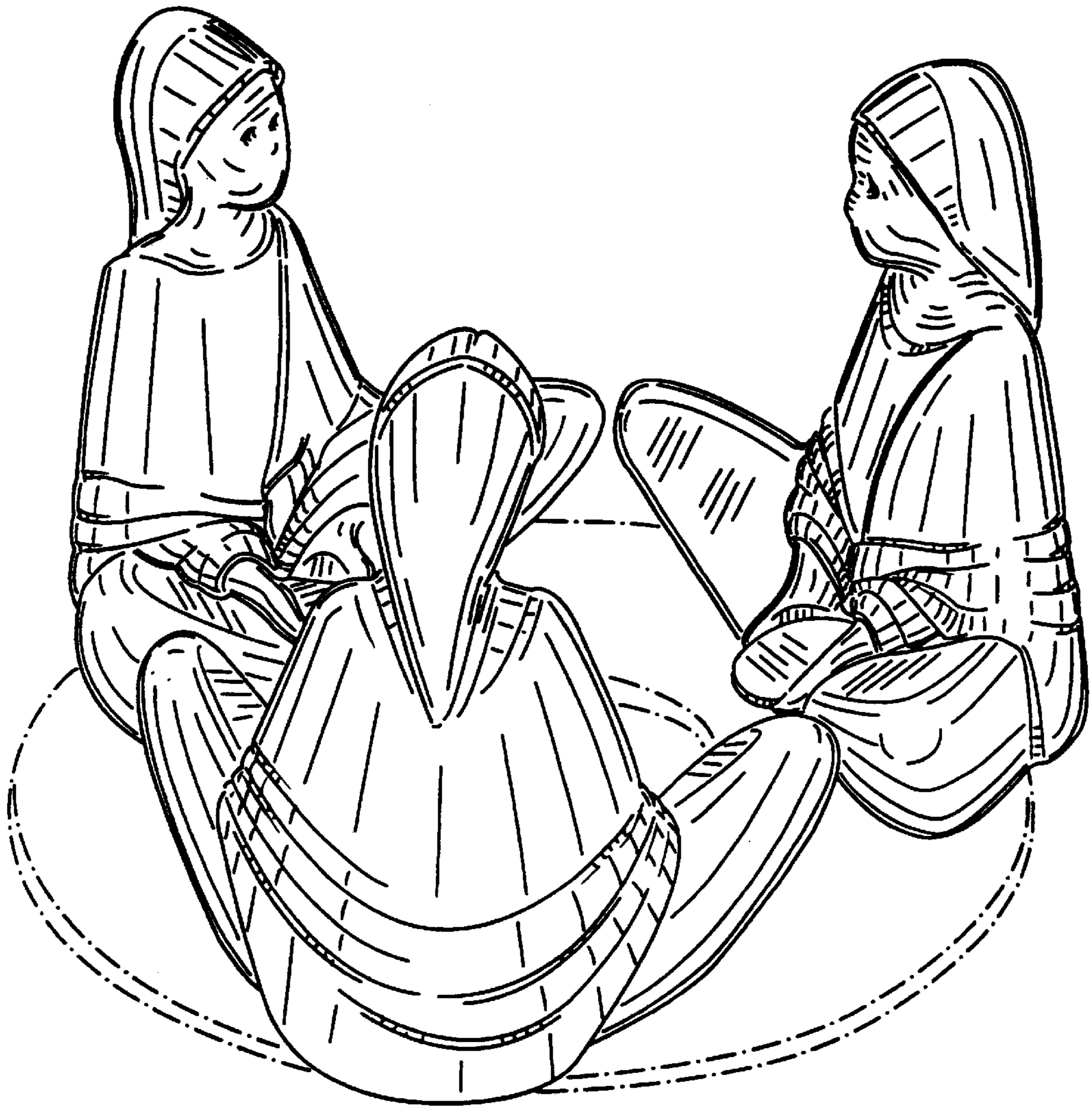

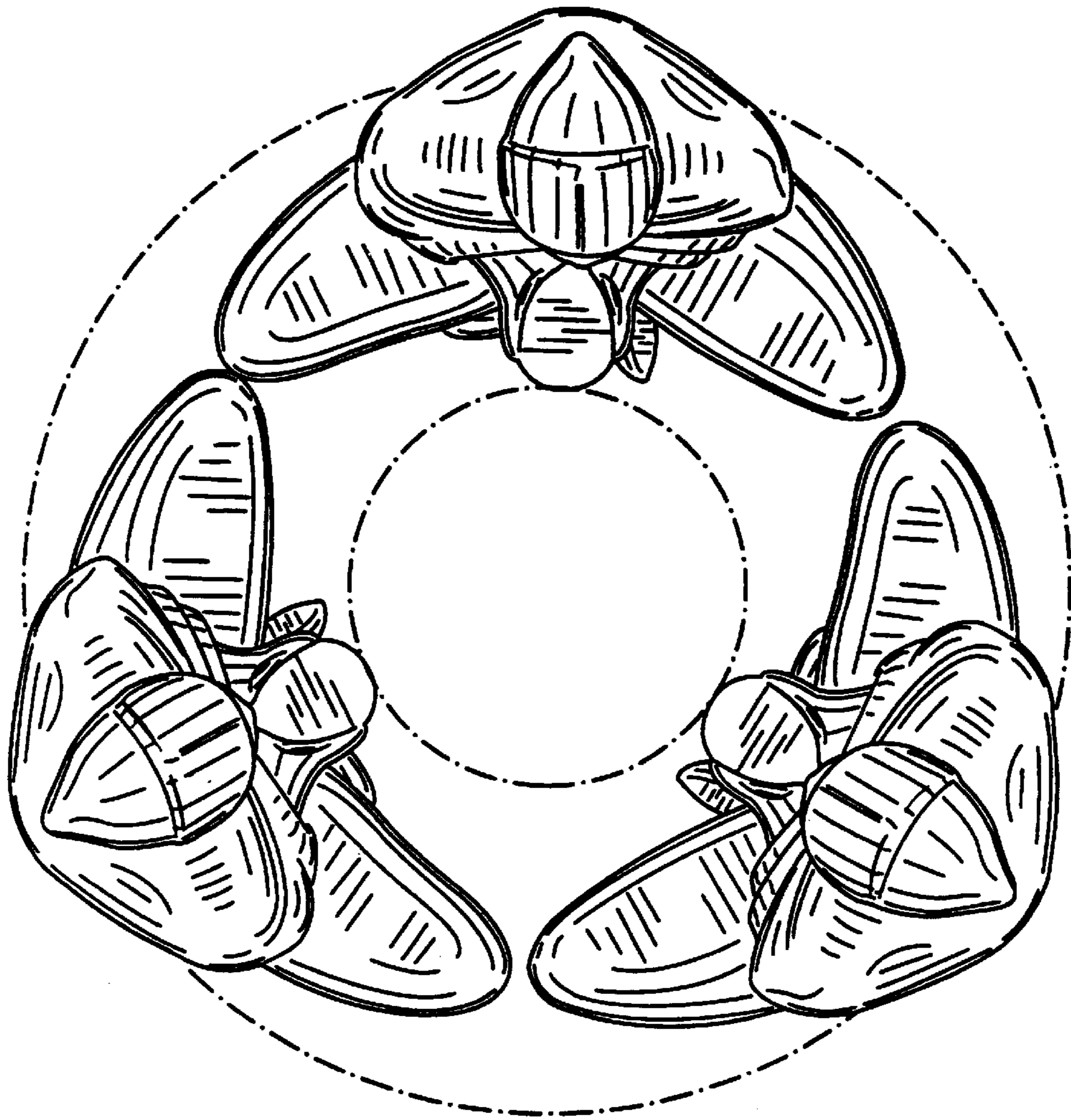
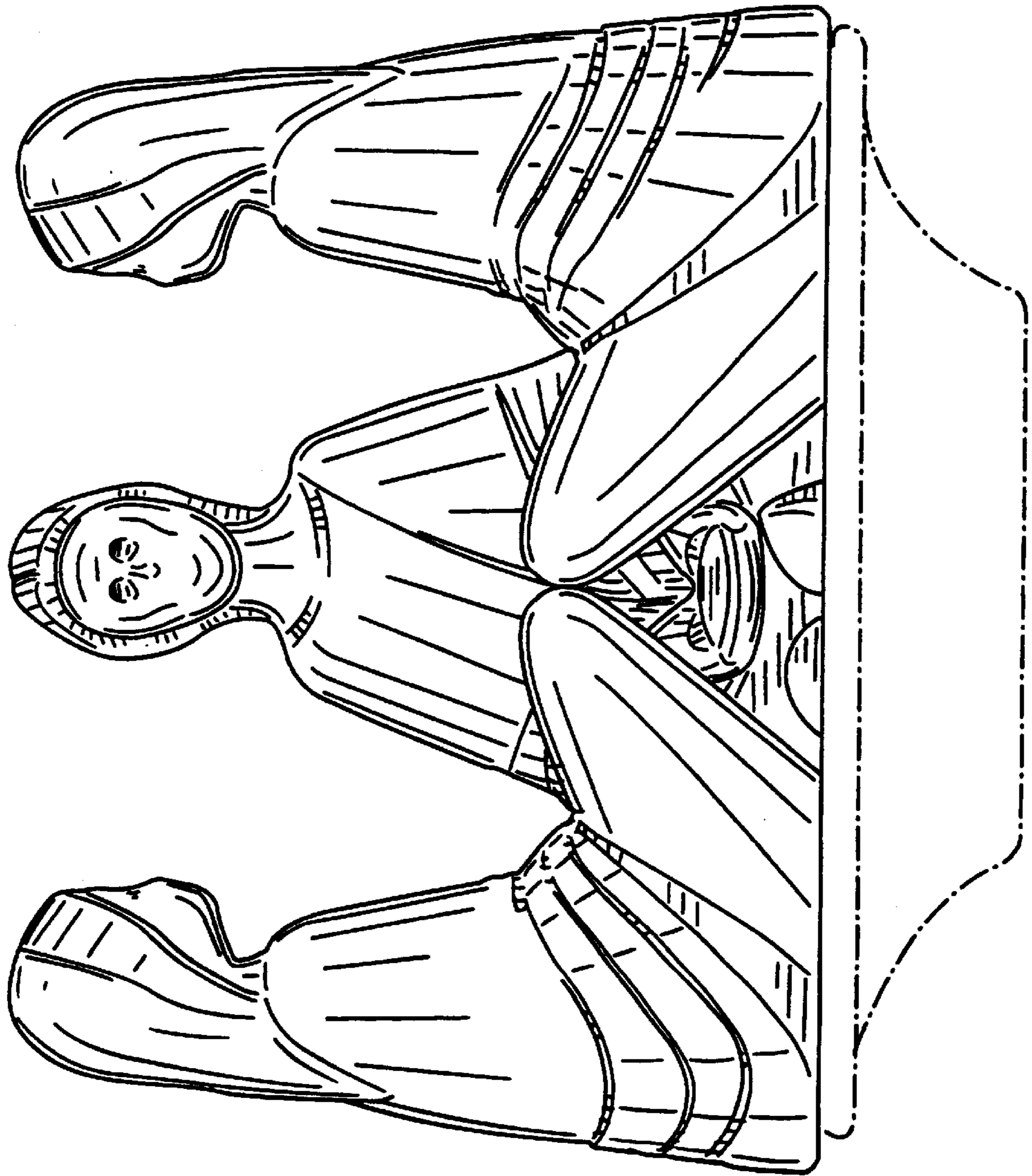

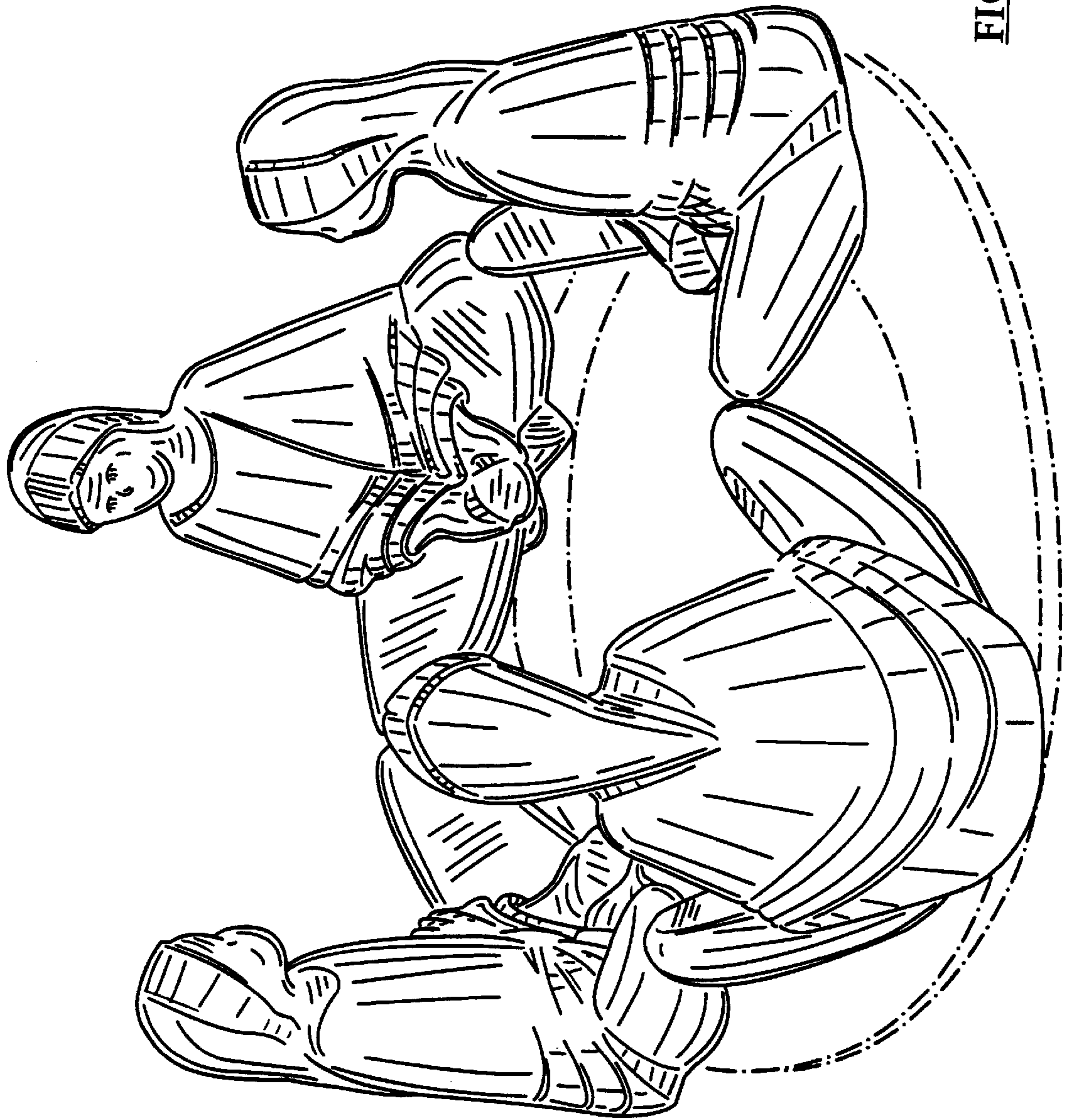

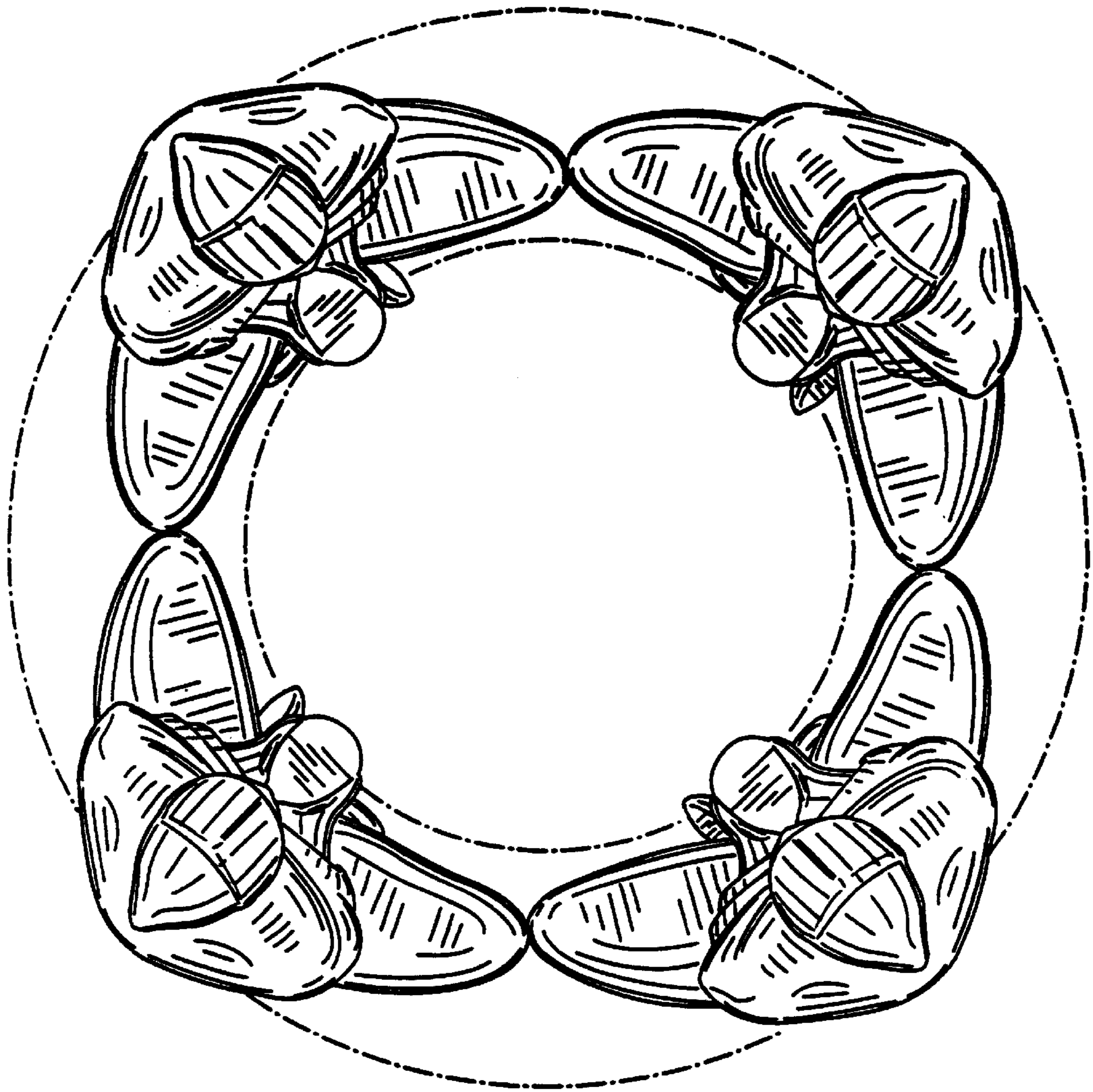
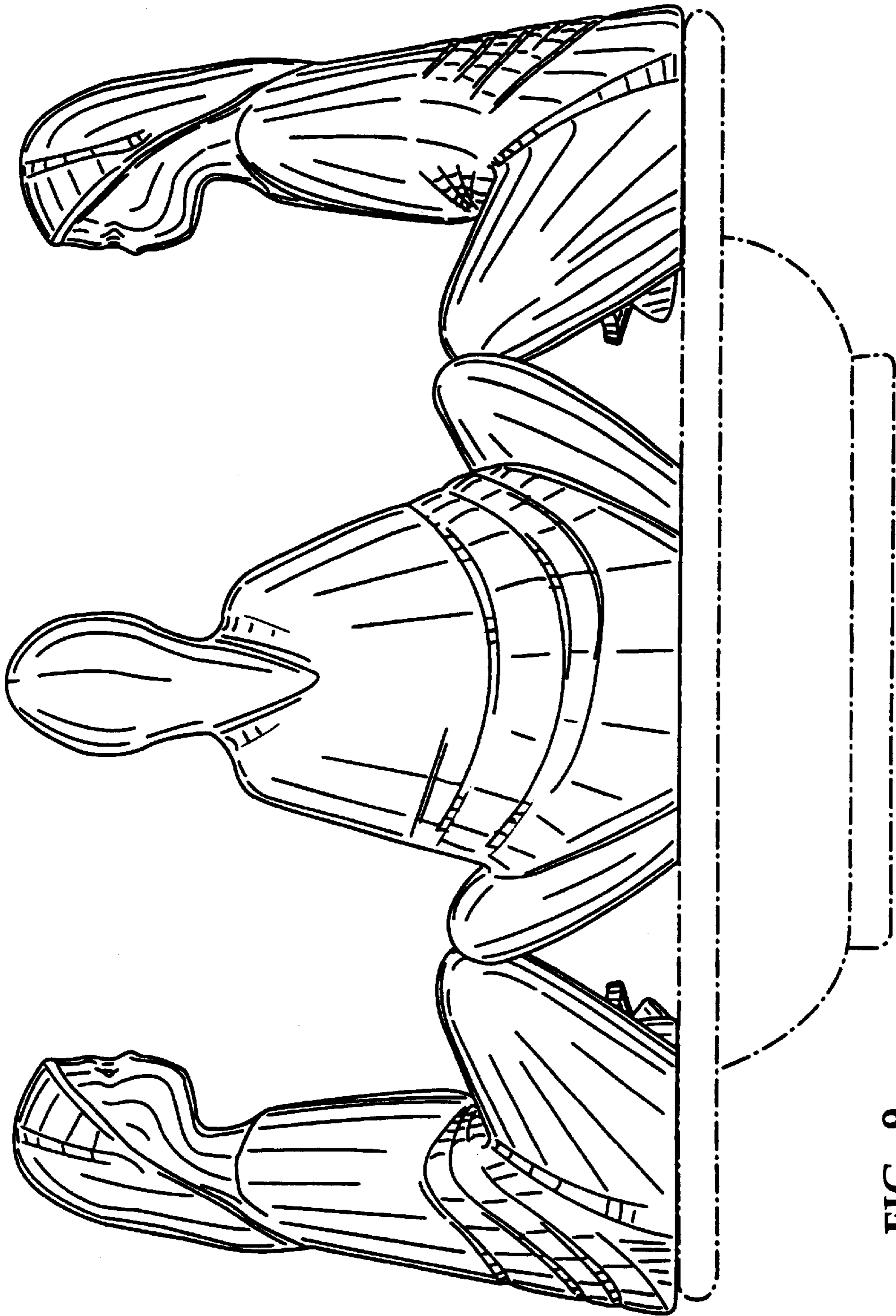

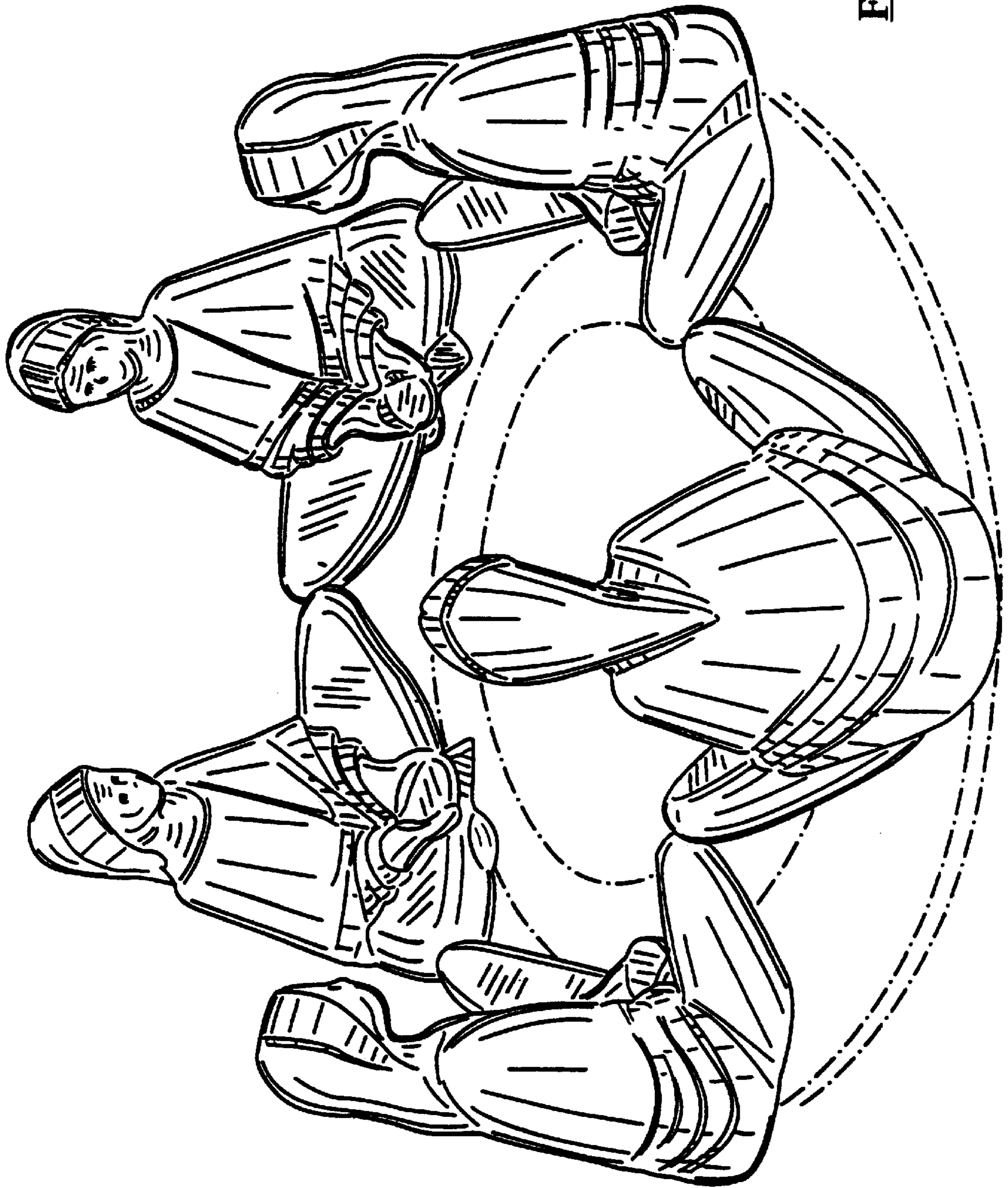

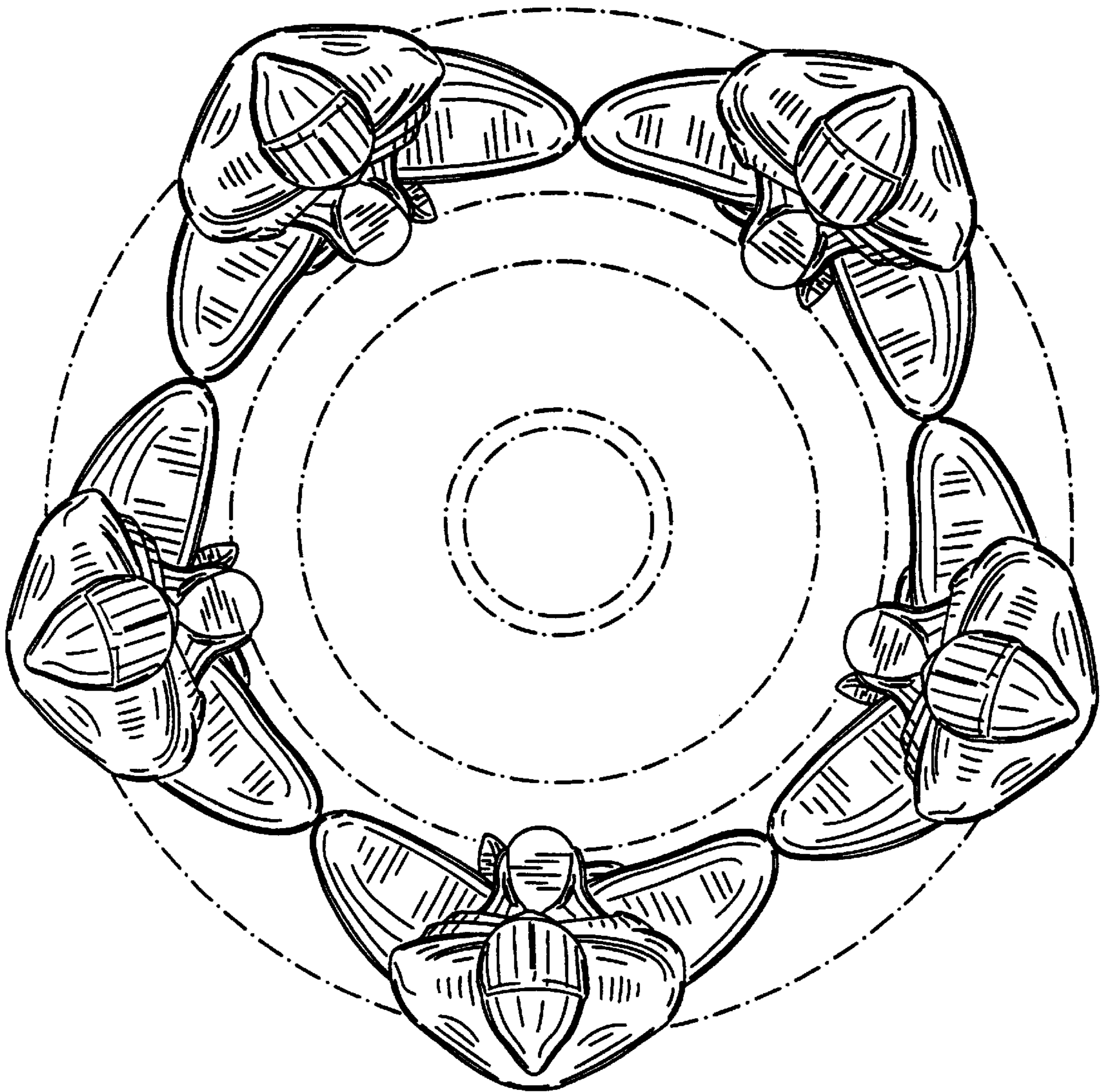

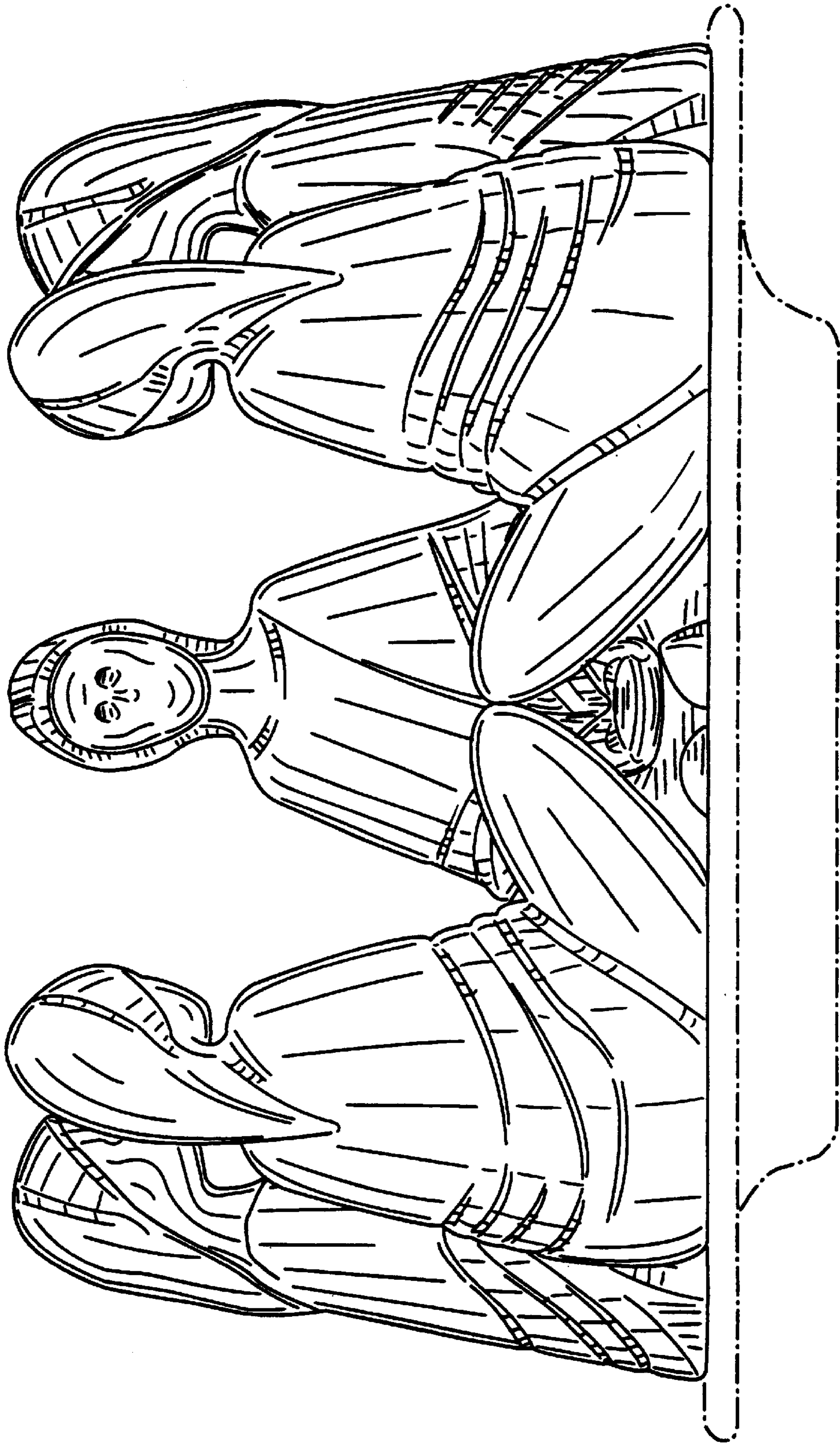
