(57) **CLAIM**

The ornamental design for a vertical dial stick case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a regular dial stick round

shaped lipstick case showing the invention;

FIG. 2 is a top view of the lipstick case of FIG. 1;

FIG. 3 is a bottom view of the lipstick case of FIG. 1;

FIG. 4 is a left side view of the lipstick case of FIG. 1;

FIG. 5 is a right side view of the lipstick case of FIG. 1; and,

FIG. 6 is a rear view of the lipstick case of FIG. 1;

FIG. 7 is a perspective view of a round shaped foundation dial stick case showing a second embodiment of the invention;

FIG. 8 is a top view of the foundation case of FIG. 7;

FIG. 9 is a bottom view of the foundation case of FIG. 7;

FIG. 10 is a left side view of the foundation case of FIG. 7;

FIG. 11 is a right side view of the foundation case of FIG. 7; and,

FIG. 12 is a rear view of the foundation case of FIG. 7;

FIG. 13 is a perspective view of a regular dial stick oval shaped lipstick case showing a third embodiment of the invention;

FIG. 14 is a top view of the lipstick case of FIG. 13;

FIG. 15 is a bottom view of the lipstick case of FIG. 13;

FIG. 16 is a left side view of the lipstick case of FIG. 13;

FIG. 17 is a right side view of the lipstick case of FIG. 13; and,

FIG. 18 is a rear view of the lipstick case of FIG. 13;

FIG. 19 is a perspective view of an oval shaped foundation dial stick case showing a fourth embodiment of the invention;

FIG. 20 is a top view of the foundation case of FIG. 19;

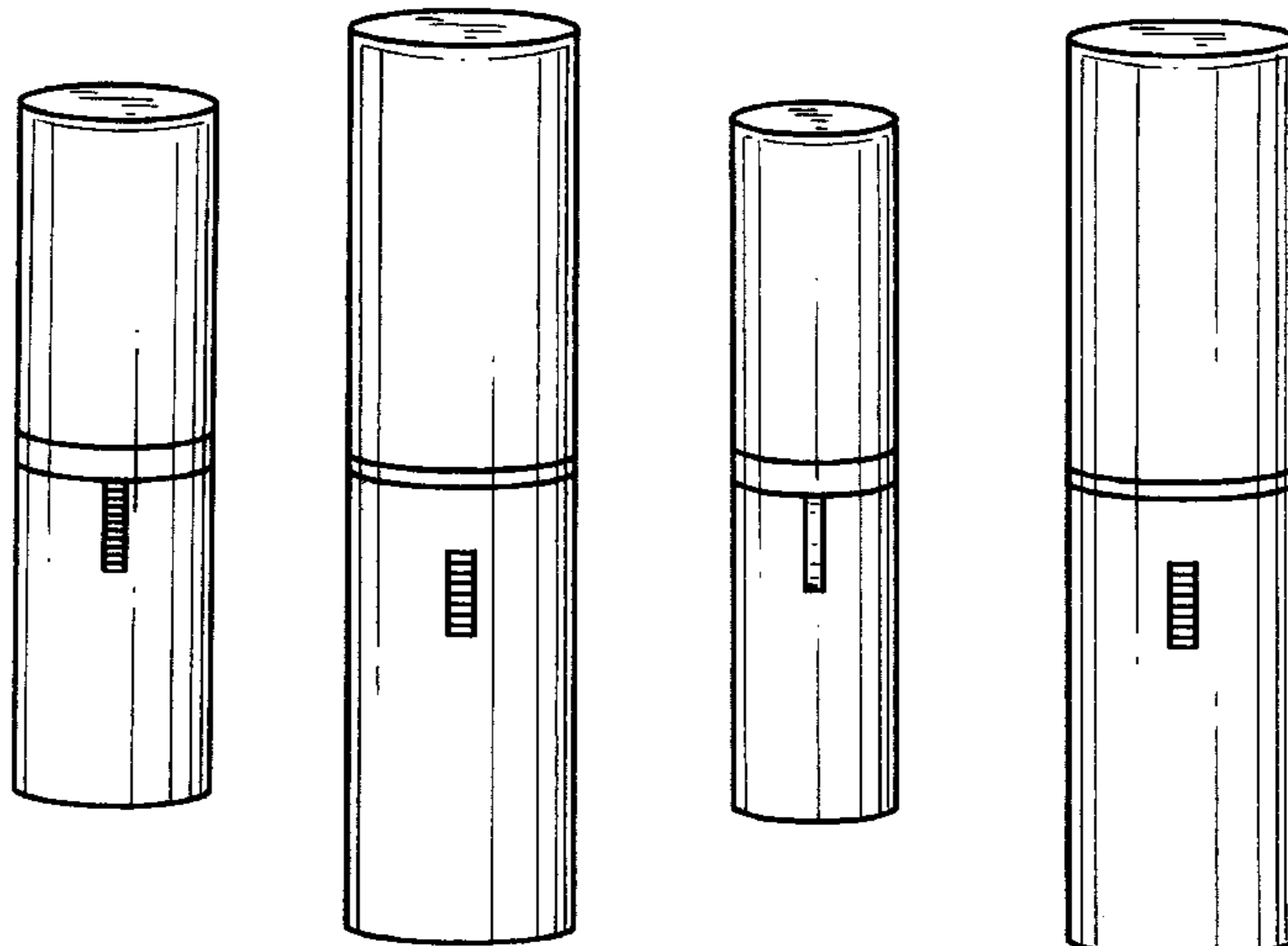
FIG. 21 is a bottom view of the foundation case of FIG. 19;

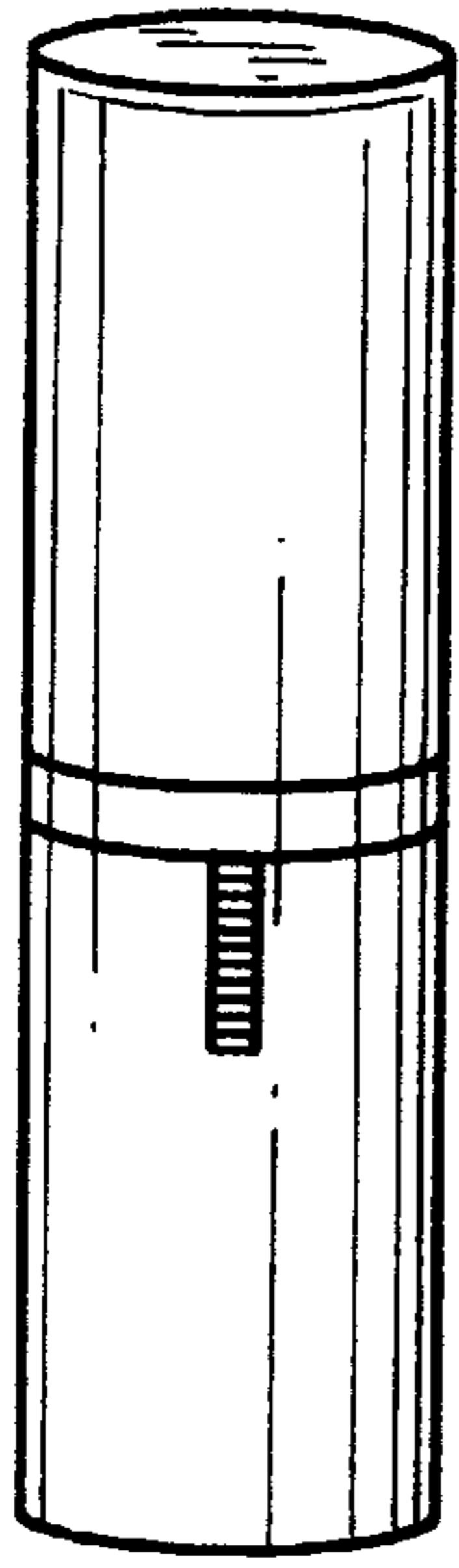

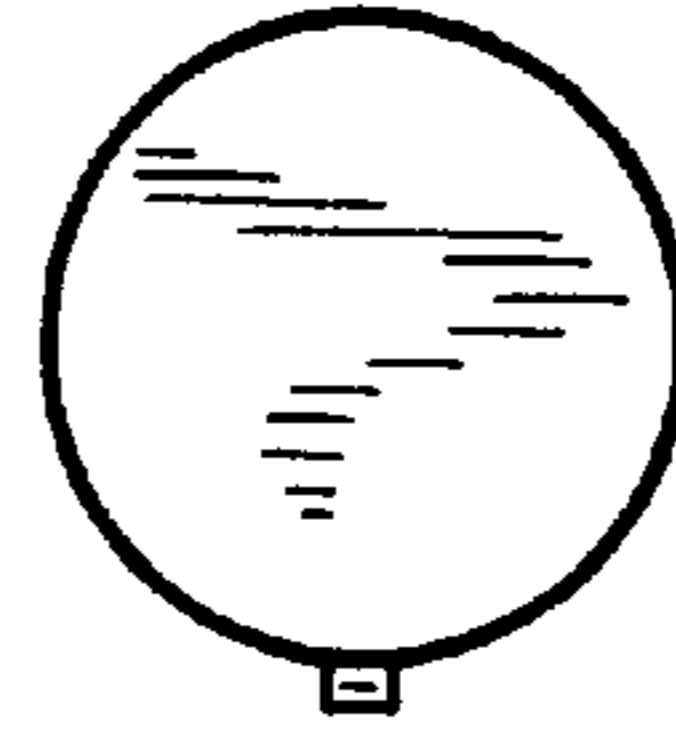

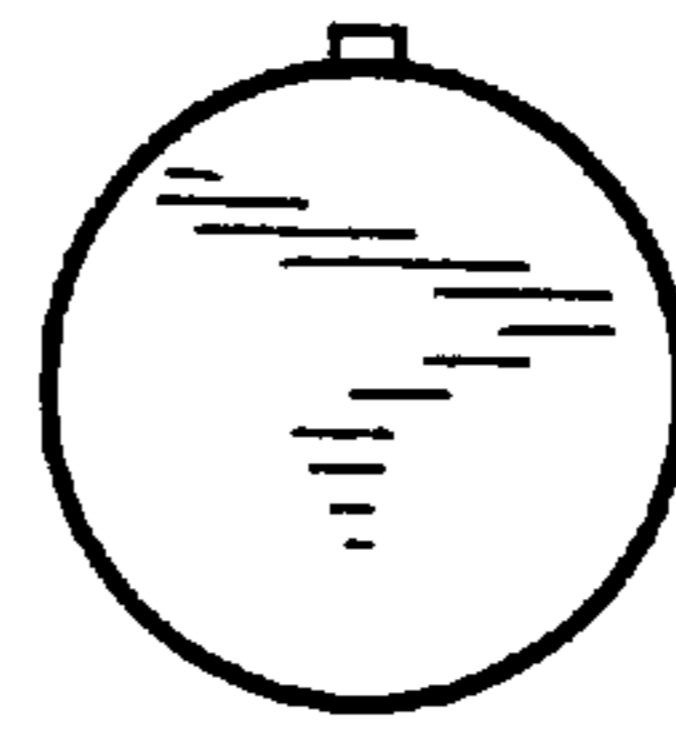

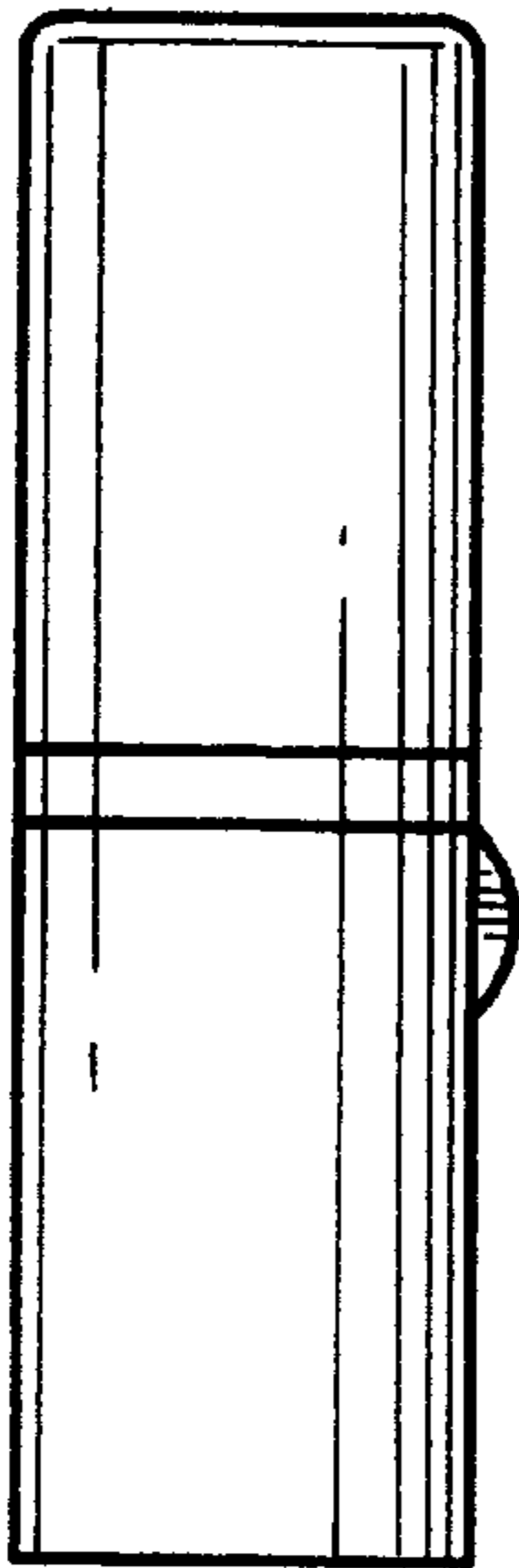

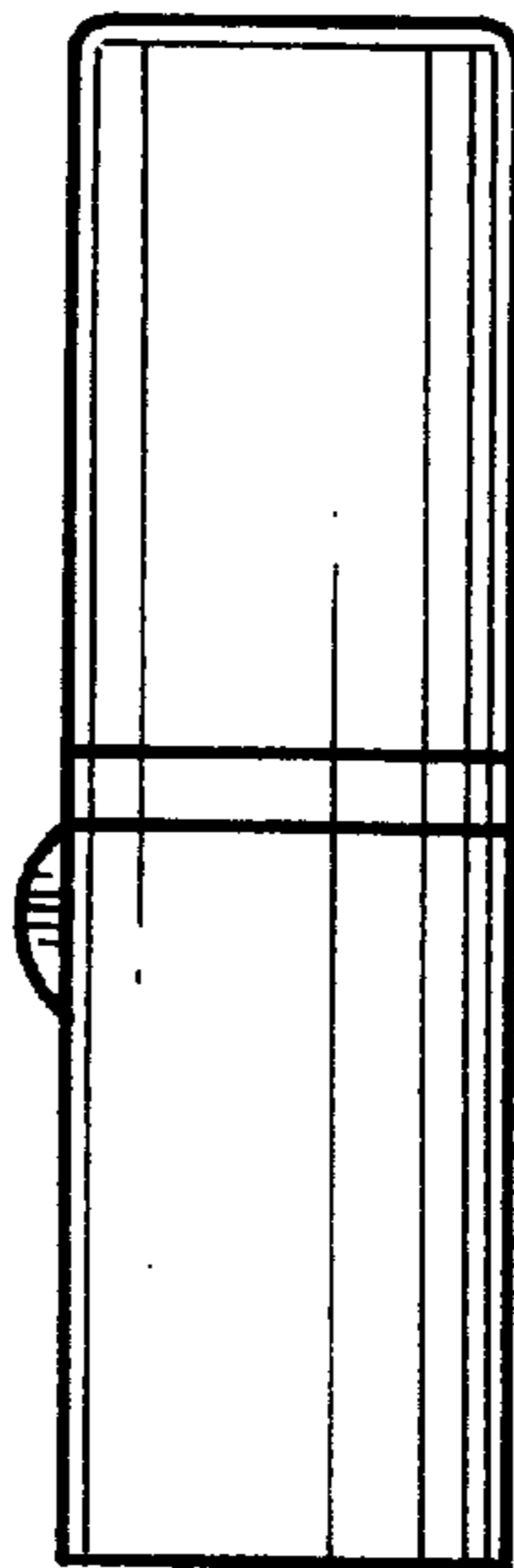

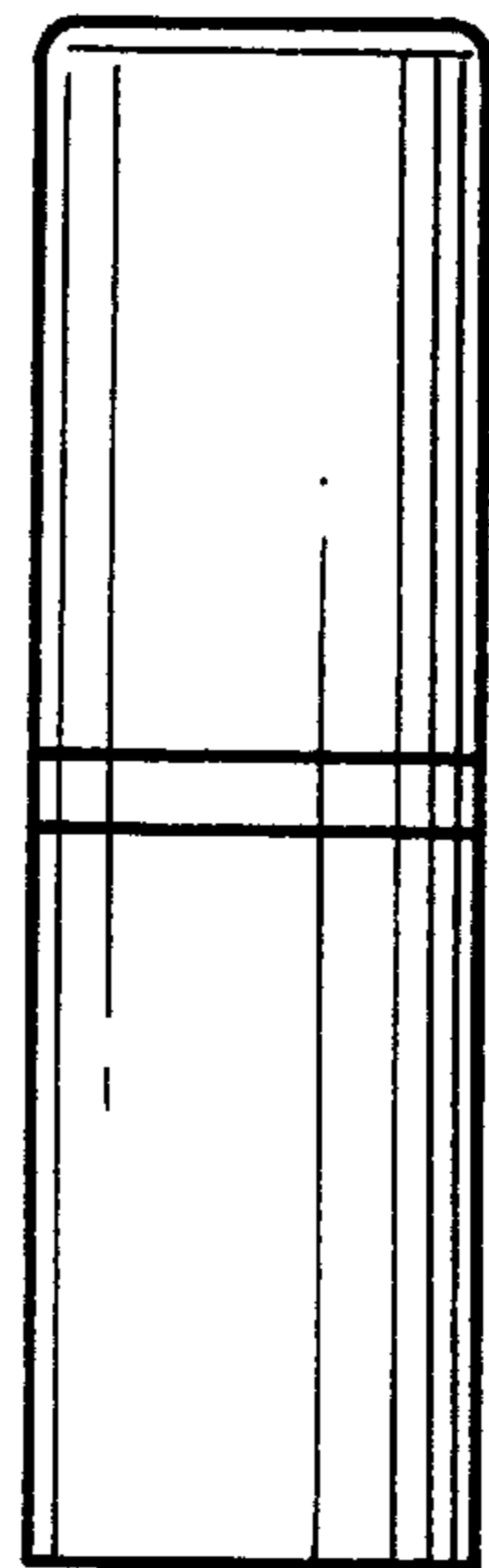

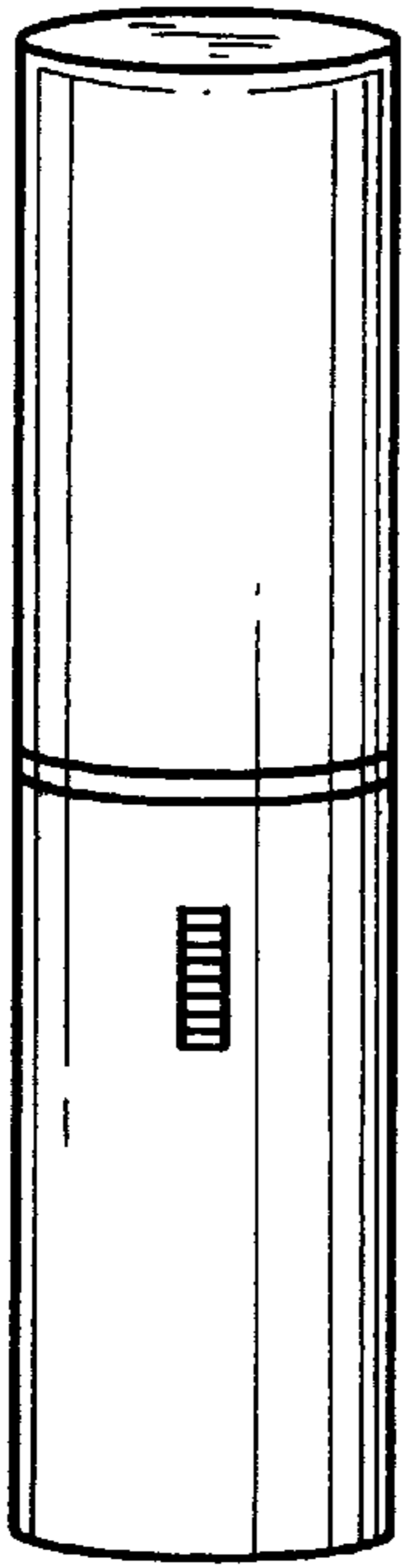

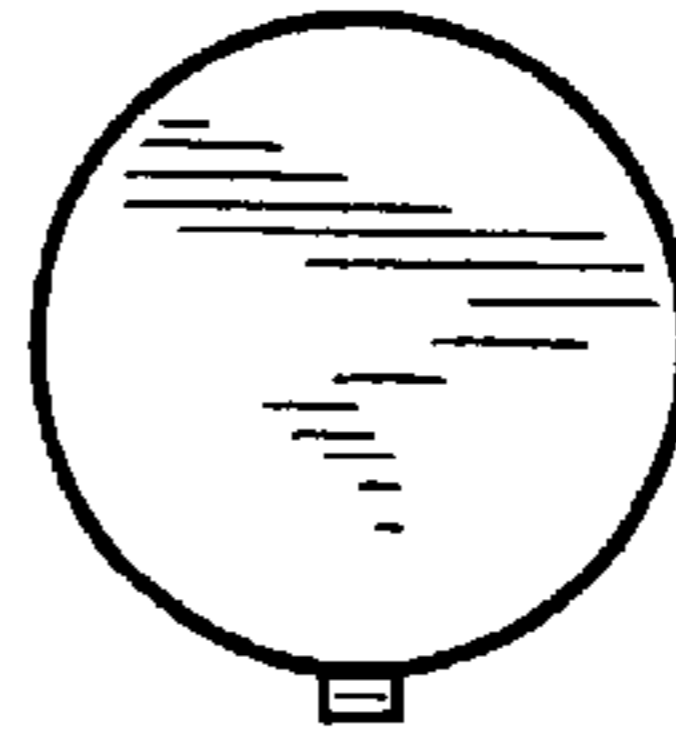

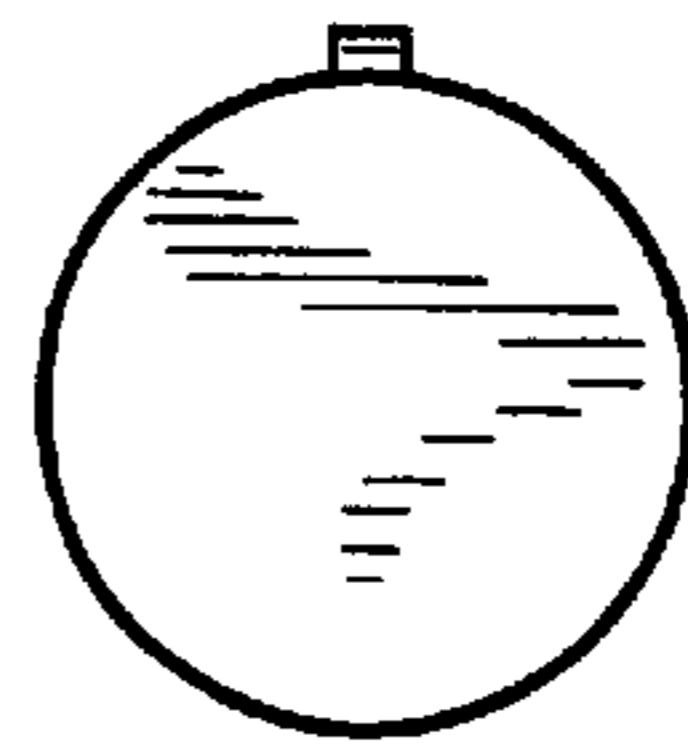

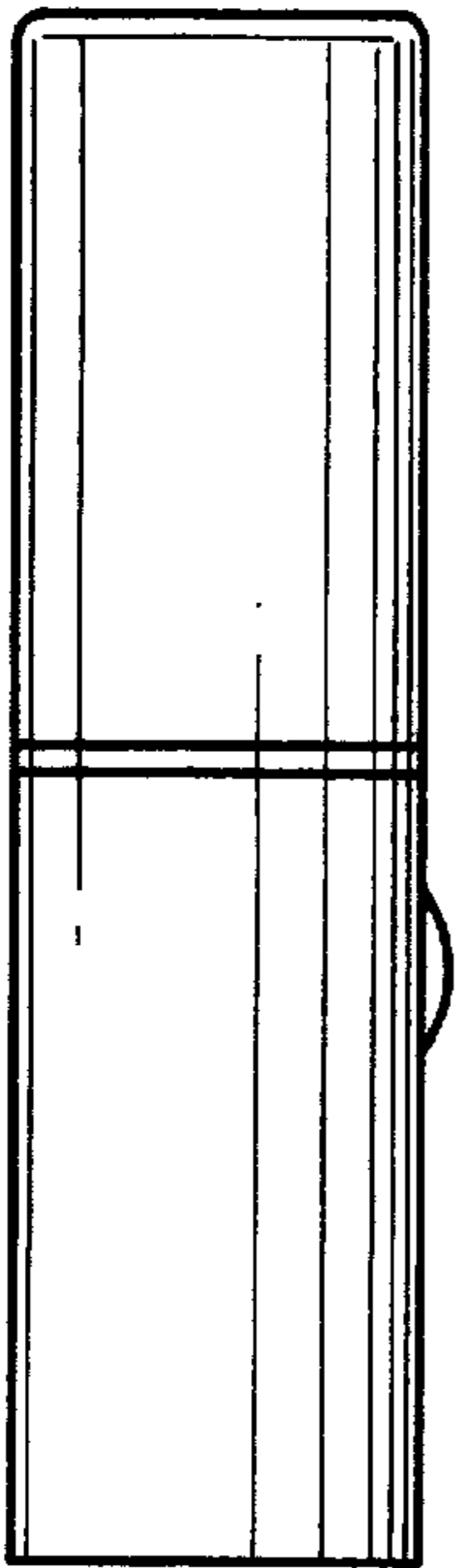

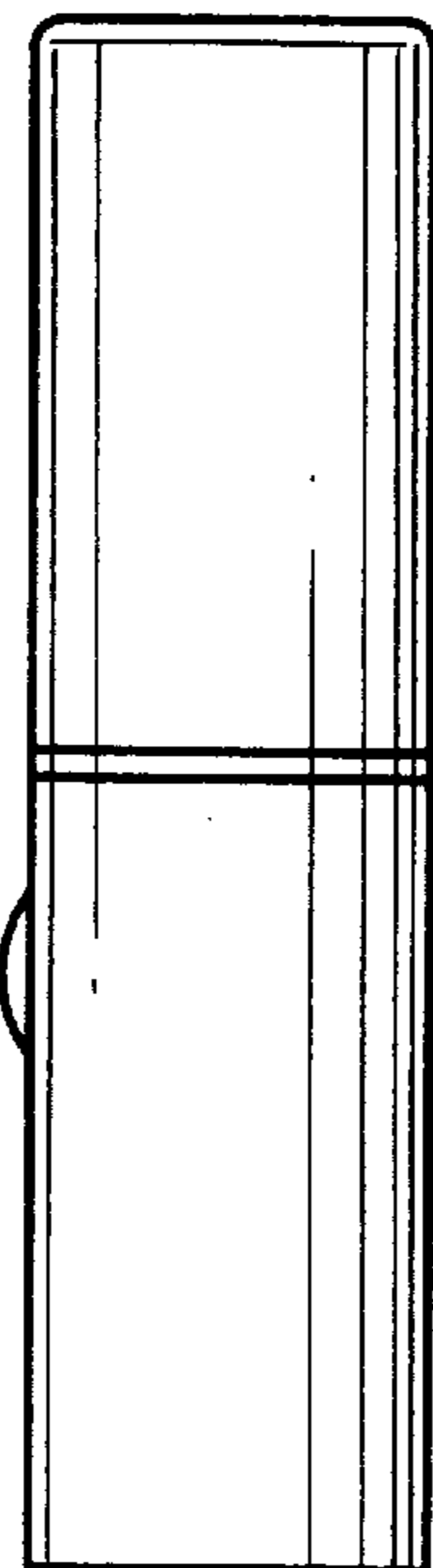

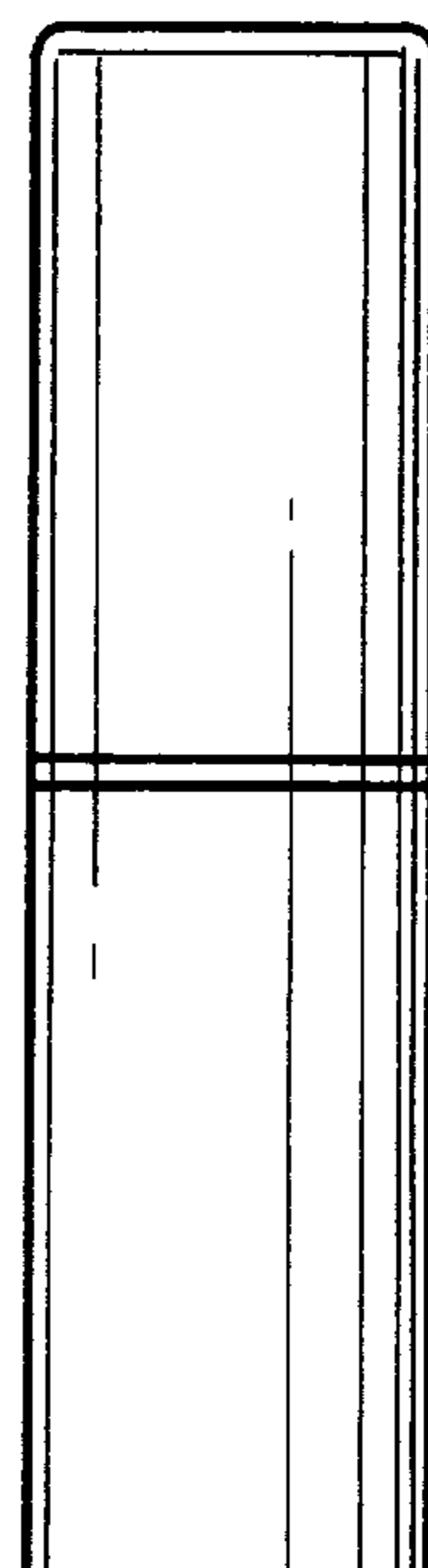

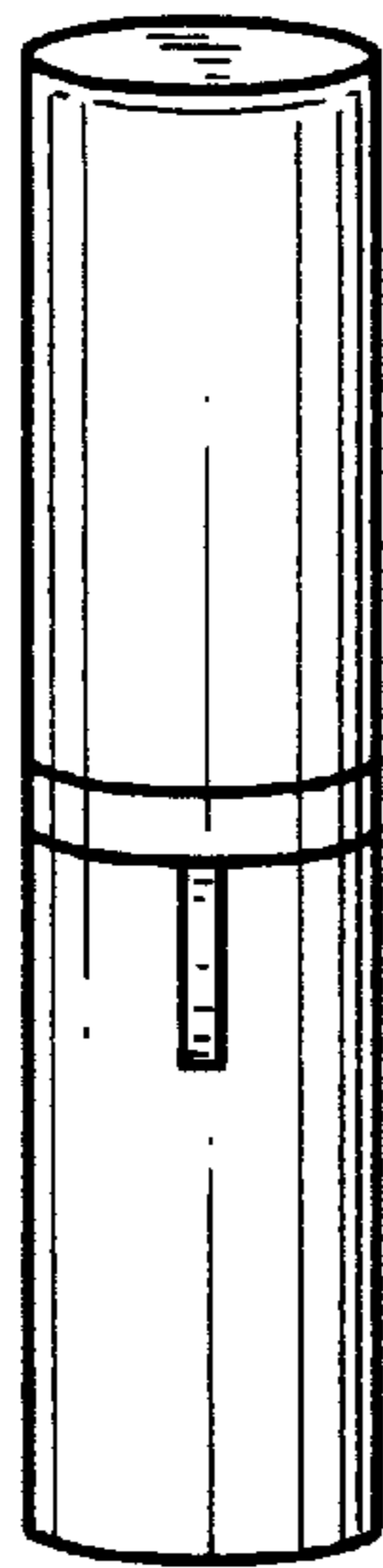

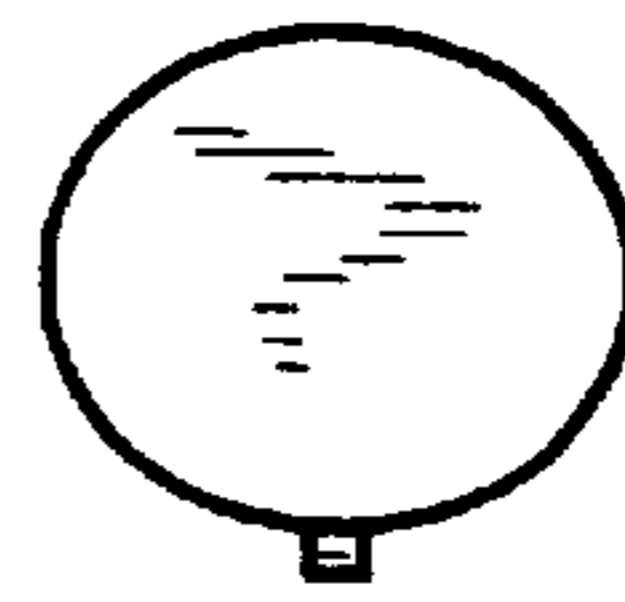

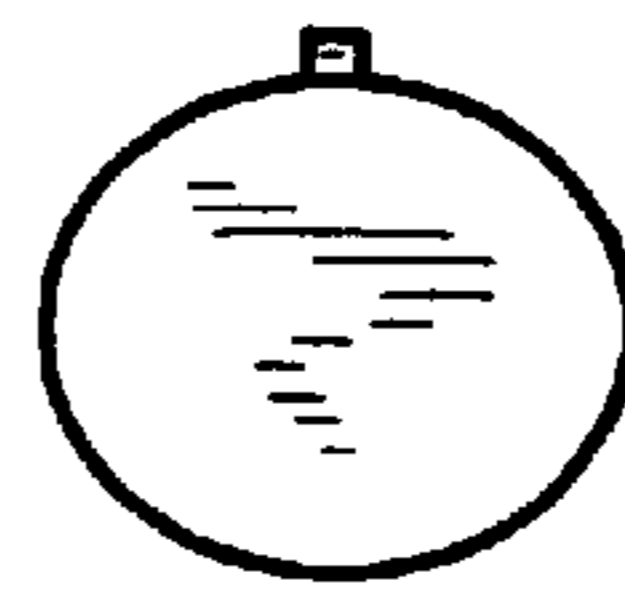

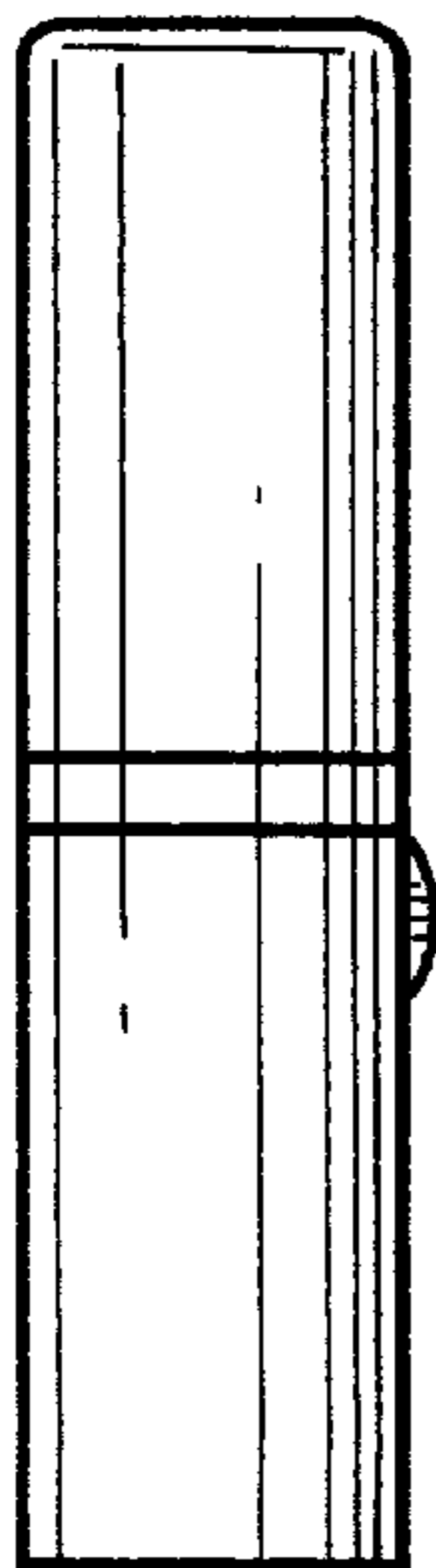

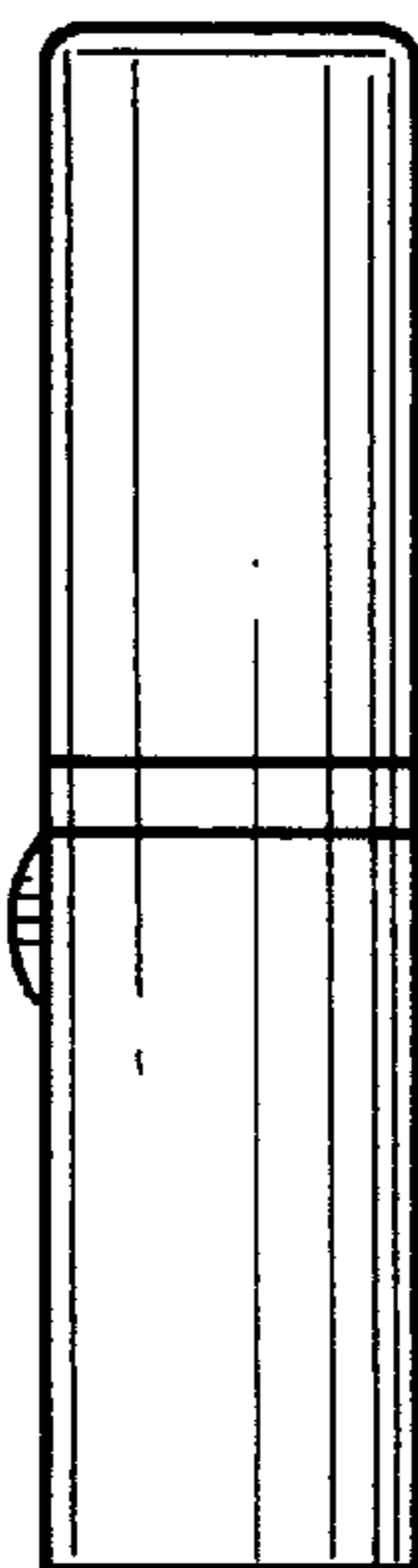

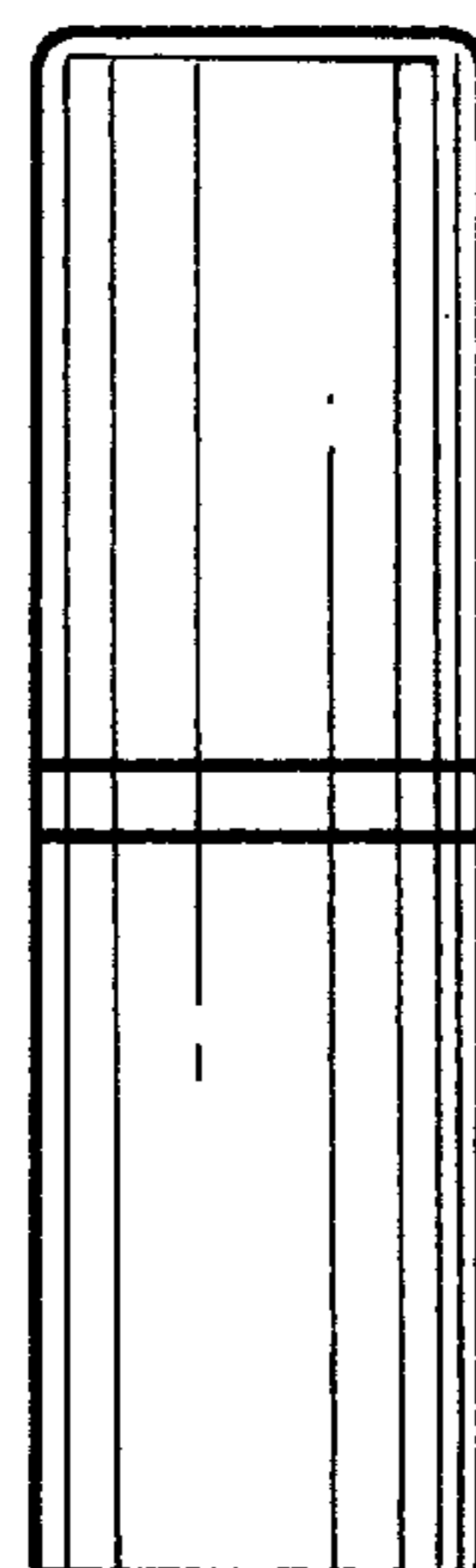

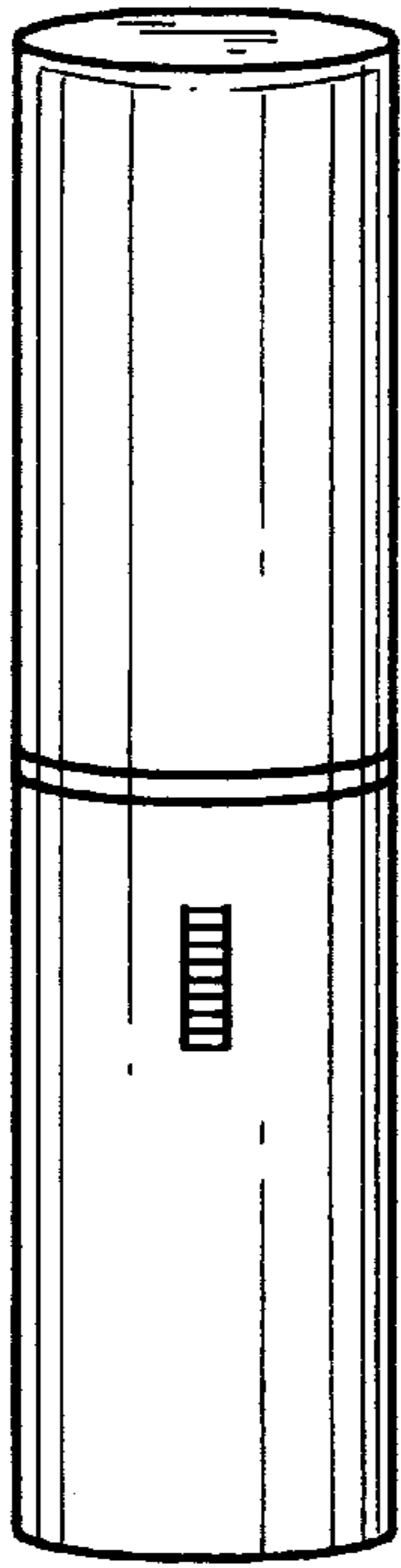

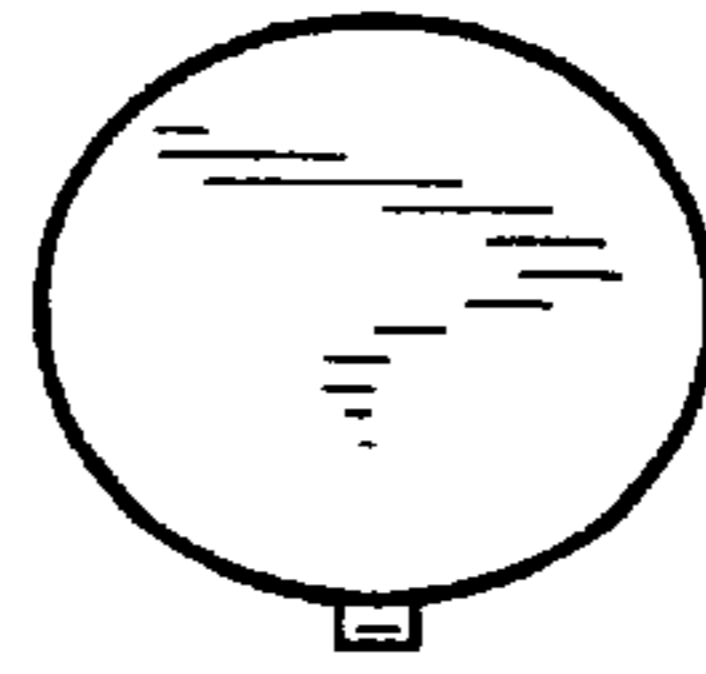

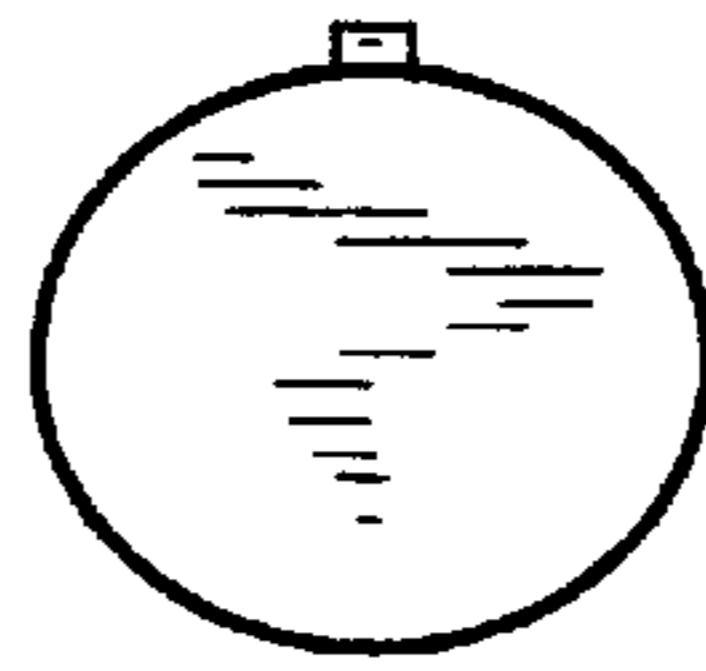

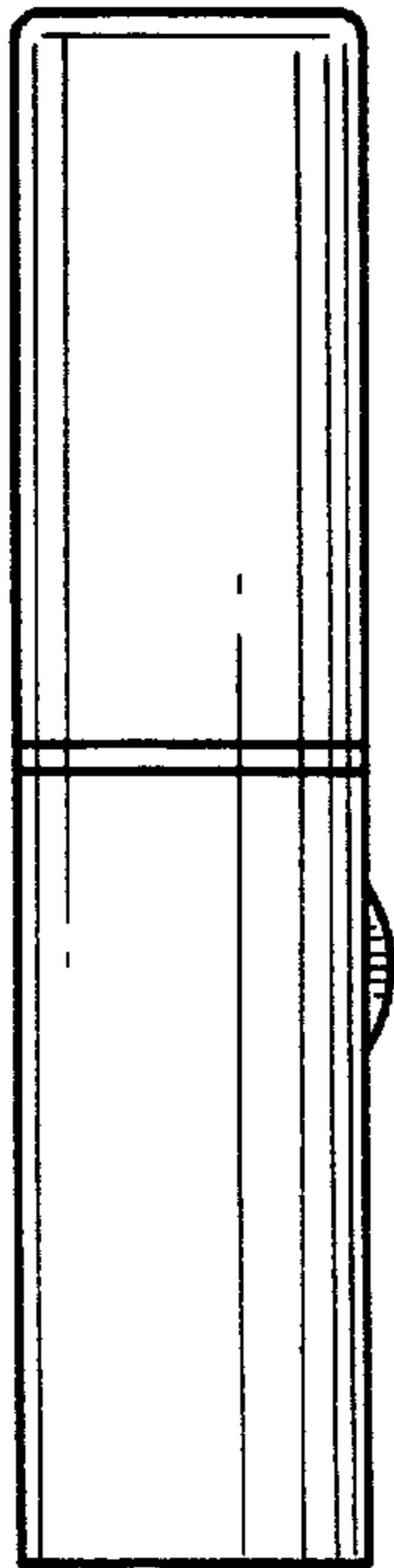

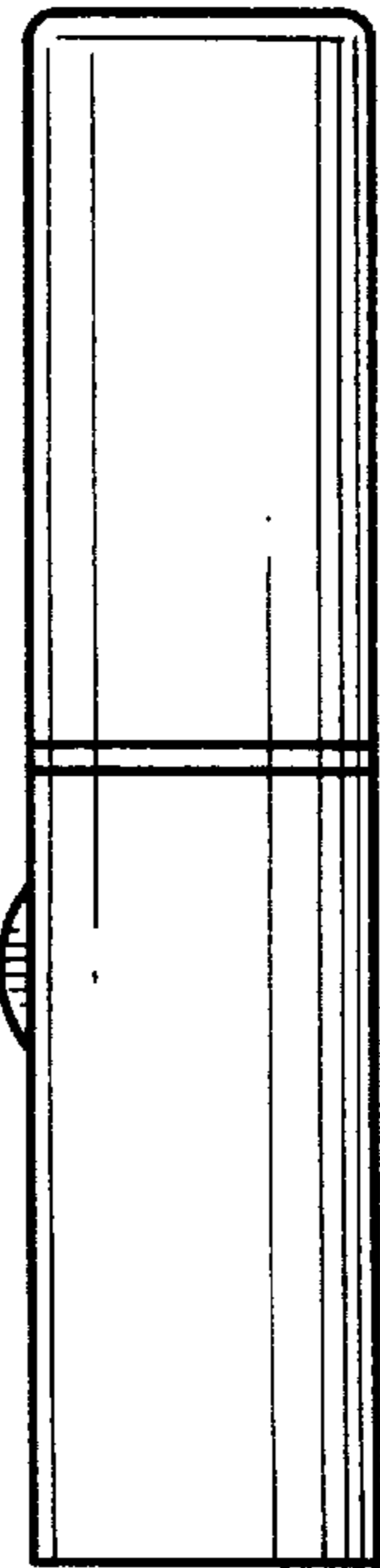

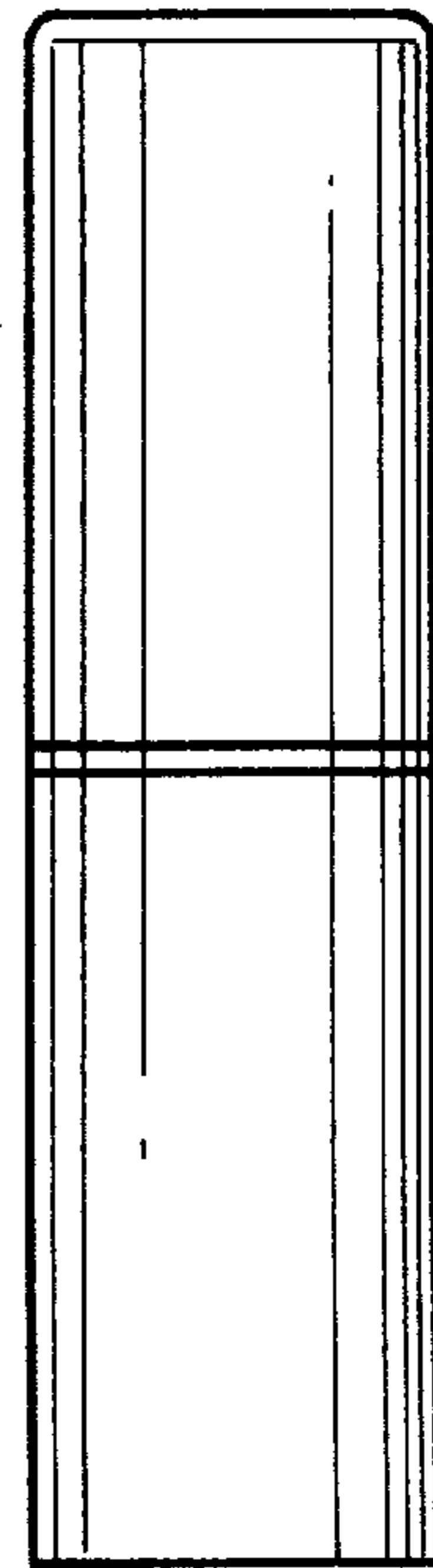
