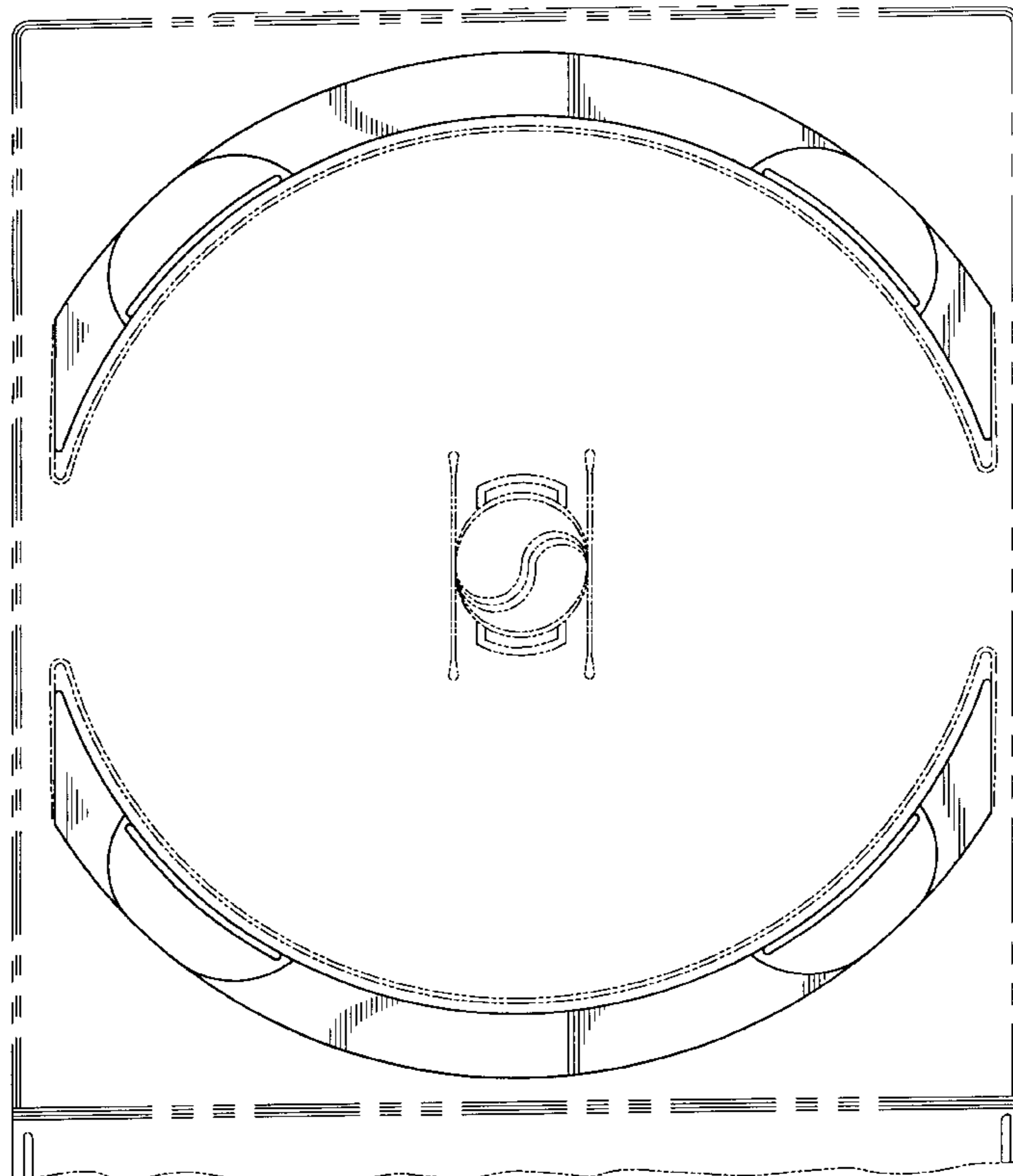
FIG. 1 is a top plan view of a disc holder showing my new

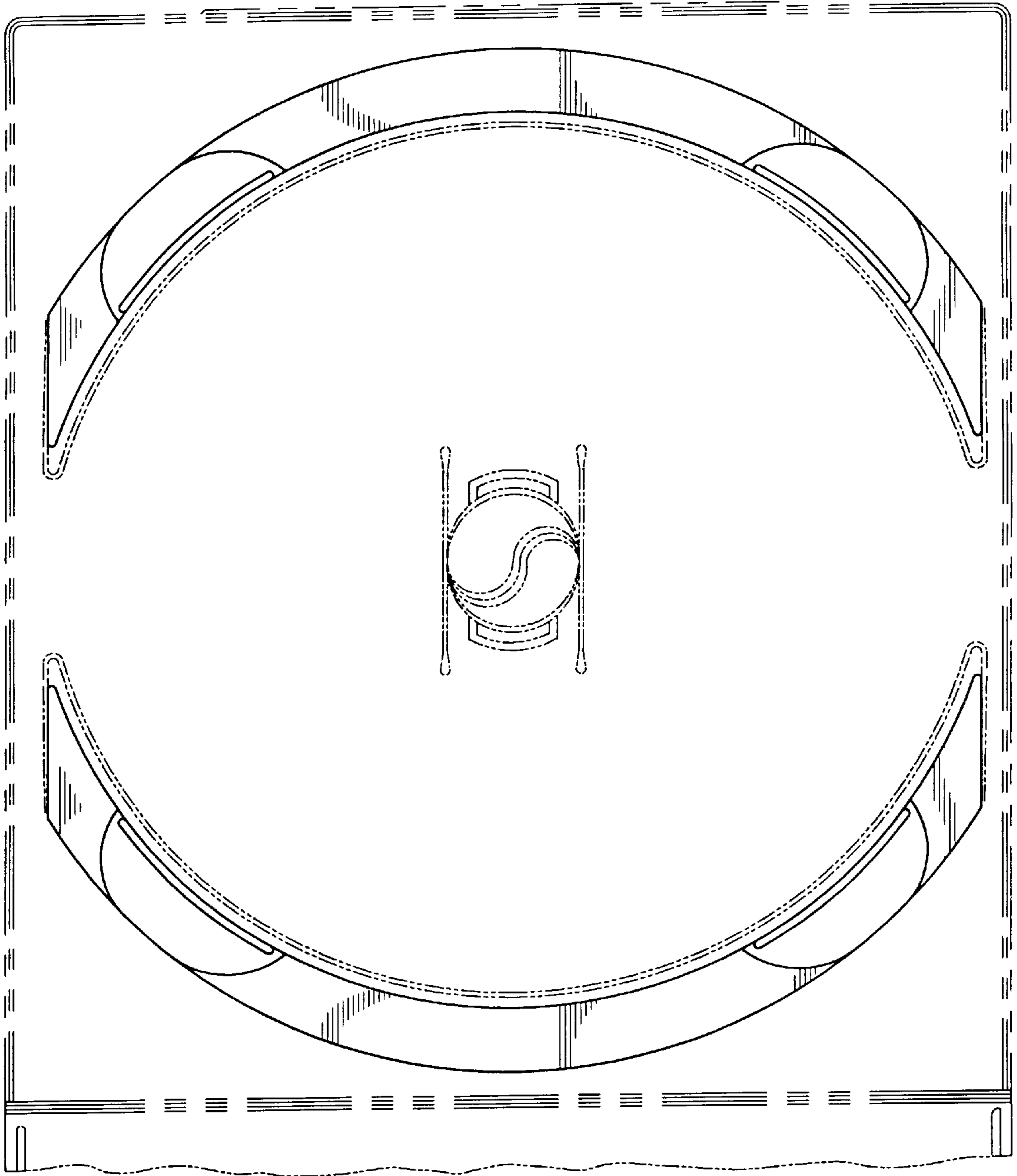
