illustrated in FIG. 1.

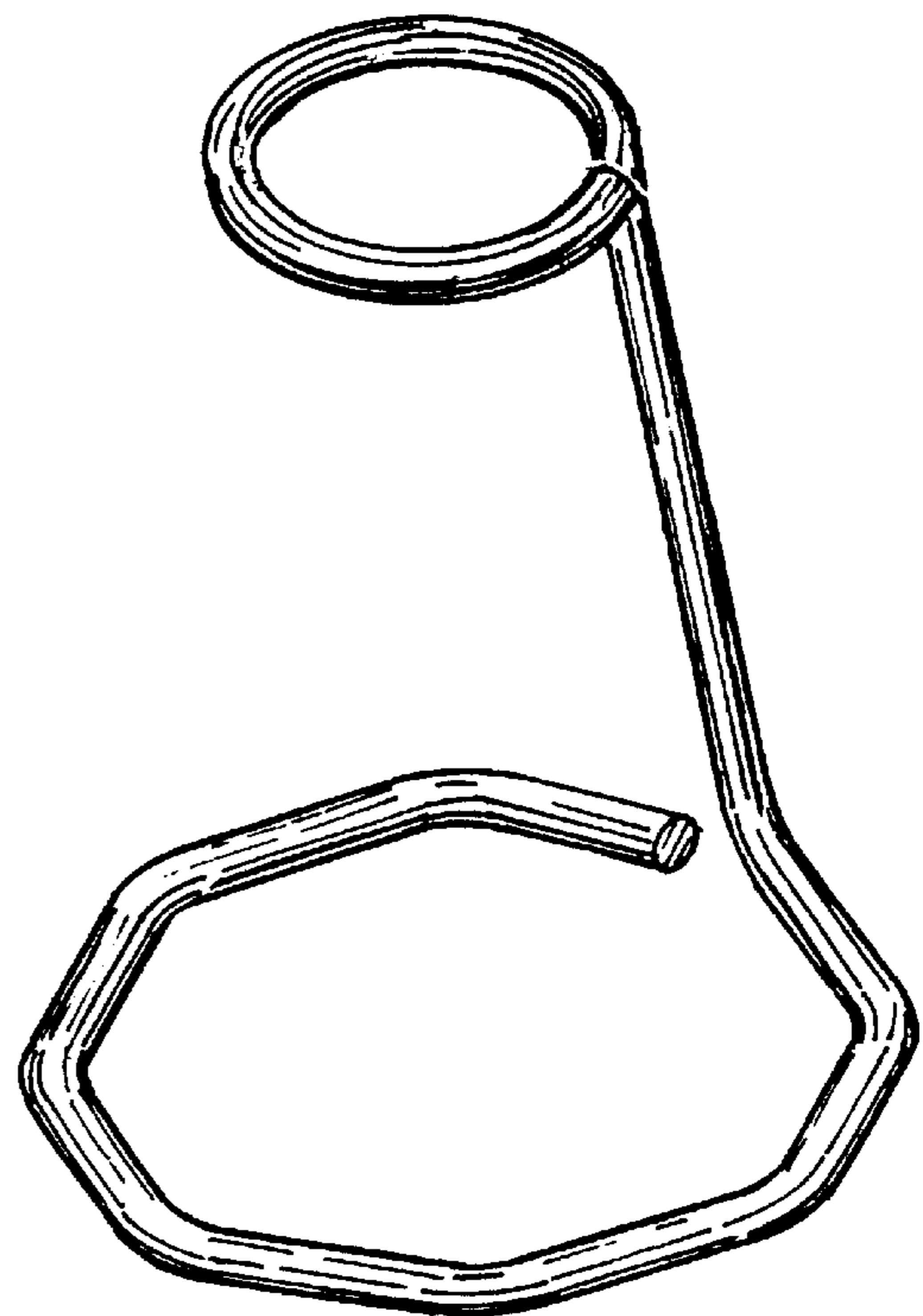
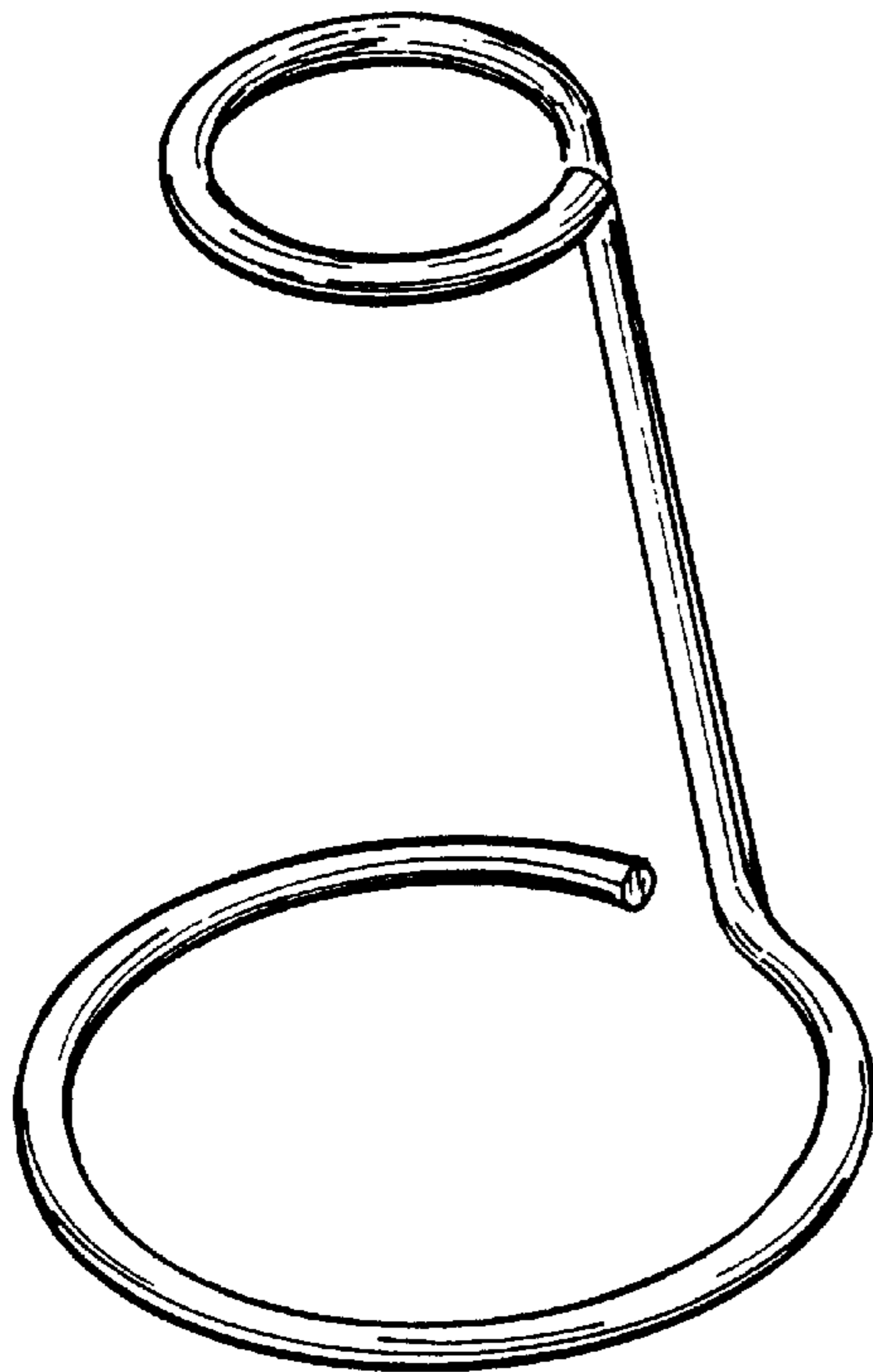
FIG. 6 is a right side view of the of the container holder

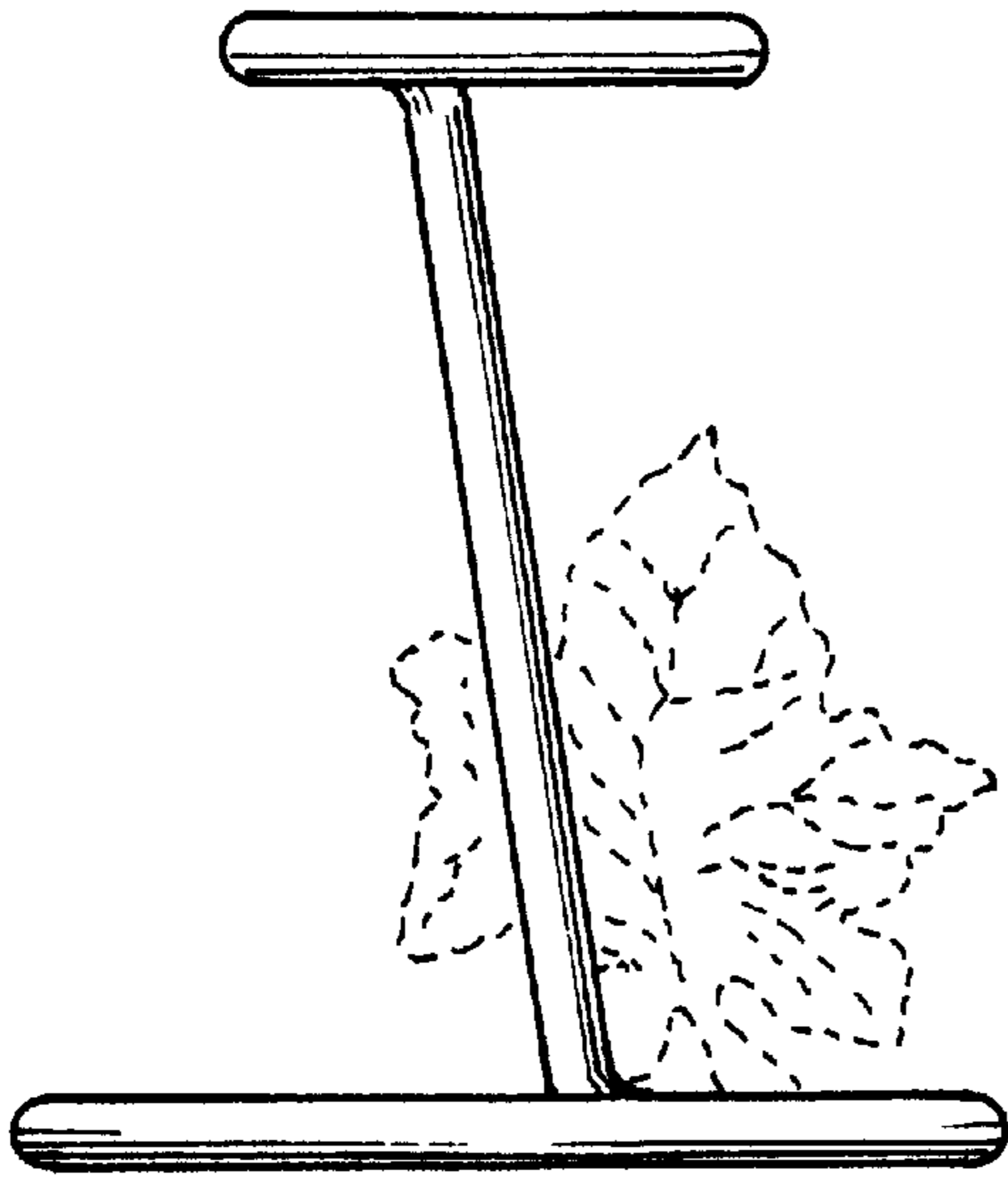

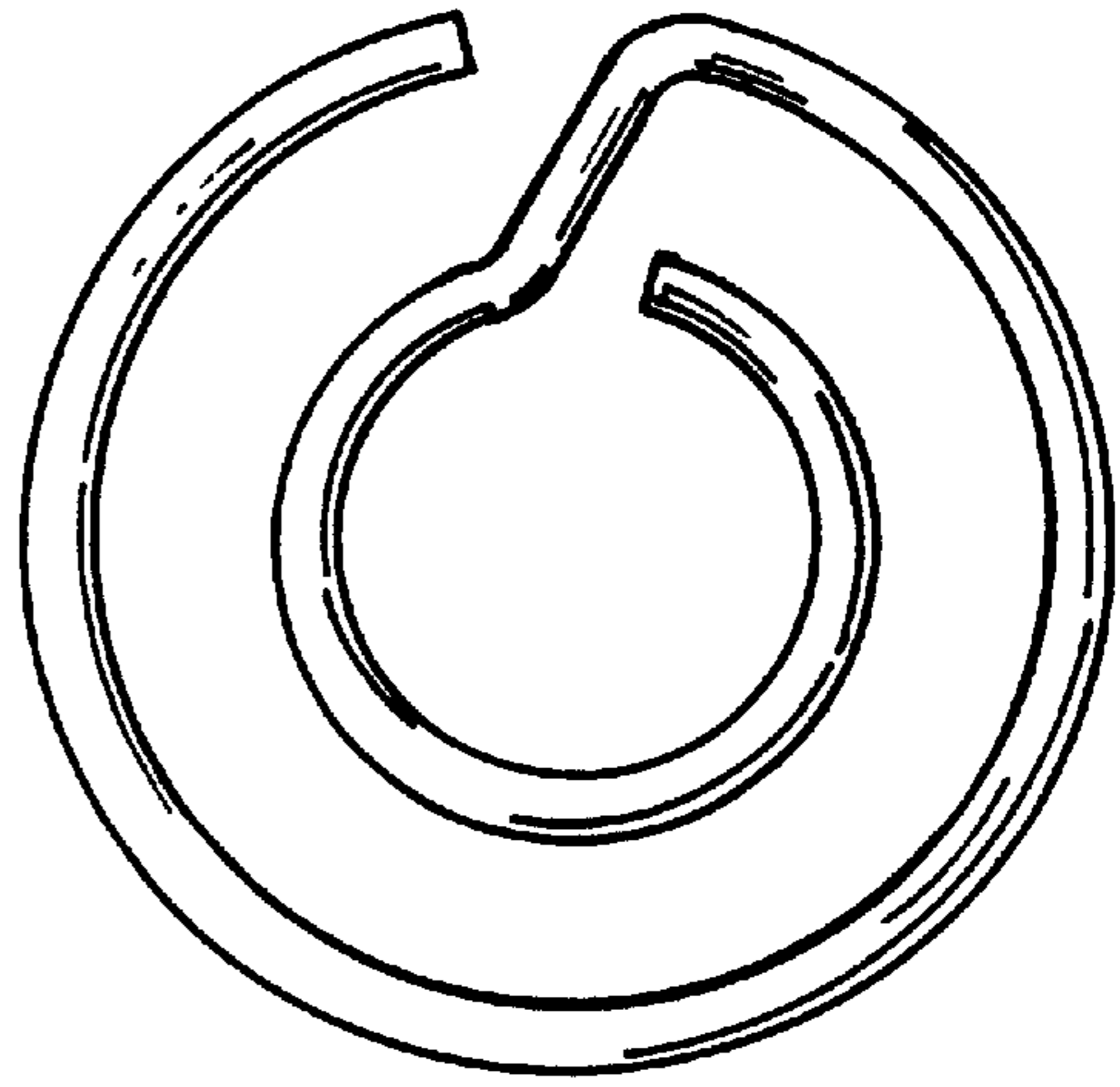

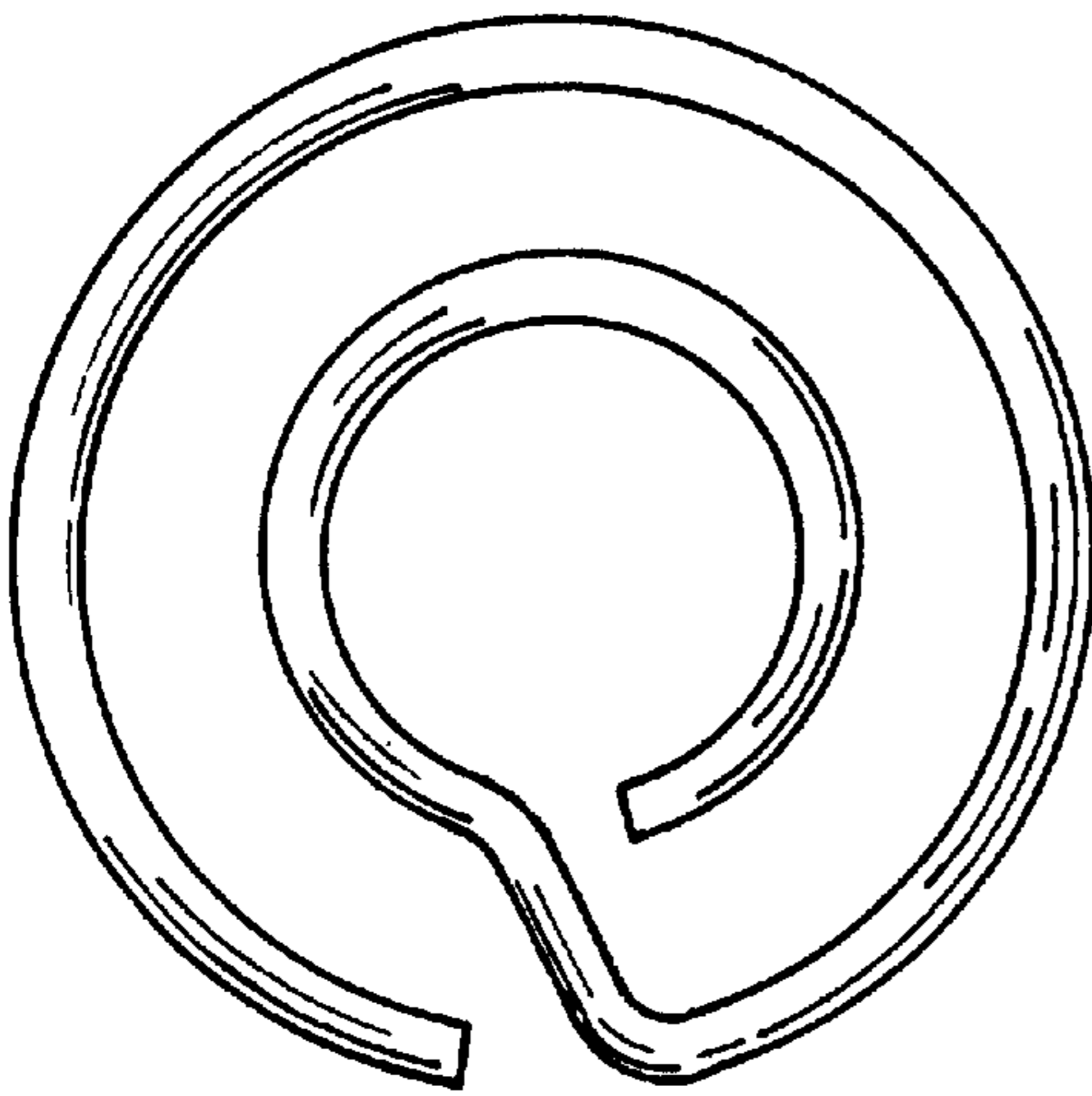

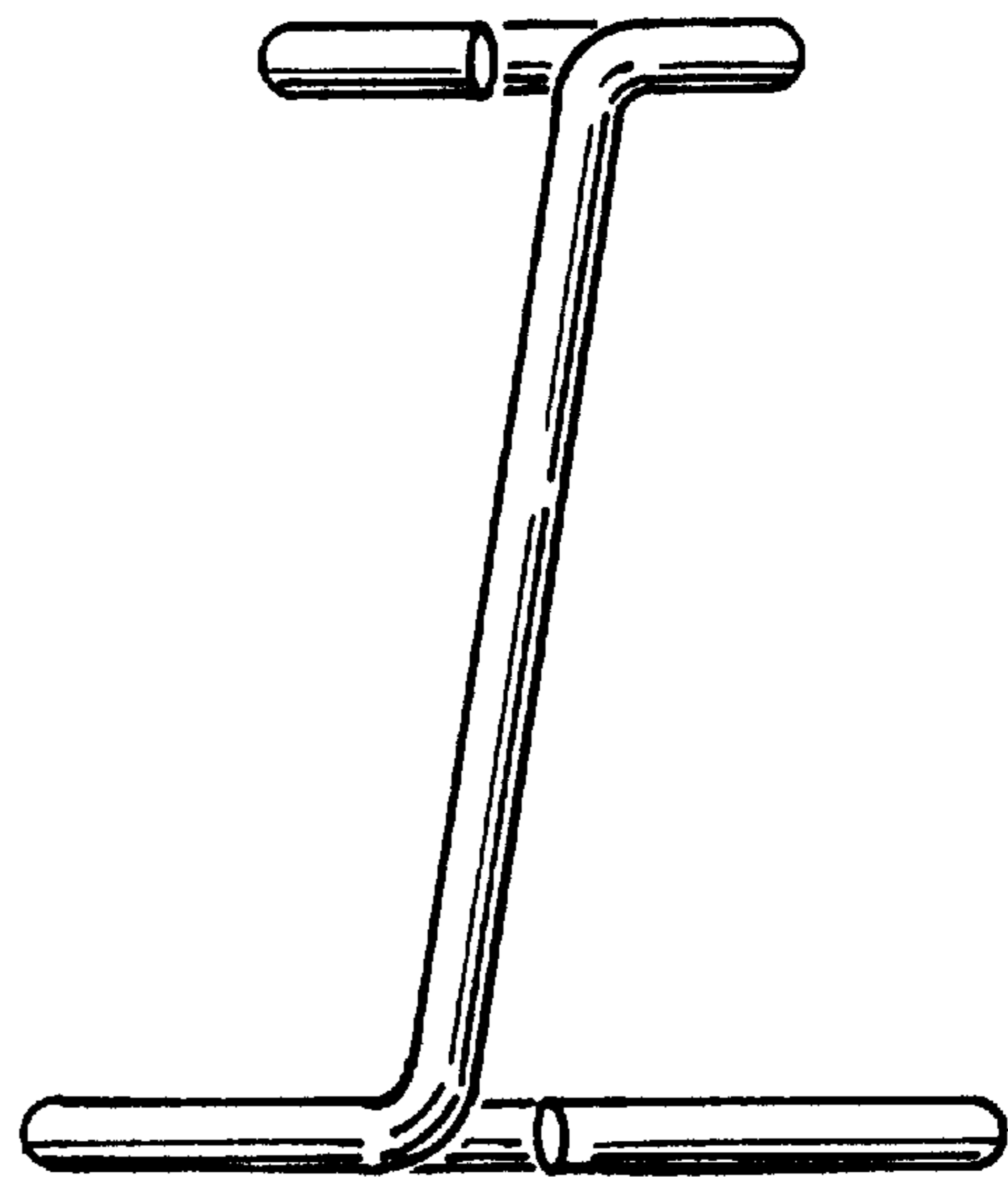

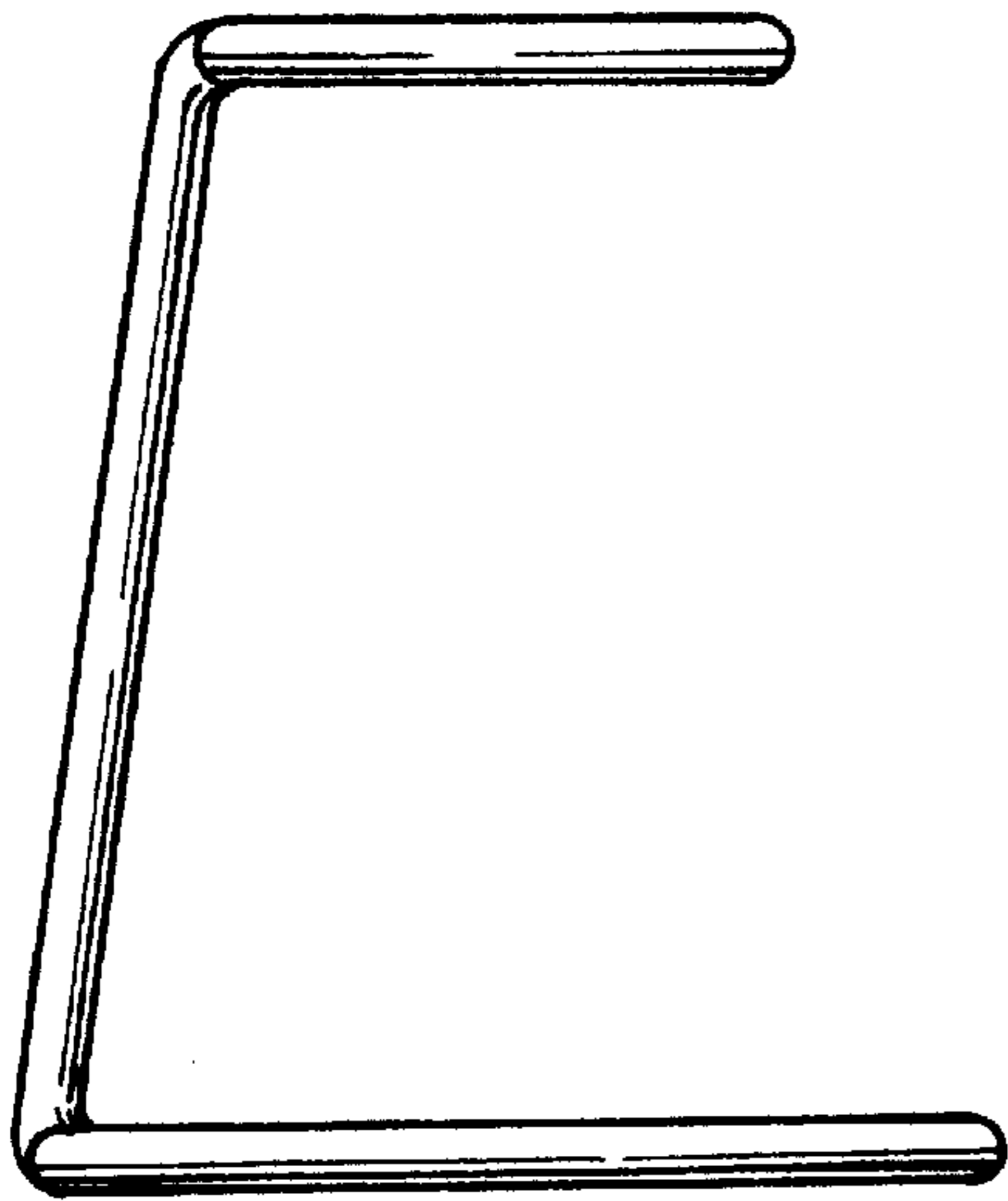

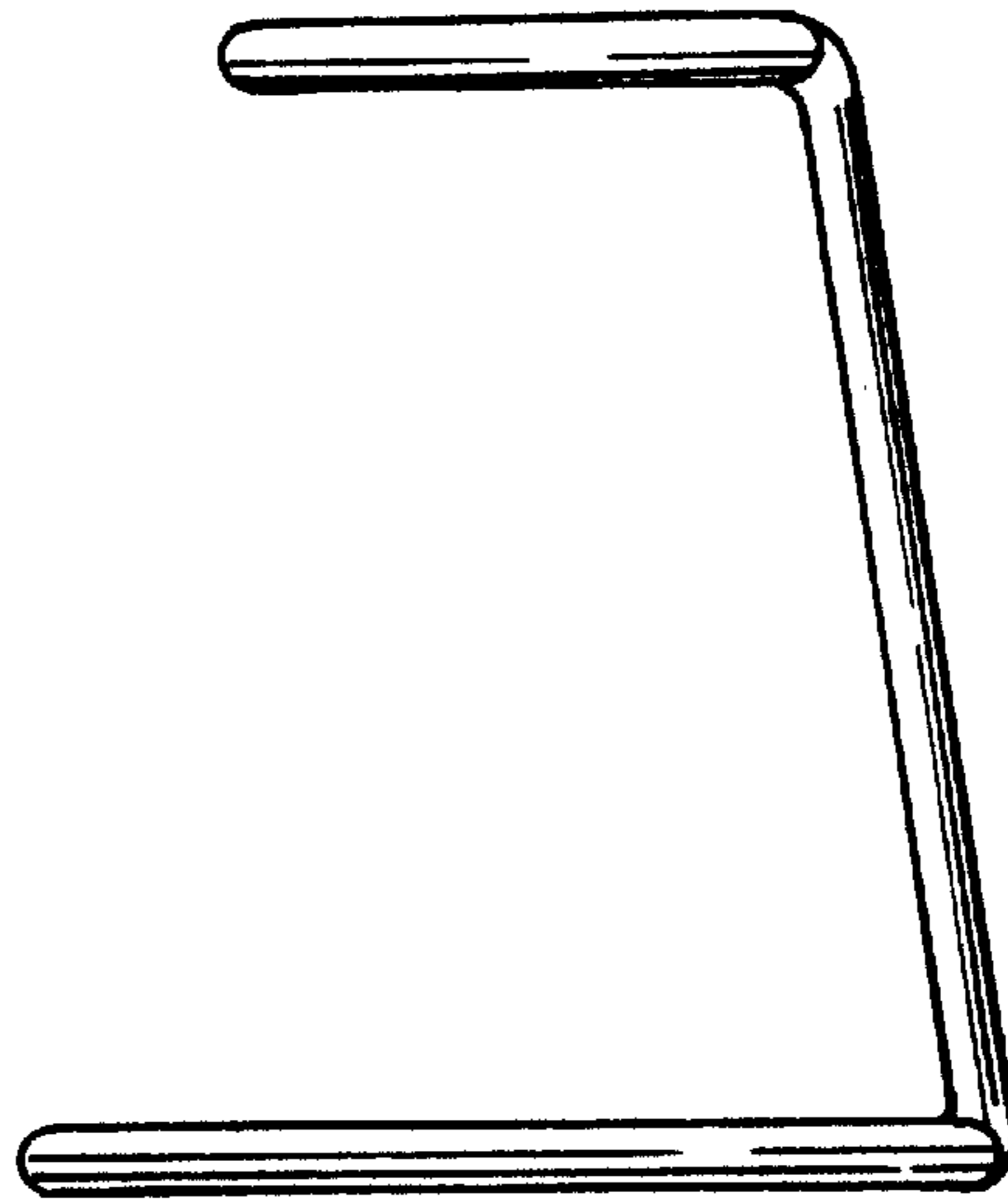

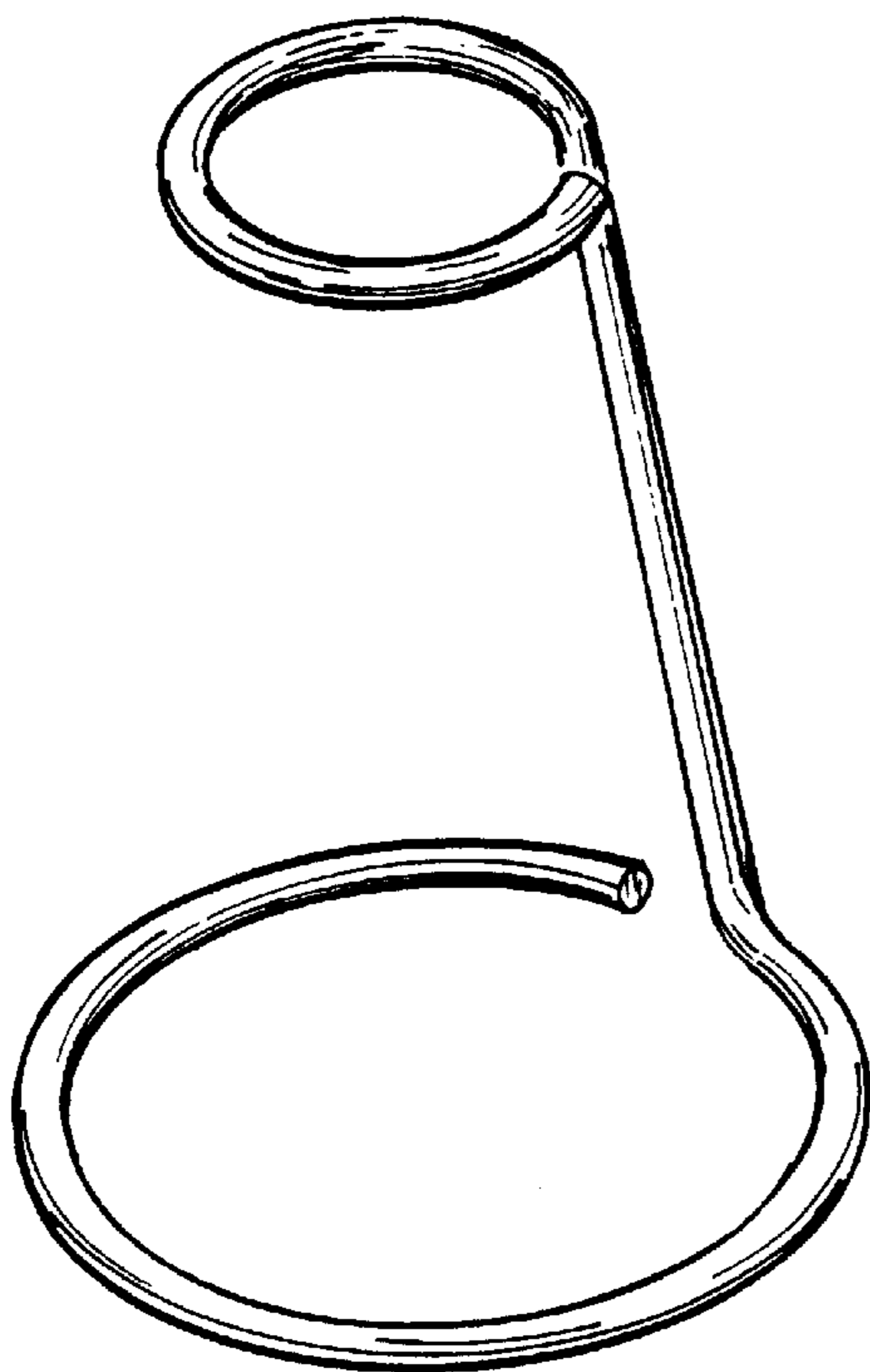

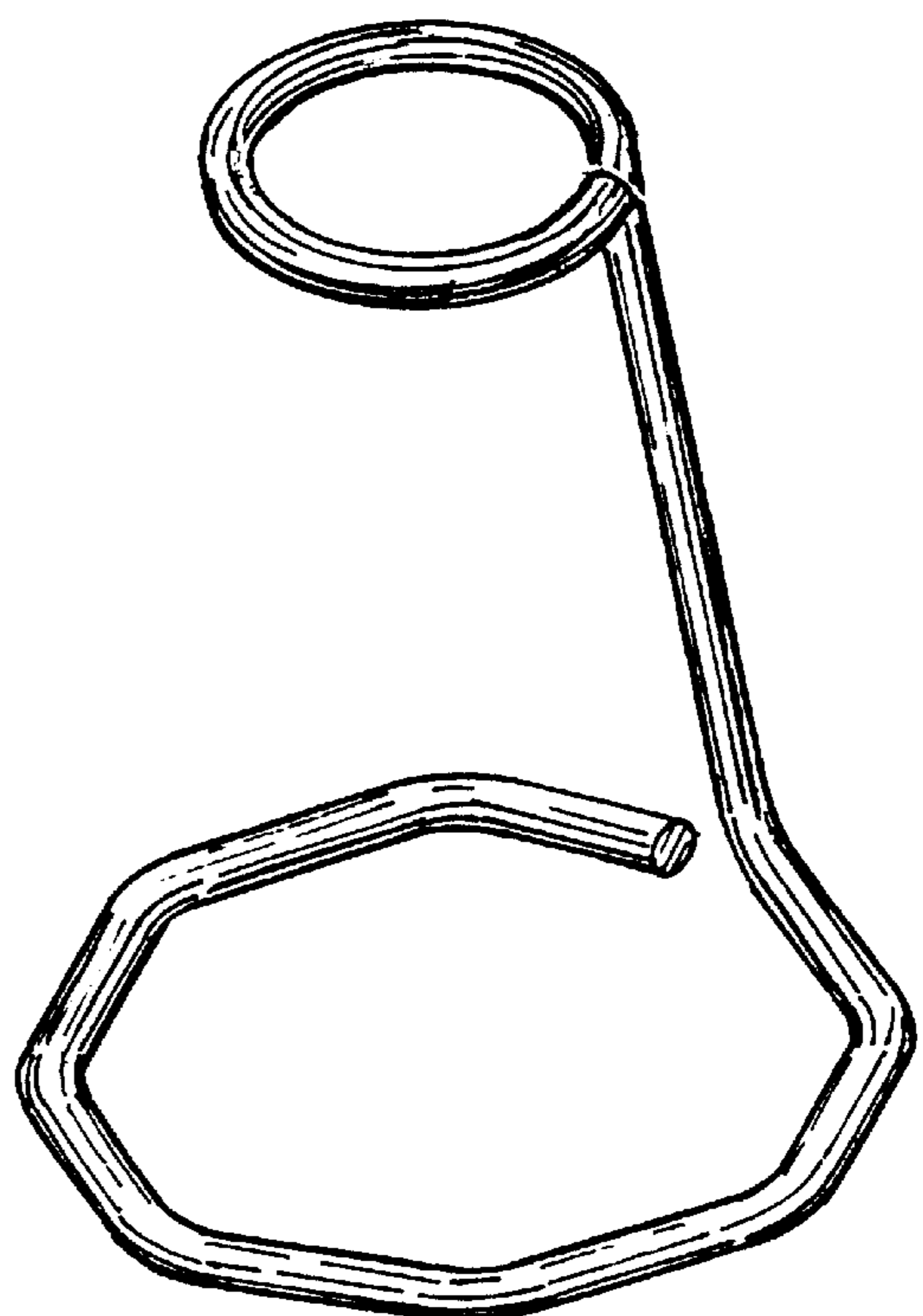
